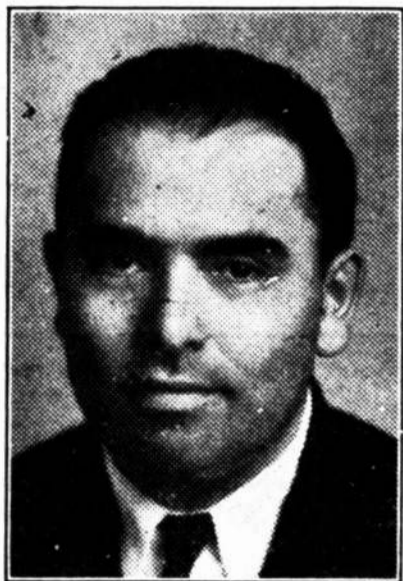
Harry Hines, chairman of the State Highway Department, will attend the meeting, as well as many other outstanding highway men of this section of the state.

# AUTO ACCIDENTS COST TWO LIVES

## J. A. Morrow Is Victim In Sweetwater Accident

The citizens of this section were shocked early Friday morning, when news reached Lamesa that J. A. (Jas) Morrow, a former long-time resident of Lamesa, had succumbed to injuries received in an automobile accident near Sweetwater. Mr. Morrow was living at Rotan and had been to Sweetwater on business. He was returning home Friday night at about 9:30 and had hardly reached the city limits of Sweetwater, when his car and a car driven by a Mr. Townsend met in a head-on collision at the top of a small hill. Both cars contained only one occupant. Both men were immediately rushed to the Sweetwater hospital, where Mr. Morrow passed away about 6:30 Friday morning. Mrs. R. E. Simpson, a sister of this city, and her son, Homer, went to Sweetwater but arrived after his death. Although mortally wounded Mr. Morrow was conscious practically to the time of his death and conversed with his wife and other members of his family who rushed to his bedside, almost to the time of his passing.

Mr. Townsend was rather seriously injured, but it was thought that he would recover. Apparently it was one of those unavoidable accidents. Mr. Morrow was born August 14, 1882 and died July 8, lacking only a few days of being fifty-six years of age. He moved from Lamesa to Seminole, later moving his family to Rotan, where he resided at the time of his death.

Besides the widow, he is survived by four daughters, Mrs. C. C. Smith, Mrs. Marvin Porter, Rotan; Mrs. Carl (Continued on Back Page)

## 6-Year Old Boy Killed Here Sunday Morning

Stark, grim tragedy stalked the heels of little Leslie Earl Hulsey, 6 years old, Sunday morning, as he innocently rolled an old automobile casing in childish glee about his home in the Morning Addition of Lamesa. As he played with the tire, it lead him into the street and almost directly under the wheels of a passing motor car, driven by a near by neighbor, Mr. Buck Churchill. The little fellow was fatally injured, but was rushed to a local hospital where he succumbed a short time later.

Details of the accident were unavailable but it was considered an unavoidable accident, and, it is understood, Mr. Churchill was held blameless.

Leslie, with his parents, had made their home in Lamesa for the past two years. He was born July 23, 1931 and died July 10. Thus it will be seen he lacked only a few days being seven when he was taken.

And once again a home is robbed of a loving little life by the motor age. Another place is vacant at the table, as bewildered parents, slowly realize the naked truth of their misfortune. To the sorrowing parents goes the sympathy of this entire community in this tragic hour. But weep not that he is gone, for did not Jesus say, "Suffer the little children to come unto me and forbid them not, for of such is the kingdom of Heaven." He is at home with God, safe in the arms of Jesus.

Besides the sorrowing parents he is survived by a younger brother, Monroe and his grandparents, Mr. and Mrs. Hulsey.

Funeral services were held at the Higginbotham Funeral Chapel Monday afternoon at 4 o'clock with Revs. Braswell and Cole officiating. Interment was in Lamesa cemetery.

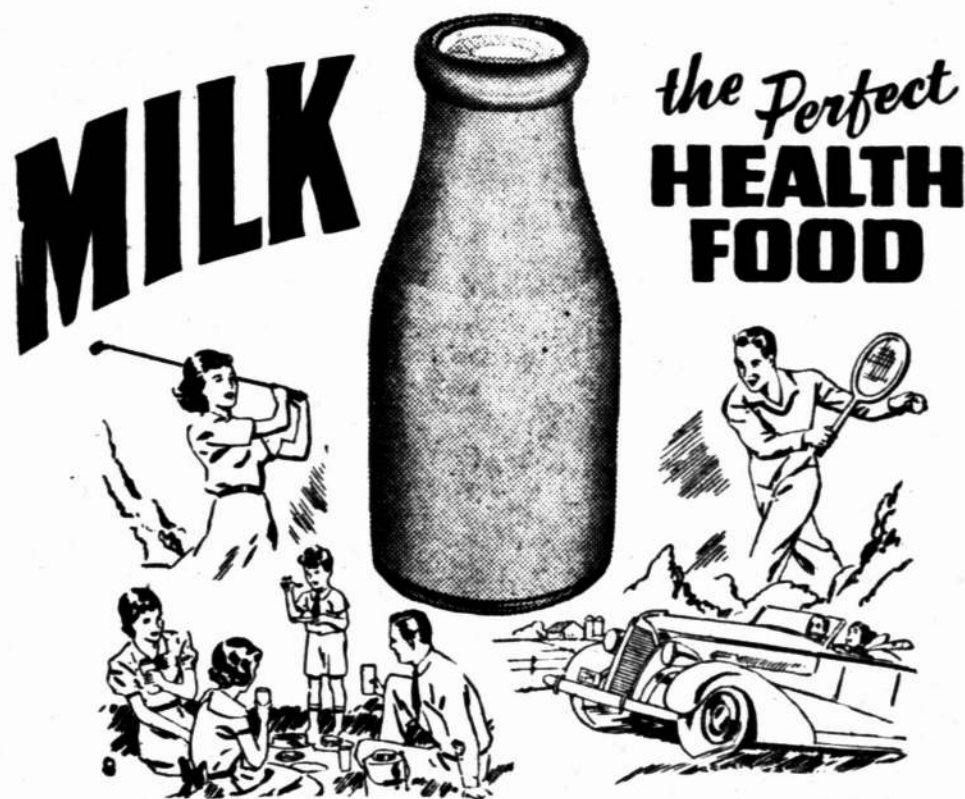



I came to Dawson County with my parents in 1902 and have lived here since that time with the exception of two years and slightly more time spent in the United States Army, during and after the World War and three years spent in the service of the Texas Cattle Raisers Association. I am married, have three children, the eldest being a girl, sixteen years of age.

It has been my opportunity to have the following Peace Officer experience: I was assigned to service with the San Antonio Police upon military enlistment and was given general duty under the Chief of Police of that city, where I served for the first nine months of my army enlistment. I was then transferred to France and after a period of several months training in peace officer work in special schools, I was placed in charge of the peace officer work in various French cities ranging in population from 12,000 to 15,000 and in which I was the highest ranking enlisted man in such work on field duty.

Following the Armistice in November 1918, I was then transferred to Germany, where I was assigned to Chief of Police duty in the combined cities of Berns Castle and Cues with combined population of some 40,000 people.

Shortly after my discharge from the Army and with the Distinguished Service Cross for services rendered, I was elected Sheriff of Dawson county, and was at that time, the youngest sheriff in Texas. All felony cases arising at that time were solved and I had a most active part in aiding with two of the most noted cases in West Texas. Those were the famous Tom Ross and Milt Good cases from Gaines county and the Nixon murder case from Ward county.

The next employment was for a three year period with the Texas Cattle Raisers Association, my main duty being that of stopping and apprehending cattle thieves. I was honored with a life membership in this organization as a recognition of services rendered while so employed.

I have had seven years regular employment in Peace Officer work and in addition I have served on special missions of many sorts, all as a background for efficient and effective service in the position of Sheriff of Dawson county, which I seek at this time.

I desire the office of Sheriff to clear the record on re-election and for the employment which it affords and which I need.

The two year period when I was sheriff in former times was the period in Texas history marked by extremes in political thought and activity which

more of the comforts and conveniences that electricity makes possible. He commended the willingness of the Texas Electric Company to cooperate with the city officials in giving Lamesa lower electric rates, pointing out that this is the fourth rate reduction since 1925.

"The new rates put into effect in Lamesa are in keeping with our policy to reduce the price of electricity as fast as increased use and other factors make such reductions possible," Mr. Cameron said. "Our record of reducing electric rates here goes back to the time when the local electric system was purchased by the predecessor of the Texas Electric Service Company.

In 1925 the residential customer who used 40 kilowatt hours of electricity paid \$5.55, but successive rate reductions have lowered the price until under the new rates now in effect the price for this amount of electricity is only \$2.60, a reduction of more than 50 percent. Few items of everyday living cost have dropped as much in price as electric service.

"The new rates, both residential and commercial, are simple in form. There is no flat charge or room count, and residential customers receive 8 kilowatt hours for the minimum payment of \$1.00. Commercial rates are uniform for all customers whose maximum demand is no more than 4 kilowatts, and for the few large commercial customers who have a load of more than 4 kilowatts, the energy blocks are lengthened slightly to compensate for the increased demand. Representatives of the company will call on all commercial customers and explain in detail the savings under the new rates."

The saving to the city on pumping and street lighting is over \$1200 annually, while the customers will make an annual saving of over \$9,000 a year. O'Donnell and the rural section served by the Texas Electric Service Company will also receive a rate reduction at this time.

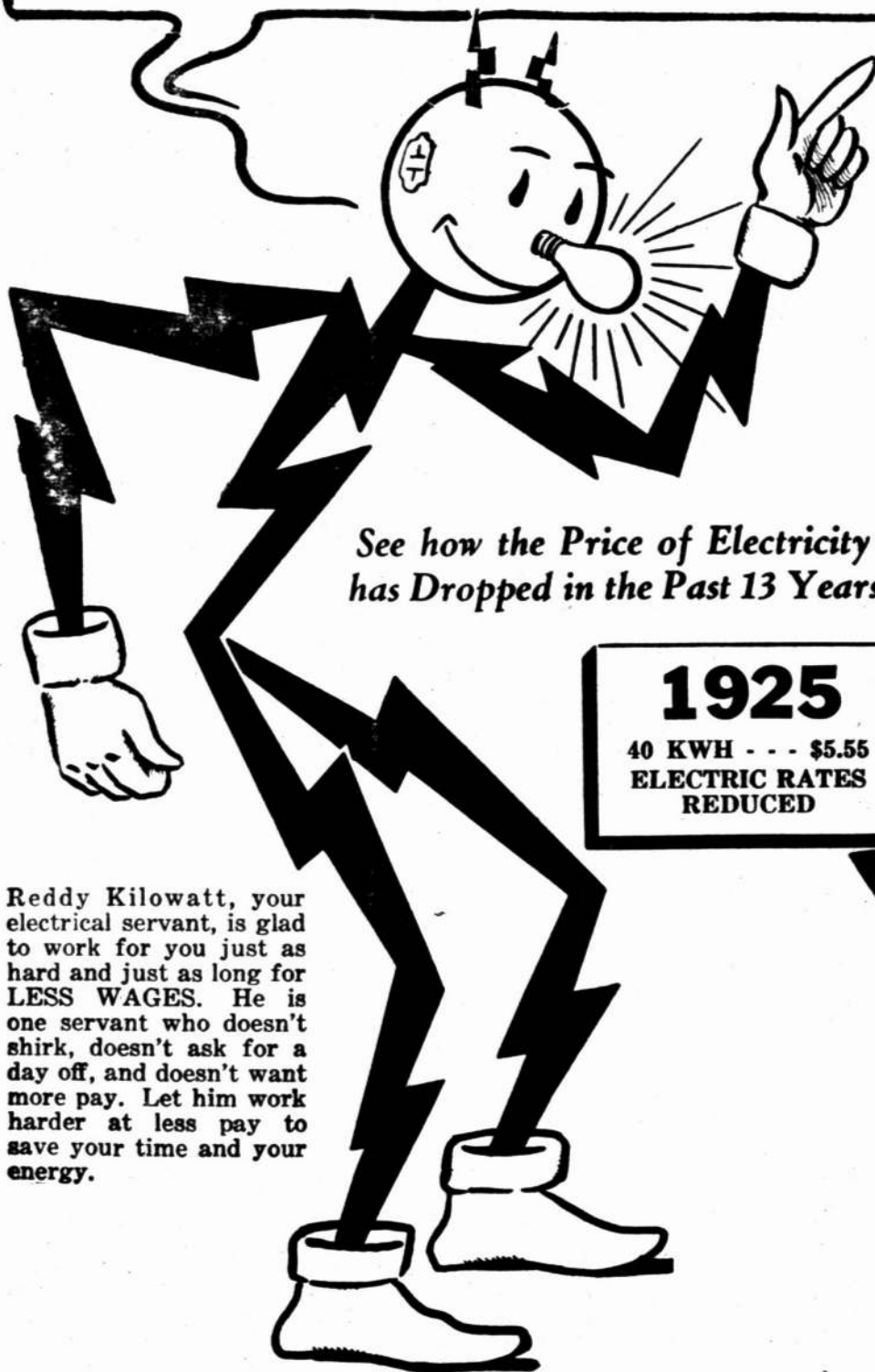

## S.C.S Notes

Solid planting of sorghums or sudan grass for the purpose of stabilizing blown out cotton and wheat lands is considered a good practice. It affords the farmer an opportunity to regain crop residues or trash and at the same time to produce a crop for the cash market or livestock feeding.

Since serious wind erosion in 1935, thousands of acres of valuable land in the Plains area have been severely damaged and made unfit for the profitable production of cotton. Crop residues or trash have become depleted, and the rich topsoil has blown away.

The serious question of what to do with these lands is facing the farmer today. The planting of sorghums and sudan grass has proved to be the quickest and safest way to stabilize and get these lands back into production. The sorghums and sudan grass are drought-resistant, and at the same time are good soil binders due to their extensive root growth. Instances are known where the stubble from a single crop of sorghum or sudan grass has prevented soil blowing through two successive seasons. They endure a great deal of hardship and neglect, but they respond to good seedbed preparation, timely neglect, and a plentiful moisture supply.

Since the rains, persons traveling by airplane and automobile have commented about the water they observed held behind terraces and in contour furrows. Water held on the land by this means soaks into the soil and is stored for the use of growing crops. Experience of many farmers shows that when there is sufficient moisture in the soil at planting time, advantage should be taken of the opportunity to get a crop started. Whether it be cotton or row crops in the spring and early summer or wheat in the fall, some crops should be planted, not only to give the farmer an income, but also to protect the soil from erosion.

"For whatsoever a man soweth, that shall he also reap." If he sows nothing he may reap dust.

Convincing proof of the advantage of conserving moisture for sorghum crops was proved at Dalhart last fall. You will remember that the rainfall in that area was below normal, ranging from 11 to 15 inches for the whole year. Yet under these conditions the survey on 43 fields showed that where moisture was held behind terraces the increase in the grain sorghum crop harvested was over 50 per cent more than in fields farmed by straight-row methods. Twenty terraced field averaged 723 pounds of headed sorghums to the acre; 21 fields contour tilled but not terraced averaged 589 pounds to the acre; and seven straight row fields produced only 461 pounds to the acre. That is a difference of 262 pounds between terraced and straight-row fields. Isn't that a pretty good dividend to collect on the cost of terracing?

Observations during the year showed that all unterraced fields except those of deep sandy soil, lost a large amount of water by runoff, and that the only crop produced was in low spots where this water accumulated, while on the higher parts of the fields from which the water ran, the crop failed in most cases. On the other hand the crops on terraced fields were remarkably uniform throughout, resulting in higher yields of grain for entire fields and at the same time providing a well distributed amount of stalks and trash to protect the soil.

Because of the immediate importance of getting a cover of forage crops on the land in the 25 most seriously affected counties, the Farm Security Administration has modified its lending policy to make credit available this spring to any eligible farmer whose land has sufficient moisture and who desires to plant cover crops. This policy makes available to the farmer money for emergency planting not heretofore provided under compliance regulations. In loans of this type preparation of a farm management plan will be waived; the loan will be secured by mortgage on the crop to be produced. Arrangements have been made to secure a rapid processing of this loan. Any farmer who wishes to secure this credit should make application at once to the Farm Security Supervisor. County Agents will be glad to tell farmers where they can get in touch with Farm Security Supervisors.

## TILLAGE METHODS IMPROVE LOCAL FARMS

Hundreds of Southern Plains farmers are making their farms more profitable by applying tillage methods designed to retain their soil and moisture by applying tillage methods designed to retain their soil and moisture. Without upsetting their general farming programs, these farmers are terracing farming on the contour, plowing pasture furrows, constructing dams and stock water ponds, planting trees, rearranging the fields and doing other things designed to increase farm income and check erosion.

Particularly noticeable are farm changes being made on the Soil Conservation Service erosion control demonstration project located near Lamesa, Texas and in similar areas near Littlefield, Hereford, Memphis and Vega, Texas.

On these areas, five year erosion control programs are being carried out. Such programs call for terracing, contour farming, growing of cover crops, strip cropping and other practices prescribed to check wind and water erosion. These are the things that are making farms pay now dividends.

On many farms field divisions fence are being relocated so that they are on the contour. Such fences are being found to make excellent permanent guide lines for contour farming and also help to eliminate point rows on contour-tilled fields. In some areas, field division roads also are being put on the contour. These, too, are valuable as contour farming guide lines.

Change in direction of rows probably is one of the most noticeable things being done in reorganizing farms for erosion control. Contour rows that sweep gracefully across slopes tend to give the farms a streamlined appearance. It also has been proven that it takes much less power to pull farming equipment along on a contour level row, than one which runs up and down the slopes.

## COTTON CLASSING SERVICE WILL BE FREE TO MEMBERS

College Station, July 11.—Forms and instructions for use in making request for the free cotton-classing service to be supplied this year for properly organized one-variety groups are now available, according to E. A. Miller, agronomist of the Extension Service of College Station.

The forms and instructions for filing may be obtained from any one of the cotton-classing offices of the bureau of agricultural economics. Address of Texas offices are P. O. Box 1366, Dallas P. O. Box 1140, Austin; and 509 U. S. Court House, El Paso.

The classing service as it will be started with the 1938 cotton crop provides free classification of a sample from each bale of cotton produced by a member of a qualified improvement group.

Notification of the grade and staple length according to the U. S. Cotton Standards, will be returned to the grower from whose bale the sample is drawn. The service is not available to individual cotton growers, only to members of organized improvement groups. Miller urged that one-variety associations that desire the free service for the current crop apply as promptly as possible, so that the Bureau may arrange all details for handling and shipping of the samples.

Only those communities that will qualify by meeting the rules and regulations of the Bureau of Agricultural Economics will be eligible to receive the classing service, Miller said.

### Farmers Are Aided By Rehabilitation Loans In This Co.

The net worth of low-income farmers in Dawson county, served by the Farm Security Administration is steadily improving, according to a statement issued this week by S. P. Collins, rural rehabilitation supervisor, as he made preparations to begin the new fiscal year for this federal agency, beginning July 1.

Mr. Collins said his agency is serving 130 families in Dawson county. He also said that in view of the progress made in the past two or three years by the rehabilitation loan program borrowers, the Farm Security Administration will be able to extend this aid to other worthy families of the low-income group.

The Farm Security Administration's broad program for farmers include rehabilitation loans, community and cooperative service, farm debt adjustment service, and tenant purchase loans. All of these different services are, of course, designed to help distressed farm families rehabilitate themselves.

A typical rehabilitation loan, Mr. Collins explained, includes money for the purchase of seed and fertilizer, for buying workstock, farm machinery, cows, brood sows and chickens. It may also include money for the purchase of needed articles in the home, such as pressure cookers and canning jars. Occasionally a few collars are set aside for the purchase of clothing and medical attention. All families obtaining a rehabilitation loan, however, are required to make budgets for living and keep accurate records of all transactions.

Just how well this program is progressing in Dawson county may be gleaned from Mr. Collins' record which shows that a number of families have completely paid all of their obligations and are now commencing their farming operations without help from this agency, and a few of the farmers in this county have repaid their loans long before they were due.

Mr. Collins said rehabilitation loans are made to come due in installments of from one to five years, depending upon the nature of things to be purchased with the loan money, and the financial condition of the particular family. Crop liens and chattel mortgages are taken as security.

Mr. Collins who has offices in the court house, said he will be glad to explain all phases of the Farm Security Administration program to all interested parties.

### FARM PONDS OF VALUE TO FARMS

Surplus run-off water in farm ponds not only is made available for livestock but also serves a valuable purpose in aiding wildlife development and possibly as a recreational spot, says L. H. Donnell, Engineer Aide, of the Soil Conservation Service demonstration camp near Lamesa, Texas.

The location of ponds is important. If ponds are to be prevented from filling with silt, erosion control practices should be used on the drainage area. Where possible, the drainage-way should include only pasture or woodland. However, when drainage is cultivated land, the pond should be protected from silting by conservation practices.

The usefulness and life of the pond will depend to a great degree upon the type of vegetative cover and the size of the drainage-way. If the water is loaded with silt, the pond will be filled within a few years and its usefulness lost, it is pointed out.

When proper attention is given to the location of ponds, farmers find them highly valuable and long lived. Ponds usually should be fenced as protection from livestock with a watering place being provided below the dam by pipe outlets or tanks. In all cases the earthen fill should be fenced to protect the structure from trampling by livestock.

### Texas Wildlife

Austin, Tex., July 5.—Texas hunters who want to bag a Mountain Sheep must go to other states to the north and west. In Texas the animal is protected by a closed season the year round.

They are found in the Guadalupe, Beech and Sierra Diable Mountains north of Van Horn, but not much is known of their occurrence, numbers, or the factors that have prevented their increase.

To gather such information the Game, Fish and Oyster commission has sent Robert Snow, experienced field naturalist of the Bighorn country to make a thorough study of the animals.

Accompanied by Dr. Walter P. Taylor, senior biologist of the Texas Cooperative Wildlife Service at A. and M. Snow and his party made their first reconnaissance recently. They saw only seven Bighorns, most of them in the Beech and Sierra Diable Mountains. Few signs were seen in the Guadalupe. Factors limiting the numbers and increase of the Bighorns remain to be determined. Residents nearby blame the Mountain Lion and more especially the Golden Eagle. Snow and his party saw few skins of Mountain Lions but many eagles.

Dr. W. B. Davis, head of the Department of Wild Game at A. and M. College, plans to join Snow for several

weeks work in the Guadalupe and adjoining Mountains during August and September. It is hoped the Bighorn study can be made cooperative so as to include not only the Texas Game, Fish and Oyster Commission, but also the New Mexico Fish and Game Commission, the U. S. Forest Service and the U. S. Biological Survey. It is planned that the study will be carried forward on both sides of the New Mexico-Texas line.

Snow trailed four Bighorns in the Guadalupe mountains three days, after locating them on a high semi-barren ridge, reached after a two-hour climb. He said their sure-footedness in leaping from crag to crag was every bit as remarkable as veteran hunters picture it. The Bighorn excited only once—when a band of Eagles circled over them. Then they ran together as if for protection.

Antelope are increasing steadily in some portions of western Texas. Game Warden W. D. Stubblefield, stationed at Ysleta, estimates there are from 2,500 to 3,000 in Hudspeth county, where range conditions are good and the attitude of the landowners favors the protection of this fleet-footed animal.

Along the Rio Grande Valley below El Paso, however, Stubblefield reported extensive clearing operations. Clearing of vegetation will be detrimental in that section not only to Antelope, but to Gambel Quail and Ring-neck Pheasants, he said.

Investigators have reported some unusual nest records in Colorado county. One Roadrunner didn't show a bird's instinctive fear of dogs or cats; it successfully raised three young in a farmer's yard within 10 yards of a dog kennel and a whole family of cats.

A quail nest is being incubated by a male quail.

A Jackdaw built its nest on the top of a Dove nest containing young Doves. One Jackdaw is incubating Dove eggs as well as her own.

Jackdaws, known to naturalists as Grackles, not only eat many dove eggs but devour many of their own eggs as well. In fact, Grackles are their own worst enemy at nesting time.

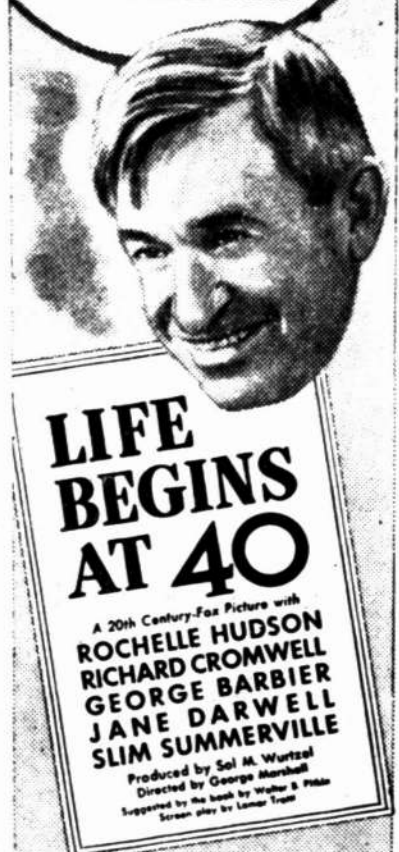

## Farmers Are Aided By Rehabilitation Loans In This Co.

The net worth of low-income farmers in Dawson county, served by the Farm Security Administration is steadily improving, according to a statement issued this week by S. P. Collins, rural rehabilitation supervisor, as he made preparations to begin the new fiscal year for this federal agency, beginning July 1.

Mr. Collins said his agency is serving 130 families in Dawson county. He also said that in view of the progress made in the past two or three years by the rehabilitation loan program borrowers, the Farm Security Administration will be able to extend this aid to other worthy families of the low-income group.

The Farm Security Administration's broad program for farmers include rehabilitation loans, community and cooperative service, farm debt adjustment service, and tenant purchase loans. All of these different services are, of course, designed to help distressed farm families rehabilitate themselves.

A typical rehabilitation loan, Mr. Collins explained, includes money for the purchase of seed and fertilizer, for buying workstock, farm machinery, cows, brood sows and chickens. It may also include money for the purchase of needed articles in the home, such as pressure cookers and canning jars. Occasionally a few dollars are set aside for the purchase of clothing and medical attention. All families obtaining a rehabilitation loan, however, are required to make budgets for living and keep accurate records of all transactions.

Just how well this program is progressing in Dawson county may be gleaned from Mr. Collins' record which shows that a number of families have completely repaid all of their obligations and are now continuing their farming operations without help from this agency, and a few of the farmers in this county have repaid their loans long before they were due.

Mr. Collins said rehabilitation loans are made to come due in installments of from one to five years, depending upon the nature of things to be purchased with the loan money, and the financial condition of the particular family. Crop liens and chattel mortgages are taken as security.

Mr. Collins who has offices in the court house, said he will be glad to explain all phases of the Farm Security Administration program to all interested parties.

## Shipment of Live Stock Off In May

Austin, Tex. July 5.—Livestock shipments to the Fort Worth stockyards and interstate points from Texas farms and ranches during May were moderately below those of the corresponding month last year, it is reported by the University of Texas Bureau of Business Research. The total of 10,308 cars represented a decline of 12 per cent from May 1937.

Cattle shipments, 6,788 cars, declined 15 per cent from May last year; shipments of calves, 844 cars, declined 4 per cent; hog shipments, 615 cars, declined 1 per cent and shipments of sheep 2,061 cars were down 6 per cent.

Miss Mattie Phenix, home demonstration agent, was to give the club a demonstration, but wasn't there, so different subjects were discussed by the members. Mrs. Everett Turner gave a report on council meeting.

The usefulness and life of the pond will depend to a great degree upon the type of vegetative cover and the size of the drainageway. If the water is loaded with silt, the pond will be filled within a few years and its usefulness lost, it is pointed out.

Where cultivated fields are terraced or tilled on the contour, there is little danger of run-off water carrying silt into the farm ponds.

When proper attention is given to the location of ponds, farmers find them highly valuable and long lived. Ponds usually should be fenced as protection from livestock with a watering place being provided below the dam by pipe outlets or tanks. In all cases the earthen fill should be fenced to protect the structure from trampling by livestock.

## FARM PONDS OF VALUE TO FARMS

Surplus run-off water in farm ponds not only is made available for livestock but also serves a valuable purpose in aiding wildlife development and possibly as a recreational spot, says L. H. Donnell, Engineer Aide, of the Soil Conservation Service demonstration camp near Lamesa, Texas.

The location of ponds is important. If ponds are to be prevented from filling with silt, erosion control practices should be used on the drainage area. Where possible, the drainageway should include only pasture or woodland. However, when drainage is cultivated land, the pond should be protected from silting by conservation practices.

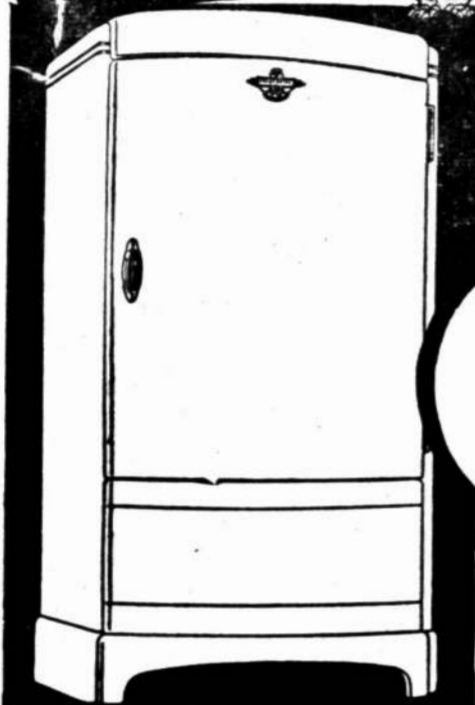

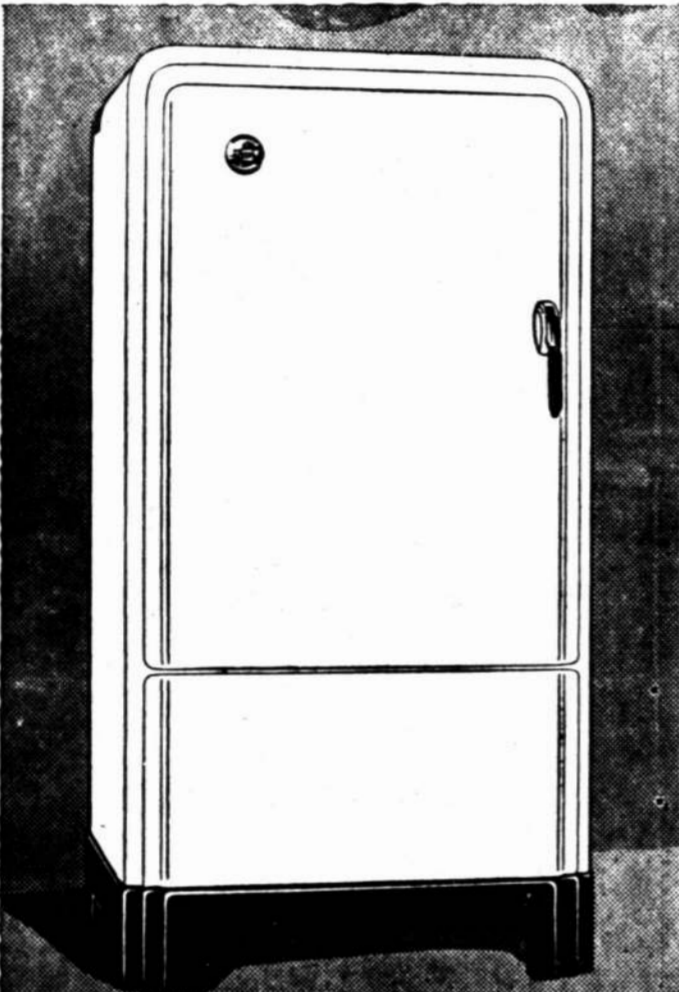

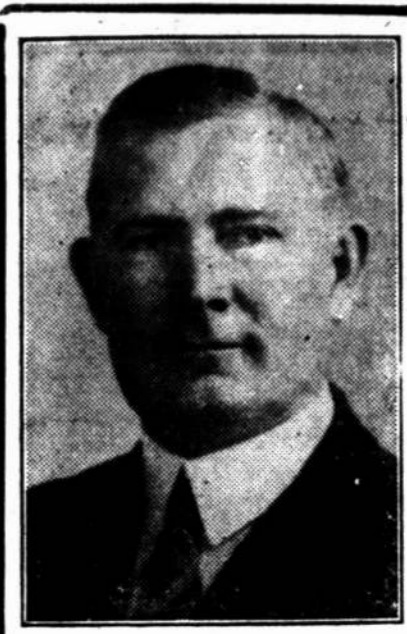

**Farm Income Is Up In May Over April**

Austin, Tex., July 5.—As computed by the University of Texas Bureau of Business Research, farm cash income in Texas during May was \$25,832,000 compared with \$20,923,000 during the preceding month and \$31,022,000 during May last year. Normally there is a decline in farm cash income for the state as a whole from April to May, so that

the increase in May this year of April caused a sharp increase as a whole after adjustment is made for seasonal variation.

The decline in income as compared with May last year was primarily the result of the drop in farm prices. In the districts in which livestock are relatively important farm cash income held up well. During the first five months of the year the computed farm cash income for the entire state—exclusive of government payments—was \$99,229,000 compared with \$112,138,000 during the corresponding months last year. It is estimated that the computed figure is about 90 per cent of the actual.
