SPAIN'S THREAT TO WITHDRAW IS HEARD AT COURT

SWEDEN DRAWN IN FUSS AS COMMERCIAL ROW IS BROUGHT UP

(By Associated Press.)
GENEVA, Mar. 12.—Representatives of the Allied powers and Germany met for two hours today and discussed the difficulties which have arisen over the plan for Germany's admission to the League of Nations and elevation to the league council.

Communiqué Is Raised.
At the end of the session, a communiqué was issued stating that various suggestions had been made by one side or another, and that the delegates would meet again after time for reflection. The preceding statement gave the impression that the situation was brighter.

Spain Is To Resign.
GENEVA, Mar. 12. (AP)—It is learned from an authoritative source that Spain has definitely decided to resign from the League of Nations unless she is given a permanent seat in the council.

From the same source it is learned that Spain has informed Sweden that, because of Sweden's friendly attitude in connection with the Spanish candidacy for a permanent seat, Spanish diplomats are breaking off the pending negotiations for a commercial treaty with Sweden.

Rumors that league officials were investigating America's stand in the World Court question failed to materialize into facts today, no mention being made of the United States' program in news dispatches.

FIRST TABULATION OF BALLOTS SHOWS THOSE FAVORING STRICT ENFORCEMENT ARE IN MAJORITY

BACKERS OF LIGHT WINES AND BEER FOLLOWING CLOSELY, HOWEVER, BUT STANDPAT WETS ARE OVERWHELMED; PASTORS BACK PRO-LAWS

With only the first 165 ballots tabulated the "bone dries" are leading in the Daily Journal's prohibition poll, being held for Lubbock and the South Plains territory in conjunction with 700 other daily newspapers in the country and under the supervision of NEA feature syndicate. First counts showed 59 votes for the retention of the present law with strict enforcement, 40 for modification of the statute and the legalizing of the sale of light wines and beer, and 6 for the repeal of the 18th amendment and a return to the open saloon.

Last Chance Today

OSAGE SLAYING TRIAL STARTED

Opposing Consels Meet Head-On As Trial Of Hale Is Opened In Pawhuska

(By The Associated Press.)
PAWUSKA, Okla., Mar. 12.—Opposing counsel met head on at the opening here today of the preliminary hearing of W. K. Hale and John Ramsey, charged with murder, and the taking of testimony awaited the clearing of legal smoke. The state moved first to delay the hearing until 2:00 P. M., to enable members of the prosecution counsel to study further evidence turned to them by the federal government. Judge L. A. Justus overruled the motion and ordered the hearing to start.

Federal Man Bombarded

The defense then opened up its guns on T. B. White, head of the federal bureau of investigation at Oklahoma City. They demanded that White be excluded from the court room and when the court refused to follow their demand, they asked that he be searched for firearms.

The state then called Dr. E. A. Shoun of Fairfax, who testified that W. E. Smith, whose death Hale and Ramsey are charged, died as the result of injuries received when his house at Fairfax was blown up in the spring of 1923. Dr. Shoun said that poisoning contracted through burns was the direct cause of death.

Dawes Announces The Committee On Tariff

WASHINGTON, Mar. 12. (AP)—Senator La Follette, Republican, Wisconsin, was named today by Vice President Dawes as the "progressive Republican" on the presidential committee which is to investigate the tariff committee.

The other members of the committee were named as follows: Senators Wadsworth of New York and Reed of Pennsylvania, Republicans, and Robinson, Arkansas, and Bruce, Maryland, Democrats.

The committee will select its own chairman and is expected to begin the inquiry next week.

Senator La Follette is the only senator listed in the congressional directory as a "progressive Republican."

Over-Insurance Is Rapped By Fireman

FORT WORTH, Mar. 12. (AP)—Over-insurance as an encouragement of arson, was attacked by J. N. Holton, state fire marshal and member of the state fire insurance commission, in an arraignment of Texas arson laws before the board of directors of the Texas Association of insurance agents here today. ORAL ARGUMENTS OPENED IN BOOK CONTRACT CASE

BROADCASTED THAT SUIT WOULD BE FILED, SAY COMPANY LAWYERS

(By The Associated Press.)
AUSTIN, Mar. 12.—In oral argument before the Supreme Court today, the American Book Company charged that S. M. N. Marrs, superintendent of public instruction, has intimidated school authorities in broadcasting reports that the Attorney General is to file suit to annul the company's contract.

Claims Are Made

The company was represented by former Attorney General W. A. Keeling, R. B. Cousins, Jr., assistant attorney general, for the state, despite the charges and said that the "claimed" contract was resisted because of defects in the functions of the textbook commission in adopting the general science and spelling texts of the company. The contracts are for six years and are worth about \$250,000. Keeling charged that though Marrs was ordered by the board of education to send out lists of the adopted books, that Marrs only sent out a circular letter a month after he was ordered to, and four months later than he should, which carried the American Book Company's texts. He declared that Marrs had evaded his duties and had not conformed to the law.

List Disregarded, Charge

Cousins charged that the text book commission list of December disregarded the Attorney General and last November disregarded the advice of the Attorney General and executed the "waived" contract and that the company was not satisfied with that but in some way another meeting of the textbook commission was held February 9, and the action was ratified. He stated that on the same day the board of education ratified the commission's action on the "claimed" contract, and within two hours, an application was filed in Supreme Court for a writ of mandamus to compel Marrs to recognize the contracts.

3 SOLONS DIE IN A MEXICAN RIOT

TEPIC, Nayarit, Mexico, Mar. 12. (AP)—As the result of riots three representatives of the state, Nayarit, were dead, number of persons injured and one girl near death as a result of a disturbance occasioned when orders for closing a Catholic church were met by armed opposition from church followers.

The immediate cause of the tragedy was in the neighboring town of Jalisco, where a Catholic priest had failed to comply with the closing law of the government and was standing his ground against presidential orders with the backing of his flock.

Upon the arrival of representatives of the government, consisting of Congressman Porras, and a friend, Senator Ortega, at Tepic, they were met by an infuriated mob of men and children who demanded their withdrawal.

Moody Halts Lottery Operating In Texas

AUSTIN, Mar. 12. (AP)—Insurance concerns that operate by classes of 25 and which permit one member to drop at the death of another in his class with \$1,000, is a lottery and cannot operate in Texas, the Attorney General advised R. L. Dunfield, state insurance commissioner, in an opinion today. One Pennsylvania concern, operating on an Alabama charter, and under a Federal insurance permit in Texas, is affected by the opinion the commissioner said.

Menu for the Family

BY SISTER MARY

Breakfast—Stewed prunes, cereal, thin cream, waffles, sirup, milk, coffee, crisp whole wheat toast.

Luncheon—Sweet potato and nut puff, steamed spinach, graham bread, milk tea.

Dinner—Sliced ham baked with potatoes, head lettuce with Thousand Island dressing, bran rolls, rhubarb, tapioca pudding, milk, coffee.

Children under school age should be served a roasted egg with their spinach for luncheon and not be allowed to partake of the sweet potato dish. The potato and nut dish is so well worth while for a family of adults, however, that the rice follows.

Sweet Potato and Nut Puff

One cup dry bread crumbs, 1/4 cups broken nut meats, 3 cups mashed sweet potatoes, 2 eggs, 4 tablespoons butter, 1 teaspoon salt, 1/2 teaspoon pepper, 4 tablespoons cream. Mix two tablespoons bread crumbs and four tablespoons nuts and reserve for top of dish. Combine mashed potatoes, remaining crumbs and nuts, cream, butter, salt and pepper and beat well. Add yolk of eggs well beaten and fold in whites of eggs beaten until stiff and dry. Turn into a well-buttered baking dish, cover with reserved crumbs and bake 30 minutes in a moderately hot oven. Serve as soon as the dish is well puffed and firm to the touch.

This combination dish is rich in protein and fat and makes an excellent meat substitute.

Myrick Building To Be 4 Stories And Basement

The Myrick Building, on Avenue J between Broadway and 13th Street here is to be finished up four stories in height, modern and fireproof through, according to plans announced late Thursday from the office of Peters and Haynes, architects who are supervising the job.

Work on the concrete skeleton work of the building, which has been finished two stories, but which has been delayed recently on account of the plans for enlarging the structure, will be resumed, and the work will be carried on to completion with all haste possible, the announcement said.

The building has a full basement, and will be equipped with two elevators, one for freight for use of the hardware firm that will occupy the basement, and a portion of the first floor, and a modern passenger elevator. The first floor will be divided into possibly three stores, present plans provide, and the other three will be devoted to offices which according to Mr. Myrick will be arranged to suit the tenant.

The foundation of the building has been laid to accommodate six stories, so that additional room might be added when need arises. W. A. Myrick, well known local capitalist, and his sons own the property.

BOY GUILTY, SAY JURYMEN

WEWOKA, Okla., Mar. 12. (AP)—Erman P. Higdon, 20, is in the Seminole county jail here today awaiting formal sentence to life imprisonment by Judge George C. Crump for the murder of his sweetheart, Rita May Goss, on February 14. A jury in district court brought in a verdict of guilty of first degree murder last night.

Whether defense counsel will ask for a new trial or appeal to the criminal court, is speculative. Higdon was visibly relieved when he heard from the jury that he was not to die in the electric chair, as the prosecution had demanded.

Higdon was charged with slaying his sweetheart two hours before they were to have been married. In a confession made to county officers a few days later he admitted killing the girl after she confided to him that she was expecting to become a mother, but that he was not the father of her child. Defense contention at the trial was that he was temporarily crazed by the revelation and shot her while irresponsible.

SCHOOL BOARDS FACE PROBLEM IN HOUSING

LOCAL ARCHITECTS MAKE PLANS FOR THREE NEW BUILDINGS NEAR HERE

Keeping pace with the demands for housing facilities at various public schools throughout the South Plains apparently is a situation hard to meet, if reports reaching here from several points contemplating building programs are to be accepted as accurate criteria of the matter.

In addition to the \$150,000 program now under way in the Lubbock Independent school district here, providing for the erection of two new ward buildings, Peters and Haynes, local architectural firm are now drafting plans for at least three new buildings on the South Plains.

One of these is a new ward building at Floydada that will cost approximately \$75,000, and will be modern in every respect. Plans on this building are now being rushed to completion, and a meeting of the school board has been called March 29, when bids on the project will be opened. Plans provide for a complete and modern gymnasium in the building.

Ordinell tax payers recently voted a bond issue of \$65,000 for the erection of a new high school building and auditorium. It is the plan of the board there, according to the architects, to put the most of the money into the auditorium, for they believe that this is now the greatest need of the school system.

A home economics department also is called for in the plans, but according to word reaching here from Miss Lillian Peek, Home Economics specialist from the state department of education, an effort will be made to induce the Board to erect a cottage, separate and apart from the main building, for use of the Home Economics department. Miss Peek is to arrive here tomorrow for a conference with the architects in connection with these plans.

Snyder also has a program calling for the expenditure of approximately \$50,000 that will provide for an addition to the present high school building. Plans on this have been completed and are now in the hands of contractors. Bids will be received by the Board on March 23.

Work is proceeding at a rapid clip on the two new buildings here. Work of pouring concrete for the foundation footings on the M. M. Dupree building in the southwest part of the city was started this morning. Excavation for the furnace room and basement has been completed, and brick work will be started within the next few days, just as soon as the concrete will allow.

Excavation work for the Sanders school in the north part of the city is well under way, and the pouring of concrete footings probably will begin in the next few days. The work is being done under supervision of J. R. Waver, local contractor, who was awarded all four contracts affecting the local schools.

WASHINGTON — Congressman Wingo of Arkansas, finding fault a few days ago, with a \$385,000 appropriation to improve the facade of one of the federal government buildings in Manhattan, said some sharp things to Congressman LaGuardia of New York, for having favored the appropriation under discussion.

TRIAL LISTENERS HEAR STORY OF KILLING

CENTER, Texas, Mar. 12. (AP)—Graphic stories of the fatal shooting of Ben F. Smith at Lufkin in September, 1924, were related here Thursday by the first of the eye witnesses, summoned by the defense in the murder trial of Grover C. Dunn, ex-ranger, whose attorneys are trying to prove he shot Smith in self defense.

Tom Mantooth, who said he was across the street at the time of the shooting, testified that when the first shot, called his attention to the scene Smith had his hands at his right side as though attempting to draw a pistol. Under cross-examination Mantooth said he wasn't "clear as to how Smith fell."

John Brantley testified that he ran to the scene immediately after the shooting and that Dunn had cautioned the crowd to stand back, that Smith "might get somebody." He denied that he had heard Smith ask who shot him, as was alleged in yesterday's testimony, or that Dunn had said "stand back, I'm going to shoot him again."

Brantley said that when he saw Smith lying on the ground with Dunn standing over him, Smith appeared to be reaching for a gun. The defense will attempt to establish that Dunn shot Smith after the latter had tried to draw his gun and counter the state testimony that he had not drawn his gun or was even looking toward Dunn when the shooting started.

SANTA FE KEEPS UP DEFENSE

DALLAS, Mar. 12. (AP)—The Santa Fe railroad today continued its defense of the reasonableness of present rates to Galveston in the Texas ports differential rate case.

T. L. Bothwell, assistant general freight agent, testified that the road would propose even lower rates on certain commodities. He said the rate on Texas cotton goods would be reduced 11 cents a hundred pounds, making it 51 cents to Galveston from Texas points, and that on the same commodity the rate to New Orleans would be 73 cents instead of the 83 1/2 cents. The re-adjustment of rates which the Interstate Commerce Commission has suspended under protest from New Orleans, gives New Orleans a better adjustment than they have at present, he testified.

The proposed rates, he said, would give New Orleans equalization from a number of points. The burlap bagging rate from New Orleans to Dallas, for instance, is 40 cents a hundred. The road proposed to reduce it to 45 cents. J. S. Hershey of the Santa Fe said that if the Amarillo oil field develops the petroleum rate from that territory to Texas ports probably would be lowered to the Wichita Falls basis.

MOODY RULES FOR MRS. MEHARG

AUSTIN, Mar. 12. (AP)—The Secretary of State of Texas is not authorized to carry an account for state funds at a bank, the Attorney General ruled in an opinion to Mrs. Emma Grigsby Meharg, secretary of state, today. The opinion was written by Assistant Attorney General George C. Christian, in answer to a letter from the secretary stating that the \$1,500,000 collected during the past year was remitted in personal checks and drafts and that the business of depositing the fees every day and making the reports makes the secretary's account a burden on the banks and the department.

In 1918 the legislature passed an act compelling the state officers to daily report the state funds, and the Attorney General held that the Secretary of State could now report monthly, and that the account is valid.

JARDINE IS SCORED BY DEMOCRAT

WASHINGTON, Mar. 12. (AP)—Secretary Jardine was accused by Representative Kincheloe, Democrat, Kentucky, of "rabbit tracking" on the farm legislation at hearings today before the house agriculture committee.

Rabbit tracking, he explained, was "weaving in and out and leaving doubt as to his exact position."

William Hirth, chairman of an agricultural committee appointed at Des Moines, when the charge was made, was testifying on a bill designed to handle the surplus crop problem through collection of an equalization fee on agricultural products and the setting up of a federal board to deal with the subject.

Asked how Secretary Jardine viewed the proposal, Hirth declared he could not say, although a few days ago he appeared to be against it.

This led to Mr. Kincheloe's remarks, after which Hirth declared the secretary "did say there was such a thing as an agricultural problem and he hoped it would be solved."

Appeal Fails When Man Fights Prison

FORT WORTH, Mar. 12. (AP)—Petition of Harry Jackson for an injunction to restrain the state from issuing a mandate to incarcerate him was dismissed in federal court here today by Judge James C. Wilson for lack of jurisdiction. Jackson was sentenced to serve five years on conviction of assault in connection with the flogging of R. H. Burleson, traveling salesman in Williamson county. Prosecuted by Dan Moody, since Attorney General, then District Attorney, Jackson after conviction appealed to all of the state courts for a reversal but his appeal was denied in each instance.

One He Can't Answer

Ingenuity Of Yankee Consul And American Dollars Saved Fine Port For China During Boxer Rebellion

PEKING, Mar. 12. (AP)—How an American consul, fearing that the partition of China was threatened after the Boxer uprising in 1900, maneuvered to save Amoy, its finest southern port for China, has been told here by Captain "Tom" (T. C. Hutchins, erstwhile naval attaché to Peking.

The intimate story, never before published, discloses that American silver dollars averted a mutiny of Chinese troops, caused the execution of some Chinese officials, effected the evacuation of the Japanese of the island of Kulangsu through a ruse in which the British consul participated and, finally, brought into being the present day international settlement in South China's great harbor.

The account shows the practical nature of America's friendship for China and reveals the resourceful methods employed by an American consul—A. Bullen Johnson—to befriended the ancient empire at a critical time. China out of gratitude offered to make America a gift of the island of Kulangsu but the United States declined. China's gratitude then took the form of degrading Consul Johnson, with the degrading "Double Dragon of the Rising Sun." He now is a member of the California state senate, having retired after nearly twenty years in the consular service.

Captain Hutchins said that in the year of the Boxer uprising, similar disturbances were occurring in Southern China but on a smaller scale. Serious trouble threatened foreign commerce in Amoy. The Japanese, having acquired the island of Formosa, landed a detachment of marines and bluejackets on the mainland. Formal protests were made to the Japanese naval officer that the landing was unnecessary and an infringement of China's rights, but the Japanese stayed on. Thereupon the British and American consuls put their heads together.

Johnson suggested to Rear Admiral Henderson of the British navy and British Consul Mansfield that they land marines on the island adjacent to the Japanese, thus complicating the international problem. Johnson would file a protest similar to that he and the British had made to the Japanese landing, then trust to complications arising which would render it advisable for both to withdraw.

The British landed marines. They hoisted the Union Jack just across the street from the Japanese and dragged field pieces to points of vantage. Then the American consul protested receiving from the British the reply that Japan had made, namely: that the Chinese government had lost control; there was no central government at Peking; it was necessary to protect nationals.

Neither Johnson nor the British believed there was a breakdown of local authority and both thought the Japanese landing was in anticipation of the partition of China. Amoy was the finest harbor in South China, nearest to Manila and hence Johnson's anxiety that this harbor be not alienated.

Peking was in the hands of the Boxers, the legation just emerging from a long siege; the Emperor and Dowager Empress were refugees. Still the American consul protested there was no disorder in the city warranting the presence of either Japanese or British troops.

But the ruse nearly went awry. Chinese troops garriooned there were on the verge of mutiny because their pay was in arrears.

Consul Johnson was popular with Chinese officials. They confided to him that unless they could produce immediately \$40,000 to pay the troops they would mutiny and loot the city. Johnson deliberated; then assured the Chinese officials he would provide the funds if certain peace and order would be maintained.

The following night some Chinese silk stores were looted, but the looters were caught. The officials reported to Johnson these arrests as evidence of the potency of the Chinese government of the region. Johnson directed the matter be kept secret until after the outlaws were executed. He demanded that the execution take place at sunrise next morning.

At sun up troops, prisoners and head men assembled for the execution but at a signal, the soldiers threw down their arms, refusing to proceed unless their arrears of pay were forthcoming. It was feared they would join the looters. The American consul hastened to the scene and pledged the unruly soldiers he would bring their money to the Yamen. The outlaws were beheaded and their heads swung on poles with placards proclaiming the crime and warning others to behave.

Johnson drew on the Secretary of State for \$40,000, which he received in silver dollars. He spent hours dividing the money into sacks of \$100 each and that night supervised its delivery to the Chinese military.

Then he called a consular conference and reiterated that the troops were being maintained. He cited the execution as evidence. The British promptly agreed to investigate and, if warranted, have the British force withdrawn, providing the Japanese marines were. A few weeks later both British and Japanese troops were removed simultaneously. Some months later the Chinese authorities refunded the \$40,000, and made the offer of the island of Kulangsu. The McKinley administration declined to accept it and suggested it be set aside as an international concession under consular control. Kulangsu has since remained an international settlement.

Huge Gathering On Hand For Lettings

AUSTIN, Mar. 11. (AP)—The largest aggregation that ever gathered for a meeting of the state highway committee was here Mon. to attend the lettings of highway surfacing contracts. Contracts for 416 miles on North Texas highways are to be let today and tomorrow. Limestone county asked for the largest amount of state aid,

\$800,000, with which to build hard surfaced roads, running north, south, east and west from Mexico. The estimated cost of the project is \$900,000.

Large delegations from Jefferson and Liberty counties asked that 36 miles of highway be running from Beaumont to Houston, be hard surfaced. Estimate of the cost was not given on the written application.

CHURCH JOINED BY THEATRES FOR A CLEAN TASTE

DETROIT, Mar. 12. (AP)—If the church is at odds with the theatre it has principally itself to blame, believes Jessie Bonstelle, theatre owner, actress and noted American woman producer.

"The drama," she pointed out, "was born in the church. It was employed originally to make more impressive the lessons of the Scriptures. The church became careless of its offspring, and the drama strayed afield. The mother neglected her child! If the child became naughty, it is the fault of the parent."

Miss Bonstelle is an ardent cooperationist between theatre and church. The Bonstelle Playhouse here, a unique enterprise that is the fruition of the life dream of its founder, has been used unparalytically as an agency toward developing a better feeling and a clearer understanding between these institutions.

Lenten services are held each year in the Playhouse. All denominations are represented among the prominent speakers during the Lenten period. There are, too, leading professional men, industrialists and business men, each of whom discusses the Christ topic from the viewpoint of his own special field.

Miss Bonstelle in arranging these services, seeks for her laymen speakers those who have attained success by rising from poverty, believing that the religious lessons by these men will be far more impressive than would the words of men who have never known want or suffering.

"It is not unusual for ministers to state that the Playhouse is doing much to create clean, wholesome appetites among those who attend its offerings," Miss Bonstelle said. "If this is true, it is because ostensibly there is no purpose to moralize; the play is produced for the play's sake. If it has a wholesome influence upon the spectator, it is because whatever lesson it may convey is insinuated rather than preached to him."

"I am no moralist," Miss Bonstelle continued, "and I know the theatre-going public will not stand for preaching plays, or plays that pretend to tell the public how to regulate their lives. The American is not built that way."

HOTEL NOTES NOT YET ALL PAID BLAIR SAYS

Reports current here Friday to the effect that all subscriptions had been paid in to the Lubbock Hotel fund were denied by R. W. Blair, president of the Hotel company, who said that there is yet approximately \$12,000 subscribed by local citizens during the campaign for funds that has not yet been paid.

Work is proceeding steadily on construction of the building, Mr. Blair said, but he reiterated his plea that all delinquent subscriptions must be paid at once, so that there will be no possible chance for a delay in construction work. He explained again that all funds subscribed locally must have been raised and spent in actual construction before the loan secured by the committee after arduous efforts can be closed.

The subscriptions were taken in the form of notes, legal tender, which were signed by applicants for stock in the organization, and legal proceedings will be instituted at once in connection with collection of these notes if they are not paid voluntarily, Mr. Blair said.

The attorney for the Hotel company has been instructed to begin filing of suits seeking collection of the notes, and a last appeal is now being made for voluntary payment.

Work on the building is moving along rapidly. Forms for the concrete on the sixth floor are now just about completed, and the pouring of concrete will begin shortly. Brick work is completed, finishing men will, or rather the beginning of finishing work will start, and all departments of the construction program are functioning with great efficiency.

Contractors hope to complete the building by the latter part of July, and barring delays from inclement weather or late arrival of materials, have promised that this will be accomplished.

A twelve year lease contract for operation of the hotel when completed and accepted by the company, was closed with an operating company headed by W. A. Myrick, Sr., several weeks ago, and every detail in connection with each department of the organization is being given attention of the Hotel company officials. The operating contract calls for an annual rental of \$20,000, and by terms of the agreement, a certain amount has been advanced by Mr. Myrick and associates in connection with the deal, so that original plans in connection with the building might be carried out.

LEOPOLD SCHEPP DIES IN NEW YORK HOME

FAMOUS PHILANTHROPIST ANSWERS CALL OF GRIM REAPER

(By The Associated Press)
NEW YORK, Mar. 12. (AP)—Leopold Schepp, who gave away millions in philanthropies and then appealed in vain to the world for advice on how to give away more for the betterment of humanity, is dead.

The end came last night, after a brief illness at his home on Central Park West. He was in his 85th year. His philanthropies, many of them so quietly carried out that they are unrecorded, reached attention of 7,000,000. It is estimated. At his death he still was active head of his coconut importing firm. Among his philanthropies were \$2,500,000 endowment fund known as the "Leopold Schepp foundation" for the aid of boys, who gave and kept for a number of years a pledge to "live straight," and a similar fund of \$1,000,000 for girls.

The public disappointed him in his appeal for suggestions for giving away "unnecessary surplus" of his fortune. Last year he sought advice from the public, answers came from all parts of the world. None was satisfactory. No more than five percent were anything but appeals for individual assistance. Mr. Schepp was born in New York. When he was ten years old he inherited his capital—18 cents—in palm leaf fans and sold them at a profit of 100 per cent to passengers on horse cars. Soon he had three or four boys working for him, and an income of \$15 or \$20 a week.

CANYON, Mar. 12.—Fred Brooks, formerly of Plainview, Texas, has discovered that life can play queer tricks upon a man.

At the opening of the World War in 1917 Brooks joined the army and spent several months in France with the A. E. F. When the armistice came he and a few companions were all that were left of his battalion. In 1919 he was discharged and in 1921 he again enlisted in the army; this time for a short period of service.

In 1922 he received an honorable discharge in California. He lost his discharge papers but was not greatly worried about the matter and returned to his home in Plainview. A few months later he was arrested as a deserter. In spite of his explanations he was taken to Fort Reno, Oklahoma, and later to Fort Sill where he was held in a guard house to await court-martial.

Because he protested his innocence and declared that his discharge papers had been lost his finger prints were sent to Washington, D. C., where it was found that they did not correspond to the finger prints of the man who had disappeared. It then developed that his lost discharge papers had been found and another man had been using his discharge papers and name.

Brooks was released at Fort Sill the real deserter was found, tried, served part of his sentence and again escaped. A second time officers came to Plainview to arrest Brooks, but this time with the aid of local officers and the record showing what had happened to him in Oklahoma he was able to convince the officers that he was not the man they were seeking.

The real deserter who escaped from prison has never been located. Brooks is now farming near Canyon and declares that he is through with the army if the army will only let him alone.

Action Deferred On Muscle Shoal Lease

WASHINGTON, Mar. 12. (P)—Final congressional action on the resolution for the leasing of Muscle Shoals was deferred today at the request of Senator McKellar, Democrat, Tennessee.

"Rum Sold In Capitol"—Bleese

WASHINGTON, Mar. 12.—Liquor is sold daily "under the very dome of the capitol," Senator Bleese, Democrat, South Carolina, who makes that charge, is willing to prove it to any doubting Thomas by buying him a drink in the halls of congress.

"Prohibition is a joke," he told the Washington's policemen's association last night, adding that it would remain so until the men who voted for prohibition stop drinking liquor. "The trouble with congress," he continued, "is that they vote dry and drink wet." Bootleggers, he said, sell their wares "every day in the house and senate rooms," and they come around to him daily and ask "how much do you need today?"

Wheeler Raps Poll

About the same time Senator Bleese was addressing the policemen, Wayne B. Wheeler, general counsel for the anti-saloon league, was delivering the organization's second attack in a few hours on the polls being taken by many newspapers on the subject total prohibition as against beer and light wine. He told a radio audience that straw ballots "are as useless as a straw hat in a blizzard."

Minority Is Heard

Only a minority of the people wants beer and wine, he said, while the majority has spoken its mind on that proposition repeatedly "not in straw votes, but in official ballots and that majority has rejected the wine and beer plea."

Senator Bleese declared it was a shame for policemen to brag about how many arrests for drunkenness had been made adding that when he was a mayor he had ordered his officers to escort drunken men to their homes. He remarked that he knew of one case where a judge sentenced for being "drunk when the judge himself 'had liquor on his breath.'"

School Inspector Is Visitor In Dawson

Mrs. Paul Gooch and her able assistant, Mrs. Lawrence West, have worked up sufficient interest among the rural teachers that the annual is assured. It is being financed by donations and advertising. It will be known, says Mrs. Gooch by the name "Coyote" and Mrs. West is supervising the work and says that all material will soon be ready for the press.

Drop Reservations For U. S. Plebiscite

WASHINGTON, Mar. 12. (P)—Traveling reservations for Assistant Solicitor Vallence of the State Department, and other members of the American group, selected to assist Major General Lassiter in the conduct of the Tacna-Arica plebiscite, were cancelled today.

No explanation for the cancellation was forthcoming. Vallence, with assistant counsel, the finger print experts and fifteen other had booked passage of a Chilean ship departing from New York tomorrow. The incident is regarded as possibly significant in view of his efforts Peru's effort to have the registration for the plebiscite, scheduled to begin Monday, postponed.

April Fool Frolic To Begin at 7:27 April 1

Promptly at 7:27 p. m., the evening of April 1, the first annual April Fool frolic of the Tech College faculty with interested citizens of Lubbock will swing into action, it was announced here Friday by F. Only about 14,000 volumes are in the Cleburne library, but the care with which these volumes were selected enables the library to render a more efficient service than many libraries with a larger number of volumes. Miss Octavia Rogan, state librarian, said.

CHINESE FIRE ON A JAP WARSHIP

PEKING, Mar. 12. (P)—While two Japanese destroyers were proceeding up the Pei river below Tientsin today, they were fired upon from the forts near the mouth of the river held by troops of the Kuomintang (nationalist). Machine guns and field batteries were used in the bombardment. One Japanese officer and two men were wounded.

The Japanese decided to abandon the attempt to move up the river and the destroyers returned to Tangnu near the mouth of the river, where two other Japanese destroyers are lying.

It is not clear whether the Japanese returned the fire of the forts. The Japanese consul general at Tientsin has lodged a strong protest with the Kuomintang leaders.

Chicken House of Mr. Dickinson Burns

Fire which broke out in the chicken house of Morgan Dickinson on the east edge of the canyon near here about 10 o'clock Friday morning, practically destroyed the house and about 25 baby chicks. The flames are believed to have originated from an oil stove that was being used in heating the house.

Quick response on the part of the Lubbock fire department with the chemical trucks prevented the blaze from spreading to the garage nearby, but the chicken house was virtually wrecked when the department arrived on the scene, about two miles from the station.

ST. LOUIS, Mar. 12. (P)—Mrs. Lucy C. Dragon, 44, past national president of the Spanish American War Veterans' Auxiliary, and founder and first president of the Missouri state auxiliary, died here last night.

\$50,000 Fire Guts 4 Ozona Buildings

SAN ANGELO, Mar. 12. (P)—Fire estimated to have done \$50,000 damage early this morning gutted the large stone building housing four business establishments at Ozona, Crockett county seat.

Joe Oberkamp's furniture and hardware store in the chief loser. The Ozona postoffice, the Red confectionery and the Ozona meat market were the other firms losing by the fire, while other stores in the same block suffered heavy damage in the removal of their stocks.

Effective use of about 200 feet of fire hose saved the remainder of the buildings in the block. Cause of the fire has not been determined.

It also advised Porto Rican officers to resign and call a constitutional convention for the purpose of organizing a republic.

"The Yankees believe themselves the superior of all races; the Yankees must go," said the handbill.
