Welch Developing Into Trading Center

Welch, until recently known to the people of Dawson county as "Shacktown," has developed into a thriving trade center in the last 12 months. Welch is located 23 miles northwest of Lamesa on the Brownfield road. Post offices have been discontinued at Pride and Lou and Welch designated for this honor in February of this year.

It was revealed to a Courier representative in conversation with a prominent business man of Welch that most every line of business was represented in their city. Those engaging in the grocery business are: Browning and Guye; Glen Dickenson Red and White dealer; and Mark Aslin. Gale Brington has hardware, Frank Meurs, postmaster and dry goods, Jim Holden, garages, and B. J. Jones, blacksmith shop. Street man, welding, Joe Brooks, filling station. J. T. Browning who is known over the county as "the Father of Welch," operates a lumber business and a Mr. Kelly a barber shop.

At the present there is only one church building in Welch, the Methodist, the other denominations also using this building. Plans are being considered for the construction of a first class school plant. W. L. Marr of Lamesa having donated a five acre tract of land for this purpose. Several new buildings are now under construction and plans for a light plant in the near future are underway. The Courier representative was informed that about all that the town needed was a drug store and a bank and if they continue as they have in the past it won't be too long before these enterprising citizens will have them.

More than 330 bales of cotton were ginned in Welch the past season, and a good feed crop was harvested. And this present prospects are very good for 1934. Farmers are all busy and a feeling that the depression is a thing of the past is the opinion of the majority of the citizens of the Welch section.

Tornadoes Lose To Athens In Final Game 22 To 28

March 17 Last Day In Texas For Corn-Hog Contracts

College Station.—Indicating that the corn-hog campaign is drawing on toward its close E. M. Regenbrecht, Extension swine specialist, has announced that March 17 has been set for the last sign-up day in Texas. Farmers who are desirous of contracting to reduce their production of corn and hogs will be well advised to get into the county agent's office before Saturday where possible. Mr. Regenbrecht states, because the rush on the last day is always great.

A ruling of interest to farmers who are now making their planting plans, Mr. Regenbrecht said, is the interpretation of paragraph 3, section (c) of the contract. This is to the effect that in cases where the crop rotation system of the producer makes it desirable for him to increase the acreage of feed crops such as oats, barley, but he is prevented from doing so under the terms of paragraph 3 section (c) of the contract, because an insufficient number of acres was planted to feed crops during either 1932 or 1933, the producer may increase the acreage of feed crops by decreasing the number of acres of corn by an equivalent number of acres below the 1934 maximum corn acreage for the land under contract. For example, if the total number of acres of feed crops was 60 in 1932 and 50 acres in 1933 the producer under the terms of paragraph 3 could not plant more than 60 acres of feed crops in 1934. He may, however, wish to plant 70 acres of feed crops in 1934. If the producer had a 1932-33 average corn acreage of 100 acres and is reducing by 20 per cent, he would be permitted to plant 80 acres of corn. However, if under this interpretation he wished to plant 70 acres of feed crops in 1934, he could do so, provided he planted only 70 acres of corn instead of 80.

The official interpretation of paragraph 3, section (c) of the contract is also of great interest, Mr. Regenbrecht said. It is that acres planted to feed crops in 1932 and 1933 that were not harvested because of the destruction of the crop by insects, flood, disease, or other Act of God, may be counted as if actually harvested, provided no other crop was planted on such land to be harvested the same year.

Lamesa Wins Second In State Tournament

Lamesa did herself proud with second honors in the State Interscholastic league school boys tournament at Austin last week end. All hats are off to Coach Gregg and his fine boys. They failed to capture first honors but they are rated by all circles in Texas as one of the best basketball teams in the state and it is believed that the team is one of the best of High School Basketball groups in the United States. That the Tornadoes could take at least half of the series of games with the winner of any tournament.

Lamesa easily took the first game with Harlingen by a score of 51-6, also captured the game with Thomas Jefferson of San Antonio by a score of 32-22, while they lost the final game to Athens by the narrow score of 28-22. Thomas Jefferson won the game with Denton by a score of 35-15. Denton had previously held the Athens Hornets to a 12-17 score in a semi-final game.

It was a great tournament with eight of the best teams in the state meeting in the Gregory Gymnasium at the State University in Austin.

Electric Co. Warns Against Kite Flying

The danger of flying kites in the vicinity of electric wires was explained today by officials of the Texas Electric Service Company, who are appealing to parents to warn youthful kite-flyers to keep away from the wires.

"Several fatal accidents already have occurred this spring as a result of boys flying kites too near electric wires," reports C. E. Cameron, manager of the electric company, "and we want to impress on parents and children of the dangers of letting kites and kite strings come in contact with wires. Above all, children should be cautioned never to use metal wire in the place of string when flying kites, for if the wire should fall across an electric line, the current would flash to the person holding it."

"Whenever kites become entangled in electric wires, don't climb poles or use long sticks to remove it. Call the company and a lineman will be sent to get it down, if possible. Another wise precaution is not to fly kites during a rain, as a wet string is almost as dangerous as a wire should it come in contact with an electric line. Kites with metal frames or wood frames braced with wire, should not be used."

"Employees of the company will visit local schools within the next few days and make a further explanation of the dangers of flying kites near electric wires."

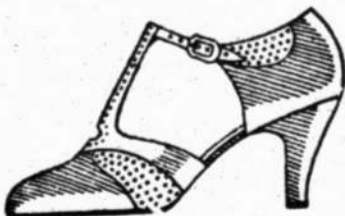

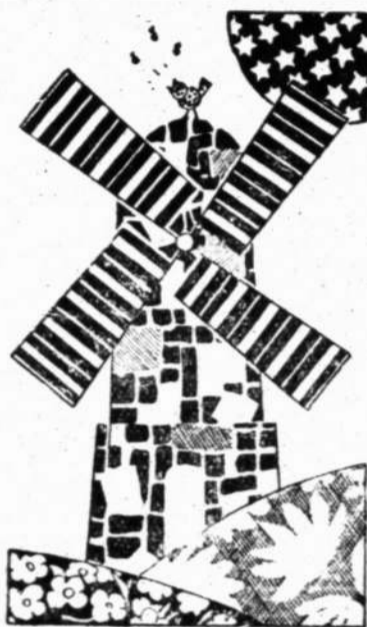

And it was Olin Cobb, Athens great forward, and Hayden Mallory, one of the most fighting guards you ever laid your peepers on, that snatched victory out of the jaws of defeat for Athens.

Mallory, playing spectacular and brilliant basketball began the drive that turned the tide of battle. As though inspired by Mallory's great performance, Cobb, who had played mediocre basketball in the first half came into his own. Gordon Johns and Mallory played perfectly on defense particularly during the second half.
Jude Smith all-state guard if there ever was one, led the Tornadoses on the attack with 10 points. J. B. Greiner followed with five points, while Jimmie Britt and George Sturdivant garnered three points each. Sturdivant gained a great majority of the hits at center and played a great defensive game. N. J. Costin and Smith guards were other defensive aces.

Really Tornadoses
The contest opened with the Tornadoses living up to their name in every respect. They swooped down on the champion Hornets just like a West Texas Tornado. And when the debris of the first quarter had been piled aside, believe it or not Lamesa was leading 9 to 0. The Hornets stunned by the terrific onslaught had failed to register a single point.
Smith led off for the Tornadoses by making good three free shots to give his team a 3-0 lead. Sturdivant and Britt followed in quick succession with beautiful field goals and Greiner sank a gratis shot and field goal to make the count Lamesa 9, Athens 0 at the end of the first quarter.

Frizzell Counts
Frizzell counted the first two points for Athens at the start of the second quarter, but Smith of Lamesa retorted with a field goal. Cobb of Athens and then Smith of Lamesa counted field goals, and then Hayden Mallory broke loose with a scoring spree that was destined to turn the tide of battle when he scored 3 points in succession. But despite the Hornet's rally, Lamesa led at the half 13-7.
Mallory continued his scoring rampage at the start of the second half with a beautiful field goal. After Costin had followed with one for Lamesa Cobb and Mallory broke loose to count three field goals. It was apparent that the Lamesa defense was crumbling. 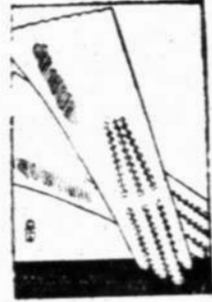

Mrs. J. F. Gross of City Views Home Demonstration Club in Wichita county can for her own family and for her doctor's family. He is a skilled physician, she is a skilled canner. They exchange work.

San Rubenstein is a Washington county farmer who never knew what terracing was until he was induced by a neighbor to let the county agent help him terrace one of his farms in 1933. No who has his entire tract of 400 acres terraced.

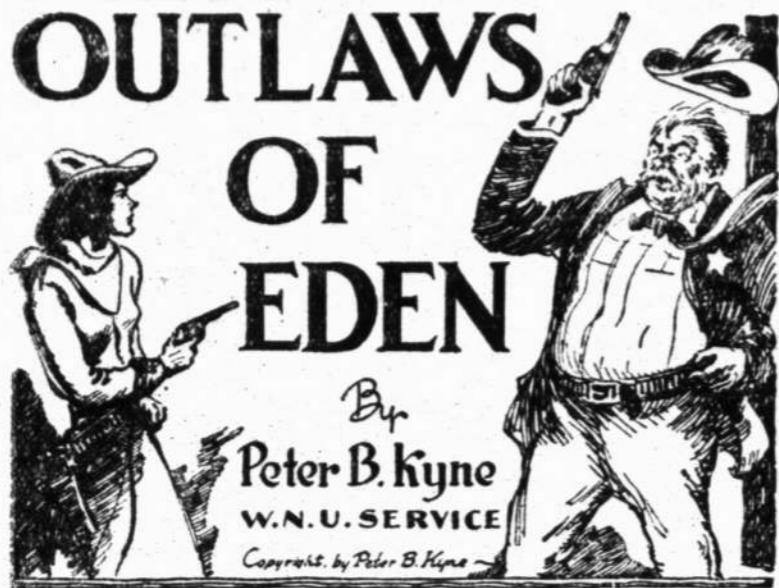

CHAPTER IV

When Nate was busy staking a jagged claim in Eden Valley, Forlorn Valley had not been overlooked by the land-grabbers. By 1880 practically every acre had been homesteaded; the district developed into a dry farming section and later into "mixed" farming.

Gold Run was the county seat, and in the heart of Forlorn Valley a settlement known as Valley Center had gradually developed into a village of about five hundred inhabitants. Orchards were planted; the raising of hogs and cattle for beef and dairying increased; an adventurer from nowhere appeared and laid out a subdivision of the "thriving city" of Valley Center. A former Middle West bank clerk, Silas Babson, who had inherited an

lown farm from his parents and sold it for seventy-five thousand dollars, came to Valley Center and started a state bank. The Bank of Valley Center was successful from the start.

Babson was a son of the soil; thirty, shrewd, rapacious, competent. From banking he reached out and interested himself in such local enterprises as creameries, a lumber yard, the largest local garage with the agency for a popular cheap automobile and pumps; he sold insurance of all kinds.

Only once had Babson lost his perspective on values and that was during the World War, and for this it would seem he was not to be blamed, since all his fellow countrymen lost theirs simultaneously. The rapid advance in the price of farm commodities had brought the usual boom of prosperity to Forlorn Valley. Ford To Have Exhibit At World's Fair

The general contract for erection of the Ford Exposition building at the Chicago World Fair has been awarded to the W. E. O'Neil Construction Company of Chicago. It was announced this week by Mr. C. O'Neil, manager of the Dallas branch of the Ford-Motor Company.

Construction work, which has already begun, is to be completed before June 1.

Fourteen hundred tons of steel will be used in the building, which will be 900 feet long and rise to 110 feet at its highest point in the huge central tower.

Specifications call for 700 square feet of fire-resistant wall board, 1,600,000 feet of lumber, 5,000 yards of concrete and 160,000 square feet of tile flooring. The entire space reserved for industrial exhibits will be skylighted.

Large quantities of chromium metal work will be used in both the interior and exterior embellishment, in line with the conservatively modernistic motif of the architecture.

The Ford building, which is to be one of the largest at the 1934 A Century of Progress will be situated on an 11-acre tract with a frontage of 1100 feet on Lake Michigan. A five-acre park on the lake shore is a part of the general project, though this was not included in this week's contract.

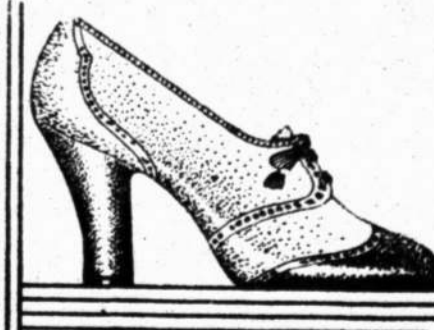
