

Truck Regulations Not Enforced--Neff

SECOND LAP IS BEFORE SOLONS

AUSTIN, Feb. 14. (AP)—The legislature this week entered the second lap of its four months grind with about 1,000 bills already introduced. However, many of these bills were duplications, the same bill being introduced in both houses.

Several legislators felt that any bills offered after last Wednesday might be unconstitutional if enacted into law. The strength of that feeling was shown in the rush of legislators to send up bills or the matter.

For the next four weeks, the public will have its turn. Public hearings on most of the important proposed legislation will be conducted during that time by the various committees.

The house committee on highways and motor traffic this week voted to return an unfavorable report on the bill by Representative Cox of Groesbeck to make the highway commission elective instead of appointive.

The move to allow defendants pleading guilty in less than capital cases to waive the right of trial by jury struck a temporary snag in the senate but a slight majority was returned for it in the only test vote.

Much of the time of the house this week was spent in arguing the bill which would allow less than unanimous verdicts in civil cases in district court. The bill was considerably amended and was announced as "dead" but a check showed that the amendment to strike out the enacting clause had failed instead of passed.

The largest hearing so far this session was held Thursday night on the so-called race track bill. Participants were here from all over the state to oppose the bill and its supporters defended it as a proposal which would help the agricultural and livestock industries.

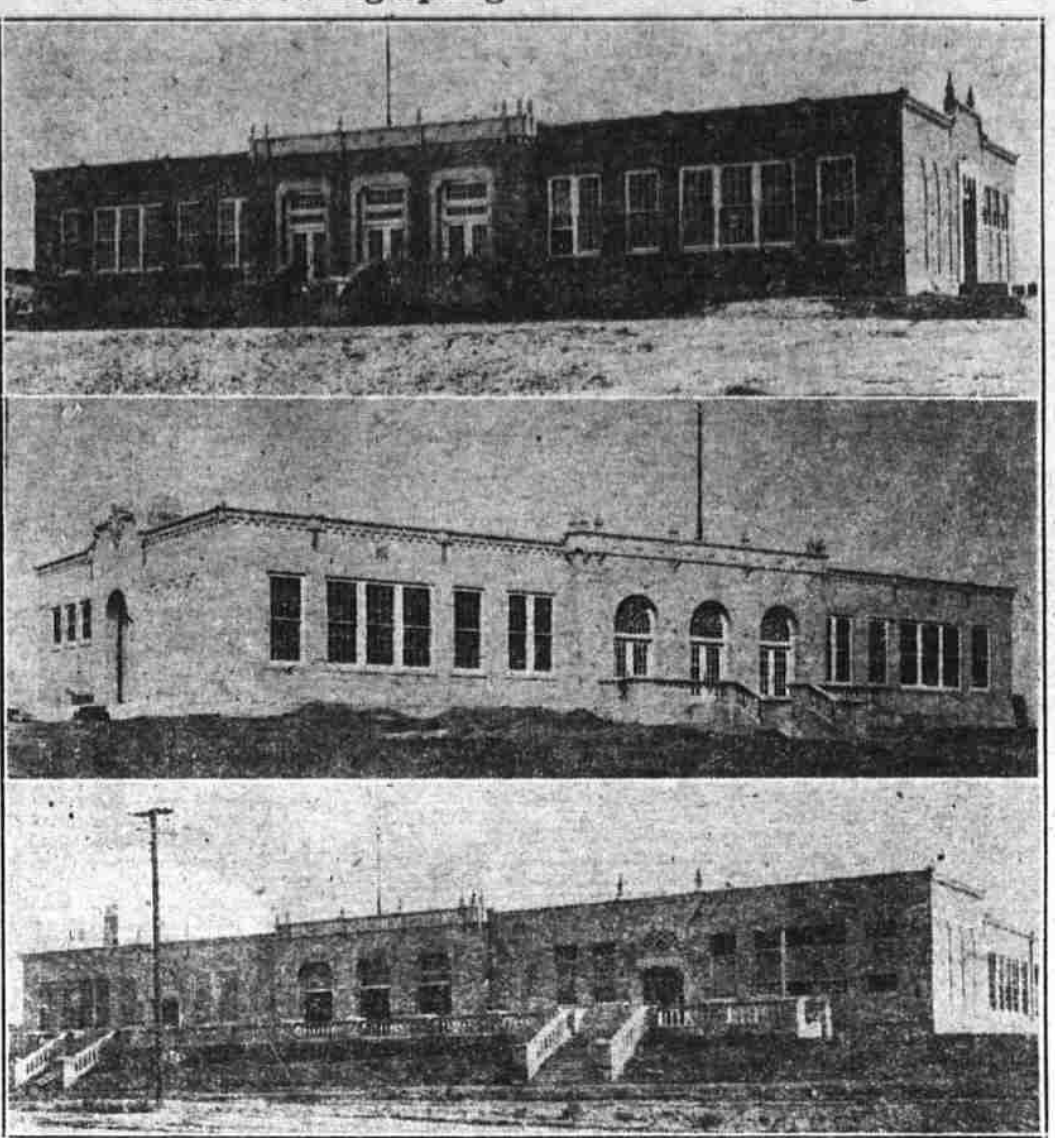

TEXANS ADDRESS WAYS AND MEANS COMMITTEE IN CAPITOL

WASHINGTON, Feb. 14. (AP)—The proposed congressional investigation of the oil industry took more definite shape today. Independent producers pressed upon the ways and means committee their demands for a limitation on petroleum products.

Democratic leader Garner threw his influence squarely behind the Hoch resolution now before the House rules committee and Republican leader Tilson said such a study for purposes of framing permanent legislation "might be a good thing."

Representative Garber, Republican, Oklahoma, co-author of the bill to fix imports for the next three years at 16,000,000 barrels annually, on which the committee is taking testimony, said the independent producers were united in support of an investigation.

Penn Heard

Robert Penn, vice president of the American Petroleum Institute, said his organization would be glad to assist in such an investigation. Because of widespread opinion among members of the institute on import limitations, Penn said, no collective position has been taken.

Teachers Named, Boundaries For Districts Made

THREE OF THE FINEST WARD SCHOOL BUILDINGS IN THIS SECTION OF TEXAS WILL BE OPENED FOR SCHOOL WORK MONDAY MORNING, FEBRUARY 23.

W. C. Blankenship, city superintendent of schools, said last night that the new buildings, which will be opened for school work Monday morning, February 23, were built from proceeds of a bond issue of \$125,000 voted here last spring.

The old Central ward building on Scurry street, a landmark and a structure in which hundreds of parents living here attended elementary school, will be closed on opening of the new buildings.

Scholastic population has jumped from 1,353 in 1926 to 2,446 in 1930 and actual enrollment from 1,298 to estimated 3,500 this session. However, per pupil cost of teaching has decreased within the same period from \$32.70 to \$27.14.

Here Overnight, Former Secretary of State COLLEAGUES OBJECTS OF RAP

'People's Genius and Energy, Not Magic Legislation To Revive Nation's Business' Is Just A Neighbor With Big Spring Citizens

Frank B. Kellogg, hale and hearty at 74, who began one of the most illustrious careers of American statesmen with his own hard work in boyhood and literally lifted himself by his own bootstraps, sat last evening in his suite in the Settles hotel and talked in neighborly fashion with a group of Big Spring men.

Enroute to Pasadena, California, for a vacation, accompanied by Mrs. Kellogg and Guy Chase, one of his law partners who has been intimate with him since 1907 when as a law student he was Mr. Kellogg's private secretary, Mr. Kellogg stopped overnight.

"What is the chance, do you think, of getting an oil tariff from congress?" asked one of his visitors.

With an expressive shrug of his shoulders the man who was for years one of the senate's most influential members smiled and said that he had not been in Washington but once in months.

For only in late December did he return from Stockholm, Sweden, where the honor which he prizes more than the many conferred upon him—Nobel Peace Prize—was awarded.

Nobel Prize Reasons for his being designated recipient of the Nobel Prize lay in his achievements while ambassador

to England and secretary of state under President Coolidge.

His success in steering to success with innate diplomacy the conference of world powers that ended with signing or promises to adhere to the Paris Peace Pact by fifteen nations was perhaps the greatest "feather in his cap" as an outstanding leader in the United States' efforts to promote continued peace.

Aside from leadership in disarmament conferences he, as secretary of state, freed China from numerous burdensome treaties and settled trouble between Chile and Peru that had flamed for two generations.

As To Business And this is what Mr. Kellogg said about conditions in business and industry throughout the world:

"In Europe they are crying hard times just as in our own country. I recall so-called panics in 1893, 1898 and 1907—and history leads me to believe the genius and energy of the American people rather than magic legislation will overcome conditions."

This is his first trip across West Texas, and he indicated his route to a vacation site in California was through the section because he wished to see it very much.

With his generous smile he waxed a bit enthusiastic in telling his callers "it's a great country."

Upon arriving yesterday afternoon Mr. Kellogg asked whether there was a golf course nearby—he certainly doesn't like to miss his golf. But he decided he had not the time to make ready for a round before nightfall. Dr. E. O. Ellington's first question to him was

Controversy In Brotherhood Is Indicated Here

Existing conditions in railroad business of southwestern lines has caused what some members of the Brotherhood of Railway Conductors of the Rio Grande division of the Texas & Pacific declare is almost total lack of employment upon 20 members of the local lodge. Prospect of a controversy increasing within the brotherhood was seen here last week.

The statement was backed by some trainmen with a copy of the mileage record for January of eighteen regular crews of the division. Regulations existing for trainmen stipulate the working day as eight hours or 100 miles.

The agreement between the brotherhood and the railroad calls for 3,000 miles per month during dull seasons, for the purpose of distributing work among the men. W. R. Perry, a former member of the O. R. C. and now of the B. of R. T., a T. & P. conductor, said:

"The January record, he pointed out, showed average mileage for the month of 4,888 miles or 48 1/2 days for each of the eighteen regular crews."

Men who have been cut off for two or three months have exhausted every possible means of having more crews put on, said Perry.

Regular conductors, said Perry, now are insisting on 4,000 miles per month during the dull season; rather than the 3,500 miles now included in the agreement between the brotherhood and the railroad company.

Engineers and firemen, Perry said, have voluntarily restricted their mileage as low as 3,200 miles per month and a movement is on foot to voluntarily enter further restrictions for the purpose of distributing work.

City To Operate Street Light At \$4,000 Year Less

Saving of \$4,000 per year in purchase of electric current for street lights has been obtained by terms of a contract just signed by the city commissioners and the Texas Electric Service Company. City Manager Smith said Saturday following completion of negotiations between himself and the power company manager here.

The former basis of charges was \$2 per month for 100 candlepower lights, \$4 per month for 250-candlepower ones and \$5.50 per month for 400-candlepower lights.

The rate is charged in the new contract is based on readings from a single meter for all lights.

The city also plans to install seventy-five 100-candlepower lights or their equivalent.

COLLEAGUES OBJECTS OF RAP

AUSTIN, Texas, Feb. 14. (AP)—Pat M. Neff, railroad commissioner today charged that truck operators could drive trucks "forty feet wide and one hundred feet high" over the highways of Texas, all because the railroad commission was not discharging its duty under the law.

"Hundreds and hundreds of these permits have been issued by the railroad commission, and the majority of the commission is still issuing more than an average of two a day," Neff said.

Neff said he had not signed any of the B permits issued by the railroad since last September. He said the motor transportation law provided that the amount and character of tonnage to be hauled, the territory in which the trucks were to be operated and the nature and character of the equipment should be given before permits were granted.

Urged Commission

"In the light of these statutory provisions, early last summer, I urged the commission to follow the mandates of the law in the granting of these truck permits. Not seeing successful in my contention before the commission, I advised the other two members of the commission on October 1st of last year that I would not sign any other permits until the commission carried out the provisions of the law by defining in each permit the nature and character of the equipment to be used, the amount and character of tonnage to be hauled, as well as setting forth 'substantially the territory to be covered,' Neff said.

"On account of the unrestrained and unlimited granting of these permits, not only by the hundreds, but by the thousands, the roads of Texas have been cluttered by these trucks, the highways have been used and are ruthlessly destroyed and the traveling public has been crowded into the ditch at the risk of life and limb," Neff said in conclusion.

C. V. Terrell, who recently succeeded Neff as chairman of the railroad commission, declined to comment on Neff's statement. Terrell indicated he would discuss the statement with Commissioner Lon A. Smith and Mark Marshall, chief of the motor transportation division, early next week and would state his position after the conference.

Commissioner Smith and Marshall will not be in Austin until next week.

THE FIRST AID KIT

In every office, shop, factory and home, it is a wise precaution to have a first aid kit.

In industrial establishments there should be a responsible person who knows how properly to apply first aid measures.

The first aid kit should be used exclusively for first aid and should not be borrowed from for any common purposes. Its various elements should be replaced as used up.

The national affiliated safety organizations list the following as the standard units of the first aid kit:

one tourniquet for use in stopping serious hemorrhages; a pair of scissors; a pair of tweezers for removal of foreign bodies; one triangular sling for a variety of uses explained in every popular volume of first aid instructions; 12 assorted safety pins; one teaspoon; one metal cup; one medicine glass with indications on it showing various medicinal measures; two medicine droppers; three paper drinking cups.

In addition, the kit should contain the following medicines: one two-ounce bottle of castor oil, one three-ounce tube of burn ointment, one two-ounce bottle of 3 per cent tincture of iodine, one two-ounce bottle of 4 per cent solution of boric acid, one two-ounce bottle of aromatic spirits of ammonia, one two-ounce bottle of Jamaica ginger.

Bandaging material should include a piece of flannel 24x36 inches, a roll of absorbent cotton, 10 yards of three-inch gauze bandage, five yards one-inch adhesive tape and several packages of sterile sterile gauze measuring approximately 3x36 inches.

In addition, when the first aid kit is for office or factory use, there should also be available a wire gauze splint, for use in case of fractures, and first aid record cards.

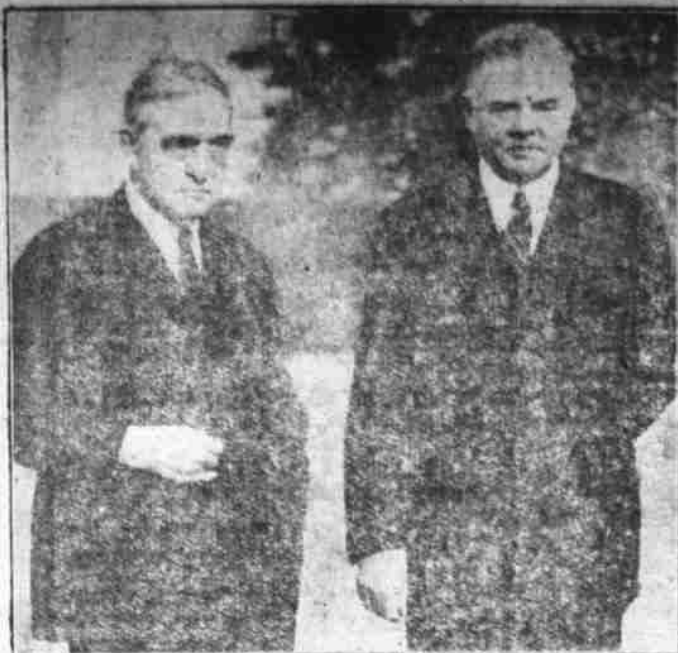

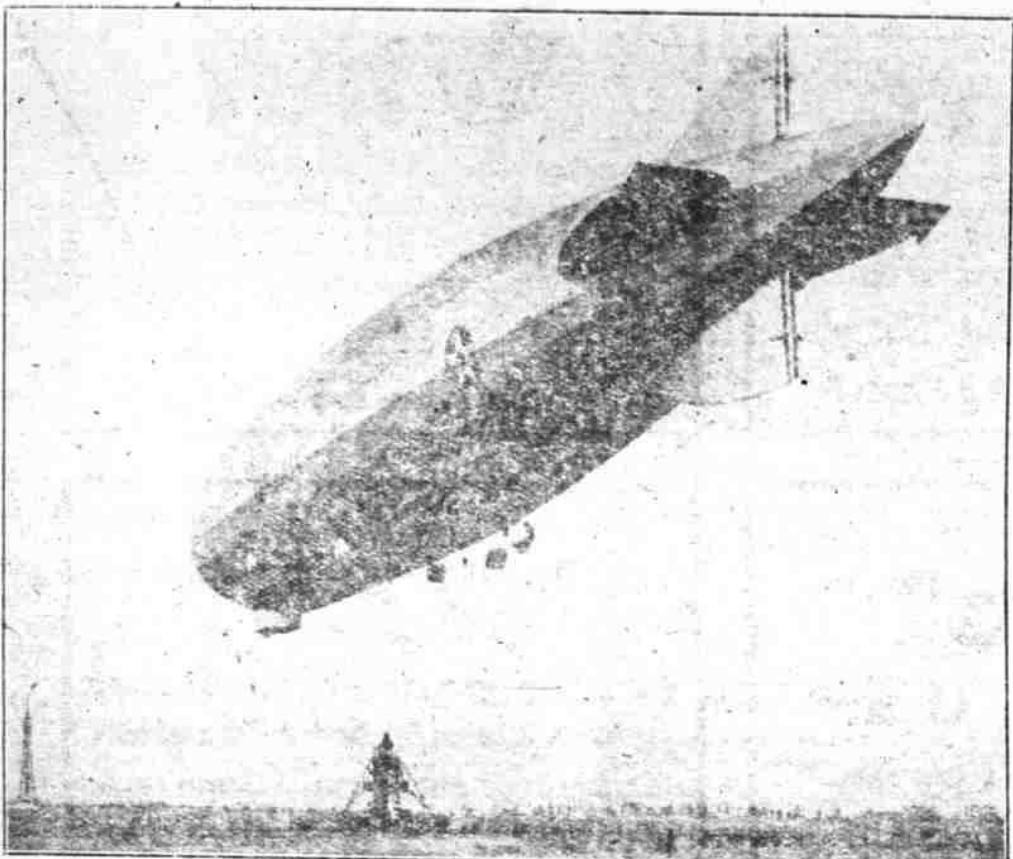

To The Editor:
Reece Adams' views concerning
the \$900,000 road bond issue.

I am like practically every man
in Howard county. We all like good
roads. We would also like to have
a nice home, a nice car and plenty
of money to pay the bills but we
don't have it.

And I think it is bad business to
get up and vote a \$900,000 road bond
issue on us. One-half to one-fourth
of the farmers had to borrow money
to pay their taxes, and some
have gone unpaid, and a big per-
cent of the farmers have been un-
able to make arrangements to get
money to live on and everything
we have to sell is practically worth-
less and no prospects of conditions
getting better soon. About 90 per
cent of the farmers own our homes
and to vote a \$900,000 road bond
on top of what we already have I
say these big bonds they are want-
ing to pile on us if carried are go-
ing to cause many men to lose their
homes, which their wives and chil-
dren have had to toil and sweat
for the past 25 years.

Our Big Spring Daily Herald
speaks about the prejudices that ex-
ist between some town men and
some country men. I want to make
this statement and I believe most
country men will bear me out in
it. We want to patronize Big Spring
and we want to see her make one
of the best and cleanest cities in the
state and we want the town peo-
ple to do the right thing and give
us a square deal. We don't want
to send our money off to mail or-
der houses and to other towns. But
when it is a bread and meat propo-
sition we have to do the best we
can. Who will pay the \$900,000 road
bond issue? The farmer and the
laboring man are the ones who are
paying it.

Who will use the highway mostly?
The rich, idle, the speculator and
this bunch of high-collared city
ducks that have been pushing the
bond issue. I can't see why the mer-
chants and business men of the
town want to vote a \$900,000 bond
issue when I heard them say the
country was the back bone of the
town and they know there isn't
anything any good with its back
bone broken. The bankers—they
know the condition we are in. They
are having to turn down farmers
and some of them still want to
vote more taxes on us. Why do
we want to vote bonds to build a
better road for \$4,000 to \$8,000 per
mile. If it isn't graft I would like
to know what to call it. If Judge
Ely had \$1,400,000 to build highways
in Howard county as he stated in
his speech why don't he spend
\$600,000 or \$800,000 of it and build
us some good highways and donate
the rest to starving humanity and
leave the bond issue off?

Why do they want to charge the
present location of the highway?
They are already located where they
will accommodate the people meet-
ing that is paying for them. That high-
collared bunch is not to be trusted. They
want to run it diagonally across
our farms and ruin them. One man
in his great eloquent speech for the
road bonds where the highway runs
diagonally across a man's farm it
would enhance the value of his
land several times. I would make it
\$75 to \$100 per acre. I think
that he ought to be a lay preacher
and get him a good mouth wash and
wash out his mouth good and go
out and apologize for making such
a statement. If a man goes out and
buys a farm and pays four or five
times the worth of it you would
call him a fool and I can't see
why the same thing wouldn't apply
to a highway. I think we should be
careful about voting the bonds. The
tax valuation of our county is
around \$7,000,000 and the oil indus-
try is \$11,000,000 and in a few years
when it plays out as it has in other
places and we vote the bonds on
us we are going to be three or
four times as high as they are
at present and if we can't pay our
taxes now what can we expect to
do then? I say when we are vot-
ing these bonds we are robbing our
children out of what they have help-
ed us work and pay for. If they
want highways they should build them
from a gas tax as Mr. Sterling
stated in his speech. We can't de-
pend on being reimbursed for the
bonds for they have never reim-
bursed us for the sterilization of our
cotton. I think we should go to the
polls and vote down this bond issue
altogether for our sake but for
the sake of the rising generation.

An Old Man Reminisces
When Mr. Newmark wrote these memoirs, which are all they are, he was an old man who enjoyed sitting back and reminiscing. One story was as good as another, whether it was about the tangle of early days or the visit of Albert Sidney Johnston or the doings of Don Pio Pico. He consulted his old files of newspapers for which he had a great respect and whenever his memory and they failed him, he sought out his many friends and out of the miscellaneous data he has made a book of some 700 pages.

The book, however, is powerful just because of the amount of detail it contains, the details that go to make up the panorama of life itself. And, say what one may, the panorama of life is always powerful whether we feel it agreeably or disagreeably.

When one has finished the book one has lived through the sixty years in Southern California that covered the span of Harris Newmark. One has seen the powerful Spanish dons with their enormous estates and outmoded codes of honor or give way to the shrewder, more far-sighted American business man.

Rise of a Community
It is an interesting commentary on the rise of a community. First there were the Spaniards with their large grants. These were mortgaged for one cause and then another, sometimes to maintain an expensive style of living, sometimes to provide for children who had no thought except for their own comfort, sometimes for the aid of friends. To the Spaniard there could come no change, this was plain in the midst of change; believing regardless of what came today, tomorrow must return to the customs of yesterday. It was perhaps inevitable that the Spaniard should lose all they had.

After the Spaniard, came the early settlers whose tracts of land especially in the city, became more valuable as the years went on. Most of them with fortunes in their possession for which they had done little to acquire lost everything through one or another unwise form of business speculation.

Up and down the sea-saw of fortune went. And throughout the pages adding the single note of unity was Mr. Hallmark, looking on, expressing commiseration and pity for those whose turns brought them low, and praise for those who were high.

I was fooled, because the infinite details of the life of Los Angeles do not interest me—but the book was worth reading.

Truck Regulation Bill Introduced By Senator Loy

AUSTIN, Feb. 14.—Senator Loy of Sherman, in introducing a bill calling for further regulation of buses and trucks operating over state highways, said he had made a drastic departure from present truck and bus regulatory measures.

The Loy bill proposed to cut the width of such vehicles from 96 inches as allowed under present statutes, to 84 inches. The length of a single commercial vehicle would be fixed at 30 feet. For coupled vehicles, the maximum length would be 45 feet.

The bill would prohibit transportation of combination of property and passengers.

Drivers of commercial vehicles would not be allowed to operate a vehicle longer than 16 continuous hours.

The maximum tonnage for such vehicles would be fixed at 5,000 pounds.

The bill provided that the highway commission require motor carriers to keep a set of accounts and make monthly reports.

Senator Loy said the bill provided for a heavy penalty for carriers making rebates.

The permit of a carrier would be forfeited upon lapse of his insurance or bond.

Each carrier would be required to carry sufficient insurance to protect other motorists in case of accidents.

The speed of commercial vehicles carrying the maximum tonnage, 5,000 pounds, would be fixed at 25 miles per hour. Motor buses would not exceed 75 miles per hour.

The bill provided that if the operator of a commercial vehicle be found guilty twice of breaking the new regulations his license would be revoked for a period of three years.

It provided for the highway commission to add as many additional patrolmen and weight inspectors as needed to enforce the bill's provisions.
