Cotton Contract Cuts Were the Rule, Not The Exception

Cutting cotton production figures and cotton adjustment contracts was the rule and not the exception in Texas and everywhere else, according to the State Cotton Review Board. The farmer who feels badly that his first figures giving average five-year production were not accepted by the board, and were reduced by the county committee to put them in line with the county allotment, may feel better if he knows that nearly all farmers took cuts of the similar nature.

When all the cotton production contracts put by farmers into their pockets were added up it was found they ran over the county allotments by a rough average of 20 per cent. In some counties the overrun went more than 40 per cent.

This does not mean that farmers were dishonest in giving their production figures, the board says, but that farmers had no way of knowing exactly what they had produced for five years. Production figures were of necessity estimates based largely on memory. The same was true of acreage figures. A farmer assumed he had 100 acres in a field but it might have been 90 or 110 acres if actually measured.

On the other hand, the Bureau of start pastures on rented acres. The curacy the total bales produced in Texas every year. The average of this for five years became the Texas allotment. Loans Refinance Farmers Debts In Dawson County

A total of \$504,600 of Federal Land Bank and Land Bank Commissioners form mortgage loans was made in Dawson County, Texas from June 1, 1933 to May 1, 1934, according to the Farm Credit Administration.

Of this total, farmers in Dawson county used approximately \$474,300 or 94 per cent to refinance their indebtedness. By refinancing, farmers obtained new mortgage loans which they used to repay their old debts. They generally reduced their annual interest charges in doing so. In a number of cases, scaledowns of indebtedness occurred in connection with the new loans. These and other advantages benefited farmers primarily. Secondly, creditors benefited from the receipt of cash or bonds in exchange for obligations they held.

Of the loan money used by farmers in Dawson county for refinancing their debts about \$186,200, it was estimated, repaid their debts to banks; \$92,900, their debts to insurance companies; \$15,100, their taxes; \$180,100 their debts to "others", or creditors not separately classified, including private mortgage lenders, mortgage loan companies, retired farmers and many others to whom farmers were in debt.

A total of about \$30,300 of loans in the county was used for purposes other than the refinancing of borrowers debts. Of this sum, \$12,100 was used for the purchase of land and equipment, the construction or improvement of buildings, and for general agricultural uses, including the provision of capital while \$18,200 the balance, was used for the purchase of stock in national farm loan associations, for loan fees, etc.

Throughout the United States approximately \$675,000,000 of land bank and Commissioner's loans were made from June 1, 1933 to May 1, 1934. Most of these loans were made to refinance debts resulting from a long period of low farm income.

Generally farmers pay considerably more interest each year on the new than on the old loans. Land bank loans made thru national farm loan associations carry an interest rate of 5 per cent, but there is a reduction to 4 1-2 per cent until July 1938. Loans made direct by banks carry a rate of 5 1-2 per cent but there is a reduction to 5 per cent until 1938. The rate on Commissioner's loans is 5 per cent. Against these rates farmers in most cases had been paying from 5 to 8 per cent, but on numerous loans they had been paying 9 per cent.

Until March 26 the land bank and Commissioner's loans were made in cash. Commencing on this date they were made mainly in government guaranteed bonds of the Federal Farm Mortgage Corporation. These bonds are exempt from all Federal, state and municipal and local taxation, except surtaxes, estate, inheritance and gift taxes. They are guaranteed fully as to principal and interest by the United States Government. In a relatively short period after they were issued, they sold above par and had met a favorable reception from farmers and their creditors all over the United States. With the uses of these bonds, the refinancing program is going forward rapidly.

County Tax Collector Receives Notice Concerning Taxes

The tax collector of Dawson county, Willie Belle Cleveland has received a letter from the Comptroller's Department telling her that on and after July 1, 1934 the penalty and interest she will be required to charge will not be 6 per cent, but will be 6 per cent interest per annum from the date it was first delinquent plus 10 per cent penalty and the \$2.00 redemption costs. For example: 30 per cent will be added to 1930 delinquent taxes; 24 per cent will be added to 1931 delinquent taxes and 18 per cent will be added to 1932 delinquent taxes.

OUTLAWS of EDEN

THE STORY

MALARIA CASES INCREASING THIS YEAR IN TEXAS

According to information reaching Texas State Department of Health the number of malaria cases is increasing; a sharp turn upward was noted for May. This is directly related to a parallel increase in the number of mosquitoes. The malaria unit reports that not for years have they noticed such large numbers of mosquitoes. Probably one item that favors this increase is the mild winter and rainfall which leads to many temporary collections of water. Of course the breeding of mosquitoes is not limited to temporary water, but they are the ones that are often the cause of the increase of the mosquito production. They must have water to propagate. Attention paid to the following and similar points will largely reduce the opportunities for mosquito breeding. Remove all trash from the back yard, including old cans, pails, bottles, and automobile tires and bodies. Clean up the premises. Put new washers in leaky hydrants screen rain water barrels or oil them regularly. Get some top minnow

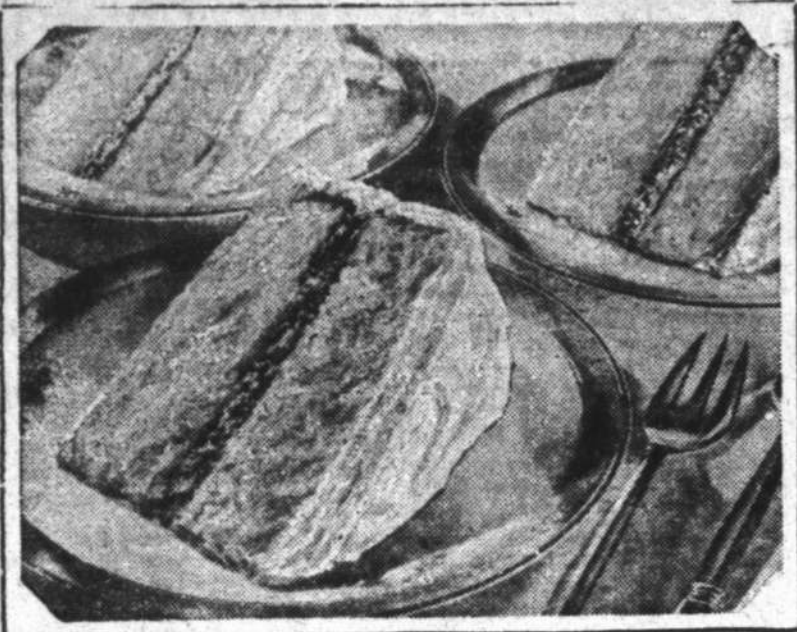

Cakes That Win Compliments



WHAT an honest sense of achievement we have when our cake receives that sincere compliment—"another piece please!"

Such cakes have a delicate flavor and fragrance, with a fine, moist, tender texture which is described by judges of cake as "velvety crumb."

Each of these cakes is a "velvety crumb" cake if you will follow directions carefully:

Lady Baltimore Cake

- 2 cups sifted cake flour
- 2 teaspoons combination baking powder
- 1/2 teaspoon salt
- 1/2 cup butter or other shortening
- 1 1/2 cups sugar
- 1/2 cup milk
- 1/2 cup water
- 1 teaspoon vanilla
- 1/2 teaspoon almond extract
- 3 eggs whites, stiffly beaten

Sift flour once, measure, add baking powder and salt, sift together three times. Cream butter thoroughly, add sugar gradually, cream together until light and fluffy. Add flour, alternately with liquid, a small amount at a time. Beat after each addition until smooth. Add flavoring; fold in egg whites. Bake in two greased 9-inch layer pans in moderate oven (375°F.) 20 minutes. Spread Lady Baltimore Filling between layers and Lady Baltimore Frosting over cake. Double recipe to make three 10-inch layers.

Lady Baltimore Frosting and Filling

- 1 1/2 cups sugar
- 1/2 teaspoon light corn syrup
- 1/2 cup boiling water
- 3 egg whites, stiffly beaten
- 1 teaspoon vanilla

- 6 figs, chopped
- 1/2 cup raisins, chopped
- 1/2 cup pecan or walnut meats, chopped

Combine sugar, corn syrup, and water. Bring quickly to a boil, stirring only until sugar is dissolved. Boil rapidly, without stirring, until a small amount of syrup forms a soft ball in cold water, or spins a long thread when dropped from tip of spoon (240°F.). Pour syrup in fine stream over egg whites, beating constantly. Add vanilla. Continue beating with a rotary egg beater 10 to 15 minutes, or until frosting is cool and of right consistency to spread. Use wooden spoon when too stiff for beater. For filling, add enough frosting to fruit and nuts to make a filling that will spread easily. Spread between layers. Spread remaining frosting on top and sides of cake. Makes enough filling and frosting to spread between layers and top and sides of Lady Baltimore Cake.

Hungarian Cream Cake

- 2 cups sifted cake flour
- 2 teaspoons combination baking powder
- 1/2 teaspoon salt
- 1 cup sugar
- 2 eggs, well beaten
- 1 1/2 cups heavy cream
- 1 teaspoon vanilla

Sift flour once, measure, add baking powder and salt, and sift together three times. Add sugar gradually to eggs, and beat well. Add flour, alternately with cream, a small amount at a time. Beat after each addition until smooth. Add vanilla. Bake in a greased pan, 8x8x2 inches, in moderate oven (350°F.) 50 minutes. Spread with your favorite chocolate frosting.

Rural Rehabilitation Plans Under Way

You will note the following important information and regulations relative to the repair of farm dwellings and premises for occupancy by Relief Roll Families. This applies to both vacant dwellings and those already occupied by families on Relief rolls.

1. The lease, a supply of which will be furnished you in a few days, will constitute a contract between the TEXAS RURAL COMMUNITIES INC., a corporation acting for the TEXAS RELIEF COMMISSION, and the LANDLORD, and will not be a contract between the landlord and the relief roll occupant.

2. No farm dwelling and premises will be leased without first receiving approval of the community Rehabilitation Committee of the community in which same are located, followed by approval of the County Rural Advisory Committee.

3. All work of repairing dwellings and premises occupied or to be occupied by Relief Clients shall be a part

of a County Work Project. Each man shall be assigned first to work on his own dwelling according to existing rules for work projects.

4. The rules and regulations governing hours and wages for Rural Areas, with which you have already been provided, will apply in repairing and remodeling farm dwellings and premises.

5. General plans and specifications for repairing or remodeling farm dwellings or premises are to be approved by the work Division of the Texas Relief Commission. The work division will also supervise and direct the repair work in the manner provided for other work projects.

6. All supervision not otherwise provided for by the Texas Relief Commission and deemed necessary by the work division must be furnished by a local Political Subdivision, organization, or agency.

7. The sum that may be spent for materials for repairs or improvements may vary with conditions and circumstances, but generally speaking should not be in excess of \$75 for any one dwelling and premises, inclusive of a pit privy.

8. The land to be used for producing food and feed for home consumption must be provided by the land lord and covered by the lease. The amount of land shall be in fair ratio to the cost of repairs, but may vary considerably because of soil and climatic conditions, and the particular needs of the occupant.

9. No cash shall be paid, the landlord. Repairs to and upkeep of the dwelling and premises is to be in lieu of rent for the years 1934-35.

10. No Relief Roll family shall be placed in a leased residence without having been finally approved by the county administrator after recommendation and approval of the case Worker, the county Rural Advisory Committee and the Community Rehabilitation Committee.

11. As long as any family is on the relief rolls its sustenance farming operations shall be under the general direction and supervision of the Texas Relief Commission, or any agency designated by it.

12. The Texas Relief Commission will reserve the right to remove the Relief Roll Tenant for cause and replace same with another tenant selected from relief roll Clients, as provided for in section 10.

You are respectively urged to give careful study to the above regulations. Each member of your County Rural Advisory Committee, each member of your county relief board and each member of each community Rehabilitation Committee in the county should be furnished a copy of the above information immediately, and also a copy of the lease form as soon as possible, in order that they may become well informed as to the details of this important project that we are now ready to put under way. J. E. Stanford, Director Rural Rehabilitation.

AAA Contract Signer Makes More Money Than Non-signer

Whether the hog processing tax comes out of the farmer or out of the consumer, the farmer who signed the corn-hog contract makes considerably more money than the one who did not sign, declares E. M. Regenbrecht, swine specialists at the Texas A & M college. He bases this statement on the contract benefits and on the current price of hogs.

Take two farmers each having 4 sows and marketing an average of 40 hogs of 200-lb weight each year. One signed the contract, the other did not. The one who signed the contract will make \$84 more than the one who did not, assuming the current Fort Worth price of \$3.30 per hundred.

The non-signing farmer, forgetting transportation and marketing costs would receive \$6.60 per head for his 40 hogs or \$264. The farmer who signed the contract would reduce his market hogs by 10 head and would sell 30 hogs. At \$3.30 per hundred he would receive for those 200 pounders \$198. In addition he will receive through the year \$5 per head for his 30 market hogs, or a total of \$150. His total hog income would be \$348 or \$84 more than received by the non contract signer. This would be subject, of course to a small deduction to take care of the local costs of his county corn-hog control association in administering the program.

"The fact is," says Regenbrecht "that the hog reduction program, at present hog prices, means a net increase to the farmer who is co-operating of about 30 per cent. What prices would have been had the reduction not been made by one and one half million farmers over the United States no one can tell. When consumer demand is lively it is probable that the process tax will come out of the consumer. When the market drags as at present it is likely coming out of the producer's hog prices. Even so, the cooperating farmer is making more money than the man who is not cooperating. In addition he is helping the United States to cut production to fit demand just as manufacturers always do. In the long run this means more favorable prices to all.

CHEVROLET LEADS FIELD IN REGISTRATION OF NEW CARS FOR APRIL

Passenger car registration for April place Chevrolet in the lead for the second consecutive month, according to Motor Statistics released by R. L. Polk and Company. Chevrolet registered 63,458 passenger cars during April or 38.2 per cent of the price class. The April figure shows an increase of 12,662 units over the March registration figure when Chevrolet led the entire industry in passenger car registering 50,796 units or 38.3 per cent of price class. Chevrolet maintained the lead in the commercial car and truck field, making an impressive showing by registering 15,050 units in April. Total registrations of Chevrolet commercial cars and trucks for the year through April were 49,797 units, 47.4 per cent of weight class.

Registration figures for March and April definitely establish Chevrolet as America's fastest selling car and forecast another year of Chevrolet dominance in the Automotive industry. Chevrolet has led the industry in sales during five of the last seven years.

TO THE COURIER

The census report of 1930 shows that in the United States there are approximately six and one third million farm homes.

President Edward A. O'Neal of the American Farm Bureau Federation, in a recent message to the farm women of America, discusses, rather too briefly I think, the important position occupied by the women of the farm homes of the country.

I am wondering if the women of the farm homes in Dawson County are wise to their real status in what may well be called the World's Finest partnership? These women play an important and most of them a magnificent part in this cooperative movement, yet there seems to be no coordination of effort to achieve the largest and the best things to which they are entitled.

Appended are some extracts from Mr. O'Neal's message, which I am asking, that as the Courier goes into most all of the homes of the county, you give it space in your columns to the end that the farm women of the county and others as well, may be made to realize that "the business of farming and the farm home are so closely allied that anything which interests or affects the one is directly reflected in the general status of the other."

Speaking of the many millions of farm homes in the nation, Mr. O'Neal says: "After more than a decade of great economic depression that our farmers have undergone, these homes yet represent the very heart of our nation and the future of our nation depends on the preservation of these homes. They are the great social, spiritual and industrial centers that make the foundation of our national life. From them comes the best of the nation, not only its new wealth in material things, but its leadership in economic and spiritual welfare.

"Since the beginning, history of a people is based on their homes. In fact, the people themselves took the names of their dwellings; even in the modern day as noted very frequently. A leader is honored by his nation in having the name of his birth and dwelling place given him on being honored by his country. Our divine Master is known as "Jesus of Nazareth." In thinking of our great National hero, George Washington, the first thing that comes into our minds is a picture of Mt. Vernon, and the same is true in thinking of Thomas Jefferson, and Monticello, or of Andrew Jackson and the Hermitage.

"Our songs and stories are based on the home. "Carry Me Back to Old Virginia," "My Old Kentucky Home," "On the Banks of the Wabash," "My Little Old Gray Home in the West," "Old Folks at Home," and last but not least, of all the popular airs of the nation, "Home, Sweet Home," all these homes in song and story are the homes of the countryside. Are any of them based on the city apartments, and the city home with cramped quarters and paved streets? Where do you find the heart or thought or in the written word any reference to the hydrant, while the old well and spring, and swimming pool are so often the claim. Every country boy or girl, whether now dwelling in the city or country can recall "Mother's Chair," "Mothers room; the children's room; the beds; the chairs, Grandfather's chair, if you please, the wardrobe with its hidden treasures; the kitchen stove, the churn the cistern-or well; all so human in the life of we country people. What a tragedy to hear a city boy ask his father to get him some horse shoes which necessitates a long automobile ride fifty or sixty miles out in the country to an old blacksmith shop.

"The humaneness of it all—the country home, the part that each member of the family plays in the great industry, the joy and the divinity of it all in the sowing and in the reaping in the creating with ones own toll the animate and inanimate life from the soil. Shall we not preserve these things?

"The reason for the home is the women, the sweetheart, the wife, the mother."

Mr. Editor, as the correspondent seeking his or her first efforts appearance in print, "If this doesn't find the waste basket, I'll come again," next week with some more of the message of President O'Neal, which I am sure will be interesting and instructive to the farm women as well as to all others interested in the common welfare of the rural life of the nation.

Collin county farmers will receive \$691,024 from the AAA this year as a result of the crop and livestock reduction programs.

Four-H club girls in Wharton county continue to lead the way in showing the home folks how to make much of living-at-home. Gardens are tended by 193 girls, 78 of whom made hot beds late in January for getting their vegetables off to a nice start.

Lespedeza sericea, a rather new legume, is being tried by Stonewall

county farmers in their effort to start pastures on rented acres. The county agent says the new Lespedeza promises well in the sandy river bottom soils.

From sales of black walnuts and cakes sold in the home demonstration market in Sulphur Springs, Mrs. D. B. Kirk, home industry demonstrator for Arbala Club, has bought a pressure cooker and a new oil stove. She says her market experience has revolutionized her cake making.

The big five ration has made 22.2 per cent more profit above feed costs than other rations used by Bastrop county poultry demonstrators. The extra profit for one month was \$6.71 per farmer, the county agent reports.

Yard improvements means, according to Mrs. M. L. Bell, yard demonstrator for Farmer's Valley Home Demonstration Club in Wilbarger county; trees for shade and background at side and back of houses; smooth unbroken grass lawn; foundation plantings of permanent shrubs screen and border plantings; roses and flowers in separate beds in side and back yard; walks for back and front yards and convenient yard service including well equipped wash house, concrete cellar, and sanitary toilet.

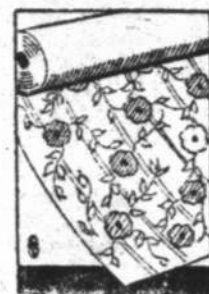

Farm Credit Administration

As the Farm Credit Administration rounds out its first year's work Production Credit Commissioner S. M. Garwood reports that the farmers production credit associations, which were organized last winter and began operations in volume in April have handled about \$44, 500,000 of spring financing.

"The associations have advanced \$27,300,000 of this amount," Mr. Garwood said, "and the balance of \$17,200,000 has been allocated to the accounts of borrowers. Most of this balance goes to farmers who are getting their loans in a series of payments during the season, so they will have the money when they need it and meanwhile save on the interest."

"Most of the loans made this spring have been for crop production," Mr. Garwood continued, "and while the spring seasonal demand for crop production loans has now passed its peak, the gradual increase in the size of the loans indicate that farmers and stockmen are turning their attention to livestock loans for general farming purposes.

"The extremely low cost of money this spring is very encouraging to

new agricultural financing. The production credit associations have been able to reduce the interests rates on new loans to 5 per cent; and this factor is enabling many farmers to get loans who up until now have postponed the purchase of needed work stock, horses, equipment, machinery repairs and improvements.

"Such loans must be secured by first liens on sufficient livestock or equipment owned or purchased, to secure the loan adequately.

June 11 - State executive committee meets to prepare the state ballot and select the place of meeting for the state convention.

June 25 - Last day for candidates to pay ballot fees.
