## It's Farm Safety Week In Nation, State, And County

National Farm Safety Week, proclaimed by President Lyndon B. Johnson, and by Governor John Connally in Texas, has been proclaimed in Mitchell County by County Judge Elmer Martin to run through Saturday.

"Farm and ranch accidents reap a grim harvest of lives each year in Texas. Thousands more suffer painful and disabling injuries, and property damage adds great loss to the agricultural economy of our state," the Governor noted in his proclamation.

Judge Martin urged all farm and ranch families to become "Safety conscious and to help reduce deaths and injuries caused by accidents," not only during this official week but throughout the year.

Theme for the observance

is "Keep Your Guard Up—Stop Accidents." The Texas observance is being sponsored by Texas Safety Association and the Texas Farm and Ranch Safety Council.

Joining the two safety organizations in the statewide accident prevention move are the Future Farmers and Future Homemakers of America, Young Farmers of Texas, and the Texas Farm Bureau.

In spite of a declining farm population, the safety organizations note in announcing Farm Safety Week, Texas farm accidents increased 28 percent in the past year. There were 280 fatalities in 1967 compared to 218 in 1966. Injuries are estimated at 31,400 for 1967, an increase of 7,000 over accidents in 1966.

Accidents involving farm

tractors and other farm machinery took the highest toll of lives last year with 51 fatalities, an increase of 50 percent, or 17 over the previous year. Second leading cause of death was firearm accidents with 48 fatalities. Drownings took 41 lives on farms and ranches; fires, 41; falls, 33; animals, 13; poisonings, 12; other miscellaneous accidents, 36.

In addition to the non-transport accidents, Texas farmers were involved in five percent, or about 9,500 of the traffic accidents on rural highways.

National farm-resident accident toll, including motor vehicle accidents, was 8,100 fatalities and 730,000 disabling injuries. Estimated economic loss from farm accidents in the nation is nearly \$2 billion.

## Water Supply Adequate In Spite Of Lake's Lowered Level

Colorado City has been pumping water from Lake Champion to supplement the town's water supply for three weeks, now according to J. A. Sadler, Jr., city manager.

Elevation at Lake Colorado City, normally 2,970 feet, is now 2,056.95. Sadler said, a loss of 13.05 feet of water.

Should the elevation fall as low as 2,051 feet, it would be considered low. The city, which purchases water for domestic consumption from Texas Electric Service Co., might then have to depend on water from Lake Champion until Lake Colorado City's level rose again.

Pumping of water from

Lake Champion to supplement water from Lake Colorado City is normal procedure and merely precautionary, Sadler added.

"We have at this time a reserve of 11 feet of water in Lake Champion. Water is still three feet above city intakes at Lake Colorado City, even though the lake is down somewhat," Sadler said.

Morgan Creek, tributary to form Lake Colorado City, is dry at the West Interstate 20 bridge. "That's mostly because of silt," said Sadler. It is also because in this season of heavy rain over most of Mitchell County, rains on the Morgan Creek watershed have been unusually

scant, he explained. "Unless it rains on the water shed, this winter we could be in trouble next summer, in 1969, but even

that is not likely," said the city manager. "No restrictions on use of water by city consumers has been contemplated, Sadler

said in answer to a question about that possibility, and about a "current" water shortage, rumor making the rounds in Colorado City.

## Post Office To Cut Services Saturday

Quick and favorable action from Congress, the Post Office cutback in service will begin all over the nation, including Colorado City, this Saturday, July 27.

First cutback is scheduled to be felt here Saturday morning. Under orders from Postmaster General W. Marvin Watson, post office windows will be open just exactly one hour, from now on each Saturday.

Windows will be open from 8:30 a.m. to 9:30 a.m. The catch is that no cash transactions will take place — no stamps sold, no packages accepted for mailing.

General delivery mail will be handled to post office patrons on request and patrons with slips for packages may apply at the window for parcel post delivery during the one-hour.

Arlene Morris, local postmaster, is still optimistically watching for some favorable congressional action to ease the cutback ordered to start here and all over the country Saturday.

Congress in passing the President's 10 percent income surtax, demanded a rollback to 1966 levels of all government agencies.

Postmaster General Watson said this will mean a loss of 83,000 postal workers over a four-year period when the annual mail volume will increase from 84 billion pieces to 93 billion pieces.

Watson told the Senate Post Office Committee, Monday, that the rollback would force a "disgraceful cut in mail service.

"We have the money," he added. "But we do not have the people to handle the growing volume of mail."

Service reductions as outlined by the postmaster gen-

eral under the new manpower edict would, Chairman Mike Monroney of Oklahoma, agreed "Be disastrous."

## Two Escape Fire House Heavily Damaged

Two Colorado City men escaped serious injury or death after their two-story house caught fire early Monday morning.

Asleep at the time in the residence at 743 Chestnut were W. J. Harrison and his stepson, Joey Normand. Harrison occupied one of two ground floor bedrooms. Normand, a 1967 Colorado High graduate, was sleeping upstairs.

Normand's mother, Mrs. Della Harrison, was away visiting in Louisiana.

The origin of the fire is not certain, but firemen suspect the air conditioner in the downstairs living room. It is in this area that the heaviest flame damage occurred. The fire was first reported at 1:49 a.m.

Harrison awoke first after the fire had already spread considerably. He found his way out of the house barefoot.

After leaving the smoking interior, the man's primary concern was for his stepson, still in the second floor bedroom.

Normand was comfortably asleep when "all of the sudden I heard popping noise and I heard my stepfather hollering at me."

The popping noise was

the sound of objects striking the side of the house. "He was throwing rocks and everything up there," Normand recalled.

Normand remembered that the light wouldn't work and that the room was filled with smoke. "If he hadn't have waken me up I'd have suffocated."

Normand threw on a pair of trousers and broke out a screen to one of the windows. He then climbed out onto the carport and jumped to the lawn.

Meanwhile, firemen were responding to a neighbor's call at 1:49 a. m. Within three or four minutes after Normand was out of the house, they were busy fighting the blaze. "I was surprised at how quickly they got there," he later stated.

The fire was brought under control within 15 to 20 minutes, but firemen continued to douse smoldering embers and to reoccurring flames until 2:44 a.m.

Direct damage was held to the first floor, which consisted of kitchen, den, living room, two bedrooms, two bedrooms, and a utility room. An accurate estimate of the damage is not yet available.

## 4-H Group Study Natural Resources At Lake

Four representatives of District II 4-H members this week are attending Texas 4-H youth conference on natural resources at Lake of the Pines near Marshall.

Attending the second annual conference from District II are Woody Anderson and David Stubblefield, members of Mitchell County 4-H Club; Shirley Stirl, a student of Hermleigh Schools, and Darlene Tate of Snyder.

They were accompanied on the trip by Warren Anderson, adult leader.

They were chosen to represent the 20-county district which is bordered on the south by Howard and Mitchell Counties; on the west by New Mexico state line and on the north by Swisher and Briscoe Counties.

Mitchell County is located in the southeast corner of the district.

Each of the 12 extension districts in Texas were eligible to send two boys, two girls and an adult sponsor to the summer conference

which highlights natural resource project work of 4-H members.

All expenses at the conference are paid by the sponsors — Federal Cartridge Corporation, Folger's Coffee Company and Southwestern Electric Power Company.

Headquarters for the four-day meeting is Wilkos Lodge, located in Marion County and owned by Southwestern Electric.

Purpose of the conference is to provide a better understanding and appreciation for natural resources and to give outstanding 4-H members additional, meaningful and educational experiences in outdoor activities that will highlight project work in natural resources.

Program will include informal learning activities tailored to the groups utilizing field trips and natural examples to provide individual learning in depth.

Natural resource areas will include forestry, rangelands, outdoor recreation, soil and water and wildlife.

# Plans For 1969 Cotton Research Program Told

Plans for a 1969 cotton research and promotion program approximating \$10 million dollars were outlined and considered in Lubbock recently by trustees of the Cotton Producers Institute.

Russell Giffen, Fresno, Calif., CPI president, pointed out that while plans call for continuation of all major projects in the \$8 million CPI program for 1968, a significant expansion is proposed in research on durable

press to enhance cotton's competitive position in a number of key markets and in promotion keyed to this product development.

High priority would be assigned to durable press (1) sheets and pillowcases, (2) shirts, (3) work trousers, casual slacks, and suits, and (4) dress fabrics. Teams composed of members of the technical, market research, and promotion staffs of the National Cotton Council have

been designated in each of these areas and would work as a unit.

The Institute utilizes staff and facilities of the National Cotton Council in carrying out its program which is financed by \$1 per bale payments by growers under the Cotton Research and Promotion Act.

Ernest Stewart, New York, director of promotion, National Cotton Council, said that in other durable product

groups which research proposals are being made for 1969, teams will be set up as progress indicates. End uses in this category are draperies, upholstery fabrics, and knit goods. A floor coverings product development team also has been established.

Promotion outline recommends expansion in national magazine advertising and in newspaper advertising sponsored 50-50 with local retailers. These two items are expected to account for the major share of the promotion budget. Television commercials, sponsored jointly with retailers, will be run in a number of test cities. Promotion-sponsored cooperative with major chains will be continued.

In the area of fabric development, fabric libraries, shows at market press weeks, and shopping center activity.

Continued also would be campaigns sponsored jointly with the manufacturers of cotton cushioning, awnings, and piece goods. Similar programs are planned also in behalf of tenting and mattress pads.

George S. Buck, Memphis, the Council's research director, presented recommendations in ten problem areas: (1) insects, (2) diseases, (3) weeds, (4) yield-quality, (5) mechanization, (6) processing - handling - marketing, (7) mill processing - finishing, (8) consumer-quality improvement, (9) product

development and (10) cottonseed.

Coordination of CPI research with all other cotton research particularly that supported by the U.S. Department of Agriculture and state experiment stations

is vital to an effective overall program," Dr. Buck emphasized in explaining procedures through which CPI works with USDA's cotton research review committee.

"One purpose of CPI research, he said, is to increase

the total effort of USDA, state experiment stations, and private industry, but of equal importance is the extent to which CPI research can strengthen, extend, and accelerate other parts of the total cotton research program."

# Three To Attend Seminar

Sponsored By Texas Farm Bureau

Three Mitchell County high school students will attend the sixth annual Citizenship seminar, sponsored by Texas Farm Bureau each summer on the campus at Baylor University, Waco.

July 30 - August 3, said Murrell Blassingame, president of Mitchell County Farm Bureau.

Students who plan to attend are Christy Stubblefield, daughter of Mr. and Mrs. Charles N. Stubblefield

of Route 3, Woody Anderson, son of Mr. and Mrs. Warren Anderson, Route 3, both students in Colorado High School; and Debbie Oliver, daughter of Mr. and Mrs. Wayne Oliver, Route 1, Loraine, student in Loraine High School.

Annual seminar is planned as an intensive course in citizenship, the American heritage, and the proper role in government, said Blassingame.

"It is designed to complement the formal education of young junior high and high school students, and to help make their role as citizens more meaningful," the local Farm Bureau head said.

Travel to and from the seminar at Baylor is to be by chartered bus. Mitchell County Farm Bureau sponsors the trip and the stay on the Waco campus by paying for transportation, room, board, and tuition for the course.

A total of 425 students from 156 Texas counties have enrolled for the seminar Blassingame said. Instruction will consist of lectures, films, and panel discussions with emphasis on economic, moral and social aspects of American society.

Four nationally known lecturers will address the 1968 seminar sessions.

They are Dr. Clifton L. Ganus, president of Hardin College, Searcy, Ark.; Dr. C. L. Kay, president of Lubbock Christian College; John Noble, author of "I Was a Slave in Russia"; and W. Cleon Skousen, author, lawyer, and former FBI agent.

# Fall Of Romanov

Theme of New Biography

Robert K. Massie's "Nicholas and Alexandra," will be reviewed by Bob Reilly in Hesperian Room at Mitchell County Public Library at 8:15 Thursday evening (tonight).

The new book, published by Atheneum Press, New York, is now on the county library shelves. It is an intimate account of the last of the Romanovs and the fall of Imperial Russia.

History offers few eras richer in human drama than the last years of Imperial Russia, ruled by Nicholas II, the czar who ruled one sixth of the earth and 120 million Russians; book critics agree.

Alexandra, golden-haired and beautiful wife of Nicholas, was the favorite granddaughter of Queen Victoria of England.

After the birth of their only male heir, Alexis, and the discovery that through Victoria the crown prince had inherited the dread disease hemophilia, the fate of the czar and his empire, was placed into the hands of Rasputin, the "Mad Monk," who knew how to relieve the pain of Alexis through hypnosis.

It was Rasputin who continually urged Alexandra to resist all outcries from the people for reform in government. Denial of every claim or for responsible government made revolution and the triumph of Lenin inevitable, historians point out.

Massie, who read all diaries, letters and memoirs left by those playing major roles in the tragic epoch, made of his book an absorbing chronicle of the lives of Nicholas and Alexandra, weddings, parties, yachts, costumes, intrigues.

Fall from the pinnacle of power to prison and death for the Romanovs is one of the most touching facts of history.

# Parsonage At Dunn Sale In New Fund

McMillin of Snyder, who also pastors the Trinity Methodist Church in Snyder. Buford is being served by the Rev.

Trustees of the two churches decided to sell the parsonage when it became apparent that it would no longer be needed. Approval was by quarterly conference action several weeks ago. A Snyder attorney, handled the sale. Sealed bids were taken, and the property was sold to the highest bidder.

The parsonage was located adjacent to the church at Dunn, 13 miles north of Colorado City.

At a time when the United Methodist Church is already short of young ministers and when many of them have to struggle to meet their college expenses, interest from this money in years to come will help many young ministerial students attending McMurry. We are very grateful."

# Thurs. Last Day To Certify Acreage

Mitchell County farmers are reminded that next Thursday, Aug. 1, is the last day to certify cotton and feed grain acres, according to announcement from the Agricultural Stabilization & Conservation office this week.

Program benefits and payments will be lost for failure to certify, said Eddie Braswell, ASCS county office manager.

"Unless acres are reported accurately, part or all of payments may be lost. An error in one commodity may cause the farm to be ineligible for all the program benefits from that farm," Braswell pointed out.

After August 1, spot checks of 2 percent of the cotton and feed grain farms

will be made by measuring and there will be no further opportunity to adjust at that time.

Early measurement service is still available for acreages where farm operators are not sure, Braswell said.

Even farmers who had early measurement must certify acreage by August 1, he concluded.

When allotment notices are being mailed by the ASCS office today with details of the 1969 wheat program, the 1969 program of feed, Price Support Loans, Domestic Marketing Certificates, and payments for diverted acreage below the farm allotment.

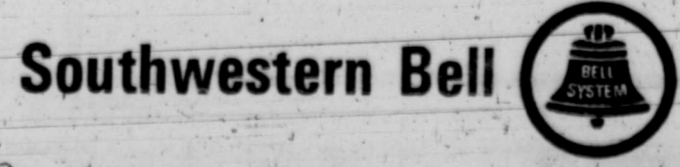

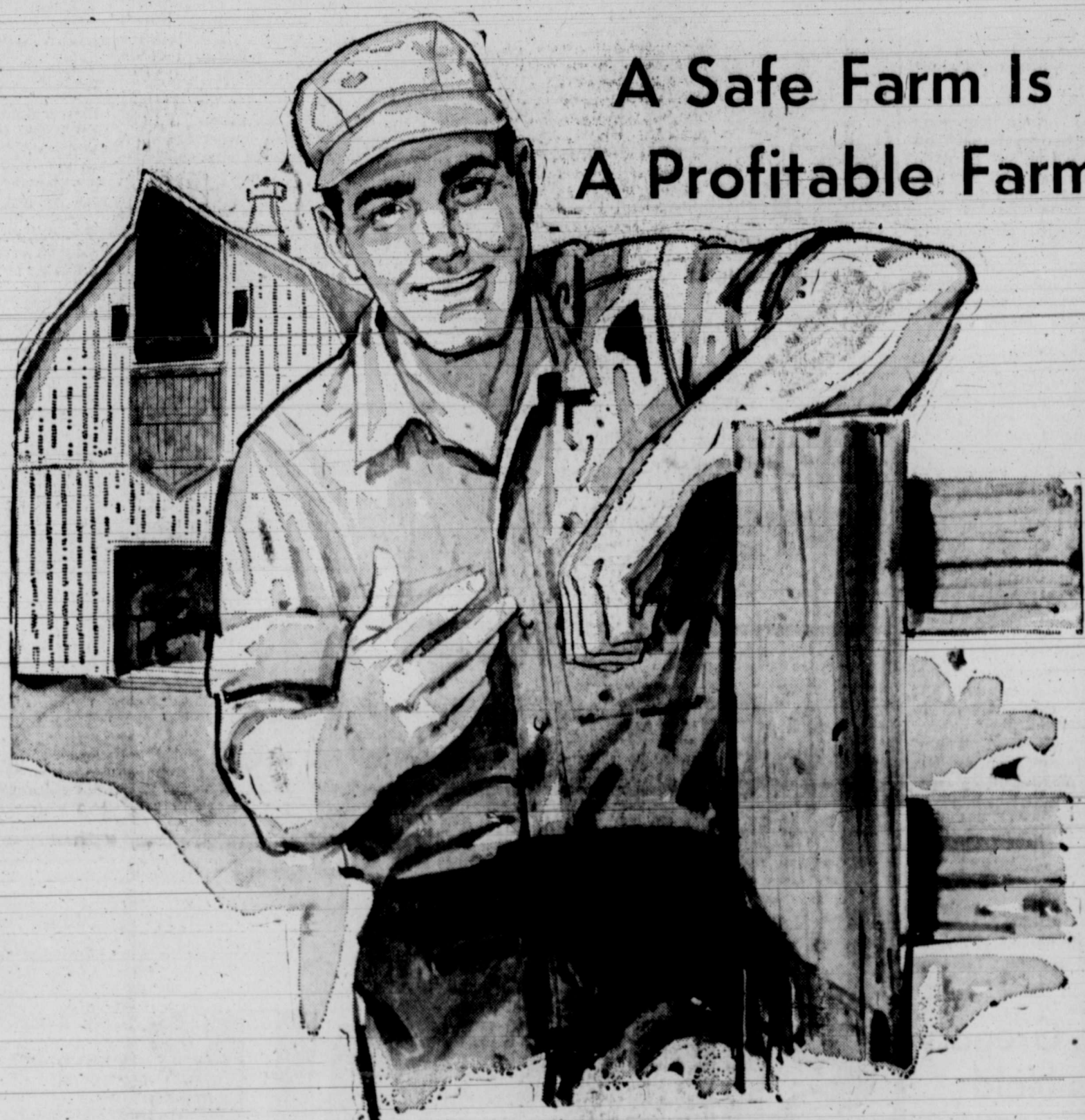

## 1,637 In Mitchell County Receive Cash Benefits

A record \$115,278 was paid out in social security cash benefits to 1,637 residents of Mitchell County for February, according to Evelyn Fisher, Big Spring Social Security District Manager. An increase of \$24,637 over the amount paid out for December 1966.

February 1968 was the first month in which increased benefit rates provided by the 1967 Amendments to the Social Security Act were payable, Fisher noted. Nationally, the amount of monthly benefits exceeds \$2 billion, an increase of more than \$360 million above the

December 1966 figure. More than 24 million men, women, and children, or nearly 1 out of every 8 Americans, are now receiving some type of monthly benefit.

About 18.4 million of those receiving benefits at the end of February were 62 or older. An additional 2.2 million were disabled workers under 62 and their young dependents.

About 3.5 million social security beneficiaries were young widowed mothers and their children, the district manager said, noting that a total of about \$19 billion has been paid to orphaned children and their mothers since January 1940, when monthly survivors benefits first became payable.

In the past 6 years alone, benefit payments to this "younger group" have amounted to 1 1/2 times as much as the amount paid out in this category during the preceding 21 years.

Many younger people also receive benefits due to disability. More than \$2.2 billion is being paid out each month to disabled workers and their dependents—a rate that is 10 percent higher than that of December 1966.

Most of the changes in the 1967 social security amendments provided more protection for younger people, Fisher noted. For instance, some 175,000 children are now eligible for benefits based upon the earnings of

Ruth Coffey's

**JUST MADE** the most peculiar discovery! Found out, without even meaning to, why I'm not, never have been and never will be a nationally known poet. And a very confusing bit of knowledge that is, too.

Was reading a little piece by Bryan Wooley, Associated Press writer, who was discussing Welborn Hope, 'Oklahoma's Tramp Poet.'

It appears that Hope, who has had 2,000 poems published in everything from country newspapers to Saturday Review of Literature, thinks a vow of poverty is necessary for a poet. "A man can't write true poetry unless he takes a personal vow of poverty," he said. "Being a poet means being poor and it means being a recluse—alone with his poverty and his thoughts."

**SO THAT'S** what has been handicapping me all these years. Not poor enough to be a true poet who writes true poetry, that article said, loosely translated.

"A poet must really believe that the most important things in this world don't cost money," Welborn Hope declares. He's going to hit the road again, soon, swapping poems for food—never, never, for money, he says.

Now you see? Not only is this particular poet (nameley me) too rich to write true poetry, she's too tired to travel.

**TOO stubborn** to take a poverty vow, too. Not that it has ever been strictly necessary to swear to stay poor.

"Course a lot depends on what he means by the word poverty. And what it meant by vow.

If poverty can be construed as meaning more sales tax, more income tax, more withholding tax plus a surcharge, almost any working woman can now qualify.

If feeling like saying "Well, I'll vow!" every time the bank statement doesn't add up right counts, I'm in.

At least, I'll vow I get poorer by the minute.

**LIFE** is just a long line of choices.

Noted that Welborn Hope, Oklahoma's Tramp poet who hails from Tulsa, works on occasion. He's even been a newspaper man... only "Never for very long at a time."

That could account for his whole attitude and is probably where he got the poverty vow idea in the first place.

Poets have a choice. They can work for a newspaper if being poor is such an asset and if poet means poor.

Or they can take the poverty vow and start hitchhiking and tramping. And trade sonnets for supper.

Newspaper writers have a choice, too. And it simply strikes me that being poor sitting still is easier... poetry or no poetry.

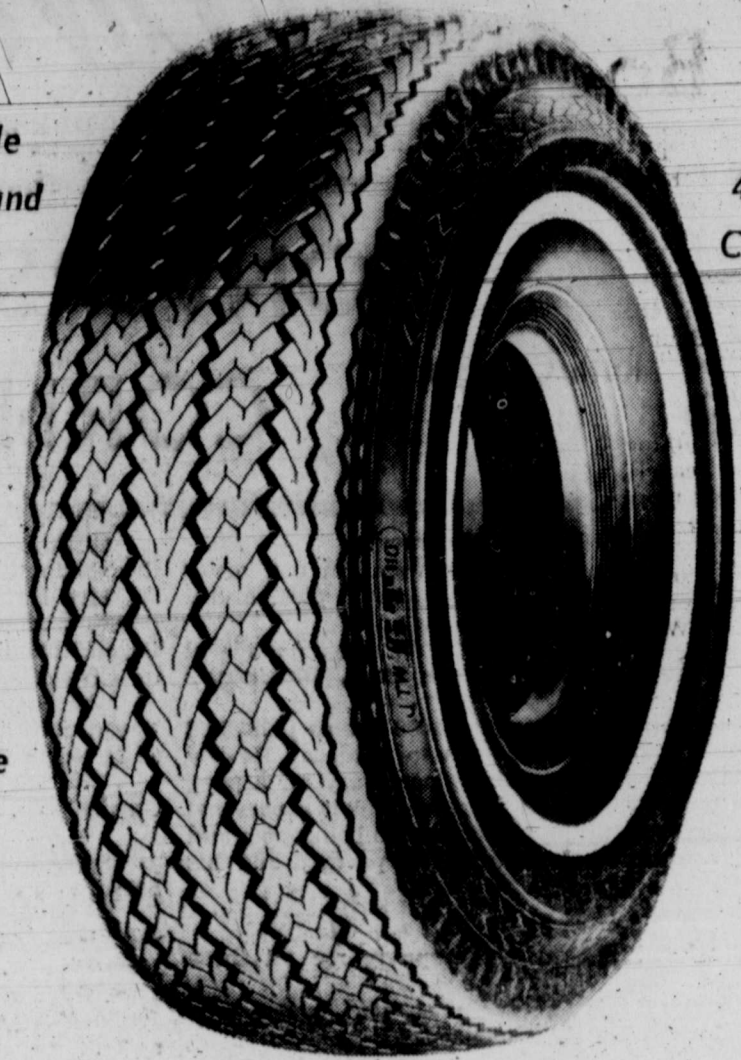

# 'Iberia' By Michener New Book At Library

EDITOR'S NOTE — This is first of a series of book reviews for Record readers featuring new volumes in Mitchell County Public Library. Reviews are to be by members of Friends of the Library and of the County Library Board.

It may come as something of a surprise to the readers of James A. Michener's more popular work; such as "Hawaii," "Tales of the South Pacific," and "The Source" to find that he has turned his attention to the West, specifically Spain in his latest book, "Iberia."

However, one finds that Mr. Michener is no novice about matters Spanish, in that the greater part of his life has been occupied in an on-again, off-again love affair with Spain that began when he was a young student serving during the holidays as a chart boy on a freighter carrying cargo between Scotland and Mediterranean ports.

Spain fascinated him, and the Spaniards entranced him; and as time passed he found himself suffering progressively from Hispanomania. Long ago he promised himself the pleasure of writing at length about the country for which he cherished an extraordinary affection. "Iberia" is the fruit of many wanderings, many reflections, studies and pleasurable encounters.

The book contains 13 chapters, each concentrating on a specific area. The focal point in each chapter may be a major city, a village or even a region, such as Las Marismas, where the best fighting bulls are raised. The advantages of a free approach such as this is that the reader becomes a partner in Mr. Michener's wanderings and feels toward him the feelings one might get in an informal conversation with an old friend.

The same feelings work to Mr. Michener's disadvantage as well. His travels, while very interesting, sometimes have all the charm of one's old friends who have interminable home movies of their grandchildren. It is his garrulity is fascinating, however. Just when you decide that Mr. Michener is an old man sitting by the fire and dilating at incredible length about his youthful wanderings in Spain, you are suddenly pulled in short by an apt image, the creation of an atmosphere or a scene, the sudden emergence of a real person in a real setting.

The book is illustrated by a considerable number of photographs by Robert Vavra, from California, a nature photographer. Mr. Vavra is a close friend of John Fuldolphia, who is the most ton, the American from Philadelphia in Spain. The photographs are excellent, done with a sensitive eye and what appears to be a genuine love of the people and land of Spain. They were done independently from the text, but fit in mood and style the feeling toward Spain which Mr. Michener appears to have. I feel that this unity is rather remarkable and would only wish that Mr. Michener's prose could have been subjected to the editing which was apparently done to the illustrations.

The subtitle, "Spanish Travels and Reflections" is probably best illustrated by quoting a passage from the book. Throughout his text, Mr. Michener attempts to relate a sense of history to contemporary life. In speaking of the period of 25 years which has followed the Spanish Civil War, and relating these periods to us, Mr. Michener says:

"It also applies to the United States, though we fight against it and blind our eye and conscience to the fact. The median age of our population is lower now. We are more overcrowded, more urban, and whether we like it or not, a permanently mixed nation racially. We are in the midst of swift change in education, technology, labor relations and religion."

"We are evolving a new morality, a new posture in world politics. Yet we refuse to understand that the advent of such change signifies also the advent of a new nation. The people of Spain seem more prepared to accept their new nation than we are to accept ours, and it may be this reluctance to accept the new that will destroy us."

Not all of Mr. Michener's reflections are of this serious nature. Particularly enchanting is his description of the attitude of "viva yo" which is a facet of the Spanish national character. "Viva yo" simply means "Hurray for me," but an important im-

plication is "To hell with everybody else." This, one would think, would be a particularly handy phrase to have around.

One wishes that the book had been shorter, less garrulous, less self-indulgent. One wishes he had come to grips with mystery and darkness, and encountered dragons on the way. He never tilts with windmills. To the end he is the cautious traveler at his leisurely ease. Nevertheless, a trip to "Iberia" with James A. Michener and Robert Vavra is well worth the taking and would probably give the reader much more pleasure than a shelf full of travel guides.

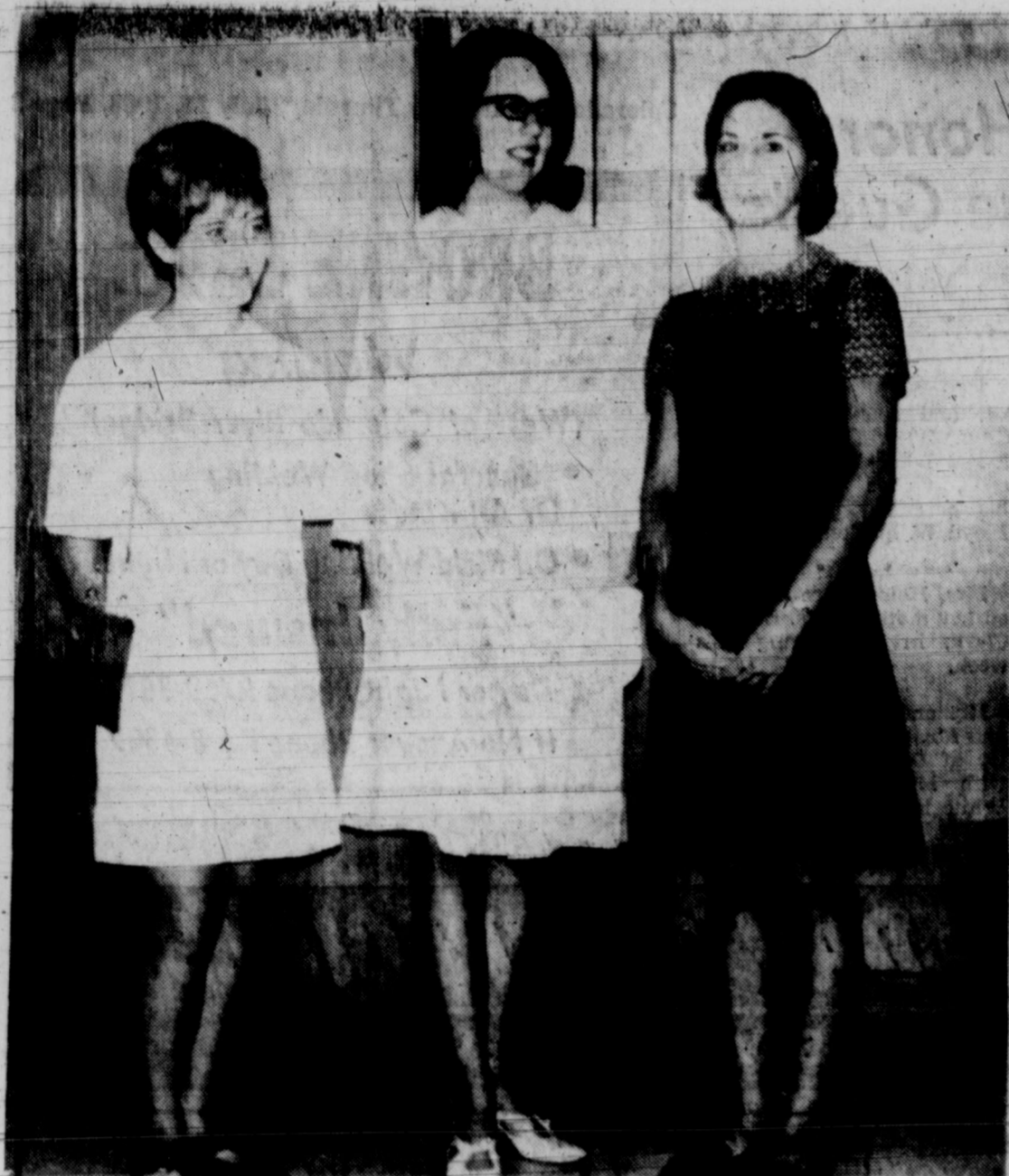

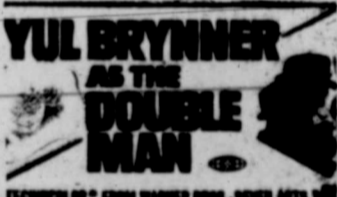

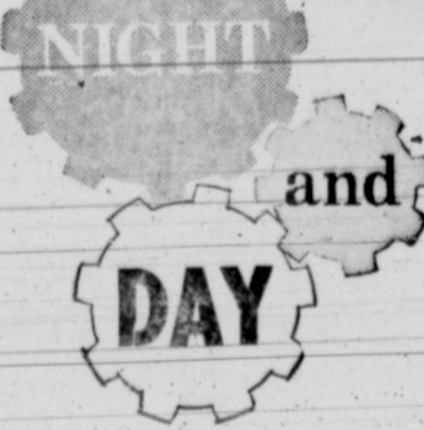
