In the shadow of '80 John'

Hettye Wallace keeps ranch, legend alive

Over 100 years ago — back in 1875 — Daniel Webster Wallace escaped the cotton fields of South Texas and began the legend of "80 John," the black cowboy who became a pioneer rancher in Mitchell County.

Years passed — over a century — filled with trail rides, Indian fights, scrimping and saving to establish a profitable 12½-section ranch near the sleepy town of Loraine.

Wallace is gone now, as is most of his family, but the ranch and the legend live on. Forty years after his death, the ranch Wallace sweated for remains, cared for by his 84-year-old daughter, Hettye, and her 86-year-old husband, Travis Branch.

Tended by the aging couple, the ranch doesn't quite live up to its past glory. Where once there were 600 head of prize Hereford cattle, now there are 52, plus Hettye's 15 mother cows. Some of the land is now leased to grow cotton, the crop which drove Wallace from Victoria County.

But the integrity and hard work that history books say made Wallace the trusted friend of many West Texas ranchers were instilled in his children and have, through them, helped others achieve their goals.

Hundreds of Mitchell County children were educated by Hettye and her two sisters because

Wallace insisted that his daughters go to college. He also established a school — the D.W. Wallace School for Negro Children — in which his daughters taught.

Although Wallace never finished grade school, he learned that an education is a valuable tool in ranching. When he was 25 years old he returned to the second grade to learn math.

There he met Laura, who had just graduated from high school. Instead of becoming a teacher, Laura married Wallace and became a pioneer woman. She bore them a son and three daughters.

Hettye graduated from Wiley College and then in 1957 received her masters degree in education from the University of Colorado. She also studied social sciences and art at the University of Chicago and the University of Southern California.

She taught for 25 years in Colorado City schools and only stopped when she started losing her hearing. She proudly says that some of her students are now teaching in public schools and colleges.

Hettye and Travis seem inspired by her legendary father. The living room of the eight-room frame house built by Wallace in 1930 is studded with framed pictures of Hettye's parents. When visitors come, the Branch's pull out photograph albums filled with articles and pictures.

When they speak of the man, their eyes shine and Hettye's voice cracks with laughter. She wrote a See Ranch, page 2A

Three killed, 2 hurt in Odessa gun battle

ODESSA, Texas (AP) — An early morning shootout that left three men dead and two wounded at a poker game still puzzles police, who said today they are still looking for other players in the high stakes game.

Odessa Police Detective Jerry Smith said the card-players began shooting at each other at about 3 a.m. Sunday at the La Cosita Apartments on the west side of this West Texas city.

"Right now it doesn't make much sense except that we got three people dead over a poker game," said Lt. Rusty Baker. "It's all still very confusing. Sometimes it doesn't take much to cause a shooting."

Smith said police would be trying to piece together more details, including how many guns were involved, when the investigation continued today.

Two victims were found in different rooms of the apartment lying in pools of blood.

One of the men who was killed was shot once at the game, then ran out of the apartment, apparently pursuing someone, Baker said.

"He went to a nearby house and broke in," Baker

said. "We don't know why he picked this particular house, because the people there didn't have anything to do with the game. He just broke down the door at 3-something in the morning, said he was looking for so-and-so and started threatening the lady of the house."

"Her husband shot him."

Baker said officers did not yet know how much money was involved in the game, and he was reticent about how much — if any — was found in apartment, saying only officers "probably" found some there.

"There was more than just the five players involved," Baker said. "How many more, I don't know. And there may be one woman involved."

Baker said that police believed several of the people at the game were from out of town.

One dead man found in the apartment was identified as Robert Notley, either 39 or 40 years old, of Odessa, said police Lt. Rusty Baker. One victim has not yet been identified and the identity of the third is being withheld pending notification of next of kin, Baker said.

Bastrop inmate called 'prime' suspect in shooting of judge

LUBBOCK, Texas (AP) — Federal officials investigating an assassination attempt against former Assistant U.S. Attorney James Kerr hope that a fugitive arrested after a 10-year hunt will provide clues in the attack.

The Lubbock Avalanche-Journal reported in a copyright story Sunday that Danny O. Armstrong, 34, of Austin is a "prime" figure in the investigation into the 1978 shooting attack on Kerr in San Antonio that preceded the assassination of U.S. District Judge John Wood Jr.

Armstrong remains in custody at a Bastrop federal correctional facility in lieu of \$300,000 bond. He was arrested earlier this month after he checked into a Lubbock hospital for surgery.

"Some of it was just sheer luck" that led to the arrest and other information came from "confidential sources," said U.S. Marshall Bill Jonas of San Antonio.

Armstrong was sought about four years ago by the FBI in an effort to secure his testimony before a federal grand jury investigating the Kerr shooting attempt, Jonas told the newspaper.

Armstrong is a "prime" figure in the investigation into the assassination attempt, a federal official who declined to be identified told the newspaper.

Kerr's luxury car was riddled with 19 bullets on Nov. 21, 1978, but the prosecutor was only cut by flying glass. Seven months later, Wood was gunned down outside his San Antonio townhouse.

Charles V. Harrelson of Dallas, a previously convicted hitman, was convicted of shooting Wood.

Armstrong has been sought since May 22, 1973, when he failed to appear before Wood in a Del Rio federal court to face charges of conspiracy to import marijuana and possession with intent to distribute marijuana.

Although no one has yet been charged in the Kerr shooting, a motorcycle club member was convicted in 1979 of federal firearms violations stemming from a raid by agents seeking weapons used in the assassination attempt.

Daniel A. Thomas, 43, was convicted after FBI agents received a tip that a gun similar to the .30-caliber automatic carbine used in the shooting was hidden at his house. Authorities entered the house and found 10 other guns.

And earlier this year, El Paso drug trafficker Jimmy Chagra was quoted in excerpts from transcripts of FBI tapes as talking about hiring a man to kill Kerr. He was described as a principal federal prosecutor of drug cases in the Southwest at the time of the attempt against his life.

A Jacksonville, Fla., jury acquitted Chagra of charges that he paid Harrelson \$250,000 to kill Wood.

Federal officials are placing greater emphasis on solving the case because the case of the assassination of Wood "for all intents and purposes is over," an FBI spokesman in San Antonio said.

The statute of limitations in the case expires in November, prosecutors say.

Two men wearing black gloves ambushed Kerr at an Alamo Heights intersection as he drove to work. His Lincoln Continental was riddled with bullets by an automatic weapon and a shotgun.

Kerr had earlier been directing a federal grand jury investigation into drug trafficking concentrating on the El Paso area.

Armstrong's attorney, Rip Collins of Austin, said last week he was not aware that Armstrong was sought for questioning in the Kerr shooting.

However, he said he did "learn from my own investigation the FBI was diligently looking" for Armstrong in 1978.

Reagan seeks \$60 million for El Salvador

WASHINGTON (AP) — President Reagan, seeking approval from a Congress skeptical about greater military aid for El Salvador, said today the government there will have trouble surviving if U.S. support is not increased, the Senate Republican leader said.

Reagan, said to be seeking \$60 million in additional military aid for El Salvador, made his pitch this morning at a hastily assembled meeting of House and Senate leaders from both parties, but his plea was expected to receive a mixed reaction in Congress, said Sen. Daniel K. Inouye, D-Hawaii.

Senate Foreign Relations Committee Chairman Charles Percy, R-Ill., said he would condition his support for the proposal on indications that the Salvadoran government was making economic and human rights progress and was not striving for a military solution.

"The president made it clear there is a serious problem in the region, that the national interests of this country are deeply involved in the outcome of that struggle," said Sen. Howard H. Baker Jr., the Senate Republican leader.

Baker said the "immediate problem" is "whether or not the See Reagan, page 2A.

Is there life after 'M-A-S-H'?

Four original cast members doing well after leaving top-rated show

LOS ANGELES (AP) — "Radar" is now on the stage. "Major Burns" is making teddy bears and "Trapper John" has two more television series credits to his name.

The television series "M-A-S-H" concludes its 11 years on the small screen with a special presentation Monday (at 7:30 in Big Spring on channel 7), but for four actors who played key roles along the way, the show ended long ago.

The four are Wayne Rogers, who left the role of Trapper John because he wanted more creative responsibility; McLean Stevenson, who shed the part of Col. Henry Blake to find fame and fortune on his own; Larry Linville, who ceased to be Maj. Frank Burns because of the character's limited scope; and Gary Burghoff, who gave up the part of Cpl. Radar O'Reilly to pursue a wider range of acting.

Since leaving the series in 1977, Rogers has had his ups and downs. On the minus side was "City of Angels," a short-lived NBC series in the Raymond Chandler mold.

"It got on the air too soon, without proper preparation," said Rogers. "And there was a problem with story quality as well."

However, "Angels" was followed by CBS' "House Calls," which Rogers today considers his finest achievement, even topping "M-A-S-H."

"House Calls" was a better experience," he says, "because I had more creative control — writing, directing, acting. I felt more a part of that series than 'M-A-S-H.' And we were able to deal with significant subjects along the way."

Rogers was surprised that "House Calls" was canceled while still high in the ratings. "I, like most people, used to think ratings were everything," he admits. "But you have to have the right friends in the network throne room. We didn't have those friends and we were canceled."

Rogers is currently working on an upcoming interview series for NBC. He wants to interview peo-

ple of "substance," though he concedes the network will most likely have him talk to entertainment figures who attract high ratings. And he still has his eyes open for another series.

Linville has been working steadily over the years

and, in addition, the actor who once kidnapped Radar's teddy bear is now making the fluffy toys in his spare time.

He got involved with stuffed bears because his sister-in-law owns Grin 'n' Bear It, a teddy bear

store in Torrance. "It started out as a joke and now I'm up to my butt in cloth, stuffing and bears," he said. "My wife dared me to make a bear and, after six or seven disasters, I came up with a decent-looking bear. They're cute as hell and we've sold lots of them. Making the things is good therapy in between acting roles."

Linville has had one series — "Grandpa Goes to Washington" with Jack Albertson in 1978 — and made several pilots over the years, and has appeared in TV movies and on stage.

"I would still like to do one more series — a good one — for five to seven years and then retire to Northern California," he said.

Since leaving "M-A-S-H" in 1980, Burghoff has devoted himself almost exclusively to stage work, performing in such plays as "The Owl and the Pussycat," "Play It Again, Sam" and, currently, "A Closer Look at Boney Kern," in Tampa, Fla.

"When I left the series, I very much wanted to cultivate an acting career. I wanted the immediate audience response, the spontaneity of stage work and of hearing the laughter," he said.

He doesn't rule out TV, but wants to be selective. "If something good came along," he says, "something with human values, of course I would take it."

Of all the ex-cast members, McLean Stevenson, who played Henry Blake from 1972-75, has had the most television exposure since he left "M-A-S-H" — three television series, supplemented by countless appearances on the "Tonight Show."

Neither "Hello, Larry" nor "The McLean Stevenson Show," another situation comedy, was a great success. But now, there's "Condo," an ABC half-hour show that has attracted some respectable ratings.

Farm workers warn of strike at convention

PHARR, Texas (AP) — State Agriculture Commissioner Jim Hightower says farm workers have "come out of the fields and into power."

Hightower, speaking at the United Farm Workers of America fifth annual state convention Sunday, said, "You have elected officials who are going to represent the people's interests."

The convention, which drew about 450 members, was stopped briefly at one point as workers chanted "Strike, Strike, Strike."

"The workers feel they have to strike to get an increase in wages," said Dolores Huerta, first vice president of the California-based national union.

"They're saying if they don't get (increased) wages, they will strike," she said.

The federal minimum wage of \$3.35 per hour covers only 35 percent of the eligible farm workers in Texas, according to union figures. The other 65 percent are covered by the Texas minimum wage law that assures farm workers at least \$1.40 per hour.

The daylong convention was dominated by discussion of the union's political platform, which included 11 resolutions dealing with Texas farm workers.

Chief among those were resolutions supporting bills introduced in the Texas Legislature this year to increase the minimum wage for farm workers and to grant workers' compensation insurance to farm workers.

A resolution against the "overuse and abuse" of pesticides in the Rio Grande Valley also was presented.

The farm workers drafted letters to Gov. Mark White urging his support for the workers' compensation bill.

Harry Hubbard, Texas AFL-CIO president, offered to set up a meeting in Austin to allow farm workers to personally deliver these letters to the governor.

Hubbard said he attended a march in support of increased minimum wages in the 1960s.

"We've made very little progress in that since (then)," he said. "But the stage is now set for progress. In 1982 every candidate for a statewide office that won was endorsed by Texas labor."

State Treasurer Ann Richards, Sen. Lloyd Doggett of Austin, Reps. Juan Hinojosa and Alejandro Moreno of McAllen also attended the convention.

Ms. Huerta told reporters state leaders have "realized the farm workers helped get them elected."

This is the first time in the union's 17-year history the farm workers have received such strong support out of Austin, she said.

biography of her father in 1960 entitled "The Story of '80 John'."

Travis, who never met the famous rancher, sports a hat suspiciously similar to the one Wallace wears in his portrait.

"Anybody that can think knows he was remarkable, considering where he started and what he accomplished," Travis said. "He worked hard and made good connections."

Travis married Hettie in 1946 and immediately began working the ranch. Their mothers had been best friends since Mrs. Branch worked for a white woman in Colorado City.

Because the couple had no children, the ranching has been left completely to Travis. Hettie, though the daughter of a rancher, preferred more artistic endeavors.

"I remember once or twice my father would have me hold the reins on the horse and I was so scared that I dropped the lines," Hettie said with a laugh. "I've always been scared of horses, so I didn't learn

much about ranching."

Hettie can not hear well enough to understand, so visitors write their questions down for her to read and answer.

Her dearest memories are of her mother. "She was brave and very kind," Hettie said, then chuckled as she remembered. "Once, when the ax man was killing people, she had a gun to make me brave, but later she told me the gun wouldn't shoot."

Their walls are hung with Hettie's paintings. Ceramics, relics of art classes, fill almost every corner.

The Branch's are not socially active now. Only old-timers in town know about them, although the ranch, about two miles from town, is marked by an historical marker.

But the Branch's and history books keep alive the story of "80 John," the son of a South Texas slave who worked his way from chopping and plowing to become one of the most respected ranchers in West Texas.

Boy killed while buying ice cream

DALLAS (AP) — A 34-year-old man was arrested in connection with the hit-and-run death of a 6-year-old boy who has been killed by a car 75 feet from an ice cream truck where he had just bought a frozen treat.

Roy Lee Smith was being held in city jail today in lieu of \$10,000 bond in connection with the death of Craig Thomas, killed Saturday after he was hit by a speeding car near his southside home, police said.

Smith was arrested about an hour after the accident one block away, police said. He appeared before County Judge Tom Boardman on charges of investigation of involuntary manslaughter and failure to stop and render aid.

Smith was arrested after several neighborhood children told police they recognized the driver of the car.

The car that struck Thomas was traveling 50 mph in a 30-mph zone, said police traffic investigator J.D. Chappell. The impact knocked the child 75 feet across the street and into a neighbor's yard, he said.

Thomas was pronounced dead on arrival at Parkland Memorial Hospital.

"It's one thing to hit a child and stay to suffer the consequences," said Kathy Johnson, the boy's mother. "You can understand an accident. But hitting a child and running away — that's the lowest thing a man can do."

The child suffered numerous cuts, broken bones and internal injuries, Chappell said.

"The driver had to know he hit the child," he said. "He never should have been driving that fast. And everyone knows kids swarm around an ice cream truck."

Smith's car had a new headlight and had just been washed when he was arrested, police said.

The mother said she was home with Thomas and her 3-year-old son when the ice cream truck drove by. Mrs. Johnson gave Thomas a dollar and told him to buy treats for himself and his brother.

A neighbor said she was washing her car when she saw the car speeding toward the boy.

"I saw this blue car coming at full speed," said Myrtis Lester, who tried to pull the boy to safety. "The ice cream man and I reached for the baby, but it was too late."

Dole, governors: need defense spending cuts

WASHINGTON (AP) — The chairman of the Senate Finance Committee, Sen. Bob Dole, threw his support to the nation's governors today in their drive to cut federal deficits by slashing at the increases in defense spending.

"I agree with them on defense spending," the Kansas Republican said. "I think we can budget a little better with cuts in that area."

Dole spoke at a convention of the National Association of Counties, which is meeting in Washington at the same time the nation's governors are holding their annual winter conference. As Dole spoke, the governors were taking their case directly to President Reagan at the White House.

Dole generally endorsed the governors' approach to the budget, saying cuts should be applied across the board and not concentrated on the most vulnerable areas, particularly aid to state and local governments and the country's needy.

He also said the so-called "untouchable" portions of the budget should be faced up to by Congress.

Besides Reagan, the governors were also taking their case for better federal management to Federal Reserve Board Chief Paul Volcker.

Certain to come up in both meetings was the governors' effort to gain a voice in the overall design of the federal budget, including demands for less defense spending and more taxes if necessary to restrain booming deficits.

A resolution for the first time injecting governors into the debate over national budget decisions was approved by the executive committee Sunday with one dissenting vote, despite doubts expressed by all sides.

Some Republicans were concerned that the resolution might be seen as an attack on the president. But Democrats said it should be tougher. And some govern-

nors said they had no business dictating to Washington on such things as defense spending.

In the end, seven members of the executive committee voted for it with only Gov. Joseph E. Brennan, a Maine Democrat, dissenting. And even Brennan said he saw some merit in its assault on federal deficits.

The resolution, a blueprint for a national budget and national recovery, called for action to hold any deficit to 2 percent of the gross national product.

To achieve this, they would allow slight additional cuts in domestic programs cut over the past two years, and they would absorb one-fourth of the impact of inflation on their own federal grants.

But they would hold growth in defense spending to 4 to 6 percent over the next two years and 3 to 5 percent over the entire 1984-88 span. They also want more restraints on the so-called untouchable parts of the budget, including government funded pension programs.

The package goes before the full conference in the closing general business session on Tuesday, where it will require the vote of two-thirds of the governors present to carry.

Gov. Scott Matheson, a Utah Democrat and chairman of the association, predicted it would be approved, but only after some changes.

"We've got to fiddle enough with it to get some Democratic votes," Matheson said. "But I think we have a good chance of resolving it with the Democratic governors."

If Matheson's Democrats can be held in line, the measure would be assured of passage, since Democratic governors outnumber Republicans by 34 to 16 following last fall's election sweep.

Persian Gulf oil states may act on their own

KUWAIT (AP) — A top government official warned today that Arab Persian Gulf states will act to preserve their own interests if OPEC fails to agree on price and production levels.

"The gulf oil exporters will have to act in such a fashion that enables them to retain a reasonable production level and revenues because we mainly depend on oil as a source of income," Minister of State for Cabinet Affairs Abdul Aziz Hussein said after a Cabinet meeting.

The statement came one day after another high Kuwaiti official predicted oil prices could drop to \$20 a barrel unless the Organization of Petroleum Exporting Countries acts to reduce its \$34 base price by at least

\$3. The shrinking oil market and recent price cuts by Nigerian and North Sea oil producers have destroyed OPEC's grip on world petroleum prices and threaten to plunge its 13 members into a free-for-all to sell their oil.

In Paris, officials of the Kuwaiti, Algerian and Venezuelan embassies declined comment on whether oil ministers from their countries would meet in the French capital to discuss how to avert a price war. All three ministers were due in Paris later today.

On Sunday, the head of the Kuwait Parliament's Economic and Financial Affairs Committee was quoted as saying OPEC's official price for oil is

"mistaken and unsound." "If we are now hesitating to slash our prices by \$3 to \$4 a barrel, I am afraid a day which is not too far will come when we will be obliged to cut prices to as low as \$20 per barrel," the newspaper Al-Watan quoted Jassem al-Khorafi as saying.

The newspaper quoted him as saying current prices are unrealistic because of a sharp drop in demand for oil by industrialized countries and the success of consumer nations in promoting energy conservation.

He criticized the Arab nations on the Persian Gulf for "leniency toward OPEC outlaws who have been trying to further the interests of their countries through violation of OPEC's prices and production

quotas." Al-Khorafi said the gulf states, expected to meet soon in Geneva or Vienna with other OPEC members, "will make their own moves and would not be defeated in a price war that is imposed on us."

The oil minister of the United Arab Emirates, Mana Saeed Oteiba, has warned that an all-out price war could begin "within a week," unless OPEC cuts its benchmark price to at least \$30 to compete with Nigeria and North Sea producers who slashed their prices two weeks ago.

The Arab states on the gulf produce a little more than 7 million barrels of oil daily, about half of OPEC's production ceiling, and about one-fifth of global output.

English and Hollywood royalty meet at gala

LOS ANGELES (AP) — The royalty of England and Hollywood got together at a gala dinner honoring Queen Elizabeth II on the second night of her 10-day, first-ever visit to California.

The queen and Prince Philip could see stars all over 20th Century-Fox's glittering Stage 9, until a few weeks ago the bleak tent city of television's "M-A-S-H."

Dinner at the studio capped a busy Sunday for the royal couple that began with services at a packed church in San Diego and included lunch at the ex-

clusive estate of former U.S. ambassador to Britain Walter Annenberg near Palm Springs and a brief ceremony with local political leaders in Long Beach.

The queen and prince, who opened their tour of California on Saturday with a festive welcome in San Diego, braved a steady downpour on their arrival in Air Force II in Palm Springs and small-but-vocal demonstrations at several stops on their tightly scheduled itinerary.

The queen was greeted by first lady Nancy Reagan

at 20th Century-Fox, where the former Nancy Davis appeared in films with now president and then actor Ronald Reagan.

Movie stars from the Reagans' film days joined British entertainers and prominent show-business Republicans such as Charlton Heston and former U.S. Sen. George Murphy on a stage converted by designer Walter Scott into a garden lighted by scores of white paper globes.

Frank Sinatra produced the show which included

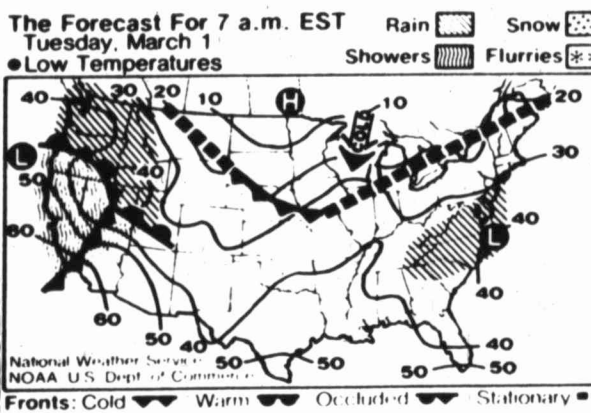
George Burns, Perry Como, Dionne Warwick, Les Brown's band and Sinatra himself.

The 87-year-old Burns cracked a faintly risqué joke which seemed to amuse the queen.

"Acting is easy," Burns said. "If the director wants me to cry, I think of my sex life. If the director wants me to laugh, I think of my sex life."

"I'm glad I came, it was an evening to remember," Julie Andrews quoted the queen as saying.

Skies were fair in the Northeast early today while rain fell along sections of the Gulf and Pacific Coasts.

Snow was scattered over the northern and central Rockies while light snow and freezing drizzle was reported in the Northern Plains.

An intense storm system centered in the Gulf of Mexico kicked up seas of nine feet or more Sunday around the Florida Peninsula. The storm system was moving northeasterly at 15 mph early today, meaning North Florida was in for more heavy rain, the National Weather Service said.

Former Green Beret surrenders in Thailand

NAKHON PHANOM, Thailand (AP) — James "Bo" Gritz, a former Green Beret who led a raid into Laos last fall in search of U.S. prisoners of war, surrendered today and Thai police tried to learn whether he had staged a second rescue mission.

Authorities said Gritz, wearing sunglasses and a red T-shirt, walked into the police station at this Thai-Lao border town and gave himself up. Police Lt. Col. Thalerngsak Sukonthaman said Gritz would be jailed after questioning.

"I got in about 3 a.m. after a very long walk," Gritz said at the police station. "I just want to collect my thoughts," he said, refusing to say whether he had staged another foray into Laos.

Gritz told The Associated Press in a telephone interview that he was being kept under guard at the police station but that the police chief had not put him behind bars with "common criminals" out of consideration for his past

record as a law-abiding man and a soldier.

In an interview broadcast on CBS radio this morning, Gritz said he was sure "more than 10" Americans still were being held captive in Southeast Asia.

"In the last 30 days, I have found that there are Americans alive and in captivity in communist Asia," said Gritz, who indicated he would return to the United States if expelled from Thailand. He did not say where he believed Americans were being held, or where he got his information.

Gritz, 44, of Westchester, Calif., was charged with illegal possession of a high-powered radio transmitter, which carries a maximum penalty of five years in prison.

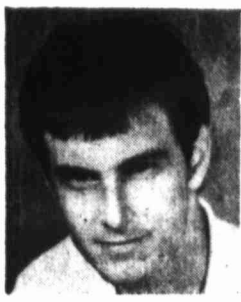

Here's 'the best of the story'

Dear Editor,

It is very interesting to read the editorial page of the paper and many times the news on this page is remembered as long as those items appearing on the front page. The comments of the readers many times bring our attention to news items with a different slant from what is read on the front page.

It would be very appropriate to do as one national commentator on another news media headlines some of his news reports with "The rest of the story," to do the same thing here.

As the bank robber of our bank being robbed in 1964 was Higinito Solo, some interesting things happened not reported in the paper. Solo was as your paper stated a very small man with albino eyes that danced uncontrollably and he had very poor eyesight. He was very quiet, possibly an introvert type of individual.

Each Sunday afternoon the Gideons had a service and share time in the county jail. Their mission has nothing to do with any crime that the men have been accused, but rather is a mission of sharing the Bible with people in need. Some accept this time of sharing, have some life changing experiences, while just as outside the jail, some reject that which is presented to them.

Soto didn't have any interest the first few weeks, but after trying to escape from having been carried to a dentist with a toothache, he was placed in stricter confinement for a few days. After this time, he was much more concerned about what was being presented to him. He accepted the Lord into his life and became a Christian.

Even though it was very difficult for him to read the Bible with poor eyesight, he studied continuously, memorized scripture, and had questions each week. He felt that the Lord was calling him to teach and as much as possible during the week he was teaching the prisoners here and others that came into the jail. He felt that he was due the punishment that he was given as a sentence and did not desire to evade this in any way. He was actually glad that these circumstances had come across his life if it was what it took for him to get to a place where he would know the Lord.

This is brought out in letters which he wrote back on prison stationery from Huntsville Prison. The following is a copy of one of his letters, among many that he wrote.

Dear Christian brothers,
Brother, I write to tell you how grateful I feel for your help that you brought to me in preaching to me the wonderful Jesus. May this encourage you to continue visiting the

perishing souls and bringing the bread of Eternal Life before them that they may not die.

As for me, ever since I came here I have been a ball of fire for the Lord. The Lord called me to teach the Word two weeks after I came to the institution. With the cooperation, with the rehabilitation plan and the help of the units Sunday School Dept. and by the Grace of God, I am respected by friends and brothers, and well-liked by everyone I come in contact with.

The Lord is with me in everything I do, studying the Bible is my delight. Much prayer for all testifying. I live an everyday Christian life knowing that "all things work together for good to them that love the Lord." I remember John 14:1-6. Truly He is the way, the truth, and the life to me.

A man from my class was converted. I am happy about that. That soul is worth my time here and what would a man give in exchange for his soul? This is one of the greatest satisfactions in being a Christian. Well, the Lord supplies all our needs. How many times we want what we don't need, but if we let the Lord be our Shepherd, we can trustfully say I shall not want.

Truly I am, I don't have what I wanted, but what God wanted that I should have. Brother, what a lesson the Lord has taught me.

Sometimes God has to break us to remake us. He makes us lay on our back that we should look up. I thank God because He stopped me in time. Brother, I have the word of God on which I stand as the only fount of knowledge, wisdom, health and salvation. 1 Cor. 13:11, but Romans 12:1,2 are my best verses. I am now using Phil. 3:13 for so is the will of God.

God bless you and keep you working in a blessed ministry.

Even though he was imprisoned rightly from his deeds against society, through this he actually became free from living a life without Jesus by his stay in the county jail. Thyroiditis causes vary

DEAR DR. DONOHUE: Can you tell me the different causes for thyroiditis? Can it come from a virus infection? Is a bacterial infection a common cause? I have had thyroiditis for a year now. Is it considered chronic after that time? I get a sore throat after eating some foods, and feel pressure in my neck. I am confused by the various kinds of thyroiditis spoken of. Can you enlighten me? — E.R.

This is for you and also for G.K., who writes in much the same vein. It can be confusing.

Briefly, there are four different inflammatory conditions of the thyroid gland — thyroiditis. I'd like to more or less limit this discussion to the two most common types. One is de Quervain's thyroiditis, which is thought to result from a viral infection. It usually occurs after a cold or viral sore throat. The person becomes sluggish, and there is persistent pain in the lower neck or along the jaw and ear area. The lower neck is tender to the touch. Of course, this is the area where the gland is located.

The rest of the story follows the lines of many other viral infections. Aspirin, when it can be used, is the standard treatment; and the inflammation eventually subsides as the virus runs its course.

The second most common form of thyroiditis is

Hashimoto's. That is a chronic process that can last many months. The cause of it is the body's production of antibodies against the thyroid tissue. This most often affects middle-aged women. A goiter appears, and eventually there is lessening or complete interruption of thyroid hormone production in the gland. Thyroid hormone medicine is given.

The third and fourth kinds of thyroiditis are not very common. One is from a bacterial infection, and that is treated with antibiotics. The other is Riedel's thyroiditis, and it leads to dense scarring of gland tissue.

I can sympathize with your swallowing discomfort. That indicates the inflammation is still there. But with your medicines, that should subside in time. Yes, one year is long enough to place you, E.R., in the chronic category.

DEAR DR. DONOHUE: My husband's problem has been diagnosed as Peyronie's disease. What do you know of this? And are there any recent findings or new help for this situation. Don't use my real initials, please! — Mrs. R.R.

There are your new initials. Peyronie's disease is the deposition of tough flat scar tissue within the body of the penis. The deposits cause an abnormal curvature. When the process is extreme, there can be pain upon intercourse.

The cause is yet unknown, but the disease usually runs a two- or three-year course, resulting in minimal curvature and resumption of ability to have sexual relations. Many treatments have been tried to stop the process, and I know of no really new ones. Vitamin E, anti-inflammatory drugs, mptaba, steroids and ultrasound have all been suggested and tried. In severe cases, surgical procedures have been used to remove the scar deposits.

Your thyroid plays a critical health role — in everything from eyesight to fertility. The booklet "Your Thyroid: How It Works for You" explains this important and misunderstood gland. Lions discuss Rainbow Project

Child abuse has reached epidemic proportions in the United States and Big Spring has its share of it, the Rev. Victor Sedinger, First Christian Church, told members of the Downtown Lions Club Wednesday.

He told the group of plans by the Howard County Ministerial Fellowship to sponsor a child abuse shelter — the Rainbow Project. It is located in the former Firehouse 6 near

the old Webb Air Force Base entrance. He said numerous individuals and firms have donated work and materials toward rehabilitating the structure leased from the city.

Sedinger said the center is of top priority because at present only the most urgent cases can be cared for by referral to Odessa. There will be dormitory space for boys and girls, for infants, plus those for

parents in residence, living and lounge quarters, etc.

He said in the future it is hoped to add counseling services and parenting workshops.

He told the group that at the current rate it may not be many years before child abuse passes cancer and congenital defects as the leading killer of children. He cited cases of neglect and abuse as well as deaths resulting from abuse.

Many individuals, institutions and churches have rallied to the support of the Rainbow Project, he said, but it will take a tremendous outpouring to raise the \$60,000 budget. "Some say that may not be enough," he added.

Several churches have included or will include it in their budgets. Some have taken special offerings and others will have a special Sunday to focus attention on the need.

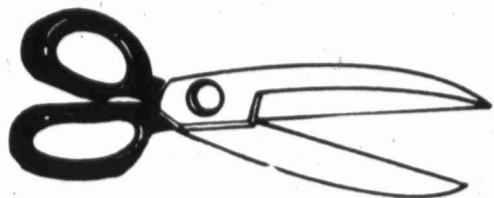

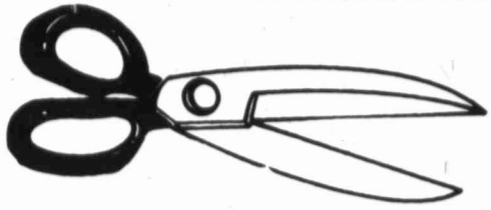

Simmons: USFL not waging 'war' against NFL teams

ORLANDO, Fla. (AP) — Chet Simmons, commissioner of the United States Football League, says his fledgling league's signing of Herschel Walker and some other top college players does not mean a declaration of war against the established National Football League.

Rankin Smith Jr., owner of the NFL's Atlanta Falcons, had called the signing of Walker by the New Jersey Generals the start of a war.

"What are they worrying about — because we've signed some of the players they wanted?" Simmons said Sunday. "We've done very nicely, but if this were war we'd have (Stanford quarterback) John Elway and (Illinois quarterback) Tony Eason locked up in a hotel room somewhere."

Among the outstanding college players signed by USFL teams are All American wide receiver Anthony Carter of Michigan, running backs Tim Spencer of Ohio State, Kelvin Bryant of North Carolina and Craig James of

SMU, quarterbacks Tom Ramsey of UCLA and Reggie Collier of Southern Mississippi, and Ohio State linebacker Marcus Marek.

Simmons said he approved the contract between the Generals and Walker because three legal briefs indicated a policy against signing underclassmen would not have held up in court.

He said that if the former Georgia star had taken the USFL to court and won, it would have opened the door for every underclassman to challenge the rule.

"Jack Manton (Walker's agent) presented us with a legal brief, and we had two of our own," Simmons explained. "All said it was fruitless to try to defend our eligibility rule. No one ever put a fist on the table and said, 'We're going to sue you,' but a lawsuit was always implied."

"If there was a challenge to our eligibility rule and we tried to defend it and lost, there would have been a court

Region V schedule complete

The table is set for the 1982 Region V Women's Junior College Tournament. All that's needed now for the Howard College Hawk Queens is to play the part of the rude host.

The Queens open the annual event Wednesday at 6 p.m. against Grayson College and must win four tournament games to defend the Region V title they won last year against McLennan Community College.

The Howard-Grayson matchup is one of two "pre-tournament" games scheduled Wednesday. Clarendon and Weatherford tangle at 8 p.m. The winners gain Thursday's quarterfinals with McLennan meeting the Weatherford-Clarendon survivor and Western Texas meeting the Howard-Grayson winner.

In other Thursday games, Odessa College meets Cooke Co. at 2 p.m. while Amarillo tackles Cisco at 4

p.m. Semifinal games are scheduled at 6 and 8 p.m. Friday with the Region V championship game to be played at 7 p.m. Saturday.

The Queens face a tougher tournament task than last winter. Howard won the Western Junior College Athletic Conference and thus an opening-night bye. This time around, the Queens enter the tournament as the fourth place team from the WJCAC, going 19-9 on the regular season and an even 6-6 mark in league play.

Western Texas, with the league's top offense and free throw shooting team, won the WJCAC title with a 11-1 record. McLennan is the top team from the Northern Junior College Athletic Conference and the highest nationally-ranked squad in the tournament, rated No. 15 with a 23-5 mark.

Howard, however, owns two wins over the High Lassies this year.

Hawk Queen Nell Haskins enters the tournament battling Mary Jo

Vodenichar of Penn St. University at Sharon, Pa. for the top scoring honors in the nation. Haskins scored 32 and 31 points in her last two outings hoping to improve on a 29.0 average. Vodenichar had a 29.1 average in the latest NJCAA stats, both players in 24 games.

The Queens were hampered by the forfeiture of four games because of an ineligible player. Two of those four wins were conference wins which prevented a better draw in the tournament. With the fours, the Queens would stand 23-5 on the year.

Two losses were to Western Texas, by one point in Big Spring and two in Snyder. Howard also lost to Amarillo, reversing that defeat in Amarillo, and split two games with Odessa.

The winner of this tournament goes into a bi-region playoff game with that winner advancing to the national tournament, to be played this year in Senatobia, Miss.

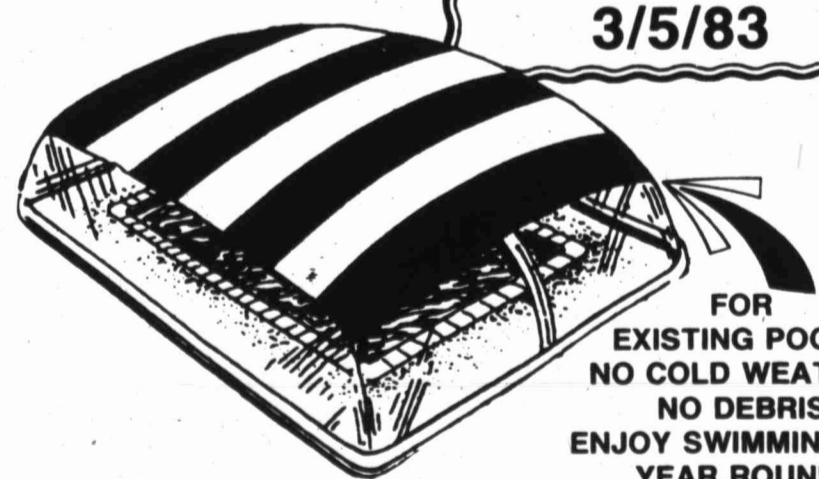
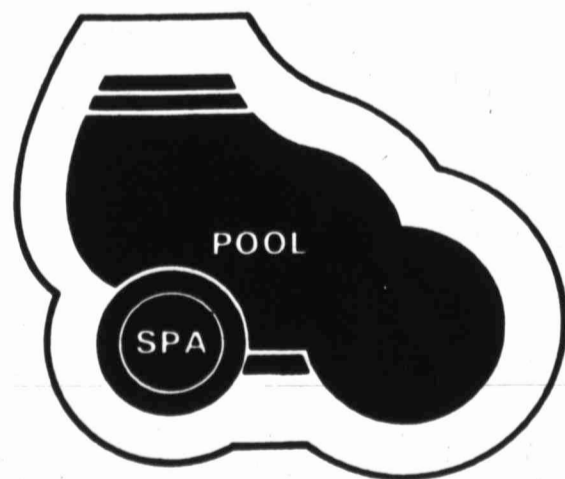

Rugby star an amateur despite negotiations

PRETORIA, South Africa (AP) — South African rugby star Naas Botha was declared innocent Monday of violating his amateur status by negotiating with the Dallas Cowboys of the National Football League.

After a two-hour hearing, the disciplinary committee of the Northern Transvaal Rugby Union lifted Botha's temporary suspension from amateur rugby imposed last week after news of his talks with the Cowboys broke.

The union said it had found no reference to U.S. football in the International Rugby Board regulations barring professionalism, and that Botha would not disqualify himself from South African rugby by playing the American professional sport.

Botha, a 25-year-old flyhalf considered

one of the best kickers in South African amateur rugby history, has been invited to a free-agent Cowboys' tryout on May 21, a Dallas team official said.

Botha walked out of the hearing room with a broad grin, and said he would resume training immediately with his club, Police. He declined any comment on the reported negotiations with the Dallas football team.

The story prompted front-page headlines across South Africa, with papers claiming Botha already had been offered a contract worth 240,000 rand (\$230,000) over three years.

A Cowboys' team spokesman was cautious about Botha's prospects of making the team but confirmed he had been invited to a tryout so the team could look at his place-kicking ability.

NCAA declared not guilty of violating anti-trust law

WASHINGTON (AP) — The National Collegiate Athletic Association did not commit antitrust violations when it established women's championships in 1981-82 and put a women's athletic group out of business, a judge ruled Monday.

U.S. District Judge Thomas P. Jackson, in a 46-page opinion, said legal competition rather than illegal monopolistic practices caused the demise of the Association for Intercollegiate Athletics for Women.

Jackson said the AIAW, which ceased operations last June, failed to prove in a trial last year "the specific intent necessary to sustain its claim of attempted monopoly" under the Sherman Act.

The judge noted that the NCAA's decision to establish the women's championships caused schools to defect from the

women's athletic group to the 77-year-old NCAA, the dominant organization of men's college sports.

Jackson concluded that the trial evidence demonstrates that "if present trends continue ... the NCAA will in the foreseeable future exert an influence in the women's market comparable to that it presently possesses in the men's ..."

However, the judge added, the NCAA women's program "originated with its members rather than its leaders and took shape in public view over more than a year. The process by which it actually came into being is the antithesis of the conspiratorial plotting of a would-be monopolist to acquire surreptitious control of a market to control prices or destroy competition."

decision striking down the rule and we would have had no defense against it.

"By making Walker an exception, the rule is still in effect and at least we have that to deal with if a kid comes along and wants to sign before he completes his eligibility. If you lose a court suit, then you face the whole world at your doorstep. I don't think a wholesale exodus from college would do any of us any good and I have no interest of encouraging any of our teams to do this."

Simmons said he "had trouble" with the signing of Walker "on a personal issue" because he had supported the USFL rule against early signings. "I honestly said it and believed it," he said.

Simmons said he changed his mind in the Walker case on advice from USFL counsel Steve Ehrhart and other lawyers.

"The exception for Herschel Walker was based on his ability, maturity and accomplishments," he said. "I've disapproved more than 200 contracts for players who have dropped out of school and wanted to play in our league, but whose class hasn't graduated."

Simmons said he thought the USFL "overwhelmingly gained credibility" by signing Walker. "On the whole question of signing a player with college eligibility remaining, the backlash may be injurious at some point, but in the long run

the whole league will benefit."

Simmons denied reports that all USFL teams had considered about chipping in to help pay Walker's contract, the largest in football history at an estimated \$5 million over three years. He also said the Generals would forfeit their first-round pick in the next draft as a result of the signing.

With the start of the USFL's inaugural season on tap next weekend, Simmons said the league has a much better chance for success than the extinct World Football League of the 1970s.

"First is the resources of our owners," he said. "You won't find players not getting paid and laundry bills not getting paid. Each club has posted \$1.5 million, giving the league a fund of \$18 million which I can call on in case of problems. Secondly, we have a TV contract (ABC and ESPN). The money is important, but the exposure is vital. Three games a week will be on television. Thirdly, we're in major cities and every franchise has a major stadium except Boston."

Simmons was asked if he had any apprehensions as the USFL prepared to give the nation's football fanatics a spring season.

"Will the fans come out, sample it and come back?" he said. "Most importantly, will everyone remember to bring the footballs next Sunday?"

Walker scandal raises questions

Besides the obvious questions of ethics and tactics involved in the tawdry Herschel Walker scam, two other matters must be addressed.

First of all, at his "Welcome to the USFL" news conference, Walker was asked if he knew that simply by negotiating with the New Jersey Generals, he was endangering his remaining collegiate eligibility.

"I reckon I've been ineligible since my freshman year or even before I went to school," he announced. "There were a lot of pro teams that talked with me before I went to school."

Well, Herschel is a bit off target on that one. Unless he had an agent negotiating his worth with a pro team, any conversations he had in those days probably were within NCAA guidelines.

That piece of information comes from Dave Berst, who handles enforcement for the NCAA and has had his fill of L'affaire Walker in the last week or so.

"It has to be an agent negotiating in your behalf," Berst said. "That's what renders you ineligible."

So ostensibly, if Walker did his own talking, there would be no problem, provided he had not signed.

"Well, you wonder if a young man is in position to do it," said Berst.

The semantics here are interesting. The NCAA has no problem with an agent talking to a pro team to find out a player's worth. It's when the agent starts negotiating the worth that the trouble starts.

Would it surprise you if some agents, in the course of determining worth, happened to negotiate, too?

Oh, no, that would never happen, would it?

Then there is the matter of Walker picking his team. He decided on the New Jersey Generals without benefit of anything so rudimentary as a draft which assigned his rights to that team.

Now sitting out at Stanford University is a young man named John Elway who, apparently, is the quintessential college quarterback. Elway has completed his four years of eligibility and will play either professional baseball or football after he graduates. His baseball rights belong to the New York Yankees, selected by that club in the draft. His National Football League rights will be assigned at that league's draft in April.

There are serious questions about how legitimate the drafts are but the fact remains that baseball and football have been operating this way for a long time. And so has basketball. The system provides an important service by assigning player rights to a single team and thus preventing a bidding war for talent. And the unions, militant enough to call player strikes in baseball and football and threaten one in basketball, have accepted it.

So most players are stuck — like it or not. Darrin Nelson, another Stanford student and one of the plums in last year's NFL draft, told the Minnesota Vikings that he simply was not interested in playing in tundra land — domed stadium notwithstanding. The Vikings ignored his position and drafted him. And because Darrin Nelson wanted to play in the NFL, he packed up some extra sweaters and a pair of galoshes and headed for the north country.

Herschel Walker was not faced with all of this but that, we have been told, was because he was a special case.
