

Four County Schools to Begin Terms

Four schools have announced terms to begin either August 6 or 13, superintendents have announced.

Supt. Herman Moseley recently announced plans for the opening at Quail Monday, September 13. This week he again reminded parents of children starting to school for the first time that they should have a certified copy of the child's birth certificate.

Booker T. Washington School in Wellington will open Monday, August 13, and operate until there is enough cotton pulling for classes to dismiss, Velman Warrick, president of the school board said.

DODSON

The Dodson school will open Monday morning, August 6, and continue until cotton opens in sufficient quantity for students to help with the harvesting, Supt. T. E. Lennon has announced.

The school faculty is complete and includes Mr. and Mrs. Lennon, Mrs. Bynum Hightower, Ted Parker, Miss Wilma Hightower, Mrs. Floyd Roberts and Kenneth McClelland. The latter is the only new faculty member.

SAMNORWOOD

The Samnorwood school will begin Monday, August 13, for the summer term. Orville Cunningham, superintendent, announced this week.

One teacher is still needed, to be placed in either the second or third grades. She will replace Mrs. Maude Brown, who resigned to accept a place in the Shamrock schools.

Mr. Cunningham also announced a faculty meeting for Saturday, August 11, at 10 a. m.

A short assembly program will be held on the opening morning at 9 a. m. This is of a get-acquainted nature, and all parents are invited to attend, the superintendent said.

Rainey O'Hair, McIlhany, Hite Bratten Win; Two Run-off Races

Collingsworth county voters in the Democratic primary Saturday, July 28, re-elected Sheriff John Rainey in the only county office at stake, then gave Buddy Forbis, who grew up here, the lead in the close district attorney's race over Allen Harp, incumbent, and Paul Spillman.

County voters also approved Representative Grainger McIlhany by a 2 - 1 vote over Johnny Wills.

Bruce Hite, running for re-election as constable of Precinct 1, led a field of three and Pat O'Hair also won over two opponents in seeking another term as commissioner of precinct 3. Both received majorities large enough that there will be no run-off.

Jack Brewer, the incumbent, led a field of four in the race for commissioner of Precinct 1. Drury Lacy was second followed by Earl Harrison and Mike Burkhalter. There will be a run-off in this race.

County Attorney Denzil Bevers, running for re-election, was the only county or precinct candidate without opposition.

L. B. Bratten won over Dick Sweat, who was seeking re-election as county Democratic Chairman.

There was only 25 votes difference in the top three candidates for governor, with Price Daniel leading with 658, Ralph Yarborough was second, 13 votes less than Daniel, 645, while Lee O'Daniel was 12 votes behind Yarborough.

Approval was given the three referendum proposals, (school integration, intermarriage, and interposition), by big majorities, but around 500 voters did not express a preference one way or another on the issues.

The largest number of votes cast was in the sheriff's race, with 2253 polled. The governor's race was second with 2209 votes and the district attorney's race was just one vote behind, 2208.

In races with only one candidate, voting dropped, with Judge Luther Gribble receiving the largest number, 1528, about 700 below the votes polled in the closely contested races.

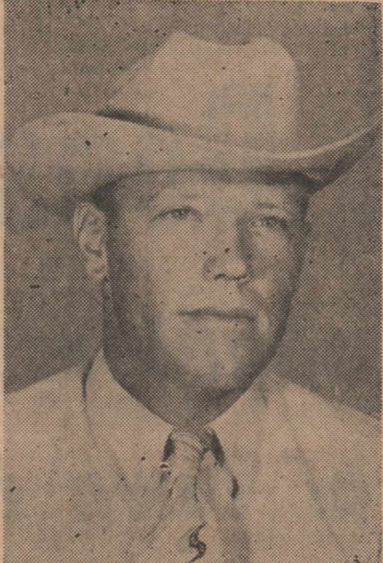

Wes Scruggs Here On Visit From Saudi Arabia

Wes (Bud) Suggs, an optometrist in the hospital maintained by Aramco Oil Company in Dhahran, Saudi Arabia, was here with his eight-year-old son, George, recently to visit his parents, Mr. and Mrs. G. N. Scruggs and other relatives.

Mrs. Scruggs and their small daughter, Kelly, went on to their former home, Torrance, California, to visit members of her family.

Traveling by air, they made a leisurely trip from Dhahran to the United States. First they stopped in the Holy Land for two weeks, centering their tour around Jerusalem.

A highlight was their seeing the famous Scrolls from the Dead Sea, found only a few years ago, and when translation is completed, it is believed they will give much information on Biblical happenings. Scruggs was able to photograph these.

The family was in Denmark a month, visiting relatives of Mrs. Scruggs. They also met her mother, Mrs. Baye, who had come from California. More slides taken by them showed Copenhagen's famous gardens and buildings.

Gifts to the family have included interesting and unusual items, and to Mr. and Mrs. Scruggs he brought a hand-made Arabian coffee set of hammered brass. There also are spear heads picked up at the edge of No Man's Land—the unoccupied strip along the Israeli-Jordan border.

Scruggs plans to fly back to Arabia August 23. Mrs. Scruggs and the children will remain in the United States about three months and later they, too, will be in

Wellington to visit.

Other relatives here are Scruggs three sisters, Mrs. Lowell Wells, Mrs. John Holton and Mrs. Herby Duncan. They were joined here by another sister, Mrs. Mildred Starr and daughters, Mary John of Amarillo and Mrs. Richard Hall of Pampa.

Mr. Love passed away in December 1935.

School Contract Goes to Singleton for \$200,800

The contract for constructing Wellington's new high school gymnasium and cafeteria has been let to Neil Singleton Construction Company of Amarillo, Velman Warrick, president of the school board, announced Wednesday morning, August 1.

The amount of the contract is \$200,800. This is for buildings only, Warrick explained. It does not include equipment for either the gymnasium or cafeteria, and contracts for this will be let later,

possibly 60 to 90 days. This was a negotiated contract, Warrick said. After the original contracts were submitted, the school board found it would have to cut down somewhere to get within the money it had available.

Neil Singleton Construction Company had submitted the original low bid of \$218,750.

There were 9 bidders, the highest submitting a bid of \$261,432.

Sub-contracts for wiring and plumbing will be announced within a few days.

Mr. Singleton left contracts here late Tuesday, and these will probably be signed Wednesday, Warrick said.

Construction is to begin immediately, and Mr. Singleton said he hopes to finish the gymnasium and cafeteria by January 15.

"This is plenty of time if we have the weather during the fall that we usually have," Warrick pointed out.

Another former county man, Bobby Bullington, works at the McKee plant, but he and his family were reported visiting in Wellington Sunday.

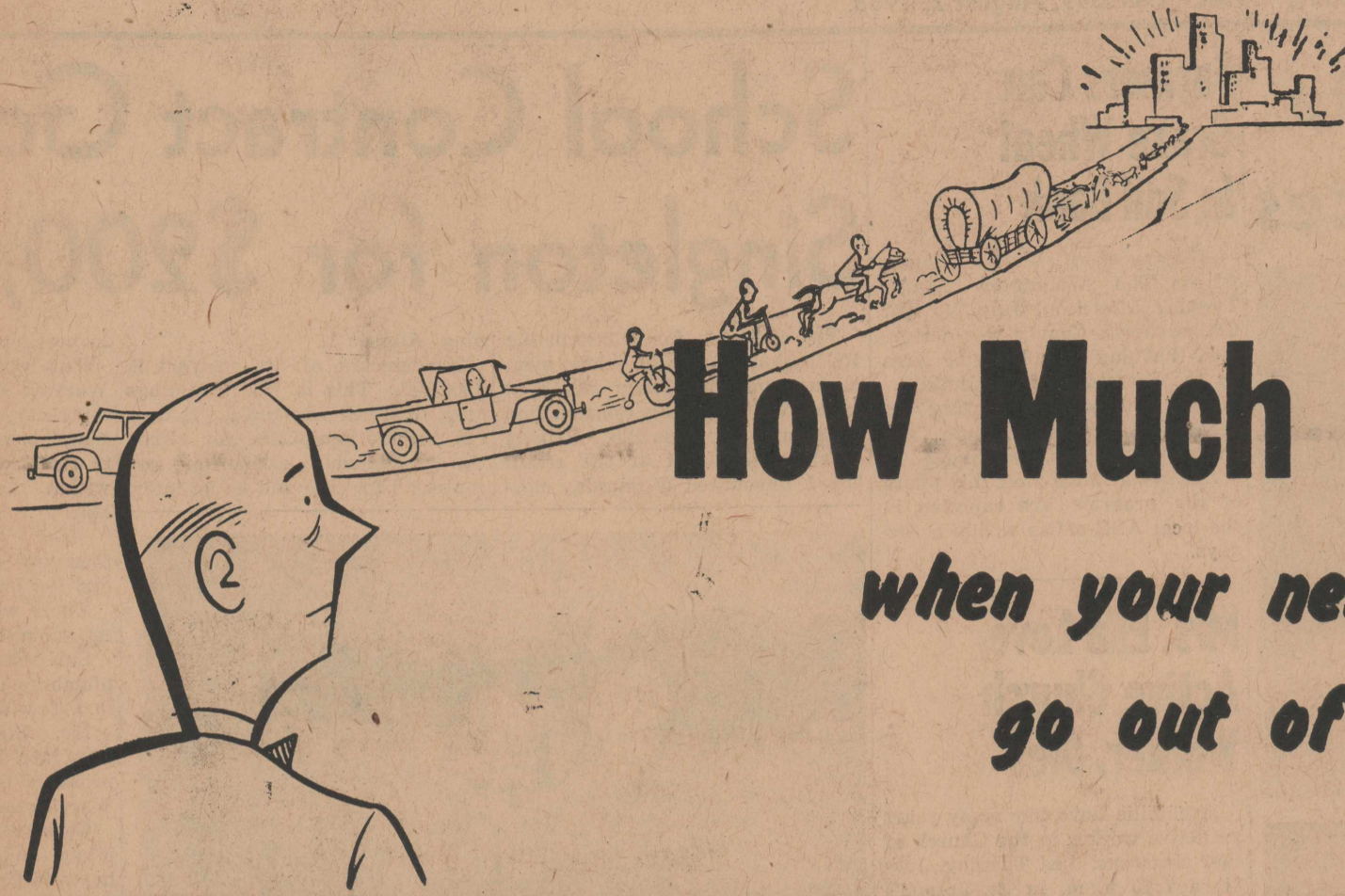
243 Soil Bank Agreements Signed In Collingsworth

Two hundred and forty-three agreements have been signed for participation in the Soil Bank program, Millard Brown, ASC secretary reported, as the July 27 deadline was passed.

This covers 9,404.7 acres and owners and operators will draw \$65,685.04 for withdrawing this land from cultivation this year.

There were 175 wheat agreements, covering 8,298 acres, bringing \$47,821.00; cotton agreements on 1,099.9 acres, which will draw \$17,810.18; and one lone peanut agreement on 6.8 acres, which will bring the farmer \$59.86.

The Skyrocks showed up extremely well against the allegedly undefeated Irish team, but were unable to score a victory under the circumstances which were apparent in Friday's game.

Coach Carl M. Anderson of the Skyrocket team, together with several other Wellington citizens, made a trip to Pampa Saturday to file protests to district Chairman. Protests were made for more than one reason, and Superintendent John A. Webb of the Wellington High School is of the opinion that the game will be played again, in view of the facts which were laid before the district chairman in regard to the way this game was handled and played.

Wellington's entire squad played an offensive game during the last two periods which might have netted them at least two more touchdowns. Bill Leggett, quarterback for Wellington, played the best game of any individual on the field, bordering on the spectacular all through the play. Leggett gained 68 yards during the game, and his prowess as a field general was practically perfect.

principals, Mrs. Lee O'Neil and Miss Katie Boverie.

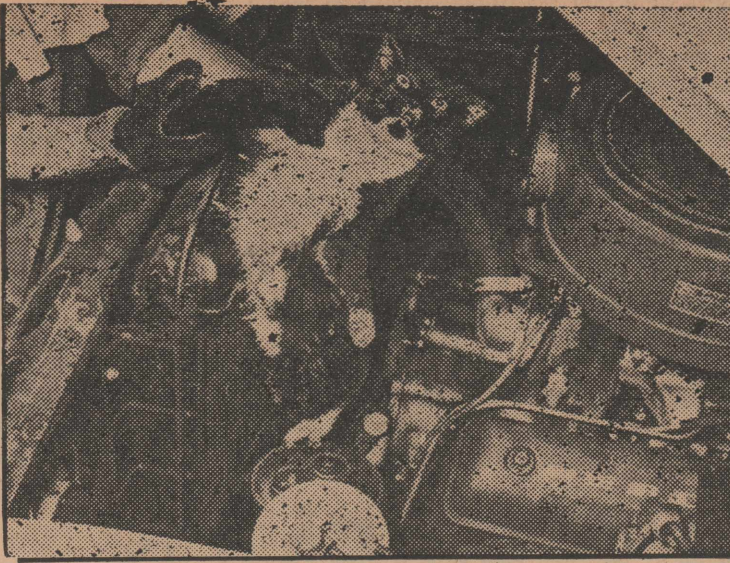

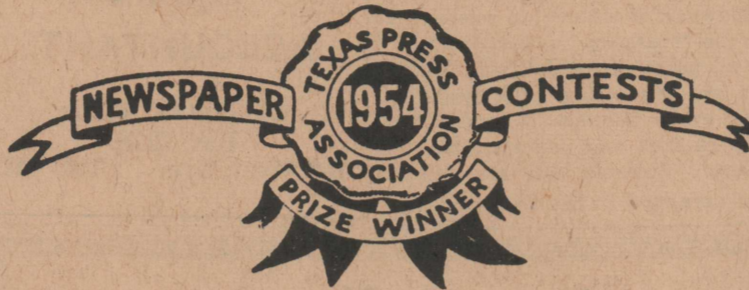

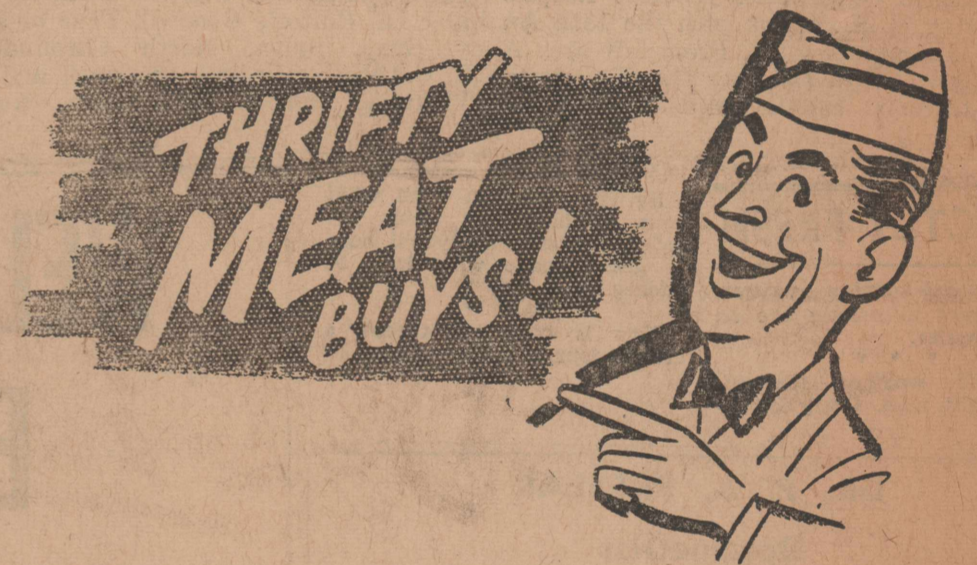

Texas Takes A Look At Ontario

This is another of a series of articles concerning Deskins Wells recent trip to the Province of Ontario.

Seventh Day

LAKE OF BAYS LULLABY

Just ruffling through notes on a rainy day ... Blair Rice of Martinsburg, Pennsylvania and Ken McClain of Parsons, West Virginia were "thank-you" boys yesterday as they expressed our gratitude for the wonderful hospitality encountered at Gravenhurst and this hotel ... non resident fishing licenses for entire season in Ontario costs \$6.50 ... non-residents 17 years old and over must buy a license ... under 17 a non-resident may angle, but only when accompanied by a member of his or her family who holds a license ... fish taken by those under 17 must be included in catch of license holder ... there are 250,000 lakes in Ontario ... it is contrary to fishery regulations to hold more than one angler's license in any

year ... all data on Ontario may be obtained free of charge by writing to the Ontario Department of Travel and Publicity, 67 College Street, Toronto 2, Ontario, Canada ... Ontario is divided into 33 vacation areas for the purposes of travel ... and anyone may have a "Where to Stay" list of any three areas ... such information lists resorts, costs, facilities, and so forth, giving complete overall pictures of each and every establishment in the various area.

WEATHER VANE

Our 'bibles', as we call the tour program booklets, had this seventh day slated for golf, fishing, tennis, boat trips and a demonstration of techniques used in fighting forest fires, but rain put a crimp in the program.

Jack Dillon, supervisor of forest fire control for the Ontario Department of Lands and Forests, was kind enough to go through with his part of the program, but wind and weather did not allow much opportunity for a good show of "water bombing" (35 lb. paper bags dropped on the target six

at a time), or enable him to give full use of his water pumps. Still, from what we could see of it, the methods appeared to be quite effective, and if we were in the neighborhood of any forest fires we would be easier in mind to know the Lands and Forests boys were close at hand.

"Beaver" planes, weighing approximately 5,000 lbs., are used in this type of work. They are a type developed in Canada for this specific purpose, and are now popular all over the world; particularly with the U. S. army and forestry services. Cruising speed is about 115 miles per hour, and only a short takeoff is required to get them airborne. Pilots claim that they can get out of any place they land on, and Mr. Dillon claims they are better on wheels than they are on ontoons. Some of our boys, eager to see what they could do, jumped at the chance to go for flips. They enthusiastically endorsed the plane after short hops over land and lakes.

Britannia Hotel is worth a visit. Rooms and other services rate

with the best to be found anywhere. An excellently trained and smart looking staff quickly won the approval of all concerned, and those fortunate enough to have rooms overlooking the lake were treated to a lovely panoramic view.

We are now in the heart of the Muskoka Lakes, some 150 miles northeast of Toronto, and this modern summer resort, built of concrete and steel, on a 440-acre site, complete with a nine-hole golf course, is only one of many fine resorts in the Providence's vacationlands. It is reputed to handle 2,500 guests per season, and has established itself as one of the most popular summer hotels. The huge dining room can handle 350 guests at a sitting. The big 'picture' windows facing the lakes add to the attractiveness of the scene. Plans are now under way to make this into an all-year-around hotel, and we can well imagine that it would be ideal for winter sports when the weather co-operates.

We were told that this land of evergreens and maple becomes a riot of color when Fall rolls around. From September 15th to 30th, autumn colors are in their resplendent loveliness, and this handwork of nature is celebrated by the "Muskoka Color Cavalcade" in all parts of the district. Visitors are increasing each year as this event becomes a 'must' for camera fans, and just plain nature lovers. Suitable side attractions are arranged in the forms of pic-

nics, boat trips, and motor tours, so we were advised.

Tomorrow we leave for Algonquin Provincial Park, Arnprior and Canada's capital, Ottawa.
