MEXICAN BANDITS MURDER FIFTY

Bribe Charges Brought Into Indian Case

DEMOCRATS WANT GREATER TAX SLASH

WOULD HAVE NEW REDUCTIONS SET AT 500 MILLION

G. O. P. SCHEDULE RAISED BY DEMOCRATS; FIRST CUT MUCH LOWER

(By Associated Press.)
WASHINGTON, Jan. 11.—Democrats members of the Senate finance committee put their proposal for a \$500,000,000 cut in the tax burden before the committee today as it began consideration of the rate schedules in the House bill, which provides for a reduction of \$320,000,000.
Simmons Leads Attack.
In addition to the rate reduction provisions of the House measure, Senator Simmons, of North Carolina, ranking democrat on the committee, asked on behalf of the minority members further cuts in the surtax rates on incomes \$22,000 and \$100,000, and repeal of the taxes on capital stock, admission and dues. Approval given by the democrats to the reductions in the normal income tax rates and the increased personal exemptions on income taxes provided by the House measure, virtually assured adoption of these schedules both in the committee and in the Senate since republicans have indicated their support.
The minority also endorsed the reduction in the maximum surtax rate from 46 per cent to 28 per cent. Warned by Secretary Mellon to keep the total reduction within the \$320,000,000 limit provided by the House measure, republicans, with a majority of 19 to 7 in committee, apparently were prepared to combat but minor changes in the bill.
Says Cut Can Be Made.
In announcing the democratic program, Senator Simmons declared the \$500,000,000 annual reduction could be made without retarding the program for retiring the public debt within 32 years.
Instead of meeting the cost of sinking fund for retirement of the debt entirely from taxation, however, he would apply the funds paid on war debts by foreign nations to this fund. These payments are now applied on retirement of the public debt. Senator Simmons said, in addition to the annual sinking fund payments, he estimates the receipts from foreign debtors this year at \$175,000,000.

TWO MEN SHOT TO DEATH BY OHIO POLICEMAN

CLEVELAND, Ohio, Jan. 11. (AP)—Two unidentified men, believed to be bandits, were shot to death early today when they attempted to attack Patrolman Daniel Candow, as he was questioning them in a restaurant.
The men told conflicting stories, including a claim that they were from Chicago, and when Candow started to search them one man drew a revolver. Candow knocked the gun from his hand and put a bullet through the man's chest.
Turning Candow shot the second man twice. He died in a hospital shortly after. The first man, recovering his revolver from the floor, pointing his gun at Candow, again was taking aim at Candow who shot him twice more, killing him instantly.

TEXAS SPECIAL SESSION IS UP

Fredericksburg Solon, Quoted On Road Muddle, Says Need Is Prevalent Now

(By Associated Press.)
AUSTIN, Jan. 11.—A special session to validate Texas road district bonds jeopardized by decision of the United States supreme court in holding invalid a \$300,000 Archer County road bond issue, should be called immediately by Governor Ferguson, Representative Alf. Peters, Fredericksburg, said today.
He declared such action should be taken to prevent impairment of Texas credit in eastern financial circles. Approximately \$2,000,000 in road bonds is involved.
Conference will be held Wednesday by Attorney General Dan Moody and his assistants to determine what will be taken on the bond issue.
C. A. Wheeler, assistant attorney general, said that the wording of the motion for rehearing, which will be filed, will be decided.
For several days the attorney general's department and attorneys representing bonding houses have been studying the opinion of the supreme court rendered last Monday affecting approximately \$2,000,000 worth of bonds in Texas.

Gun Toter Jailed Here Is Released On Bond of \$1,000

D. J. Payne, formerly of this city, but who is now living in Sudan, was released under \$1,000 bond from the county jail here Sunday after his arrest late Saturday night by Joe Cox, City Policeman in the Mexican quarter of the city, on a charge of carrying concealed weapons.
The weapons, however, far from being concealed in a liberal sense, according to the report of policeman Cox, who charged that Payne was making his rounds through the Mexican quarter flashing two big "six-guns" in an effort to terrify residents there.
The accused man was bound over to action of the grand jury which was sworn in by district judge Clark M. Mullaney here Monday morning.

North Africa Has 2-Day Standstorm

TUNIS, North Africa, Jan. 11. (AP)—A cyclone has visited South Tunisia, raising a sand storm which lasted more than two days. Enormous numbers of trees were uprooted, including hundreds of palms in the Gafsa Oasis. Trains have been interrupted, principally between Metlaef and Gafsa. The track being buried under the sand.
A deluge of rain put an end to the sand storm.

EX-MARSHALL IS TIED WITH CASE BY DIRE RUMORS

ALVA McDONALD SAYS HE WILL APPEAR BEFORE GRAND JURORS

(By Associated Press.)
GUTHRIE, Okla., Jan. 11.—Possibility that the United States grand jury, convened here for investigation of the deaths of several Osage Indians in Osage county, will inquire into rumors that a \$10,000 bribe made futile an inquiry into the deaths several months ago, loomed today.
Alva McDonald, former United States Marshall of the western district of Oklahoma, who declared that the bribe rumors were directed at him, said he would appear before the grand jury today and demand that he be heard.
McDonald Denies Charge.
The rumors are that McDonald and another former official divided \$10,000 they received from a Pawhuska attorney at the time of the first investigation. McDonald said. He declared he had given federal investigators valuable assistance and that the other party mentioned in the bribe rumors had never been connected with the Osage inquiry.
Despite the fact that Edwin K. Brown, assistant United States Attorney General, stated Saturday there would be developments in the grand jury investigations that would "startle the nation," only two indictments have been returned thus far.
W. K. Hale, of Fairfax, "King of the Osage Hills," was indicted Saturday afternoon with John Ramsey, a cowboy-farmer. They were charged in connection with the slaying of Henry Roan, an Osage Indian. Hale was named beneficiary of Roan's \$25,000 life insurance policy and is making an effort to collect it in federal court at Tulsa. The insurance company has

MEXICAN GUARD FACES CHARGES

Slays Husband Of Woman Who Hired Him To Guard Her Children For Her

(By Associated Press.)
BROWNSVILLE, Texas, Jan. 11.—Guadalupe Rivera, a guard hired by Mrs. Williams to protect her home here when she learned that her husband, Henry W. Williams, was on his way to Brownsville to get their two young children "if it costs me my life," and who shot and killed Williams was charged with murder, police said today.
Juan Rivera, brother of Guadalupe and who was with the latter at the time of the shooting, will also be charged with murder, according to County Attorney L. Faulk.
Bullet In Stomach.
Williams died in a local hospital at eight o'clock last night, following the shooting at five o'clock in the afternoon. He died immediately after the bullet, which entered his stomach, had been removed.
Mrs. Williams filed suit on September 18 for divorce from her husband, and a short time before Christmas had secured an injunction restraining him from taking their two young children left with them the day this injunction was granted and before it was served.
Mrs. Williams followed him, secured the children at Gorman, Texas, the home of his parents, returned to Brownsville last Thursday and Williams returned yesterday afternoon, arriving here in an automobile with only three tires. Dr. Lawrence Williams, of Waco, brother of the dead man, will arrive here tonight and the body will be shipped to the old family home at Jonesboro for burial.

Nation-Wide Auto Theft Ring Found By Texas Officers

SAN ANTONIO, Jan. 11. (AP)—Information that is expected to lead to organization of a nation-wide automobile stealing group was obtained today by city detectives in questioning a man arrested here for theft of an automobile.
This gigantic swindle directed by a "master mind" in Washington, has had police of the entire United States baffled for more than five years, according to officers.
A man was arrested Friday when he went to a used car company to get final payment on a coupe he had sold them the day before. The owner of the car passing the agency recognized the coupe as one that had been stolen from him and notified the police.
In questioning and searching the man's effects, detectives discovered, they say, that he is the "Texas cog" in the big theft ring.

THEY WRECK AND LOOT TRAIN AND SET FIRE TO IT



Twenty bodies burned past recognition at Guadalupe. Mexican City, Jan. 11.—Fully fifty persons were butchered by the bandits who attacked and wrecked the Guadalupe, Mexico City passenger train near Yucucaro, in the state of Michoacan, Saturday night.
Penniless survivors, stripped of all their belongings, began arriving in Guadalupe last night to tell a tale of horror unequalled in Mexico's criminal annals for years.
No Americans On Train
No foreigners were killed, they believe, and apparently no Americans were on the train, although reports of this point are conflicting. The dead include all the soldiers of the train guard, most of the crew and numerous Mexican passengers.
An unknown number of bandits were engaged. They boarded the train as passengers. When near Yucucaro station they locked the doors of the coaches, slit the throats of the train guards, or shot them as they slept, and systematically knifed or shot the majority of the train crew.
Resistors Are Butchered
They then began robbing the passengers, murdering every one who resisted. The survivors described the scene within the coaches as ghastly, the imprisoned passengers frantically beseeching for mercy, many only to be butchered at the whim of the bandits.
Several foreigners are said to have been in the Pullman car, including the manager of the Guadalupe branch of the Bank of Montreal. These passengers are reported to have escaped injury, although the Pullman was burned along with the other cars when the bandits fled in the locomotive.
The bandits are reported to have obtained 300,000 pesos in booty.
Relief trains bearing military reinforcements, have been sent out from Guadalupe, the officers under order to get the bandits dead or alive.
Officials declare the perpetrators of the massacre must be captured at all costs.

STATE TO MAKE ROAD CONTRACT

Engineers Field And Garrett Return From Conference In Texas Capital

Geo. A. Field, Division engineer for the state highway department with headquarters here, and B. K. Garrett, resident engineer for Lubbock county, attached to the state department, returned here Sunday from Austin to which place they had been called on matters pertaining to highway construction in this part of the state.
While in the capital city the two gained information that state officials plan to let contracts on the Slaton to Lubbock hard surface road project just as soon as an agreement can be reached with the Lubbock county commissioners' court in connection with the recent protest filed by the court with the highway department. The highway commission is ready to proceed with contracts awards any time the court here is ready, Mr. Field said.
Refers To Action Here
He referred to the recent action of the Commissioners Court here in demanding that they have right of supervision over awarding of the contracts, subject to the approval of the state department, and he said that the latter has agreed, as they have always done, that the local court may have representation, either the entire court, or any portion thereof, at the contract awarding, and that they may have a voice in the negotiations.
The state department, however, he said, will not agree to have the contract awarded here, but on this score virtual agreement has already been reached, for according to county Judge Chas. Nordyke, the court merely wants representation when the contracts are awarded, and not to have the contracts awarded here necessarily.
Action on the part of the court in connection with the suggestion of the state department is expected shortly and it is believed that the contracts will be awarded immediately following this.

LUBBOCK COUNTY COMMISSIONERS IN SESSION

The Commissioners Court of Lubbock county went into regular semi-monthly session in the office of county judge Chas. Nordyke here Monday morning, facing a full day's grind of routine matters and several current issues, the most important of which probably is letting of the contract for repainting the inside of the court house and jail building.
The morning and early afternoon was consumed with routine matters pertaining to the court, such as approval of bills of various kinds by the different commissioners.
The court took up the matter of awarding the contract for repainting the building about 3 o'clock, but it was announced that awards probably would not be made until late in the afternoon.
In regard to the highway construction situation, with which the county officials are now faced, Judge Nordyke expressed the belief that the difficulty arising from the recent action of the court in connection with the awarding of construction contracts, will be smoothed over entirely satisfactory to all concerned, but he said he doubted that this phase of the work would be taken up by the court at the session today.
He said he believed the court would agree to have the contracts awarded in Austin by the highway commission, provide the commission would allow the local body a voice in the proceedings. Three of the commissioners have virtually agreed to this, he told the Daily Journal, and he himself expressed favor toward such action.

Working Women Are Supporting Others, Is Shown By Survey

WASHINGTON, Jan. 11 (AP)—Women who work generally do so because they have dependent relatives to support the government has learned through a study undertaken in cooperation with the Bryn Mawr Sunday School for Women in Industry.

The results of the inquiry as to 101 students in the institution, prepared by Professor Amy Howes, and made public by the Women's Bureau of the Labor Department showed that about half of the women so enrolled had to contribute to family support and that a fifth were the sole carriers of such a burden.

Further, it was concluded, the dependents of women are more frequently the older parents, who will never be self-supporting again, who usually fall to the care of unmarried daughters.

Italy's Dowager Is Laid To Rest Along Side Of Dead Ruler

ROME, Jan. 11 (AP)—Margherita of Savoy, Italy's first Queen of Italian birth, was laid to rest in the Pantheon tomb of the nation's illustrious dead, where also lies the body of her husband, King Humbert, who was assassinated in 1900. The body was brought from Bordighera, where the Queen Mother died January 4, on a special train which one minute stops at all points enroute to the capital. Arriving here it was conveyed through crowded streets and draped with mourning to the Pantheon. There a short ceremony was held after which the body was entombed in a special aperture above that containing the remains of that containing King Humbert.

Austin Ex-Service Men Riled Over Seizing Of War Vets Freed Of Death Charges

AUSTIN, Jan. 11.—The questioning of Otto Wolter Jr., and Will Wolter, brothers, by officers in Bastrop county, following their arrest here will be considered by Travis Post, American legion, at its meeting tonight.

Spradley, of Nacogdoches, East Texas officer, who has been here in connection with his investigation of the Engler triple murder, declared that new evidence which had been secured during the last week should result in indictments of the "guilty person or persons" within the next two weeks. Spradley issued a statement, in which he said the two Wolter brothers were completely exonerated in the case. Spradley denied, however, that the two men had been held and questioned without a warrant and exhibited two warrants purporting to be signed by Justice of the Peace F. I. Tannehill, of Austin.

EXPECT TO HEAR REPLY FROM MEXICO

NOTE WILL ARRIVE FROM MEXICAN MINISTER TODAY, THOUGHT

(By Associated Press.)

MEXICO CITY, Jan. 11.—It is reported unofficially that Foreign Minister Saenz will send a note on Wednesday to United States Ambassador Sheffield in reply to the ambassador's formal protest against the retroactive feature of the new Mexican anti-alien law. This law and the new petroleum act are held to violate pledges given the United States at the time that country accorded recognition to Mexico.

It is said, however, that it is the purpose of the Mexican government to maintain its sovereign right under the Mexican constitution to enact without foreign interference any legislation it may desire.

Claims No Injury. Minister Saenz says there is no intention to injure any foreign interests and that if any American interest or individual complains of injury the Mexican courts and the Mexican government will adjust them properly.

The protest of the ambassador created much interest in the capital. The newspapers made a feature of the dispatch from Washington announcing the American government's action in ordering Mr. Sheffield to lay before the Mexican government its representations against the retroactive and the features of the anti-alien laws. The belief prevails in well informed circles that there will be no early clarification of the situation but ultimately there will be an amicable adjustment. The conversations of Ambassador Sheffield and Minister Saenz are said to be pleasant thus far.

Huge Sum Will Be Spent For Roads In 1926, Builder Says

CHICAGO, Jan. 11 (AP)—A prediction that \$1,350,000,000 would be spent this year on hard road construction was made today by William McConnell, president of the American Road Builders' Association, in convention here.

He said there are now 122,000 miles of hard surfaced roads in the United States, an additional 180,000 miles of improved roads, in nearly 2,000,000 miles of roads upon which little or no work has been done.

Nearly 100 carloads of building machinery valued at \$3,000,000 have been sent here by 400 firms for display at the convention.

Jim Asks Faculty Of University To Chip In To Forum

AUSTIN, Jan. 11 (AP)—Texas University faculty members were asked to subscribe to the Ferguson Forum, organ of Governor Miriam A. Ferguson's administration, in a circular last week. The paper is published at Temple by James E. Ferguson, former governor, husband and chief advisor of the present Governor.

Many state employees in the Capitol are subscribers. W. B. Shoe, former head of the Workmen's Compensation division of the fire insurance commission, said last fall he was fired because of refusal to subscribe to the Forum.

The circular to faculty members declares the Forum gives more "political news" than all Texas newspapers and urges them to fortify themselves in anticipation of the forthcoming elections.

THE SHERIFF QUESTION

Sheriff Eud Johnston will not run again.

The man who was been at the helm of law enforcement in Lubbock county for nearly four years and who had previously announced his candidacy for a third term, has withdrawn from the race and will reassume the active management of his ranch.

People who are in favor of law enforcement are sorry to learn of Sheriff Johnston's decision, and it is their fervent hope that his successor will be a man capable of walking in his footsteps, a fearless upholder of law and order.

There are many other men in Lubbock county who can handle the sheriff's office and it now falls upon the shoulders of the voters to see that the man who succeeds Bud Johnston is a man capable of defending the peace of the county and the morals of its people.

The problem is up to all of us. Let's choose a sheriff who is equal to his task—a man who can carry on the program so successfully handled by Bud Johnston.

AN EXCEPTIONAL MEMORIAL

It is an unusual memorial which the heirs of a former Springfield (Ill.) banker are erecting to their father. In 1878 the J. Bunn bank failed. It had weathered the panic of '73 but loans on real estate on which it could not realize forced it to close five years later. The owner of the bank hoped to repay those who had suffered financially, but was unable to do so in his life time. Some years ago his heirs created a fund to reimburse those who lost by the bank's failure. The sum of \$50,000, representing the original loan and accrued interest, was accumulated and is now being disbursed, mainly to heirs of the depositors.

There have been many instances wherein men have refused to take advantage of bankruptcy laws or to recognize the statute of limitations as running against a debt. When ability to repay long outlived claims was gained, payment was made. Yet, the practice has not run universally by any means, more's the pity. Honor obligation too often is regarded as not exceeding legal liability.

Nearly 50 years have passed since the Bunn bank failed and the lapse of time would by most people have been considered as having wiped out all claims. Under many conditions it would have been a not unreasonable conclusion. Heirs especially might seem to be exempt from paying out their own funds to discharge debts of a parent. That the heirs in this instance contribute so much in behalf of the family honor is a more substantial memorial than could be fashioned from granite because it has its foundation laid in personal integrity.

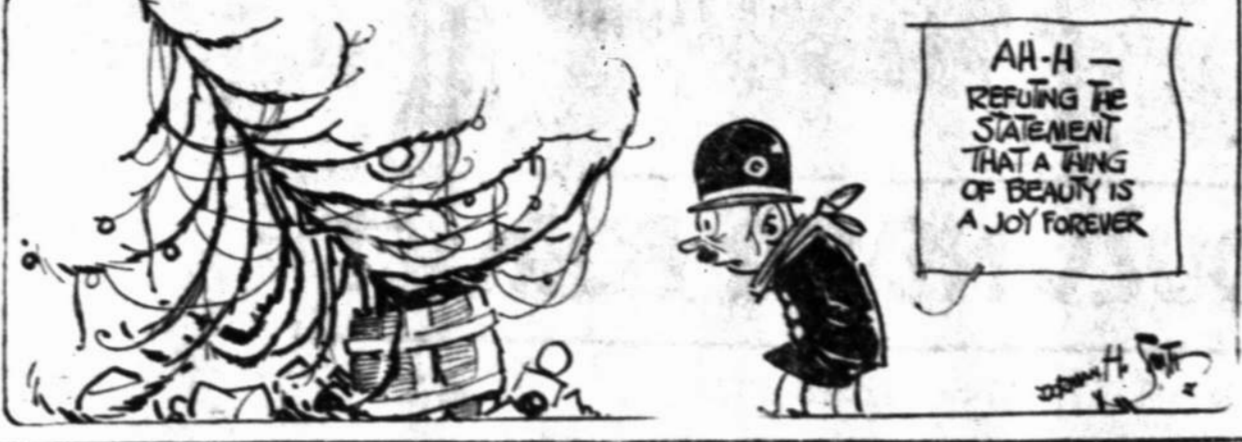

HOLIDAYS BRING PEACE TO U. S. CAPITAL

WASHINGTON, Jan. 11—Holiday week is quiet in Washington, always. Congress goes home, almost in a body. So do a majority of the department heads. The supreme court justices are pretty well thinned out. Lesser officialdom gets a few days leave if it cannot do its best to contract a bad cold or some such thing—not serious enough to interfere with the occasion's enjoyment but sufficiently grave to prevent going to work.

With congress in recess there's nothing to detain the army of "fixers" for special interests which have things they want the national legislature to do or leave undone, so, for the most part they streak it for distant Christmas trees. The members of the diplomatic corps, though far from their various native lands, generally have holiday invitations hither and yon and underlings preside in their stead.

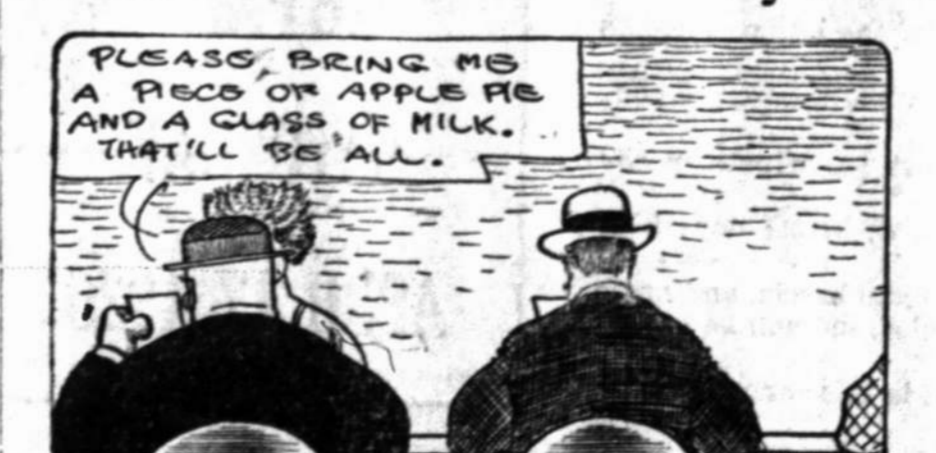

T. C. U. CAGERS ARE DALLAS LAD WINS FACING BRIGHT PROSPECTS

PORT WORTH, Tex., Jan. 11. (AP)—Starting Captain "Long Tom" George, outstanding center of the conference, the Texas Christian university basketball quintet of 1926 promises to make a determined bid for the Southwest conference championship. Much depends on the outcome of Tuesday night's battle at Austin against the Texas university Longhorns, the opening conference melee for the Horned Frogs and Longhorns. If Coach Matty Bell's Frogs can capture this game, getting off to a running start, they may well capture the title.

Last season, the Frogs lost to the Longhorns in Austin by a one point margin. Later in the season, they trounced the Longhorns by a top heavy margin at Fort Worth. Coach Bell fielded his ace, George, on the sidelines until the Longhorns had gone into a 19 point lead. He then rushed the big center into the fray, and his mighty play almost enabled the Frogs to overcome the 10 point handicap. This year it is a certainty George will start every game, unless handicapped by illness or injury.

George is astoundingly fast for a man of his huge bulk, and is a natural basketball player. In addition to being pivot of the Frogs offensive, he is the mainstay on the defense, his long arms breaking up many promising rallies of the opposition.

If Donald Frazee, crack guard, were in condition, chances of the Frogs for victory would be much brighter. Frazee has a bad ankle that slows his play, but Coach Bell likely will start him. "Black" Wolfe, husky all-around athlete, "Blacker" Williams, who was a football backfield star of this past season, and Acker, also a football star, are other capable guards.

Starting forwards will be picked from among Frank Cantelmi, speedy veteran; Harvel Light and Harry Taylor. The last two are most probable starters, for Cantelmi has not been able to strike his best stride.

Cooper, who took up golf at the age of three and has been chasing golf balls ever since, according to his father, Sidney J. Cooper, won his first tournament at the age of 14, a local affair at Dallas. He won the Texas State tournament at Galveston in 1923 and again at San Antonio in 1924, and was runner up in the Texas tournament last year. He neither drinks nor smokes.

Cooper shot a par 70 on the south course and on the north 68, four under par, a 74, two over par, and 67, five under par, to total his 275.

TALK OF TRADING SAM JONES MAY END WITH COBB MAKING HIM A TIGER

I see there is talk of trading Sam Jones of the New York Americans. Jones is the pitcher whom Ty Cobb once told me he regarded as the greatest in the American League.

By the great stylist Cobb meant a pitcher who had what he classed as an easy, perfect delivery, a rare assortment of curves, a fine change of pace, was a brilliant fielder and a brains.

I agreed with Cobb in his size-up of Jones, yet somehow Sam has never achieved the pitching pinnacle that one would expect of a player with so many mental and physical assets.

It may sound rather funny, but control-plus has been his greatest handicap. Most pitchers suffer from wildness. Sam, on the other hand has just the opposite experience.

Jones is at his best when he is working the corners. When things are breaking good he takes every advantage of his ability to make the ball behave as he wants it.

It is when things are breaking badly that Jones instead of pitching in his usual manner starts getting the ball too good. Then he suffers.

Control-plus is a rather unusual attribute, but it goes for many of the top exhibitions that Samuel has staged.

MR. PSYCHOLOGY

Jones, by the way, never pitched a game against the Detroit club without being the center of an argument between the Tigers and the umpires.

Jones is a firm believer in the value of psychology. Some years ago when trick pitching began to play such a prominent part in the curtailing of batting, Jones always took advantage of it.

I don't believe Sam ever cheated in pitching in his life, but he worked on the nerves of the opposition. It was just about as effective.

Well do I recall a funny incident of several years ago that had Jones as central figure.

It was common gossip then and much fact, that a number of American League pitchers were resorting to various illegal methods in order to increase their effectiveness.

The batters began paying more attention to the antics of the pitchers than trying to hit the ball. Just before game time in New York one day Jones, who had been selected to pitch against Detroit, came back to the bench after warming up and said to me:

"I'm going to take a glass full of water, throw it on my baseball trousers just above the knee, make a pretense of occasionally rubbing the ball on the foreign spot and watch the Tigers growl."

CASE OF SAM JONES

In the first inning he struck out two men and made the third man tap weakly to the infield. After the first man up in the second inning had filed out, the Tigers noticed Jones appeared to be rubbing the ball on the wet spot.

A complaint was registered. I told the Tigers it was water, that I had seen Jones throw it on his uniform with the remark that he would be suspected of cheating and the Detroit batters would suffer as a result of paying much attention to what was really nothing.

My truthful statement of fact didn't help the situation. Every batter who had faced Jones up to that time insisted his curve ball was breaking a foot and his fast one was doing a Salome on its way to the plate.

During the rest of the game the Tigers turned detectives instead of batters and as a result their hitting slumped and Jones won as he pleased.

Ever since that occasion Jones always resorts to some sort of fake stuff to detract the Tigers and has been fairly successful. I am sure Cobb would welcome him on his staff.

Longhorn Coach Is Chosen As Referee

AUSTIN, Jan. 11. (AP)—Curtis Alderson, assistant football and basketball coach at Texas University, was picked by a number of sport writers the best referee to officiate in a high school football game in this state during the 1925 season.

Alderson is a close student of almost every imaginable sport. It is said he knows by heart the football and basketball rule books.

Congressman Has Appeal Refused

WASHINGTON, Jan. 11. (AP)—Section three of the federal future trading act of 1921, taxing certain transactions in grain, was today declared void and unconstitutional by the supreme court.

It is section three which imposes a tax of 20 cents on each bushel involved in transactions known as "privileges," "puts" and "calls" or "ups and downs."

OIL PRODUCTION IS FOUND TO BE AT LOW DEPTH

SAN ANGELO, Jan. 11. (AP)—Production from a shallowly pay, 2,450 to 2,470 feet in the southern part of the proven Reagan county field, developed Saturday when Big Lake Oil company's well number 23-A was completed at 2,370 feet with an initial flow rating of 1,000 barrels daily. The new well is only 150 feet from Big Lake number 23, which produced only gas at the 2,400 foot level, eruptions for ten consecutive days blowing the tools from the hole. Number 23 later came in at around 2,925 feet for an initial flow gauging 1,000 barrels and now is pumping an average of 600 barrels every 24 hours.

Significance almost as striking of the first big production in Big Lake number 3 in October, 1924, attaches to Saturday's development, for it defines the higher producing horizon both north and south of the railroad and promises many additional millions of barrels of oil without extension of the proven area. Drilling of offsets to many of the present producers from the Texas sand around 2,900 and 3,000 feet is anticipated.

EDUCATORS WILL BEGIN TO WORK SOON

FORT WORTH, Jan. 11. (AP)—The Texas educational commission, representative of the varied educational forces of the state, will begin functioning within a few days. This was stated here today at the close of the meeting of the Texas state teachers association executive committee at which a committee was authorized to organize the commission.

With J. M. Bledsoe, Commerce, as chairman, the committee to work out final details of the commission will include Lee Clark, Gainesville; L. C. Stockard, Dallas; G. D. Staton, Wills Point, and R. T. Ellis, of Fort Worth.

PROHIBITION IS BIG AID TO GRAPE GROWERS

DETROIT, Jan. 11. (AP)—The Michigan grapegrowers has been a chief beneficiary of prohibition, not because of a demand for grapes for wine-making but because of the creation of a national thirst for grapejuice, said Seraphin Bruno, a well known grower of western Michigan. His views found acceptance from most of the growers visiting the Detroit market.

Grape prices have varied since prohibition almost entirely due to increased demand from grape juice manufacturers. Bruno asserted, Wine-makers in the old days seldom paid more than \$60 a ton. The price last fall was \$90 and more.

"There is some wine-making, I presume," Mr. Bruno said, "but grape-growers know, through their pocket-books, that it is kickless grapejuice that has done the business."

Violet-Ray Being Used For Better Eggs And Chicks

MADISON, Wis., Jan. 11. (AP)—The ultra-violet ray, already employed profitably by medical men to heal human ills, is being used at the University of Wisconsin to produce "more and better" eggs and chickens.

Nearly three times as many eggs can be produced by action of the ray, the departments of agricultural chemistry and poultry have found.

Heavier shells in irradiated pens also increased marketability of eggs and greater hatchability resulted. The ultra-violet light was found to cure fowls suffering from rickets.

On January 1, 1925, four groups of pedigreed leghorns were put on similar rations in identically arranged pens, without natural light. The pens were artificially lighted during the daylight hours.

Two groups were subjected to ultra-violet radiation. When the eggs were collected two to three times as many eggs were found in the irradiated pens as in the ordinarily lighted houses. Egg production began to increase markedly within eight days after ultra-violet light was applied.

Mrs. Lenine Wants Males To Show No Courtesy To Her

MOSCOW, Jan. 11. (AP)—Madame Lenine would be offended if a male "comrade" offered her a seat in a train, opened a door for her or stepped aside to give her precedence.

Hand-kissing and hat-tipping have been relegated to the past in Communist Russia for hygienic reasons and men and women are on a par.

There is no sex in Communism.

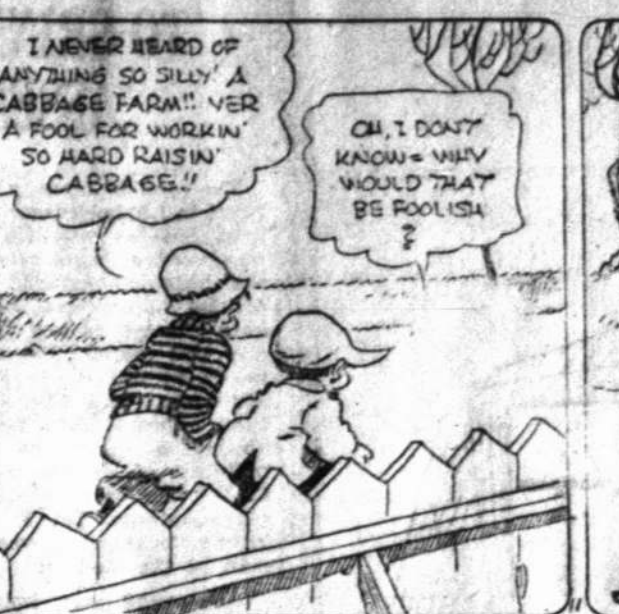

MULLICAN STARTS COURT WHEELS TO GRINDING AS GRANDJURY HAS ASSEMBLED TO PROBE SITUATION

The regular January term of district court in Lubbock county got underway here Monday morning at 10 o'clock when twelve men were selected from the body summoned, to act as the official inquisitorial body to investigate charges of law violations in the city and county. The grand jury was sworn in by district Judge Clark M. Mullican, with the suggestion that they adjourn until next Monday on account of the illness and consequent inability of district attorney Walter C. Wither to assist them in various investigations. Dr. I. E. Barr, well known local man, was elected foreman of the body.

The grand jury immediately went into session, and voted unanimously to accept the suggestion of Judge Mullican and will not assume official du-

ties until next Monday, unless called into special session.

Juryman Named

The grand jury is composed of the following Lubbock county citizens: Dr. I. E. Barr, Lubbock, foreman; Sam C. Arnett, Lubbock; R. O. Rush, Lubbock; J. T. Pinkston, Slaton; Charles Austin, Slaton; Joe Teague, Sr., Slaton; Bob Crump, Shallowater; Jimmie Reed, Beeton; W. B. Copeland, Slide; D. B. Melrose, H. W. Laster, and J. C. Newton, all of Idalou. In his charge to the body, Judge Mullican warned that they were to confine their investigations to crime, and that under no circumstances were they to permit politics to enter the various phases of the work. He pointed to the fact that this is to be a political year, that various and sun-

dry charges against individuals purely of a political nature, probably would be submitted for investigation, but that the grand jury must not in any way enter this field of activity.

Judge Gives Charge

The judge explained that the grand jury was interested in crime only, saying that a charge must involve a felony before the body should take time to open an investigation. You are not to be the least bit interested in a misdemeanor case, the judge told the body, for this will be cared for in proper channels outside of the district court.

Judge Mullican laid stress on the recent campaign of Sheriff Johnston and Police Chief May for the suppression of illicit liquor and extract traffic, saying that the city and county of Lubbock has a certain responsibility in keeping this kind of business at least to a minimum, for if the parents of the young manhood and the youths themselves, would not make an effort to stop the practice, it was the duty of the grand jury and court machinery to do all possible for its suppression.

He explained that sale of extracts,

about which so much has been heard, is not a violation of the law only insofar as it is sold for beverage purposes, and if investigation proved that the latter had been the case here, bills of indictment should be returned against all guilty ones. These men, he said, are violators of the law just the same as the bootlegger or the man who manufactures what is termed whiskey, and they should be punished for their actions.

He warned the grand jury, however, against crowding the docket of the court with bills on which convictions could not be gained, saying that the court did not have time to devote to this kind of business on account of the already congested condition of the court machinery.

gobias. Twenty Bodies Burned. Twenty bodies, burned beyond recognition, already have been found in the tangled mass of ruins and it is feared still others are in it. Those of the military escort who were not killed were wounded.

The attack started when the train was running between Negrete and Youreucaro. Twenty armed men, wearing disguises, suddenly began going their knives on the soldiers and robbing and killing the passengers. Of the military escort all but seven were killed. The bandits are said to have been acting under orders of former Colonel Manuel Munez. Their booty was three hundred thousand pesos.

Immediately the news of the crime arrived here, orders were issued for federal troops to go in pursuit of the bandits.
