MURDER COUNT FILED AGAINST CHILDRESS MAN AFTER SLAYING PRECIPITATED BY SHORT FUSS

(By the Associated Press) CHILDRESS, Jan. 31.—Andy Green, 47, farmer, who lives 18 miles north of Childress, was held on a charge of murder today, for the slaying of A. A. Moore, 76, a neighbor. Green made a statement explaining the shooting. District Attorney James Mahan said. In this statement it was said that Moore had locked a gate on his farm and refused passage. The grand jury, convened by Judge C. C. Small, is expected to investigate the shooting.

ARMY BILL IS REPORTED OUT BY COMMITTEE

CARRIES \$399,000,000 PART OF WHICH IS FOR NON-MILITARY

(By Associated Press) WASHINGTON, Jan. 31.—Carrying a total of \$399,000,000 including \$0,433,000 for non-military activities, the annual army appropriations committee. The amount represents an increase of \$3,654,000 over current funds, but a decrease of \$494,000 under the budget estimates.

The committee said that after a "careful study into the foundation of published reports," it had found that a deficit existed in the nation's ammunition reserve, but not to an alarming amount. It asked that \$7,393,000 be used for procurement of ammunition next year and said the war department plans to present a program for 1929 looking to the gradual elimination of the existing deficit.

Rivers and Harbors Of the total non-military allotment, \$50,000,000 was made available in a lump sum for the carrying out of existing river and harbor projects.

Continuance during the next fiscal year of an army of 118,750 men, including 1,248 men to be absorbed into the air corps under the five year aviation program, also was provided.

The appropriation for the air corps amounted to \$24,850,000, plus a contract authorization of \$5,000,000. The committee said that its total number of planes the second increment of the five year program will be more than met at the end of the year.

There will be on hand, except possibly as many as 101 planes on order, 1,350 planes against the program figure of 1,250 planes, the report said. "In types of planes there will be a shortage of 27 bombardment planes.

Some Disatisfaction "There is some dissatisfaction with the estimate because it is not intended to permit the purchase of more than 23 bombardment planes and because it contemplates the use of liberty motors in all of the 150 observation planes provided for. The committee believes it would be unwise to proceed to a more rapid rate in the procurement of bombers."

New Markets For Cotton Crop Found

GALVESTON, Jan. 31 (AP)—New markets for this season's cotton in Texas are being opened, and indications are that heavy shipments are to begin soon to Murmansk, Russia, and Bombay, India.

The first direct shipment from Texas to Bombay will be made from here late in February when the British steamer Tapti lifts 14,000 bales, according to announcement here today.

Monday the Dutch steamer Hardenburg sailed from here with a cotton cargo for Murmansk. Texas shipments to Russia last year were more than 300,000 bales.

Cold Winds Send Temperature Down

HICKMAN INSANITY PLEAS GO ON

TWO MORE HELD AS SUSPECTS IN OKLAHOMA RAID

(By Associated Press) GAINESVILLE, Jan. 31.—Two more suspects in the robbery of the Love County National bank at Marietta, Okla., in which Oscar Boyd Harrison of Goose Creek, Tex., was killed, and Sheriff S. C. Long, fatally wounded, were arrested in the Red river bottoms today.

The men were captured near the spot where an automobile thought to have been used by a bandit who escaped with about \$9,000 after the gun battle in the bank was found. It was announced through the district attorney's office at Marietta that charges of first degree murder and robbery with firearms would be filed Wednesday against nine men in connection with the bank robbery.

SIX ACCEPTED FOR JURY DUTY IN STORY CASE

SEVERAL EXCUSED FOR SCRUPLES AGAINST DEATH PENALTY

(By Associated Press) SHERMAN, Jan. 31.—Six jurors from a total of 49 veniremen examined had been selected to sit in the trial of Yancy Story on a charge of robbery with firearms of the Farmers National bank at Krum, two years ago, when court recessed at noon today.

Several of the veniremen examined were excused because of scruples against capital punishment, and others were disqualified because of opinions, having relatives in Denton county, where the robbery occurred.

Members of Jury Members of the jury now are: R. W. Pinney, farmer, Sherman; W. C. Dodson, farmer, Whitehouse; J. J. Morrin, farmer, Whitesboro; J. L. McMahon, farmer, Tobeau; T. R. Smith, farmer, Sadler; Roy Seibert, farmer and bank stock owner, Sadler.

Two jurors had been selected when court recessed last night, after a defense motion for a continuance on the ground that Story is unable to stand trial, had been overruled.

Rangers to Testify Captain Tom R. Hickman and M. T. Gonzales of the Texas ranger force, have arrived to testify during the trial. They conducted an investigation following an automobile wreck near Denton, Texas, in which story had claimed he was injured so he cannot stand trial.

Selection of jurors was expected to be completed during the day. District Judge Silas Hare announced night sessions beginning Wednesday in an effort to close the case this week.

Tax Offices To Be Held Open Tonight

The offices of County Tax Collector I. F. Holland, in the court house; City Tax Collector R. A. Holland and School Tax Collector A. C. Fines Here Total \$1,087 In January

One hundred and sixty fines aggregating \$1,087 had been paid into the city police department for the month of January up until noon today. Injunction Given In Local Land Case

AUSTIN, Jan. 31 (AP)—The Supreme Court issued a temporary injunction Tuesday restraining the 72nd district court at Lubbock and the 95th district at Dallas from further action in the H. J. Lowery versus Barrier brothers suit involving 430 acres of land in Lubbock county, until a final hearing is had.

Injunction was issued on application of attorneys for the seven Barrier brothers, whose cross action is still pending at Dallas. Lowered original petition has been dismissed for want of prosecution there, but he has filed another suit of the same description in Lubbock county. He lives at Lubbock. Some of the Barrier brothers live at Dallas.

They object to removal of the suit under the circumstances. Hearing on petition for a permanent injunction will be had by the Supreme Court later.

MANY MEMBERS OF HIS FAMILY TERMED CRAZY

MORE DEPOSITIONS ARE ENTERED TODAY BY DEFENSE COUNSEL

(By Associated Press) HALL OF JUSTICE, LOS ANGELES, Jan. 31.—Further testimony that traces of insanity were exhibited in several generations of the family of William Edward Hickman, kidnaper and slayer of Marian Parker, was presented in superior court here today in the youth's sanity trial.

A deposition from Spencer Lane, 90, of Hartford, Ark., in which he characterized the defendant's grandfather, Otto Buck, as "crazy" was read into the record by Jerome K. Walsh, defense attorney.

Lane deposed that the defendant's grandfather, Otto Buck, was what he called a "nutty guy."

"He had epileptic fits and was what I called a 'fitted feller,'" the deposition said.

Lane declared Buck didn't have "sense enough to say anything when he was in a fit."

"He was what I call crazy," the Ozarkian said.

"He didn't have sense enough to go to work and earn a living."

Lane, the Arkansas witness which was read in court by District Attorney Asa Keyes, was taken by the latter's deputy, James Costello, who accompanied Walsh on the middle west tour for evidence.

Costello brought out that Lane's opinion of Buck's insanity was based mainly on his "fitted" tendencies. The witness also admitted that Buck did support his wife by his labor.

MOODY ASKED BY NORFLEET TO DENY REQUISITION PLEA OF PENNSYLVANIA FOR HIS RETURN ON KIDNAP CHARGE

(By Associated Press) AUSTIN, Jan. 31.—Frank Norfleet, Hale Center ranchman, famous as a tracker of criminals, Tuesday appealed to the Governor's office to refuse a Pennsylvania requisition for him on a kidnaping indictment which he claimed is pending in that state in connection with his return of an alleged swindler to Amarillo without requisition papers.

The Governor's secretaries said no request for Norfleet's return has been received from Philadelphia but he was to see the Governor later. He told Secretary Pat Daugherty that he surprised the man reading his (Norfleet's) own book of his experiences tracking down a band of men who had swindled him. The man has been tried, convicted and sent to the penitentiary from Amarillo, Norfleet said. He related that a reward offered the man came to him and that he decided to run him down, finally catching him through an automobile license number, and urging him at a pistol point to come back to Texas.

LEAVES MARACAY FOR 1,000 MILE HOP AT 6:15 TODAY

(By Associated Press) CARACAS, Venezuela, Jan. 31.—Colonel Charles A. Lindbergh, with St. Thomas the Virgin Islands, as his next stopping place hopped off from Maracay at 6:15 a. m. He will fly 1,000 miles.

Treacherous Path Ahead Of Flier

CARACAS, Venezuela, Jan. 31 (AP)—Islands, among which more than four centuries ago the tiny craft of a stout hearted Italian, Christopher Columbus, threaded the way, today marked the route of a stout hearted blazer of air trails in the new world Columbus discovered.

Thousand Miles of Flying The lesser Antilles, separating the sunlit waters of the Caribbean from the Atlantic, pointed a way to the north for Col. Charles Lindbergh. A thousand miles of flying was ahead of the Lone Eagle. At the end of this trail lay St. Thomas, one of the Virgin Islands, where the population waited to do honor to a fellow American.

It was the long way round that Lindbergh chose for his Spirit of St. Louis, which now carries painted on its fuselage the flag of another republic—Venezuela. To have followed the lane along which steamers laden with the fruits of the tropics play across the Caribbean would have been some 400 miles shorter.

Leaves Autographs Not only does Lindbergh take with him the flag of Venezuela, he takes also the warm regard of another people. Behind him he leaves a pretty young Venezuelan girl who prizes three autographs he gave her and cherishes the ingratiating smile which accompanied the gift.

Taking from her own hand a small glove on which was embroidered in Spanish—"To the twentieth century hero, the Lone Eagle, the friendly ambassador of the air," she gave it to Lindbergh. When she asked for something in return, Lindbergh, puzzled, scratched his head and then took a piece of paper and wrote on it three times "Charlie Lindbergh."

MRS. HICKMAN TELLS HER STORY

"He Must Be Insane—If I Hadn't Let Him Go Away This Wouldn't Have Happened." She Writes in Exclusive Article for The Journal

EDITOR'S NOTE: Stunned by the confession of her son, William Edward Hickman, to the murder of little Marian Parker, Mrs. Eva Hickman has gone to Los Angeles to testify in his behalf at his trial. In order that the nation may understand why she will testify for him, she has written the following article, setting forth a mother's emotions as a son goes to trial for his life for murder. It is presented here exactly as she wrote it.

 I have a message for mothers. Don't let your boy get away from you. Don't let him out of your sight until you are sure he knows what he's about.

Of course, it seems that with all the talking and reasoning I did with my Edward before he left home he would have remembered some of it. But as soon as he got away it seems he didn't realize or pay any attention to what I said to him.

Must Be Insane
 It's just too pitiful, too pitiful for words. I'm just so hurt, so hurt. He's not so black. His raising hasn't been to that effect. He's bound to be insane.

Young like he is. The way it's all put up as if he was a soulless monster. If only a closer watch could have been kept on him. If I had been with him, if I hadn't let him go away this wouldn't have happened.

Edward just can't be right that's all. Or he never could have done a thing like that. When he was a boy growing up he was just like other boys. He was a mischievous and lively child. It's been in the last year he's changed. He's been restless and full of notions and didn't seem to know what he wanted to do. He wouldn't stay at one thing; it was just his mind.

Didn't Discuss Murder
 When I saw him the other day when I walked into that jail cell, the first time I'd seen him since last October, he just said "Hello, mother," as if he'd parted from me that very morning. Then he said, "How are you?" Don't cry, mother. He was really holding back. He didn't mention the trouble at all. He didn't and I didn't. But next time I see Edward I'll pull him out and see what he will say in regard to it.

I wouldn't have been a true mother at all if I hadn't come to see him. I hope that I can help him but I won't see how. He doesn't look like a criminal. But maybe that's because he's mine. I think like that. He looks all right to me.

He studied very hard that last year in high school for an oratorical contest when he lost, he was so disappointed. He came home and never think such a thing as this would befall him. I can't figure where he could carry out a thing like that. Seems like someone old-

er than he is in it. For little old Ed. It's just unbelievable. I can hardly make myself believe he's in it. It's so tragic. Sometimes I seem bound to break. Then I take on a little courage and go on.

Recalls His Childhood
 I can see him in every conceivable way when he used to be at home and picture him in this trouble. Anyone who was normal couldn't do such a thing. How can everyone be so bitter? If there was just justice and fairness. Lots and lots of things can be turned and twisted. Only my God is with me. Anybody in trouble like this draws nearer to God.

Mrs. Eva Hickman there in 1913. The witness testified Mrs. Hickman who she said was the mother of William Edward Hickman, suffered from depression, and "was stubborn when she was to be given medicine or a bath."

The state, by cross-examination, threw a doubt into the mind of the witness that Mrs. Hickman was the mother of William Edward Hickman. It brought out that Mrs. Smith was only a student nurse and that she attended Mrs. Hickman in a group of forty patients, who were under the care of five nurses.

Dr. H. P. Ruth of Tulsa, Okla., who also examined Mrs. Eva Hickman, termed her illness "mild dementia." Under questioning of the state, he said he based his opinion on her extreme melancholia, hallucinations of being abused, and general appearance of ill health.

Domestic Trouble
 Dr. Ruth admitted her condition came after she and her husband

had considerable domestic trouble. He admitted having seen Mr. Hickman making a "regular hangout" of a Hartford, Ark., restaurant in which worked a woman to whom he gave great attention and that Hickman ran away with her. Dr. Ruth admitted he knew that it was "very generally known that he was unfaithful to his wife."

"My conclusion," he testified, "was that her condition was the result of her worry over her family of five children and the unfaithful husband."

He admitted that her mental illness was of a spasmodic and curable type.

Hickman Family Secrets Are Told

LOS ANGELES, Jan. 31.—Family secrets, gathered from the hills of Arkansas and brought to a Los Angeles court room in the hope that they would save William Edward Hickman from the gallows heightened interest in the sanity trial of the youthful kidnaper and murderer today.

Hickman is charged with the kidnapping and murder of 13-year old Marian Parker about December 16 last in Los Angeles. The girl was the daughter of an official at a bank in which Hickman formerly was employed.

Pictures of the lives of Hickman's ancestors, some of them long since dead, were brought into court yesterday in the form of depositions which had been taken by prosecution and defense in Sebastian county, Arkansas. These were intended by the defense to show a strain of insanity running through the young criminal's family for at least three generations, beginning with his maternal grandparents, Becky and Otto Buck.

About 100 typed pages, the testimony of midwest witnesses, all relatives and friends of Hickman's family, were read into the court record of the trial yesterday, leaving about five hundred pages to be read. Other depositions follow the Hickman family away from Sebastian county and to Kansas City and will include the testimony of boyhood companions of the defendant. The first depositions offered painted the grandfather as subject

to "fit," the grandmother as frail and given to tears and "talking foolishly," the mother, Mrs. Eva Hickman as depressed, morose and at one time attempting suicide, and the father, William Thomas Hickman, as "queer" and "running around with other women."

Thomas Lewis, son-in-law of Becky Buck, declared in his deposition that "the old lady's mind was awful weak" while anything "flustered" Mrs. Hickman.

Queerness Of Mother
 Mrs. Agie Smith of Cameron, Okla., sister-in-law of Hickman's mother told in a deposition of the "queerness" of Mrs. Hickman. At one time, she said, William, the father, awoke to find his wife standing over him with a butcher knife in her hands. Another time, folks in her home town, according to the witness, were shocked to discover Mrs. Hickman dancing a jig while engaged in her household duties.

Except for the defense's silence, only three witnesses will be presented by the defense, according to Jerome Walsh, chief counsel for Hickman. These will be Mrs. Hickman, William Hickman, the father, and Alfred Hickman, the young defendant's brother.

Jury Closely Guarded
 Last night the jury of eight men and four women as well as the man and woman who were chosen as alternate jurors, were each locked up in separate rooms for the night. Under the order of Judge J. J. Trabucco, the jury will remain isolated until after the completion of the case. Several jurors, taken by surprise, asked for a chance to arrange their affairs before going in to the seclusion ordered by the court but Judge Trabucco denied this request.

Another change in the usual court procedure was ordered by Judge Trabucco when he decreed that beginning today court would be opened at 9:30 o'clock instead of 10 in the morning and would close at 5 o'clock.

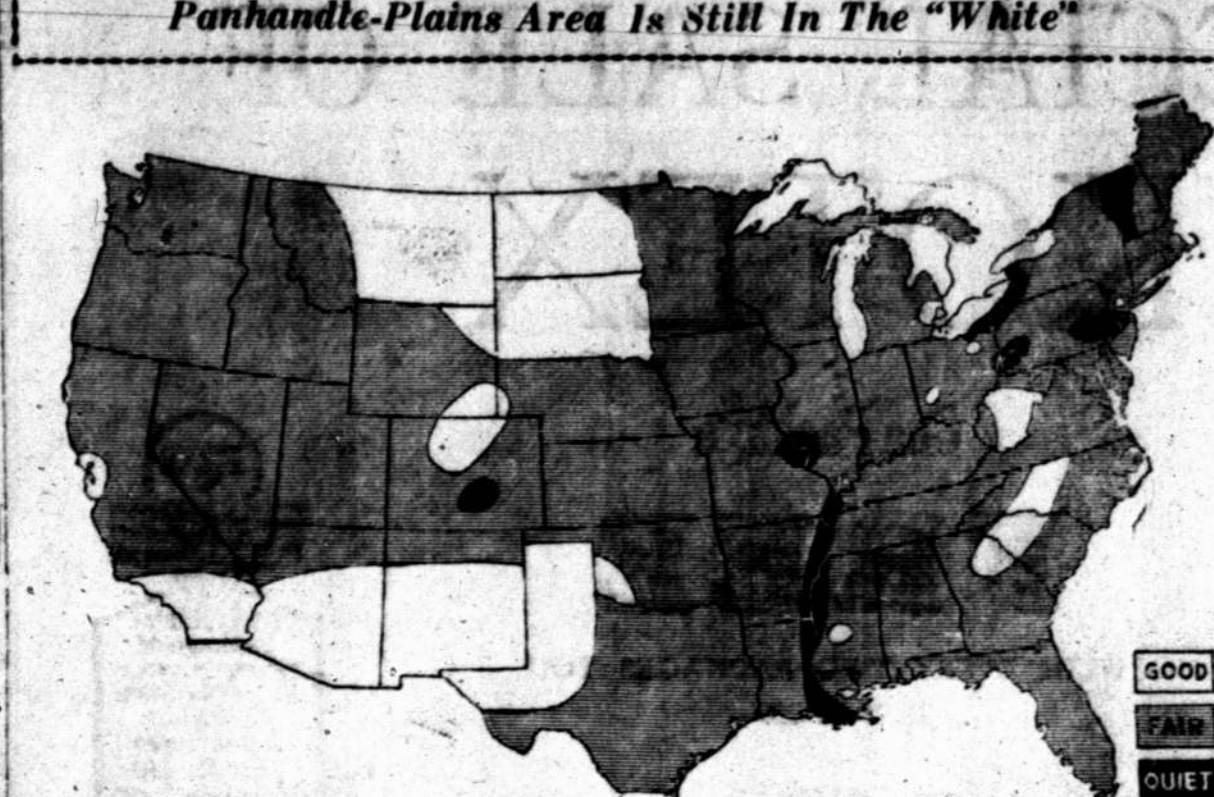

UNION TREATY IS WIDENED TO INCLUDE WORLD

COMMERCIAL AVIATION ON WORLD BASIS IS URGED IN SESSION

(By Associated Press)
HAVANA, Jan. 31.—The scope of treaties arrived at by the Pan-American conference has been widened to include the world instead of the United States and 20 Latin American Republics. The treaties involved are those dealing with commercial aviation.

When the treaties came up for discussion in the communicating committee yesterday, Felipe Espil, Argentina, said that if the article limiting adherence to members of the Pan-American union were not amended, other countries, notably Canada, would be forced to conclude 21 separate conventions with the other nations of the Americas.

No Objections By U. S.
Henry F. Fletcher, United States, had announced previously that the United States would have no objection to any amendment to the draft treaty to give it the widest possible scope, including thereby governments not members of the Pan-American union.

Senator Espil moved that the provisions be open to any country having aviation lines. The committee then adopted an amendment making the director-generalship, now held by the United States, with Mexico voting for the proposal of rotating the membership of the board and Bolivia absent, the proposal was rejected by all the other delegations. After defeat of this

proposal, the Mexicans withdrew the amendment extending the process of "democratizing" the Pan-American union at the start.

Hughes Opposes Plan
Charles Evans Hughes, chairman of the United States delegation, opposed the proposals on the ground that they would amount to "artificial restrictions." These, he said, would be contrary to the democratic spirit that all apparently were desirous of seeing firmly established in the Pan-American union.

boardment planes in view of the fact that an advance type is now only at the test stage.

"With respect to using liberty motors, the army still possesses over 2,000. It costs around \$700 to put one in a plane as against as much as \$7,000 for a more modern type, of which two or more are bought for each plane. No convincing reason has been advanced as to why this type of motor should not be used."

Entertainment Increase
The bill calls for an increase from \$290 to \$528 in the amount allowed military attaches for entertainment purposes, requested by Colonel Stanley H. Ford, assistant chief of staff, who declared that such a move would immeasurably aid in the collection of military information which would be invaluable in case of war. This money, he explained, would be used to promote contacts with foreign officers so that facts concerning military power of other nations might be learned "just as foreign officers obtain information concerning our army."

An appropriation of \$53,941,000 for sea coast defenses of the United States and its possessions was provided, including the completion of existing batteries in Hawaii and Panama, for trackage of railway guns, for anti-aircraft defenses and for additional searchlights.

A national guard strength of 188,000 men, with 18 squadrons for the guard air service was provided, as well as 15-day camp training for 15,125 officers of the organized re-

serves, or 1,257 less than provided for this year.

Mentions Battalion
Other provisions called for \$180,938 for the training of a munitions battalion composed of 250 university students who would be instructed before and after graduation with a view to speeding up production in time of war, \$965,000 for completing tests of new field weapons, and civilian training camps to care for 33,000 men.

Funds for new construction at military posts include:
Brooks Field, Texas, barracks \$154,000, officers quarters \$200,000;
Fort Bliss, Texas, non-commissioned officers quarters \$300,000; Kelly Field, Texas, barracks \$316,000, officers quarters \$100,000; Fort Sam Houston, Texas, barracks \$500,000.

Final Vote Nears On Shipping Bill

WASHINGTON, Jan. 31 (AP)—Nearing a final vote on the Jones bill to build up the merchant marine, the senate today defeated the Copeland amendment proposing loans to builders of new ships for foreign trade service. An amendment by Senator Bruce, Democrat, Maryland, placing the clerical forces in government shipping business under the civil service was accepted.
