## DISTRICT FIELD MEET AND COURT OF HONOR FOR BOY SCOUTS JUNE 2 AND 3

Next Thursday and Friday, June 2nd and 3rd, boy scouts from all the towns in the southern district of the South Plains Area Council will come to Lamesa to compete in the district field meet and to attend a district-wide Court of Honor. They will arrive here in the afternoon of June 2nd, and after selecting their troop campsites and setting up their camps, will participate in an impressive flag ceremony. Next they will prepare and eat their suppers. At 8:30 all will gather around the council ring for a camp fire program and Court of Honor. The fire will be lighted during an Indian Ceremony put on by "Chief Waktia Wa-ta-ka-pe" of the Yann'sa Tripe. The Court of Honor will follow after which the various troops will engage in several contests.

Friday morning will be given over to numerous athletic contests and games, and the field meet proper will begin at 2:00 P. M. Streamers and banners will be awarded troops whose teams qualify in the several events. The banner events are as follows:

1. Grand Entry:
  - (a) Attendance (75 per cent of registered scouts must be present to qualify for streamer)
  - (b) Inspection (Troops must make 50 per cent of possible number of points to qualify for streamer).
2. Signaling - Semaphore—One or more teams of four scouts each, from each troop. Must send and receive correctly 50 letters in two minutes to qualify.
3. Signaling - General Service—One or more teams of four scouts each. Must send and receive 25 letters in two minutes to qualify.
4. Knot tying—One or more teams of eight scouts—19 tenderfoot knots.
5. Fire by friction—One or more teams must make average of not more than 30 seconds to qualify.
6. Fire by Flint and Steel—One or more teams of four scouts. Teams must make average of not more than 15 seconds.
7. Flag Shuttle Relay—One or more teams of eight scouts from each troop.
8. First Aid—One or more teams of four scouts. Twelve problems.

## "GRUDGES"

"Grudges, grudges", who's got grudges to sharpen? Wouldn't at least one head pop out of every house should suddenly proclaim his ability on your street if the scissors grinder should suddenly proclaim his ability to put new edges on old grievances instead of old shears? Don't you suppose that he would be kept so busy that he would not need to move his barrow away from your own neighborhood?

"Grudges, grudges!" Nearly every one has at least one, and many of us have large and heterogeneous collections—wrongs which ranked in spite of our best efforts to overcome them, sources of irritation and inflammation, breeding spots for resentment and hatred and revenge. These "slings and arrows of outrageous fortune" come alike to all of us.

No, one of us escapes the attacks of injustice. They are experiences which we haven't quite learned to avoid. But the outcome depends upon our own volition, upon the way we choose to conduct ourselves under fire. There is the cowardice which sends us scuttling to the rear rank or the courage which takes us up in the vanguard; the self-pity which makes us wallow in mire, or the pride which keeps us smiling; the bitterness which only prolongs the warfare, or the perseverance which brings it to a successful termination. "She is her own worst enemy". How often we hear it spoken! Sometimes with a laugh, sometimes angrily, but rarely with full recognition of the truth it conveys. All of us are our own worst enemies. For no matter how malicious, how contemptible, how dangerous an enemy we may have, our greatest sufferings are caused, not by what is done against us, but by our own deceptions to these trials.

live over and over again. The pang of disappointment may tear at pride and trust and hope, but even their sharpness would subside earlier if we did not indulge in resentment, brooding over our wrongs until they assume greater and greater proportion.

What is your first impulse after a physical fall? Why, to pick yourself up and remove every trace of the tumble. You don't wipe the mud off your clothing and permit it to remain on your nose. It never would occur to you to leave a great jagged tear in your jacket so that everyone would see what a terrible fall you had had.

Regardless of whether the accident had been due to your own carelessness or the outright ill will of another, you would not wear your injury on your sleeve so that you could have the doubtful satisfaction of showing everybody what a mean thing so-and-so did to you.

But suppose the hurt to have been mental. Not a bruised cheek, but aching pride. Not broken bones, but broken friendship. Would you be as quick to recover your former poise and dignity? Just as vigorous in removing every trace of the debacle? Or would you cherish the wounds as evidence of what had been done to you, describing their cause to every one who would listen to you, each repetition of the offense reopening your wounds, inflaming your thinking, increasing your anger, swelling your resentment until you bend and groan beneath the flagellations of self-torture?

Certainly no enemy could wish us worse than that we should constantly hold up before our mental vision the picture of an injury, for dwelling on a hurt makes it rankle terribly. Its shadow never grows less, but constantly increases until it overcasts pleasant prospects which have nothing to do with it.

### Legion Auxiliary To Sell Poppies

World War veterans of Lamesa who waded knee-deep through fields of poppies to attack an enemy position would feel at home at the American Legion Auxiliary headquarters on the West side of the square this week. The headquarters center is literally knee-deep in poppies as members of the Auxiliary prepare for their memorial poppy sale Saturday. Hundreds of the little blood-red flowers are being unboxed, counted and arranged for the women who will offer them on the streets Saturday.

The poppies have been received from the U. S. Veterans' Hospital, at Legon, Texas, Department of the Auxiliary. They are carefully made replicas of the poppies which grew in such profusion on the battle fields in France. The work of making these flowers, entirely directed and financed by the Auxiliary, has given employment to hundreds of disabled men during the winter and spring.

Auxiliary headquarters is a very busy as final preparations for the poppy sale are being made. Committee chairman and workers are constantly coming and going, completing details of the arrangement. Mrs. Phillip Yonge, general chairman of the activity, estimates that 15 girls will be on the streets Saturday with baskets of poppies for sale.

The workers have been divided into teams, and each team assigned one side of the square. The poppies are being arranged in baskets ready for the workers to take out early Saturday morning and the coin boxes into which poppy purchasers will drop their contribution for the welfare of the disabled and dependents are being made ready.

### ANNOUNCEMENT TO THE PEOPLE OF DAWSON COUNTY

Feeling the great need for an organization that will give relief to bereaved families at times when most needed, and desiring to be able to go into homes and lift a burden instead of seeing undertakers leave another, as they have to do today, therefore:

I will begin within the next two weeks, the organization of the Dawson County Burial Association.

This Association is for the benefit and protection of Dawson county citizens, and will be possible only by and through your assistance and co-operation.

I have taken this plan for our mutual benefit and protection, and my ad next week will briefly explain the plan, as it is especially for the benefit of those who are not able, at all times, financially, to lift this burden when needed, but it gives equal benefits and protection to all, regardless of financial condition, as all pay alike and share alike.

Your assistance and co-operation will enable me through our association to relieve the burden and embarrassment that falls heaviest with bereavement.

All money paid into this Dawson County Burial Association, remains in this county, as there is no other office or officers outside the county, and no money leaves the county, except when some member dies outside the county.

### THE CRIMINAL INVESTIGATOR by PEARL P. GIBSON

For more than twenty years I worked in law offices in small towns and cities of Texas, and during that time helped in preparing hundreds of criminal cases for trial, besides doing considerable special investigation for clients, going out of the state in more than one instance in connection with the work.

My experience covered so long a period of time, and such a variety of cases, that I seldom analyze my own reasoning without some incident arises that makes me traverse the reasons for arriving at a judgement.

Had Charles Lindbergh, with no more to recommend him to the public attention than the fact that he was practically obscure son of a poor congressman, it is scarcely probable that a child of his would have received any attention from the criminal world.

Had the kidnapers only been interested in money, they would probably have selected the child of a wealthy, but more obscure parents, or, having ascertained the financial standing of the Lindbergh connections, would have demanded much higher ransom.

Colonel Lindbergh's personal achievements having placed him in public attention, even above kings and presidents, made his household the target of ambitious criminals, and it is possible that their own boasting will be their undoing, and eventually bring them to justice.

A criminal lawyer's work gives him the inside of crime, the motives leading up to the act, as well as the consummation of the act, and so he comes to know more of the inside story than the judge or jury, because he must know the facts in order to guard against surprises, and be able to direct his case.

The very nature of my work has largely placed me apart from my people, but my heart often carries an understanding and sympathy for the suffering of humanity that one who has not had the experiences I have cannot fathom, and I would say to the youth of the country, the criminal seldom embarks upon his career

I will need others to help me, that I may prepare to render this needed relief to the people of this county.

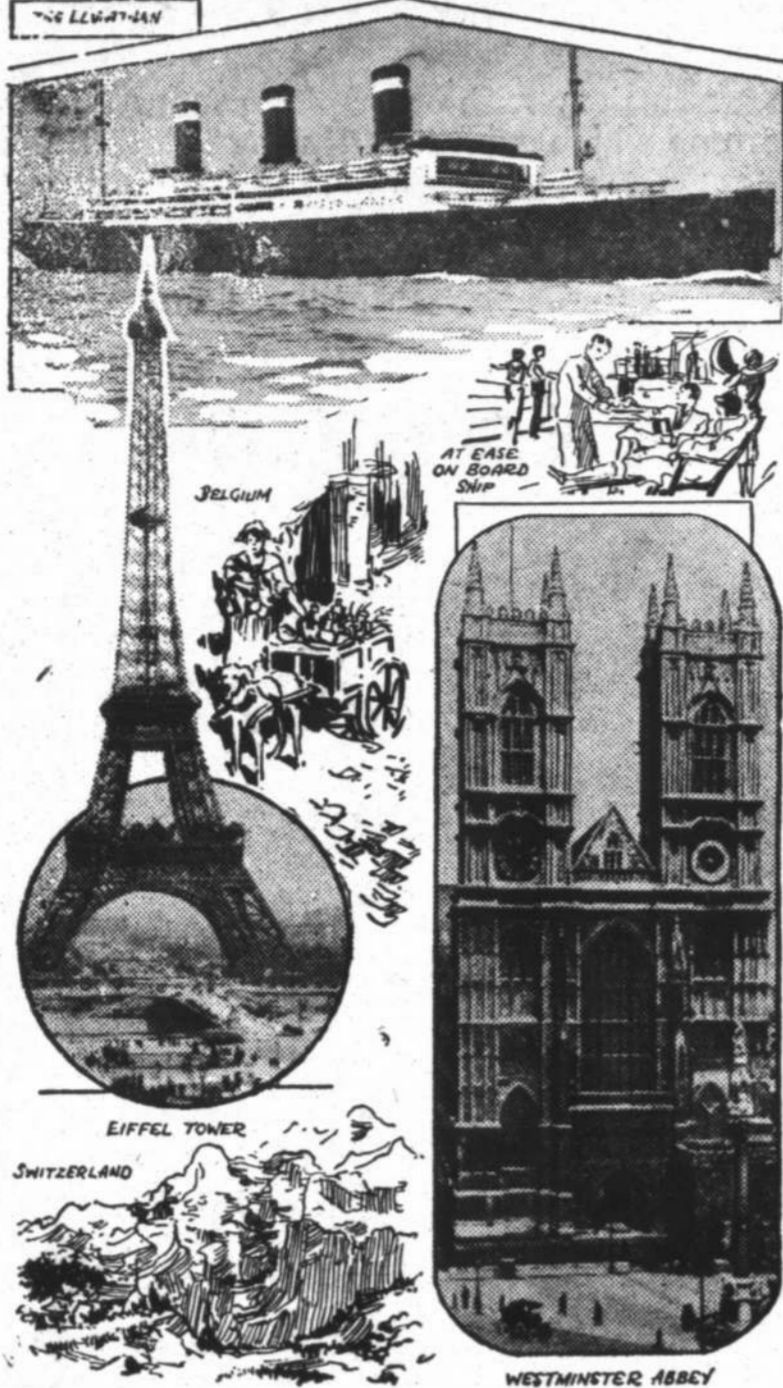

**THE COMPTROLLER'S REPORT**

Did citizens take time to read it, they would find Comptroller Shepard's annual report for the state's fiscal year ending August 31, 1931, a most interesting document.

It reveals, for instance, that every department of state government spent more money from September 30, 1930 to August 31, 1931, than they did in the previous fiscal year. Legislative expense increased from \$258,951.34 in 1930 to \$707,321.08 in 1931; the judiciary spent \$2,721,340.39 in 1931 as compared with \$2,512,328.39 in 1930; the cost of operating the executive and administrative departments rose from \$911,313.66 to \$1,049,233.66; support of free schools became three-quarters of a million dollars more expensive; it cost approximately \$300,000 more to operate the penal and eleemosynary institutions of the state. Law enforcement and maintenance of the militia increased almost \$60,000, and the comptroller's figures do not reflect the cost of military oc-

cupation of the East Texas oil fields; that expense was incurred after August 31, 1931.

We did spend almost six millions less for construction and maintenance of state highways. But since the highway commission gets none of its money from the state's general revenue fund, that lone example of economy will not be reflected in the state's revenue requirements or its tax rate.

In a year when private business was curtailing expenses, cutting corners, reducing overhead and economizing in every possible way, the state government went ahead and spent more money than it did in the fiscal year of 1929-1930. If the reduced costs of supplies and materials is taken into consideration, it becomes apparent that the state actually is saving money.

There is ample opportunity for tax reduction in Texas.

**DUBOSE ANNOUNCES AS CANDIDATE FOR JUDGE**

After due deliberation I have decided to enter the race for county judge of Dawson county.

I wish for it to be thoroughly understood that there is nothing personal, so far as I am concerned, between the present judge and myself. No doubt that our ideas are widely different in some respects, but every one has the right to his own opinion, even if it is wrong.

I have never believed that high taxes are essential to prosperity but I have always believed that the path of high taxes leads to economical destruction. The history of fallen nations is replete with proof of this and our present state of chaos emphasizes the same thing. High tax ideas usually come from the scheming of designing persons and are put over by their unsuspecting followers.

Some say that taxes cannot be reduced. I have heard them say that cotton cannot be raised for less than 20 cents a pound. Yet we are raising it slightly below those figures, so we taxpayers are put to the ridiculous impossibility of paying the same amount of taxes on practically no income. Please note that the ones who say they are not too high or that they are about as low as possible are those who directly or indirectly reap the reward of high taxes.

I know of but one way to reduce taxes and that is to reduce the cost of government. I would begin by reducing the salaries, and the county judge's would head the list. I am not willing to see all government officials draw the same pay they have been drawing when those who are paying it are in almost destitute circumstances. I do not expect to be the commissioners' court entirely but I have enough confidence in the people who are elected commissioners to believe that at least two commissioners of any court are willing to share the burden of these times with those who have honored them with the office.

If I am elected county judge of Dawson county you are going to hear of something being raised over in that office and it won't be the cost of government either. Give me the other officers necessary and you may reliably expect us to tie into these high taxes with a bull dog grip and chew and choke as much as possible until the cost of government shall be at least somewhat in proportion to the income of the taxpayers.

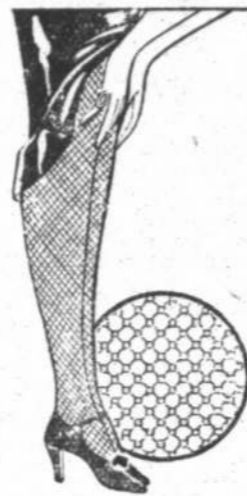

### Lesson for May 29

#### JOSEPH THE DREAMER

LESSON TEXT—Genesis 37:1-11.  
 GOLDEN TEXT—Recompense to no man evil for evil. Provide things honest in the sight of all men.

PRIMARY TOPIC—A Boy's Dream.  
 JUNIOR TOPIC—A Boy's Dream.  
 INTERMEDIATE AND SENIOR TOPIC—Right and Wrong Ambition.  
 YOUNG PEOPLE AND ADULT TOPIC—Right and Wrong Ambition.

I. Joseph the Favored Child (vv. 1-3).  
 Joseph was Jacob's favorite son. This favoritism expressed itself in a superior position and more respectable clothes. That Jacob should feel partial toward Joseph perhaps was inevitable, but that he should manifest it was extremely unwise.

II. Joseph Hated by His Brethren (v. 4).  
 His superior character was a continual reminder to his brethren of their evil deeds. The slight rebuke of a righteous life is hard for the wicked to bear. His father's favoritism fanned this hatred into a flame which at last burst forth upon him. Such parental indiscretion may lead to murder. The good are not always loved.

III. Joseph's Dreams (vv. 5-11).  
 God showed to Joseph by means of these dreams his future. It was right for Joseph to have these dreams because they were from God, but perhaps he was indiscreet in making them known. Often times the manner in which a thing is done offends more than the thing itself.

1. His brothers' sheaves bowing in obedience to his (v. 5-8). This was rightly interpreted by them to mean their subjection and obedience to him. This intensified their hatred of him. It was hard enough for them to endure the father's favoritism, but to have this dream narrated, which pictured his rule over him, was more than they could endure.

2. The sun, moon, and eleven stars rendering obedience to him (v. 9-11). This dream is wider in its application than that of the sheaves. The eleven stars are identical with the eleven sheaves. The sun and moon is rightly interpreted by his father as representing his father and mother rendering obedience to him. This dream created within his father's mind a suspicion of a lurking ambition of selfishness and vanity in Joseph's bosom. He rebuked him for it, but possessed the good sense to observe it. The hatred of his brethren revealed itself in envy.

IV. Joseph Sent by His Father on a Mission of Mercy to His Brethren (vv. 12-17).  
 His brethren had gone to Shechem, about fifty miles distant from Hebron, where was abundance of pasture for their flocks. Jacob became anxious about their welfare and sent Joseph to find out their condition. Knowing the attitude of his brethren toward him, he no doubt realized that his mission was fraught with grave danger. It means exposure to highway robbers, wild beasts, and the murderous hatred of his brethren. Undeterred by the envious hatred of his brethren, he willingly responded, "Here am I."

V. Joseph's Reception by His Brethren (vv. 18-28).  
 As soon as they saw him their hatred began to burn.

1. Their murderous plot (v. 18-22). They said, "Behold, this dreamer cometh. Come now therefore, and let us slay him." They thought to prevent these dreams from coming true by destroying the dreamer. Reuben dissuaded them from this act by proposing to cast him into a pit, thinking to rescue him and return him to his father.

2. They stripped him of his coat of many colors and cast him into the pit (vv. 23, 24). In spite of his earnest entreaty against this wicked act, they perpetrated this heartless cruelty (Gen. 42:21).

3. Their feasting (v. 25). Their heartlessness manifested itself in their enjoyment of a meal, perhaps within the sight and hearing of Joseph's cry.

4. Sold to the Ishmaelites (vv. 25-28). In the providence of God, these merchantmen passed by at the opportune time. Judah proposed that they sell him, as no gain could accrue from letting him die in the pit. Having done this infamous deed, they sought to cover it up by lying and deceit. They took his coat of many colors and dipped it in the blood of a kid and sent it to his father, allowing him to draw his own conclusion as to the matter. Jacob is now reaping what he had sown. Many years before this he had wronged a brother and deceived his father by trickery and lying.
