Delphian Club To Sponsor National Girl's Week Here

In cooperation with a movement of the General Federation of Womens' Clubs to establish a National Girls' Week, the Lamesa Delphian Chapter voted at their last meeting to observe the first week in April as Girls Week. With Mrs. L. M. Pratt chairman of arrangements, they asked the cooperation of all Womens' Clubs, Service Clubs, Schools and Churches of the city.

One feature of the celebration will be a Girls' Parade and the Delphians will be hostess at a Mother and Daughter tea on Saturday afternoon, April 8, at the Club House from three to five o'clock. A program will be given by the girls of Lamesa and a cordial invitation is extended to all mothers of the community to attend with their daughters.

District 8 S. S. and Baptist Training Service Meet in Snyder

Snyder, March 25. (Special)—The annual District 8 Sunday School and Baptist Training Service Convention, which will meet here Tuesday and Wednesday, March 29 and 30, will headline some of the outstanding Baptists of the State on its program. For this reason, and because the Snyder church is extensively advertising the meeting a crowd of 400 or 500 persons is expected from the nine counties of the district.

The Tuesday morning service, opening at 9:30 o'clock with a song service and devotional led by Willard Jones of Snyder, will feature an address on "The Baptist Training Service in Our Modern Age" by Miss Pauline Wright, young peoples leader of the First Baptist Church, Lubbock. "Every Sunday School Promoting a Library" by W. C. Blakenship of Big Spring; seven conferences on Sunday School Work, and an address by Rev. R. C. Campbell of Lubbock on "Growing a Great Church."

G. S. Hopkins of Dallas, head of Baptist Sunday School work in the state, will talk at 2:00 o'clock the song service opening at 1:30. After four conferences on the R. T. S., Rev. Vinston Borum of Midland will speak on "The Whole Church in the Training Service," and J. D. Carroll, educational director of the First Baptist Church, Lubbock, will talk on the Baptist Every-Member Canvass. This afternoon meeting will adjourn at 4:40 o'clock.

Dr. J. C. Hardy, president of Baylor College, Belton, will speak at the Tuesday night service. Rev. Willis Taylor of Lamesa will lead the song service and devotional, opening at 7:30 o'clock, and Rev. S. B. Hughes of Big Spring will speak on Sunday School work. After the Snyder church plays host at an entertainment, in the church basement, guests will be furnished bed and breakfast without cost. Lunch will be served by the Snyder W. M. S. Tuesday.

The Wednesday morning devotional and song service, beginning at 9 o'clock, will be conducted by Mr. Baleh of Big Spring. Miss Daisy Lewis of San Angelo will then conduct a general B. T. S. conference, followed by a general Sunday School conference under direction of C. C. Taylor of Lamesa. After the business session, Rev. John Cobb of Rotan will speak on "Daily Vacation Bible School," and Rev. Phillip C. McGhey, host pastor, will conclude the two-day program with an address on "Utilizing the Church Organization in Winning the Lost." In addition to the features mentioned, several musical numbers by the leading singers of the district have been arranged.

For one year the West Texas Chamber of Commerce has been working on definite plans for reducing taxes. Houston Hart, present president of the organization, has worked diligently on this one phase of the work and creditable results have already been seen. More than one million dollars have been reduced in the budget of various local governments for the current fiscal year.

Credit goes to this, our own West Texas organization, for calling on the last session of the legislature asking them to cut expenses rather than to impose additional taxes. The South Texas Chamber of Commerce approved a brief which they submitted to the legislature, contending the way to reduce taxes is to reduce them rather than to levy additional ones.

The Trade at Home Idea

Few years ago, we heard lot of talk about how to combat the mail order business. Today, business interests have little to say about this because they have learned to combat it by modern methods of merchandising. The least said about the mail order business, the better for the "Trade at Home" idea, it is believed. Merchants now-a-days have learned they can get the business that is going out of town if they can supply the kind of goods wanted at a price which is reasonable.

Merchants have learned how to buy, how to display, how to advertise, and how to meet a demanding public. They have learned that the old style of waiting for the customer to call at the store and ask for his needs is obsolete. The job has to be done in a modern manner. The customer must be sought. He must be attracted to the store, and when he has once gained entrance, he must be met courteously and shown quality goods at a price in line with what the same goods can be purchased from a near by competitor, or else the customer passes on and a sale is lost. The customer does not look for schemes, although many schemes are interesting. He is looking for quality goods, right prices, fair and courteous treatment. Here is where the home merchant has the advantage of the mail order establishment. The mail order house is too remote, and cannot supply that personal touch so necessary in these modern days of selling.

A teacher went into a certain business house not long since and called for a certain kind of shoe. The merchant told her he was sorry, but he did not stock this shoe. The teacher left this store and straightway went to another town and purchased the shoe she wanted. Why? First, she felt duty-bound to buy from the home mer-

Pyramiding business—Mass Production—High Powered Salesmanship are terms which were coined during a period of unwholesome growth, and for the present had best be junked. Some of those terms we may be able to salvage later, but we have pyramided, massed and highpowered until the topheavy structure toppled, and in the midst of the disaster fear caught us and completed the havoc. But we've reached bedrock at last, and with true American resiliency are going about practical reconstruction.

Since the first of the year there are long lists of newly chartered industries with conservative capital stocks, which mean that to a large extent different communities are making ready to take care of their own raw materials. Many more banks have opened since the first of the year than have closed. If any millions of dollars are being spent in the state on irrigation projects; for we know that water, soil and labor make a combination and with facilities to handle excess raw materials will prosper.

Industries which may be handled without too much expense are to be encouraged—over development along industrial lines—which may prove profitable under some conditions, may prove a boomerang in adversity.

A community spirit of co-operative development, with friendly competitive rivalry is the soundest basis of development.

Our country is fortunate in many things. The fact that it had not reached the state of over development industrially, and most of all in the quality of its citizenship, and practical insight of its leaders.

Lesson for March 27

JESUS RISES FROM THE DEAD

LESSON TEXT—John 20:1-9.
 GOLDEN TEXT—But now is Christ risen from the dead, and become the first fruits of them that sleep.

PRIMARY TOPIC—Jesus Living Again.
 JUNIOR TOPIC—Jesus the Conqueror.
 INTERMEDIATE AND SENIOR TOPIC—Loving and Serving the Risen Lord.
 YOUNG PEOPLE AND ADULT TOPIC—The Fact and Meaning of the Resurrection.

I. The Empty Tomb (vv. 1-10).
 John does not enter into a description of the resurrection of Christ or give any proof other than that the tomb was empty, and that Jesus had repeatedly manifested himself after the tomb was found empty. "To see the body of Christ with a spear-thrust and nail prints and the empty tomb was all that faith needed."

1. The testimony of Mary Magdalene (vv. 1, 2). This woman, out of whom Jesus had cast seven demons (Mark 16:9; Luke 8:2), announced the fact of the empty tomb to Peter and John. Prompted by great love to him for his kindness to her, she went early to the tomb even "when it was yet dark."

2. Personal investigation by Peter and John (vv. 3-10). The news of the empty tomb which Mary brought with breathless haste so moved John and Peter that they both ran to investigate. When John came to the empty tomb, he gazed into it, but when Peter came he entered it. This investigation convinced them of the reality of the resurrection. The removal of the stone from the sepulchre, the arrangement of the grave clothes, convinced them that the enemy could not have done this.

II. The Manifestations of the Risen Lord (vv. 11-29).

1. To Mary Magdalene (vv. 11-18).
 a. Mary weeping at the empty tomb (v. 11). Peter and John went home, but Mary could not. She stood weeping. Home was nothing to her while her Lord was missing. Earnest love need not to weep long for Jesus is found of those who love him. She should have been rejoicing that the grave was empty, for the empty tomb was eloquent proof of his messianicship and deity.

b. Mary questioned by the angels (vv. 12, 13). Through her tears, she saw angels at the tomb, who inquired as to the cause of her sorrow.

c. Jesus revealed himself to Mary (vv. 14-16). She first saw the angels and then her eyes lighted upon the Lord. She did not recognize him in his resurrection body, but his voice was familiar to her. As soon as he called her by name, she recognized him and fell at his feet weeping.

d. Jesus forbade her to touch him (v. 17). This showed that she was coming into a new relationship to him.

e. Mary's testimony (v. 18). She told the disciples that she had seen the Lord.

2. To the disciples (vv. 19-29). He appeared to several of his disciples at different times during the day. This is the first appearance to the disciples as a body. The rumors of his several appearances on that day caused the disciples to assemble to talk over the matter. For fear of the Jews, they met in a private room and barred the door. While they were discussing the strange happenings of the day, the Lord mysteriously appeared to them.

a. When Thomas was absent (vv. 19-23).
 (1) His message of peace (v. 19). This revealed his attitude toward them. He did not come with censure for their failure and desertion.

(2) He showed his hands and his side (v. 20). Having calmed their fears, he gave them unmistakable evidence of his resurrection.

(3) He commissioned them (v. 21). "As my Father hath sent me even so send I you." This commission was not simply to a class, as the eleven, but to all Christians (Luke 24:33).

(4) He bestowed the Holy Spirit upon them (v. 22). This was their equipment. Only as empowered by the Holy Ghost can one go forward as a successful witness for Christ.

(5) The disciples' authority (v. 23). This authority was not by virtue of office, but by virtue of having the Holy Ghost. This spiritual gift gave spiritual discernment to know who had or who had not repented and consequently to pronounce pardon or withhold it.

b. When Thomas was present (vv. 24-29).
 (1) The victory of sight and touch (vv. 24-28). The Lord graciously supplied the evidence which Thomas needed. The Lord does not rebuke those who sincerely seek light.

(2) Greater blessing for those who believe, not having seen (v. 29).

How Can A Farmer Get A Federal Farm Loan

Some of the details regarding the requirements for federal farm loans as quoted in an official government bulletin are quoted below:

WHAT IS THE SECURITY REQUIRED?

Each individual who obtains a loan for crop production in 1932 must give an absolute first lien on all of the crops growing or to be grown by him in 1932 in such form as to entitle it to filing in the county in which he resides.

HOW LARGE A LOAN CAN I OBTAIN?

The largest amount which can be loaned to an individual is \$400. The amount loaned will be based on the requirements of the applicant for seed, fertilizer, feed for work stock, and fuel and oil for tractors, and other necessary supplies, and the acreage of crops on which he gives a crop lien to secure the payment of the loan made to him. Loans may be approved in less amounts than that for which application is made.

WHAT MUST I DO IN ORDER TO OBTAIN A LOAN?

You must make application on Form No. 2 furnished by the secretary of agriculture and accompanied with a note (Form No. 3) crop mortgage, lien, etc., as detailed in answer to question 10 (Form No. 4) and voucher (Form No. 5) on the proper forms, sending all to the regional office for your state as shown in answer to question 2.

If the applicant for a loan is a tenant, or is farming land under contract for deed or so called contract, or has given a prior mortgage on his 1932 crop, he must secure the waivers of the actual owners of the land, his landlord, and of all prior mortgage holders in the space provided on the mortgage form for the purpose. If the applicant is the owner of the land and farms it with ten-

ants or share croppers, the waivers of such tenants or share croppers must be secured in the space provided on the mortgage form for the purpose. If the applicant leases the land from another and in turn operates it with tenants or share croppers, waivers of both the actual owners of the leased land (unless the rental of said land has been paid) and of said tenants or share croppers must be secured in the space provided on the mortgage form. In all cases where waivers are required (except from tenants and share croppers) the person waiving must certify that at the time of signing such waiver he is in actual possession and owner of any rent note, mortgage, land sale contract, or other paper, and must enter into an agreement on this form that he will not assign, hypothecate, or sell such security without first having secured the written consent of the duly authorized agent of the secretary of agriculture; and, further, that in the event advances are made in compliance with pertinent regulations of the secretary of agriculture, for the purpose of harvesting and marketing of said crops, it is agreed that the money so advanced may be repaid from the proceeds derived from the sale thereof prior to the satisfaction of any lien, claim or interest of the signor.

What are the penalties for false representation in obtaining this loan?

The law provides that any person who shall intentionally make any material false representation for the purpose of obtaining an advance, loan or sale, or of assisting in obtaining such advance, loan, or sale under this resolution shall upon conviction thereof be punished by a fine not exceeding \$1,000, or by imprisonment not exceeding six months or both.

Can a tenant obtain a loan from this fund?

In order for a tenant to obtain a loan from this fund his landlord must sign the waiver, which is a part of the mortgage form, but in no case will the tenant be granted a loan if his landlord has applied for or has granted a loan. The total of all loans to tenants of any one landlord within a single county shall not exceed \$1000.

When and how will the money be advanced?

The right is reserved to make payment of the loan in installments. On receipt of the complete documents, and approval of the application by the designated agents of the secretary of agriculture at the proper regional office, initial payment on the loan will be made. The amount of each installment will be determined by the secretary of agriculture thru a designated agent.

Will the installments be paid automatically?

Before the second installment is paid, the borrower is required to report to the regional office how the first installment has been expended. A form will be furnished for such a report at the time the first check is sent. In the case of loans paid in three installments the right is reserved to ask an accounting for the second installment before the third is paid. In order to secure subsequent installments the borrower must report expenditure of the initial installment not later than June 1, 1932.

What rate of interest is charged on the loans?

Interest at the rate of 5 1/2 per cent will be charged on all loans. As all notes are due Nov. 30, 1932 interest from the date of approval of the loan to Nov. 30 will be deducted from the principal of the loan when the advance is made.

If application is granted for a less amount than applied for how will the fact be indicated?

On approval of your application you will be notified of the amount for which your loan is approved. If this is less than the amount for which you applied proper cred-

it for the reduction will be shown on your note, mortgage, and voucher.

If an application is finally disallowed, what will be done with the papers?

If an application is finally disallowed, and voucher will be returned for any reason, the note, turned to the applicant. The application itself will be retained as a part of the records in the case.

When and how is the loan to be repaid?

The notes are due and payable Nov. 30, 1932, or sooner if the crops covered by the mortgage are sold prior to that date, and will bear interest at the rate of 5 1/2 per cent per annum. As noted in the reply to other questions, interest to Nov. 30, 1932 is deducted at the time the last advance is made on the loan.

WARNING TO BOYS WHO FLY KITES

A warning to the parents of boys who fly kites was issued Monday by officials of the Texas Electric Service Company, who called attention to the danger that is incurred by flying kites near electric wires. Serious accidents have resulted from kites becoming entangled in wires and the subsequent efforts of boys to get them down.

"Boys should be cautioned to fly kites in open places," the power company officials declared. "If kites become entangled in the electric wires, under no circumstances should boys try to get them down. The Texas Electric Service Company will gladly send out trained men who understand the dangers of high voltage current to remove the kite."

"Kites with metal frames and the use of fine wire instead of cotton string are two other great hazards, for if the metal frame or the wire string comes in contact with electric wires, serious injuries may result and electric service to a large part of town may be interrupted."

Employees of the power company may visit local schools in the near future with a verbal explanation of the hazards of kite flying.

HAVE YOU HAD YOUR INGREDIENT "X" TODAY?

St. Louis, Mo., March 15. Special "Cluck, cluck. Have you had your ingredient X today?" Such will be the daily interrogation of mother hen to baby chicks as the result of an announcement today of the development of Ingredient X in the research laboratories and on the experimental farm of the Purina Mills.

"Ingredient X," explains Dr. H. J. Smith, in charge of the research work which developed this new factor, "is simply the blending together of the proteins in a ration in such a way as to make them work together perfectly, much like the gear wheels of an automobile. In other words, Ingredient X is proteins synchronized or properly meshed together."

Not all proteins, Dr. Smith says will work together. The protein combination that will make milk will not necessarily produce growth in chickens economically.

In beginning this far reaching protein study some six years ago, many sources of protein—all that can be obtained in commercial quantities—were used in many and various combinations and fitted with what is known as a basal ration made up of the carbohydrates, fats, vitamins, and minerals known to be essential to growth.

Proteins were studied singly and finally in many combinations in order to get the right combination that would work together and produce in chicks good feathering, rapid growth, high livability, palatability and still not be prohibitive in cost. The right combination of proteins was finally found.

The experiment involved the studying of some 52,000 chicks in battery brooders and on the Purina Experimental Farm. They were weighed 308,502 times in order that everything be checked to the minutest detail.
