

Entrance Examination Schedule Announced For Advanced Pupils

September Seventh has been announced as the opening date for the Lamesa Public schools with entrance examinations to be held on September Fourth at the high school building for those pupils who expect to enter the eleventh grade from unaccredited schools.

The entrance requirements concerning vaccination certificates against smallpox, bringing receipted book cards for State owned text-books if a pupil was in a Texas school last term and bringing last terms school report apply to both schools. Credits from other Dawson County high schools are being furnished Mr. McCollum from the county superintendent's office for those pupils whose grades are recorded in Miss Busterbaums office. Free high school tuition pupils from other counties than Dawson must make application for proper forms to their respective county superintendents and present those forms to the Lamesa high school principal at the time of admission.

The examination schedule is as follows: Plane geometry, room 109, 8:30 A. M.; Arithmetic, room 109, 9:30 A. M.; English, room 110, 10:30; American History, room 110, 1:00 P. M.; Spanish, 1st year and 2nd year, room 109, 2:30 P. M.; Civics, room 109, 4:00 P. M.

Pupils will be expected to be on time for each examination to be taken and all pupils who have not already taken the tests and passed will be expected to appear on Friday for the reason that teachers will be busy from the opening day on and tests can only be given as they find time, thus pupils who do not appear at the appointed time may suffer considerable delay before being admitted to classes. These examinations are a State Department requirement for accredited schools which must be observed.

Pupils from other high schools who have moved to Lamesa School District should bring proper credentials for a conference with Mr. McCollum on Thursday, Friday or Saturday, September 3, 4 or 5 in order to plan subject scheduled and it is asked that such pupils appear in the forenoon because of the football team practice directed by Mr. McCollum in the afternoons.

Vaccination Will Be Required Of Pupils Entering School

Children enrolling in the Elementary school must present book cards and report cards from school attended last year. The state Textbook Law strictly forbids the issuance of books to any pupils who cannot show clear records from the preceding year.

Vaccination against smallpox is required of all children who have not had the disease or who have not been vaccinated. Records are on file in the local school for children who have attended here before but children attending this school for the first time must present certificate of immunity signed by a medical doctor regardless of whether or not such child has had smallpox or vaccination. Enrollment cannot be completed until the above mentioned requirements are met.

Complete announcements concerning assignments and paces of enrollment will be found in this paper next week. Children should watch for these announcements and be prepared to report to their respective rooms with as little confusion as possible.

The principal of the Elementary school will be in his office most of the week preceding the opening of school to give any assistance to pupils with irregularities. Children who do not have book cards and report cards will find this a convenient time to straighten out such records and thus save a great deal of time and confusion on opening day.

Parents are urged to start all children of scholastic age to school on the first day and keep them there as long as possible. Children expecting to pick cotton this fall will find it to their advantage to begin when school opens and attend until jobs are secured after which time they may withdraw. A special effort will be made on the part of school people to see that every child in the district is enrolled and kept in school unless there are legal reasons for non-attendance.

Second Primary Closes Political Year In County

Ring down the curtain on county politics, the second primary last Saturday completed the Democratic nominations for precinct, county, and state offices, which is equivalent to election in this county.

In the county races, W. M. Yates received the nomination for County Judge with a majority of 575 votes. R. W. (Buster) Herndon was nominated tax assessor-collector by the narrow margin of 49 votes.

With the nomination of Sam Hodge as Commissioner in Precinct 2, and Oscar Kelley in Precinct 3, the entire present set of commissioners were re-nominated for another term, as the other two won their race in the first primary.

J. W. Howell was elected public weigher for Precinct 1 with a majority of 584.

Hunters Getting Ready For Opening Of Game Season

T. A. Harris, state game warden for this territory reminds us that with the hunting season soon opening on some of the game, it might not be amiss for us to recall some of the regulations which are placed on this sport.

There will be a short season in which prairie chickens may be hunted, only four days, September 1, 2, 3, and 4. The birds are reported very scarce this year. September 1st will also open the season for dove. This season will last until October 31.

Quail season opens December 1, and lasts until January 16. Borden and Glasscock counties which have had a closed season for some time, will be open for quail hunting this year.

The duck season will last one month, from November 25 to December 25. One regulation which applies to duck and dove hunting is the one which limits the hunter to carrying only three shells in his gun at a time. This also applies to dove hunting. A federal law allows nothing but shot guns to be used on these migratory birds.

One of the main things to remember is that you are required to have license to hunt. These licenses may be secured at any local hardware store or sporting goods house. So you had better get them before you start out or it might cause embarrassment if the game warden asks for them.

Public Library Dream Realized

Word came to Judge Philip Yonge last Friday that efforts of both the county and city commissioners had not been in vain, because the project regarding the government paid library had been approved.

Mrs. Mary Dalbridge, district supervisor of this project, mailed requisition papers for two librarians and promises the services of a third at an early date. Monday morning, August 24, Miss Ruth Terrell and Miss Perna Rush were assigned duties and will be found in the library mending books, mailing cards to holders of overdue books and serving the people to the best of their ability.

The securing of their services does not increase government expenses, but simply means transfer of them to a more important service for the public. No charge will be made for library membership but books which become past due without renewal service necessitate penalty fees.

Library hours at present are from nine until six every day of the week. There is a constant demand for magazines which readers may contribute.

Three Bales Cotton Ginned In Lamesa Monday Morning

In a neck and neck race for first bale honors, Kenneth Cox, living two miles east of Lamesa brought the first Dawson county cotton for 1936 to the McDonald gin last Monday morning. However a Borden County man, N. W. Minnick, of ten miles north of Gail, had already brought in a load of cotton and had it ginned at the Tinsley Gin, getting a 425 pound bale, the first ginned in Lamesa.

And in a short while, Mr. Ray, from three miles north of town brought in the third bale to be ginned and the second of Dawson county cotton, to the Tinsley Gin.

Late Monday afternoon, H. H. Barran, Lamesa's well known auctioneer, sold the three bales to the highest bidders on the west side of the court house lawn. The first bale of Dawson county cotton was auctioned first, and after spirited bidding by Sam Richardson of the Self Serving Grocery, who opened the bidding at 15c, and C. Baldwin of the Baldwin Store, and Geo. Norman, manager of Higginbotham-Bartlett Co., it was purchased by Higginbotham-Bartlett for 18½c, the 525 pound bale bringing Mr. Cox \$97.13 which was a neat premium over market price. In addition to the sale price, Mr. Cox received a premium of \$41.00, donated by the various Lamesa merchants through the Chamber of Commerce Secretary, Mr. A. G. Bearden.

The Borden county cotton, which was ginned from snapped cotton and having a short staple of barely 7-8 in., was put up by Mr. Barran and bought by Walter Jones, for Tinsley Gin, at 14c a pound. This netted Mr. Minnick a nice premium, and he was also given a cash premium by the Chamber of Commerce of \$20.50, for the first bale of cotton from the Lamesa trade territory to be ginned here.

Then the bale of cotton belonging to Mr. Ray, weighing 406 pounds and ginned from picked cotton, was auctioned off and sold to Tinsley's Gin for 14c a pound.

This was an unusual situation, and the fact that all three bales were bought by Lamesa boosters for premium prices, speaks well for the spirit which this city displays towards the producers of this trade territory. Even Lubbock, our big sister on the north, could raise the bid on her first bale, Tuesday, to only 15½ cents. The Lamesa spirit is appreciated by the producers too, as was shown when Mr. Minnick brought his cotton from ten miles north of Gail to Lamesa to be ginned. Mr. Minnick brought his cotton into town late Sunday.

Merchants who stand behind their trade territory as these men do should not have to worry about outside and mail order competition, for they deserve, in turn, the trade of those with whom they co-operate.

This concluded the picnics for the year. However, everyone had such a good time that they voted to hold another one which will be held at the call of the Entertainment Committee some time during September at which time all members will be notified in order that they may be on hand.

Screw Worm Flies Develop In Animals

Screw worm control depends a great deal upon a proper understanding of how screw worm flies develop.

The true screw worm lives only upon the healthy flesh of animals. It is the young of a certain kind of fly, and is called the true screw worm because it is the harmful parasitic species. It is usually the first to lay its eggs on the broken skin of an animal. This injury may be a cut, scratch, tick bite, or wound of any kind.

The true screw worm fly breeds only in living animals. Joe E. Clayton, district supervisor of screw worm control in this area, with headquarters at Gall, Texas, gave a few facts about the life history of the screw worm fly. From 10 to 400 eggs are laid on the wound; young maggots appear in 11 to 21 hours. They immediately burrow in the flesh and feed in clusters, forming pockets in the wound.

Unless the animal is found and maggots killed, these maggots drop from the wound in 4 to 10 days and go into the ground, where they change into flies in 10 to 14 days. The flies then mate and the females are ready to lay eggs in 6 to 10 days. The total cycle requires from 18 to 37 days, usually averaging about 24 days.

Mr. Clayton will be glad to demonstrate the use of benzol and pine tar oil in the screw worm treatment.

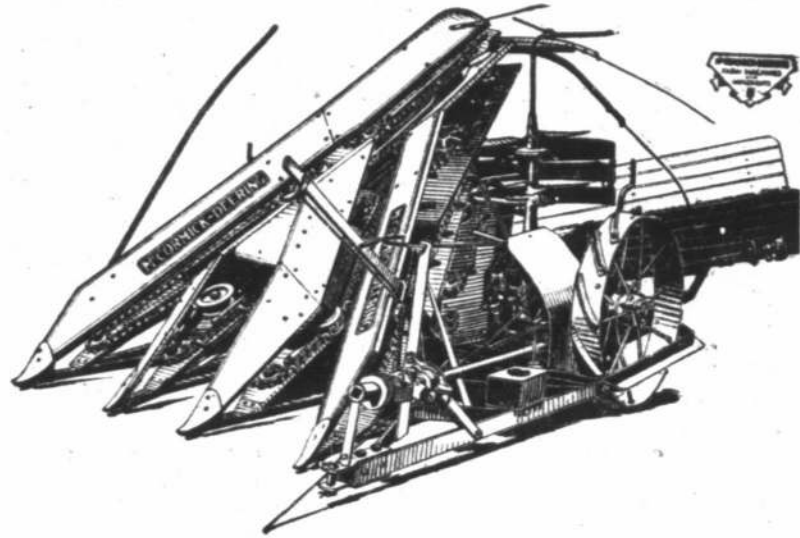

Story of Wardrobe Work—Mrs. Tipton

In planning for a \$50 wardrobe I spent \$12.26 for dresses, \$8.92 for footwear, \$5.00 for underwear. I haven't spent anything for headwear, \$4.20 for accessories and cosmetics, making a total of \$30.38. This means that I have a balance of \$19.62 to spend on something else that I can use in my house.

I began my wardrobe work with a determination to learn how to make any money go farther and still be dressed neatly, and to help my club women, neighbors, and last but not least, my daughters. I believe the work that I have done will show up for years to come through the ones I have helped.

Our club goals are for every club woman to have a foundation pattern and to know how to use it. Seventy-five per cent have reached this goal. We have fourteen regular members. About half of them have completed their patterns and have learned to use them with great success. We have made patterns for four non-club members who have used them. I have made fifteen patterns. One of our club ladies made a pattern for her mother, which makes sixteen patterns we have made.

I have helped the Bartlett Club ladies to start their patterns, make one and started another.

I have made eight garments for people besides my family and helped to fit four. There have been eight closets built and three remodeled. We did not have a closet in our house when I started my wardrobe work, so my daughter and I started to work and made a double closet. We fixed one end for the men folks and the other end for our clothes.

I used a broom handle to make a rod on which to hang our clothes with a storage space for quilts and hats, or anything we wanted to use it for. I made a shoe rack out of scrap lumber and I make a stocking bag out of feed sacks and hung on the closet door. I papered it all inside with real light paper. I can open my closet door and air my clothes by raising my south window in my bedroom.

The total cost of the closet was \$1.50. I would not take anything for what I have learned in my wardrobe work, and I feel like I could not have saved as much if I had not been wardrobe demonstrator.

I have made by my foundation pattern 6 dresses and 5 slips.

The women of the club have made 81 dresses, 10 slips, 11 coats, 2 aprons 19 under garments making a total of 123 garments, having been made by foundation pattern.

PRACTICAL COOKERY

It is often economy in labor to cook more food at one time than is used for one meal. But the problem of combining foods into entirely different dishes for the second appearance at the table requires originality and skill in seasoning and in combining natural food flavors.

Certain vegetables which were served plain when freshly cooked can be reheated in a sauce for the second appearance. Corn on the cob can next be served cut off the cob, creamed, or in fritters. Bony cuts of chicken or roasts with left over gravy or broth have many possibilities.

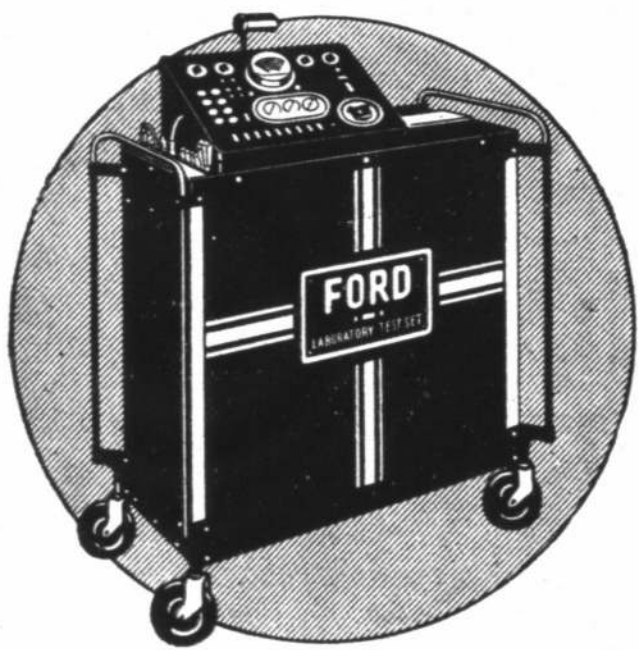

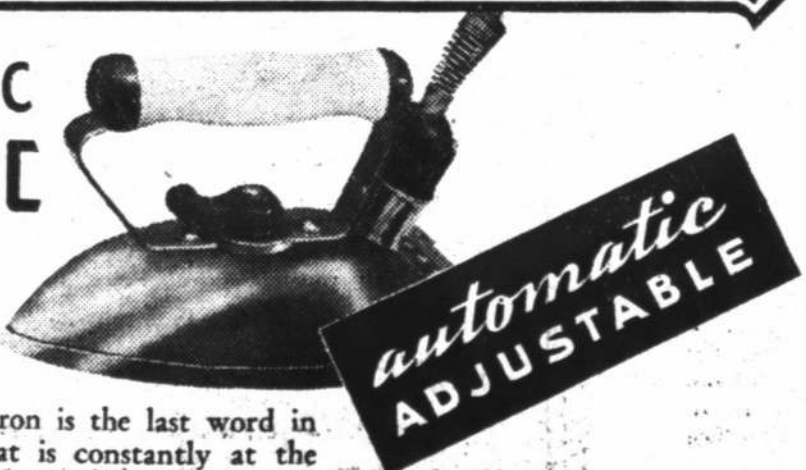

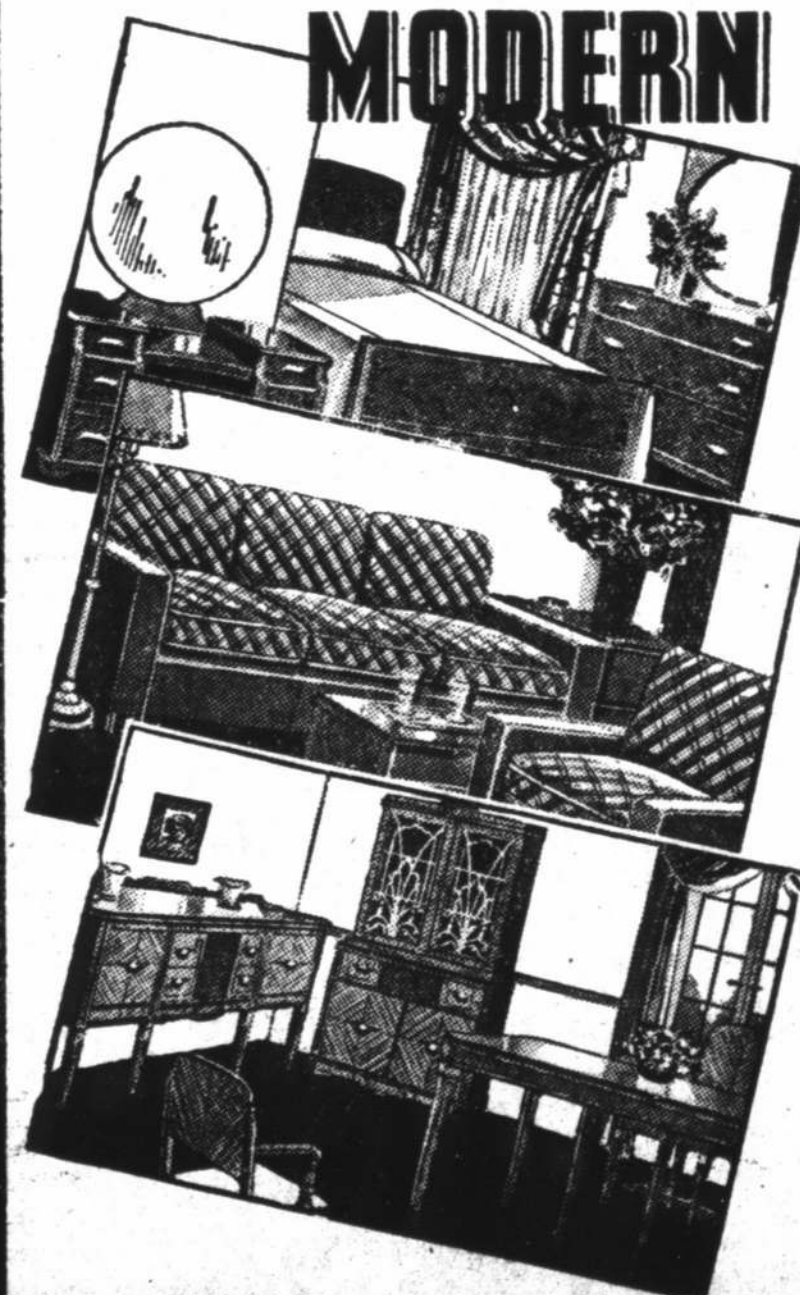

Highway Employees Will Visit Frontier Celebration Aug. 22

Fort Worth—Thirty Thousand employees of the State Highway Department will be given a week-end holiday to attend the Fort Worth Centennial on August 22nd by an order issued by the State Highway Commission received here today.

The Order granting the holiday was passed by the state Highway Commission in response to an invitation extended by J. J. Hurley, city projects agent, who has been appointed to make arrangements for entertaining the huge group of state highway employees.

The order gives the state highway employees a holiday not only on August 22, which occurs on Saturday, but also on the Monday following. All state highway offices throughout Texas will be closed on those dates.

The commission appointed H. H. Allen, its public relations director, to confer with Miss Margaret Hall, chairman of the special days committee of the exposition, and Hurley. Allen will forward an invitation to highway employees in each district to attend the exposition.

Soil Survey Being Made In County

A land use survey to secure data which will enable farmers and ranchers to clearly define their present problems and at the same time obtain the greatest possible benefits from their operations is being conducted in Dawson county by a group of field specialists of the Land Use Planning Division.

The crew consists of Malcolm Anderson, R. L. Bomar, Ralph Gray, Q. R. Rutledge, Fred Goodman and Felix Neff have headquarters in the county agents office and individual information and cooperation will be given anyone contacting them.

This survey will include every possible factor having a bearing upon the lands in Dawson county together with the citizens residing here. It will determine the acres owned and rented by each operator, how many acres of each farm have been in the past several years, the principal crops, total acreage in pasture, the number of acres idle or fallow, an inventory of facilities for the farm and home, and the operator's ideas as to what practices are best for his particular farm.

A soil survey will be undertaken after a close co-operative study is made in land use, farm management and cover surveys. Objective of the cover survey is to determine by actual inspection and study, various types of forage and their bearing on the present use and condition of the land in this region.

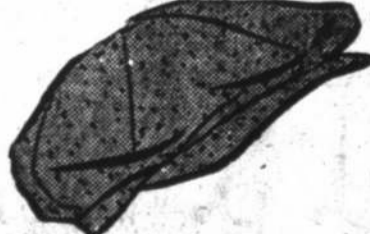
