

Bank Deposits Here Establish Record

Favorable Report Given Beer Bill By Senate Committee; Vote Due As Soon As Economy Bill Disposed Of

House Gives Measure Heavy Majority After Brief But Spirited Attacks By Pros; Measure Would Be Effective In Fifteen Days

WASHINGTON, President Roosevelt's third major proposal of the special session—the Cullen 22 percent beer bill—was rushed through an enthusiastic house to the senate where democratic leaders confidently predicted speedy approval. Upheavals during three hours of debate in which the minority prohibitionists hammered vainly against the administration's revenue legislation, the house overwhelmingly passed the bill, 316 to 67.

Party Lines Shattered
Party lines were shattered. Fifty-eight democrats and 29 republicans, including Representatives Greenwood of Indiana, democratic whip, and Snell of New York, republican leader, voted in opposition.

Supporting the measure that is expected to bring in from \$125,000,000 to \$150,000,000 annually in revenue, 238 democrats, 73 republicans and five farmer-laborites shoved the measure through with applause and cheers. The last house, December 21, passed the bill 230 to 160.

Action came within less than 30 hours after President Roosevelt yesterday sent an unexpected message to congress asking for immediate passage for revenue purposes and fulfill the party's pledge to modify the Volstead act to permit the manufacture and sale of beer.

Action In Senate
Shortly after the measure was received in the senate Chairman Harrison had it referred to the finance committee, and called that group into executive session tomorrow with a view to reporting it for action as soon as the president's now-pending economy proposals have been approved.

Senator Robinson of Arkansas, the democratic leader, said "we want the votes to pass it." The plan is to accept the house bill that levies a tax of \$5 on a barrel of 31 gallons.

Before final passage in the house, Speaker Hines again broke custom and had his name called so he could vote for the bill. Until he became speaker it had been the practice of his predecessors to vote only in case of a tie.

Left to States
The measure leaves all regulatory and control methods to the states; allows advertising; requires brewers to pay an annual license fee of \$1,000 on each brewery; provides for protection to the dry.

Victory
Despite the vociferous opposition to the proposed drastic cuts in veterans' compensation President Roosevelt will be granted the extraordinary powers he seeks from congress.

Through caucus rule the party will back him to a finish. The legislation designed to aid in balancing the budget will not be privileged to the extent of the banking act, which was almost unprecedented. It will be put through the committee routine.

Nevertheless the President has the whip hand. In view of the soundness of the measures he has thus far proposed it is safe to say he can have anything he wants from Congress.

Optimistic
In connection with banking situation Mr. Roosevelt expressed what appeared to be real optimism. He says the outlook is excellent.

Amendments
At the capital it was predicted that certain objectionable features in the banking bill would have to be ironed out. This had been expected.

Time
It was said at the White House if every bank doesn't open the first day it doesn't mean it won't open the next, or the next after that.

"A bank not opening its doors immediately need not convey the idea it isn't 100 per cent solvent," the assertion continued. "It will take time to make the necessary examinations."

Ector County May Get New Crude Outlet

Rumored Operations Take Shape As Week Opens

Deals for the drilling of tests for oil in Ector County, reported previously as rumors, were rapidly taking shape as the week opened. Plans for a pipeline outlet are now being talked.

Negotiations have been completed between the Landreth Production Co. and the Texas Company for the drilling of their No. 1 Holt, 660 feet north and east from the south and west lines of the south-east quarter of section 16, block 43, township 1 north, T. & P. Ry. Co. survey. The new test is to be a mile east of Landreth's No. 3 Holt, recent producer. In section 15, and is 2 1/2 miles due north of the Standford Dick Cowden producers which opened a pool in northern Ector last year.

The original Landreth 1 Holt was completed following 110 barrels daily from total depths of 4,627 feet after a shot.

Landreth has also acquired a half interest in the north half of section 20 from the Llano Oil & Development Co. and plans a south offset to the Landreth-Texas Company test mentioned. If it proves a commercial producer.

Production of Standford's two original wells on the Dick Cowden ranch is now going into large tanks on a restricted basis. The territory extending southeast from that area to the L. C. Harrison's No. 1 Addis estate five miles west of Odessa and the Texas & Pacific Railroad tracks is receiving a group of tests including the recent operations undertaken by the Moran Drilling Co. and by A. W. Cherry and others on J. L. Johnson land.

Two more producers, it was estimated, would be needed to assure production of building a pipeline outlet.

L. G. Bradstreet is completing a deal for the drilling of another test on Elliott Cowden holdings in section 16.

Elliott Roosevelt Takes In El Paso And Juarez Sights

EL PASO (AP)—Elliott Roosevelt, second son of the president, took in El Paso and Juarez, Chihuahua, in one stride Monday, and prepared to depart by motor early Tuesday for Tucson, Ariz. He arrived in El Paso on the midnight plane from Fort Worth, accompanied by Ralph Hitecock.

He visited Juarez, where he was met by officials and business men, and after a short drive about the city was taken to a Juarez distillery where he was shown through the plant and given samples of the product, which he tasted.

Products Manufactured Here During 1931 Valued At \$728,932; Wages And Salaries Amount To \$254,205 Total

Census of manufacturers, compiled by the United States department of commerce, show that the total production of local manufacturing and printing and publishing plants in 1931 was valued at \$728,932. The total is based on reports from ten establishments.

The number of wage earners employed by these establishments in 1931 was 209; wages paid during the year amounted to \$254,205; and materials, fuel, and electric energy cost \$315,023.

This special summary was compiled by the Bureau of Census exclusively for the Big Spring Chamber of Commerce in recognition of its assistance in the manufacturers-census canvass. Figures are preliminary and subject to revision.

The figure on the number of wage earners during the year does not include salaried officers and employees. Average number of wage earners is based on the numbers reported for the several months of the year. This average probably exceeds somewhat the number that would have been required for the work performed if all had been continuously employed throughout the year. In comparing the figures with 1929 it must be kept in mind that the proportion for part time labor was probably much larger last year. Manufacturers' profits could not be calculated because no data were collected on interest on investment, rent, depreciation, taxes, insurance and advertising.

Dr. Truett To Preach Daily Through Thursday, Probably Friday

Heavy increase was noted Tuesday night in attendance at the revival meeting being held at the First Baptist church.

Dr. George W. Truett, who is doing the preaching, delivered a special message on "The Glory of the Ministry" before 35 pastors of various denominations gathered at noon Wednesday at the First Methodist church from a number of nearby cities and towns.

The services will continue through Thursday evening and probably will extend through Friday. Services are held daily at 10 a. m. and 7:45 p. m.

Tuesday evening Dr. Truett spoke in part as follows: "I want to help you build on a secure foundation for your spiritual welfare. There are many single passages in the scriptures that lay plainly for us the way whereby sinners are saved. 1 Peter 3:18: 'For Christ also hath once suffered for sins, the just for the unjust, that he might bring us to God. There are two facts in this scripture which stand out. First, the awful fact of sin, and second, the glorious fact of God's remedy for a sinner.'

"Sin must be suffered for, since Christ once suffered for sin. Men who are not acquainted with the Bible know that sin is attended with a sorrow. God has established elements that remind us of our sin. Take one's memory. What haunting power one's memory has. Memory burns like fire. We can not forget. God has implanted conscious in our breast. Conscious isn't dead. It leaps out in the dark, at the unexpected moment. Conscious must be reckoned with. We have the Word of God and when we turn its pages it will not let us miss the truth. Sin is an awful reality in our lives. We must be delivered from sin if we would be saved. 'Except we repent Ye shall all perish.' 'Except Ye are born again Ye can not see the Kingdom of God.'

"Is there any remedy for a sinner? For Christ also hath once suffered for sins, the just for the unjust, that he might bring us to God. Here is the door of hope opened for us. Here is the one physician who can heal our heart. That scripture states the central fact of the saving grace of God. Our religion is distinctly a religion of redemption. Christ died meeting every demand of the Holy law of the eternal Father. That awful fact is the supreme fact of the New Testament. What is the answer? (Continued On Page 7)

H. Bennett told how he had been sent to Dallas for an operation he described as unusual and very successful.

Deadline For Filing Income Tax Returns Extended To March 31

WASHINGTON, (AP)—The deadline for filing income tax returns was extended from March 15 to March 31 by the internal revenue bureau acting on a treasury department decision. Those who take advantage of the rule to defer filing their return must pay interest of 6 per cent per annum on the first quarterly installment from March 15.

The decision was made as long lines of harried taxpayers besieged the offices of collectors of internal revenue throughout the country seeking to get their returns, held up by the national banking holiday, into the offices before the stroke of midnight Wednesday. While no official had any additional comment upon the relaxation of the stringent rules, the treasury has been bombarded with requests that some action be taken to defer payment of the tax until citizens whose money was tied up in banks could make arrangements to meet the amount due. Officials had declined to relax the regulations requiring the filing and payment of at least one-fourth of the tax tomorrow until the order was issued Tuesday night.

Withdrawals Very Small As Banks Reopen

Depositors Keep Staffs Working At Top Speed Throughout Day

Confidence! People of Big Spring and territory Wednesday expressed confidence by action!

Crowding into the three local banks throughout the day they bore cash and checks by the tens of thousands of dollars and deposited them.

The total of deposits for the day established a record, it was learned from interviews with bankers shortly after closing time Wednesday. Meanwhile, there were practically no withdrawals except the routine ones always made.

Merchants, workers, professional men, all kept bank employees going at top speed throughout the first day the banks have been allowed to open and transact the usual business since March 2.

The exact figures on amount of deposits made Wednesday could not be obtained when The Herald went to press.

However, it was authoritatively learned that the total of new deposits had established a record.

Bankers said the deposits were largely by regular customers and that there was no evidence of any money coming out of hoarding or of any withdrawals for the purpose of hoarding.

The opening day for the banks occurred on pay day for the Texas and Pacific Railway company and this further enlivened business. The business district was busy and people on all sides expressed their confidence not only in the local banks but in "the new deal" all around.

DALLAS, (AP)—E. A. McKimsey, governor of the Dallas Federal Reserve bank, announced Wednesday at least 90 per cent of members of the eleventh federal reserve district would resume normal operations at once.

He continued to withhold the list of banks given permission by the government to re-open. Regardless, hundreds have made public receipt of license to resume operations.

Coincident with opening of federal reserve members Banking Commissioner Shaw granted permission to approved state banks in dozens of cities to resume normal transactions.

While the backbone of the financial stridency was broken Monday and Tuesday when large city banks resumed operations, it was the opening of hundreds of smaller banks members of the federal reserve and state system Wednesday that gave the last final impetus to the forward movement.

AUSTIN, (AP)—Banking Commissioner Shaw Wednesday issued a proclamation ordering all state banks, banks and trust companies, trust companies and private banks except those otherwise ordered, to resume business without restrictions.

The proclamation said until further notice state banks wherever located "may, if they think it necessary for their protection, declare and enact restrictions on withdrawal of deposits as heretofore permitted."

The Rotary Code of Ethics For Business Men of All Lines

My business standards shall have in them a note of sympathy for our common humanity. My business dealings, ambitions and relations shall always cause me to take into consideration my highest duties as a member of society. In every position in business life, in every responsibility that comes before me, my chief thought shall be to fill that responsibility and discharge that duty so when I have ended each of them, I shall have lifted the level of human ideals and achievements a little higher than I found it. As a Rotarian it is my duty:

FIRST: To consider my vocation worthy and as affording me distinct opportunity to serve society.

SECOND: To improve myself, increase my efficiency and enlarge my service, and by so doing attest my faith in the fundamental principle of Rotary, that he profits most who serves best.

THIRD: To realize that I am a business man and ambitious to succeed; but that I am first an ethical man, and wish no success that is not founded on the highest justice and morality.

FOURTH: To hold that the exchange of my goods, my service and my ideas for profit is legitimate and ethical, provided that all parties in the exchange are benefited thereby.

FIFTH: To use my best endeavors to elevate the standards of the vocation in which I am engaged, and so conduct my affairs that others in my vocation may find it wise, profitable and conducive to happiness to emulate my example.

SIXTH: To conduct my business in such a manner that I may give a perfect service equal to or even better than my competitor, and when in doubt to give added service beyond the strict measure of debt or obligation.

SEVENTH: To understand that one of the greatest assets of a professional or of a business man is his friends, and that any advantage gained by reason of friendship is eminently ethical and proper.

EIGHTH: To hold that true friends demand nothing of one another and that any abuse of the confidence of friendship for profit is foreign to the spirit of Rotary, and in violation of its Code of Ethics.

NINTH: To consider no personal success legitimate or ethical which is secured by taking unfair advantage of certain opportunities in the social order that are absolutely denied others, nor will I take advantage of opportunities to achieve material success that others will not take because of the questionable morality involved.

TENTH: To be not more obligated to a Brother Rotarian than I am to every other man in human society; because the genius of Rotary is not in its competition but in its cooperation; for provincialism can never have a place in an institution like Rotary, and Rotarians assert that human rights are not confined to Rotary clubs but are as deep and as broad as the race itself; and for these high purposes does Rotary exist to educate all men and all institutions.

ELEVENTH: Finally, believing in the universality of the Golden Rule—All things whatsoever ye would that men should do unto you, do ye even so unto them—we contend that Society best holds together when equal opportunity is accorded all men in the natural resources of this planet.

The Objects Of Rotary

To encourage and foster:

(1) The ideal of **SERVICE** as the basis of all worthy enterprise.

(2) High ethical standards in business and professions.

(3) The application of the ideal of service by every Rotarian to his personal, business, and community life.

(4) The development of acquaintance as an opportunity for service.

(5) The recognition of the worthiness of all useful occupations and the dignifying by each Rotarian of his occupation as an opportunity to serve society.

(6) The advancement of understanding, good-will, and international peace through a world fellowship of business and professional men united in the ideal of service.

**Chairman Of Harriman
National Charged With
Misuses**

NEW YORK.—Joseph W. Harriman, former president and now chairman of the board of directors of the Harriman National Bank and Trust company, was arrested at his Manhattan home late Tuesday, and an hour later United States Attorney George Z. Medaille stated the misuse of \$1,393,000 in connection with bank stock purchase by Harriman was indicated by evidence in the hands of federal investigators.

Harriman, 66, native of Belleville, N. Y., who has been in the banking business since he was 16, was charged in the federal warrant with having caused false entries to be made in the books of the bank with intent to deceive the controller of the currency and his agents.

Medaille was told over the telephone by John Pinkley, deputy United States marshal, that Harriman was ill in bed in care of a doctor and a nurse, apparently unable to be moved.

The federal attorney instructed the deputy marshal to retain Harriman in custody in his sickbed pending arrival of a physician assigned to examine the banker for the government.

The Harriman National Bank and Trust company did not reopen yesterday, and under the new emergency bank bill, was placed in the hands of a conservator, Henry E. Cooper, president of the bank.

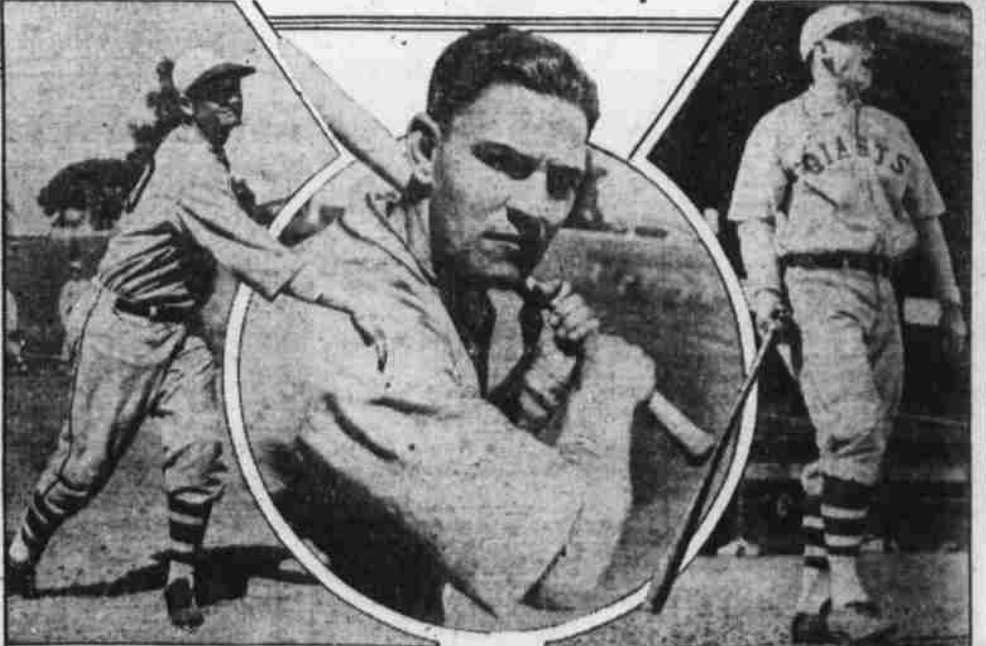

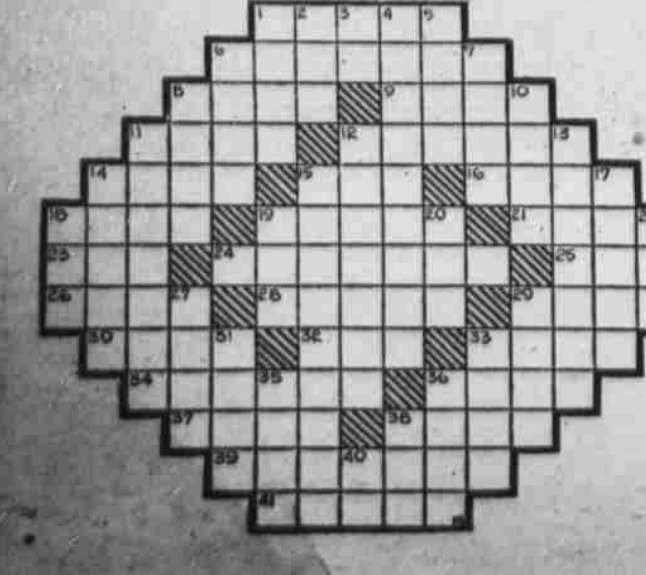

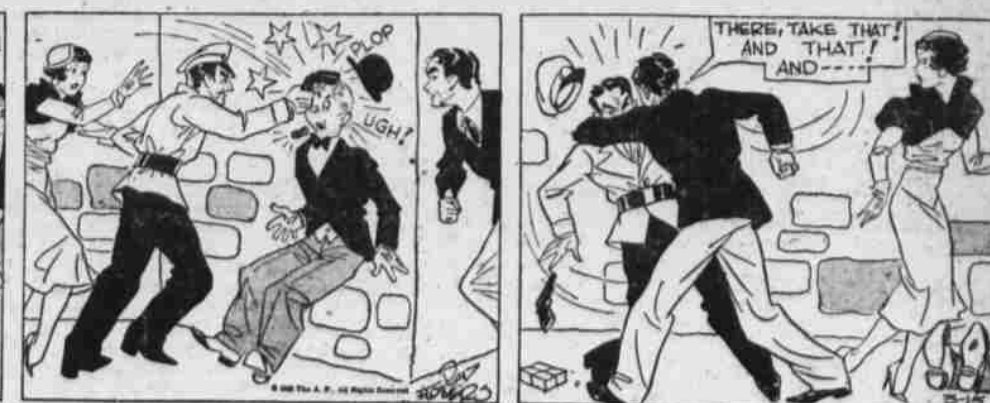
