Lamesa Public Schools Ready For Opening Monday Sept. 7

FACULTY READY FOR OPENING SESSION 1931-32

Lamesa Public Schools will open on September 7, 1931 with prospects now indicating that the enrollment will be as large as in times past if not larger. The scholastic census shows a gain of 39 and total 1171 and the transfer list is 125. Five year old pupils in the kindergarten and some over age pupils attend each year, a record of whom is not now in hand.

NEW PROGRAM FOR 4-H CLUB GIRLS OUTLINED

An entirely new state program of work for the 4-H club girls has been outlined for 1932. The program is to be placed on the demonstration basis with only two or three types of demonstrations being conducted in a county. The demonstrations outlined for Dawson county next year will probably be gardening, food preservation and clothing. This program is for girls between the age of 10 and 20 years and each girl is to follow the same program of work regardless of any previous work she may have done. It is believed that this program will offer the girls greater opportunity to exercise their initiative and judgment and certainly more thorough work may be expected from a program concentrating on three phases than from the present program having eight different phases of work in gardening, poultry, dairying, clothing, food preparation, food preservation, bedroom improvement and yard improvement.

In each club there will be one girl who is demonstrator or leader in gardening, one in food preservation and one in clothing. All other club members are co-operators with these three.

The gardening demonstrators shall take charge of the family garden and provide a variety of fresh vegetables for the maximum number of months possible and a surplus for canning. A hot bed should be constructed to provide fresh green vegetables through a longer season. Accurate records of production should be kept and a savings account started. These girls also help their fellow club members to have more successful gardens and to keep more accurate records for them.

The food preservation demonstrators shall plan a canning budget which will provide the family a balanced diet during the non-productive months of the year. From this she shall preserve at least 100 containers of at least five different kinds of foods and assist others with their work.

Each clothing demonstrator shall provide a harmonious and economical wardrobe suited to her type and social needs. In doing this it will be necessary for her to care for and repair her own clothing, provide adequate storage space, plan her entire wardrobe, keep clothing accounts and make at least four garments which may be work clothes, dresses, or undergarments. The co-operators may go to her for assistance in their clothing work.

MOCK TRIAL AT

The trial began two weeks ago when it was revealed that somebody had been squandering the club's funds. Mon D. Thaxton as treasurer for the club has come in for a good deal of suspicion as well as other officers of the club. Upon the hearing of the dirty work an auditing committee was appointed to look into the matter. W. A. Wilson and W. B. Collins were appointed on the auditing committee and were to represent the club. Carl Rountree is on the defensive.

Following this classification the budget for the county superintendent's office was arranged.

The time and place for the Teachers Institute at Lubbock was decided upon being held Sept. 7-9.

The meeting closed with the setting of the county apportionment at \$1.00 per capita.

L. A. HOLLAR ADDRESSES DISTRICT TRUSTEES MEETING TUESDAY

L. A. Hollar representing the State Department of Education was in Lamesa Tuesday and addressed the District Trustees in a meeting held at 10 o'clock in the court room. 41 were present with 21 districts represented.

Mr. Hollars talk was a discussion on the new school legislation and local school problems. He also discussed the new budgeting system of rural schools on the recent decision of the Supreme Court on High School tuition.

Mr. Hollar told those present that the State Department of Education proposes to remedy the Supreme Court decision.

Professor V. Z. Rogers of the Lamesa Public Schools was also present and made a talk on the tuition of pupils between the ages of 18-20.

Following Rogers talk a motion was made and unanimously adopted to instruct the county school superintendent to notify Senator Pink L. Parrish by Air Mail that the departments proposed high school tuition bill was unanimously indorsed at this meeting and that his services would be solicited in asking Governor Sterling to submit the above bill at this time to the legislature.

RECIEPES FOR WATERMELON PRESERVES

As Given By
H. D. Agent

Watermelon rinds are used by many to make preserves and sweet pickles, but few have realized that beautifully colored and well flavored garnishes for frozen deserts, crystallized crumbles and rings for fruit cakes and deserts crystallized confections, jams, marmalades, fancy preserves for simple deserts, and sweet pickles and sour pickles to accent the flavor of a meat dish can be made from these.

In making any of these one initial process is followed. Only thick rinds should be used. The green should be cut away and all pink removed as this pink will make a spongy, ragged product. These rinds should then be soaked to crispness. Place the cleaned rinds in a large granite vessel, cover them over with a solution of two tablepoons slaked lime dissolved in one gallon of water. Weights should be placed on these to hold them under the water. No tin, iron, aluminum or lime rocks should be used as weights for these may react with the lime water. Let the rinds remain over night, then wash and soak two hours in clear water. Drop the pieces of rind in rapidly boiling water and let them boil for ten minutes remove from the liquid and cut into uniformly shaped pieces or grind according to the product to be made.

Colored garnishes may be made by cutting these into one half inch cubes then cooking them in a syrup of one cup water and 3 cups sugar with one fourth cup white karo added to prevent crystallization. Boil the cubes in this until they are glossy in appearance, then add a vegetable coloring and oil flavoring, cook just long enough to color and flavor the products uniformly. Then pack in sterilized glass containers; fill to overflowing, seal and process immediately at 10 pounds pressure for 15 minutes.

Candied crescents may be made by cutting the prepared rind into crescents then cooking them in a medium syrup of one and one half cup sugar and one half cup water until they are transparent. These are dried over night. Add one cup sugar to the original syrup and one fourth cup white karo, bring to a boil and add the crescents, boil about five minutes. Drain and dry. On the third day add one more cup of sugar. Dip the crescents in this thick syrup and place on a wire rack to dry.

Gingered rings may be made by a similar process. Cook them until tender and transparent in a syrup to which has been added strong ginger tea. Dry them dip in a syrup which will spin a thread and place on a wire rack to dry.

Watermelon ground products may be made from the scraps and cuttings from the fancy shapes. Of these products watermelon pineapple jam is delicious. Run the rind through a food cropper using the coarse size blade. For cooking use a heavy aluminum or enamel lined kettle, pint water and cook until clear. Combine one quart rind, 1 quart sugar, 1 1/2 cup white karo and 1 and mixture is of medium consistency. Add the grated pineapple about 10 minutes before the rind has finished cooking, when jam has cooked slow in syrup and

is amber in color. Let come to a boil again and cook slowly for 10 minutes. Fill sterilized container to overflowing. Seal and process immediately for 15 minutes at 10 pounds pressure. Store in cool, dark place.

Watermelon Rind Sweet Pickles
Soak the rinds overnight in lime water, next morning drain and allow to stand in fresh cold water two hours. Cut these in strips one eighth inch thick and about 1 1/2 in long. For 7 pounds of rind combine 3 pints of 5% vinegar, 4 lbs. sugar, 1 qt. water and 34 ounce whole cloves, 2 sticks cinnamon, 1 1/2 ounce ginger root tied loosely in a closely woven bag. Add rind and cook until clear and tender. Seal in sterilized glass jar filled to overflowing.

Variations of these recipes may be used for pie melon products.
