SWINE MEN OF WEST TEXAS IN SESSION TODAY

30 BREEDERS PRESENT AT ANNUAL MEETING AND AUCTION SALE

Approximately 30 swine breeders and members of the Panhandle Swine Breeders' association are in Lubbock today to attend the annual sale and meeting of the association which will be held today and tomorrow in the Tech stock judging pavilion.

The sale and meeting is a renewal of the activities of the association which have been more or less dormant since 1923, officials said today upon their arrival here.

Refuge to Preside
The meeting this afternoon will be presided over by H. C. Roffey of Canyon, president of the association. Discussion of the problems of the industry and plans for its development in this section will feature the meeting's program this afternoon. It will start at 1 o'clock. R. E. Pruett of Tulsa, secretary of the association, will also be in charge of the meeting today.

Tonight at the Tech cafeteria on the campus, the men will be guests of the Lubbock Chamber of Commerce. The association will hold their annual election of officers and the sale will start tomorrow afternoon at 1 o'clock.

Three classes of registered pure bred swine will be offered in the auction. Some fifty hogs will be on sale including Hampshires, Poland Chinas and Durocs from the leading farms of the state.

Stimulate Industry
The association will have as its purpose during the coming year the stimulation of greater work in the swine breeding industry, feeling that the prospects now for its development are even greater than at any time in the past, members of the association said today.

THREE TO DIE FOR MURDERS

BYRON DUNN AND TWO OTHERS TO PAY FOR SLAYING ORGIES

LAKE CHARLES, La., Jan. 26.—Three cases having been unsuccessfully carried on appeal to higher courts, both states and federal, three men are to pay the death penalty Friday, one of them in Lake Charles and the other two in Deridder, under a uniform action says the execution.

Byron Dunn will go to the gallows for the murder three years ago of Deputy Sheriff Sam E. Dupon, who, with federal prohibition Agent W. E. Collins, disappeared on the night of March 6, 1925, and whose shot-riddled bodies were found the following day in Dupon's automobile near Starks. The two officers, armed with a search warrant, had left Lake Charles to go to Vinton, about 37 miles distant, for the purpose of raiding Dunn's home for liquor.

Byron and his older brother, Robert, were tried and convicted on a charge of murdering Dupon. The death sentence imposed on Robert was afterwards commuted to life imprisonment. Unless a reprieve is granted, Joe Getman, of Deridder, and Milton Braxton, of Sulphur, confessed slayers of J. J. Breville, Deridder taxicab driver, will go to the scaffold Friday in Deridder. Breville was murdered and stabbed to death while driving his car in which he was sitting, in a highway where they were riding as passengers. His body was dumped in an abandoned mill pond near Deridder and the car driven to a point near Vinton where it was burned. Breville was largely the basis the defense set up in their trial.

SELECTION OF HICKMAN JURY BEGINS

RANGER IS HELD WITH OFFICERS ON DRUNK COUNT

SAN ANTONIO, Jan. 26.—Three peace officers, one a Ranger and another a constable who tried to enforce prohibition, were jailed for drunkenness and disturbance of the peace here early today. The Ranger, after clearing an all night cafe of policemen, went to police headquarters where he was arrested as he heaped verbal abuse on the department. A county deputy was arrested for intoxication after his auto had struck another car and a constable was arrested when he sought to arrest a friend. The two had consumed the friend's liquor and the constable set out to take the friend to jail. He ran into a policeman who arrested both.

Police recorded a fourth unusual arrest on the blotter when they raided a business club and arrested eleven persons, two of whom said they were "high school girls." Patrolmen said that they still carried their high school books, not having been home since Wednesday morning.

NEW RATES ON POTATOES FOR TEXAS ARE SET

BOTH REDUCTIONS AND INCREASES INCLUDED IN I. C. C. ORDER

(By Associated Press)
WASHINGTON, Jan. 26.—Reductions in freight rates on potatoes from Colorado to points in Oklahoma and Texas, ranging from two to ten per cent were ordered today by the interstate commerce commission effective May 7.

The commission also ordered a management of potato rates from Utah and Idaho to the Texas and Oklahoma points which involve both increases and reductions. **Divided Into Groups**
In laying down the basis for the new rate schedules, the commission divided Oklahoma and Texas territory into seven groups. Group one included points around Amarillo, Texas, and Woodward, Oklahoma. Group 2, Oklahoma City, Tulsa, Enid and Lubbock, Texas; group 3, Shawnee, Okla., and Dallas and Fort Worth, Texas; group 4, Greenville, Texas, and surrounding territory; group 5, San Antonio, Abilene, Houston and similarly located Texas points; group 6, the El Paso section, and group 7, the region of Brownsville.

Rates As Fixed
From the Greeley district in Colorado to group 1, the commission fixed the rate at 35 cents a hundred pounds; to group 2, 63 cents; to group 3, 67 cents; to group 4, 71 cents; to group 5, 75 cents; to group 6, 73 cents; to group 7, 80 cents. From points on the Denver and Salt Lake railroad in Colorado, rates to the various groups were made six cents higher than the Greeley rate, from Utah, and Idaho falls, 12 cents higher and from western slope of Colorado, 6 cents above.

DEFENSE PLAN IN NEW ATTACK IS OVERRULED

TALESMEN QUESTIONED ON QUALIFICATIONS; WOMEN INCLUDED

(By Associated Press)
LOS ANGELES, Jan. 26.—The trial of William Edward Hickman, kidnaper-killer of little Marian Parker, got off to its second start at 10 o'clock today. Superior Judge Carlos Hardy, who yesterday disqualified himself, appeared behind the bench, and formally turned over the case to Judge J. J. Trabucco, prominent jurist of Mariposa county. The defendant, just a minute earlier had been brought in by a deputy sheriff and today was seated directly behind his chief counsel. Judge Trabucco called upon the court clerk for a panel of talesmen and the filling of the jury box with prospective jurors, was started.

Attack New Judge
The defense, following the same tactics which resulted in Judge Hardy's disqualification yesterday, today objected to Judge Trabucco hearing the case on the grounds that he had been appointed by the presiding judge of the Superior Court here and not by agreement of counsel or by the judicial council.

Judge Trabucco promptly overruled the attack on his eligibility and went ahead with the hearing. **Talesmen Questioned**
Six men and six women were put in the jury box, and the district attorney briefly outlined the case. Defense counsel Jerome Walsh interrupted with a brief objection to a phrase of District Attorney Keyes' outline, and promptly was overruled by the court. Judge Trabucco then took over the attention of the talesmen, questioned them on their general qualifications.

"Traveling Judge" Assigned To Case

TWO CHICAGO HOMES DAMAGED WHEN GANGSTERS OPEN RETALIATORY MOVE AGAINST MAYOR AND ADMINISTRATION

(By Associated Press)
CHICAGO, Jan. 26.—Terrorists opened fire on the city administration today with dynamite bombs, exploding them almost simultaneously against the homes of two of Mayor Thompson's close political advisers.

One bomb, carrying an unusually large quantity of dynamite, tore away a portion of the residence of Charles C. Fitzmorris, city controller and former chief of police. The other smashed windows in the home of Dr. William H. Reid, commissioner of public service during an earlier Thompson administration.

Tossed From Closed Car
In both instances the bombs were tossed from a closed car. At the Fitzmorris home, which is in the fashionable Hyde park section, the bomb shattered the front door, wrecked the lower portion of the house (a brick and frame structure) and broke windows as far away as six blocks. Several guests of the Windmere hotel across the street, alarmed by the detonation, fled to the street.

Fitzmorris, his wife and their 19 year old son were in the living room on the second floor. They were unhurt. A few minutes later the report of the Reid bombing on Oakfield boulevard was made. Although the bomb exploded near a building two doors from the Reid residence, police saw in the two bombings a close connection. Dr. Reid, however, played the bomb was not meant for him but for someone in the building beside which it exploded. Police learned that the first floor of that place is occupied by John F. Allen. Allen was the target of a bomb during his unsuccessful aldermanic campaign, and moved to the Oakfield boulevard address he explained, to escape his enemies.

Believed Gangsters
Detectives regarded the bombings as retaliatory measures by gangsters who have been harassed by the administration and in many instances ordered to leave town. It was pointed out that the war on underworld leaders now being conducted follows much the same pattern laid out by Fitzmorris during his years as head of the police department.

Burial will be made in the Carlisle cemetery with the Powell Undertaking company in charge.

FIVE MEN HELD WHILE POSSES SEARCH RED RIVER BOTTOMS

GAINESVILLE, Tex., Jan. 26.—A bank robber who yesterday was killed in a holdup of the Love County National Bank at Marietta, Okla., today was identified as Oscar Boyd Harrison, 26, of Goose Creek, Texas, by Mrs. R. A. Travatt of Blanco, Texas, for whom he worked three years ago.

Mrs. Travatt, reading descriptions of the dead robber, recalled a man who had worked for her on her farm at Blanco, and went to Marietta, where she identified him as Harrison.

Five Men Arrested
Five men have been arrested in connection with the robbery. Three are in jail at Marietta and two are being held at Ardmore. All are said to be residents of Love county, Okla. One of the men, officers said, has made a written statement in which he implicated some of those in jail with participation in the holdup.

A posse of Texas and Oklahoma officers is on its way to the Red River bottom, north of Gainesville, to search for a house in which the leader of the bandit gang is said to have barricaded himself. He is said to be wounded.

Sheriff Resting Well In Ardmore

ARDMORE, Okla., Jan. 26.—(AP)—Sheriff B. C. Long, of Love county, who was seriously wounded yesterday when he engaged two bandits in a gun fight in the lobby of the Love County National bank at Marietta, was gaining strength rapidly today, it was declared by attending surgeons at the Ardmore hospital, where the wounded officer was brought for medical attention.

"Sheriff Long was shot three times by one of the robbers after he had killed the other. The man who wounded the sheriff escaped with between \$5,000 and \$6,000, and had not been apprehended early today."

SIX IS STORM TOLL IN EAST

SEVEREST WIND STORM IN YEARS SWEEPS EASTERN STATES

NEW YORK, Jan. 26.—The toll of the severest wind storm experienced in eastern states for years today stood at six deaths, scores of injured and heavy property damage.

Extending from Cape Hatteras to Newfoundland, the gale left in its path disrupted communications and hampered traffic on land, and a marked curtailment of shipping at sea.

72-Mile An Hour Gale
In New York city, the wind reached a velocity of 72 miles an hour, which was said by weather bureau officials to be equivalent to a velocity of 60 miles an hour by the system of measurement in vogue prior to January 1.

Boston, Lacon, Que., Camden, N. J., Scranton, Pa., Bloomburg, Pa., and Syracuse, N. Y., had one fatality each.

Some \$250,000 worth of plate glass was broken in New York city.

In upstate New York blizzards piled falling snow into heavy drifts. Grain valued at \$20,000,000, intended for export, was in ships bottled up behind the breakwater near Buffalo.

He whom a dream hath possessed
knoweth no more of doubting.

For mist and the blowing of
winds and the mousing of words
he knows.

That little bit of verse is called
to mind by reading the story of
Fanny Read.

Fanny Read has lived a voluntary
recluse in an old tavern in
Hancock, N. Y., since the Civil
War. When the war started she
kissed her sweetheart goodbye and
promised to wait for him. Her
husband returned but she still waiting.
Through all the years she has
refused to leave the building.
Last he came back and found her
gone.

It is nearly 67 years now since
Fanny Read's sweetheart went
away. Long long since it must be
some painfully decreed that she
never would see him again. Yet
still she is waiting for him, a voluntary
prisoner.

Most people, doubtless, will feel
pity for this solitary old lady. Her
life, on the surface, seems a tragedy.

One who can bourn a single
delusion throughout a long life is
fortunate. We are born to follow
will-o-the-wisp fires, as fast as
one fades in the swamp we seek
another, and the revolving cycle of
years brings us only new delusions.
Our dreams, the one and the
eternally return in different
shapes, and each death and rebirth
is paid for by the loss of a portion
of our joy in life.

So it is that to be possessed,
throughout life, by one unyielding
dream—to be bound up as by a
cable—may be a blessing. And it
does not matter particularly
what this dream of hope may be
or where it leads the dreamer.
Fanny Read has been led to fidelity
and loneliness, to an abnegation
of the common joy of life, yet
for all that, she has had her
great dream, and has kept it
throughout life.

It is even beside the point to say
that this may have been at the
cost of mental balance. For all
dreams unbalance the Columbia.
Doubt it not, was fair maid, when
he sailed to the unattainable rim
of the western world. The great
dream that made Daniel Boone
consider himself an instrument wielded
of God to make the wilderness
habitable surely left him partly unbalanced.
But that does not matter
for our city.

For sanity and disillusion are
questionable boons, at best. The
truly lucky are those who can be
seized by dreams, transported to
high mountain tops and shown the

the reach of commonplace facts.

Says:

That Girl on Broadway says
there are many people whose
mouths aren't large enough to hold
their tongues.

Lubbock is the center of
dairy cattle population and the
South Plains is admirably
adapted to dairy farming, says
Dean A. H. Leidigh, of the
school of agriculture at Texas
Tech, in the current issue of
the B. C. D. publication, "The
Hub." As the Plainsman sees it,
Dean Leidigh's statement is
welcome news but the people
of Lubbock and the South
Plains should never be entirely
satisfied until this noted educator
can say the same of poultry farming.

To show the average reader just
how close to home the scarcity of
food laying hens comes, The
Plainsman will relate the figures at
hand for the past year. A short time ago
Lubbock people were paying 60
cents per dozen for first quality
eggs. Sixty-five miles northwest of
here, in Oilton, to be exact, the
price at the same time was 25
cents per dozen for strictly fresh
eggs—and in Oilton the supply
exceeded the demand.

Other centers of similar size
and accessibility in West Texas
were probably in the same position
of Oilton but since The Plainsman
doesn't have the figures at hand
for any other markets he'll
confine his comparisons to the
capital of Lamb county—which is
an "inland town."

Now suppose for a moment
that Oilton had a rail connection
with Lubbock for example, by
way of Littlefield or Anton.
Suppose, again, that the
over-supply of eggs in the Oilton
territory was thus made
available for Lubbock consumption.
The result of our imagination
on this "inland town" is
to construct eggs would
not have been 60 cents per
dozen at Lubbock. They would
have been lower.

In our deductions we have
reached a climax. The Hub of the
South Plains is still in crying need
of additional facilities. The price
of eggs is a mere example of many
other situations which would be
bettered by more railway connections.

Rail connections are already estab-
lished between Lubbock and
most of the smaller agricultural
centers. Let's suppose again that
the residents of these smaller
centers and their neighbors in
outlying communities can be awak-
ened to the profits which are
awaiting them in poultry raising.
Let's suppose, again, that the
price of eggs is a mere example of many
other situations which would be
bettered by more railway connections.

It is only a common sense con-
clusion that the price of eggs is low
when the price is high. By
increasing the volume of business
done by local egg retailers and
wholesalers their profits would be
protected. The profits of producers
could be augmented and the buying
public would save money in this
particular avenue of buying.

While he does not put him-
self forward as an expert in
agricultural lines, The Plainsman
believes that augmentation
of the poultry and egg in-
dustry on the South Plains is
just as important as the in-
creasing of the dairy business.
He hopes to see the time
when the hen and the sow will
be as much headliners as the
steer of the cowboy and the dairy
cow of today.

VENUE

The favorite pastime of criminals
these days, after they have been
run to earth and are late behind
the bars, seems to be trying to get
a change of venue.—Cleveland
Times.

When a man has robbed a bank
or killed a man in cold blood or
committed some other crime that
appeals the community in which it
occurred, it is entirely logical for
him to think that he will be better
off in the hands of a jury selected
from the citizenry of some other
county. Psychologically, his reason-
ing or that of his lawyer is er-
roneously correct. For instance, if a
bank robber shoots down a banker
in a given community, the victim
is, in a sense at least, the acquain-
tance of nearly everyone in the
county, but to the dwellers else-
where he is just a banker and the
crime becomes impersonal. But it
is beyond cavil that the law pro-
viding a change of venue never took
into account the possibility of al-
leging that the sense of community
outrage could result in the allega-
tion of inability to secure a fair
trial therein. For, if that were true,
no man charged with the commis-
sion of a major crime could ever
be tried in the locality where it
was committed. When the law pro-
viding for change of venue was
written newspapers did not have as
side circulation as they do now. But
the modern lawyer makes a great
point of newspaper reports of
crime, arrest and charge, and would
derive from that existent fact the
impossibility of obtaining a fair
trial. It is very doubtful if the ac-
curate reporting of crime and legal
procedure by a competent newspa-
per ever resulted in forming the
opinion of an intelligent man or
woman to such an extent that he or
she could not accord a defendant
a fair trial on the evidence and
the law. It is a notable fact that
defendants and their lawyers are
seldom satisfied with one
change of venue. Common sense
dictates that a court has only to
consider that the law is the law,
the defendant the defendant, and
his lawyer a lawyer, and act ac-
cordingly. Change of venue is ex-
pensive and usually unnecessary.
But Sub S. P. still maintains in
this country he would much
prefer to be tried in another one,
preferably El Paso or Jefferson or
Elidale.—Sub State Press in Dallas
News.

GRADE FOR NEW
PLAINS LINE IS
NEARING FINISH

PLAINVIEW, Jan. 26.—With the
exception of part of the grade in
the switch yards at Plainview, all

BERT ACOSTA IS
SENTENCED FOR
FLYING TOO LOW

NAUGATUCK, Conn., Jan. 26.—
Bert Acosta, famous trans-Atlantic
flier, was sentenced to serve five

BIG DISTINCTION
BY LAW SCHOOL

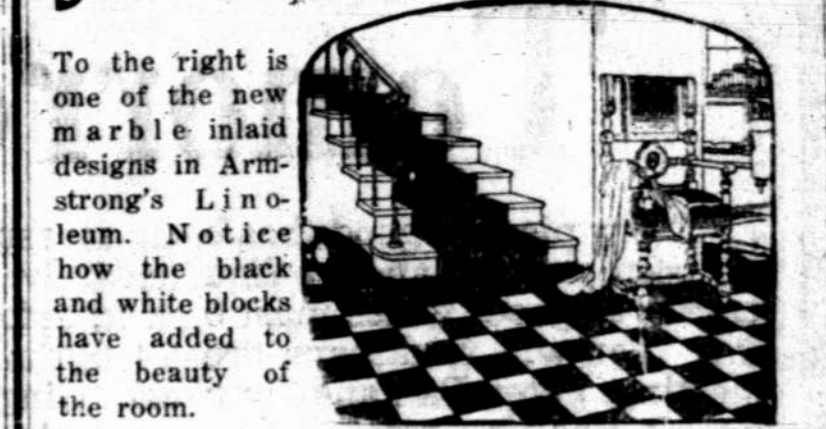

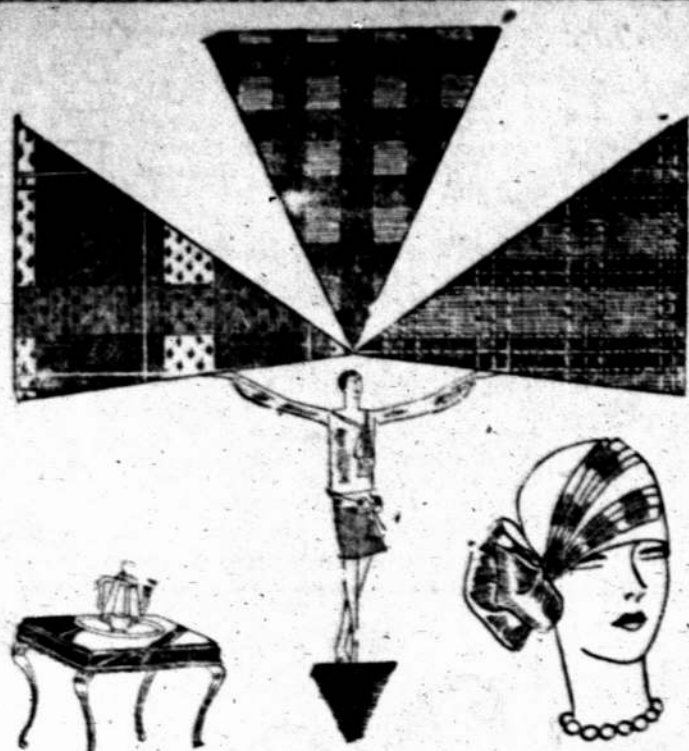

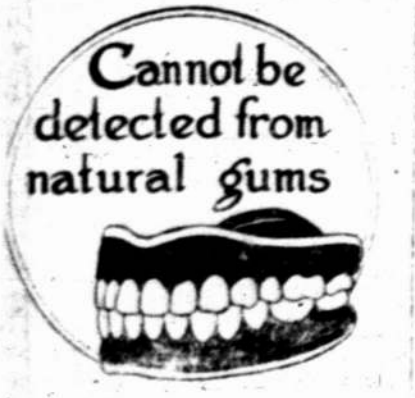
