

CARPATHIA IGNORES TAFT'S REQUEST FOR INFORMATION

RESCUE SHIP AVOIDS INQUIRY CONCERNING SINKING OF THE TITANIC.

SURVIVORS' NAMES

Is All That Carpathia Will Give—It Now Seems Certain Most of Mourners Perished.

New York, April 18.—Even the request from President Taft for information concerning the sinking of the Titanic has been ignored by the Carpathia. The rescue ship studiously avoids all inquiries concerning the sinking of the Titanic and the rescue of the survivors further than to give the names of those rescued, and to say that some of those who were known to be aboard the Titanic had not been taken aboard the Carpathia. A wireless from the Carpathia says that John Jacob Astor is not aboard that ship.

All hope is also abandoned for Isadore Straus, Benjamin Guggenheim, Major Butt, Henry B. Harris, Charles M. Hays, George D. Widener, the Philadelphia capitalist, and many other notables.

A censorship appears to exist on the Carpathia. Up to this forenoon not one inkling of the secret of what transpired in the Titanic sinking has been given although the Carpathia has been impudently wireless for such information. The Carpathia carries only thirteen life boats of the Titanic. It was heretofore supposed that the Titanic had twenty boats.

The story is expected to remain unknown until the Carpathia docks about 1 o'clock tomorrow morning. Private messages suggest that the Carpathia survivors are ignorant of the fate of the Titanic, many wives believing their husbands were picked up by other vessels.

Ismay Will Be One of the First Witnesses.

Washington, D. C., April 18.—J. Bruce Ismay, president of the International Mercantile Marine Company, which owned the Titanic and who is among the rescued on the Carpathia, will be among the first witnesses summoned by the Senate in its investigation of the disaster. Senator Smith of Michigan today was appointed to take six other Senators to New York to procure witnesses.

Iceberg Photographed.

New York, April 18.—Capt. William Ferrie Wood, commander of the freight steamer Etonian of the Leyland line, had a narrow escape from accident with the same iceberg that sank the Titanic. He arrived in New York yesterday and has written the following account of his adventure:

"When I first learned that I was approaching ice fields I was in latitude 42, longitude 50. That was at noon April 12. From that time on I sighted the icebergs and the ice fields. I saw that the ice field was an unusually heavy one, and approached it with caution.

"As I got nearer I saw that there were at least twenty icebergs and the field extended as far as the eye could see. I maneuvered north, south and west, proceeding very slowly, taking great care to avoid the ice. It was nearly 5 o'clock in the afternoon when I sighted a schooner with none of its sails set.

"I halted the schooner and learned that it was the Dorothy Baird. Signaling to the captain, I asked him if he wanted to be reported. He replied that he did. Then I inquired how far the ice field extended. In answer he said that the field extended as far as he could see from aloft, and warned me to be careful.

"I then came almost to a stop and crept along with the greatest caution until I passed the field. I estimated that the field of icebergs extended at least 100 miles. This was from 49.42 degrees north and 49.50 west.

"As we got close enough to the

largest iceberg I maneuvered" about for a good position and took a photograph of it. I believe that the iceberg which I photographed was at least 500 feet long and 100 feet in height at its tallest peak. I should judge that the berg must have been at least several times that bulk under water, as icebergs always float low. There was another one near by, but it was a long, flat low one. The water was very cold, and was making a haze."

Astor's Son Will Receive Bulk of Vast Fortune

New York, April 18.—The belief that John Jacob Astor died when millionaires and peasants went down together on the Titanic has become almost a conviction in New York and Newport mansions today. It was hard for society people to realize at first that a man said to possess as much as \$150,000,000 had choked and struggled in the grip of the same fate that overtook the servant who had served him at dinner.

"Mrs. John Jacob Astor and maid," read the only mention of the famous name in the list of survivors from the wrecked liner.

"And maid," were the words from the terse list that caused most thought when society people began to wonder what it all meant when the first shock of the death of one of their most prominent leaders had passed. The maid, a paid servant, was saved with her mistress.

That men's lives are of equal value in the face of death, and women, without regard to birth or fortune, come first, was borne in upon the minds of people of fashion.

William Vincent Astor, the 21-year-old son of Col. John Jacob Astor by his former wife, Mrs. Ava Willing Astor, will, if the reports prove true, that Col. Astor is among the lost, be the chief heir of this vast estate.

Bodies Will Never Rise.

Boston, Mass., April 18.—"The bodies of the victims of the Titanic are at the bottom of the deep, never to leave it," declared Prof. Robert W. Wood of the chair of experimental physics of John Hopkins university.

"It is altogether improbable that any of the corpses will ever return to the surface, as is the case with bodies drowned in shallow water.

"At the depth of two miles the pressure of the water is something like 6,000 pounds to the square inch, which is far too great to be overcome by buoyancy ordinarily given drowned bodies by the gases generated in them.

"That the bodies sank to the bottom of the sea there is no question," he continued. "The Titanic victims who were not carried down with the boat followed until the very bottom of the sea was reached. There was such a thing as their stopping in their downward course a half mile, a mile or at any other point.

"Great changes necessarily have been wrought in the vessel itself by the enormous pressure to which it has been subjected. No effect was produced on any portion or compartment or room to whose inside as well as outside walls the water had access. In such instances the pressure from one side neutralized that from the other.

"But wherever there was an air-tight or watertight compartment, the 6,000 pounds to a square inch pressure of water has crumpled those walls of the vessel as if they were tissue paper."

ALVAREZ MAY MAKE TRIAL FLIGHTS HERE

Although Mons Andre Houpert, the French aviator, is at present en route to his home in Paris, France, and Miss Mathilde Moisant accompanied by her sister, Miss Louise, is traveling across the Western States to San Francisco, Signor Francisco Alvarez, the Mexican birdman, is still in the city and will no doubt remain here for the next two weeks, it being quite possible that a number of flights in a Moisant monoplane will be made by him before the expiration of that time.

Following the narrow escape from death of Miss Moisant at Lake Wichita last Sunday afternoon, and the complete destruction of her flying machine, R. Pease, manager of the aviators, wired the circumstances of the accident to the Moisant headquarters in New York, and received a reply yesterday morning instructing him to ship to the factory near New York City the metal parts of the engine belonging to the machine which was destroyed, and also the remaining monoplane which was brought here, but which was not used in any of the flights owing to defective valves.

These instructions were complied with yesterday morning, and the manager of the Moisant factory sent word that as soon as possible a new monoplane would be shipped to this city so that Signor Alvarez will be able to continue his tour of the United States.

In the meantime R. Pease, manager, Signor Francisco Alvarez, aviator, and Rene Porsh, French mechanic, will remain in the city, and as soon as the monoplane arrives from New York, Alvarez intends to make a number of trial flights before proceeding on the tour. All three of the party have expressed themselves as being highly pleased with the treatment accorded them by Wichita Falls people, and do not seem at all dismayed at the prospect of remaining here for the next three weeks, this being the time which it is estimated will be necessary before all arrangements for continuing the trip can be completed.

Roosevelt's New York Expenses \$56,129.75

Taft's Only \$5,585.64 According to Statements Filed Yesterday—Perkins a Contributor.

New York, April 18.—That Theodore Roosevelt was plentifully supplied with money for his primary flight in New York county recently, and that George W. Perkins, director of the "Harvester Trust" and a large stockholder in the United States Steel Corporation, was a heavy contributor was shown today when Roosevelt managers filed a statement of expenses with the Secretary of State in Albany.

The Roosevelt managers spent \$59,126.75 and the Republican county committee, which was accused by Mr. Roosevelt of stealing the election, spent only \$5,585.64. This was contributed by the Taft National League.

The county committee, through its treasurer, Ogden W. Mills, also filed a statement in Albany. The corrupt practices act requires that this shall be done.

Among the contributors to the Roosevelt fund were Mr. Perkins and Frank A. Munsey and Alexander S. Cochran, each of whom gave \$15,000; George Baxter gave \$5,000, H. L. Stoddard \$2,500, Charles H. Duell \$1,500, F. H. Hooker, A. Foster Higgins and R. P. Perkins \$1,000 each, Byron L. Smith and Oscar Straus \$500 each, H. L. Saterlee \$100.

The disclosures were particularly interesting to politicians because when, early in the year, it was said that Mr. Perkins was backing Mr. Roosevelt in return for an implied promise that if elected President Mr. Roosevelt would interfere with either the harvester nor the steel trusts, the intimations were denied. It was interesting also because of the charge repeatedly made by Mr. Roosevelt, when he failed to carry a single district in his primary flight in New York, that the regular organization carried the elections by "outrageous frauds."

SNOW REPORTED NEAR ALBANY, TEXAS

A Texas Central conductor arriving in Waco this morning reported two inches of snow along that road near Albany, according to the Associated Press. Wichita Valley points report hail. The mercury dropped down to about forty degrees this afternoon. Warmer weather is promised by the weather man tonight and tomorrow.

BELIEVE REPLY NOT RESENTFUL

WASHINGTON OFFICIALS BELIEVE MEXICO MERELY SEEKING TO AVOID FINANCIAL RESPONSIBILITY.

THE ARMY IS CAUTIONED

Federals Decline to Assume Any Responsibility for Acts of Rebel Leader Orozco.

Washington, D. C., April 18.—Mexico's reply last night, to the United States' admonition to protect Americans is not taken here as resentful but as intended to relieve the Mexican government of financial liability for damages done foreigners by the rebels.

Mexico replied to the note of Acting Secretary Huntington Wilson last night, declining to assume responsibility for Orozco's acts, denying the right of the Washington Government to deliver the admonition contained therein, taking exception to the communication directed to Orozco through Consul Letcher, and deploring the making public of that communication in the same note to which the Government was required to make answer.

The reply was given to the press by the Minister of Foreign Relations. It denies the right of the Washington Government to deliver the admonition for the reason that it is not based on any justifiable incident.

It denies responsibility by the constituted Government for acts committed in territory removed from obedience to the law as contrary to principles of international law, while accepting full responsibility for every loss or damage sustained by foreigners legally chargeable to the Government.

A caution has been issued by leaders of the Federal forces to insure proper treatment of foreigners, who may be taken as prisoners of war. At the same time it is asserted that no basis exists for supposing that any other course would be pursued.

Orozco is held to be answerable for his offenses only to the Mexican courts, and, therefore, should not have been made the recipient of a diplomatic communication.

AN AD CLUB MAY BE ORGANIZED

Proposed to Organize Quiescent Body on a More Active Basis.

Reorganization of the Wichita Falls Ad Club, which has been in a quiescent stage practically since it was first formed, is now proposed and it appears likely that a new, strong organization will be effected. Those interested in the matter expect to form temporary organization sometime next week.

It is hoped to secure a sufficient number of members to permit holding monthly or semi-monthly luncheons, similar to those held by clubs in larger cities. At these luncheons, speakers from other points address the members along instructive advertising lines.

A number of local advertisers expect to attend the meeting of the Associated Ad Clubs at Dallas next month. Several Wichitans attended the Boston convention of this organization last year and played a prominent part in landing the meeting for the city.

It is hoped to send a substantial delegation from this city. Bert Bean and J. C. Forrester are among those who will attend and there will no doubt be a number of others.

WOLTER'S FRIENDS PLAN ENTERTAINMENT

Local friends of Jake Wolter, of Houston, will speak here on Saturday of next week, are making preparations for the entertainment of the senatorial candidate when he visits this city.

Col. Wolter will come to Wichita Falls from Henrietta late Saturday afternoon, April 27, and will probably speak here Saturday night. He will remain here all day Sunday and practically all day Monday and his friends in this city are making plans for seeing that he is well entertained while in Wichita Falls.

A week from today Judge W. F. Ramsey, gubernatorial candidate, will be in the city and his friends will make the necessary arrangements for his visit. Next Thursday is also the date of the opening of the local ball season and of the Elk's minstrel so that the Cleburne candidate will have counter attractions with which to compete.

News From The Oil Fields

The Petrolia Field. The staff correspondent of the Oil City Derrick has the following dispatch in that paper of the date of April 15th:

The Petrolia field is receiving considerable attention just at present, owing to the huge gasser drilled in a few days ago by the Lons Star Gas Co., on the E. L. Holloway lease. It is estimated all the way up to 25,000,000 cubic feet per day and the roar of escaping gas can be heard for miles as it tears out of the open six-inch casing. It was struck before the last string of casing with a packer had been set in. The company is at work trying to put in the casing and packer but so far has not made any headway. The well is in the 1,700-foot gas sand in which all of the big gas wells in this field are found.

That Petrolia has a big gas field there is no doubt and it would seem reasonable to think that there is a big oil field lying around there somewhere. It has already one well that came in at better than 1,000 barrels per day and is still making 75 barrels. This well is owned by the J. M. Guffy Petroleum Company and is only a quarter to half a mile from the Holloway gasser. Both of these wells are on the eastern edge of the field. On the western edge of the field, the Producers Oil Company's No. 2 on the Byers lands, about one and a half miles southwest of Petrolia, which struck oil a few days ago and was reported in these letters, is not completed, but is, doubtless, good for 75 barrels or better. This well is about such a well as the one drilled by the Developers Oil Co., half a mile north, about 10 days ago. The Developers Co., has a rig up offsetting the Byers well. These two wells are 2 1/2 miles almost due west of the Holloway gasser and the Guffy pumper, giving the field a width of that distance, while the northwest, southeast length is somewhat greater, showing room for a good sized field and it is more likely that more will be added.

Andy Garland, with Charley B. Shaffer, the big operator of the Illinois and other fields, has a rig up for a well on their block of 600 acres on the Summit and Ellis lands, 2 1/2 miles east and 4 1/2 miles south of Petrolia. This is on the southeast northwest line and looks to be right in line with the center of the field and is therefore considered to be an excellent location and a very important test.

The Producers Oil Co., is drilling a deep test on the Stein farm, six miles east of the town of Petrolia, that is also an important test, as it is intended for a test below the big lime. This well is now 2,700 feet.

About a mile southwest of the well mentioned on the Byers lands, A. A. Little and associates have a rig up on what is known as the Dale pasture, owned by J. H. Kempner, that will be very important test as its only well contemplated, at present, between the Byers well and the test of Jack E. Kelly at Dean Station. The Kelly well is shut down at about 1900 feet in salt water.

The test of Benson and Little on the Williams lease, near Thornberry, northwest of Petrolia, is going along alright at something better than 800 feet. The Corsicana Petroleum Company's test on the Stansfield Brothers ranch, 16 miles east of Petrolia, is 1,450 feet. This is another important test. The Culberson Oil Company's test on the Howerson lands is about 1,700 feet and therefore, does not look very promising.

The Ninety-Nine Pumping Company's test on the Morgan Jones ranch about two and three-quarters miles west of Petrolia, which was completed a short time since without making a paying well, looks like an "ear mark" for an extension of the field. The well is shut in except that a two-inch line is connected with the casing head and extended out, say 250 feet, in the field and run up, a couple of joints and the gas allowed to escape there and that line has about all it can do to furnish an outlet for that gas.

Cisco to Have Natural Gas. Cisco, Texas, April 18.—A corps of surveyors arrived in Cisco Tuesday from Moran and began a survey of the city, also of the distance from Moran to Cisco, preparatory to piping natural gas from the Moran wells to this city for domestic and commercial uses. Some few months ago a franchise was granted the Texas Oil Co., by the city council, giving them the permission to lay pipes throughout the city for the distribution of gas. Also lines are being surveyed from Baird and Abilene to Moran's gas fields.

I. O. O. F. GRAND LODGE CONVENES MONDAY

Dallas Odd Fellows Making Extensive Preparations for Entertainment of Visitors.

Dallas, Texas, April 18.—Odd Fellows and Rebekahs are making extensive preparations for the entertainment of the grand lodge of Odd Fellows and State assembly of Rebekahs to be held in this city beginning Monday and continuing three days.

The general committee, having charge of the local entertainment will hold its final meeting Saturday night at the Odd Fellows Hall. The reception committee, which is to be very large, will meet all trains arriving here Monday and will escort the visitors to the headquarters at the Oriental and the Waldorf, and will provide them with badges.

The opening session will be held at the Majestic Theatre at 10 o'clock Monday morning, all other sessions of the Odd Fellows being held at the Coliseum, (here being both morning and evening sessions. The Rebekahs will hold their sessions at the Odd Fellows Hall, corner of Main and Austin streets.

On Monday night the Elmira and Dallas Rebekah Lodges will give an entertainment and reception to the delegates and visiting Rebekahs at the Odd Fellows Hall. The territory inundated is almost as large as a New England State.

Fairfield, Texas, April 18.—The safe of the Guaranty State Bank was blown and robbed last night. Officials say that three or four thousand dollars was stolen. The bank was organized just a few days ago.

WITNESSES SHOW JURY HOW SHEET COULD HAVE BEEN TORN TO MATCH ANONYMOUS LETTER.

MYSTERIOUS MEN

Three Suspicious Characters Observed Lurking Near Parsonage Before It Burned.

Fort Worth, Texas, April 18.—The Norris defense scored heavily this morning with the demonstration by two witnesses of the possibility of fitting another sheet of paper to the torn section of an already torn paper. L. H. Nutt, of the Farmers & Mechanics Bank, demonstrated that it could be done by tearing the original sheet again together with a part to be fitted to it.

J. H. Morrow, a stamp collector using a hollow needle pen and water showing that it could be done by following the line of the torn sheet with the water pen and then tearing along the water weakened part.

The State's cross examination was limited to showing that it would be necessary to have one of the original torn parts or duplicates to do the work, evidently expecting to show custody of the anonymous letter all the time. Morrow gave it as his opinion that it could be done from a good photograph carefully cut.

George Rozelle testified to being at the parsonage the night before it burned on the morning of March 2, and on leaving about 9:30 or 10 o'clock. Seeing three men near the residence, he overtook two, one of whom asked how the doctor felt about the indictment. After returning to the house and coming out again he saw the two men who disappeared before he could catch up with them. He said he could identify none of them. Rozelle was not allowed to testify whether Norris asked him to secure blood hounds to track the parsonage incendiary.

Eight of the attorneys for the defense, including Messrs. Gillespie, Lattimore, Odell and Doyle, met in the office of Lattimore, Cummings, Doyle & Bouldin, where a conference was held on the procedure to be taken Thursday morning.

It was there that Mr. Lattimore was interviewed by a reporter. He said: "We are going to put on some witnesses who will give some of the scarier testimony so far brought out in this case."

"Some of them," he said, "were eye-witnesses to some of the most vital transactions in connection with the case."

Asked who these witnesses were to be, Mr. Lattimore said that there would be "some expert witnesses, though we are at present not at liberty to divulge the names of any of them."

With reference to Mrs. Norris being placed on the stand he was rather non-committal, but left the impression that she would not be while the belief is that the seven women mentioned Tuesday, who were to attack the credibility of Mrs. K. K. Taylor will not be called.

Mr. Lattimore expressed the opinion that today would see the defense close its case direct and that will be followed by the state in rebuttal, after which the defense will call witnesses in surrebutal.

SIBERIAN GOLD MINERS KILLED BY SOLDIERS

A Sketch of Pascual Orozco

Mexico City, April 18.—While most of the other military personages of the two revolutions have permitted their personalities, views and daily movements to become subject matter for the pencils and typewriters of the correspondents with considerable freedom, the most interesting figures of them all at the present moment are at the same time one of the least known either in Mexico or out. That is Pascual Orozco, the fighting hero of the present revolution as well as of that of a year ago.

Orozco is a lean, angular man whose personality is redolent of the camp and the hills and not at all of the council chamber of state nor of the drawing room. Outside his own particular circle there are not many who know even how old he is. It is a moral certainty that he can "hog tie" a steer quickly and artistically, that he can throw a diamond hitch on a pack animal and that when he speaks he is in the habit of receiving respectful attention.

For a Mexican he is a large man. A life in the deserts and mountains of the north has tanned him with a parchment finish and has bequeathed him the loose figure that looks a good deal better on horseback than on the ground. His hair and mustache are black and the latter droops from unrestrained habit. His photographs show him slightly stooped and looking straight at the camera as if more interested in it than in the results of the snap-shots.

What he thinks, what he intends to do—become apparent chiefly in his actions. Not that he has the reputation of being morose or silent, for his men seem to think him an ideal leader; but he has never courted publicity in any of his campaigns. He had been fighting in the Madero revolution last year several months before the reporters found out what his name was and began putting him in the news. The capture of Juarez early in May, 1911, less than a year ago, brought him into public view. President Madero had been busy and conspicuous with his organization of a provisional government whose ramifications extended all the way from Washington to the interior of his own country, but Orozco had been doing most of the fighting.

Twice since then, Orozco has been in Mexico City. He came first to personally escort President Madero to the palace on the day of his inauguration in September. He came again quietly last February on personal business with the government.

In a period of a little over a year, Pascual Orozco has removed himself from his rather humble station of being the trusty man who could be given the responsibility of conveying a pack train of valuable ore through the mountains to Chihuahua city, to a position where he expects to make or unmake presidents. So far as anybody knows there are no heraldic symbols of Spanish nobility anywhere up the Orozco family tree. Men who used to know him in Chihuahua when with a revolver and rifle, he took charge of his own pack train and delivered ore through a country where his main business was to watch out for and keep off bandits in Chihuahua, say that in those days he had difficulty in reading anything that was not set in clear type. But he prospered in a material way and was far from being poor when he took up the revolutionary cause. His claim against the Madero government for

personal services and expense incurred by himself and father, who is now a colonel under his command amounted to \$50,000 gold. The assertion that only half that amount was allowed has been reported, to have done much to wear him away from the Madero interests.

It is probable that a feeling that he himself "made" Madero, and that he has not been pleased with his own handiwork, is responsible for his present revolutionary activity. He has evidently come to the conclusion that his own ideas on important subjects are about as sound as anybody else's and he has thus far kept himself in a relation to the revolution where his ideas will have to be considered in the event of a successful outcome.

He has developed rapidly as a factor in Mexican revolutionary politics; and it is the very possibility that his development is yet incomplete that makes his personality particularly interesting. He has made his revolution so substantial an affair, that it is hard to believe that he himself will be obliterated, even though the movement may be suppressed. He is a young man with an undoubted ability for leadership, and with the taste of authority he has enjoyed it is not likely that he will permit himself to be retired to private life even if he should be persuaded to compromise with the government upon political differences.

Members of the opposition party in the Mexican congress have started a movement to abolish the office of vice president, their main object being to abolish Pino Suarez, whom they do not like. This opposition includes some of the people who made Madero president and it is likely that the effort to change the constitution will cause considerable strife.

But there is another aspect of the case. The office was created at the time the New York financial interests furnished money for the nationalization of the Mexican railways, there not having been previously a vice presidency. The idea was to give an immediate successor to the head of the government in the event the president died or was suddenly removed. The interests which really created the office have not yet been heard from and may prove a very effective source of support to the Madero government in saving Pino Suarez to the administration.

As in some other countries the student element of Mexico is allotted more or less importance of a political character. Their views are published in the newspapers as sometimes, are the reports of their riots and other manifestations. They are a select body of young men from whose number will be picked, the congressmen and cabinet officers of a later day.

They are now busy supporting the "constitutional government," welcoming home former President de la Barra and in many other ways, not all being entirely consistent; but among other things they have formed a military corps for home guard duty. A cadet from Chapultepec is in command. On one of the principal residence streets every evening they may be seen in the midst of military evolutions and setting up drills.

Running is one of the disagreeable features of this performance. "Forward!" shouts the officer and the corps breaks into a run to the end

Council of Captains Called to Organize Warfare Against Dirt

Arrangements for next Monday's clean-up campaign are being rapidly completed and although the time for preparation was very short, everything is being gotten in readiness for a successful day.

A meeting of all district captains has been called for tomorrow night at 8 o'clock at the Chamber of Commerce rooms, at which time the work will be carefully outlined. Every captain and every officer is expected to attend this meeting and help plan the details so that on Monday the work may proceed smoothly and without delay.

The business houses are to remain closed until 3:30 in the afternoon, by which time it is expected that the work will have been completed. It being a holiday, some of them will not open at all on that day. The committee in charge of this feature is to visit all merchants and business men; but those whom the committee fails

to see are expected to follow the general example.

In the interval between now and Monday there is time for all district captains to visit those in their territory and get their forces organized for the work.

"The success of the clean-up will depend on individual effort," said J. A. Kemp this morning. "I think every able-bodied man ought to get out and do his full share and if he is not repaid for his time and labor in dollars and cents he will be more than compensated by the satisfaction which every good citizen derives from seeing a clean, sanitary city. This alone should be sufficient incentive. I have been made captain of the district where I reside and I am going to close my office and see that the work is well done; also, I'm going to expect everybody in my territory to help make that the very cleanest part of town."

The Northwestern Night Trains Will be Discontinued Instead of the Day Trains

Effective next Sunday the night trains on the Wichita Falls and Northwestern will be discontinued and the day trains will handle all the traffic from that section. This will interrupt the through service between Hammon and Dallas over the Northwestern and Katy.

It was announced several days ago that the day trains would be discontinued, but this order was cancelled before taking effect, and it was decided yesterday to take off the night trains instead. There will be a slight

change in the schedule of the day train.

The announcement that service would be curtailed met with pronounced and emphatic protests from points on the Northwestern, coupled with threats to carry the matter before the corporations commission of Oklahoma. It remains to be seen whether the change in plans will meet with any more approval. It is believed, however, that the discontinuance of the night trains will be accepted without so much protest.

WHY SHOULD WE IMPORT POTATOES?

Easily Grown in America, Yet Importations Rose in Decade from \$47,098 to Nearly \$3,000,000.

St. Paul, April 15.—The recent wholesale importations of potatoes into New York from the Old World ought to cause some rather deep and quiet "reflecting" on our part. That in a country as wide and big as the United States it is necessary to bring potatoes—just common potatoes—from across the ocean is strange indeed. And this, too, in the face of facts like the following:

Henry Schroeder, near Dilworth, Clay county, Minn., in the spring of 1911 bought 420 acres of land, paying \$75 per acre for it. He planted it all to potatoes, and in the fall the potato harvest brought him in \$120 an acre, or in other words, paid for the farm and left him \$45 an acre clear money besides. E. D. Grant in 1917 planted eighty acres to potatoes in the same locality, and the crop sold for \$3, 976, or \$112 an acre.

The fact that 2 1/2 million bushels of potatoes were imported into the United States in February, or about twice as much as the average annual importations during the decade ending with 1912, lends interest to figures compiled by the bureau of statistics, Department of Commerce and Labor, showing the imports of food-stuffs of all kinds in the eight months ending with February, 1912, aggregating

million in the corresponding period of 1911, and 145 million in 1902, having thus nearly doubled in ten years. The chief growth occurs in the class of articles not grown in the United States, such as coffee, tea, cocoa, and tropical fruits.

Imports of coffee, cocoa and tea have greatly increased during the decade though in coffee the growth is solely due to higher prices. Eight months' imports of coffee show a decrease in quantity from \$63,440,000 pounds in 1902 to 602 million in 1912, while the value increased from 49 million dollars to 78 million, the average import price advancing from 63 cents per pound in 1902 to nearly 13 cents in 1912. Cocoa imports in the eight months under review increased from 34 million pounds in 1905 to 79 million in the current fiscal year, and the value including prepared cocoa and chocolate, from 4 1/2 million dollars to over 9 million. Tea imports have also increased both in quantity and value, the eight months' figures being 87 million pounds, valued at 15 1/4 million dollars, compared with 64 million pounds valued at 8 million dollars a decade earlier.

NEW NEWS OF YESTERDAY

Cherished Plan That Zachary Taylor Gave Up.

He Wanted to Make Vice-President Fillmore a Member of His Cabinet But Yielded to Opposition of Senate.

"I have often wondered whether President Zachary Taylor was not right when he tried to make the vice-president of the United States an ex-officio member of his cabinet," said Thurlow Weed, the great Whig leader, to me about two years before his death, which occurred in 1882, when he was chatting reminiscently of General Taylor, who more than to any other man, owed his election to the presidency to Thurlow Weed.

"For some reason the explanation for which I never learned," continued Mr. Weed, "Taylor conceived a great liking for Vice-President Fillmore. I doubt whether the two men had ever met until the time of their inauguration as president and vice-president was close at hand. However Fillmore had an inspiring, almost captivating manner which he knew well how to use, especially when brought into contact with a man of the bluntness, simplicity and rugged honesty of Zachary Taylor. It may be that Fillmore in that way had captivated 'Old Rough and Ready,' having in mind the desire to keep a good grip upon such New York state patronage as Taylor had to dispense.

"Whether this surmise be correct or not, it is the fact that when General Taylor was deciding upon his cabinet a short time before his inauguration he determined to invite Mr. Fillmore to become a member of the cabinet ex-officio.

"He spoke of that determination to one or two members of his proposed cabinet who were with him a day or two before the inauguration. He said that in his opinion the vice-president should be made thoroughly familiar with administrative business, since he might at any moment be called upon, as John Tyler had been, to take the oath as president.

"Whatever their private opinions may have been of this plan the men to whom General Taylor talked did not venture to suggest any objection to it to General Taylor. They did hint to him, however, that before he invited Fillmore to become ex-officio a member of his cabinet he should ask some of the Whig senators what their opinion about the expediency of the plan was. At first General Taylor declined to take the hint. He said that the cabinet was his official family, and it was not necessary for him to find out what the senate thought respecting cabinet appointments, since he had learned that the senate, as a matter of form and courtesy always confirmed nominations to the cabinet.

"Then it was said to General Taylor that he ought to remember that the vice-president of the United States is the presiding officer of the senate and in case of a tie has power to vote so as to break it. For that reason it would be no more than courtesy to learn what senators thought of the propriety of having the vice-president sit ex-officio at cabinet meetings.

"General Taylor saw the force of this suggestion, and conferred with two or three senators. They told him bluntly that the senate would not for an instant tolerate an ex-officio appointment of the vice president as member of the cabinet; that it would be regarded as a grievous mistake if the president were to invite the vice president to attend all the cabinet meetings, even though the vice president was present only informally.

"When General Taylor learned how the senate was sure to feel in case he followed this plan he abandoned it. But I know that as long as he was president he felt more than ever convinced that it would be the part of wisdom to recognize the vice-president as ex-officio and informally a cabinet officer.

"I don't know but what I am inclined to agree with the view taken by General Taylor. The vice-president is now only a headboard, a contingent possibility. He is about the most influential of all our public officers, and I think he ought to be as influential as any except the president himself."

It occurs to the average newspaper reader, after reading the details of the sinking of the great White Star ship Titanic, that if all passenger carrying ocean going ships were forbidden to take on more passengers than they are able to carry life-boats with which to take them off in cases of emergency, many lives that are sacrificed on account of shortage of life-boats could be preserved. The Titanic, without doubt was the greatest ship ever constructed, and has proven to be the most dangerous.

The Palestine Herald comments on the Austin papers' complaint of peddlers invading the town and taking out business that should be secured by Austin merchants. The Herald remarks: "The peddler nuisance is one that all towns have to contend with more or less, and it is not surprising that Austin is especially invaded by this class. Whatever other excuse may be given the fact remains, judging by the columns of the papers there that the local merchants of Austin do not try to retain the home trade. They are small advertisers, and wherever this condition exists, outside houses and peddlers usually find a profitable field. In a community where the home merchants are aggressive the peddler nuisance is usually at the minimum. People, as a rule, prefer to do business with the home man, with the man who is responsible and who is ready to make things satisfactory, but the people have no way of knowing what the home man can do for them except as they see his announcements in the newspapers or by visiting his store. If the Austin men want to discourage the peddler nuisance let them use their newspapers more liberally, and they will get results. This fact will be attested to by many live, busy stores in Palestine."

There's food for thought in the comment worth the while of Denton as well as Austin merchants.—Denton Record and Chronicle.

The wisdom of electing as members of the Texas Legislature such able men as the late Judge James H. Robertson can be readily seen by reviewing the workings of what is known as "the Robertson Life Insurance Law." At the time it was passed the various life insurance companies were taking in premiums on life insurance from the people of Texas from \$7,000,000 to \$8,000,000 annually. Judge Robertson himself carried life insurance to the amount of about \$30,000, and he began to hunt up statistics and make figures, with the result that he found that while the twenty-one life insurance companies had taken from Texas about \$70,000,000 in premiums they had only returned \$22,000,000. He gave up his lucrative law practice and was elected to the legislature, with the result that he framed the life insurance law that now bears his name which demanded that the companies invest 75 per cent of their reserves in Texas and pay an earning tax of 2 to 3 per cent. This law and its author was abused from one end of the state to the other, and the companies that wrote 90 per cent of the life insurance in Texas moved from the State. The enemies of the law pointed to the fact that by the removal of the companies the State would lose about \$135,000 annually as revenue that would be paid in by the companies, and for a time things looked a little bit squally for Judge Robert-

erson and his law. But he never weakened. The State of New York had a law just like it, and his answer to his critics was: "The law is right. What is good for New York is also good for Texas." Suddenly things began to look better. Local life insurance companies began to be organized, and it was pointed out that a small company legally managed was bound to be just as safe as a large company. These local life insurance companies have flourished from the day they were organized, and today as much life insurance is being written in Texas as before the Robertson law was passed. As a result Texas money is being kept at home, and at least \$10,000,000 have been loaned by the local companies to the farmers of Texas, that otherwise would have gone to New York. What Texas needs is just a few more good laws like that given to her by Judge Robertson, but until her biggest and brainiest men can see their way clear to give their time as legislators, the State will necessarily suffer by entrusting that very important matter to those who have little or no experience in the making of laws, and are sent to the legislature by their friends more for the purpose of giving them an opportunity to use that honor and position as a stepping-stone to something higher.

CLARA BARTON, FOUNDER OF AMERICAN RED CROSS
Someone has said "the young may die; the old must die." An All Wise Providence has ordained and while it must be so the world is grieved when one so noble, so self-sacrificing, and so good as Clara Barton taken into the realms beyond after years devoted to helping suffering humanity.
America has her Washingtons, Jeffersons, Lees and others whose names are written down in the hearts of all Americans, but Clara Barton accomplished a work compared with which the careers of the military generals fade in the distance "as a shadow."
Congress so recognized her work, her integrity and her noble purpose that it placed at her command fifteen million dollars with which to search for missing and suffering men after the battles of the civil war.
By the organization of the American Red Cross Society Miss Barton was enabled to do more and better work, but her work in time of peace was as great as in the time of war. In the Johnstown flood she was looked upon as one endowed with divine powers and the starving peas-

antry of Russia were saved, from death by her distribution of food. The Armenians were ministered to when Turkey left them destitute and it was these people she had to leave to go to Cuba to care for the American boys who were dying from yellow fever.
Miss Barton always rushed to scenes of suffering in America, no matter in what location. She must be thought of as one of the bravest of all persons not that she rushed into danger without thinking or caring, but because she realized the dangers others were suffering and risked her life and health to save life and alleviate pain.
Clara Barton is dead, but her work will go on forever. Others will take it up where she left off and her example will always live as an inspiration to those who follow in her footsteps.—Venusaeola (Fla.) Journal.

MUCH INTEREST IN BAPTIST ENCAMPMENT

Meeting Here is Being Well Advertised Over North Texas and Western Oklahoma.

The committee in charge of arrangements for the Inter-state Baptist Encampment which will be held at Lake Wichita June 18th to July 2nd inclusive, has been busily engaged for the last few weeks in perfecting a program and also in advertising the encampment throughout the entire state of Texas, as well as the Southwestern part of Oklahoma. COUNTY NOT LIABLE FOR THE EXPENSE

Answering an inquiry by a county judge as to whether the county is liable for the expense of holding the recent county school trustees election, Assistant Attorney General Mead has ruled that the county is not liable for the expense to election officers for holding such election, and among other things he says: "The law specially provides that the persons who hold the election in common school districts for the election of trustees are not entitled to any compensation. In view of the fact that in your county, and in a great many

other Texas counties, the election was not held for the entire county and not held at the regular voting precincts, but part of the election was held by the officers who held the elections for the common school districts and in other parts of the county were held in various ways and by various officers, we are inclined to the opinion that the county is not liable for the expense of the election officers under those conditions. There are several provisions of this law which are vague and on account of the confusion that is caused thereby it is very likely that the next legislature will amend the law so as to avoid future confusion and save the counties from the enormous expense incident to holding the elections as now provided for."

EXTEND CALL TO A MISSOURI MAN

The First Christian Church of this city has extended a call to its pastor to Rev. F. F. Walters of Independence, Mo. Rev. Walters is expected here next week to look over the field after which he will decide whether he will accept. He is now engaged in evangelistic work and has held some of the most important pastorates in that state, among them being Joplin, Neosho and Springfield, also Grand Junction, Colo. He is a graduate of Drake University and is about forty years of age.

PRIMARIES FOR OREGON FRIDAY

National Political Interest Will Center in Western States. Salem, Ore., April 18.—National political interest is turned to Oregon in view of the statewide primary election to be held Friday with the Oregon presidential preference feature added to the primary law that has been in effect for the past six years. The primaries are open to Republicans and Democrats, or other political organization having twenty-five per cent of the vote required to constitute it a "party" under the law. The names of Taft, Roosevelt and La Follette will appear on the Republican ticket and those of Clark and Wilson on the Democratic. In view of the fact that primary elections are an established fact here, it is believed there will be no occasion for confusion such as marked the recent New York primaries, and since the primaries are conducted by the state in the same manner as are general elections there is reason to believe there will be a truly representative vote of the adherents of all the candidates.

WARNING ISSUED TO INDIGENT CONSUMPTIVES

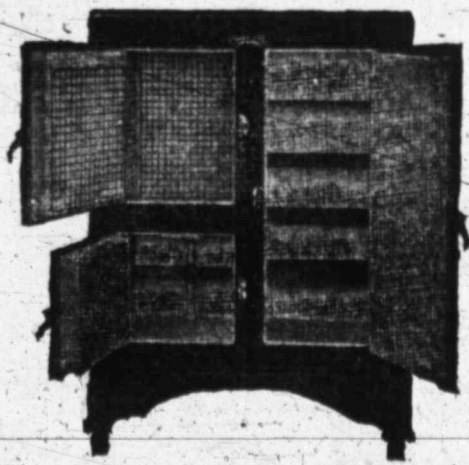
Waco, Texas, April 18.—That physicians of Northern and Eastern States who send advanced and indigent consumptives to the Southwest are guilty of malpractice, was the decision of the Southwestern Conference on Tuberculosis in session at Waco, Texas. The morning session of the conference was devoted to a consideration of plans for ameliorating the condition of consumptive strangers in the Southwest, and resolutions calling upon the Federal Government to convert military forts and reservations into tuberculosis hospitals were adopted. The question of discouraging further immigration of consumptives was discussed at length. A few extremists advocated quarantine restrictions but this suggestion was rejected by the conference as inadvisable at this time. The advocates of publicity of the fate of poor consumptives as a deterrent of further immigration won the day and it was decided to call upon the newspapers of the country to give publicity to the facts that there are no free hospitals for consumptives in the Southwest; that the charity organizations have no funds for the care of strangers and that suitable work is hard to find. The conference decided that it was inadvisable for any consumptives to come west without funds sufficient to maintain themselves for one year, and deplorable physicians who advised patients otherwise.

In addition to expressing preference for President, each Oregon voter will be entitled to vote for one of the ten delegates which his party is to have in the national convention. Of the ten receiving the highest vote each will receive \$200 from the state to pay his expenses at the convention. Voters also express a choice for presidential elector, each voter voting for one, and the five highest being the nominees for the November election. Delegates to the national conventions will be obligated to support the candidates of their party receiving the majority in the preference primary. So far as the state is concerned interest centers largely in the advisory vote on United States senator, it being expected that as in the past the legislative assembly will simply register the selection of the people for this office. A hard fight to displace Jonathan Bourne, Jr., is being made by Ben Selling, a prominent Portland merchant who was president of the state senate two years ago. The chief objection made to Senator Bourne is that his interests are in Massachusetts and not in Oregon; that he has visited Oregon but three times in the past six years. Mr. Selling stands among the Progressives of the Republicans and apparently will make a strong run for the place. There are two other candidates for the senatorship, but the contest is believed to be between Bourne and Selling. Bourne created some little stir at the outset of the race by announcing that he would not spend a cent to secure re-election.

JUDGE RAMSEY HERE ON NEXT THURSDAY
Cieburne Man is Surprising Even His Friends With Boldness and Vigor of His Challenge.
Judge William F. Ramsey, candidate for governor of Texas, will speak here on Thursday afternoon of next week. He will speak in most of the important towns along the Port Worth and Denver. Judge Ramsey will be the first candidate for a State office to open his campaign in Wichita Falls and a good sized crowd is expected to turn out to hear him. He will be followed a few days later by Col. Jake Wolters, candidate for the senatorial nomination. Judge Ramsey will come here from Vernon and will speak at 2 o'clock in the afternoon. He will remain here over night going to Henrietta the following day.

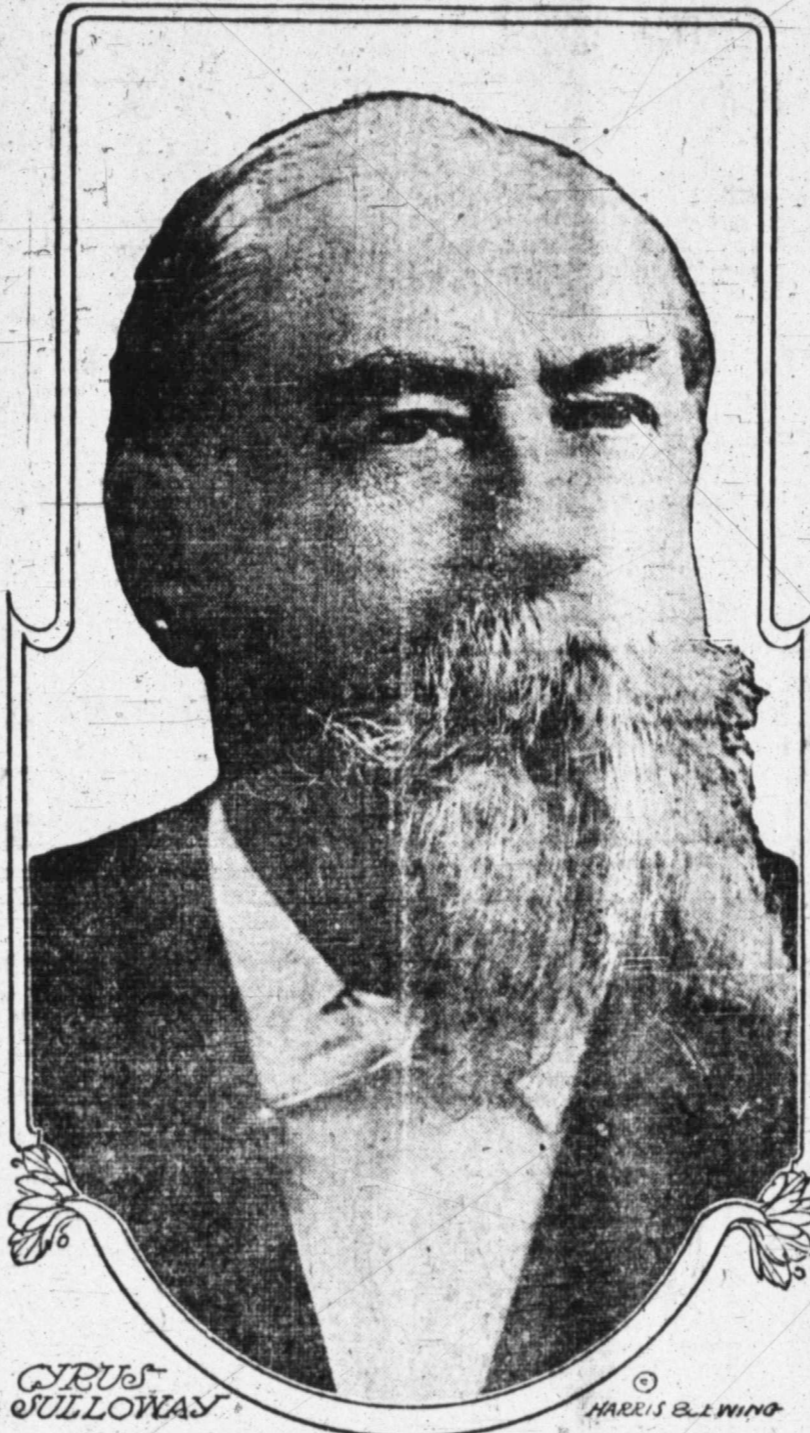

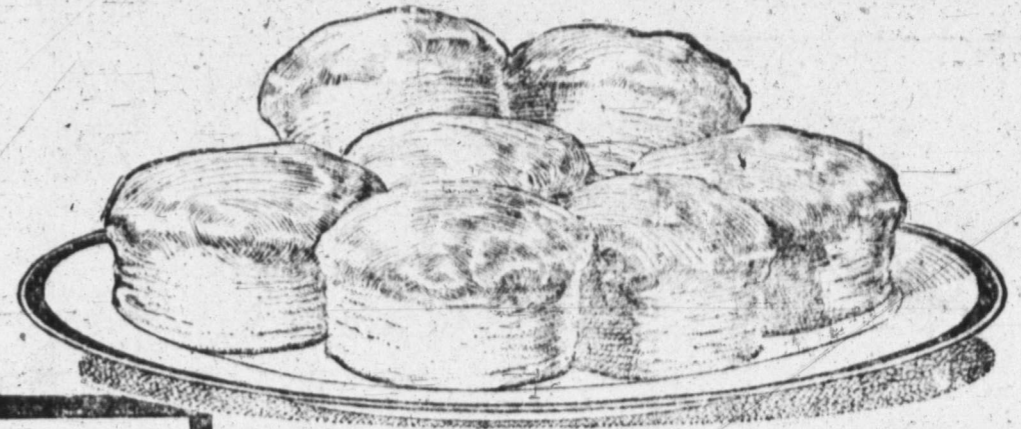

CHINA WITHOUT THE PIGTAIL

Cutting of Queues Brought Education If Not Improved Looks.

(London Mail)
The man who has been following the market in wigs ought to be a better judge of the Chinese revolution than any diplomatist or newspaper correspondent. He alone can say whether the price of hair has risen and whether the millions of Chinese who have cut off their pig-tails have parted with them for good or are hiding them against the day when a pigtail will be again the mark of a patriot. For a pigtail is easily replaced—when you have it. Even in pre-revolutionary days some people were content to fix them to their hats so as not to appear demoralized in public places. I confess that the Chinese without his pigtail is a severe disappointment. He outrages my sense of the aesthetic proprieties. I had fancied that he would carry the sacrifice as gracefully as some of my Chinese friends in the European legations. I overlooked the saving grace of European clothes. To my infinite displeasure I find that the Chinese in long blue padded coat appears undisturbed without his pigtail. And when he adds to the outrage a clean cut which is the present fashion—well, he is hideous.

But every reform demands its penalty. Our Puritan ancestors set this example to the Chinese, and the victorious soldiers of Cromwell did not disdain to be known to the gay cavaliers as "sheepers." They laid their hair and sometimes their heads upon the altar of their country. It is amazing how swiftly the South has discovered that the queue is a badge of slavery and not a national ornament that distinguishes the beaver born from the barbarian of Europe and America. Those who did not lean to this conversion by the light of nature have been generously assisted by organized bands armed with shears. The pigtail that ventures into the streets of Canton, Shanghai, Nankin and a hundred other cities, must belong to a man who is weary of life and the new republic. When the Manchus overthrew the Ming they imposed on them the shaven forehead and the queue instead of the topknot of the defunct Ming. As soon as the U-Chinese had time to savor how he came to possess this appendix he began to cherish it as a woman cherishes the bracelet which is an ancient mark of slavery. It became more than a personal ornament. It was a visible sign of race, setting him apart from the outer barbarian and the foreign devil. For a Chinese to lose his pigtail was to lose more than face. It was to reduce him to the level of the barbarian and to disgrace his ancestors. I wonder if it is the pigtail that has saved the Chinese from the baldness that afflicts our own short haired civilization? Until this very day I had never seen a bald-headed Chinese, and the public spectacle brought my rickshaw boy to a dead stop in the crowded street. He had a vision

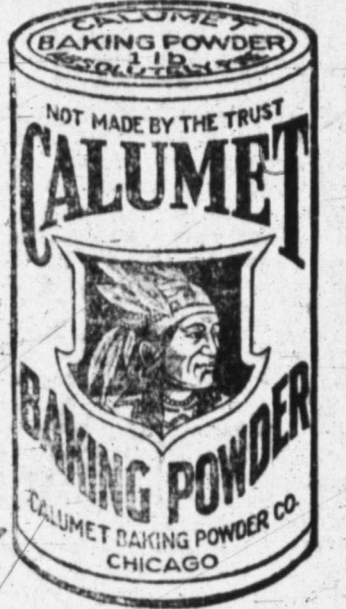

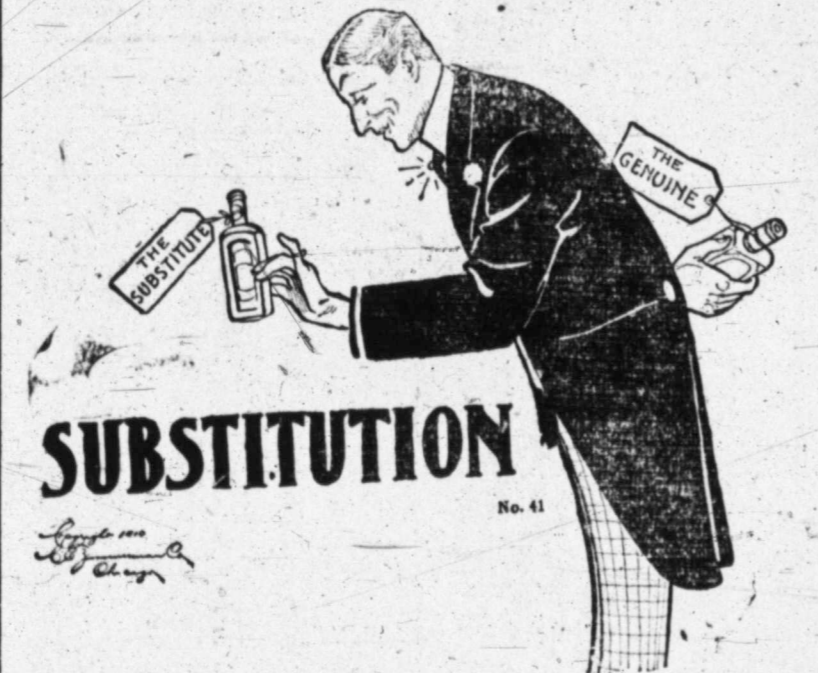
