Tunney's Punches Waft Heeney From Fight Picture

Technical Kayo Gives Champion Victory In 11th

Heeney Started With Rush, Charging Fiercely At Tunney In First Rounds But Master Boxer Wins.

CHALLENGER DEALT TERRIFIC BEATING

Anzac Is Game But Bull-Like Punches Are Nullified By Steady Tattoo Of Lefts and Rights.

YANKEE STADIUM, New York, July 26.—Blinded and staggering, his face a bloody mess, Tom Heeney, the hard rock from down under, collapsed and fell a victim to technical knockout in the eleventh round of his world's heavyweight championship battle with Gene Tunney tonight.

Tunney, born and bred in New York, and defending his title at home for the first time, cut the sturdy, courageous New Zealander to pieces, subjecting him to one of the worst beatings a challenger ever received.

\$5,000 See Bout.
Upward of 50,000 spectators saw Heeney made in to unbroken slugs through round after round as Tunney, the master boxer, lashed his face with left hooks and pounded his heart with vicious solid rights.

Heeney came charging in like a bull, but the elusive Tunney, cool and collected, evaded his wild rights to the jaw and stabbed him with lefts to the face until the third of the gloves against Heeney's cut and bruised face almost became monstrous.

Heeney Started Well.
The Associated Press score card showed Tunney winning at least nine of the eleven rounds, with Heeney winning the first and dividing honors with the title holder in the second. Heeney's make-offensive was the first round. After that he was a badly pounded target who, although boring in with tireless energy, could never escape Tunney's masterful attack.

The crowd, estimated in excess of 50,000 with gate receipts approximating \$750,000, was the smallest to witness a world's heavyweight championship battle since the fiasco at Flamingo.

Speeches to Jury Will Start Today

Termination of Waybourne Murder Trial at Close Date Seen With Progress Of Case Yesterday.

(By Associated Press)
BASTROP, July 26.—Lawyer speeches to the jury will begin Friday in the murder trial of Mrs. W. W. Waybourne, who went on the witness stand Thursday and placed all the blame for the killing of her husband upon Hugo Middleton, blacksmith.

Testifying for the last witness, Mrs. Waybourne denied Middleton's testimony that she had him in a Me-Lean to kill Waybourne, she was found beaten to death in her last March. She said she knew nothing of the plot until he told her later of it and she said, of planning his 35-year-old father, J. J. Middleton, last fall. The blacksmith is indicted in both cases and the defense theory has been that he implicated Mrs. Waybourne in the 15-hour murder as a defense against her telling his alleged confession in his father's death.

Mrs. Waybourne had recovered from the nervous hysteria which kept her off the stand Wednesday. She broke in sob, however, when telling of the finding to her husband's body.

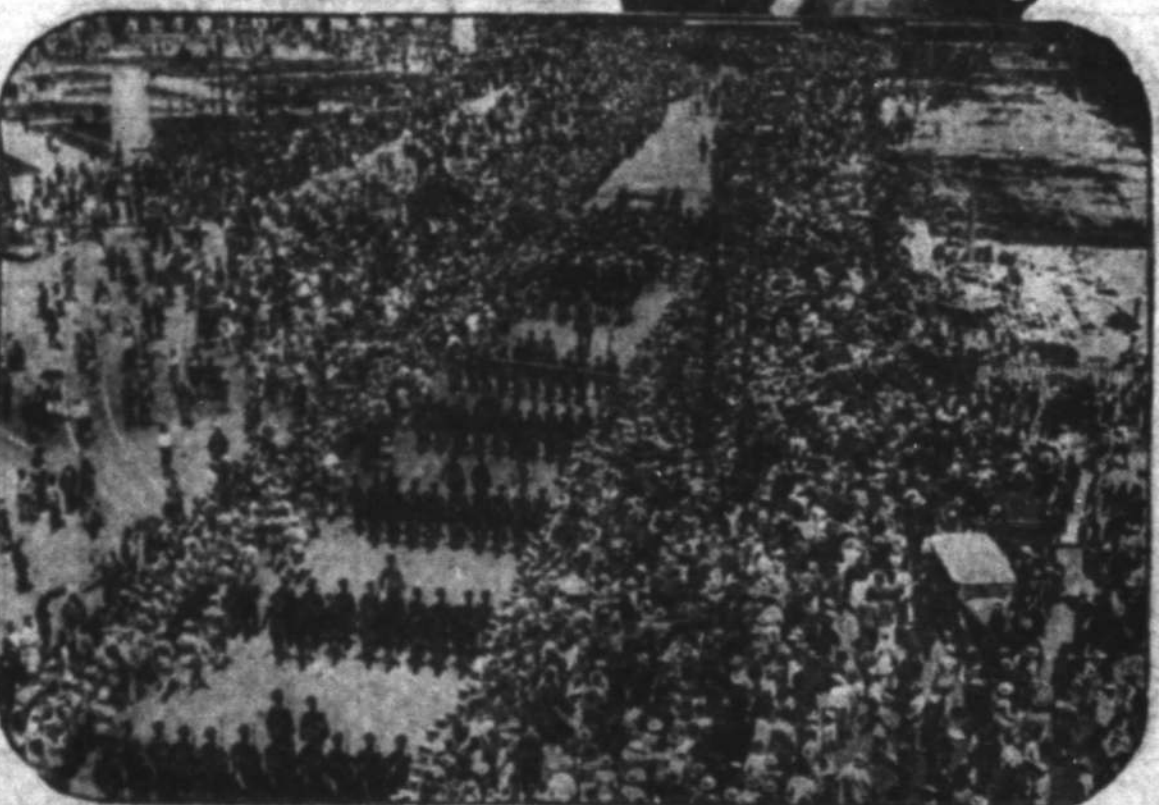
District Attorney Merton Harris cross-examined the widow only three or four minutes. He elicited from her the statement that she was with Middleton when she was arrested and that she had told no one of his alleged confession.

She said she had wanted "to make sure" these were true, she also said she had refused Middleton's offer to make her the beneficiary of his will.

BRECKENRIDGE, Tex., July 26.—A rise of Guadalupe creek, which traverses this city, caused several thousand dollars worth of damage today.

Climax Expected
Starting several months ago the political races for a number of offices have waxed more and more bitter, and it is thought that the excitement of the entire campaign will reach a high pitch tonight as the final speaking goes on. A number of candidates have had private speaking dates over the county in addition to the combined speaking of all of the candidates. Campaign expenses listed recently show costly contests fought in practically all of the races, with the greatest of interest around the sheriff, district and county judges, and county attorney's offices.

STILL MORE RAIN

Showers Yesterday Were Fairly General

Adding to record rainfall during the past week of more than five and one-half inches, a heavy downpour fell in Lubbock and the surrounding territory for more than an hour last night, beginning at about 7 o'clock.

The moisture was unofficially estimated at one-half inch boosting the total during the past few days to around six inches, one of the heaviest amounts of precipitation on record for the month of July.

State Candidates Move to Larger Cities for Final

Moody and Connally Turn To Radio for Their Final Appeal to Voters On Eve Of Election.

MOODY SPEAKS AT DALLAS THURSDAY
Wardlaw Introduces Wire Purporting to Show That Patronage Was Promised For Support to Moody.

AUSTIN, Tex., July 26.—Crowding the final whistle at the close of a generally active campaign, state political candidates mainly will move to larger cities of Texas Friday to take parting shots at their opponents and make election eve appeals to be remembered by the voters at the ballot box Saturday.

Governor Moody's closing speech for reelection will be at Waco Friday night and will be broadcast by radio. Of the candidates for United States senator, Earle B. Mayfield, present incumbent, seeking reelection will close at San Antonio. Alvin Owsley at Dallas, Mrs. Minnie Fisher Cunningham at Galveston, and Congressman Tom Blanton at Abilene.

"Congressman Tom Connally will close his campaign with an address to be delivered to a radio audience from the radio studio of WBAP, the Fort Worth Star-Telegram, between 9 and 10 o'clock."

Louis J. Wardlaw, candidate for Governor, who has already made his big city speeches, will go to Belton to close.

Wind-up dates of other candidates were not available here Thursday.

Made 22 Speeches
Governor Moody returned to speak at Dallas Thursday night after having made 22 appearances, mostly on his rapid-fire excursion into West Texas.

Senator Mayfield spoke at Smithville Thursday afternoon but at the last minute cancelled his scheduled night address at Austin after a heavy rain soaked Woodbridge Park, where one of his opponents, Tom Connally, spoke a few nights ago.

State Treasurer W. Greenway Halcher will conclude what might be described as a "quiet, active" campaign in Tarrant and Dallas counties Friday. The pre-election campaign is over for State School Superintendent S. M. Marra, W. E. James, one of his opponents for reelection, will close Friday in East Texas. James Headquarters, in a statement Thursday said his campaign was over.

Drowning In Bath Tub Claims Lives Of Mother, Kiddies

Father Returns Home To Find All Of Family Dead; Can Advance No Reason For Tragedy.

MINNEAPOLIS, July 26.—Three children and their mother were found dead in their home here tonight when Phillip Johnson, the father and husband, returned to his home after his day's work.

Indications were that all four persons had drowned, one at a time, in the bath tub.

When Mr. Johnson came home he found the three children, Lois Betty, 4 months old, Ernest Bert, 7, and Phillip, Jr., 6, all lying on a bed. All three were dead. A moment later Mr. Johnson found the body of his wife in the bath tub, which was nearly full of water. A towel was tied about her neck.

Mr. Johnson told police when he left for work this morning his wife seemed to be in a cheerful frame of mind. He was unable to give any reason which might have prompted her to take her own life.

BISHOPS RAP WETS

Declare They Will Keep On Opposing Smith

RICHMOND, Va., July 26.—Four Southern Methodist bishops, in a joint statement made public here tonight served notice upon opponents of prohibition that the supporters of the law will not be driven from the field by the cry that they are "bringing the church into politics" by opposing an out-standing enemy of national prohibition for the presidency.

The statement, signed by Bishops James Cannon, Jr., of Richmond; John W. Moore, of Dallas; Edwin Mouson, of Charlotte, and Horace M. Dubose, of Nashville, called upon the ministry and laity of the Methodist Episcopal church, south, to continue the fight against the liquor traffic and "would-be nullifiers of the law."

BOLTERS SCORED

Democratic Principles Affirmed At Meeting

HOUSTON, Tex., July 26.—Democratic principles were reaffirmed here tonight when several prominent Democrats pleaded for support of party nominees and scored "bolters" at a "unity meeting" attended by 1,000 persons.

Frank Andrews, attorney, chairman of the meeting, drew frequent applause when he asserted that no major good to the South ever has resulted from a republican administration.

Paving of Nineteen Blocks In Residence District And Of Six Blocks In Alleys Is Voted.

ROUTE TO NEW DENVER DEPOT TO BE SURFACED

College Avenue, Twentieth Street and Avenue M Are Among Streets to Get Hard Covering.

Bringing direct realization of results to property owners, from the operation of the Stoner tax system in Lubbock during the past year, members of the city commission yesterday announced a reduction of the city's tax rate for 1929 from \$1.50 per hundred to \$1.25. The reduction received the unanimous vote of the entire commission.

The reduction represents a direct saving of \$46,250 to property owners in the city on their taxes for the coming year.

Indicating that they are to keep abreast of the city's progress, the commission not only ordered the reduction of the tax rate but authorized the paving of alleys in six blocks in the business district, 10 additional blocks of pavement in the residence district, the extension of the city's fire limits so as to include additional several blocks in the business district and approved the construction bid on several hundred feet of sidewalk from Texas Avenue out Broadway. The alleys to be paved are in block 118, 119, 122, 124 and one in 150 Old Town. Residence streets to be paved are: College Avenue South from 19th Street to 20th Street and then one block east and west; Avenue O from 13th to 14th Streets and then from Avenue P to Avenue H on 18th; Avenue L between Broadway and Main; 14th Street between Texas Avenue and Avenue H and Avenue M from 19th Street to 23rd Street.

75 Percent Taxed
In making the reduction of the tax rate, the commissioners also voted to tax 75 per cent of the total property valuation. Total valuation of property in the city for 1929 is \$25,397,486, according to a report

Questions Sincerity of Former Oklahoma Senator In Withdrawing from Democratic Party.

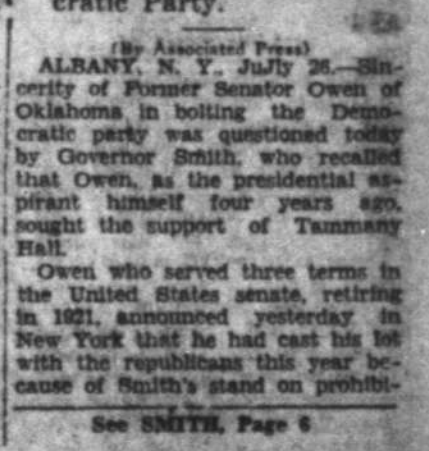

Kiwanians Talk Over Highways

Need of Hard-Surfaced Roads Through Lubbock County Stressed In Talks By Club Members.

Stressing the need of hard-surfaced highways throughout Lubbock county a general discussion of the Texas Trans-continental Trail, which passes through this city was held at the weekly luncheon of the Kiwanis Club at the Hotel Lubbock yesterday.

Instances were related by several speakers of travelers being diverted to other highways missing Lubbock because of the lack of hard-surfaced highways here.

Tom Garrard, local attorney and B. Sherrod, president of the Board of City Development, made talks favoring immediate action toward the betterment of the roads of the county. Mr. Sherrod presented facts and figures concerning the cost of hard surfacing the highways through Lubbock county. He estimated that with state and federal aid it would cost the county between two and two and a half million dollars.

A sing-song led by Hunter Richardson concluded the program. L. F. Grimes was chairman of the program yesterday.

Mullican Speaks In Judge's Race

Makes Caustic Attack At Political Opponents and Denounces "Curb-Stone" Politicians.

Centering a caustic, vitriolic attack against County Attorney L. A. Howard and against his opponent, Judge Charles Nordyke, Judge Clark M. Mullican of the 9th district court spoke in the district court room in the interest of his campaign for re-election last night.

Despite the showers that fell during the early evening a large crowd gathered for the speaking, virtually filling the downstairs of the room. Denouncing what he termed curb-stone politicians and declaring the sole issue of the campaign was that of qualifications, the speaker entered into a comparison of his and his opponents' records. Heeney Fought Gamely Though Given Terrific Beating

Australian Waded In Only to Meet Tunney's Punches

Gene Showed Jabs, Hooks And Hard Blows to Body And Face of Courageous Challenger.

of Shelby, five years ago when Jack Dempsey ruined the banks of that boom town by defeating Tunney.

If the estimated gate receipts are correct, promoter Tex Rickard and his six hundred millionaires suffered a loss in the neighborhood of \$250,000. Tunney was guaranteed the rich purse of \$250,000, with \$100,000 going to Heeney.

The battle in advance, lacked the colorful appeal associated with the Tunney-Dempsey battles in Philadelphia and Chicago, each in turn with its record-shattering gate and attendance. Rickard had figured on a gate of at least \$1,500,000 tonight. He needed more than \$750,000 to show a profit.

The battle was a struggle between a boxer who has proved himself perfection in his art and a strong, durable fighter whose chief asset is his natural strength. Tunney, a master of defensive boxing, allowed Heeney to see the early pace and then, after slowing him up with savage blows under his heart, proceeded to batter him into a state of collapse.

It took no expert, after the savagely fought tenth round, to tell that Heeney, the plodder, had met his master, and that his finish was coming. As this round ended, Heeney was lying flat on his back, his body rolled to the edge of the ring, completely knocked out. His seconds rushed into the ring as the bell clanged and the fallen New Zealand gladiator was dragged to his corner where restoratives were applied.

His seconds worked frantically over him, shaking his head to sweep the cobwebs out of his brain and applying the smelling salts to his bleeding nose.

Heeney, with marvelous recuperative power, came charging out of his corner as the eleventh round opened, only to fall an easy victim to another barrage of well-timed punches that knocked him groggy and reeling.

As he stood there, with his back to the ropes, his arms hanging heavily at his sides, a certain victim to a finishing knockout blow, Ed Forbes, the referee, humanely waved Tunney to his corner. Heeney had had his chance and lost but only after a same, uphill battle.

With the exception of the 11th, and Heeney's desperate charge in the first, the tenth round was the most dramatic of the battle. It was so one-sided that Heeney, bleeding from a wicked cut over his left eye, was pathetic. Tunney opened up with one of those terrific rights just under the heart and then shot a left to the face. By that time blood was streaming into Heeney's eye, blinding him. He waded out with a left to the body. Tunney retaliated with a left and right to the stomach. They traded lefts to the body and then Tunney threw right and left to the head. Heeney tried for a left to the head and missed, with Tunney driving both fists to the body as he weakened for a same-charging in. He repeated and then hooked two hard lefts to the head. Heeney slid into the ropes and was on the verge of falling to the floor in Tunney's own corner. Instead he lunged forward and fell flat on his face, rolling over to the edge of the ring and nearly into the laps of workers in the press row.

Protest Disallowed
Heeney complained that Tunney jammed his thumb into his right eye in the eighth round, blinding him, but Referee Forbes paid no attention to the protest. The hard rock blinked continually and bled into the ropes, with Tunney apparently believing Heeney's actions a trick to entrap him, refusing to go in and find him. Heeney, in distress and seriously handicapped, Tunney, as a result of his victim's handicap, his rock-ribbed New Zealander at his best, making his most impressive showing up to this stage of the battle. His blows, however, did not carry dynamite.

Had Advantage in Reach
Tunney entered the ring facing a weight disadvantage of eleven and a half pounds, but overshadowed his opponent in height and reach. Tunney scaled 192 pounds when they weighed in at 2 o'clock this afternoon with Heeney scaling 207 1/2, the heaviest he has weighed for any of his American battles. It also was the heaviest Tunney has been since he won the title from Dempsey, two years ago.

The champion was a 3 to 1 favorite in the betting.
Although the battle lacked the magnetic appeal, from a box office standpoint the crowd was characteristically representative of heavy-weight encounters. Persons prominent in the industrial, social, business and professional affairs of the nation were crowded around the ring.

Jack Gets Hand
Jack Dempsey, the old Manassa Mauler, himself twice defeated by the man who conquered Heeney tonight, was in a front row press seat. When Dempsey, faultlessly attired in a light green suit, climbed into the ring to be introduced before the fight started, he received one of the greatest tributes ever accorded a ring hero. The ovation exceeded the cheers and applause given Tunney.

Champion Gene Tunney Retains His Heavyweight Crown



Fighters Came By Air and Water To Championship Tilt

Both Tom and Gene Evaded Large Crowds That Waited All Day To Welcome Them In Gotham.

(By Associated Press)
NEW YORK, July 26.—By water and by air and simultaneously, Gene Tunney, king of the heavyweights, and Tom Heeney, British challenger, swooped down upon New York today for their fifteenth round battle tonight in the Yankee stadium.

Wingman from Speculator, N. Y., after rising from Lake Pleasant in an amphibian plane shortly after 10 a. m., the champion landed in the Hudson river off 31 street at exactly 12:20, the very moment Heeney's entourage, travelling the 80 miles of water from Fairhaven, N. J., in the yacht Phantom, docked at 41st street. Ducking crowds that had waited hours around Madison Square Garden, where weigh-ins and ceremonies had been scheduled, Gene and his challenger hustled to Yankee stadium, scene of the international quarrel, to face the coming flash camera and the final analysis of the scales.

Heeney 5 Pounds Over
To the obvious disappointment of his handlers, Heeney tipped the beam at 203 1/2 pounds, five more than he expected to carry into the ring, while the champion weighed 192 pounds, the exact figure he had set for himself, and three pounds more than he scaled for his battle with Jack Dempsey in Chicago last fall.

Anxious and eager—"physically perfect" the examining physicians called them—the tall bronzed champion and his rival grinned for cameramen, but not together, and hustled from the building as soon as possible to seek absolute rest and quiet for the few hours remaining before ring time, 10 p. m., eastern daylight time. Before they left, however, there was a short meeting. Hurrying to dress, Gene paved the "bushy" challenger. Smiling recognition, Heeney waved a "hi-fi," Tom and Heeney returned, "Elo Gene." Then they passed immediately, not to meet again until he's being clanged for the opening round of their title match.

Hoover Listens Hears Big Fight Over Radio

NEW YORK, July 26.—Another side of Herbert Hoover was revealed late today as Gene Tunney and Tom Heeney fought their fight for the heavyweight championship of the world, 3,000 miles across the continent.

Slipping the cares of a political campaign from his shoulders, the republican presidential nominee tuned in on the fight, surrounded by members of his family and some friends who were dinner guests at the home on San Juan Hill.

A brand new radio set, installed only yesterday, was used in receiving the blow by blow account as broadcast over the country.

Big Bill Plans To Retire If Beaten

Appreciates Reinstatement But Says He Must Beat French Top-Notchers or Quit Game.

(By Associated Press)
PARIS, July 26.—"Big Bill" Tilden's international tennis future rests upon the outcome of his single matches against Rene Lacoste and Henri Cochet in the Davis Cup challenge round, starting tomorrow. The lanky Philadelphian, reinstated for play against the French defenders after he had been disbarred because of alleged illegitimacy, said today that unless he came through his matches against the two top-ranking French sets with "flying colors" he was through with international competition.

"I am glad to be given the chance to play my last Davis Cup matches with the United States," Tilden told the Associated Press today. "If I don't come through these next two battles with flying colors, I am through. I never will play international tennis again."

Was Gene's First Defense of Title Before Home Folk

Champion Was Born and Bred In Metropolis But Fights Have Been Away From Great Center.

YANKEE STADIUM NEW YORK, July 26.—For the first time in his career as heavyweight champion, Gene Tunney, born and bred in Greenwich Village, tonight came back to his home town to defend the title against Tom Heeney, New Zealand challenger who plowed his way through Tex Rickard's elimination tournament, in a 15 round battle.

The Anzac boasted an 11-1-2 pound weight advantage over Tunney, scaling 203 1/2 pounds to 192 for the champion. Despite predictions of financial failure, over 50,000 were in the ball park of the American league, to witness the main event of the season.

Give Heeney Hand
The burly Anzac climbed first through the ropes. The crowd roared up a volley of cheers for him as the New Zealander, a colorful figure, clad in a cream maro cloak, dotted with black feathers, turned under the blazing light and smiled his appreciation.

The cheers that greeted Heeney was nothing compared to the volume of sound that rolled back and forth across the big ball park as Tunney, clad in a simple purple robe with scarlet trimmings, appeared in the ring.

Neither Perturbed
Tom came right over to greet him and they smiled and snook hand with the best of feeling. Neither seemed the least perturbed.
Koude Hanson, the Danish heavy-weight and Johnny Rocco of Cleveland, were introduced from the ring along with Tommy Laughlin, the light heavyweight champion.

As Gene sat in his corner smiling, warring to his friends and at times conversing with newspapermen near him, Jack Sharkey, Boston heavy-weight was the last man introduced before the principals.
The crowd roared so far Jack Dempsey, former heavyweight champion, sitting at the ringside at a heavy-weight championship fight and not participating for the first time in nine years, that Joe Humphreys, announcer called him into the ring. The applause for Dempsey lasted five minutes and dwarfed anything that had gone before.

Round By Round Account Tells Story Of Punishment Meted to Burly Anzac By Champion, Gene Fighting at Best

Plucky New Zealander Started With Rush But Was Subjected to Fierce Trimming In Late Rounds

Round One
Grimly determined, Tunney whipped a solid right to Heeney's jaw. The challenger ducked and swarmed into Gene with short left and right hooks to the chin that drove the champion to the ropes. Heeney shot over a solid right to the head and the Anzac, sticking to his right hand, Gene crashed two rights on Heeney's jaw but averting left hook almost bowled the champion from his feet. Tunney was out fast, stabbing with his left but Tom beat both hands like a tattoo on Tunney's chin as they swarmed in close. Gene ripped a solid right to Heeney's head and moved the challenger and Tunney was on the run as Tom ripped after him, both hands failing to the head, there was a bad bruise over Tunney's left eye at the end of the round.

Round Two
Tunney obviously started at Heeney's flimsy offensive started boxing the challenger. He shot his left to Heeney's head but could not keep the bull dog of the Anzac away. Tunney blasted left and right into the sturdy head of the hard rock without causing a flicker of Heeney's eye lashes. Gene swapped with his challenger ripped left and right hooks into the chin in a furious exchange. Tunney swarmed as Tom ripped in. When Gene left hook dropped low, Tom mentioned it, and Gene smiled and asked forgiveness. A second later they were chasing each other all along one side of the ring in a slugging exchange of head elts that rocked both on the exchange as the crowd stood and roared its approval.

Round Three
Absolutely unnailed by the power in Tunney's newly found right, Heeney plodded into a right handed exchange with the titlist. Tunney dropped his guard and stood before the champion, hands ready and daring another exchange. Gene accommodated him and they cracked lefts and rights, short vicious pokes that stung jaw and cheek. Gene didn't seem to like that and he bounced back to the center, spearing the challenger with a succession of lefts as Tom stalked after him. Tunney slipped, as Heeney swept a right hook to his head and nearly fell, but came back to firmer footing, without having been down and unharmed. Heeney slugged at the challenger's head while Tunney met his attack with solid left hooks to the body.

Round Four
Rising in sympathy with Heeney's unexpectedly determined onslaught the crowd belated the invader on as he whipped a short left and right into Gene's chin. Tunney batted them right off and then clinched and shot the challengers head back with a stinging left hook. Getting the upper hand decisively for the first time in the fight, Gene threw a right into Heeney's head with every ounce of his weight and strength behind it. This time Heeney's head hit the Anzac's and Tunney pressed his advantage to two crushing rights to the heart. Sensing the turn, with blood beginning to drip from a cut under his chin, Heeney tore savagely into the champion and nailed him to the ropes with a rocking volley to the head. Back to the hem, in the same position as when Dempsey felled him last fall, Tunney fought vainly to stay out of danger but Heeney nailed him repeatedly on the head. The bell broke up the challengers onslaught.

Round Five
Tunney smashed his right full under Heeney's head but the Anzac seemed to like it and bounded in close to slug at the champion's body. Gene drilled a left and right into Tom's rugged head and blood dribbled from the challenger's nose. Boxing easily again on the defense, his natural style, Gene prodded the Anzac jolts to the head and body as Tom sturdily ploughed into what ever punishment came his way. Tom slipped, as Tunney hooked him in a clinch but was up without a count. Tunney pecked at him steadily up to the bell.

Round Six
Tunney's masterly defense had Heeney quite muddled now as Tom plodded in only to find his clouts caught on the champion's arms and his body battered by Gene's thunderous right. The challenger stepped in with a bullet-like left hook to the body and bounded his right again off Heeney's corrugated features. In a clinch with the broad-shouldered New Zealander half a head shorter, Tunney roused it to the bell.

Round Seven
Taking a breather, Tunney was content to snail with the challenger, killing the effectiveness of Tom's left hook by carrying his right hand against his cheek. As Tunney danced about, spearing Tom with his left, the Anzac missed frequently, his short arms going by Tunney's head. Tom caught the champion again near the ropes. Tunney's vital spee and slashed a left and right to Gene's head. Gene wobbled a bit and tore out of the precarious position so fast that he landed in the center of the ring before Tom could get away from the ropes.

Round Eight
Freshened by half a bucket of water poured over his head and a new haircomb, Tunney came out to hold the challenger helpless. Heeney's left eye swelled and nearly closed when something irritated it. Tom shook his head in desperation as he could hardly see from that eye. Finally he closed it of his own accord and tore into Tunney with wild, one good eye. Quick to see his advantage Gene held the challenger a moment, looked over his difficulty and then pumped lefts and rights to Tom's head and body. Tom wobbled under the blows, but blood spurted from his nose as he lashed forward in one despairing effort. Tunney met his courageous attack with sharp left hooks right up to the bell.

Round Nine
Hardly able to see from his left eye, despite the ministrations, Heeney gallantly piled into the champion. It seemed dye from the tight had gotten onto Tunney's gloves and into the challenger's eye. Tunney, a sportsman himself, stood and slugged with the challenger, but Tom got the worst of that too, as Tunney's knifing lefts drummed the Anzac's head, blood began to ooze from Heeney's battered left eye. A goaty sight and becoming scarier, Heeney again summoned his strength for another surge and ripped his right and left to the champion's head.

Round Ten
Heeney's eye looked almost normal as he came out doggedly to battle the unmarred champion. Gene grabbed Tom as the Anzac lunged forward and sank a left and right in the body. The snap seemed to have disappeared from Heeney's punches and Tunney apparently had little desire to cut up the challenger further. Gene grabbed Heeney as the Anzac plunged in close and showered him with left hooks to the head and body. Tom reeled under full left and right hand clouts to the head. His back to the ropes, Tom blindly staggered forward. Tunney half kidding, stabbed him easily with a left and let him get away. Gene flayed Tom about the head on the ropes and Tom reeled under the punishment. The challenger was helpless.

Round Eleven
Tom came out with a left that missed and Tunney measured him for a final blow. Showing amazing recuperative powers, his head a mass of blood, Tom plunged again into the champion and smashed with a right to the head. A right to the heart sent Tom reeling again. Tom could barely stagger in the close places.

Pleasure Was All Mine, Says Tunney

Champion Pays Tribute to Gameness of His Opponent—Was Sure All the Way

YANKEE STADIUM, New York, July 26.—After defending his heavyweight title like a true champion like a true champion here tonight, Gene first paid a glowing tribute to the rugged gameness of Tom Henney, his opponent, over whom he scored a technical knockout in the eleventh round of their fifteen-round bout and then he broadcast the following message to the world:

"I intend to remain in the fight business."

"I am very gratified to have won," Tunney exclaimed when he had gained his dressing room only after a large detail of police fought a way for him through cheering crowds which numbered thousands of his admirers.

Tunney was greatly concerned over Henney's condition, and though he was happy over his victory, his joy increased when word came from the challenger's quarters that the New Zealander was not in serious shape.

"I made Henney fight my fight for me," Tunney said when he was asked about the most important factor in his victory.

"I almost knocked Henney down in the first round," he continued, "and when I saw what a tough fellow he was, I decided to center my attack on his body. He was too ragged to be knocked out with one punch. It took a good many hard rights to his body before he weakened."

"His habit of coming in at me was also of great assistance to me. His rushing just added so much more force to my blows and he was weakened by every one of them."

Was Only Way. "There was no other way to fight," Tunney went on. "Just wear Henney down until I had sapped his strength and gloved him down. Henney was no Jack Dempsey in there tonight. I was never in danger and none of his punches distressed me in the least. He had nothing to be afraid of and I was confident from the first round on that we would never go the full distance with me chopping away at his head with my left and pounding at his body with my right."

Tunney's only scars of battle were a bruise on his chest and several scratches on his back, the latter indicating they were made when he brushed against the ropes. The champion had two of these rope marks when he entered the ring.

His face was unmarked, but his right ear, which he injured early in his training, had been aggravated by several hard Henney blows. Lou Pink, Tunney's trainer, promptly bathed this inflamed organ to reduce the swelling and eliminate danger of a " cauliflower ear," a ring scar which the champion is anxious to avoid.

Texas University Seeks \$7,000,000 Budget For 1928

Amount Sought for Next Year Is Two Million Above Sum Usually Appropriated; Enlargement

(By Associated Press)
AUSTIN, Tex., July 25.—Request for appropriations totalling about \$7,000,000 for Texas University and its branches for the biennium beginning September 1, 1929, was laid before the State Board of Control and discussed Wednesday by the University Board of Regents.

This is a two million dollar increase over the sum currently appropriated. The increase includes provision for \$300,000 additional salary funds at the Main University, including raised salaries and creation of new places. Provision is made for enlargement of the law faculty and increase of present salaries.

A boost in salary funds at the Medical School branch at Galveston is also requested.

The Regents up to late today had not considered action on whether Athletic Director L. Theo. Bellmont will be retained after his year's probation, but were in closed session again Wednesday night. The Regents maintain a policy of closed meetings and some of their actions have not been revealed until days after.

In the budget estimates, a \$425,000 building program was for the School of Mines at El Paso. The Attorney General ruled recently that this branch of the University does not come under the constitutional inhibition against appropriation for building purposes.

Fishing Trip Hoover Plans For Vacation

STANFORD UNIVERSITY, Cal. July 26. (AP)—Arrangements for his fishing trip in far northern California, and an inspection of the vast war library which he donated to Stanford University, occupied much of the attention today of Herbert Hoover, republican presidential candidate. Between times, he did some work on his acceptance address and received callers, who included Louis Mayer, motion picture producer; Mayor James Rolph, Jr. of San Francisco, and Mrs. Worthington Scranton, national committeewoman from

Pennsylvania, who assured him that Pennsylvania would be found in the republican column in November and that Washington and Oregon would give him substantial majorities.

CHICAGO GRAIN
CHICAGO, July 26. (AP)—Speculators overreached in big selling of corn for July and September delivery made hurried attempts today to escape and as a result September corn jumped up 5c a bushel and July 4c, as compared with the day's lowest figures.

Closing quotations were unsettled, at 3-8c to 3-1-2c gain over yesterday's finish. Wheat closed 1-5-8c to 2c net higher, oats varying from 7-8c decline to 1-3-4c advance and provisions at 20c off to 7c up.

Affairs in corn were brought to a crucial stage by an order from the Government grain futures administration requiring a report on all individual interests of 100,000 bushels or more in July corn.

THE FRANK SYSTEM

There is a great waste of money by the United States Government. We are of the opinion that there is enough money wasted by the government in extravagance and privileges afforded to officers, and employees to keep up an ordinary sized nation. And the people—the tax payers have to pay the bill. It then behooves some senator, or some congressman to make for himself a great name by entering into a fight to stop the leaks in the government expense barrel. It would be a big job, and he would have to scrap big odds, but the people should demand such, and they should know more about things like that rather than for candidates for the offices of Congress and Senate to take up so much time telling the people about tariff. We are not blaming any special candidate, for it is a privilege that all are granted, but just what would you say of your congressman at Washington should he send you a collect telegram, everytime he wanted to hand you a little blarney. Would you stand for it. Would you stand for a long distance call from Washington, charged to your account, especially for political electioneering. Unreasonable you say. True, but they do the same thing in principle. When you get a lot of congressional junk through the mails without any stamp on it, just put it down in your mental notebook that you are paying the postage. It might as well be sent collect. Government printers are paid salaries to set up in type and print it. Railway mail clerks and postoffice employees at both ends of the line have to handle it. When you consider the aggregate number of pieces of mail imposed upon the postal system you can imagine the burden it places upon this branch of the government. If all such junk were barred from the mails it wouldn't cost you as much to get legitimate mail carried. Your politically alert public servant wouldn't have the nerve to send you a letter or extension of remarks collect. But he accomplishes the same result indirectly by using the government frank. You pay for all the free privileges that the congressman enjoys but you don't like to have to pay for the propaganda to perpetuate him in office, whatever your attitude toward him personally may be.

It looks like that if an intelligent lawmaker realized that you realized that he was virtually sending you his political patter "collect" he would be a boob to solicit your vote by such methods. Every boost by way of the "franking" route is a knock to thinking people. Besides if they only knew how little their constituents, or whatever they call us, cared about their silly speeches and the insignificant episodes which a liberal system allows them to color so expertly for the furtherance of their little ambitious schemes, they would be amazed. We don't know how others feel but personally we don't want any more mail! We have practically no personal mail except once a month and it is just another one of those tyrannies of life thrust upon us that we are forced to open a lot of business, political and miscellaneous propaganda every day and make disposition of the same. You can't let the stuff pile up in the front room. It clutters up the premises. Second-hand paper prices do not justify saving and collecting the junk. We cook with electricity and do not need it to start fires. We find newspapers more suitable for table clothes and general wrapping purposes. We can think of no earthly purpose to which to put these gratuitous pieces unless they were sent blank so we could write our column on them. Read it? Nobody reads such things these days. Nobody but a glutton would attempt such a diet and he would soon be overcome with mental indigestion. We believe in economy in government and the first place to strike is to rub this guy 'Frank' clean off the payroll.

POLITICAL DISEASE

The disclosures in the federal patronage probes in Mississippi and other Southern states have been somewhat startling. Grand jury indictments have been returned against five or six persons charged with corruption and graft in the sale of federal positions, and testimony

has been written into the record to the effect that holders of federal offices, principally postmasters, have been required to make regular contributions to the republican organization. Some of the money received for appointments or as "contributions" from office holders went into the party campaign funds, while some of it went into the pocket of party officials, according to the published testimony.

This situation is bad, and the worst phase of it is that what has been discovered in Mississippi may exist in even more serious degree in other states. The disclosures at Biloxi show merely the symptoms of a disease that under our present system of government appointments may exist all over the country; and if as is often charged, there is gross incompetence and infidelity in public office in America, here is one of the outstanding reasons for such a deplorable condition. Federal appointive offices, for many years past, have been considered merely as the spoils that accompany political success. Under democratic and republican administrations alike, there has been an apportionment of patronage among party leaders, such rewards for service to the party being frankly admitted. The "faithful stewards" of the party are given authority over their share of appointive offices, and the party and its administration discreetly trusts in the wisdom and the judgment of those to whom such authority is delegated. That there is corruption under such a system is inevitable, and that it is widespread is certain. The wonder is that there have not been more startling disclosures than those of the Mississippi grand jury investigation.

Public office is a trust and not a chattel. The marketing of "influence" which comes with political success is in violation of both the spirit and the letter of the fundamental law of the country, and can not be too vigorously condemned. But should we undertake to place all the responsibility for such a shameful practice upon the shoulders of the man who sells the office and receives pay for it, or should we insist that the man higher up, even the president of the United States himself, share in our condemnation because he has permitted such a misuse of the power entrusted to him and delegated by him to subordinates?

FAITH DOES THINGS

"We were sustained by faith," declared one of a group of flyers who recently completed one of the most perilous flights in history. This flyer has repeatedly made that statement. By their faith they conquered.

After consideration we might not be as inclined to scoff at this statement as we were at first. After all we might say that nothing really worth doing was ever done in any other way. Before the deed, comes its conception in the mind of the doer. Between the first effort to put it into execution and the final triumph come many hours of uncertainty, disillusion and hardship. What is it that keeps a man going in such times, if not faith? Where faith is lacking the job is given up. For it does not matter what you are doing if it is truly important and worth while, there will be moments when ultimate victory seems utterly impossible of attainment. If you lack faith you quit, then and there.

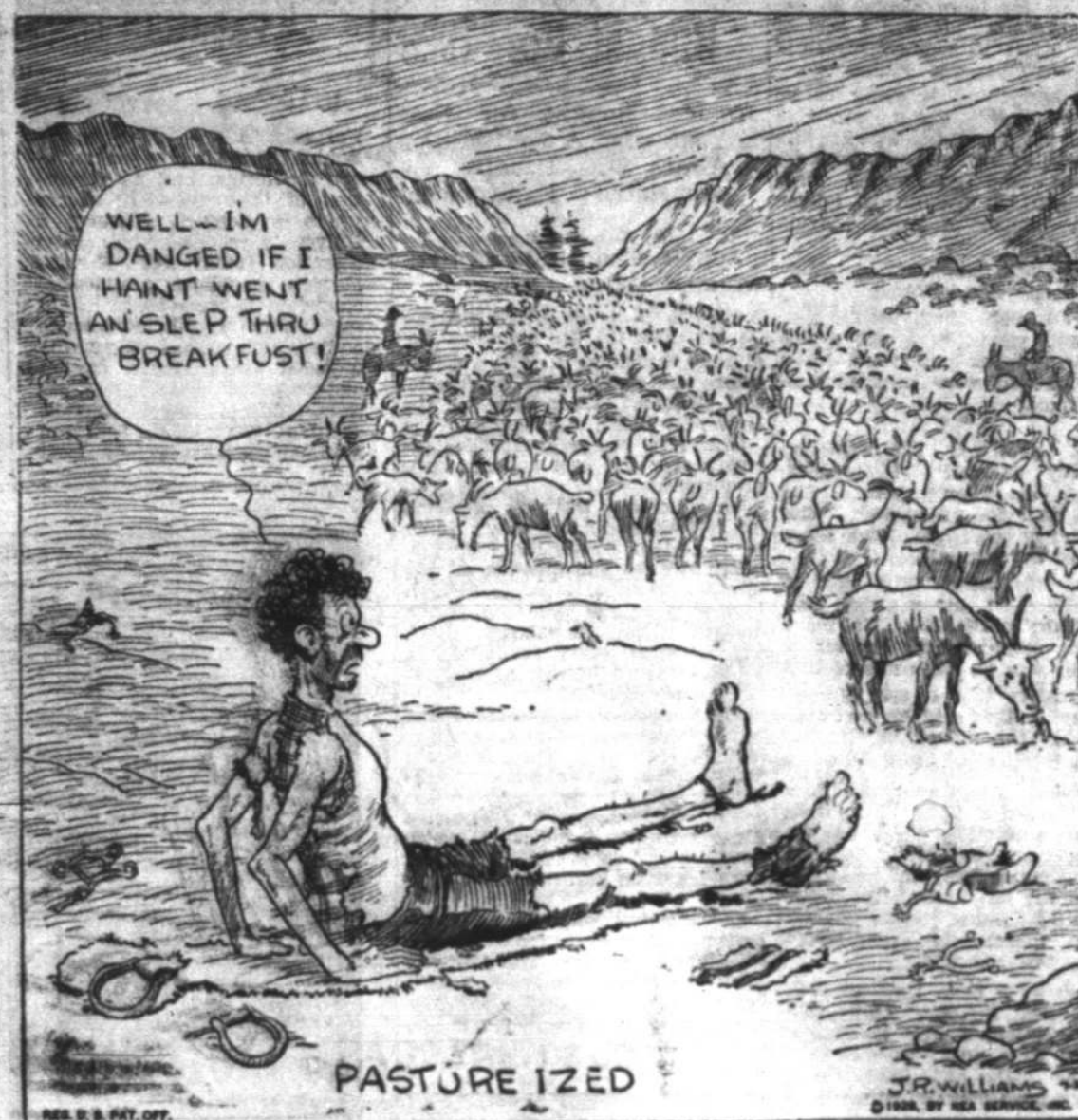
A review of history brings out any number of instances where the fate of nations hung on the faith of the leaders in the cause which they were supporting. Where would America be today if Washington had not had faith in his cause when he was spending that unhappy and trying winter at Valley Forge? A little later, when Jefferson fought against privilege and a powerful social aristocracy to make the new government a true democracy, there came times of almost complete discouragement and despair. There must have been times in Abraham Lincoln's administration when it seemed that it would be impossible for him to bring the South back into the Union. The history of these United States would have been far different if he had not had faith in the cause which he championed so nobly, and kept fighting.

It has been written that faith can move mountains and it doubtless can. It is the one quality, possession of which distinguished the great from the near-great who lack it. It may be said that without faith one can do very little that is difficult of attainment, and practically all the worth while things of life come hard.

Some people can look in the face of men and tell whether they are "men." But politically we have noticed that they are pretty sure what political brand is on the animal before they express their opinion about it. Several years ago Hoover was considered a democrat, and the "rock-rib" demos could see nothing wrong with his face, but as soon as he was nominated for the republican presidency, they could at once see oppression written all over his face. This thing of imagination is a wonderful thing.

Some people would not allow the minister of the Gospel to even so much as raise his voice in protest of the election of a man to high office, especially when great moral questions are involved. If this does not come under the scope of the ministry we do not know what would. We believe that where moral issues are involved as is the question of prohibition and the protestant religion, they should speak.

PRESS COMMENT

ATHLETES AND SCHOLARSHIPS

College athletes have been exonerated again. The standing charge against them is that they are dumb everywhere except on the athletic field, that they make little or no effort to maintain satisfactory classroom records, and that they are usually spending their time rather than their money in the roughneck in appearance and conduct. It isn't so, according to investigators who have examined Princeton students recently.

The athletes in the senior class at Princeton "measure up to or above the average" in scholarship and behavior," the investigators report. It was not shown how many athletes survived the classroom grind and reached the senior year's work, but the inference is that there were many of them.

If the college athlete fails to make good as a student, it is because he doesn't want to rather than because he can't. Modern college athletics requires keen and active minds. A boy who can master the signal system of an average football eleven can memorize, even if he can't understand any of the logarithms that was ever devised to harass and discourage an upperclassman. Moreover, there undoubtedly is a certain value in the training that is given the athlete in discipline and in observance of a regular routine, for no matter what his natural inclinations may be, the athlete can not make good unless he follows at least in part the rigid training rules that are prescribed by his instructors.

Most colleges surround their athletes with more glory than they are entitled to, perhaps, and many supporters of college athletics are prone to claim for the athletes many more virtues than they actually possess. The athlete is very much like his non-athletic fellows, in most respects—probably no smarter than the average college student, but of necessity as smart as the average probably no more amenable to discipline than the average but of

necessity as obedient as the average probably no more gentlemanly in his conduct but of necessity yielding to regulations calculated to conserve his health and strength. They are heroes for a season, but their feet are of lead, just the same.—Brownwood Bulletin.

YOUR HEALTH

EDITOR'S NOTE: This is the second of three articles on infections of the nervous system. Tomorrow: Encephalitis.

Of the three great epidemic diseases that attack the central nervous system, infantile paralysis is perhaps most dreaded by the mothers of growing children.

One of the first pandemics of this disease that swept the world was that which appeared in Norway and Sweden about 1906, spread over the nations of the world rapidly and then appeared in epidemic form in the United States.

It attacked first on the eastern coast of this country and then in Minnesota and in adjoining states which are the western homeland of the Scandinavian immigrants.

In his Kobek lecture, Dr. Simon Flexner points out that this epidemic has not yet run its course, and that considerable outbreaks of infantile paralysis have occurred in 1927 in California, Massachusetts and New York state, in Germany and Rumania.

In the epidemics that swept New York in 1916, 20,000 cases were reported and many more may have occurred. Thus the pandemic has lasted 20 years, and it is not possible to predict when it will wear itself out by "wearing itself out" one means that the disease will have attacked those it can reach and who have no resistance against it.

It is known today that there are some cases of infantile paralysis which pass through phases of fever and the other symptoms but without paralysis so that it is not possible to say definitely exactly how many cases really occur and are diagnosed and just how much the disease spreads.

The cause of this disease has not been determined. Many investigations have been made which indicate that there is an infectious substance, either a germ or a virus the latter being infectious material so small that it cannot be seen even with the most high powered microscope.

It has been proved definitely that it is possible to pass the disease to monkeys by transmitting the infectious material. Dr. Flexner is convinced that the disease is passed from one person to another by the way of secretions of the nose and throat, from the nose, it is carried to the spine, and there it affects the anterior side of the spine so that another name for the disease is "acute anterior poliomyelitis," an inflammation of the material in the front of the spine. From the front of the spine pass the nerves that control motion.

Therefore, severe inflammation and crippling of these nerves result in the condition of paralysis that is the chief mark of the disease.

The Fight With It
It has been found that persons who are recovering from the disease developed in their blood material which fights the disease. Hence it is becoming customary to treat the condition by obtaining the blood of persons who have recently recovered and injecting this into persons who are suffering with infantile paralysis. The suggestion is also made that such blood may have the power of preventing the disease, and in the presence of an epidemic, attempts are already being made to control the disease by injecting the blood serum that has been mentioned.

DAILY MARKETS

KANSAS CITY LIVESTOCK

KANSAS CITY, July 26.—U. S. D. A.—No material price changes were registered on cattle at Mot. Point. Around the 31 market circuit trade on native grain feeds was somewhat uneven, demand fairly broad for light weight yearlings and light weight steers, and narrow for matured steers. Western grass steers moved slowly to packers, shading values on the off-quality kind at some markets. Chicago scored \$18.85 on choice yearlings, equalling the season's high mark paid at Omaha on Wednesday. Omaha to medium Kansas-grazed Texas steers ranged from \$9.75 to \$12.50, kinds above \$11.50 fairly well-covered and scaling upward to 175 pounds. Total receipts of around 35,000 were about the same as a week ago and 2,000 less than same day last year.

The supply of hogs was estimated at 69,200 as compared with 79,575 last Thursday and 83,511 a year ago. Decreased receipts, stilling shipping demand, and the better grades were generally 10 to 15 higher. Packers were bearish refusing to follow the pace set by shippers at several points. The extreme top of \$11.70 was paid at St. Louis.

Fat lambs were on a steady to strong basis with a few markets reporting a slight upturn. Aged stock continued to hold at the same levels. Choice range lambs realized \$15.25 while \$11.00 was paid for Colorado rangers at Kansas City. Aggregate offerings were around 38,500. A 2,500 decrease from a week ago and a shortage of 10,500 from the same day last year.

WALL STREET STOCKS

NEW YORK, July 26.—The line of least resistance in today's stock market was again upward. The rally, which ran from 1 to 6 points in many issues, lost some of its snap in the late trading on the usual evening up of some speculative accounts in anticipation of the weekly brokers' loan statement, but the main trend continued higher. Trading showed a moderate reduction in volume, the day's sales again falling below 1,500,000 shares. Funds were available at the renewal figure of \$1-3 per cent.

The Federal Reserve bank reported a decrease of \$10,496,000 in bankers' loans in the week ended July 25, bringing the total down to \$4,183,919,000 as against \$3,141,182,000 on July 27, 1927.

Heavy buying of American Smelting, which crossed 200 and closed just below that figure for a net gain of 4-5-8 points, was accompanied by unconfirmed reports that William C. Durant had acquired a large block of the stock. Most of the other copper shares pointed upward despite trade reports of a poor demand for the red metal.

NEW YORK, July 26.—Cotton prices advanced \$2 a bale today on reports of further showers or rains in the eastern belt and increasing apprehensions of boll weevil damage in that section, combined with relatively firm Liverpool cables and a firm technical position. December contracts sold up to 29.41, or 45 points net higher, and closed at 29.76. The general market closed firm at net advances of 29 to 43 points.

October sold up to 29.99, and Jan-

uary to 29.74, net advances of 42 to 45 points on the more active months, while May, selling at 29.61, showed a net gain of about 50 points.

Closing prices were within 4 or 5 points of the best on most positions.

NEW ORLEANS COTTON

NEW ORLEANS, La., July 26.—Cotton prices advanced today under trade buying induced by talk of increased weevil activity and reports of an over-abundance of rain. At the highest October traded at 29.84, or up approximately \$2 a bale. The option closed at 29.94, or 36 points net up, with the general market steady at a net advance of 36 to 40 points.

Liverpool cables were 9 to 12 points better than due and first trades here showed gains of 10 to 20 points.

Profit-taking was absorbed on setbacks of 7 to 11 points and the market started upward again for the remainder of the session, closing at or near the highs with October at 29.84, December 29.93 and January 29.92, or 36 to 40 points net up. Receipts 1,703; for week 12,720; for year 8,483,206; last year 12,872,502. Exports 11,515; for week 54,564; for year 7,518,713; last year 10,905,203. Stocks 633,379; last year 964,840. E. B. Suller of Fort Worth, secretary of the Texas and Southwestern Cattle Raisers association, said that interests of that body and of the sheep and goat raisers were so similar that movements benefiting one would automatically aid the other.
