TRAIL OF TERROR, MURDER, RAPE, PILLAGE

Bullets End Convicts' Spree

STEPHENVILLE, Tex. (AP) — A four-day odyssey of terror across three states ended here in Monday night's darkness when one escaped convict died with his jaw blown away and two others meekly surrendering.

MERCY

The trio killed two old enemies on the spur of the moment and almost casually, repeatedly raped two young women, wounded five persons and robbed a bank and burglarized at will.

They "showed the only sense of remorse we know of," said Erath County Dist. Atty. Bob Glasgow, when they let

The survivors said they fled over three walls at the Colorado penitentiary, stole an automobile, shot out the tires of a car bearing two young women and kidnaped and raped the women repeatedly as they fled across New Mexico and Texas.

They planned to head for Mexico but decided to come to this West Central Texas region and rob a bank first.

One suddenly recalled a man who testified against him in an old trial and decided to kill him, the prisoners related. They shot and killed another witness, a woman, who resided in

this region.

Mrs. Ray Ott who was slain Saturday evening near here and Rotan rancher T. L. Baker who was shot to death in front of his house. The body was found next to that of his dog.

Ironically, dogs caused the convicts' downfall shortly before midnight.

As the escapees approached the house of Cobb Butler near a farm road at 11:05 p.m. the barking dogs alerted three policemen from Mineral Wells and one from Eastland who were in a car a short distance away. They were among the area officers who had joined state police

in building a blockade around a five square-mile area in the Central Texas county of Erath.

Officer Richard Trail said, "The dogs started barking and we saw the three suspects run from behind the house. One of the officers threw his spotlight on the suspects, and the suspects were advised to halt. Instead they broke and ran, and we started shooting."

Trail was with Jim Ellmore, Freddie McDonald and Larry Brandenburg of Mineral Wells, just north of here in Palo Pinto County.

The officers said they fired approximately 15 shots.

"It was a short volley, but it was pretty rapid fire," Trail said, explaining that the officers were armed with handguns, shotguns and rifles.

Ellmore said he did not think the convicts returned the fire, although they were armed with rifles and had ammunition in their pockets.

Trail said the convicts ran toward a line of bushes and Mangum dropped dead. Moments later Ulmer and Williams came out of the brush with their hands up.

"They didn't say a word," Trail said. "They

just surrendered." McDonald said, "We were told they would try to get into town or break the perimeter tonight. The dogs were the tipoff."

Dist. Atty. Bob Glasgow said the two surviving convicts would be charged with the murder of Mrs. Ott.

She was killed Saturday evening when the three convicts broke into her home and also wounded her husband. She had testified against Ulmer, who had been charged with burglarizing the Ott home last January.

Ulmer was in prison under conviction of

murdering a man near the Colorado-Wyoming border. He was serving a life sentence.

Williams was convicted earlier this year in a Jan. 18 robbery of a surplus store in Fort Collins, Colo. Earlier he had been charged with burglarizing the Baker home and stealing several guns. He was serving a sentence of 40 to 60 years.

Saturday night, after abandoning their last stolen vehicle, they failed in an attempt to get another car and were chased on foot into this area of rolling hills, timber and brush and small farming communities.

Course On Care Of Aged Slated

More than 150 staff members, representing nursing homes and homes for the aging throughout West Texas, are expected to convene at Big Spring State Hospital Wednesday and Thursday to study a team approach method for delivering improved care to older persons.

The two-day course, entitled "Recreation and Recreation, A Panoramic View," is conducted by a team of instructors from Presbyterian Village of Dallas, a long term care complex including all levels of care for older persons. The instructors are part of a Regional Training Facility, established under a grant from the Health, Education and Welfare Department.

The sessions, featuring group discussions as well as classroom instruction, will focus on a cooperative nursing home staff effort to increase ability in developing an environment conducive to maintaining health, providing rehabilitation and preventing mental, physical and psycho-social deterioration in a practical manner.

Planning for the special training session included members of the Big Spring; Veterans Administration Hospital, Big Spring State Hospital, the Texas Department of Public Welfare and representatives from various nursing homes in the area.

The program is sponsored

by the Texas Association of Homes for the Aging, a statewide organization representing nursing homes and homes for the aging which operate on a not-for-profit basis — principally religious or community sponsored. It is one of more than 30 such training sessions planned by the association over the next two years.

Howard College, which also is assisting in the sponsorship of the program, will present certificates of credit as part of the staff upgrading process.

Originally planned to be held at the Big Spring VA Hospital, the site was changed to accommodate the large number of registrants for the course.

TO DISCUSS EMPLOYEES' RIGHTS

Union Advisor Asks City To Set Special Meeting

Kenneth Howell, adviser to Local 826 AFL and CIO, spoke to the city council here this morning asking for a special meeting to discuss the civil rights of local employees.

The city council was in the process of discussing the matter with Howell at the news deadline. Howell told the group that he was representing the city employees as a group and individually and that he had some questions to ask about violation of overtime pay on the wage and hour laws.

He also read a policy memo sent to employees in April which required them to go through their supervisor and not directly to a city councilman when they have a grievance.

Howell claimed that as taxpayers they had a right to go to the councilmen. Both Mayor Wade Choate and City Manager Harry Nagel told Howell that as employees on a job, there must be a chain of command.

INSTRUCTIONS

The employees in the memo were instructed to go to their immediate department supervisor with grievances. These in turn could go then to the city manager and lastly to the council, if not satisfied.

Howell was invited to speak at the end of the meeting since a letter requesting to be on the agenda had only been presented to the mayor Monday. Legally, requests must come four days in advance to be placed on an agenda.

In other action, the council approved the parks and recreation minutes following lengthy discussion of portions of their minutes.

Representatives from the Texas Little League had Councilman Eddie Acri speak for them saying that "they were not properly informed of the parks and recreation meeting and need a chance to re-appear." The council agreed to have them placed back on the agenda of that group.

The council also tentatively agreed that land for a new park for the group could probably be available in the area of the new city park, but that park improvements would probably be up to the league itself.

SEAL ADOPTED

The official city seal was adopted. A request was granted to advertise for furniture in the remodeling of offices and the council room of city hall. The council accepted the gifts of the Dora Roberts Foundation with gratitude.

A water deposit policy was approved for one year after lengthy discussion. The administration will be given the power of making a decision on deposits as to credit rating.

All deposits will be returned after a year of good credit and prompt payment of bills. After the computer can be set up, former deposits will be repaid to those who have a good credit standing with the department.

The council passed the policy with Acri voting "No". Acri thought all persons should pay a deposit for the first year, or no one pay a deposit.

The council gave final approval to the plumbing ordinance change, to the resolution backing the Regional Emergency Medical Care System and to the ordinance concerning appointment of board members and chairmen.

The following appointments were approved. To the city planning and zoning board, the three whose terms are expiring, J. D. Jones, George Elliot and Ben Bancroft were re-appointed. Bill Sheppard was named chairman.

On the parks and recreation board, the terms of Jim Zapp, Harold Davis and Father Delaney were up and they were replaced with A. C. Mize, Larry Willard and Harold Rossen. Willard was named chairman. Replacing them as alternates were Rev. Steve Birdwell, MSgt. Samuel Earls and Mrs. Julie Shirly.

On the board of adjustment and appeals, all members remain the same with Roy Crim named chairman.

On the traffic commission, members remained the same with Lt. Col. Joe Dromsky as chairman. On the zoning board of adjustment, Daryle Hohertz was named chairman. Fred Haller chose not to serve again and was replaced by Winston Winkle with Dr.

Paul F. Kionka named as alternate.

The electrical board remained the same, as did the plumbing ordinance appeals board. Named to replace the late R. W. Currie on the CRMWD Board was his son, John Currie.

Eddie Acri was reappointed to the juvenile board and the joint airport zoning board remained the same.

Mrs. A. O. Vanderford was named chairman of the Detox Advisory board.

The council approved continuation of funding for the Detox Center, approved minutes of the tourism committee and approved vouchers.

In the city managers

report, Nagel discussed new policies concerning the Dora Roberts Community Center which will be presented to the council in the near future.

All council members were present including Harold Hall, Charles Tompkins, Mrs. Polly Mays, Acri and Mayor Choate.

Lindbergh Is Cancer Victim

HANA, Hawaii (AP) — Charles A. Lindbergh, who sparked worldwide excitement with his "Lone Eagle" flight from New York to Paris in 1927, has been buried in a small, seaside graveyard less than eight hours after his death.

The only family members present on Monday when the 72-year-old aviation hero was buried beside the non-denominational Kipahulu Hawaiian Church were his widow, Anne, and one of the five Lindbergh children, Land.

EULOGY

The other four living children of the man who flew out of obscurity with an epic solo crossing of the Atlantic in a single-engine plane were too far away to fly to Hawaii in time for the service.

The eulogy — part of which Lindbergh had written himself — was delivered by a young Protestant minister, the Rev. John Tincher.

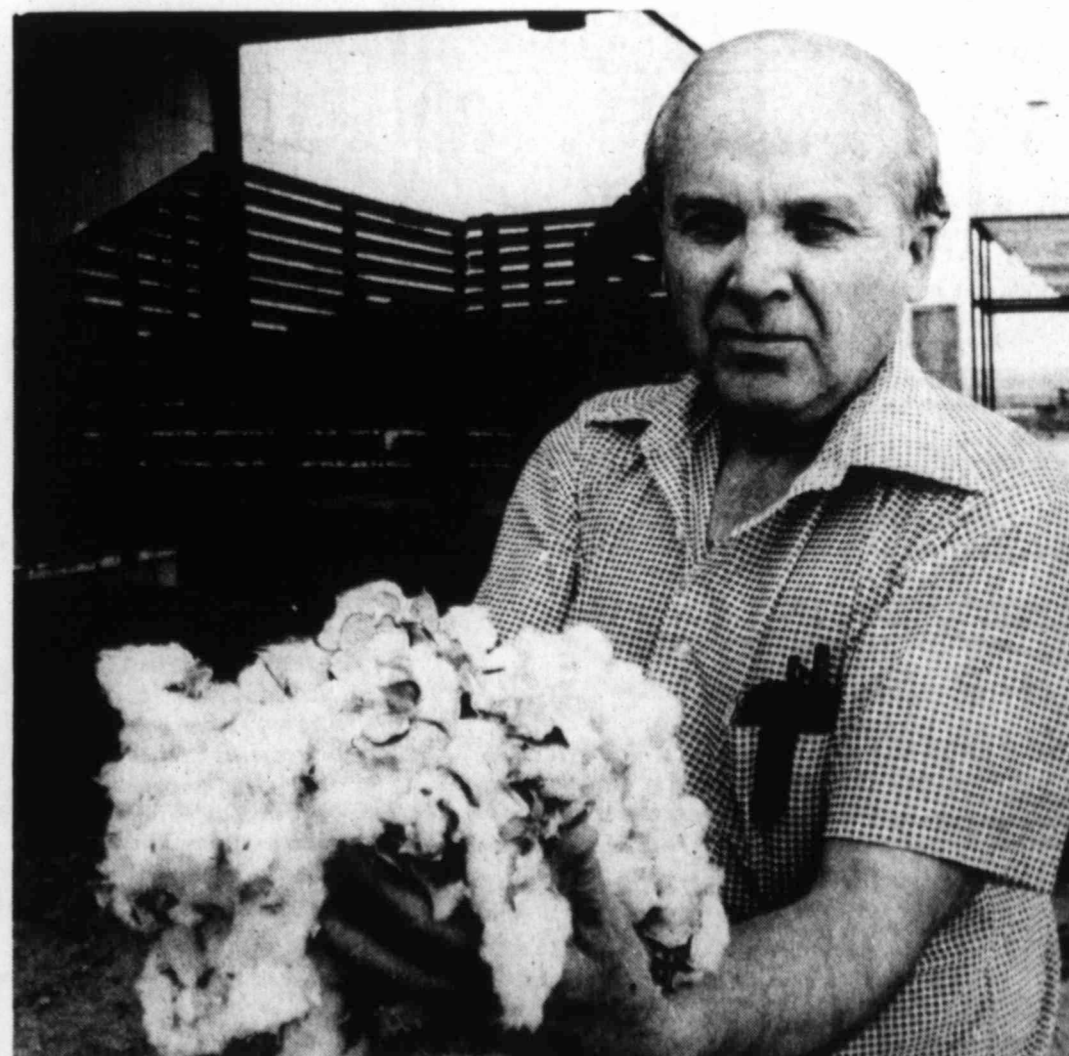

Lindbergh penned these words: "We commit the body of General Charles A. Lindbergh to its final resting place, but his spirit we commend to Almighty God, knowing that death is but a new adventure in existence and remembering how Jesus said upon the Cross, 'Father, into Thy hands I commend my spirit.'"

At his own request, Lindbergh was buried in a khaki shirt and dark cotton trousers. His casket of eucalyptus wood was built by cowboys from nearby ranches.

"The Lone Eagle planned his final trip as much as he planned his Atlantic trip or anything else he ever did in his life," said Dr. Milton Howell, a longtime friend.

Cook said, "Chicago Today has experienced substantial financial losses for a number of years. The quality journalism was there. The revenues were not." Chicago Today is one of Chicago's two afternoon papers. It has a circulation of 414,000.

Floating Bonds Face An Uncertain Future

NEW YORK (AP) — The performance last week of the corporate bond market's newest investment vehicle—notes with floating interest rates—left Wall Street debating whether they are really here to stay. Floating notes brought to market last week by The New York Bank for Savings, Mellon National Corp. of Pittsburgh and

Crocker National Corp. each nearly sold out. But in all three cases, the size of the offerings had to be reduced from originally planned levels. The issuers blamed "market conditions," but a spokesman for a leading bond underwriting house suggested that the small investor—the target of the floating rate notes—may be signaling he is not as willing as many believed to withdraw all his savings and lend them to corporate floating bond issuers. The notes are sold in \$1,000 denominations to give investors access to high-yield, short-term issues. "I think there is a point where the bond market can be saturated with these floating notes," the underwriter's spokesman said.

Man Remains Active After 70 Years As Doc

ELIZABETHTOWN, Ky. (AP) — Aze hasn't forced Dr. Jesse Smith Bean into retirement, even after 70 years of practicing medicine. "I just got in the habit, and I can't quit," said the 96-year-old general practitioner who specializes in chronic and nervous diseases and obstetrics.

His wife died in 1966 at the age of 81. They were married 57½ years, and had one son Leonard T. Bean, who became mayor of Elizabethtown.

"I just can't make up my mind to retire and sit around and do nothing," said Bean, who admits his eyesight is failing him.

Nevertheless, his hours are 8 a.m. until 7 p.m. Bean is the oldest practicing physician in Kentucky and one of the oldest in the nation.

He has practiced out of the office at his home for 30 years and until a hospital was built 10 years ago "I was in the office all the time," Bean said. Now patients number three or four a day.

Bean, a native of Ohio County, graduated from the old Hospital College of Medicine in 1904, now the University of Louisville.

Bean then set up practice in Olaton, and later in four other towns before he moved to Vine Grove in 1926 and Elizabethtown in 1944.

He recalls making only house calls when he began practicing because doctors didn't have offices then. A patient's kitchen was the operating room. There were no hospitals, no telephones. Horses were often the mode of transportation.

"In those days, people didn't pay much. Nobody had anything," he said, adding he once received a cow as payment from a patient he treated for pneumonia.

Bean says he has no secret for his health and energy. "I live a modern, average life, have regular meals, sleep, and attend to my

FBI Joining Theft Probe

NEWTON, Mass. (AP) — The FBI said today it has joined the investigation of the theft of an estimated \$500,000 to \$1 million in rare, 17th century Dutch paintings and drawings from a lawyer's home.

George S. Abrams said Sunday his art works all are over 350 years old but are "relatively unsalable" because they are well known by collectors.

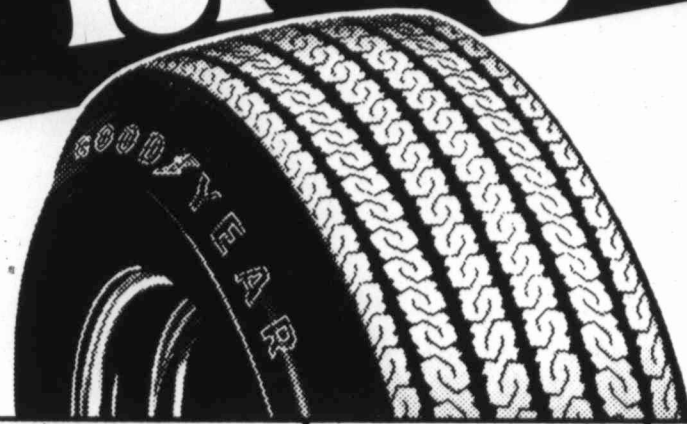

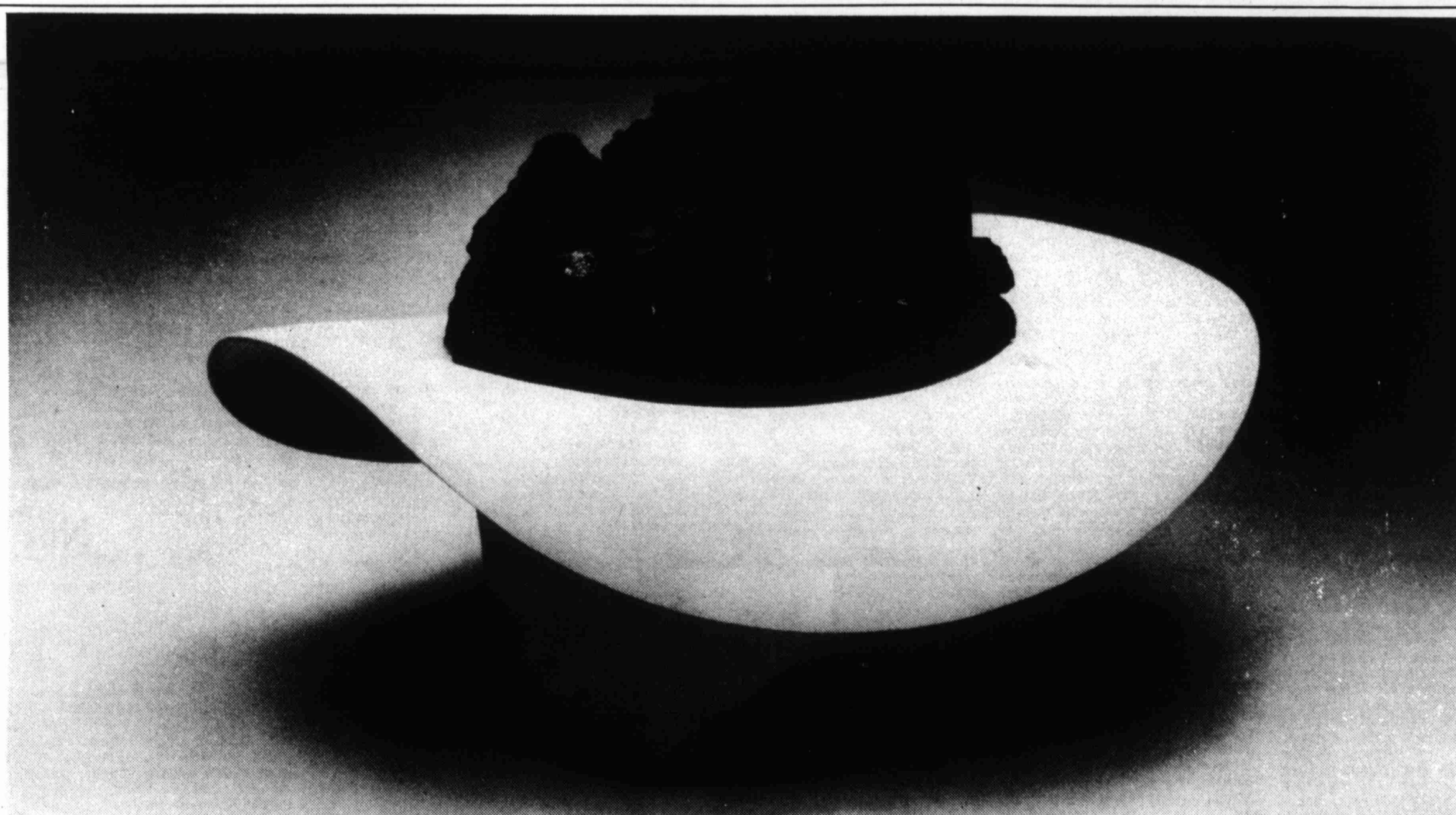

Move With Leaden Feet

In one of his recent commentaries, Howard K. Smith of ABC News lifted a voice in dissent from the chorus that our traumatic but effective switch within government "proves the system works."

"I don't think we can be self-satisfied with a system that works only after tearing us apart for a year and a half," he said. "I am being aspoilsportfor, I hope, a constructive reason. We are in peril of a pleasing feeling that with Nixon out and Ford in, our political system is all right. It isn't. The cause of Watergate is bad campaign finance practice, too much special interest loot in politics hunting for mischief to do. It kills needed legislation. It dirties politicians. . . . and Congress is moving with unwilling, leaden feet."

The Harris poll reflects that a majority of citizens wants full disclosure of campaign contributions (although less interested in disclosure of private financial affairs of public officials and employees).

A full disclosure law is the least that Congress can do now. Perhaps there is some argument to make haste slowly, but Congress is grossly derelict in not making any appreciable "haste" at all in campaign reform.

Col. Wilson E. Spier, director of the Texas Department of Public Safety, issued his estimate that Labor Day weekend traffic mishaps will claim 34 lives. Unfortunately, he may be right, for drivers have shown a disposition to fudge more and more on the 55 mph speed limit. They may be fudging only on themselves and on the other individuals whom their recklessness might kill or maim.

If there is any validity to the thesis "that he who pays the fiddler calls the tune" (and we believe there is), then the public is entitled to know who is putting up the ante for the fiddler.

We Can Do Our Part

We can't control all of Texas, but we can be diligent about a safer holiday weekend in our own part of the vineyard. Recently we have experienced a shocking, numbing wave of fatal accidents in our city and area. You can help curb this by being doubly careful and doubly alert; our officers can curb it by pinching down on violations in the area.

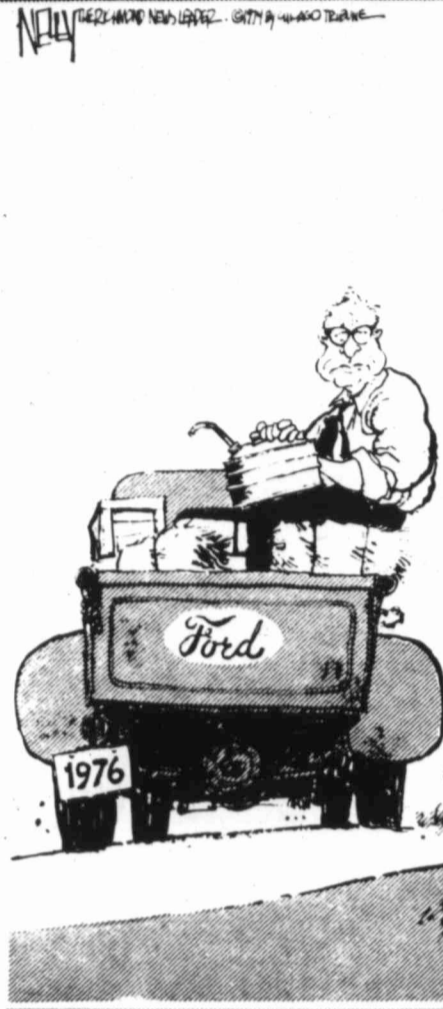
If the virgin birth is the cornerstone of Christianity, why don't we accept the biological theory of parthenogenesis as being possible for the continuing development of the race?

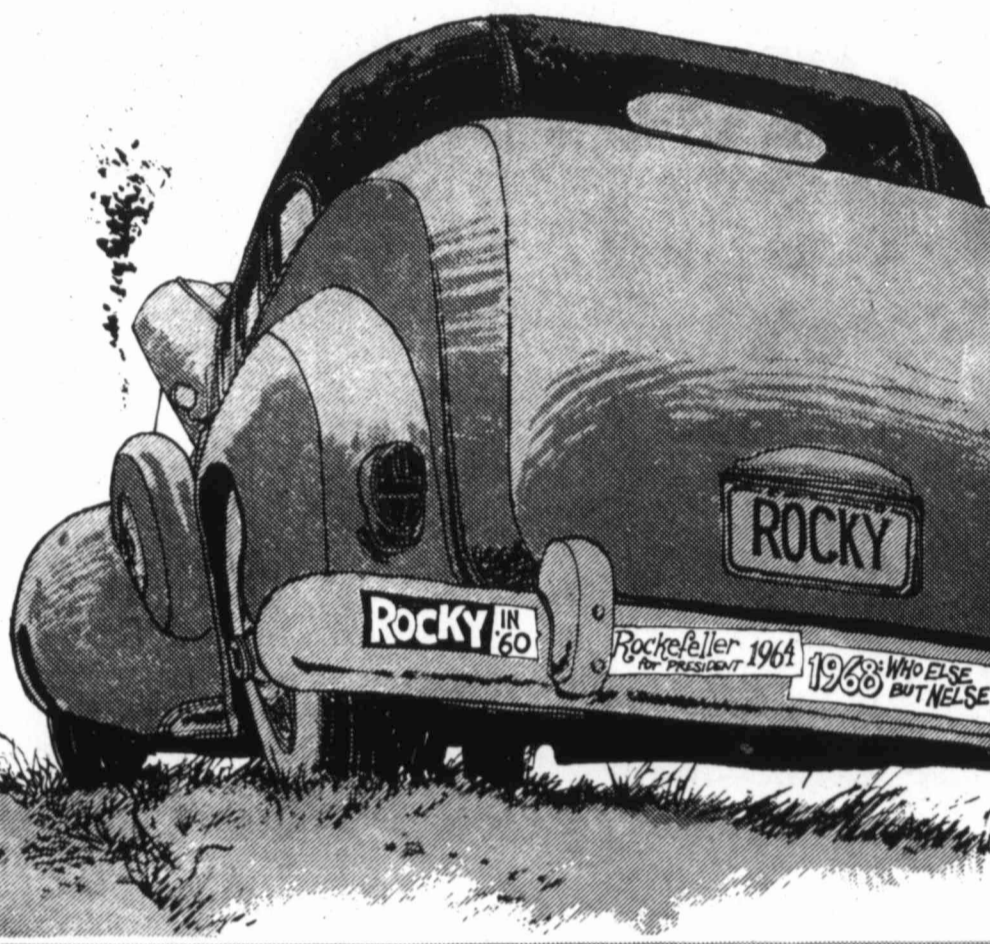

Peruvian Tragedy

Pedro Beltran, a septuagenarian with the noble face of an Inca, and the cosmopolitan aristocrat, served briefly as prime minister of his native Peru. But mostly he has been a Publisher, the principal owner of La Prensa, the New York Times of Peru. He is a conservative who has argued throughout his life for improved social conditions and for human liberty.

WHEN GEN. VELASCO took over Peru, as generals tend to do every decade or so, he recognized many obstacles to his creeping totalitarianism, not the least of them Pedro Beltran. He moved against Beltran in bits and pieces, the way that cowardly tyrants tend to do. First the government recognized a compulsion to broaden a city street and incidentally tear down Beltran's historic home. Then they started taxing his farm and otherwise making it all but impossible to continue to manage it.

Then, Beltran having journeyed to the United States and Europe to teach a few courses in Latin-American history and economics, he returned and was accused by a court order requiring him to sell his newspaper. On the grounds that he had been absent more than the consecutive days a newspaper owner is permitted to be absent under the terms of a dusty old statute never before enforced or even ventilated. Needless to say, the appraisal made of his stock was a preposterous figure. Gen. Velasco's mastery of the techniques of tyranny was becoming more and more highly developed.

THAT WAS A couple of years ago. Now Gen. Velasco appears not to care about appearances. A few weeks ago he simply nationalized the press and turned it over to a couple of government-run labor unions to administer. Pedro Beltran, by now an expatriate, was in Paris when it happened. He issued a most eloquent statement, reminding his countrymen that the cry for Latin-American independence had been uttered a century and a half ago against the oppressive Spanish Viceroy. And that cry was "The people want to know what it's all about." It is now official that, in Peru, they will not know.

It is a strange government down there, curiously immune to sustained criticism from the centers of liberal concern around the world. The reason for it is that the generals who took over the country aren't the

usual kind who conform to the country's traditional modes. This Velasco fellow is a socialist. Not of the Allende brand. He doesn't go about proclaiming his solidarity with the socialistic world; indeed, he affects to eschew any ideological affiliation whatever. But he has managed to deflect a lot of the usual criticism aimed at military despots by appearing to give things away to the poor.

PERON DID THIS for a while, perhaps you will remember. He just gave things away to the poor, and managed to set back the Argentinian economy by a generation, so that after the circus was over, people were poorer than ever. Finally the world turned against Peron, and for some reason he comes down to us as having been a "right-wing dictator," even though his alliances were always with the proletariat and the labor unions, and he was opposed by the Church, by business, by the press, and, finally, by the military.

Gen. Velasco's military associates are thoroughly in tune with the new brand of Peruvian leftism that is eroding Peruvian institutions. It is only the navy down there that he worries about, since it continues to be anti-Communist, and there are signs not only from the navy, but from the people, of a grave dissatisfaction with Gen. Velasco's policies. In the past, generals have returned rule to the civilian arm after an interval.

GEN. VELASCO apparently has no such plans. He recently concluded a deal with Aeroflot, the Soviet airline, containing a most extraordinary provision never before experienced, to my knowledge, in commercial aviation. Article 13 says that in the event of "international conflict, internal disorder, or public calamities," the Peruvian government can avail itself of the entire resources of Aeroflot in Peru. This means, in effect, that the Soviet Union could quite legally make available its civil air arm to Peru to help it quell internal disorders, or to wage some kind of military action against its traditional rival to the south, Chile.

AGAIN, NO NOTICE taken. Of course we do not pay much attention these days to the Monroe Doctrine, let alone its implications. But it is sad to think that after all our experience in hemispheric solidarity and what-not, Peru's tyrants are lining up the Soviet air force for the sake of making it tougher for the Peruvian people to know what it's all about.

Issues Are Evident

NEW YORK (AP) — An economic miracle is likely to be needed if prices, jobs, interest rates and a whole string of related subjects aren't to be chief among the issues of President Gerald R. Ford's 1976 election campaign.

Since economic miracles have been forever sought but seldom found, some economists now concede that the campaign issues are being written at the moment, and that the writing is looking even grimmer than before.

Consultants and other seers now are revising their outlook to include a continuation of 1975. Poor growing conditions are expected to force food prices higher. The jobless rate is headed to six per cent.

Unpleasant as they are, these easily understood indicators of performance are mere symptoms of underlying difficulties that some business analysts term

grave and that few consider less than worrisome. For one thing, business is finding it difficult to finance itself. Utilities, unable to sell stock, are paying inflationary interest rates for borrowed money. Other companies are seeking federal help. Wall Street has fallen into a coma, and has little to offer either small or large businesses. Relatively few companies now attempt to sell new stock issues, especially the small, emerging businesses. Incorporations are way off.

Housing is very hard hit. The thrift institutions, which support housing, can offer only half the interest rate available at some other institutions. And so they have little money to lend on mortgages.

This has the predictable impact of reducing the demand for housing and putting some builders into a bind that is almost diabolical.

It goes like this: The thrifts offer only 5.25 per cent on passbook savings. With higher rates available from others, including Uncle Sam, people withdraw their funds. This is disincentivizing. The loan-making ability of the thrifts — savings and loan associations and savings banks — is thus impaired. The housing industry goes into a recession. While people might want houses they can't finance them.

Neither can the builder finance himself. The banks which lend to builders specify that the borrower maintain a minimum net worth in order to remain creditworthy. But the builder can't sell enough homes to maintain his net worth.

For Ford to untangle knots such as this quickly and under pressure of time would make the late great magician Henry Houdini's underwater escapades seem dull.

Better Check

Dear Dr. Thosteson: About 18 or 20 years ago my husband had a concussion of the brain, but that is all I know about it.

I have known him two years and been married for a year and he has been having blackout spells all this time, off and on. He also has a shaking of his face and head. This seems to happen when he is overtired and nervous and upset.

Please tell me if you think something is seriously wrong. Can this cause him to forget? Or turn against someone without meaning to?

He won't go to a doctor. That's why I'm writing to you. — Mrs. A.M.A.

You're really asking too much of me — but yes, I think it could be serious. Blackouts are not something to pass over lightly.

Whether the concussion had anything to do with it, I couldn't say, or whether his memory or attitude toward others will change — but conditions such as his are likely to worsen as time passes.

The time to do something about it is now. If your regular doctor isn't able to make a thorough examination, he can refer your husband to a neurologist. A certain amount of testing will be

necessary: X-ray, electroencephalogram ("brain wave" test), perhaps a brain scan.

The time to find out exactly what his condition is, and to start treating it, is now. Not after something catastrophic develops. The concussion 20 years ago may or may not be a factor in this. Some brain injuries may not manifest themselves for years after the accident.

Dear Dr. Thosteson: Please send your booklet, "You Can Stop Sinus Trouble." Enclosed is 25 cents and a long, stamped, self-addressed envelope. Also please comment on your children (1 to 4 years old) with constantly running noses but no other symptoms of a cold. — S.A.D.

A constantly running nose but with no other symptoms of a cold usually means that it isn't a cold. The two principal directions in which to look are these: first, allergy; second, some physical defect inside the nose.

Allergy, in varying degrees, is after all a very common problem, and a drippy nose is one way allergy can manifest itself. Identifying the allergy isn't so simple, and I would suggest having a series of tests by an allergist.

A physical defect inside the nose, deviated septum, adenoids, or some such condition, also can reverse the natural drainage direction, so the nose runs. Examination of the nose should indicate whether that possibility is worth exploring further.

Dear Dr. Thosteson: Is a laxative good for a two-month-old baby? She stays constipated nearly all of the time. She is on a canned milk formula. — Mrs. A.R.

I would not recommend a medicinal laxative for a child that young. Better to change the formula, particularly increasing the sugar or syrup content of it.

Fratricide

WASHINGTON — The menace posed to the Democratic party in the uproarious meeting of its Charter Commission in Kansas City last weekend was epitomized in the strange decision of Joe Crangle, state chairman of New York, to walk out on the heels of bolting black members.

CRANGLE, A PARTY professional from Buffalo, N.Y., is no radical and scarcely a reformer. But like so many other prominent leaders, he desperately fears offending the party's black minority. When party leaders like Crangle shy from confrontation, operatives of the AFL-CIO's Committee on Political Education (COPE) are isolated — labelled villainous reactionaries thwarting legitimate minority aspirations.

Labor has had just about enough of that, as witness this private ultimatum in Washington by COPE director Al Barkan to Gov. John J. Gilligan of Ohio: if you and the other party leaders will not fight to prevent recurrence of the disaster of 1972, organized labor will not man the barricades alone; instead, we will cut formal ties with the party.

THAT WOULD PROPEL the Democratic party lurching leftward precisely at the moment President Ford is wisely trying to position his party in the center. It would mean the dreaded midterm party convention in Kansas City in December would be less like the 1968 Chicago bloodbath than the 1972 Miami Beach festival of the left.

A repeat of Miami Beach is precisely what a small party faction on the left wants. Willie Brown, the black California state assemblyman who led the walkout in Kansas City, made clear that he LIKED Miami Beach (where his notorious

harangue was a hit on national television).

BEHIND THE walkout in Kansas City last weekend was an effort to retain at least a de facto quota system into the future. This intent had been obscured by skillful maneuvering for party unity by Democratic national chairman Robert Strauss, tirelessly working to avoid confrontation (much to Barkan's displeasure). But by the time of last week's meeting, COPE and other moderate elements of the party were insisting on removing from the proposed party charter implications of a quota system and European-style centralized party control — even if this means confrontation.

THERE HAS been wide misunderstanding about what was really involved at Kansas City. At no time was there any attempt to close party doors to women, blacks or other minorities or (as has been widely reported) to reinstitute the discredited unit rule for conventions.

What's more, the moderate caucus at Kansas City was not dictated to by Barkan's COPE operatives. In charge were three sensible and widely respected moderates: Rep. Thomas Foley of Washington, Rep. James O'Hara of Michigan and state chairman Don Fowler of South Carolina (helped by Strauss's key aides).

THERE IS NOT much question that Willie Brown, his political career sagging after losing out for the speakership of the California Assembly, fully intended to kick over the table. It is not surprising that eight of the nine other black members followed Brown, some reluctantly. Far more surprising, enough party leaders followed to break up the commission meeting.

"I have a great deal of sympathy with the predicament of women today," Mace explained. "Their problems are real. They have suffered, and still suffer, many injustices. 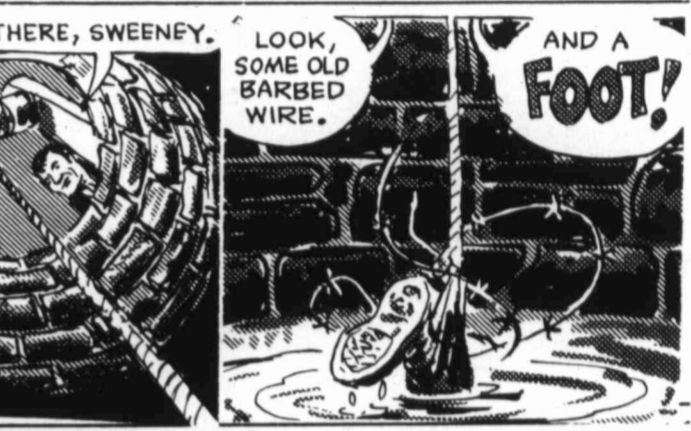
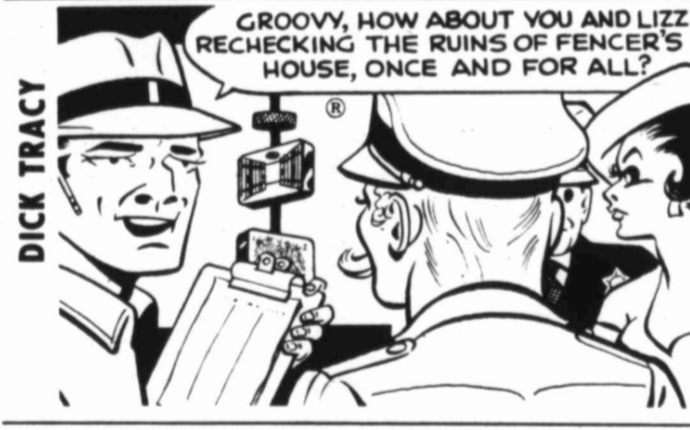
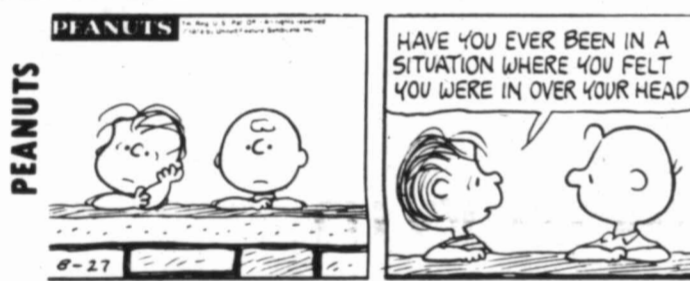

"The squeeze is something we do more on this club than a lot of other clubs because we're more sure of getting the run home," said winning pitcher Jerry Koosman, 13-8. "So many times, we'll hit into a double play or leave the runner stranded on third if we try any other thing."

"I just thought the squeeze play gave us a good chance, especially with a guy like Millan at the plate," Koosman added. "It's a funny thing. It's a play you never practice except in the spring—and then even then not much. But it's a tough play to defend against. "A lot of plays are habit. This is one of them. You get more practice executing the play than you get defending against it."

"What the pitcher has to do is try and be able, if he sees the batter turn around, to knock him down. Everybody knows the play is coming but you're never sure unless you see the hitter turn around. "What made it so beautiful is that Felix never turned around. He just dumped his bat in front of the ball. He got a perfect pitch to hit. I'm the biggest believer on this club in the squeeze—and not just because I won tonight."

Driesell Says Bid Kennedy's Misplay Too Low Ruins Cincinnati

COLLEGE PARK, Md. (AP) — Coach Lefty Driesell was well aware of the talents of Moses Malone when he won a monumental recruiting war and signed the 6-foot-11 basketball star for the University of Maryland. Now that the 17-year-old giant is being wooed by the Utah Stars of the American Basketball Association, Driesell figures Malone is being downgraded by the proffered contract. "He is worth more than they offered," Driesell said Monday, as he awaited Malone's decision on whether to sign with the Stars or begin classes Wednesday as a freshman at Maryland. "I have never told him not to sign, but to get what he was worth," said Driesell, who has seen a copy of the Utah contract which an ABA source claims was worth more than \$1 million.

According to Driesell, the total guaranteed contract calls for four years at \$100,000 a year, plus an additional \$90,000 in bonuses. "I didn't read beyond that," Driesell said, "because the rest was on a make-good basis." In addition to claiming Malone was worth more than the offer, Driesell said: "I believe he can get a much better contract in seven months, at the end of our season, or in the future. "I told Moses when I was recruiting him, that if it was me, I would consider at the end of each season what was best for me." Malone is already pre-registered at Maryland, and classes start Wednesday. He was on the campus Monday, but gave no indication of what he planned to do. He left the campus early in the afternoon with Maryland's star junior guard, John Lucas, and assistant coach Howard White. Early Monday morning, Malone and his mother talked at the family home with Bucky Buckwalter, director of player personnel for the Stars, and James Collier, primary owner of the ABA team. "This thing is like the tide. Sometimes it's in, sometimes it's out," Collier said. "I don't know if Moses will sign. I hope so." Under ABA rules, if the Stars don't sign Malone by Sept. 1, they won't be able to do so until his freshman year.

A back-pay windfall is in store for everyone who was in the active military, reserve forces, or the National Guard during late 1972.

The one-shot back pay due stems from a ruling by the U.S. Court of Appeals that former President Nixon illegally delayed the government pay raise scheduled by law for October, 1972. The active duty pay increase was 6.7 per cent.

The Second Supplemental Appropriations Act, signed June 8, 1974 provided the military services with funding authority for retroactive payments to military personnel, including those who have since separated or retired.

The Texas National Guard is now processing the payments for current and former guardsmen. Persons who were in the Guard or Army Reserves or on active duty during that period and remain in that status today will receive the money automatically within the next several weeks.

Others, who have moved from active duty to reserves or from one component to another, must request the payment. Reservists separated or retired from service since Oct. 1, 1972 are eligible for the back pay. They should write their last unit of assignment, including full name, Social Security number, rank, current mailing address, date separated and duty station during October-December 1972.

ODYSSEY OF FUGITIVES

'I Raped Her But I Didn't Intend To Hurt Her'

STEPHENVILLE, Tex. (AP) — Texas Rangers, FBI agents and local officers talked through the night with Dalton Williams and Jerry Ulmer, two of the three escaped convicts captured near Stephenville late Monday. The third, Richard Mangum, was shot to death.

This is the story the survivors told as related by Erath County Dist. Atty. Robert Glasgow:

CLIMB WALL Williams said the three had a hacksaw, drill and bits in their possession at the Colorado State Penitentiary at Canon City.

They cut the lock on a tool shed last Thursday and hid there until darkness.

Next they climbed over two inner walls and one outer wall and were free. Initially they intended to go to Mexico and thence overseas with Army buddies they hoped to meet along the Mexican border in Texas.

They stole a car—a Colorado deputy warden said this occurred within sight of the prison guard towers—and headed for Raton, N.M., on Interstate 25.

ROB GAS FIRM At Raton, they stole two rifles and a shotgun and stuck up a gasoline station, obtaining \$130.

They drove on and hid in a canyon all one day. The trio headed for Las Vegas, N.M., where they hoped to buy clothing. But they were choosy and didn't find

The survivors told how they moved through the countryside from one house to another, most of them evacuated by terrorized residents.

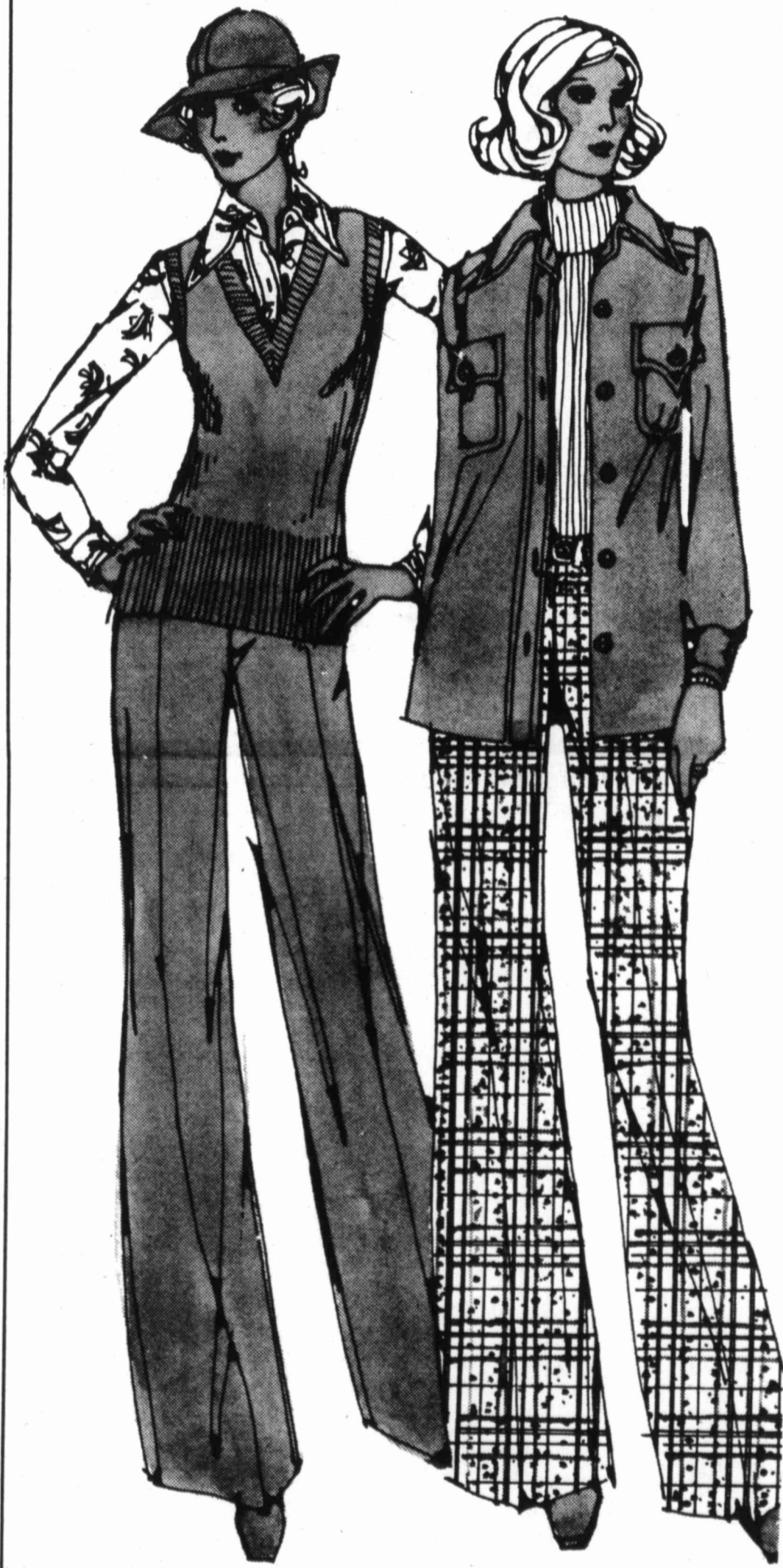
At one point, officers approached within 150
