

Rockets Face Tough Lefors Team Friday

One of the Rockets' top games of the season is slated for Friday night, October 12, when the Lefors Pirates come here for a conference tilt.

Neither team has lost a conference game, and indications to date are that the Pirates probably will be the Rockets' closest opponents for the district title.

The Pirates are a strong team, don't mistake that. They're big and experienced. Six or seven of the boys who started against the Rockets last year will be on the starting line-up again Friday, Coach Al Duncan declared.

Stracener, 180 pound fullback, and Hughes, 135 pound quarterback, are expected to spark the backfield performance of the Lefors team, while 207-pound Vanderlinden at tackle, will do his share in clearing the way for Pirate ball carriers.

Under Coach John Hosea, the Pirates have played two conference and one non-conference game this year. After defeating Shamrock 20 to 0 and Clarendon 6 to 0, they tied the Panhandle Panthers 6 to 6 on a foggy field Friday night.

A large crowd of Lefors fans are expected to make the trip here with the team.

The game will begin at 8:00 p. m., rather than 8:30 as have the other games played here.

Mill Iron Ranch To Hold Annual Registered Bull Sale Nov. 1

The Mill Iron Ranch will hold its third annual sale of registered Hereford bulls at the Cottonwood headquarters on Thursday, November 1, Lafayette M. Hughes announced this week.

In announcing the sale, Mr. Hughes said: "With but few exceptions all of our Mill Iron bull calves since 1937 have been sold to neighbors and friends within a radius of approximately 150 miles. These same neighbors and friends will have the first opportunity to buy this year's bull calf crop, which is the best we have yet produced."

Twice this fall individual cattlemen offered to buy the entire bull calf crop of 1945; but the offers were turned down because Mr. Hughes wanted to stay with his original plan of placing his bulls with commercial cattlemen adjoining the Mill Iron Ranches.

This crop has a 33 1-3 per cent cut, which cut is going through feed lots to packers for further proof that Mill Iron breeding is a key to high meat quality. Only the top of two thirds will be offered

for sale this year.

Phenomenal results have been obtained by commercial cattlemen who have been using these bulls as herd sires for the past eight years. Herds of mixed breed have been improved in a few short years to such an extent that it is difficult to tell them from a pure bred herd. One buyer, who had a herd of Jerseys, reported that the first cross resulted in a crop of white faced, heavy set calves that fed out remarkably well.

However, the majority of the bulls have gone to commercial cattlemen who used them to improve the quality of their Hereford herds. The results can be seen on scores of ranches in the Southeastern part of the Panhandle. The Mill Iron bulls have been used to produce herds of a high quality and remarkable uniformity.

Austin (Polly) O'Neil, manager of the Mill Iron, says that for weeks inquiries have been coming from commercial cattlemen and

owners of registered herds asking the Wellington office the date of the next sale. The majority of these come from cattlemen who have been using Mill Iron bulls.

Typical of these from owners of registered herds is a letter from Jack Casement of Westplains, Colorado. In part he says, "I have intended to drop you a line all summer to tell you what a fine calf the one we got from you in June is making, and ask if there is any chance of coming down and getting another one this fall. Our old Colorado Domino E. 1st never got over being stifted last summer. This leaves us using, for our herd bull, one that is not nearly up to the caliber of the cows he is with, which is, of course, slow suicide. And I certainly do not know where I could remedy the situation better than with the help of Mill Iron."

The sale will be held as usual at the Cottonwood headquarters located two miles south and 10 east of Wellington.

Alfalfa Men Certify 150,000 Pounds Of Seed

Approximately 150,000 pounds of alfalfa seed were certified from this year's crop, Morris Wells, president of the county Certified Alfalfa Seed Growers Association, announced after records of certification had been completed.

The amount was produced by 27 growers on approximately 900 acres of land.

This is the first year that an attempt has been made to certify the seed grown here.

It was pointed out that this means an additional 3 cents per pound on all seed certified, or a total of approximately \$4,500 for the growers in the association.

Marion Baumgardner, Future Farmer of the Wellington chapter, was chosen from more than 20,000 members of that organization in Texas to represent them at the National F.F.A. annual convention in Kansas City this week.

At this convention, Baumgardner will be awarded the American Farmer degree, the highest award offered by the Future Farmers of America.

The son of Mr. and Mrs. Joe Baumgardner who live south of Wellington, he was active in Future Farmer work during the time he was in high school and he has continued this activity since his graduation.

He has had an outstanding project program since he enrolled in vocational agriculture in 1939. Walker Todd, vocational agriculture instructor here declared.

Baumgardner was awarded the Lone Star Farmer degree in 1943 and served as state parliamentarian.

L. C. Jones Dies Early Wednesday

L. C. "Casey" Jones, 56, died at a Shamrock hospital at 4:00 a. m. Wednesday morning, October 10, after a critical illness of three days.

For many years a Wellington resident, few men in the county were more widely known than he. His death was due to a ruptured main artery, caused by an injury which he received two years ago September 15. He had been in ill health since that time.

Funeral services will be held from the Methodist Church in Wellington, although arrangements were not complete when The Leader went to press. Burial will be here.

He was born December 18, 1888. For a number of years he was in the car business here, and throughout the time of his residence here he was a consistent booster of this area. He left here several years ago.

Mr. Jones is survived by his widow; one daughter, Mrs. Mannon Nix, and one granddaughter, June Ann Nix, all of Shamrock. He is a brother-in-law of Mrs. L. J. Campbell and an uncle of Mrs. Tom Salem of Wellington.

Brother Of Clyde Drake Dies In Jap Prison In 1943

Clyde Drake learned last week that his brother, Pfc. J. P. Drake, a member of the "Lost Battalion" which was captured by the Japanese in Java, died in a prison camp in 1943. This information was sent his parents, Mr. and Mrs. Chas. Drake, of Memphis, by the War Department.

Mr. Drake is county treasurer of Hall County.

With Pfc. Drake from the time he entered service was Pfc. Rayford Harris of Memphis, who was liberated September 4 from a prison camp in Thailand. Pfc. Harris is a brother of Miss Molly Harris, who was a music teacher and an active worker in the Baptist Church here a number of years ago.

Judge Riggs Is New Kiwanis Lt. Governor

Judge Howard Riggs, a member of the board of directors of the Wellington Kiwanis Club, was named Kiwanis lieutenant governor for District 6 at the state convention in Galveston Tuesday morning, October 9.

Attending the convention along with Judge Riggs are Horace Clark, president of the city club, Myrett Henry and Cameron Beam, directors. The convention convened Sunday morning and continued through Tuesday.

In taking over as lieutenant governor of Kiwanis International, Judge Riggs will serve a territory including the entire Panhandle of Texas and the western Oklahoma counties. Among the duties of his office, he will visit the various clubs at least once during the year.

Election to this office is regarded as a distinct honor, and this is the first time that a Wellington member has been named to the place.

LETTERS FROM MEN IN SERVICE

(The following letter was written by Cpl. W. S. Jones to his parents, Mr. and Mrs. W. D. Jones.)

Sunday afternoon
Sept. 16, 1945
Tripoli, Libya.

Dearest folks,

Just a few lines this afternoon to say hello from the office as I had to work today after spending a considerable time in Tunis. We had a very hard time getting out of Tunis. First, all planes were full of guys going to Manila and the Philippines, and the CBI. We finally got on a cargo plane and got back, but the plane had trouble getting here. It was having trouble with his landing gears, but we made it okay though.

I met a boy in Tunis, an MP who was born and raised around Cooper and Sulphur Springs, and then moved to Memphis. His folks now live in Amarillo though. His name was White, a corporal.

I told you about seeing Tuffy Maddox in Rome, didn't I? I was sitting at a table at the Fifth Army dance one night and he was talking to someone at the next table and had his back to me. When he turned around and started walking off, I thought he looked familiar and then it came to me. I recognized him right off and stopped him and talked to him. He didn't remember me at first so I asked him where he was from just to make sure it was him. I think he has been over here about 34 months and is probably going home this week or next. He sure gives the boys a rough time when they start giving him any trouble. I saw him every night as he was an

MP on the main gate at the Fifth Army Rest Center, which is right next to the Air Forces Rest Center. They used to be Mussolini's Rest Center for his troops, and are really nice and beautiful. It has a big stadium, monuments, clubs, dance floors, and swimming pools.

I usually took a walk right after lunch every day, and one afternoon I visited the Vatican City, but they will not let you take a camera in there so I didn't get any pictures, but I bought some post cards with pictures of the places inside. One afternoon I visited the famous St. Peter's Cathedral, which is the most beautiful and wonderful church I have ever seen. It is really large; I think it holds 100,000 people. I saw the Pope's home and everything of interest there. Just as soon as I have the films developed, I will send the pictures I took to you. All in all I had a wonderful time. I enjoyed talking to you very much and sorry I didn't have any longer than I did.

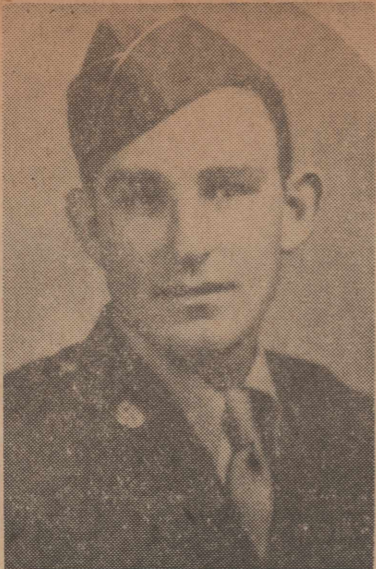

After the first two minutes of play the outcome of the game was never in doubt, as a well coached Rocket eleven swamped a hard playing group of boys of squal size who were obviously lacking in coaching or training.

The first touchdown happened quicker than you can read this. Wellington kicked to McLean and Myatt returned to his own 39. One lone thrust gained 2 yards. went on to roll up the score that Duncan was obviously trying to hold down. Highlights were Russell's run from the Tiger 6 yard line to the Rocket 40. It took grand blocking to get him started; but he used elusive footwork to gain the extra distance. Squyres made one touchdown that was called back. James Winters took a poor put from McLean on his 35 and ran it over for a touchdown. The last tally was when Robert Fulton intercepted a pass in the fog and carried it back for the last score.

In fact it is likely to be the decisive game; for the Clarendon Bronchos are the only other team that is undefeated in conference play and both the Rockets and the Pirates are believed to have an edge over the Bronchos. Lefors defeated a stout Shamrock team 20 to 0 and Shamrock turned around and beat Memphis by a score of 18 to 0. 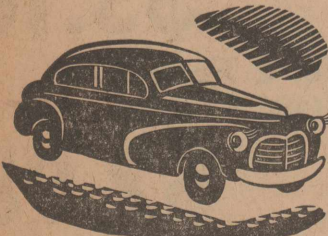

"With three men on the nozzle, Havron, Clark and Moore, in typical Navy courage they proceeded into the blazing area in an heroic endeavor to control the spreading fire.

"Making a wide sweep with the hose, they plunged through the smoke and took up a position of great advantage behind the burning buildings. Many times the men on the nozzles were lost from sight due to the dense clouds and heat. At times, it looked necessary to withdraw, but they held their positions. It was accomplished by having relief crews on the nozzle. With the bank building out of danger, the men swept out the fire from every angle which they could reach."

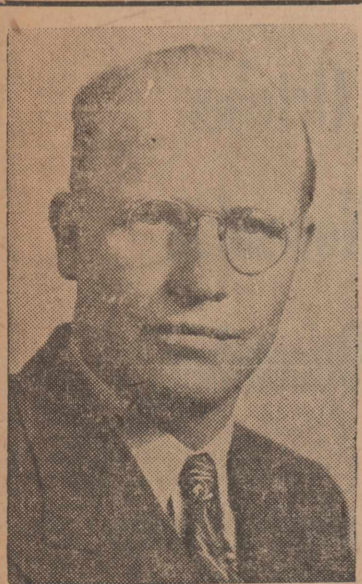

Ross Swift Home After Submarine Tender Duty

After a year of repair and maintenance work on submarines fighting the Japanese, Ross Swift, EM 1-c, reached Dodson September 19, for a 28 day leave with his wife and two small daughters, Jeanette and Zenith. Swift was assigned to a submarine tender, and was in charge of the main power repair on disabled craft at Pearl Harbor, Guam and Eniwetok.

Swift speaks with pride of some of the submarines on which he worked, the Burfish, which survived 61 depth charges; the Ronquil, which came back after 45 depth charges under 75 feet of water; and of another submarine, which set a record of picking up 52 flyers downed in the Pacific on one patrol.

Only once did Swift's ship contact an enemy submarine.

"That was the third night out of Pearl Harbor, on our way to Guam. The Barron was escorting us, and they went into action and received credit for sinking the Jap sub," he said.

Swift put in a good word for the work of the Seabees on Guam. "They've built the best harbor in the entire Pacific on the island,

and they blasted and dredged and built a breakwater so that the water is as smooth as your floor. They've put in a floating drydock that will take care of the biggest ships—the King George and the Missouri."

It was at Guam that Swift saw Don Smith, Wayne Branum and A. B. Cooper Jr., each of whom learned he was there and looked him up.

At the end of his leave, Swift is due for further sea duty, but before going out, he will take part in the Navy Day celebration at New Orleans, when a large number of submarines, destroyers, etc., will participate.

They must have a good memory and a quick functioning mind to make these changes. Some years ago a football team would have fifteen plays and the player stayed in one position.

Fire Prevention Week

Fire Prevention Week, October 7 to 13, should command greater interest this year than ever before. Never in history was so much property destroyed by fire in 365 days as during the past 12 months.

In our country, which has not been subjected to the ravages of war, there are 1,000 home fires every day. Once every 50 minutes someone is burned to death—a large percentage of them children left in homes which contain unnecessary fire hazards. Eight hundred million matches are used daily, each one capable of starting a fire in a home or factory. Two hundred and fifty billion cigarettes are smoked each year—each is a fire hazard which can ignite waste paper, bed clothes, material placed carelessly on shelves, clothing, and a thousand and one other articles.—Alfred Hinds in The Paducah Post.

Your County Agent Says...

By J. W. THOMAS

All farmers who have a home orchard should prepare to treat for the peach tree borer. This borer is the greatest enemy of peach and plum trees in this area.

One ounce of paradichlorobenzene should be placed around each 4 year old or older tree which is infested with borers, 1-2 ounce of P. D. B. is sufficient for younger trees. P. D. B. should be put out by the middle of October. Put P. D. B. out in a narrow band around the tree, 1 1-2 inches from the trunk and cover with 3 to 5 inches of dirt. This mound of dirt and P. D. B. should be pulled away from the trunk of the tree after five or six weeks. The soil temperature at this time of the year causes evaporation which forms gas that is 3 times as heavy as the air. This gas goes into the burrows of the tree and roots where the tree borer is, in the larva stage, has bored in to spend the winter. The life cycle of the borer includes the egg, larva, pupa and moth stage. The larva is the only destructive stage. The moth lays the egg on the trunk of the tree in the late summer. The egg hatches and the larva crawls down near the ground surface, a few inches above or below, and bores into the tree or roots. He works here all winter boring around in the cambium layer and vicinity, often girdling the tree, then in the spring the larva goes through the stage of pupation and emerges as a moth to lay eggs in the summer. By treating in the fall the larva is killed before much destruction is done to the tree, however, the same treatment can be applied in the spring when soil temperature is between 60 and 80 degrees F.

Some of our leading orchardists in the county have other methods of borer control which have proven very effective.

Wells Fights Through Entire Italy Campaign

Arthur Wells, who left school teaching in the Panhandle to fight in the foxholes of Italy, has come back into civilian life and is again preparing to take up his profession where he left off. He received his discharge Saturday, September 20, and during last week end he and Mrs. Wells were through Wellington en route to Lubbock to visit his parents, Mr. and Mrs. J. O. Wells. She has been teaching in Shamrock while he was overseas.

In service three years, he was overseas 22 months, fighting from Cassino up to the Brenner Pass. "And boy, it's a long way!" he declares.

The end of the war found Wells at Bargo. "When we fired our last round of shot, we knocked down our own observation plane. We were sure scared for a while, but both guys got out all right. There, we'd gone all the way up Italy, and that had to happen the last time we fired a shot," he recalls.

After Wells' unit crossed the Po River, going was much easier.

"The Germans didn't have anything to give resistance with," he declared. "The German prisoners we took blamed it on the fighter planes that we sent over at about house-top height, strafing the enemy. At one point we had orders to dig in for the night. Prisoners had said that just a little farther on were 350 mm artillery, pieces, tanks, and horse drawn artillery and that they would attack that night. We got ready. Then, just about dark, all 600 Germans walked into our camp to surrender."

Something of the slight resistance they met late in the war was illustrated by Mr. Wells when he pointed out that his outfit acted as a task force and in a drive which lasted 15 days, lost only three infantrymen.

LETTERS FROM MEN IN SERVICE

(This is a letter Mr. and Mrs. J. W. Russell received recently from their son, Cpl. John W. Russell.)

Sept. 20, 1945
Oahu, T. H.

Dearest Mother and Dad,
Now that the censorship of our mail has ended, I will be able to tell you more about myself and some of the things I have done in the past 18 months. I landed here Sept. 1944, and was sent to a Replacement Depot at Schofield Barracks about 30 miles from Honolulu. I stayed there for two weeks doing various odd jobs. Then came the break of my life . . . I was interviewed and sent to Fort Hase to attend a stenographic school. As you know the course took 18 weeks, and I can truthfully say that those 18 weeks were the best I have put in since being in the Army. After completing the required course I was sent to Fort Shafter to this Headquarters where I have been ever since. This being the highest headquarters in this theater helps make my work very interesting and gives me a very good lead on knowing just about what was going to happen next. All in all, I can say that the Army hasn't been very bad from my point of view. Of course, I have had a break that a lot of boys haven't enjoyed.

Boy! Did I have a pleasant surprise the other day. I was sitting at my desk transcribing a few shorthand notes that had been dictated to me by one of my officers when the telephone rang and someone asked for me. As soon as I answered the telephone I knew the voice but couldn't think who it was for a few minutes; then I let out a yell . . . It was none other than Richard Jack Gilbreth. Being in such a swell office, I was able to take the rest of the day off without loss of pay (How about that?) I rushed down to the USO club in Honolulu and there stood old Richard . . . boy, were we glad to see each other! After a few slaps on the back we decided to go out to his ship and get him an overnight pass. As Richard had already informed his officer that he had an uncle on the island, it wasn't difficult for him to get an overnight liberty. We had plenty to talk about that night. We wished for dear old Quail and Wellington and

the good times we spent there. Believe me, Mother, I was so happy to see Richard; it made me feel like I was at home. We didn't sleep much that night because there was so much for us to talk about. Richard really did look good; he seemed to be a lot heavier than the last time I saw him.

I guess everyone there at home is anxious to see their boys coming home. I know that all the boys are really anxious to get home just as soon as they can. That is about all you hear around here . . . "When are you going home?" "Home—oh! boy! does that sound good to me." "There is no place like home." Yes, you realize that more than ever before when you are away in the Army and not a chance to go home. Things have happened so fast the

past few months that it seems incredible that I may be coming home within a very short time. Anyway, it is a pleasant thought to all of us fellows who have been over here for such a long time. Now that the war is over, it is only natural to think of home and the ones you have been away from so long. The period we are going through now is called "sweating it out." Boy, that is the roughest part of all; but knowing that we have achieved our goal makes up for all of our sacrifices. Now we can come home to our loved ones and live in a world that is decent. Let us hope and pray that my boy and other boys in the future generations won't have to do the same in years to come. Yes, Mother, I am very anxious to get home to

see my darling boy and wife; it seems I have lived a lifetime since I last saw you, Dad, Pat, and Johnny seventeen months ago. It will be the happiest time of my life to see all my folks and friends in and around Wellington and Quail. So keep old Quail on the map . . . I don't want to miss it.

Give all my regards to all the people around home. Take good care of yourself and Dad, and remember I love you.

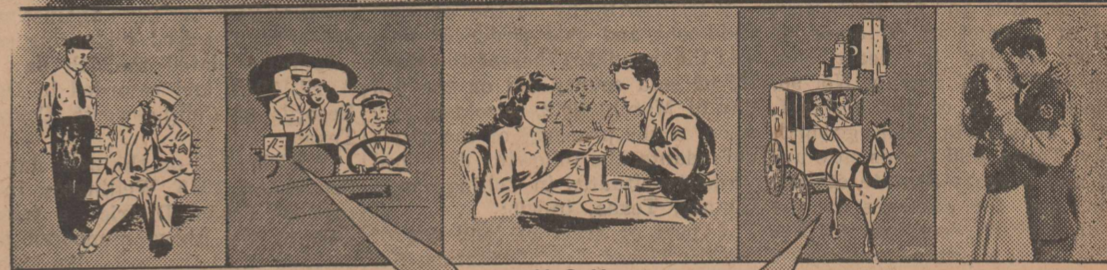

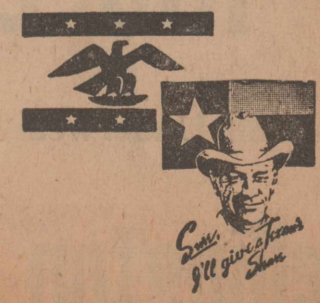

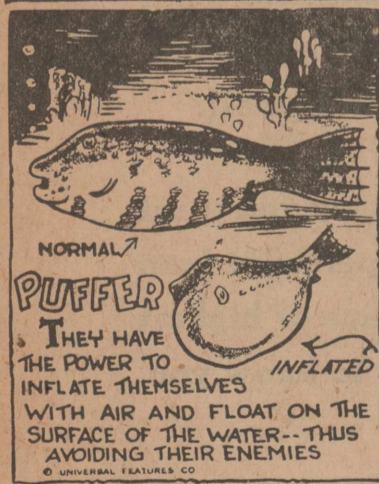

Newsom Awarded Bronze Star Posthumously

The Bronze Star Medal for heroic achievement has been awarded posthumously to Pvt. Carl W. Newsom, who was killed in action in the Philippines December 7, 1944. The presentation will be made to Mrs. Newsom, who with their daughter, Carla Jean, now live at Lubbock.

The citation given with the medal reads: "For heroic achievement in connection with military operations against the enemy on 7 December 1944 during the Operation. As the platoon of which Private Newsom was a rifleman was assaulting a heavily fortified enemy position, it encountered flanking enemy machine gun fire. Realizing the necessity for protection on the flank receiving enemy fire, Private Newsom with utter disregard for his own safety, moved twenty-five yards into an exposed position and placed effective fire on the enemy position. During this action, Private Newsom was fatally wounded. His courage inspired all the men in his platoon and materially aided the assault troops in completing their mission."

Pvt. Newsom was employed by the Curtis Candy Company during the time he lived here. He entered service in June 1944 and went overseas three months later. His unit had received the Presidential Citation and he was awarded the Infantryman's Badge of Honor. An active church worker, he was Sunday School superintendent of the Nazarene Church when he enlisted.

89-Year-Old City -

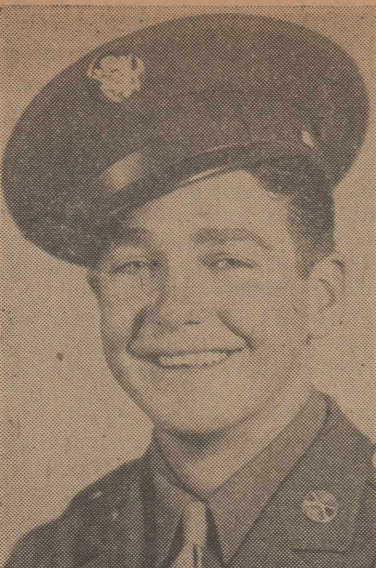

Noles Writes From Tokyo

This letter was written by Lt. John Roy Noles, a former prisoner of the Japanese, to his parents, Mr. and Mrs. E. L. Winn of Stephenville, shortly after his liberation. He was in the same camp as Lt. Col. John Coleman of Wellington.

Tokyo, September 11, 1945. Dear Mother and Dad: Open up the gates for that son of yours is on his way and in good shape. Hope all of you are well. I arrived in Yokohama yesterday morning. Am now on ship that is taking us to Manila where we are expected to stay about one week. Then we head for San Francisco. From all reports we leave here tomorrow.

On the 22nd of August we were told that the war was over, which was the beginning of many happy hours. On September 2nd we raised the flag. The same day B-29's dropped food. All of us ate for the next twelve hours (a few rest periods included). This was the first American food we had tasted since June, very little then. We smoked so much nearly all of us have blisters on our tongues.

On the 8th of September we saw

our first American soldiers. The next day we left that flea infested and stinking hole called a camp. Yesterday morning about 8:00 a. m. we arrived here. There was a band playing and several nurses were there. Also, the general in command of the 8th Army. All this was hard to take.

I hope that all of you are well. Would like to hear about everyone. Please write and tell in brief form about all. I imagine you may write to Manila when you receive this and I will get your letter there. Tell everyone hello and send my love.
