EPIDEMICS FEARED AS STORM AFTERMATH GOVERNMENT CHARGED IN LEASE JURY TAMPERING

BURNS CLAIMS SINCLAIR MEN ARE INNOCENT

ACCUSATION IS FILED WITH AFFIDAVITS IN COUNTER ATTACK

WASHINGTON, Nov. 7.—A charge of jury tampering in the Fall-Sinclair oil case was lodged against the government itself today by William J. Burns.

As a result H. R. Lamb, assistant attorney general, was called before the grand jury which earlier in the day had heard Burns and the activities of Sinclair men who, he said, had been employed by a Sinclair official to watch, but not to approach directly, the jury.

Burns' accusation against the prosecution, accompanied by affidavits, was filed with Justice Sides, the trial judge. The affidavits made by Burns detectives said that five days after the trial started, one of the jurors, Norman Glascock, was in conversation with a man who had been driving a car registered in Lamb's name. The same man, one affidavit said, previously had traded Glascock's car about Washington.

Charges Disclaimed Even before Lamb went into the grand jury room, District Attorney Gordon had made a disclaimer of the new charge. He said Lamb was in no sense an investigator for the prosecution in the oil trial, but was engaged in the prosecution of anti-trust cases.

Burns told government attorneys that it was Henry Mason Day, one of Harry F. Sinclair's confidential agents, who retained the services of Burns' men to trail the jurors. The son of the detective chief, W. Sherman Burns, the present active head of the Burns' Agency, also appeared before the grand jury and later disclosed some of the details of the shadowing agreement.

The younger Burns said his agency had been employed to shadow the jury on the day it became evident that the jurors would not be locked up. This was on October 13.

Employed by Defense "Inasmuch as the jury was not locked up we were employed to place it under surveillance for their defense," he said.

"Nothing that was done in this case by our men was at all improper. We are a detective agency."

SEATTLE, Nov. 7.—Has the state a right to tear a family apart because a father and mother put religion over the flag? "Yes," says the state of Washington, which has done just that.

"No," say Mr. and Mrs. J. W. Tremain of Seattle, whose son, Russell, has been forcibly taken away from them by the courts because they would not allow him to go through the rigmarole of "saluting" the flag in a public school.

For two years the Tremain family has been held apart—the son refused the flag, the parents refused to raise their boy—merely because the had objected to repeating a "flag oath" that Ed Howe says was "invented by a busybody old maid in Kansas."

When Russell, then ten years old, refused to say the "oath," his parents backed him up. He was not allowed to attend school unless he would agree to repeat the "oath." So he stayed out.

Then a truant officer arrested his parents for keeping him out. They were found guilty and fined \$25. His father refused to pay and spent eight days in jail.

Not content with that, the court forcibly took Russell away from his parents and put him in a detention home. His parents had the choice of being fined or of having their child placed in a state institution, which placed God above the flag, or of losing control of their boy. They chose their religion.

Two years of efforts to compromise the case have failed. Today, the court is making it impossible for the parents to get back their son. It is allowing his adoption by another family, without his parents' consent, on the theory that he is a ward of the court.

Congress' Probe Of Lobby Charge Seen At Capital

WASHINGTON, Nov. 7.—Congressional investigation of charges that a lobby has been set up here for repeal of the federal inheritance tax was predicted today during the House Ways and Means hearings on tax reduction. The prediction was made during cross examination of Governor Fred W. Green of Michigan, who urged repeal of that levy as well as the sale tax on automobiles. After the governor had testified he had paid his own expenses to Washington, Representative Rainey, Democrat of Illinois, declared he was glad to hear that, because there would be an investigation into the subject during the winter.

Green On Stand Governor Green, who followed Thomas P. Henry, president of the American Automobile Association to the witness stand to urge repeal of the automobile sales tax, declared that he was willing to advocate retirement by the federal government from the field of inheritance taxes.

After the governor had said Michigan was dissatisfied with the inheritance levy, he was asked "Who is financing this lobby in Washington," and he replied that he "knew nothing about it."

"I know," said Rainey. The Illinois representative said he proposed to ask every witness a similar question. He declared some governors who would appear on the question would not pay their own expenses.

Garner Queries Witness Representative Garner of Texas, ranking Democrat on the committee, asked the governor if he did not think the federal estate tax kept states from bidding against each other for wealthy citizens, but the governor did not think that was a sound argument in favor of the federal tax. Rainey interrupted to say that there were more than 1,000 millionaires in Florida.

Wehrle, of Kansas City, conferred with officials of Travel Air, Inc. for the purchase of 18 monoplane for maintenance of the route.

Although Major Wehrle would not divulge the names of the men involved with him in the new enterprise, he said a number of men in Arizona, Texas and California were interested.

Pecos, Abilene and Dallas, Texas, will be among the cities served by the transport.

Efforts To Master Tough Steak Fatal LOS ANGELES, Nov. 7.—A struggle with a tough piece of steak last night resulted in the death of Carl Neran, 32.

"This steak is plenty tough," Neran told his dinner companion, Jack Neagles, the latter reported to the police.

"Why don't you pick it up and eat it like a sandwich?" was Neagle's suggestion.

Neran acted on the suggestion and with the first bite choked. When he realized the case was serious, Neagles took Neran to a nearby drugstore where an ambulance was called. Neran died on the way to the receiving hospital where surgeons removed a large piece of steak from his throat.

Snow Squalls and Freezing Weather Add to Discomfort of Thousands of Homeless

(By The Associated Press) BOSTON, Nov. 7.—Snow squalls and freezing weather added today to the discomfort of the thousands in the New England flood area whose homes had been surrounded and cellars filled with water.

Furnaces were useless in such places. In many of the rural districts, stoves are used for house heating and it was impossible in such districts to get warmth from wood fires.

The dead in the flood area is known to exceed 150. Relief workers bent their efforts today toward the feeding and clothing of those driven from their homes and toward the prevention of the spread of disease.

6,000 Are Homeless While the waters in the northern states continued to subside, the situation to the south remained acute with 6,000 persons reported routed from their dwellings in Springfield, Mass., where the full effects of the Connecticut river at flood stage were being experienced. The river's rise today was most serious at Hartford.

The work of relief went on unceasingly while from Vermont, scene of the most severe loss of life, came fresh reports of victims that threatened to boost the death list considerably.

On the face of incomplete information of the disaster which overtook residents of the Winoski valley where 36 persons are known to have perished it was feared that a complete check of the debris littered by nature would reveal further deaths.

More Deaths Reported Reports from the remote Lamerle river valley, the first to come from there, told of seven deaths and it was believed in Burlington that there would be many more.

Bolton led all Vermont places with 32 fatalities in the town and vicinity. Waterbury had 21, while Barre was next with seven known dead and a reported possibility that the figure might reach 20.

Duxbury and North Duxbury were said to have lost 12 persons each but reports from there are unauthenticated.

Reconstruction Starts Despite the magnitude of the blow, however, Vermont and its sister states were making valiant efforts to retrieve their losses without outside aid.

First Move Lost In Malt Sale Ban

MINNEAPOLIS, Nov. 7.—Bringing to naught the government's first attempt to stop sales of malt and other materials for home brewing, Federal Judge William A. Cant, today quashed a search warrant which was the basis of a raid of prohibition agents on the Cleo Supply company here October 8.

Judge Cant ordered the Northwest Prohibition department to return the \$15,000 stock to Leo E. Brill, proprietor of the company, subject to a libel proceeding in which the government seeks to attach the stock on the ground that it was being used illicitly by purchasers.

2. Fourth best.  
3. Any new bid made after first round.

city to take personal charge of the situation and the relief measures. Previous to this, the relief committee had been directed to Montpelier to co-operate with authorities there.

**Army Base Established**  
An army base has been established at Copcord, N. H., and from there supplies succeeded in reaching Montpelier with typhoid fever serum, medicine and yeast.

A flock of army and privately commissioned planes circled ceaselessly over both Vermont and New Hampshire and brought back the first definite pictures of what happened to many places.

The victims told of an unending panorama of inundated landscapes, barns, houses, automobiles and even an occasional freight car grotesquely picked up by the swirling water and set down in alien surroundings, of wrecked bridges and uprooted railroad tracks, of burst dams and desolate farms.

**Relief Agencies Active**  
Everywhere relief agencies, the Red Cross, army officers, the Salvation Army and others were working to succor those most sorely affected while medical authorities sounded warnings against drinking of unboiled water where there had been any possibility of pollution. In a number of places inoculation against typhus and other ravages was being used as a precautionary measure.

Railroad communication was being gradually restored. In Vermont little could be done but in New Hampshire and Massachusetts the various companies pressed with vigor their efforts to patch together the intricate net work of lines which the storm turned topky turvy.

As a result the milk situation in this city and in other cities un-effected by the flood was somewhat on the road to normal after a partially milkless Sunday. Even today, however, in the face of strenuous attempts by milk and railroad companies, the situation was far from satisfactory.

The other principals, however, fore saw little difficulty from the Hudkins camp in as much as the Nebraska is eager to have his crack at the title. The proposed bout arrangements also are to be passed upon by the other two members of the state athletic commission, but Strelinger said he believed they would concur in the plan as the affair had been left in his hands.  
 Would Use Same Tickets  
 Strelinger announced that those of last Thursday spectators who had purchased reserved seat tickets and retained the stubs would be given the same seats at the fight November 21. Some other plan, which the commissioners admitted none of the conferees were ingenious enough to invent, would be necessary to provide for the thousands who paid their \$2.20 each for general admission and received no rain checks or other means of identification when Dundee failed to appear.

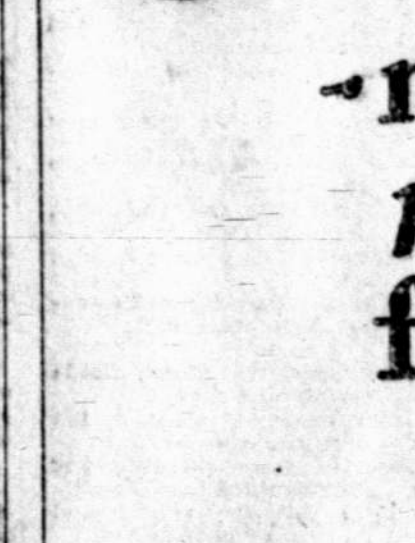

licensed and bonded to make investigations and have a perfect right to investigate a juror. "Our operatives were sent back whenever it was found that one of the jurors did not need shadowing. Our men did not shadow Robert C. Flagg, juror number 6, because we had not gotten to him on the list."

Government Charged

Asserting that his operatives had a perfect right to shadow members of the jury, Burns said their investigation had shown that the only approach made to a juror was made by a representative of the government itself.

"Of course my men had no right

to approach jurors," Burns said, "and if any of them did we will be glad to assist the government in their prosecution."

Burns then said Henry Mason Day, Sinclair oil official, who refused to disclose before the grand jury whether he had any connection between the Burns men and Harry F. Sinclair, had retained his agency in the case. Day now is at liberty on \$25,000 bond under a charge of conspiracy to influence the verdict of the jury, laid jointly against him and Sinclair.

Talks Freely of Case

Burns, who talked very freely with newspaper men after he left the grand jury room, asserted that the information one of his operatives had received that a government agent actually had approached one of the jurors "fully justified the defense" in engaging priv-

Francisco Mesa Perez were taken prisoners on a neighboring hill. "I expected it," said Gomez when captured.

Gomez Rides Silently

A bright moon was shining as the prisoners started their march to Teocelo. They arrived there about daylight. General Gomez, having regained his composure, rode silently on his horse. He was clad in corduroy breeches, a brown woolen shirt and his head was covered with a wide brimmed straw hat. The column went to the mill-

site detectives to shadow the jurors. Burns said that William Long, one of his operatives, trailed this government agent to the Potomac flying field, where the agent talked with a member of the jury for 20 minutes. He declined to name either the agent or the juror, but said the names of both were in information and affidavits which were filed Friday with Justice Siddons.

The detective declared the only other person who had been found "tampering with a juror" was a newspaper man who tried to get information from Edward J. Kidwell, juror number 11. His reference was to Donald T. King, a Washington reporter.

Claims Had No Right "A newspaper man has no right to ask this juror questions and should have been brought before the court," Burns declared. He added that none of his men had done anything in violation of the law; that the defense had just as much right to keep track of the jurors as the government.

Lamb Much Surprised Lamb later expressed the utmost surprise that his name had been mentioned in connection with the case and denied that he had at any time followed Glascock to the Potomac flying field, as charged in one of the affidavits.

"I have never been at the Potomac flying field," Lamb said. "I never heard of Mr. Glascock until I was brought down here."

Lamb said that on October 22, the date Long claims his automobile was at the Potomac flying field, his car was in the shop of George Aikens for repairs and he did not obtain it until that afternoon when he drove to a country club to play golf.

Had Small Roadster Lamb said it was true that he had a small roadster and used the license number P-1738. At times it has been under care of very competent mechanics, he said, and at other times his garage door had been left unlocked.

"The car may have been used at such times by some one other than myself, but I had no knowledge of it."

Aikens will be called before the jury later.

Lamb characterized attempts to connect him with approaching jurors as "pure lies," and said that he will consider consulting with counsel regarding filing suit against those connected with the making of the affidavits. He was greatly concerned with whatever embarrassment might be caused Attorney General Sargent, he said.

Late in the day the government sent before the grand jury Douglas Catchin, recently enlisted marine, and who was about to sail for Haiti when summoned. Catchin, who previously was employed here by the Burns agency, was reported to have boasted that if he could get out of the country immediately, he would be "fixed for life."

itary barracks where the court martial was held. Gomez refused a blanket offered him. He remained in his cell for the night. He remained cold nights passed by them as they roamed the mountains to evade the pursuing federal troops.

Gomez Makes Will

A notary was called and Gomez made his will. He left his bungalow and ranch in Sonora and some money to his mother and his wife and two children, who are now in Los Angeles. He then wrote a letter to his wife advising her of his wishes regarding their children.

Viscarra asked permission to witness his uncle's execution. He declared that Gomez had been almost a father to him and expressed satisfaction in dying at his side. The condemned prisoners were then taken to the Municipal cemetery where a firing squad awaited their arrival.

Gomez faced the firing squad calmly. The captain in command had been one of Gomez' subordinates when Gomez was a federal general. Gomez recognized him and gave him his wrist watch, the silk handkerchief he wore around his neck and a fifty peso gold piece.

Stands Firmly At Wall

Gomez stood firmly against the wall. The rifles of the firing squad were leveled at him. The volley sounded and the Calles government had executed the last penalty of those who rebelled against it. Viscarra was executed next and then Castanos. Gomez was exempted from the final coup de grace.

The other rebel leaders, Palacios and Mesa Perez were also executed. Late last night the bodies of former General Palacios and Colonel Fernando Martinez Pulido, who were executed soon after their capture with General Gomez, arrived at Mexico City.

General Palacios, who was said to have been executed on Saturday was court martialed in Jalapa together with Colonel Pulido, and both were executed at the city cemetery, their bodies being sent to Mexico City under the orders of General Escobar.

Face Death Bravely

Palacios and Pulido went bravely to death, declaring that their last thoughts were of their relatives. Standing before the execution squad, Pulido obtained a few pesos from Palacios with which he presented the soldiers, requesting them to aim their rifles carefully, straight at his heart.

Fifteen flying columns are now combing the mountains where Generals Almada, Horacio Lucero, Oscar Aguilar and Antonio Madina, the remaining rebel leaders in the Gomez-Serrano uprising are believed to be hiding. Their capture is expected momentarily.

In military circles it was stated today that the state of Vera Cruz has been completely pacified. The devil tree of Madagascar is said to drop poison spines on persons or animals who seek to take advantage of its apparently welcoming shade.

Molty Indicted In Slaying Of Women

NEW ORLEANS, Nov. 7 (AP)—Henry Molty, confessed slayer of his wife and sister-in-law, Mrs. Joe Molty, today was indicted by the grand jury on a charge of murder.

The bodies of the two women were found in trunks in the Molty home after their heads, arms and legs had been severed. Molty said he killed his wife because she had been unfaithful and his sister-in-law because she had contributed to his troubles.
