## Another ISD Joins Hereford In Suit

The Chapel Hill Independent School District is the most recent target of lawsuits over the Texas Voting Rights Act, bringing the total to six cases in the state consolidated under the heading "Hereford" Independent School District vs. Griffin Bell.

Five cases involving four school districts and the city of Beeville were consolidated last month by John R. Brown, chief judge of the Fifth Circuit Court of Appeals. The school districts in the consolidation now are Hereford, Trinity, Midland, Hawkins and Chapel Hill, while the other political entity involved is the city of Beeville.

Attorneys for both the consolidated entities and the United States

Department of Justice have been given until June 15 to file arguments and briefs with the U.S. District Court for the Northern District of Texas in Dallas. Both sides then have seven days to file a reply brief to the opposition's arguments.

No date for the hearing has been established, although it is expected to begin a few days after the three-judge panel which has been appointed to hear the case has reviewed the briefs and rebuttals.

Judges on the panel are U.S. District Judge Halbert O. Woodward of Lubbock, U.S. District Judge Patrick E. Higginbotham of Dallas and Circuit Judge Irving L. Goldberg of Dallas.

The panel, before it can decide whether the six entities are covered by the federal Voting Rights Act, must settle the

question of the necessity of three judges.

Woodward originally had heard the case of the Hereford Independent School District, which had filed suit against U.S. Attorney General Bell, and decided the HISD was not covered under the federal Voting Rights Act.

The HISD changed its voting system in 1974 from an at-large to place system with a majority runoff requirement. The attorney general's office in Washington D.C. said the change might be discriminatory against language-minority groups within the school district.

Texas was not regulated by the Voting Rights Act of 1965 until 1975 when an amendment made it mandatory for any change in voting methods or procedures adopted since 1972 to be reported to the

attorney general.

Woodward ruled that Hereford's ISD was not a political subdivision as defined by the VRA.

After Woodward ruled that Hereford was not subject to the pre-clearance provision of the act, a similar case involving city council elections at Beeville emerged, two circuit judges ruled a three-judge panel should be convened to decide whether one or three judges should hear the VRA coverage issue.

The U.S. Department of Justice filed a motion to modify the judgment in the case involving the HISD and Woodward decided to hold the judgment until Brown could appoint a three-judge court.

The panel may decide one judge is all that is needed to settle the issue.

The Department of Justice argues that

once a state is covered by the act, every political entity in the state is covered by the act.

The Voting Rights Act of 1965 (1975 in the case of Texas) defines a political subdivision as "any county or parish, except that where registration for voting is not conducted under the supervision of a county or parish, the term shall include any other subdivision of a state which conducts registration for voting."

School districts and cities in Texas do not register voters.

The HISD is the only entity which has filed suit against Bell. The other five are the subjects of lawsuits from the attorney general's office.

Alexander M. Peters, chief of the civil rights division of the U.S. Department of Justice, is among the attorneys

representing the federal government. Others are Carmen L. Jones, Michael Corey, David Hunter, Jeremy Schwarz and S. Michael Scadron.

Hunter, Schwartz and Scadron are attorneys for the civil rights division.

Attorneys for the consolidated body including Richard Green of Hereford will meet in a strategy session Friday in Austin.

State Attorney General John Hill whose office is acting as an amicus "friend of the court" may have representative at Friday's meeting.

Hill is expected to be present when the hearing convenes.

Any decision by the three-judge panel is appealable to the U.S. Supreme Court in Washington D.C.

### TWDB Renders Compromise Decision On Cloud Seeding

The Texas Water Development Board has rendered a compromise decision concerning applications for two firms to conduct weather modification activities over counties of the Texas Panhandle and South Plains region.

ATMOSPHERICS INC. OF Levelland and Plains Weather Improvement Co. of Plainview received approval of permits to operate, but only through Oct. 31 of this year, rather than for the four year period the companies had sought.

Both the firms conduct cloud seeding operations in neighboring Castro County, and the aircraft engaged in the operations sometimes make flights over Deaf Smith County.

The six man water board announced its ruling after a hearing attended by numerous area farmers.

Proponents of the weather modification activities claim that hail is reduced and rainfall is enhanced by cloud seeding.

HOWEVER, AN organization called Citizens for Natural Weather, which is made up primarily of dryland farmers and now claims a membership of some 4,000, says that the cloud seeding actually decreases rainfall and causes a "downwind effect" which prompts more severe hailfall in areas downwind of the target areas for seeding.

The group was formed last year and urged the TWDB not to renew cloud

seeding permits to the two firms, and contested permit applications through a series of hearings.

The CNW group wants a system of elections which would permit farmers in each county to determine whether cloud seeding would be permitted in their airspace.

Legislation providing for such a vote was passed in the recently concluded session of the Texas Legislature, and is awaiting the signature of Gov. Briscoe.

TWDB COUNSEL Bruce Bigelow is now in the process of drawing up a formal order to clarify the board's position on the proposed elections.

Farmers have been confused over whether the board was actually ordering the elections or suggesting them.

## 'Landing' May Have Been Hoax

LONDON (AP)—An apparently false Ugandan report that President Idi Amin had arrived in London for the Commonwealth conference heightened suspicions today that the burly black dictator's trip was a huge hoax.

Radio Uganda announced Amin's arrival in London and said he was demanding "to be carried shoulder-high by the British for several miles" as "part of the Field Marshal's celebrations of the British Queen's Silver Jubilee."

A Foreign Office spokesman said the government had no word of Amin's arrival. "If he had landed legally in this country, I would know," the spokesman added.

Radio Uganda reported Tuesday that Amin had left for London despite word from Prime Minister James Callaghan and other British leaders that he was not wanted at the Commonwealth meeting or the simultaneous celebrations of Queen Elizabeth's 25 years on the throne.

Later Tuesday, the Ugandan radio said Amin had stopped in an Arab country, which was assumed to be Libya. The broadcast said he would go on to France, West Germany or Ireland and would reach England Wednesday or Thursday by boat. But there has been no report of his leaving Libya or any other Arab country, and he has not been sighted in Europe.

The Nairobi Daily Nation, the leading newspaper in Kenya, Uganda's eastern neighbor, said a Ugandan army major told it the 6-foot-4, 250-pound president had been seen in the Kampala area after the government radio said he had left for London. The major was not identified.

There was growing speculation that all the official reports of Amin's trip were part of a hoax intended to twist the tail of the British lion. But British officials were taking a relaxed attitude that extended also to the announcement Wednesday that the Ugandan government had barred the 300 British residents of Uganda from leaving the country until Amin returned from London.

"I don't take these reports very seriously and I wish you would not," said Amin. (See AMIN, Page 2)

## Committee Set To Kill Rebate

WASHINGTON (AP)—The House Ways and Means Committee is ready to kill President Carter's proposed rebate on fuel-efficient cars, but Democratic leaders are trying to salvage his plan to tax big gas-gulping vehicles.

"The rebate doesn't have any support at all," Rep. Al Ullman, chairman of the influential committee, said Wednesday.

But in an apparent effort to delay a vote on the companion tax on cars that get poor gas mileage, Ullman postponed until today a formal vote on killing the rebate.

The committee finished its second day of work on Carter's energy-tax proposals Wednesday. One opponent, Rep. Joe Waggoner, D-La., said 20 of the 37 members of the panel were ready to vote against the so-called gas-guzzler tax.

Ullman predicted the tax will be

approved by the panel. But it will not go into effect at least until the 1979 model year, he said, and some committee members want to postpone it until 1980.

But Waggoner said he was advising against any delay. "The votes are there to kill it but it won't be killed if they approve the delay," he said.

Working on Carter's other energy tax proposals, the panel approved a tax credit of up to \$400 per person who improve the fuel efficiency of their homes and a credit of up to \$2,000 for purchasers of home heating and cooling systems powered by the sun or wind.

In both cases, the credits proposed by Carter were rejected in favor of versions offered by committee members.

The rebate and gas-guzzler tax are key elements of the far-reaching energy program Carter spelled out on April 20.

Another major provision—a standby gasoline tax of up to 50 cents a gallon—also is in deep trouble.

In an effort to reduce U.S. gasoline consumption 10 per cent by 1985, Carter asked Congress to impose a gradually increasing tax of up to \$2,500 on cars that get poor gasoline mileage and allow a rebate of up to \$500 for buyers of fuel-efficient models.

The tax and rebate would be based on the fuel-efficiency standards already in the law. These standards require each manufacturer to produce a fleet of passenger cars that averages 18 miles per gallon for 1978 models, 19 mpg in 1979 and 27.5 mpg by 1985.

Current law already sets a penalty on the manufacturer, which would be paid ultimately by the purchaser, of \$50 for

each mile per gallon the fleet falls below the standard. And the penalty would be paid for every car made by that company, not just the ones that did not meet the standard.

If, for example, a company fleet of two million cars averaged only 18 mpg in 1979, rather than the 19 mpg standard, that firm would be penalized \$100 million.

General Motors says it can meet the 1978 standard; Chrysler and Ford are not sure. Committee members who favor the gas-guzzler tax are trying to modify Carter's proposals in a way that will not reduce the competitive position of any of the three largest manufacturers.

The fourth U.S. automaker, American Motors, specializes in small cars and supports the tax.

## Carter Asks For Yearly Audit

Carter said, "We're suggesting they do it every year I'm in office."

Carter didn't make it clear whether the IRS conducted a full-scale audit each time it checked one of his returns. Nor did he reveal any IRS findings. But White House Deputy Press Secretary Rex Granum said Carter authorized him to say an annual, full-scale audit would be welcome as long as Carter is President.

In reply to queries about published reports that the IRS is auditing Carter's 1975 income tax return, White House spokesmen made what Press Secretary Jody Powell conceded were "mistakes and unwarranted assumptions" Wednesday afternoon as they stumbled through a confusing, 2 1/2-hour explanation.

The briefing was interrupted by an hour and a quarter recess so the

spokesmen could check their facts.

Granum said at first that the IRS began the audit because the President's accountant, Robert Perry of Americus, Ga., a town near the Carter's hometown of Plains, invited the agency on the President's behalf to "satisfy itself" of the accuracy of Carter's returns.

But Powell said after the recess that Perry, lawyer Harvey Hill of Atlanta, who has been Carter's attorney on occasion since 1968, and Robert Lipshutz, the President's White House counsel, cannot agree on whether they or the IRS brought up checking Carter's past returns.

"A statement that we brought them up first and brought it the audit on, I'm not prepared to make," Powell said.

Despite the confusion, this became clear:

The audit began early this year, is still

going on and the IRS has not told Carter why agents started it or what specific thing about his 1975 return caught their eye.

Carter is confident the audit will validate his return.

He "feels he has no problems," Granum said. Powell added that there has been no allegation of any impropriety of illegality.

"As soon as this audit is complete, we will make the results of it available to you and everybody else," Powell said.

"Carter does not think the audit is politically motivated."

"There is no feeling on our part that it is," Granum said. And Powell added: "There is no basis for us to claim or hint or imply that the thing was politically motivated."

## Summer Wound Turkey Ambassador

**KUHF (AP).** Two unidentified gunmen shot and seriously wounded Turkey's ambassador to the United States as he was entering the residence of Rome's post Parisi section police said.

Ambassador Lata Carter was taken to a hospital with wounds in the chest and neck officials said.

The Turkish Embassy said the two assailants rushed Mr. Carter after he stepped out of his car. Each fired one shot and escaped a spokesman said.

In the past few years Turkish diplomats in Vienna and Paris have been slain. It is believed the attack may have been an attempt to avenge the shooting of a Turkish diplomat in Vienna last year.

The assassin's names are not known.

## States Could Lose Medicaid Dollars

**WASHINGTON (AP).** Twenty states may lose millions of dollars in Medicaid payments because they did not properly certify nursing homes that serve Medicaid clients, HHS Secretary Joseph A. Califano Jr.

But he says the law that is forcing him to withhold the money should be changed.

The 20 states and others may be forced to pay back \$77 million they received in Medicaid money in 1975, the secretary of health, education and welfare said Wednesday.

HEW is obligated to reduce the amount of federal matching funds for Medicaid in states which fail to make an annual review of each nursing home that accepts Medicaid patients.

## Missionaries Tell Rosalynd D. Beating

**REDFE Beating (AP).** Two American missionaries who said they were beaten in a Brazilian jail told their story in Rosalynd Carter and the First Lady expressed her sympathy and promised to act for them about it.

Father Lawrence Buehmann, C. S. B., a Roman Catholic, and Thomas Caputo, M. S. M., a Missionary from the Society of the Sacred Heart, were arrested last month while distributing food to the poor.

They said they were stripped naked, thrown into a crowded cell and not allowed to contact the U.S. Consulate for three days, during which time they were beaten and shackled around to prison trustees. They said they were released on the fourth day after being allowed to call the consulate.

## Cuba's Castro Says Carter 'Idealistic'

**WASHINGTON (AP).** Jimmy Carter is idealistic and intelligent, Richard Nixon is naive and foolish. The Soviet Union is

the freest country in the world. China is a good ally of the United States.

Cuban President Fidel Castro, holder of these opinions, is discussing subjects he has mentioned publicly for years.

Despite his high opinion of Carter, Castro says differences between the United States and Cuba are so fundamental that he doubts the establishment of full diplomatic relations is likely during the remaining years of the President's current term.

While more optimistic about achievement of the goal if Carter is re-elected, Castro suggested that relations between the two countries have reached a plateau with the recent agreement on an exchange of diplomats at the anti-ambassadorial eve.

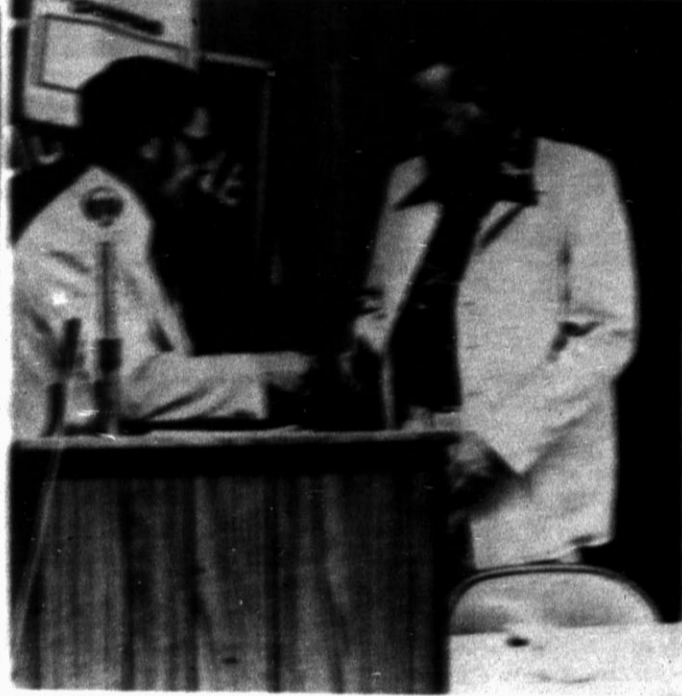

# Mennonites Reminiscent Of Western Frontier Days

**GRANDVILLE, Tex. (AP).** It is not a scene from a Hollywood western frontier picture.

The 100 working men and women in the fields trying to urge crops from the West Texas Plains to women wear jeans and wear no jewelry. The outdoors of their houses is a one room ranch house school.

"I would be a movie scene but it happened in 1977."

And these frontiersmen speak German.

These new pioneers are Mennonites looking for a homestead. A colony of 600 uprooted their families from Mexico for much political unrest and Canada on and headed for Texas. They have purchased more than 500 acres near the New Mexico border.

They are not looking for a new life. Father Bishop Henry Reimer says the colonists want to go back to their traditional life styles, including black wedding dresses and hard work.

This is why we come to Texas, the leader of the Old Colony Mennonite Church said. "To get back to the old ways and to keep the kids on the farm and keep their German."

The Mennonites are Protestants and use a German version of the Bible. The family is responsible for instilling religion in their children.

They began arriving in the Lone Star State last fall. Eventually they hope to bring thousands more settlers to the vast property.

In addition to the crops the men have started a dairy herd and plan to establish cheese factories, machine shops and a furniture factory.

They have received a warm welcome from area residents. Schriener Mayor Bob Clark said the Mennonites are not "wellfare

people.

"They take care of themselves, control their children and they are work oriented and, for that reason, I am glad they are here," Clark said.

Local bank president Lwayne Herman also thinks the new neighbors will be an advantage for the region.

"The only negative comment I've heard is that they might not spend as much money here because they are self-sustaining," Herman said.

The Mennonites say they will pay local taxes although they could claim a religious exemption for their church-owned land. They say they'll pay the taxes until they build their own school system.

Bishop Reimer hopes Texas will provide the right atmosphere for the children to "learn like we grew up."

"We have to work for our kids, what else do we have to work for?" In the Bible it says we should keep them in their mother's language," he said.

And they are doing just that. The lessons are taught in German. English is taught as a second language.

In the small schoolhouse the children ages six to 13 sit on wooden benches. The boys on one side and the girls on the other. The Bible is the only textbook.

The girls never cut their blonde hair. It's kept in braids. They wear quiet while the blue jean-clad boys leave at the end of the day. The boys always leave first, another age-old tradition.

Another Mennonite custom dictates that a woman wears a black dress on her wedding day. Helen Reimer, 25, the bishop's daughter, explains the simple reason for the simple garb.

"It is the way it is always done," she said.

Chihuahua, Mexico, is the current site of the world's largest Mennonite colony. But Reimer thinks 30,000 of the Mexican Mennonites may eventually come to West Texas.

The Canadian Mennonites also face a financial crunch. Reimer said farmland there costs up to \$3,000 an acre. The Texas Mennonites hope that many of their 20,000 brethren north of the border will make the trip south to join the colony.

### Old Cans, Big Business

It started out in Florida 11 years ago as an experiment in charity.

Collect old cans, turn them in, and Reynolds Aluminum Company would make a per-pound contribution to charity.

Then the company discovered that recycling those old cans was not only commendable conservation but good business.

Now you can sell an old can for 17 cents a pound. And you can make a collector of trash collected last amounting to \$1 million.

In Pleasant Hill, Ga., Walter Gornau launched his anti-litter campaign by collecting and selling aluminum cans.

Last year he harvested \$900.

The tin can man of Pleasant Hill is 84.

The recycling champion of the Chicago area is Mr. E. Williams

of West 154th Street. Last year he collected and turned in some 10,000 pounds of aluminum for an extra income of \$1,700.

For the Camp Fire Girls of Seattle the incentive was more than money. They collected enough old cans in one cleanup week to keep a 10-year-old boy alive. Young Chris Harrison needs weekly kidney treatment which he can afford now.

**COLLEGE STATION.** The Austwell Community of Refugio County in District 14 of the Texas Agricultural Extension Service has been named the state's top rural community in competition in the Texas Community Improvement Program.

The announcement came from Dr. James L. Mallett, state community resource development program leader, after a judging team visited the top four communities that were named finalists recently.

Placing second in statewide competition was the Wildorado Community in Oldham County (District 1), while Little River Academy in Bell County (District 8) placed third and the Sulphur Bluff Community in Hopkins County (District 5) finished fourth.

The state judging panel included Extension specialists Miss Glenda N. Moore, Charles K. Baker and Geronimo Chavez.

According to the judges, the four communities in the state finals offered close competition. "We were impressed with the total program that each has in operation. Each community showed total involvement of residents of the area—young and old as well. The cooperative spirit of the people working together is the key to success in the community improvement venture," said Mallett.

Cash awards are provided to

the top communities at the district, regional and state levels, and state finalists also receive handsome silver trays.

The community improvement program is designed to aid communities with a population of 1,000 people or less by assisting them in organizing leadership and utilizing community resources more effectively and efficiently, said Mallett.

The Texas Community Improvement Program is sponsored by the investor-owned electric utility companies of the state and is administered by the Texas Agricultural Extension Service.

# Another Bumper Crop Of Wheat Expected

WASHINGTON (AP) - Despite too much rain in some areas and not enough in others, farmers are headed for another bumper wheat crop.

The Agricultural Department said as of June 5 most of the winter wheat was headed out and combines were harvesting fields in much of the southern part of the country. But in the main breadbasket of the Great Plains, the harvest is lagging because of wet weather in some areas. About 13 per cent of the Texas wheat was combined as of June 5, and about 2 per cent in Oklahoma, both behind normal

progress, the department said Tuesday in a weekly weather report.

Winter wheat makes up about three-fourths of the U.S. wheat supply. Spring-planted varieties in the northern states provide the remainder.

A month ago, USDA forecast that the 1977 winter wheat harvest will be about 1.46 billion bushels. Although that estimate was down 6 per cent from the 1976 harvest, it was 3 per cent more than USDA indicated last December in its initial crop forecast.

The Agriculture Department has scheduled a new winter wheat estimate, based on surveys made on June 1.

Some private forecasters say the new estimate will be larger than last month's.

In its weather report, the department said last week's rain in many parts of the country helped corn and other crops. The West and parts of the South, however, continue to need moisture.

With nearly all of the corn planted, development is "far ahead of recent years" across much of the country, officials said.

"In the Corn Belt, the average plant height ranged from 8 to 16 inches," the report said.

"Most of the early corn was too tall to cultivate. Kentucky's early corn grew shoulder-high, and Wisconsin reached knee-high."

Normally, the average corn plant in the Midwest is five or six inches high by June 5, officials said.

With corn planting out of the way, soybean planting has made rapid progress. By June 5, 84 per cent of the acreage was planted, compared with 80 per cent a year ago, and the average progress on June 5 was 61 per cent.

## Continental Opens Office At Tulia

TULIA--Continental Grain Company today announced the leasing of a 13-million-bushel grain facility here.

Company officials said the installation will serve as a major assembly point for grain from the Texas Panhandle, northern Oklahoma, Kansas and eastern Colorado enroute to export markets via Texas Gulf and West Coast ports.

Continental Grain will operate a buying office at Tulia. The elevator is equipped to receive rail and truck shipments.



## Year's First Wheat

Deaf Smith County's first load of wheat for the 1977 crop year was delivered to Hereford Grain Corporation by Wayne Rainart Wednesday afternoon. According to Francis Backus of Hereford Grain, the first load had a test weight of 62 pounds per bushel and a moisture content of 11.8. It was harvested on dryland acreage five miles east of Hereford. Rainart took only enough time to pose next to his truck for a moment before heading back to the field to resume harvest. Harvesting of the county's dryland wheat should commence on a large scale soon, while irrigated wheat probably won't be harvested until later in the month.

# Acreage Reports Required On Crops

Important changes - acreage report on all crops required for 1977: The farm acreages of wheat, grain sorghum, corn, barley and cotton must be reported by August 1, 1977. This change has occurred due to the Senate and House Agriculture Committees reporting out of Committee farm bills which provide that if a set-aside is deemed necessary for 1978, the percentage of set-aside could be based on 1977 planted crops. Failure to file an acreage report could result in the farm having zero planted acreage credit and may be ineligible for program benefits in 1978. Acreage reports must be accurate and reported field by field.

Final planting dates: The final planting dates for corn, grain sorghum and cotton in Deaf Smith County are:

Corn	May 31, 1977
Cotton	May 31, 1977
Grain Sorghum	June 20, 1977

This does not mean you cannot plant after these dates, but it is the final date you would have to plant if a natural disaster keeps you from planting during the entire 30 day period prior to the final dates. If the above should occur, you have five days after the final date to file for prevented planting credit.

1977 ACP: Burning of crop residue: The State ASC Committee has determined that the deliberate burning of crop residue is a practice that defeats the purpose of the conservation program. Because of this determination, No Cost Share can be earned if you burn crop residue. A refund will be required.

Disaster provisions: Wheat, cotton, grain sorghum, corn and barley acreage that is destroyed or makes a low yield due to reasons beyond your control might be eligible for disaster payments. Any acreage that is destroyed and will not be

harvested for grain or lint, must be appraised prior to making other use of the land. An application for low yield must be filed within 15 days after harvest of the crop on the farm that is affected. Farm stored production may not be commingled with prior years production unless the old production is measured by this office prior to harvesting 1977 wheat. The prior years production will have to be counted as current year production if not verified prior to harvest.

Drought & flood conservation program: At the time we started sign-up on this program, we were told there would be adequate funds for all requests. At the present time, it looks like we will not have the funds that we first thought. We should know something within the near future, and will let you know at that time. Sorry for the untruth.

1977 beef referendum: The dates for the Beef Referendum are June 6 thru June 17 for registration, and July 5 thru July 15 for voting.

You will register in the County ASCS office in the county in which your cattle are located. If you own cattle in more than one county, you will register and vote in the county in which your farm or ranch headquarters is located. When registering to vote, you must certify that you are registering only once.

Any bona-fide cattleman, regardless of age or number of cattle owned, may register and vote. A bona-fide cattleman is one who has owned cattle during a representative period - Jan 1, 1976 thru Dec. 31, 1976.

Each business entity is entitled to one vote. A business entity may be a family, joint tenants, a partnership, owners of community property, or a corporation. Either the husband or wife may register and vote for a family business entity. However, any member of a group may register and vote separately, if he is an eligible producer separate from the group.

Any person may challenge the registration of any producer, if he believes that such producer has not owned cattle during the representative period, Jan. 1, 1976 through Dec. 31, 1976.

Any producer who is challenged must prove to the satisfaction of the county ASCS executive director that he is a bona-fide cattleman. Records such as tax returns, sales documents, purchase documents or other similar documents may be used as proof. But such proof will not be required unless a person is challenged.

You may register and/or vote absentee by requesting forms from the ASCS office in the county where your cattle are located. Such absentee request may be made in person, by telephone, or by mail.

The County ASCS office began accepting requests from absentee registration and voting beginning June 3. They will mail the appropriate form to you for registration or voting (or both, if requested). You may request both forms - for registration and for voting - at the same time, but they will be mailed to you separately and must be returned separately. You must return these in your own envelope and pay your own postage.

There can be no proxy voting for another member of a family or business.


Either a husband or wife can vote for their business entity providing they also do the registering. An exception to this would be if the husband registers, he could give the wife written permission to vote for the entity.

The ballots will be counted in the ASCS office by ASCS employees. Any interested person may witness the counting of the ballots.

The counting will be done on July 20 and the results announced as soon as practical.

# Referendum Registration Is Currently Underway

Deaf Smith County cattle producers can register to vote in the national Beef Referendum, now through June 17, at the Agricultural Stabilization and Conservation Service (ASCS) office in Hereford.

At stake is the Beef Research and Information Plan - a producer's self-help plan to strengthen beef markets here and abroad, increase research to solve beef industry problems and improve communications throughout the cattle business.

The Plan would be funded by a deduction of 30 cents per \$100 on all cattle sales. But any producer who does not want to participate can get a prompt refund.

"The Beef Research and Information Plan will benefit every producer right here in Deaf Smith County," according to Jim Conkright of Hereford. "I urge all local producers to

study up on the Plan and vote for it."

Producers will return to the ASCS office the first two weeks of July to actually cast their ballots.

Any legitimate cattle producer who has owned cattle during 1976 is eligible to register and vote, including FFA and 4-H youths who own their own cattle.

## Pecos, DeSoto Open Playoffs

AUSTIN (AP)—Pecos looked for its first victory today in four trips to the state school-boy baseball tournament, and Duncanville sought to keep its championship streak alive.

The tournament opener at 1 p.m. matched Pecos and no-hit specialist Linvel Mosby against newcomer DeSoto.

Waco Midway and Uvalde, also making their first appearances in the tournament, were scheduled in the second game.

In the 4A semi-finals Thursday night, defending champion Duncanville plays Victoria Stroman and Fort Worth Southwest plays Houston Sharpstown.

Duncanville won the title in 1975, as well as last year, after moving from 3A to 4A.

Pecos was eliminated in first-game losses in 1973, 1974 and 1976, and Sharpstown also lost in the semifinals last year.

The two 1977 championship games are scheduled for Friday night.

# Johnstone Waits On Pitch; Homers To Lift Phillies

PHILADELPHIA (AP) - Jay Johnstone got out his little calculator and figured that a baseball traveling at a speed of 90 miles-per-hour over a distance of 60 1/2 feet should get to the batter fast enough even for him.

"I've been jumping at the ball, over anxious," said Johnstone after ending an 0-13 slump with a fifth-inning two-run homer that gave the Philadelphia Phillies a 3-2 victory over the Houston Astros Wednesday night.

"I should know that a ball going 90 m.p.h. is going to get there," Johnstone said. "I have

to wait. I've been going out after pitches and as a result had nothing behind my swing."

His game-winning homer notwithstanding, Johnstone still isn't satisfied with his patience at the plate.

"My last time up I lunged and hit a lazy ground ball," Johnstone pointed out. "I've been making up my mind to swing at pitches and when they're not in the strike zone I've been hacking."

Johnstone also disclosed that he's been nursing an injury for

three weeks. He got hit in the left leg by a ball that came through the netting of the batting cage under the stands.

"I don't want this to sound like an excuse," Johnstone said before talking about the injury.

"But it was the left leg, the one I drive off of when I swing. I was hitting around .340 at the time. Ever since then I haven't been hitting the same, haven't had that good swing," Johnstone said.

"Yeah, it feels better now, but maybe that's because I got a hit

The biggest thing is to tell myself to wait on the ball," said the Phillies' outfielder.

And talking about slumps, how about Mark Lemongello, the Houston pitcher. The 21-year-old righthander lost his ninth against a single victory with that one pitch to Johnstone.

Lemongello worked six innings, gave up six hits, and was ahead 2-1 until Johnstone unloaded his second homer of the season.

"I threw one bad pitch the

whole night and it cost me another game," said the discouraged Lemongello. "It was a fastball right down the middle and he Johnstone killed it."

Lemongello felt that he wasted too much time trying to keep Garry Maddox close to first before pitching to Johnstone. He threw to first at least four times.

"I worried too much about Maddox...and not enough about Johnstone," Lemongello said.

Johnstone, incidentally, said

it was a fastball down and in. "The guys in the dugout told me, 'you can't believe what an easy swing you took at that ball.'"

Johnstone said Lemongello's toying with Maddox helped relax him in the batter's box.

"I never moved, just stayed in the box," Johnstone said. "I checked my feet, checked my hold on the bat. 'I made me relax. You do things like that when you're not hitting.'"

The Phillies jumped to a 1-0 lead in the second after Richie

Hedner had been cut down at the plate on a single by Ted Sizemore. Sizemore took second on the fine throw by Cesar Cedeno to Ed Herrmann. Larry Bowa then singled through the middle scoring Sizemore.

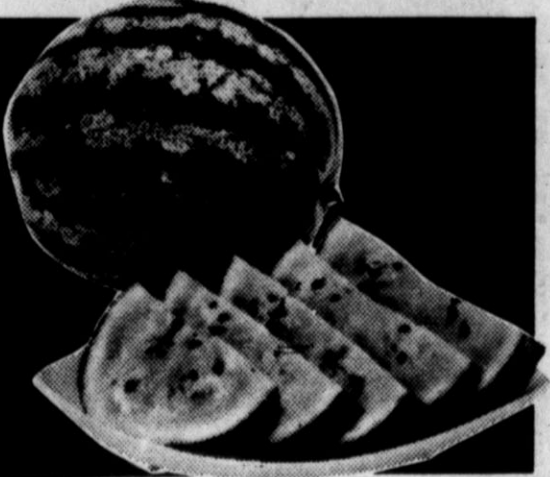

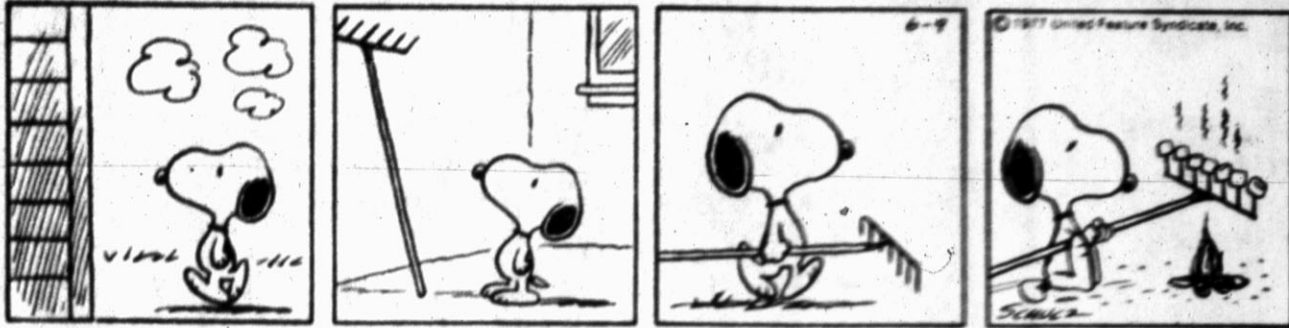

NEW YORK (AP)—The American Jewish Congress is pressing the U.S. Department of Defense to tell how many if any, Jews are among American military personnel assigned to Arab lands.

A letter from the Pentagon claims it doesn't know, but the Congress points out it would be easy to determine since most service personnel indicate their religious preference in their records, and only 1,214 are on duty in Arab countries.

Rabbi Arthur Hertzberg, the Congress president, initiated the inquiry with Defense Secretary Harold Brown to determine if a presidential executive order forbidding federal agencies from applying any religious restrictions was being complied with by the military in Arab lands.

In a follow-up letter, the Congress said it suspects no Jews are serving in any post in Arab countries, and the Defense Department should take steps to correct its practice so the world will understand the United States will not go along with "religious bigotry as a condition for stationing our troops abroad."

# Dutch Give Ultimatum To Molluccan Terrorists

ASSEN. The Netherlands (AP) - The Dutch government was sending word today to South Moluccan terrorists holding 55 hostages in a train and a schoolhouse in northern Holland to free their captives or face dangerous consequences.

A government spokesman said it was "out of the question" that the twin sieges, which began 17 days ago, will be allowed to continue much longer.

Officials are becoming increasingly worried about the condition of the hostages, especially the 51 persons held aboard the commuter train 12 miles north of Assen.

Cardiologist Jakob Nieveen said they may develop heart

problems due to the stress, the lack of exercise and the uncomfortable conditions. More than half of them are over 40.

Dr. Nieveen made the comment after examining Theo J. van Hattem, 46, who was freed from the train Wednesday after becoming ill. Doctors said he might have had a slight heart attack.

Premier Joop den Uyl and his cabinet were hoping mediators Josina Soumokil and Hassan Tan could convince the terrorists their position is hopeless, both "for their demands and for the political aims they have in view," a Justice Ministry spokesman said.

The mediators, elders in the 40,000-member South Moluc-

can community in The Netherlands, talked for nearly six hours with the gunmen aboard the train Saturday but failed to make any progress.

Eight to ten terrorists are believed to be on the train and four others are holding four teachers at the elementary school in nearby Bovensmilde.

Dutch officials have said they have several plans for an attack on the train should mediation fail. Some 1,200 troops and hundreds of police are surrounding the train, and about 100 Dutch marines are dug in about 100 yards away from it.

Troops and police also are around the schoolhouse. When the siege began 105 children were also taken hostage, but they were released after four days along with one teacher.

The two gangs, which struck simultaneously, are demanding passage out of the country for themselves and 21 other South Moluccans held in Dutch jails for previous terrorism and sabotage. The terror campaign is aimed at forcing the Dutch government to support the South Moluccan community's demand for independence from Indonesia for their native islands, which were part of the prewar Dutch East Indies.

# Alamo City Gay Leader Says No Need For Byrant Appearance

SAN ANTONIO, Tex. (AP) - A Baptist preacher says he's bringing Anita Bryant and her anti-gay campaign to San Antonio but the leader of that city's gay community says he doesn't know why.

The Rev. Joe West said Wednesday he will meet with Miss Bryant in Houston on June 16 when she performs for the state bar association. The preacher said he is planning a San Antonio rally including an appearance by Miss Bryant.

But gay spokesman Jim Eggeing said there is no reason for the Save Our Children campaign that successfully fought a Dade County, Fla. gay rights ordinance to come to the Alamo city.

Eggeing, a former school-teacher who said he was fired when he told administrators he was gay, said San Antonio has no such ordinance and the city council has refused to hold further discussions on such a law.

He said a spokesman for the city's gays addressed the city

council on June 2. That appearance attracted a "we hate gays, we hate perverts" audience, Eggeing said.

Despite that audience, he said gay life in San Antonio is not too bad. The city has several gay bars scattered through the town.

"Our major push now is to show the city council and the county commissioners that we have political clout. It may not be enough to swing a vote but we can eliminate people who are actively hostile towards gays," Eggeing said.

He added that a "significant sector of the electorate" is gay. But Eggeing said no one knows what percentage of the metropolitan area's one million residents are homosexual.

The city's gay community held a rally and raised \$2,000 for the Dade County gay movement. A counter-rally at the Alamo attracted people opposed to the Dade County gay rights ordinance.

The Rev. West said his rally

will not be specifically anti-gay. "It's more than a battle against homosexuality. It's a battle of morality vs. immorality," the preacher said.

Tuesday's Dade County defeat of the gay rights ordinance was a solid victory, he said, and may signal the beginning of the "greatest moral revival of our time." He said voters apparently saw through the gay's "fairy tales" about the ordinance.

"It's not a matter of civil rights at all. There's no comparison between gays and minorities. If I were a Mexican or a black or a Jew I'd be outraged at the comparison," he said.

Eggeing disagrees. He said it is a battle between civil libertarians and bigots. He saw

the Tuesday Florida election as something of a victory for the gays.

"The national averages say that one out of ten people are gay. The vote was two to one against the ordinance. That means it was reduced by a factor of five from the national averages," he said.

# Bell Doesn't Have To Pay In Suit

AUSTIN (AP) - A Matagorda County jury awarded John Thomas and his wife \$34,992 after a telephone truck tailed them on Interstate 45 in 1971, but the supreme court reversed that verdict today because the trial judge failed to ask the jury if Thomas contributed to the accident.

Thomas testified that moments before the crash his speedometer read 55 after his wife told him he was going too fast.

The highway was straight, level and dry, and the weather was clear.

The Southwestern Bell Telephone Co. driver, John Cliver Jr., testified he drove 65 miles an hour.

Both vehicles were in the right lane.

Cliver said he did not know how Thomas' car suddenly appeared in front of him.

"Possibly I'd been following a car and the car swerved out to pass around this vehicle, you know how you unconsciously follow a car. And I had been, maybe, following it and it veered out. Otherwise, I don't know," he said.

Cliver also said Thomas' car "was a very dirty color that blended in real well with the road."

The phone company lawyer said Thomas drove slower than a reasonable person would in those circumstances, and that contributed to the accident.

The lawyer asked the trial judge to submit a contributory negligence issue to the jury.

The civil appeals court that affirmed the trial court judgment ruled the contributory negligence issue requested by Bell was incorrectly worded.

But the supreme court said the wording was "substantially correct."

The old law on contributory negligence held that a plaintiff could recover nothing if a jury found he contributed to the accident, no matter how little. And the plaintiff's lawyer could not tell the jury that a yes answer to that issue meant the plaintiff got nothing.

Since then, the law has been changed to one of comparative negligence. The per cent of negligence of the plaintiff is

deducted from the per cent of negligence of the defendant.

But the new law is not retroactive. When the case is retried, it will be tried under the old contributory negligence rule, and if the jury answers that question yes, Thomas will not get \$34,992 or even \$1.

# Mexican Government Rejects Political Action By Priests

MEXICO CITY (AP) - A Communist party proposal that priests be allowed to participate freely in Mexican politics touched off a lively debate this week until the government flatly rejected the idea.

Government Secretary Jesus Reyes Heróles called the suggestion "risky, negative and against history."

He said Mexico's long tradition of church-state separation "has permitted peace, coexistence and social development. There is no reason to change a constitutional principle that cost the country so much in previous decades."

The idea was initiated by Arnoldo Martínez Verdugo, central committee secretary of the Mexican Communist party. He urged last week that the Federal Election Commission consider the electoral law reform to make full citizens of religious leaders.

The Constitution prohibits Catholic priests or the clergy of other religions from voting or associating with political activities. Mexico is a predominantly Catholic country.

Martínez Verdugo got the support of the official opposition party, National Action (PAN), but received a hostile reaction from the capitol city press.

"Excelsior," the prestigious Mexico City morning daily which often reflects the government position in its editorials, said Mexico's banning of priests from political action, first considered as sacrilege, was now "admired throughout the world."

"The worldly clerics who descend from the altar and mix

in political action don't support the state, honor the church or serve the people," the newspaper said.

The Mexican government is formed mostly of members of the Institutional Revolutionary Party (PRI), which has been in power for nearly half a century. Two other parties, including the PAN, are legally registered and others are tolerated but not allowed to participate in the elections.

Government secretary Reyes Heróles was asked by reporters why, in his opinion, the Communist party had spoken

out in favor of church political action.

He said he believed it was a case of "political opportunism" using the Spanish and Italian Communist parties as models.

"But the conditions in Italy and Spain are very much different from our country's," he said.

Mexico was dominated by church influence during its early history. The war of independence from Spain was touched off by a Catholic priest who rallied the masses.

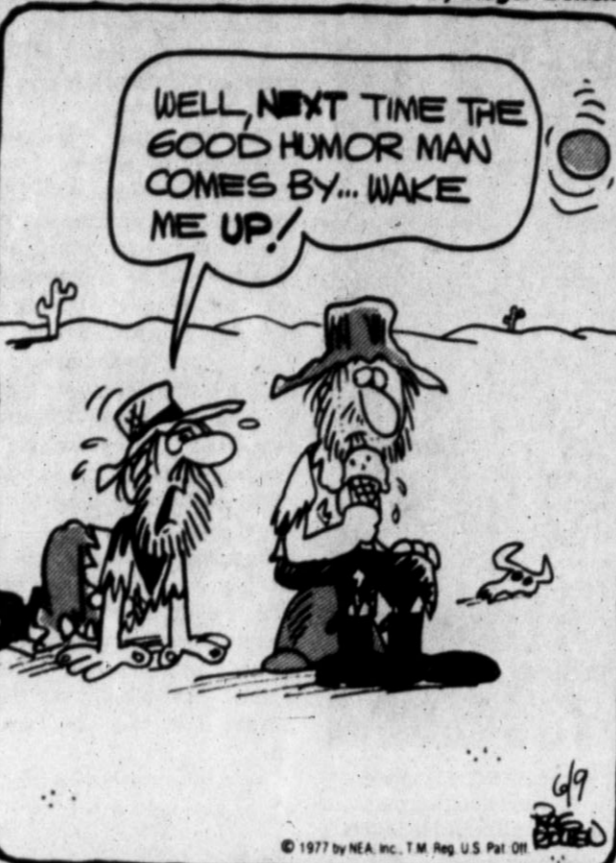


