Hiway Cops

'Joy Riders' Solons Shout

Suggest Thirty Be Put To Weighing Trucks; Judiciary Cut Proposed

AUSTIN (UP)—Texas motor patrolmen were declared "joy riders" and "birds of prey" by members of the house of representatives before adoption of a resolution calling on the highway department to put 30 of the 120 "at work" weighing trucks and testing brakes. Fifteen men are assigned to such work.

Purchase of little tricycles to carry the testing machinery was directed.

Harold Kayton, author, said he favors abolishing the patrol but as long as the state has it, they should be put to work.

Rep. Earle Morrison, Terrell, declared he never had seen a motor patrolman.

The death of Sen. Thomas J. Walsh was declared a "national tragedy" in a house resolution. Another called upon purchasers of crude oil to come to the rescue of the industry by raising prices, declaring that "ruthless low prices threaten its life." Five oil prohibition enforcement laws suggested by Commissioner E. O. Thompson were filed by members in both house and senate. Both received, also, a bill to create Texas Canyon state park in Brewster and Presidio counties by withdrawing certain state land there from sale.

A new proposal for prohibition ratification or repeal is made in another bill. It calls for election of delegates Nov. 6 and a convention Dec. 4, this year.

Rep. R. L. Anderson kept alive a bill to limit length of trains by getting it printed in face of an adverse committee report. The bill would limit freight to 70 cars and passenger trains to 11.

A pending bill to strengthen the law fixing gasoline standard was set for house action next Tuesday.

Twenty-six bills were introduced at the morning call in the senate, bringing its session total to 388, as the last day for introductions began. Bills can be introduced up to the time of adjournment today.

New Bills

Bills provided: Creation of a state board of housing for promotion of public health; describing powers and duties of the insurance commission; allow formation of independent cooperative organizations for transporting oil; create office of state electrical inspector; and a bill designed to stop state expense account padding. A proposed constitutional amendment would authorize the legislature to combine certain counties.

After the morning call, the senate turned again to consideration of its judiciary appropriations bill in which it seeks to reduce salaries of the judiciary.

Although the house committee already had cut the former appropriation for eleemosynary institutions 26 per cent, the house today ordered a further cut in the salary of the resident superintendent of the Austin asylum. This would reduce the pay to \$2100 year.

Griffin's Supporters Attack Maury Hughes For Criticizing Him

UVALDE (UP)—Criticism by Maury Hughes of Dallas, of the political standing of Gordon Griffin, young attorney of McAllen, who is candidate for congress at the Democratic run-off election March 15, has aroused his supporters who denounce the Democratic executive committee chairman for entrance in affairs of the 15th congressional district.

Hughes demanded that Griffin be "black-listed" as an unloyal Democrat.

He said his affiliation with the Good Government party of Hidalgo county, and his candidacy for county office as a Republican some years ago barred him from having support of the Democrats.

At a rally at Weslaco early this week delegates from four counties in the district which has been represented in congress by John N. Garner since 1898, denounced Hughes.

They questioned his authority for advising in matters relative to the district's election.

A resolution was passed and signed by many present denouncing Hughes.

Three prominent political leaders who addressed the meeting were Joe T. Canales, Brownsville attorney; Polk Hornaday, former representative from Cameron county, and Major J. B. Galbraith, of Brownsville.

Milton H. West, an attorney of Brownsville, was endorsed by Hughes for election as Garner's successor.

Among the prominent "exes" scattered over the world are:

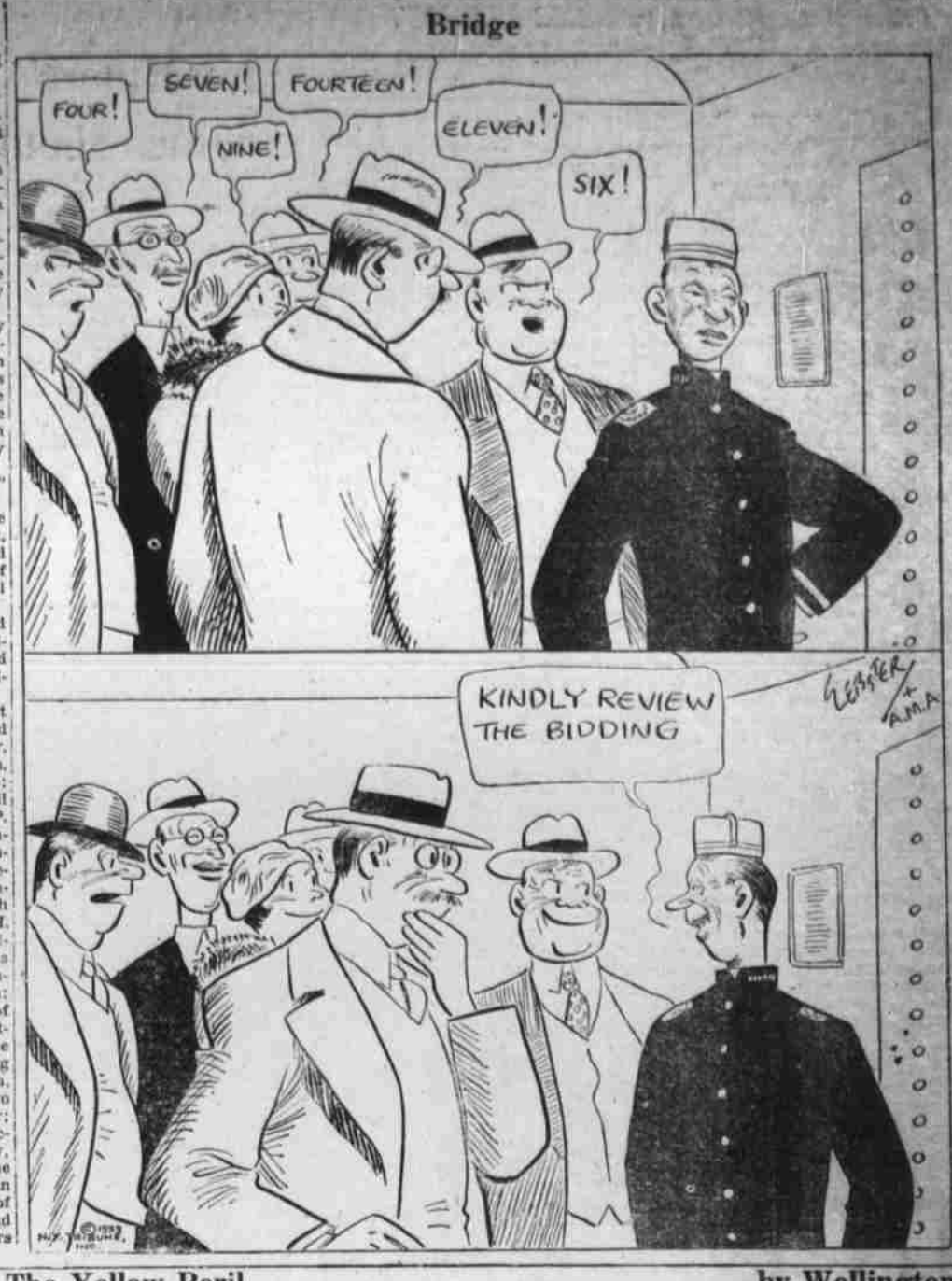

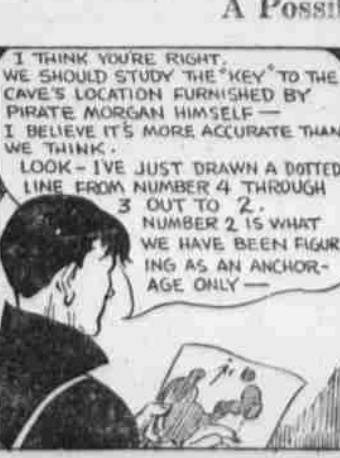

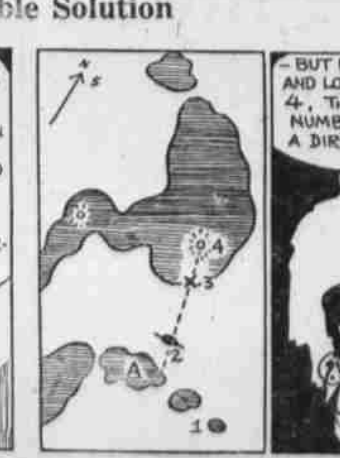

Easterwood Says Public Support Merited By Child Welfare Program

The following is the text of a speech made recently at the Area C Child Welfare Conference of the American Legion at the Baker Hotel, Mineral Wells, by Colonel W. E. Easterwood Jr., national vice commander of the Legion:

Throughout the ages men have fought wars, died of pestilence, of liberty, the most precious heritage of mankind. Desire of freedom from spiritual bondage brought our ancestors to Plymouth Rock; the same desire of freedom from civil bondage brought on the war of the revolution, and the desire to insure physical freedom to an enslaved people was mainly responsible for our own great and devastating civil war.

Eighteen years ago a great war's conflagration swept the entire world because men sought freedom of thought, freedom of commerce and freedom of militaristic domination by certain powers. We, ourselves, were irresistibly drawn into that conflict to preserve our national integrity. Out of the ashes of that great world cataclysm there arose the American Legion—strong, powerful and just, dedicated to service of God and country.

We have for 14 years served and served well—and we are justly proud of that service record. But, great as was the world war and all those other conflicts, there is today a war for freedom being waged by the American Legion and other organizations, more noble in purpose, more beautiful in concept, more beneficial to our people in lasting results, than all past conflicts combined. It is a war, my comrades, to set free from the bondage of illiteracy, to sever the

shackles of greed, to lift from the dungeons of despair, the lonely, neglected, underprivileged and unfortunate little children of our land. Remember what that Holy Man of Nazareth, Jesus the Christ, once said, "Suffer little children to come unto me, and forbid them not, for of such is the Kingdom of Heaven." The American Legion has remembered and has taken heed of that sacred admonition, and today stands forth unselfishly determined that man's inhumanity to man shall not further extend to those unfortunate little ones.

The American Legion first adopted its child welfare program in convention at New Orleans in 1932. During the intervening ten years, our workers in the field of child welfare, cooperating with other social agencies, have received a liberal education. Our great research department has brought forth many interesting and pertinent facts, and today, after ten years we feel, and not without some justification, that we have taken our proper place among the great organizations of the world who are devoting at least a part of their time and efforts to this great humanitarian work. Everything possible has been done by our national organization to assist the various departments in the building up of their Child Welfare program. No stone has been, or will be, left unturned to help carry through the program. The tools have been placed in your hands, the job is there to be done, and it is not only your privilege to take up this task, it is your solemn duty.

You may at times ask of your fellow man, and not without a reason, as Cain asked of Abel, "Am I my brother's keeper?" But no

Christian man or woman can square himself with his conscience, his fellow man or his God, should he apply those words of interrogation to the distressed little ones everywhere about us.

To interpret the American Legion to the public through its child welfare program is only to gauge the depths of love our people hold for the children of our land. As the Supreme Being notes even the sparrow's fall, so is noted by our people any act of individual or collective assistance rendered to, or on behalf of, our children. When a powerful and great organization such as the American Legion has seen fit to make as one of its outstanding activities, the care and protection of the nation's children, you may be assured that our people will fully understand. When they see, as they have seen, health clinics established, hospital beds provided, playgrounds built and supervised, homes found or provided, legislation sponsored and passed, educational facilities provided, and numerous other things undertaken and accomplished, rest assured that our people, themselves, will properly interpret the American Legion. The thing that matters is to do these things, do them now, energetically, enthusiastically, and unselfishly. And when you have done those things for the youth of our land, you will find that the American Legion has won everlasting approbation and has become eternally enmeshed in the heartstrings of the American people.

Nothing further is needed to demonstrate to the people of this country that the American Legion is an unspending, fearless and unselfish organization, truly serving for God and country. And nothing you may do will bring to our support the great mass of people so quickly as to have them recognize in the American Legion a real unselfish champion of the children of our land.

From the standpoint of national selfishness and national protection we must also realize that a nation must depend for its perpetuity, its defense and its glory upon the home and the child. The nation will be come whatever these make it. Advance in civilization, in character, in all that makes individual or national existence worth while depends upon the spiritual, mental and physical life of the nation's children. All these depend, in turn, upon the conditions under which the child comes to maturity; his environment, his educational advantages, his physical training, his spiritual opportunities. All are of the utmost importance to the child and society, for in their influence upon the citizen-to-be, these will make or mar the future of the nation. Truly, as President Wilson once said, "The nation marches forward today on the feet of little children."

In the future we hope nations are not to live by, nor prosper by, forcible annexation of other territories and peoples. The greatness of nations will be measured by the individual greatness of their people. And no nation will become truly great whose children in the main are deprived of the right to an education, to protection from child labor, and to be morally safeguarded. The underprivileged childhood and youth of America are calling to their protection today every unselfish, high thinking, brave-souled, patriotic man and woman in our country. The childhood and youth of our land are standing with outstretched hands and pleading voice, begging for protection. The American Legion has heard that cry. It has taken its stand. Thank God, it has answered the call of little children. I realize fully that it is unnecessary for me to bespeak the support of every department and every Leg-

Violation Of Proration Would Be Made Felony By Ernest Thompson

Railroad Commissioner Drafts Five New Production Control Measures For Legislature

AUSTIN, (UP)—Five new oil production control bills, one making it a penitentiary offense to overproduce, were prepared by Railroad Commissioner E. O. Thompson and were ready for the House of Representatives.

One bill makes it a felony, punishable by from one to five years in the penitentiary for any person, agent, employee or representative of an oil company to knowingly permit any well to overproduce, or to willfully deliver excess oil from a well, or who shall willfully conceal the delivery of oil by a by-pass or other means to prevent the measurement of the oil.

Another act would make it a felony punishable from one to five years imprisonment for failure to make reports, or to make false reports, as prescribed by the commission. A penalty of from \$25 to \$100 or confinement in jail from 30 days to six months, or both, is provided for allowing natural gas to escape into the air where there is sufficient quantity escaping to be burned.

Considerable complaint has been made that wells are producing without flares burning.

The measures were prepared by Thompson at the request of Chairman A. G. Walker of the criminal jurisdiction committee of the house. They are Thompson's reply to what changes are needed to better control the East Texas production situation, and are intended to put the much-called for "teeth" in the law.

Former Sheriff Of Limestone Drops Dead

COOLIDGE, (UP)—Abe Therrell, 63, former sheriff of Limestone county and a prominent land owner, dropped dead here.

He was en route with his son, Abe Jr., of Waco, to his home in Groesbeck. A heart attack was assigned as the cause of his demise.

Surviving relatives include three other sons, Allen, Groesbeck; John Ed, and Tommy, of Waco, and two daughters, Nellie and Mary Elsie, Waco.

Texas House Asks Crude Purchasers To Hike Quotations

AUSTIN, (UP)—The House Thursday adopted a resolution calling on crude oil purchasing companies throughout the United States to increase the price of crude petroleum.

Sports Parade

NEW YORK, (UP)—Those good Democrats who are wondering whether they will get a nice short mail route when James A. Farley takes over the postmaster generalship business where cheered when Brigadier General John J. Puelan was elevated to the chairmanship of the New York State Athletic Commission and D. Walker West named to the same body.

Those two appointments proved Big Jim Farley, like the elephant which he helped Roosevelt trounce so soundly in November, doesn't forget. Promotion of Puelan and election of West enabled Farley to mark "paid in full" on the debt he owed these men.

Farley became indebted to the general and the wealthy Binghamton ironmaster back in 1927, when, as chairman of the commission, he insisted Jack Dempsey be barred from fighting in New York until he met "Old Har" Wills, then first on the list of challengers for the heavyweight title.

When he first started his battle to prevent Dempsey from sidestepping Wills for Gene Tunney, Farley had support of Commissioner William Muldoon. But as time went on and criticism and pressure became hotter and hotter, Muldoon deserted Farley and joined forces with Commissioner George Brower, who wanted a Gene-Jack bout for New York.

Just when it seemed Farley was licked, he appealed to Phelan and Wear, then members of the license committee. Phelan and Wear didn't fall him, refusing to grant Dempsey a license to fight in this state.

Although he used every trick in his bag, Tex Richard was unable to make Phelan and Wear desert their friend, and in the end was forced to take the first Dempsey-Tunney scrap to Philadelphia.

So yesterday, before he handed in his resignation from the commission, Farley saw to it that the general was made chairman and Wear given a seat in boxing's most influential ruling group.

A place on the commission doesn't bring a man any salary, but as a means of gaining the public eye and ear, it's invaluable. Farley's phenomenal rise furnishes ample proof of what a fine spring board it is for a man who wants to dive into big-time politics. When Governor Al Smith appointed Farley in 1924, everybody asked "who is this man Jim Farley?" Now, less than nine years later, his name is on the front page more often than the weather report.

Asked shortly before he tendered his resignation if he had any suggestions to make as to the conduct of boxing Farley said he had but one—that the commission be given control over amateur boxing in New York state.

Circumstantial Evidence Heard In Quinn Trial

ENID, Ok., (UP)—Over vigorous protests of defense attorneys, circumstantial evidence linking Earl Quinn with the slaying of two Blackwell school teachers was presented in district court here.

Only four of defense counsel James H. Mathers' 43 objections were sustained by Judge J. W. Bird, who acted quickly in an effort to speed the second trial of the former Kansas City gangster on the murder charge.

For the second time Quinn glowered at Bruce Potter, former Kay county attorney who led the prosecution that resulted in Quinn's conviction and death penalty more than a year ago.

The former prosecutor was a witness. Quinn sneered as Potter related routine testimony.

C. M. Heber, state criminal bureau ballistics expert, produced bullets and cartridge into the exhibits. Mathers protested vigorously the admission of the various ex-

hibits. With introduction of S. Charles Mannison, negro pullman porter, the state began its case of Quinn's movements the day of the crime up to his arrest in Kansas City about five months later. The porter identified Quinn as the man who boarded a train at Wallington, Kan., the night of the slayings, Dec. 28, 1930.

Letter Says Bids On Federal Building To Be Asked Soon

"Bids will be asked within a fortnight," Congressman R. E. Thomson informed H. L. Bohannon Thursday in a communication regarding status of the federal building to be constructed here.

Dallas architects in charge of drawing plans are making slight changes and bids will probably be asked soon, said Thomson unless "another unforeseen delay should occur."

Congress May Meet Before End Of Month

Opening Of Special Session Moved Up Because Of Emergencies

WASHINGTON, (UP)—President-elect Roosevelt is expected by democratic leaders here to call congress into special session the latter part of this month in order to begin work promptly upon various emergency measures.

The date originally fixed was April 17. The session may now begin about March 20, it was learned today by the United Press.

Emergency banking and relief legislation will be the first consideration of the special session. Leaders have given up hope of enacting measures of this character in the few remaining days of this session.

Missionary Says Mexicans Returning There From Texas

FORT WORTH, (UP)—The depression is driving the Mexican population of Texas back into Mexico, believes Rev. G. A. Walls, director of the Mexican Presbyterian Mission here.

Two years ago a survey of Fort Worth showed 5,000 residents were Mexicans. Today the number has decreased to approximately 2,000.

"The situation is an indication that the days of the 'vanishing Mexican' are here," said Rev. Walls. "There are a number of reasons for Mexican inhabitants of the United States to return to Mexico. The first is that their language and nationality prevent many of them from securing jobs during these times."

In four weeks here recently nearly 30 Mexicans were deported for illegal entrance to the United States. Of four taken into custody during last week, two had served in the United States army, Rev. Walls said.

Despite this fact they must now return to their fatherland because of a technical error in their entry more than 15 years ago.

Incomes Of Howard County Public Officers Shown In Reports Filed This Week With District Clerk

**Tax Collector, With \$4,131 Highest; Sheriff And Tax
Assessor Rank Next; Reports Include
Fees And Ex Officio Salaries**

Reports of annual incomes of county officers, including fees and ex-officio salaries have been filed with the district clerk here. Tax collector's office, outside the

jurisdiction of the county commissioners' court, led in the amount of pay for 1932 with \$4,131.90 a report filed by Tax Collector Loy Acuff showed. The figure is \$118.10 under the maximum allowed by law.

Sheriff and tax assessor were next with salaries totaling in excess of three thousand dollars, and delinquent collections to be received during this year will run the sheriff's total near his maximum, the report filed by Sheriff Jess Slaughter indicated.

Thus far the sheriff has made \$3,012.19 and will be allowed \$3,012.19 uncollected fees. Tax Assessor Anderson Bailey was slightly above Slaughter's figure with \$3,016.67. However, his uncollected fees are listed at only \$312.12.

The county judgeship, according to reports, was less remunerative despite responsibility for the financial operations of the county.

Judge H. R. Debenport's fees listed in the report amounted to \$743.47, and delinquent collections of \$65.80. His ex-officio was in excess of any other officer. He received \$2,700 by that means.

County Clerk J. L. Prichard reported a net earning \$2,655.26. County Attorney James Little made

\$2,232.50, his report shows. Justice of the Peace Cecil C. Collings earned \$1,507.30, his statement sets out. District Clerk Hugh Dudderly was the recipient of \$1,726.55, his report revealed.

High points in the reports follow:

TAX COLLECTOR—Earned \$4,131.90, uncollected \$312.12, expense \$2,665.59, net \$4,131.90. Tax collector is allowed fees yielding him \$3,500, then one fourth of all others until his maximum of \$4,250 is reached. Under the law, Acuff will be forced to return to the county \$1,714.11 of his uncollected fees.

SHERIFF—Earned \$6,258.75, uncollected \$1,199.25, ex officio \$3,000, expense \$5,047.21, net \$3,012.19. Under the law Slaughter will be allowed to keep his collections until

he reaches his maximum of \$4,000. **COUNTY ATTORNEY**—Earned \$1,544.90, uncollected \$140, ex officio \$500, expense \$72.45, net \$2,232.50. **COUNTY CLERK**—Earned \$4,209, uncollected \$255.90, ex officio \$1,000, expense \$2,507.84, net \$2,655.26. **COUNTY JUDGE**—Earned \$1,576.75, uncollected \$437.85, ex officio \$500, expense \$312.35, net \$1,726.55.

Practically all county salaries are determined by the fee system operating in Texas.

Quickly Chief Justice Hughes will step forward. Mr. Roosevelt will rise, both will raise their right hands and in clear solemn tones the oath of office will be read. Mr. Roosevelt will, as he signifies his determination to uphold the constitution, bend and kiss a Bible and then begin his inaugural address. In these ceremonies the outgoing President is only a spectator. His power vanishes in the twinkling of an eye as the hands of the clock meet at high noon. A moment before he is one of the most powerful men in the world. A moment later he is again a private citizen, stepping back into the ranks on a parity with the humblest voter.

As soon as the inauguration address is over, Mr. and Mrs. Hoover, after congratulating the new President, will drive directly to Union Station, three squares away and board their train.

Inaugural Parade
President Roosevelt will be driven back to the White House at a good clip while the inaugural parade forms on the Capitol plaza.

By the time the Roosevelts and their personal guests have finished a buffet luncheon, the parade will be heading around the bend near the White House. The Presidential party then go out to the temporary reviewing stand and witness the three-hour pageant.

Bands, army, navy and marine units in full dress with every button freshly polished. Then come dozens of state and local military units and marching clubs from all parts of the country, with bands, colorful uniforms, flags and banners in all colors of the rainbow.

Until almost dusk the parade will move by. Then the Roosevelts will give their first dinner and the remainder of Washington will attend the Inaugural Ball.

tion then developing.

Senator Pat Harrison became interested. So did the new State Secretary Cordell Hull. They thought that might be a way to show national confidence in banks.

Word then came from Hyde Park that the matter should be dropped.

"Most opponents based their objections on the fact that state action was covering the situation that a Federal guarantee would only be of psychological importance and that a guarantee puts a premium on bad banking. The latter objection was enough."

Allotment—
President Hoover's veto message on the Smith Cotton Bill had been prepared by the Agriculture Department and Farm Board last Tuesday.

The measure is known inside to be a stumbling block to the Allotment Plan. As such it has recently been receiving hot support from textile interests opposed to the Allotment Bill. Boys in the cloakroom figure that if the Smith Bill became law, cotton Congressmen will lose interest in allotment. That would mean its defeat. They thought Mr. Hoover might be persuaded to sign the Smith Bill because of his opposition to allotment.

The White House grapevine indicated they were wrong.

Inflation—
Al Smith out-talked the inflation boys when he went before the Harrison Investigating Committee. He did not say anything particularly new. It was the typical Al Smith way in which he said it that left his opponents floored.

The hearings have gone a long way toward curbing actions of the inflationists. You may have noticed inflation talk has died down on the floor in each House of Congress since the hearings have been on. The public works bond issue—a half-way inflation measure—is not getting the support expected.

It may be different shortly.

Speaker—
The Tammany boys had it hot and heavy among themselves before the Speakership vote yesterday.

The root of trouble was inner opposition to Congressman O'Connor. He was running for Speaker. Word got out that perhaps Congressman Cullen, leader of the delegation, would also be a candidate for the same job. That sent O'Connor off into tantrums. The difficulty was complicated by the fact that Congressman Black was a candidate for whip and the O'Connor-Cullen misunderstanding hurt his chances.

Whenever anyone asked them about it, most members of the delegation whispered behind their hands: "There may be a secret ballot and no one will know how anyone votes."

That suggested a little athletic throwing might be expected.

Banks—

NEW YORK

Improvement—
Several reassuring signs have appeared on the local banking horizon.

1.—New York City banks were able to put their house in order very rapidly to meet any possible demands. Several of the most important actually hold cash, call loans and government securities equal in amount to their total deposits. Internal conditions are now thoroughly healthy.

2.—Banks throughout the entire New York Federal Reserve District are keeping their feet on the ground and depositors are responding in kind. A tiny institution in the whole district that had to place any restriction on withdrawals.

3.—Repercussions from the National City revelations died away quickly. The appointment of James H. Perkins to succeed Mitchell as Chairman put an immediate damper on the rumor bounds.

4.—Cooperation between Stock Exchange and banking authorities to keep stock prices from running amuck has brought results. There has been virtually no forced liquidation and none is now in prospect. Also the pressure has been taken off the government list.

Industry—
Conservative men find grounds for some encouragement in side trade reports. A confidential index prepared by financial authorities shows a more than seasonal gain in industrial activity for February over January despite banking complications.

The index of physical volume of trade has risen from the low point of 79 last August to 91 this month (on the basis of 1926=100). Of course dollar volume is much lower—around 54—because of the difference in the price level.

James H. Perkins—new City Bank head—is the complete antithesis of Charles E. Mitchell. He is an old-line conservative banker and in no sense a salesman. The change of policy indicated by his choice is meant to stick. Other personnel changes will follow.

Hasty efforts were made over last week-end to interest Ogden Mills in becoming National City boss but Mills refused the crown. The probable effect on his political aspirations was rated a controlling factor.

Investigation—
The senate seems to credit Richard Whitney with omniscience. It is told here that they wanted him to produce records of activity in National City stock prior to 1927. He told them he had no such records—whereupon they threatened to hold him in contempt. He finally persuaded them he could not perform the impossible.

The dope here is that the Democrats are certain to carry on with the investigation. But the Republicans have skinned the cream. No shining target to equal Mitchell is in sight.

Sam Untermyer wants in on the party. His Los Angeles speech was a direct bid for the job of chief inquisitor. There are several bankers he would like to take a crack at for personal reasons.

Paris—
William C. Bullitt is likely to make a bull's-eye. Unusually strong Pennsylvania backing provides the ammunition. His friends in New York will be surprised if he fails to get the Paris embassy.

Rome—
Mayor Curley of Boston is not looking toward Puerto Rico or to the Irish Free State as has been stated in dispatches. His disappointment at losing the hoped for Navy appointment is believed to be a strong and rather Ireland nor southern outpost would compensate him. Friends in powerful quarters think he would like to go to Rome. You are on fairly safe ground in thinking that Roosevelt has held out hope in this direction.

State—
Old-time Wilson says that there was keen competition between Sumner Welles of Washington and William Phillips of Boston for Under-Secretary of State.

Welles was in the lead at first. Now Phillips—who had the job under Wilson—is believed to have eclipsed him. Roosevelt will probably place Welles well elsewhere.

Navy—

Friends of Vincent Astor are congratulating him on his expected appointment as Under-Secretary of the Navy. Politicians think Roosevelt showed his mettle clearly in this selection. It is not according to any political Hoyle but drafts into the public service a man of exceptional abilities.

Archibald McNeill of Connecticut, spoken of as a possibly Navy appointee, according to Roosevelt associates is not on the political horizon.

McAdoo Calls Upon New York Stock Exchange To Close In Emergency

WASHINGTON, (UP)—Senator-elect McAdoo of California Thursday issued a statement calling upon the New York Stock Exchange to close until the country gets its bearings.

His statement follows in full: "When the World War broke out in 1914 a critical financial situation developed and the New York Stock Exchange was closed for a reasonable length of time. This had a salutary effect. The present situation is somewhat analogous to the war situation in 1914.

Henry Ford Tells Inside Story Of Detroit Banking Situation And Why He Entered Picture With Own Money

By JAMES C. AUSTIN

United Press Staff Correspondent (Copyright, 1933, By United Press)

DETROIT, Mich. (UP)—Henry Ford entered the Detroit banking situation because of insistent urgings of Bankers' representatives and because of a conviction that simplified banking is needed in America. He felt he would be able to help iron out what he believes are some of the wrinkles in the national banking fabric.

Ford made clear his views on the Detroit and on the national banking situation in an interview with the United Press.

His banking theory is based on a belief there should be two kinds of banking.

In the first depositors would put their money in the bank for service and safe-keeping. They would pay a small sum to the bank for the service and receive no interest. The banker would not lend the money.

The second would be for depositors who desired a return on their money. Such a bank would lend to productive enterprises.

May Ask Release

He hoped to put these theories into practice in Detroit, a hope he has not abandoned despite the fact that even while he was talking to the United Press representative authoritative word was going around that those in control of the First National-Detroit bank, one of two which Ford on Sunday agreed to take over, would ask to be released from their agreement.

This word came after Senator James Couzens, Ford's old business partner, had conferred with bankers and then with Ford. The acting cause of the changed plans of the First National-Detroit group was not clear.

Ford, looking much thinner than usual, his tanned face contrasting with the silver grey of his hair, reiterated he had not receded from his original position with regard to taking over the banks.

"During the last week representatives of two big Detroit banks came to me not once, but three times, and stated it was impossible for them, under the conditions imposed, to reopen the closed banks," he said.

Organized Banks

"Then after an investigation I offered to do what was demanded and organized two new banks to take over the assets and perform the functions of the old banks. I made the offer and it was accepted. When I made it I made my position clear and I indicated as exactly as I could the nature and the character of the banks that would operate."

"They would be banks for the people and banks for the assistance and aid of productive business. If there is any desire on the part of any of the banks involved to withdraw from their acceptance of my offer they have not so advised me. We are ready to proceed provided they can do as they agreed."

"I want to make my position clear. I was not keen about going into the banking business. I am an automobile manufacturer. My position and my ideas regarding banking are well known. But when I was repeatedly asked to create these new banks I decided to do so."

"I stand for a balanced banking situation in Detroit. My interest in seeing that such a position is maintained in Detroit will remain unabated regardless of what my arise tomorrow or later in regard to my plan to establish two new banks in this city."

Wall Street Fights
Commercial Detroit frankly regarded the situation as one in which the old line eastern banking interests, the so-called "Wall Street Banks," are bitterly fighting to prevent Ford from becoming the dominant banking power of the Detroit area.

"America needs simplified banking," Ford said. "During what I call the crazy age in America . . . many banking directors apparently were selected on a country club basis and vice-president on their strength as social assets. . . . Banking is not a business in which great financial returns can come to the bankers. Banking is a service. The minute a bank is primarily run to make money it becomes a poor bank just as the minute that a great surgeon be-

comes obsessed with a desire to make large sums of money out of his profession he becomes distinctly a poor surgeon."

"Money, by itself was not the cause of the depression. Money is not enough. The depression came because of our state of mind; out of the fact that thousands of people had come to believe that the way to make money was through plunging on stocks or commodities instead of producing the goods and creating wealth by work."

"I'm not opposed to the so-called Wall Street banker or to Wall Street. In many ways in my judgment their services are required. They are in a way the scavengers of commerce. When a concern gets out of date or inefficient in its management they go to these banks for relief and they clear them up and get rid of them."

For Savings

"I believe that there should be a type of bank that is purely for savings in which money is deposited with the assurance of absolute safety by the banker. On the contrary the banker should receive a small fee for handling the fund."

"For men who are ready to take a degree of risk, who have confidence in the banking structure and its management, another type of bank should be created in which money should be loaned on productive enterprises."

"All unused bank balances, after a certain figure, should be taxed to bring them out of the vaults and into active business" so that the money would become an asset in commerce and industry."

Senator Couzens is represented as being favorable toward reopening of the First National Bank and possibly the Guardian National Bank of Commerce on a limited withdrawal basis provided adequate state legislation can be secured which would enable the existing banks to reopen assisted by a Reconstruction Finance Corporation loan of approximately \$75,000,000 to \$100,000,000.

The so-called Couzens plan would permit the state commissioner of banking to allow banks to segregate their "live" and "frozen" assets, largely real estate mortgages, and continue on the basis of the "live" assets. The frozen assets would be gradually thawed and put to functioning as times improved and their liquidity increased.
