Petticoats Made Pepy's Waistcoats

 PARIS, April 14.—Samuel Pepys, a famous diary writer, whose father was a London tailor, was perhaps the first masculine couturier and a very ingenious one at that. He used his wife's petticoats and skirts to make waistcoats for himself.

This was in the lean days before he became prosperous and held high office. No man had ever before written down his innermost feelings in so little disguise, and his famous diary has thrown the most penetrating light upon the history and manners of his day. He was an ardent admirer of the well-dressed man, or woman, and took a keen interest in shopping expeditions for the family wearing apparel.

The laws regulating expenses during early centuries clearly show that dress was originally a symbol of rank, strictly prescribed for the various classes of society. An early French law complains of each man thinking himself as he pleased, without reference to his rank, so that it was impossible to tell whether he was a prince, a nobleman, a citizen, or an ordinary laborer.

This is a peculiar coincidence with modern times for the older codes of affairs has been fulfilled in a letter of the law. The only places where costumes still retain their old significance is in the uniforms of the army and navy, the policeman, the lawyer's wig and gown, the judge's robe, the bishop's mitre and the university student's gown.

According to Herbert Spencer, this is true because those who wore these uniforms were and are people whose office it is to uphold established arrangements in church and state. The railways and post-offices impose set costumes on their employees and maid servants continue to wear caps and aprons over well-ordered plain dresses, and butlers and waiters are characterized by the black suits and white coats. The clergy has set itself irrevocably aside from the vacillations of fashion for its garments voluntarily mark it as apart from men.

Political and religious opinion has been symbolized by dress, as with the Puritans and Quakers—many of whose adaptations are seen this time in the grand salons of Paris.

Both and Molyneux, with lace cuffs, belts and crossed berths, standing at the sides of a dress, the tricolor of France, the white shade of the Bourbons and the blue and green of the republicans in the circus of ancient Constantinople, the orange and green of Irish political parties, and the blue and buff of English electioneering might be multiplied indefinitely. Look in any fashion magazine and you will find their counterparts.

In France, during the last half of the 18th century, dress attained its highest point of significance in its marked unmistakable differences of the revolution. Sentimentality gave birth to fashion. Rousseau's "Emile" and "Julie ou la Nouvelle Heloise" and Goethe's "Werther" Women's hair was dressed in "bandeaux of love" or "miffs of sentiment" and Marie Antoinette's "ladies of her court sought bravely to return to the simplicity of nature by mass-overdressing. In the fashion at Versailles attired as empresses and milk maids.

Today, one of the most romantic and sentimental collections of feminine finery seen in Paris has come from the work room of the famous millinet maker. The names given to the frocks, "Love me," "Irresistible," "My Heart," preclude any doubt as to the sentiment of fashion begun 170 years ago.

TOTAL CAPITAL OF NEW FIRMS IS \$25,695,000

AUSTIN, April 14. — Total capital of new companies organized in Texas during the first quarter of 1931 amounted to \$25,695,000, compared to \$17,313,000 during the corresponding period of last year, according to the Bureau of Business Research of The University of Texas. This increase of 44 per cent in capitalization was recorded in a group of companies 6 per cent fewer in number than in 1930. The total number of new companies chartered during the first quarter of 1931 was 621 compared to 660 during the first quarter of 1930.

"Petroleum activities were responsible for 111 of the new corporations formed during the first three months of this year," the Bureau's report showed. "This figure exceeds all other types of new organizations in number. Real estate and building units number 53 compared to 43 during the corresponding period of last year. Banking and finance companies totaled 68, more than double the number organized during the first quarter of 1930.

"Charters granted during March accounted for much of the increase, both in capital and in number. The total capitalization of new companies organized during March amounted to \$10,488,000, the highest monthly figure, with the exception of December, since June, 1929. The 241 companies chartered were the largest group since January, 1930.

"Foreign permits granted during the first quarter of the year totaled 118 compared to 109 during the corresponding period of 1930."

MEXICAN IMPORTS SLUMP
 JUAREZ, Mex., April 14. — Mexican imports into this border port has decreased 40 per cent during the first quarter of 1931 in comparison with the first quarter of 1930, according to a bulletin issued by customs officials. The bulletin says that exports have fallen off approximately 50 per cent because of decreased production of silver and lumber, lowered exports of cattle, and general economic conditions.

PROGRESS IN CALIFORNIA WATER PLAN

SACRAMENTO, Cal., April 10.—A statewide program of water development, costing \$180,000,000 and greater in magnitude than the famous Boulder Canyon dam, may emerge from the present session of the California state legislature.

Ten years of expert research in which more than a million dollars has been spent, culminated in the definite plan now before the lawmakers.

Recently a state water commission went to Washington, D. C., to lay before California's engineers-president the scheme for a coordinated plan of development. They found President Hoover thoroughly in sympathy, and members of congress willing to learn more about it.

As a result, members of the interior department sub-committee on appropriations, headed by Congressman Frank Murphy of Ohio, will visit California this summer to make an inspection of the projects for which federal aid is sought.

The main water problem in California is a shortage during the summer and fall in many sections, and all year in others. On the other hand, flood conditions and a water surplus apparently exists in certain parts of the state.

Rich Lands Endangered. Rich orange, olive, dairy and cotton lands in south Fresno, Madera, eastern Kings, north Kern and all of Tulare counties, that have been producing crops of land values of approximately \$4,000,000 to \$6,000,000 are in danger of being abandoned.

At the delta of Sacramento river the summer flow of water has dropped so low that the salty brine from the ocean has worked up the channels into the fertile farm land. Much of this country is endangered unless a fresh water supply is found.

So the plan evolved out of the 10-year study is as follows: At a point above Redding, known as Kennett, a large storage dam is to be erected, costing \$84,000,000. This dam would pay for itself out of electric power developed, and would fill many purposes.

Many Uses. First it would create a great fresh water lake, acting as a flood control project. It would produce hydro-electric power. It would release enough water in the low period months to prevent the encroachment of salt water in the delta section. And it would provide a new water supply for the farm lands of the Southern San Joaquin.

At this point enters an audacious, but practical scheme in water engineering. When this water reaches the delta—opposite the place the San Joaquin river enters into San Francisco bay—it would be picked up by a series of booster dams and pumps, similar to the famous locks of the Panama canal, and sent down the San Joaquin Valley to the thirsty orange, lemon and olive groves.

Other Projects. Several other projects are part of the great state scheme, including a fresh-water canal to furnish fresh water to the big industrial plants along San Francisco bay, another to store dam at Frant on the San Joaquin river costing \$15,000,000 and operating much after the plan of the Kennett dam, a \$30,000,000 flood control project on the Santa Ana river in Southern California, and federal aid toward the \$294,000,000 canal to transfer Boulder dam water from Colorado river to Los Angeles.

The legislative program involves a constitutional amendment permitting the state to guarantee to the federal government a return of the money and interest should congress agree to "loan" the state federal money for use and one-half per cent interest to start the project.

Miss Hunter, elected by the men students as the most popular girl on the campus, revealed she had "never smoked a cigarette."

"Smoking isn't necessary to popularity," she said. "Clothes are not essential. The last requirement is being a perfect dancer. College men like a girl who can dance."

Other requirements she listed as "a moderate interest in sports, such as swimming and skating and 'frill-tips' instead of heart affairs while in college."

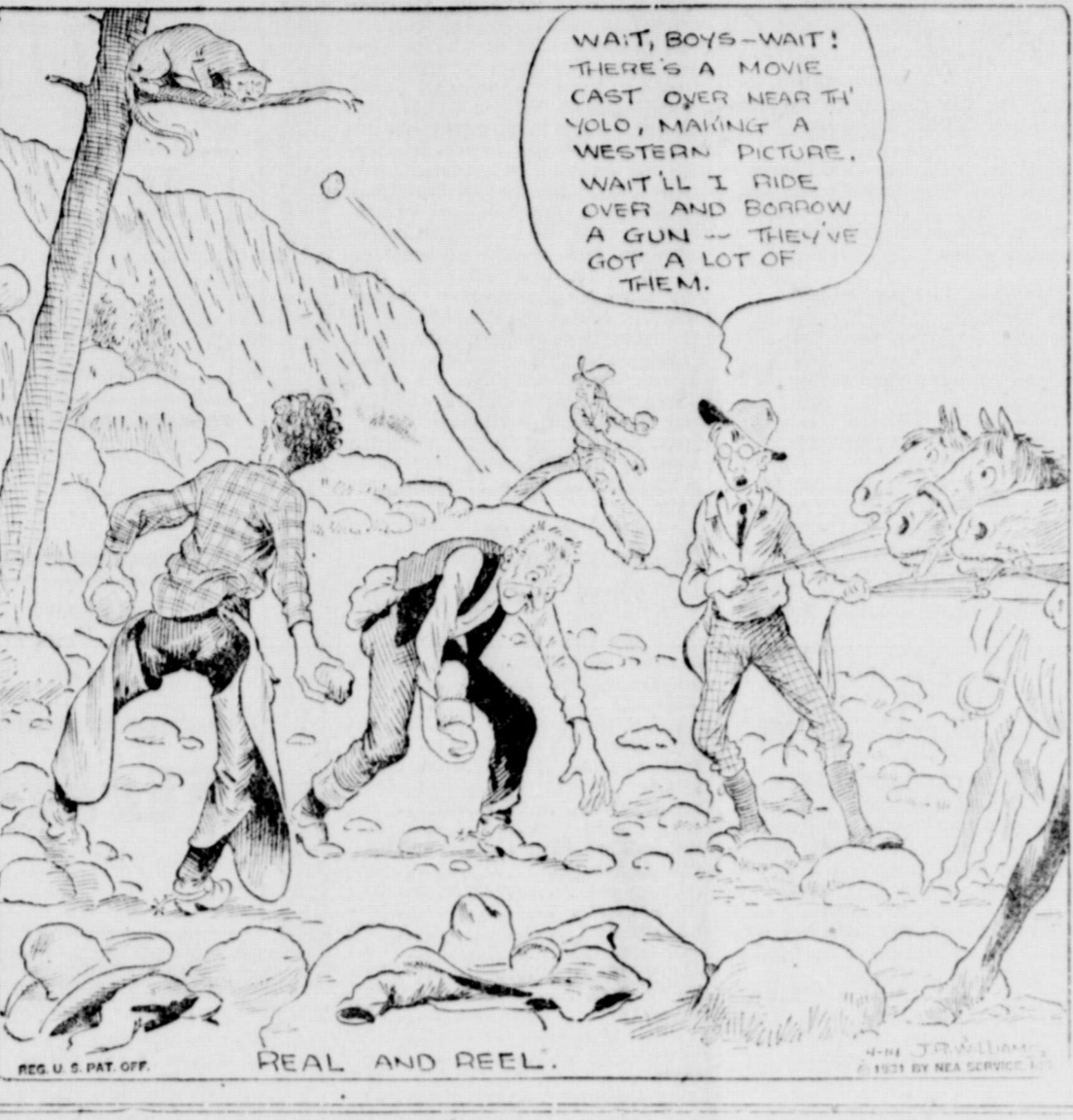
CO-EDS GO PING-PONG

TEXAS TOPICS

AUSTIN, April 14.—Murder is murder. That is criminal appeals court's decision.

True as it sounds, the pronouncement has the capacity to send people to the electric chair, rather than freeing them after three or five years in prison.

The ruling in which that succinct pronouncement was made settles a long-verified legal question. The John W. Brady case at Austin would have required a decision on the point, had Brady's three-year sentence been reversed, instead of affirmed.

His lawyers claimed that when he was given a murder sentence of three years—anything less than five—his conviction was for "murder without malice," and that upon subsequent retrial, he could not have been tried for any more serious charge than "murder without malice" nor receive over a five-year sentence.

The court, in the appeal of Rance Conway of Limestone county declared there is but one defense of murder, and that murder without malice is not a separate crime.

Under this decision, a conviction up to five years may be reversed and upon retrial the accused may receive the death penalty.

EYE RESEARCH WORK BRINGS FAME TO U. S.

BALTIMORE, Md., April 10.—Research in diseases of the eye, which has put the United States in the forefront of ophthalmology, is under way at the Wilmer Institute of Johns Hopkins Hospital where the afflicted King Praja Dhikop of Siam soon will be examined by Dr. William Holland Wilmer preliminary to an operation in New York.

Both Tarkington and Charles A. Lindbergh are among the distinguished patients treated by Dr. Wilmer who, during the war, was responsible for the eyesight of A. E. F. fliers.

Research to broaden the field of eye knowledge carried on at the institute which is the ophthalmological department of Johns Hopkins hospital and the central structure of the corresponding department of Johns Hopkins University.

In general, research is progressing with respect to the chemistry of the eye with radium as it is related to the eye and with specified diseases about which insufficient knowledge now is available. Chemical research especially deals with a study of the blood in relation with the eye and a hint of the direction of this work is contained in the statement that it has been thought a super abundance of calcium in the blood may have some relation to cataracts.

Cataracts are the affliction of the King of Siam. Records of the institute also show that large numbers of persons suffering from cataracts also have diabetes.

More adequate knowledge also is sought regarding trachoma and the specialists concede that little is known of the disease called glaucoma. With radium the Wilmer institute staff hopes to aid industrial workers whose eyes have been injured by flying particles. Radium is expected to hasten absorption of scar tissues and thus to restore clear vision after such injury.

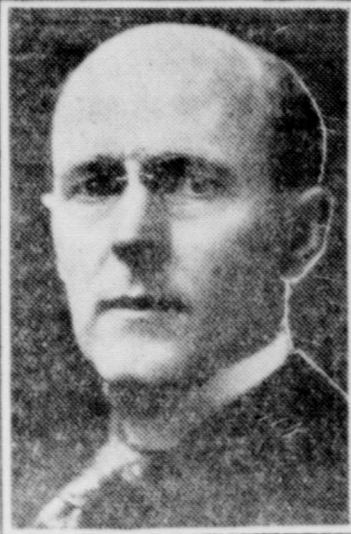

lar realization of the importance of becoming better acquainted with the history and development of the United States exists in the countries of Latin America. An increasing number of students from the countries to the south are being enrolled in the colleges and universities of the United States. I cannot emphasize too strongly this important aspect of inter-American relations. These cultural currents not only contribute to better international understanding, but also emphasize the essential unity of interest of the American republics.
Spreads Information
 Through the Pan-American Society and its branches established in different sections of the country, we enjoy the great advantage of inhabiting a hemisphere free from the jealousies and antagonisms which have proved such obstacles to progress and prosperity in other sections of the world. We have developed an international system based on the principle of equality, combined with a full recognition of the obligations as well as the rights of States.
 The American republics are today rapidly approaching the time when every major difference existing between them will be settled by the orderly processes of conciliation and arbitration. In this respect, the Western Hemisphere has placed an enviable record before the nations of the world. From the earliest period of their history, the governments of the republics of this hemisphere have been earnest advocates of the peaceful settlement of international disputes. The common purpose to eliminate war and the determination to achieve peace and security represent a major contribution of the Americas to modern civilization.
Heavy Obligations
 The full significance of this

achievement is not always realized, for it carries with it heavy obligations to posterity. Future progress along these lines can only be assured through constant vigilance and by an unswerving determination to make the union of the American Republics, as now expressed in the Pan-American Union, an example to the world. We are not attempting in any way to develop a super-state, or to interfere with the freedom of action of any of the states, members of the union, but rather to develop an atmosphere of good will—a spirit of cooperation and mutual understanding—in which any difference that may arise, no matter how important, will find a ready solution.
 I cordially congratulate you, gentlemen of the governing board, on your happy initiative in establishing Pan-American Day at the same time, I send a message of fraternal greeting, in the name of the people of the United States to all the inhabitants of our sister republics.

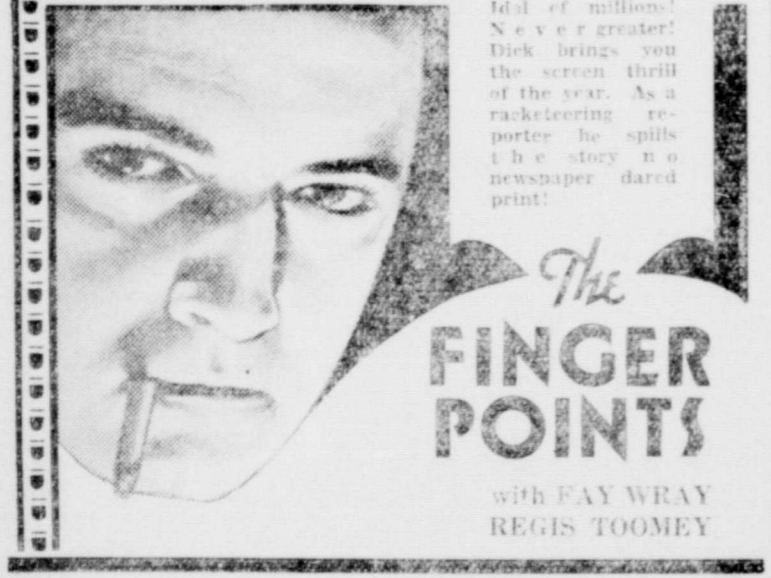
