Notice To Persons On Dawson County Relief Rolls

Upon instructions embraced in a Resolution passed by the TEXAS Relief Commission June 27, 1934, NOTICE is hereby given to the effect that persons physically able to work who are offered employment at the prevailing wage scale in the locality wherein the work is to be performed, and who refuses to accept without good cause, shall not be furnished relief.

The following instruction are issued to all citizens of Dawson county, to-wit:

Any person or persons offering employment to others whether on Relief Rolls or not will inform the Local County Relief Board Chairman in writing immediately when employment offered by such citizen is refused. Such advice to the county Board Chairman will include, when possible, the work-seeker's full name, Address, Employment offered and wages offered.

When any person has been offered employment, and has refused it, under the conditions above stated, the County Relief Board of Dawson County is prohibited from giving either direct or work relief to such person.

This pronouncement is published under direction from the Texas Relief Commission, whose membership requests the universal cooperation of the people of Texas in support of this action which is directed at the displacement of persons on Relief who refuse to accept work.

Postal Receipts Show Increase

Postal receipts at Lamesa for the quarter ending June 30 of this year show an increase of a little more than 15 per cent over the corresponding quarter of 1933, according to information given out by J. D. Dyer, Postmaster. The receipts for the June quarter of 1933 were \$3556, and for the June quarter of 1934, \$4096.16.

New Air Mail Rates Are Now In Effect

Effective July 1st air mail rates were reduced from 3 cents for the first ounce and 13 cents for each additional ounce to a flat rate of 6 cents an ounce, regardless of weight, for all points having air mail connections in the United States and Canada. New air mail service is now in operation to all leading cities in the United States and the new rates are so low that it is expected a very large increase in the volume of air mail will be noticed.

Facts About Dawson Co. Pink Bollworm Claim Warrants

According to information Tuesday morning given by Charles L. Harless representative of the Comptroller's office in Austin to local people, Pink Bollworm warrants for Dawson county will be completed and turned over to the Pink Bollworm Claim Board Friday of this week.

According to information given out Monday here by Fred W. Davis, chairman of the Pink Bollworm Claim Commission, as soon as the warrants for Dawson county are received from the Comptroller's Department, they will be dispatched to the Lamesa Chamber of Commerce by a representative of the Claims Board, where they will be distributed.

The Lamesa Chamber of Commerce will give due notice in next week's paper when these warrants are to be received and disbursed here. Following is a letter which was sent by received by Senator Arthur P. Duggan, from George H. Sheppard, Comptroller, which will explain further facts with reference to Dawson County Pink Bollworm warrants. The letter is a reply to one Senator Duggan has written the Comptroller's Department urging that Dawson County Pink Bollworm Warrants be issued as soon as possible because of the need for them here.

Dear Senator:

Replying to your favor of July 3, 1934, with reference to the payment of Pink Bollworm claims, I am pleased to advise that these claims are being paid as fast as they are filed in this department.

Up to this time warrants have been issued in payment of claims from Midland and Martin counties, and have been returned to the Compensation Claims Board of the Agriculture Department for distribution. This morning I received approximately one-third of the Claims for Howard county. I am preparing to issue warrants in payment of these claims this date. No other claims have been filed in this department covering Pink Bollworm Claims.

My force is working over time in order that there may be no delay in getting these claims paid. I will thank you to assure all those interested in this matter that I am doing everything possible to get these claims paid without delay.

The impression that seems to prevail in the Pink Bollworm section is that these claims are being held up in this department. That situation is not true. As above stated, all claims that have been filed have been paid immediately, and will be paid as fast as presented.

Farmers are urged to be careful and not be in too big a hurry to cash these warrants. The discount will range between 2 and 3 per cent, officials from Austin advise. The banks in Lamesa and local business men have agreed to handle these warrants on a businesslike basis. There will be plenty of demand for them outside of Lamesa and many will want to discount them more than 2 to 3 per cent. It is thought that calls will be made by the Treasury Department at Austin within 90 days from the time these warrants are issued and if held that long, will be worth 100 cents on the dollar. They have been drawn on the General Fund of Texas and are not deficiency warrants. Let everyone who receives these warrants do their best to get the most benefit from them.

Administrator Is Appointed For Housing Program

Press dispatches received Monday state that James A. Moffett, former vice-president of the Standard Oil Company in California, has been appointed to the office of administrator for the federal housing program. This is the latest development in the plan which has created so much interest among local people. Mr. Moffett state that he believes that the plan can be put into effect with very little delay.

"We hope," Mr. Moffett continued "to see approximately \$500,000,000 put into home renovation and repairs and by next fall we believe fully that amount will be in use. Ultimately we believe the program will result in the employment of 5,000,000 men."

This program authorizes government modernization and repair. If a bank, for example, lends \$50,000 for modernization, the government will guarantee that there will be no loss on \$10,000.

Mr. Moffett points out that there will be no complicated forms and regulations. A homeowner who needs money for repairs or additions will ask a building and loan association a bank, or some similar financial agency for a loan. That institution will then consult the housing administration and if the latter approves of the terms, will guarantee that there will be no loss on 20 per cent of the amount loaned. The borrower, under present plans, may not have to offer other security.

The central aim of the program is to establish a standard type, long-term mortgage at a comparatively low rate of interest. Other clauses of the plan include refinancing of existing mortgages and the guarantee of deposits in building and loan associations.

Buying Of Cattle In County To Get Underway Friday

Trucks Must Have NRA Insignia To Get Federal Work

Austin, July 9.—After July 13 no truck operating for hire without NRA insignia plates will be allowed to work upon any project upon which Federal funds are being spent, according to Col. H. F. Stewart, chairman of the Texas trucking code authority. "This will include much of the road construction, public building renovations and other public works projects under way" he said.

The names of over 400 truck operators who have not registered under the Code have been certified to the NRA Compliance Office at San Antonio, according to Mr. Stewart.

"Almost 2000 registrations have been made in Texas," he continued, "but of course there are always some laggards who stay out until the last minute. July 13 is the last day on which anyone operating a truck for hire can operate legally without the NRA plate, but the code Authority will continue to accept registrations from those who can show reason for not having registered. Anyone who should register and who has not done so by that date will be subject to the full penalties of the Recovery Act, and each day is a separate offense under the code."

Full information on registration may be had from the headquarters of the code authority in the Littlefield building at Austin.

Newspaper Mailing Rates Lowered

Postmaster General James A. Farley signed an order on May 29 reducing the advertising mailing rates on second class postage matter to rates that were in effect prior to the passage of the Revenue Act of 1932. The new rates became effective July 1, 1934, and represent a reduction of from one-half cent for the first and second zones to three cents for the seventh and eighth zones per pound.

With the designation of Dawson county as a drouth county the program of relief will get underway Friday, July 13 with the starting of the buying of cattle. L. B. Stuart has been selected as appraiser for Dawson county and has taken application to sell over 7,000 head of cattle to the government.

Applications to sell cattle must be made with the county agent, who routes the appraiser and directs his activities. The cattle must be inspected at the producers farm or pen, and if possible each farmer who has made application will be notified when the appraiser will be at his place. Each producer will deliver his own cattle to local stock pens after they have been inspected at his farm. According to the officials checks will be mailed to the producer within two weeks after delivery of the cattle.

These cattle are paid for on the basis of market value plus a bonus with a price not less than \$12.00 per head for anything over two years of age. Diseased and inedible cattle will be destroyed and they will be paid for just the same.

Price schedules are as follows: over two years of age \$12.00 to \$20; one to two years of age \$10 to \$15; under one year \$4.00 to \$8.00.

June Driest For Years Is Record

Just in case some of our readers might still be in doubt on the matter, the Index this week begs to inform that Mr. Don L. Jones, superintendent of the Lubbock Experimental Farm is authority for the statement that the June just past was the driest since 1911.

Until we received the figures we were not certain just how dry and hot the month really was, but we agreed with the Southwest that it was entirely TOO lacking in both moisture and coolness. The figures given out by Mr. Jones are as follows:

"Total evaporation, 12,184 inches; number of clear days 18; number of partly cloudy days, 11; number of cloudy days, 1; precipitation for June .28 of an inch; normal precipitation for June, 2.45 inches; total precipitation from January 1 to July 1 4.72 inches; normal precipitation from January 1, to July 1, 8.18 inches; departure from normal minus 3.46 inches."

Pure Water Company Gets Federal Approval

The Pure Water Company of Lamesa has secured the approval of the Health Department at Washington of its product, known as Fluoride Free water. The local company submitted its formula to the national health department and after a study of more than a month this department wrote its full indorsement to the local company. The department warned however that it was not only necessary to see that children drank this water from birth but their foods should be cooked in the water if the teeth of these children showed free of the ill effects of fluorides.

Prior to this the local company had secured the indorsement of its formula from the State Health Department at Austin. Research has shown that drinking water containing more than 2 p.p. of Fluorides causes brown stain and brittle enamel of children's teeth. The chemical analysis of the water here shows 67 of Fluorides. Most Plains water tests above 4 p.p.

The local water company is to be commended for its action to try to prevent bad teeth of the children of this community.

Liberty Bell Is Heard Over Radio By Millions

Silenced by the century old crack in its side, the Liberty bell vibrated to the touch of a rubber hammer set moving by radio from the south polar ice caps, and the sound was carried back on the ether waves to the world and the bell ringer Admiral Richard E. Byrd.

County Club Work

Mrs. Gowen who is chairman of the Home Demonstration Extension Committee has given three tile making demonstrations. Munger, Central and Woody clubs have profited by her demonstrations.

To date, Mrs. Gowen holds the record for the largest number of tile laid.

"We shall see if my sub-irrigated tomatoes produce much heavier than the surface irrigated tomatoes of my neighbor" said Mrs. M. K. Kidd of Wilson community.

Mrs. Kidd has shared her garden with Mrs. Timms, her neighbor. Tile for sub-irrigation has been put down for Mrs. Kidd's tomatoes, while Mrs. Timms waters hers from the surface. The soil is exactly the same in the gardens. The tomatoes are of Marglobe variety and were put out the same day.

FARM NOTES

Over 200 cotton reduction contracts have been returned to the county agent for correction. These corrections were made by the county committee.

Following are a few of the reasons why the contracts were returned: When a contract stated that a crop had been hailed out the contract was returned with the question asked, if the crop was hailed out before July 1, and if cotton had been replanted that year. Another reason was the discrepancy in acres. Others signed contracts stating that they were cash tenants, these signatures had to be verified, with other minor questions to be answered. Also signatures signed by men for estates and companies had to be verified.

Dawson county has been allotted 24,278 bales of cotton from this year's crop, this is based on a four year average, or for the years of 1929, 1930, 1931, 1932 and is 60 per cent of the production for these years. This 24,278 allotment means that Dawson county will have that many bales of tax free cotton.

Each farmer in the county will have to make application for certificates of Exemption or bales tags before any are allowed. Each school district committee will notify farmers in their districts to come to the school house and make application for bales tags. No application blanks have yet been received.

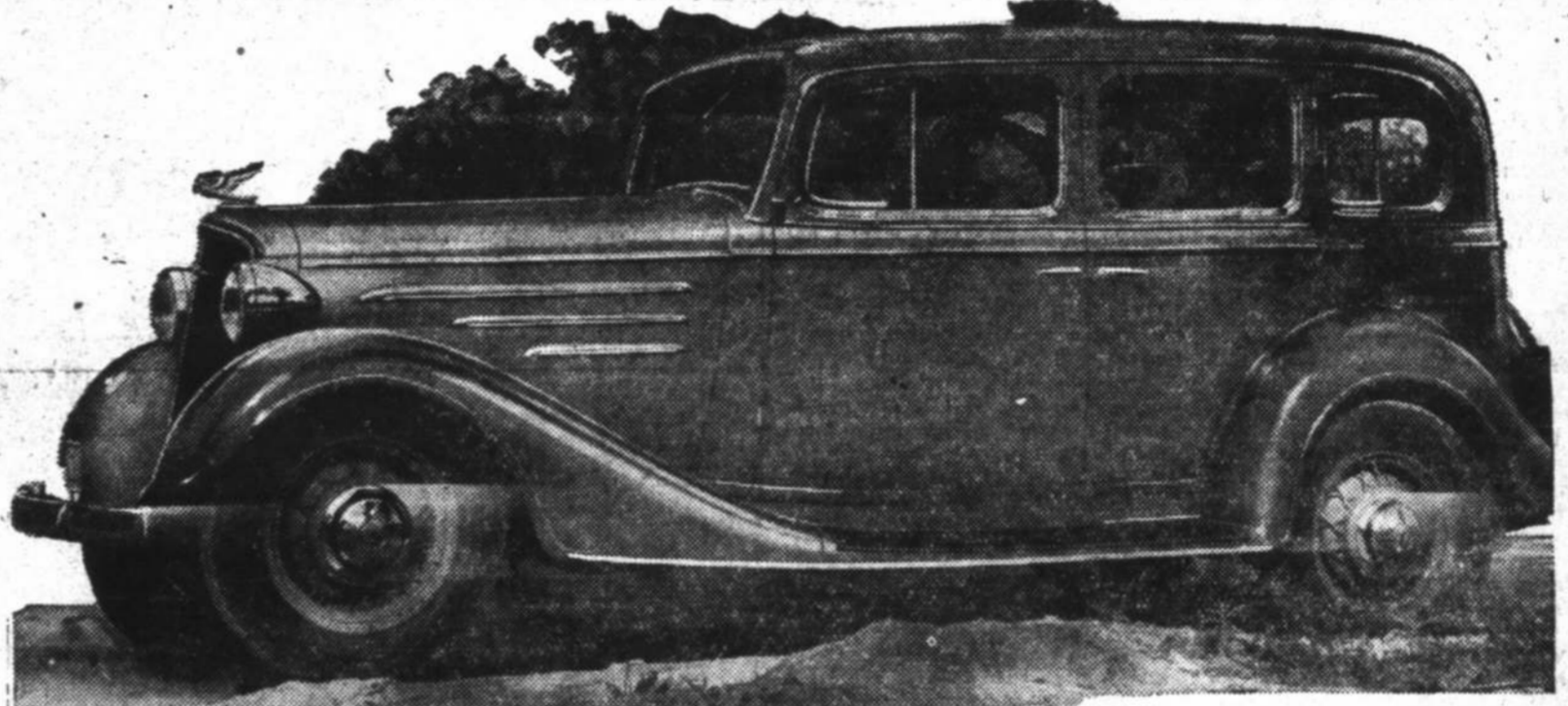
