### "Revenooers" Raid Ozark-Type Liquor Still In Abernathy; Moonshine-Maker Fined \$600

closed in 1945, after V.J. Day. They contain information, pictures, mats and engravings of our men who helped lick the Germans and Japs.

Due to bungling in high places in Washington, the peace for which our men fought on the battlefield, high seas and in the air was lost over conference tables.

World War III started with our Air Lift to supply West Berlin with food, fuel and other necessities. American airmen lost their lives in that operation.

Back to those files. We're using them to get information about our men who are being called back to the Armed Forces.

Files were pulled on Weldon A. Crow, Walter L. Rutledge and Russell L. Paxton.

Crow, called to duty this month with the Lubbock Army reserve unit, volunteered for service in World War II in January, 1942. His physical condition caused removal from infantry training at Camp San Luis Obispo, Calif., to Hottel General Hospital, Santa Barbara, Calif. He was given a disability discharge and arrived home March 28, 1943. Our file also reveals that he tried to re-enlist in November, 1943. He underwent major surgery in the veterans hospital at Amarillo a few years ago. Whether the surgery was sufficient to make him physically fit for military duty now will be known when he takes a physical at Reese Air Force Base between now and Sept. 1. Mr. and Mrs. Crow have two daughters, Charlotte, who will be a Senior in AHS, and Lanny, 2.

Walter L. Rutledge entered service as a volunteer with Crow in January, 1943, and went with him from Fort Sill, to Camp San Luis Obispo. Rutledge moved to Camp Rucker, Ala., on April 2, 1943. On July 1, 1943, in line of training at that camp, Rutledge fell 18 feet from a tree and sustained a broken back which kept him in Army hospitals for several months. He was discharged Oct. 25, 1945, and immediately re-enlisted. Early in 1946, he was sent to the ETO on M. P. duty with the Army. Rutledge married Mauricette Helene Pingret in Reims, France, Dec. 26, 1946. She came to the States in May, 1947, and was at home with her husband's parents, the late O. Rutledge and Mrs. Rutledge, until Walter L. came home in August, 1948. Mr. and Mrs. Walter L. Rutledge now have a son, Richard, eight months old, and they reside in a new home at 509 10th St. Whether Rutledge's back injury sustained in 1943, will let him pass the physical at RAFB remains a question. Rutledge hopes to pass the physical so he can make the Army his career. He has about seven and one-half years, counting reserve time, toward retirement.

They are not in the Review's service file, because they were too young to be in World War II, but Harold Glenn Rutledge, another son of Mrs. O. Rutledge, and Gerald Jeffery, son of Mr. and Mrs. P. E. Jeffery, soon will have a file at our office. They are in the same reserve unit with Crow and Walter L. Rutledge, and were called to duty along with them. Harold and Gerald will take physical exams at Reese Air Force Base between now and Sept. 1. The reserve unit will enter training at headquarters, municipal airport, Lubbock, on Sept. 11, and will ship from there to a regular training camp about Sept. 21. Crow and the Rutledge brothers are assigned as cooks and Jeffery as filler personnel.

Son of Mrs. Addie Lou Paxton of Lakeview community, Russell L. Paxton will re-enter the Air Force as staff sergeant, and will be a cook. He was called to return home for about 21 days before going into active duty. He'll report to Brooks Field about Sept. 11, and will be stationed at Lackland Air Force Base, San Antonio. Russell entered service in World War II, Dec. 3, 1941, and served in the States and was in New Guinea, Guam and the Philippines. He holds the Defense Ribbon, Philippine Liberation Ribbon and two battle stars. He returned to the states from Guam in Sept., 1945, and was discharged at El Paso Oct. 12, 1945. S/Sgt. and Mrs. Russell Paxton have two children, Sharon Lee, 6, and Russell Bruce, 5.

Other local young men who will soon be in our service file are Lupo Ramos, Billy Joe Templeman, A. L. Stone, Jr., Leo Lebow and Nolan Williams, who passed

physical exams in Amarillo August 16, and Roy Downs, who went for his exam this week.

It's legal in Louisville, but the liquor still found on East Fourth Street in Abernathy was operating outside the law. Here are two reprint stories from the Lubbock Morning Avalanche and Avalanche-Journal on the raid made here Friday night.

A still producing rye whiskey was progressing in true Ozark fashion until "them revenooers" broke the party up late Friday night.

The still was discovered in full operation by two Lubbock liquor board inspectors and a Lubbock deputy sheriff when they raided a one-room shack in Abernathy about 8:45 p. m. Friday.

Officers said the shack was located "just inside of Lubbock county on Fourth street in Abernathy, on the Lubbock-Hale county line."

Leon Bowman, deputy supervisor for the liquor board, said the raiding party confiscated about 50 gallons of rye mash, four gallons of rye whiskey and the five-piece still.

Most of the whiskey was already bottled in pints, some of the bottles being marked with the labels of nationally known distillers.

Two men caught operating the still were arrested and placed in the county jail Friday night. Officers said they would be charged early this morning in county court-at-law.

The still consisted of two large wooden barrels, a small stove, a large steel container and a metal barrel.

The owner of the still readily told officers this story of how he and his assistant produced the liquor.

First you put the rye mash into the wooden barrels, pour water over the mash and add yeast and a few other essential ingredients.

You leave this alone for approximately 72 hours while it ferments.

Then you pour the liquid into the large steel container and let it boil. As it boils the liquid is forced through a tube and runs off into the metal barrel. This is the finished product.

The rye whiskey is then bottled in pints and sold to "those in need."

"This is fine liquor," the owner told newsmen proudly. "I've never had anyone complain about it. There's one catch to making this stuff though. Everytime I go to make a batch of it up, I have to move out of my house."

Bowman said this was the first still he has found while working this region.

Bowman was accompanied on the raid by Inspector Fred Weatherford and Dep. Sheriff Geno Lewis.

An Abernathy man who admitted he produced rye whiskey for 9 cents a pint and sold it for \$3, was fined \$600 and court costs on a liquor law violation charge.

The man, Carl Blakely, 51, was fined by Judge James G. Denton, of the county court-at-law after pleading guilty of liquor law violation early Saturday morning.

Blakely was charged in connection with Friday night's raid by liquor control board and sheriff's deputies who seized a whiskey still.

The five-piece still was found in a one-room shack on Abernathy's Fourth Street just inside Lubbock county. The officers also confiscated about 50 gallons of rye mash and four gallons of rye whiskey.

Leon Bowman, deputy supervisor for the liquor control board, said this was the first still he had found in this region.

Blakely sold the whiskey in pint bottles, some of the bottles still carrying the labels of nationally known distillers. He said he used Dr. Pepper to give the whiskey a "natural" color.

## Abernathy Schools Will Open New Term With General Assembly Monday, Sept. 4

Abernathy Public Schools will open the 1950-51 term on Monday, September 4th with a General Assembly at 9 A. M. in the Auditorium.

Immediately after the assembly all elementary children will report to classrooms for enrollment, issuance of textbooks, and for the making of assignments. High school students will meet an abbreviated schedule. The first day session will end at 11:30 o'clock. The cafeteria will not operate on opening day.

School buses will operate regular routes on opening day. All departments will operate on full regular schedule on Tuesday the 5th. The regular school will open at 8:45 and close at 3:45.

## Second Democratic Primary Election Scheduled Saturday; Ballot Is Short

Voters in the second Democratic primary election Saturday, August 26, will have a comparatively short ballot to study before making selections. Voters in South Hale county will ballot on five state places and one county office.

Holding greatest interest in the election is the hotly contested race for Hale county judge. Backers for both candidates, Marsh S. Watson, incumbent, and Lee Nowlin, have hurled charges and counter charges via press and radio for several weeks. This race is expected to draw voters to the polls Saturday.

State races include: For lieutenant governor: Pierce P. Brooks, and Ben Ramsey; for associate justice of supreme court, place 1: Fagan Dickson and Will Wilson; for associate justice of supreme court, place 3: Meade F. Griffin of Hale county and George W. Harwood; for judge of court of criminal appeals: W. A. Morrison and Robert L. (Bob) Lattimore; for commissioner of agriculture: John C. White and J. E. McDonald.

Voting in Abernathy's Hale county box will be at Firemen's hall. Polls for the Lubbock county part of this area will be at Thompson Implement Co. Polls will be at Lakeview, in Hale county, and at New Deal in Lubbock county.

Dedication Program Dedication program for the new church building will begin at 2 p. m. Sunday. Program details were not complete at press time. Rev. Marvin Boyd, district superintendent, will be principal speaker. Also to appear on the program are Rev. Wesley Daniel, Lakeview pastor, and several former pastors of the church. There will be special music, and the church history will be given.

Mrs. W. H. Ragland of Abernathy is the only known living charter member of the church. The following information is from Mary L. Cox's History of Hale County, Texas: "The Lakeview Methodist Church was organized by R. M. Morris, of Plainview, in March, 1893, at the old Ivey School house in the Strip Community. This was the third Methodist Church to be organized in Hale County."

A building was constructed for the church at the Strip site in the early 1900's and was moved to Lakeview about 1922. That building was sold to Petersburg colored people recently and moved to that city to be used as their church.

The new Lakeview Methodist church building and its new fixtures and furniture, including a new piano, carry a value of \$12,000.00. Constructed of frame and stucco, the building is 32 x 60-ft., and has a seating capacity of about 200. It has four class rooms and auditorium.

Members of the building committee are A. B. Colwell, B. A. McDougal, Lawrence Amerson, Clayton Enger, Aaron Mayo and S. M. Harrison. Jesse Anderson of Abernathy was in charge of construction. Much of the labor was contributed by church members and those of neighboring churches.

The building was completed a few weeks ago, and has been in use since the old structure was moved to Petersburg.

**A STATEMENT OF FACT**

An expression was made recently through the newspapers by Mr. Marshal Surratt, Tax Collector, that there was a lack of co-operation on my part as County Judge to assist him in preparing his tax rolls by withholding the tax rate for 1950.

I served you for ten years as Tax Assessor-Collector and know the many problems in getting the tax roll written and the receipts made by October 1st. each year. This same situation confronts all county and state tax collectors and there is BUT ONE ANSWER AND EXPLANATION and that is the law governing budgets and fixing of tax rates

The budget Law, Article 689a, provides that the county judge is the budget officer of the County, and it is the responsibility of the county judge to prepare and complete the budget during the month of July. When the budget is completed, which must be prior to August 1st., a copy shall then be filed with the clerk of the county court, in order that it may be available for the inspection of any taxpayer. This has been done. The Budget Law also provides that the Commissioners' Court shall set a day for public hearing on the county budget; and further provides that the date for this hearing shall be some time AFTER AUGUST 15th, and prior to the

time that the commissioner's court shall vote on the budget and either approve it as filed by the county judge or make such changes in it as they deem advisable.

On August 14th., by a proper order of the commissioners' court, I was authorized to give notice of Budget Hearing to be held August 28th., which is the earliest date it can be held, and which notice was published on August 16th. Preparation and approval of the budget and fixing of the tax rate has been handled in 1949 and 1950 according to law and as had been in prior years, as can be fully determined by an examination of the Commissioners Court Minutes.

## In Order That The People May Know

TO THE TAX PAYERS OF HALE COUNTY: As your public servant, I feel that you should be informed as to some of the proceedings and workings of the County and what your money is being spent for.

In order for me to serve you efficiently, I must have the cooperation of other County Officials. In order for me to have the tax roll ready for you to get the three per cent discount in October that is allowed by law, I must have the County Tax Rate. The 1950 State rate was set July 25, 1950. As of this date, August 14, 1950, I do not have a County rate nor has there been a board of equalization that should have acted prior to the first day of June, 1950.

So that you may know the handicap that I work under, I will give you the facts, along with my apology for not getting things done on time. In 1949, I received the tax rate on September 14, late in the afternoon; yet, according to law, I am to have the tax roll ready the first day of October. In addition to typing the roll, all receipts must be typed in advance and ready at the time the roll is ready. In 1949 the roll consisted of 664 pages, there were 10,195 receipts, and if you will note, I had fourteen working days in which to do this tremendous amount of work, and have it done on time. My deputies were very cooperative in working until eight o'clock at night for five weeks, without any extra pay; but it is not my plan that they shall have to do that this year. I now know where the fault is, and I know that it is not in the efficiency of my office. When the tax rate is held up to this late date, I will be forced to hire extra help at the expense of the tax payers. In 1949 I did hire extra help for proofing and typing, but I paid it from my own pocket. I hired this extra help to prove to the one causing the delay that we could get the job done by putting forth everything we had, and by working day and night.

In order that the tax roll may be made on time this year and that you get the three per cent discount allowed you by law, ask your County Judge why the delay. My assessments have been ready since May 8, 1950.

## A Correction

In recent issues of the newspapers over the County there appeared an affidavit signed by Mr. Marshal Surratt, Tax Assessor-Collector, Mr. Fred Shelton, County Clerk and Mrs. Fern Bird, County Treasurer.

The first paragraph is an index to the weakness and the incorrectness of their statements. The County Judge has nothing whatsoever to do with primary elections and the arranging of names on the ballot. The Democratic Executive Committee handles this matter entirely. Furthermore there were no elections in 1949 other than a Special Election called by the Governor on November 8, 1949 for the purpose of voting on amendments, etc. I did not make such a statement to anyone.

I did have occasion to talk with the above named three officials relative to the removal of approximately \$114,000.00 in bonds, representing principally the investment of the permanent school funds in these interest bearing securities. These bonds were kept in an approved storage vault located in the tax collector's office where it has been for many years. The County Judge and the County Treasurer each kept a key to the inside door of this storage vault and neither could enter the compartment containing the bonds without both keys. Early in January of 1949, soon after assuming the duties of County Judge, Mrs. Bird, the County Treasurer requested my key, stating she wished to check the bonds. The key was later returned to my office without further comment. A day or two afterwards, I learned the bonds had been removed from the approved storage in the tax collector's office to the office of the County Clerk. Realizing the seriousness of this act, I immediately went to the office of the County Clerk and inquired of him if the bonds were in his office and he advised me they had been placed there. I asked that he get in touch with the insurance firm carrying the coverage on these bonds and ask them to investigate the matter. This was done with the result, after consulting with the National Surety Corporation of New York through their Dallas office, that the bonds be returned to their original storage vault, or that they, the National Surety Corporation be released from further liability, in as much as a policy could not be written covering the bonds as stored in the County Clerk's office. The bonds were returned to the original storage vault.

Later rumors were being circulated by these officials that their offices were being plundered after their closing hours, which was causing much discussion and confusion. I called Mr. Ted Andrews, the Sheriff and discussed these rumors and suspicions with him and asked if these officials or either of them had reported such to him for investigation. He advised me they had not. I asked Mr. Andrews to make an investigation and requested him on his return to his office, that he tell these three officials I wished to talk with them and if he, Mr. Andrews had time to come back and sit with us and gather such information as would assist him in apprehending any person or persons that might be entering their offices after closing hours as being rumored. Mr. Andrews did return and was present throughout the discussions.

Some minor repairs were being made in my office and I was working in the County Court room. Mr. Shelton was admonished concerning his attitude toward his duties as clerk of the Commissioners Court and the County Court. Statements and references made as to me being on the bench during the interview with these officials were injected by Mr. Chas. Dean, an attorney and brother-in-law of Mr. Lee Nowlin, the day following the interview, who inferred that I had conducted some kind of a trial and further cursed and abused me, based strictly upon personal hatred.

I told the three officials on the occasion as stated by Mr. Watson, that he wished to see them and I was present throughout the discussion with the three officials as above related by Mr. Watson and at no time was there any reference made to a court being in session while he was talking with the three together, neither was there any vindictive spirit displayed by Mr. Watson or any abusive language used.

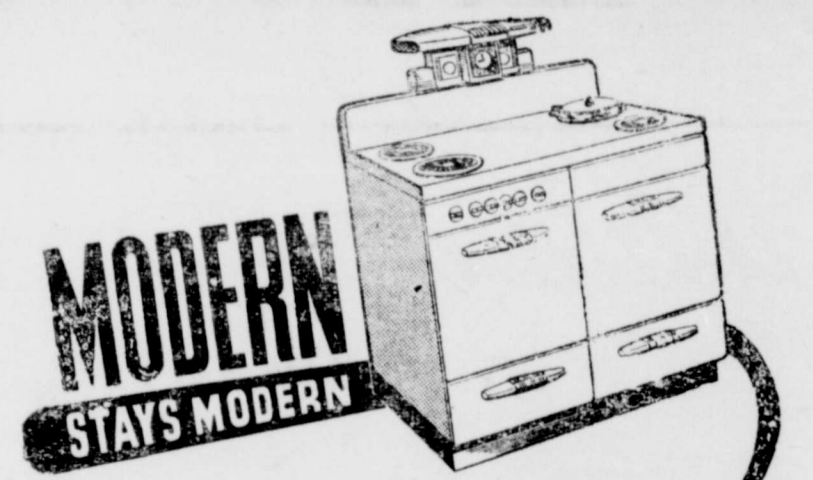

## A Correction

In recent issues of the newspapers over the County there appeared an affidavit signed by Mr. Marshal Surratt, Tax Assessor-Collector, Mr. Fred Shelton, County Clerk and Mrs. Fern Bird, County Treasurer.

The first paragraph is an index to the weakness and the incorrectness of their statements. The County Judge has nothing whatsoever to do with primary elections and the arranging of names on the ballot. The Democratic Executive Committee handles this matter entirely. Furthermore there were no elections in 1949 other than a Special Election called by the Governor on November 8, 1949 for the purpose of voting on amendments, etc. I did not make such a statement to anyone.

I did have occasion to talk with the above named three officials relative to the removal of approximately \$114,000.00 in bonds, representing principally the investment of the permanent school funds in these interest bearing securities. These bonds were kept in an approved storage vault located in the tax collector's office where it has been for many years. The County Judge and the County Treasurer each kept a key to the inside door of this storage vault and neither could enter the compartment containing the bonds without both keys. Early in January of 1949, soon after assuming the duties of County Judge, Mrs. Bird, the County Treasurer requested my key, stating she wished to check the bonds. The key was later returned to my office without further comment. A day or two afterwards, I learned the bonds had been removed from the approved storage in the tax collector's office to the office of the County Clerk. Realizing the seriousness of this act, I immediately went to the office of the County Clerk and inquired of him if the bonds were in his office and he advised me they had been placed there. I asked that he get in touch with the insurance firm carrying the coverage on these bonds and ask them to investigate the matter. This was done with the result, after consulting with the National Surety Corporation of New York through their Dallas office, that the bonds be returned to their original storage vault, or that they, the National Surety Corporation be released from further liability, in as much as a policy could not be written covering the bonds as stored in the County Clerk's office. The bonds were returned to the original storage vault.

Later rumors were being circulated by these officials that their offices were being plundered after their closing hours, which was causing much discussion and confusion. I called Mr. Ted Andrews, the Sheriff and discussed these rumors and suspicions with him and asked if these officials or either of them had reported such to him for investigation. He advised me they had not. I asked Mr. Andrews to make an investigation and requested him on his return to his office, that he tell these three officials I wished to talk with them and if he, Mr. Andrews had time to come back and sit with us and gather such information as would assist him in apprehending any person or persons that might be entering their offices after closing hours as being rumored. Mr. Andrews did return and was present throughout the discussions.

Some minor repairs were being made in my office and I was working in the County Court room. Mr. Shelton was admonished concerning his attitude toward his duties as clerk of the Commissioners Court and the County Court. Statements and references made as to me being on the bench during the interview with these officials were injected by Mr. Chas. Dean, an attorney and brother-in-law of Mr. Lee Nowlin, the day following the interview, who inferred that I had conducted some kind of a trial and further cursed and abused me, based strictly upon personal hatred.

I told the three officials on the occasion as stated by Mr. Watson, that he wished to see them and I was present throughout the discussion with the three officials as above related by Mr. Watson and at no time was there any reference made to a court being in session while he was talking with the three together, neither was there any vindictive spirit displayed by Mr. Watson or any abusive language used.

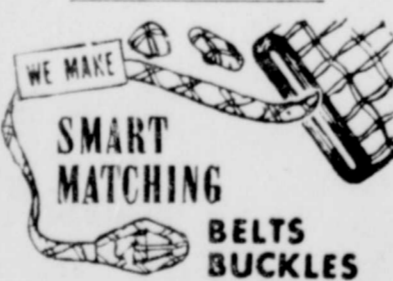

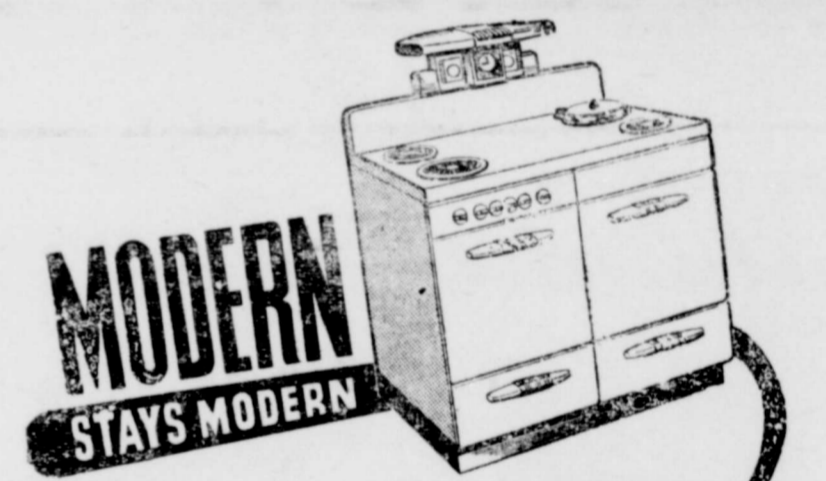
