## Lubbock And Slaton Compromise On Road Project

### Crosbyton 'Old Timer' Takes Own Life With Shotgun

#### Inquest Declares Death From Self Inflicted Wounds

S. F. Grisson Is Instantly Killed After He Shoots Himself In Chest; Leans Gun Against Barrel

#### No Reason Offered

Wife Of Sixty-Year-Old Man Nearby At Time Of Shooting; Was Long-Time Resident Of County

(Special To The Avalanche) CROSBYTON, Nov. 14.—S. F. Grisson, about 60, long-time resident of Crosby county, ended his life here today by shooting himself in the chest with a shotgun. No reason for his act was apparent and an inquest, held following the incident by Justice of the Peace Carter Chase, resulted in a verdict of "death from gunshot wounds, self-inflicted."

Shortly after 5:30 o'clock Mrs. Grisson went to the back yard and bused herself by hanging clothes. Her husband went to the back steps of the Grisson house, located in the northeast part of the city, and leaning upon the barrel of the gun pushed the trigger with a stick. Death was instantaneous as the pellets from the 12 gauge gun tore through his body.

Witness To Death J. G. Brunson, who was digging postholes 50 yards away, turned in the direction of the gun's report and saw Grisson fall to the ground. Mrs. Grisson, although she also heard the report, did not investigate until Brunson called to her.

The Grisson had lived here for more than ten years and Grisson supported himself and his wife by doing odd jobs about the city.

#### Damage Suit Will Be Resumed Today

The case of R. A. Ramey, et al., of El Paso, versus D. E. Braucht, et al., of Houston, in which the plaintiff seeks \$16,000 alleged damages, which was started Thursday in the 99th district court before Judge Clark M. Mullican, will be continued today. The suit grew out of construction of the administration building of Texas Technological college in 1924-25. Ramey, contractor for the construction of the building, charges that he and the defendant entered into a contract whereby the latter was to furnish leaders stone for the exterior work of the structure and alleges that the agreement further stipulated that delivery of the material was to be made January 10, 1925.

#### Good's Condition Is Still Serious

(By Associated Press) WASHINGTON, Nov. 14.—With his wife maintaining a ceaseless vigil near his bedside, Secretary James W. Good continued in a serious condition at Walter Reed hospital in his struggle for recovery from yesterday's sudden operation for acute appendicitis. The present critical stage of his condition will not be passed until probably after tomorrow night in the opinion of his physicians, who include the most expert members of the army medical corps. The doctors reported, however, that he was doing as well as could be expected.

#### TWO MEET DEATH

Seven Others In Hospital For Inhaling Gas NORFOLK, Va., Nov. 14.—(AP)—Lieutenant R. H. Hollenbeck and Boatman's Mate Thomas George Weber lost their lives and seven other men, all members of the crew of the battleship New York, are in a hospital as the result of being overcome by a poisonous gas aboard their ship at the Norfolk navy yard early tonight. Weber lost his life when he went to the rescue of Hollenbeck, one of a party of four who were overcome after entering a blower on the side of the ship.

#### Thirteen Blocks Of Paving Okehed By City Fathers

Contract Will Be Let On November 29 By Lubbock Commission; Widening Of Thirteenth Authorized

#### Report on Health

Few Contagious Diseases In City, Dr. Rollo Says In Report; Dairies Said Satisfactory Here

THIRTEEN additional blocks of paving will be authorized for Lubbock when contract will be let on November 29 by the city commission, following action Thursday afternoon by the body in advertising for bids. Bids also are to be accepted for the widening of 13th street between Avenues K and Q, from 30 feet to 55 feet.

The new paving will include 14th street from Avenue Q to College Avenue and alleys in blocks 131, 148, 149 and north and south alley in block 117. Block 131 is the territory between Broadway and 13th street and Avenues J and K. Block 148 is south of 13th street and between Avenues J and K. Block 149 is south of 13th street and between Texas Avenue and Avenue J while block 117 is between Main and Broadway and Avenues J and K.

Rollo, representative of the city health department, appeared before the commission meeting and reported that only a very few contagious diseases exist in Lubbock and that due precaution has been taken to prevent the spread. #### QUINTUS WATSON DIES

Former State Senator Is Victim Of Illness HOUSTON, Nov. 14.—(AP)—The long career of Quintus W. Watson in Texas legal and legislative circles was ended in his death today. He has been ill several weeks.

The former state senator, whose voice had been heard in the Texas legislature for many years, died here today after a long illness. In his early life he staked his fortune with the fortunes of ranchmen in a section of the state later to become a farming area.

#### Half Thousand Will Give Support To Visiting Team

Among football fans in "The City that Faith Built" came to light at Wichita Falls this week and a special train bearing a half-thousand and enthusiastic Coyote boosters will arrive in this city at 12:30 today for the annual clash between the snarling Pack and the Gold and Black Westerners.

Encouraged by the recent success of the Holton-coached eleven, the Wichita followers will invade Lubbock in full regalia, led by the high school band and pep squad. They will be met at the Denver station by an even larger delegation of Westerner fans, including the local band and pep organization.

To Stage Parade Upon the arrival of the Wichita special the rival forces will join in a parade through the downtown business section with the two bands leading the demonstration. Incoming visitors from Wichita who do not join in the parade will ride uptown in cars provided by the high school and chamber of commerce.

The game starts at 3 o'clock. The chamber of commerce committee and high school officials have arranged to have ample transportation facilities for the Coyote boosters at the Hotel Lubbock at 2 o'clock to take the crowd to Tech field for the game. All cars will be marked. Those who have machines available for this service have been asked to report to Garnett Reeves at the chamber of commerce.

Rivalry between the Westerners and the Coyotes has reached a high peak this season, with both clubs fighting for district honors. Comparative scores give the Lubbock eleven a decided edge over the visitors, but the Coyotes have been decided "in-and-outers" this year.

#### Petitions Will Be Presented Today To Commission Seeking County-Wide Election For Paving Three Highways

Representatives Of Two Cities Get Together On Single Plan For Voting Of \$991,000 In Bonds To Provide Hard-Surfacing Of Highways 7, 9 And 53

PETITIONS will be presented to the Lubbock county commissioners' court at 11 o'clock this morning, asking an election to be called on a county-wide proposal to pave all of highways 7, 9 and 53 through the county.

The amount of the bond issue to provide payment for this program is \$991,000, which includes absorbing \$21,500 in bonds voted by road district number one, necessary by any county-wide bond election. Highway 7 is figured at \$325,000, number 9 at \$247,000 and highway 53 at \$370,500.

Program Result of Compromise. This program is the result of a compromise offered at the hearing before the commissioners' court yesterday and Wednesday on calling an election in road district number two. The compromise was offered by action representatives, and approved at a meeting of the Lubbock County Good Roads association's general committee, of which Charles F. O'Neal is chairman, held last night.

The committee also passed, by unanimous vote, two resolutions, one pledging their support to a future paving program for hard-surfacing state highway 134, from Lubbock to the Hockley county line, whether by a county-wide vote or by separate road district, and further pledging support to paving roads in the eastern part of the county, if they become designated state highways. These other roads include one proposed from Slaton north to intersect 53 near Idalou and one from Idalou up the Denver railroad towards Petersburg.

The second resolution pledged support and assistance to Slaton, Acuff, Becton and Idalou in securing state designation of these highways as soon as possible.

O'Neal, as chairman of the Lubbock committee, and J. H. Brewer, as chairman of the Slaton road committee, signed both resolutions as passed. State Senator Pink Parrish

#### Stock Prices In \$2 To \$20 Rally

Values Hold Gains After Leading Financial Heads Of Country Take Steps To Restore Confidence

FRENOSIL, Associated Press Financial Editor NEW YORK, Nov. 14.—(AP)—Stock prices rallied \$2 to \$20 a share, and held most of their gains today as the country's leading financial authorities took steps to restore public confidence. The stock exchange inquiry into the character and source of recent "short" selling, coupled with the overnight announcement of a proposed cut in federal income taxes, sent "bear" traders scurrying to cover, and attracted a large volume of investment buying by interests awaiting indications of a definite turn in the market. Trading failed to maintain the terrific pace set yesterday. Total sales for the three-hour session ran over 7,000,000 shares.

Rate Reduced After the market closed, the New York Federal Reserve Bank reduced its rediscount rate from 5 to 4 1/2 per cent, foreshadowing a general reduction throughout the Federal Reserve system, and announced a decrease of \$710,000,000 in brokers' loans to \$4,172,000,000, the lowest level since June, 1928.

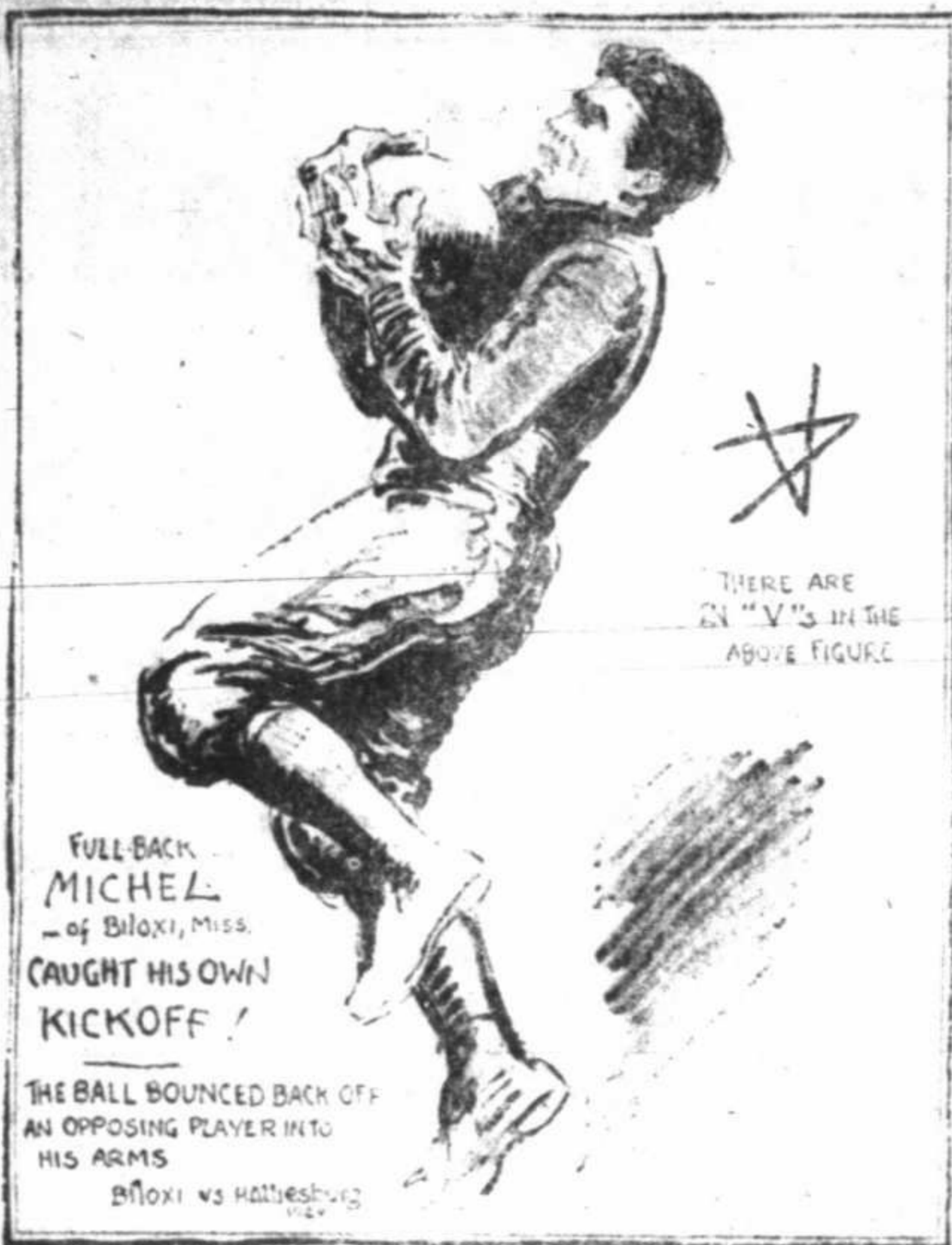

### Congress Urged To Increase Annual Appropriation For Federal Aid Road Projects To \$125,000,000 By Group

American Association Of State Highway Officials Complete Annual Convention At San Antonio

SAN ANTONIO, Nov. 14. (AP)—Congress was urged to increase the appropriation for Federal aid highway projects to \$125,000,000 annually, an increase of \$50,000,000 annually by the American Association of State Highway Officials, completing its annual convention today.

Officers Named. Vice-presidents were chosen as follows: first district, L. D. Barrows, Maine; second district, R. H. Baker, Tennessee; third district, T. H. Cutler, Missouri; and fourth district, J. D. Wood, Idaho. W. W. Mack, of Delaware, was re-elected treasurer and executive committee members were chosen as follows: term expiring 1931, L. H. Went, Oklahoma; term expiring 1932, H. G. Shirley, Virginia; and term expiring 1934, Thomas H. MacDonald, chief of the bureau of public roads, Washington, D. C., and C. M. Babcock, Minnesota.

The next meeting place will be chosen by the executive committee at a session to be held next June. W. C. Markham of Washington, executive secretary, announced increase asked. The Federal Aid increase to \$125,000,000 was asked for the fiscal years 1932 and 1933, while it was requested that the present appropriation for the fiscal year 1931 be raised from \$75,000,000 to \$10,000,000.

The resolution declared that during the past year less than 10 per cent of the funds used in construction of state trunk line highways was contributed by the Federal government and that several

being "unilaterally opposed to privately owned and controlled toll bridges upon state and Federal aid systems of highways." It expressed itself not opposed to "publicly constructed, owned and operated toll bridges where adequate public funds are not available for immediate construction of free bridges needed to complete interstate and intrastate highway systems as planned."

It was suggested that the general bridge law be changed so that all franchises would be effective only on state approval as to location, design, plans and specifications and state supervision of construction and maintenance.

Increase Endorsed. The association endorsed increasing authorization for federal highways for 1931 to \$10,000,000, also proposed legislation increasing the 1932 and 1933 allotments to \$12,500,000 per year.

The executive committee was authorized to appoint a committee on roadside beautification to deal with problems and studies relating to roadside parks, strips of natural timber screen, roadside advertising and beautification. Roadside advertising signs were condemned as distracting.

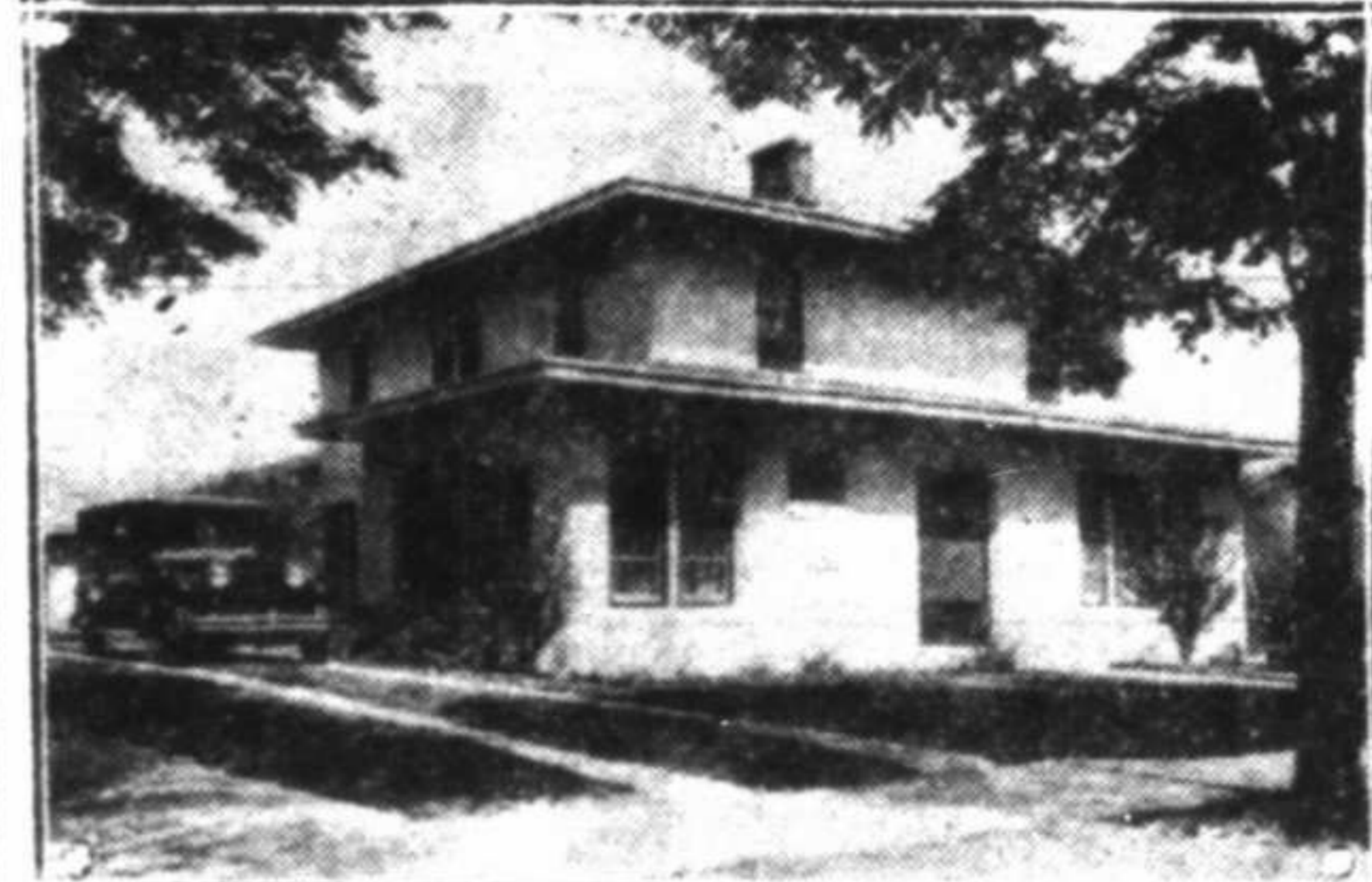

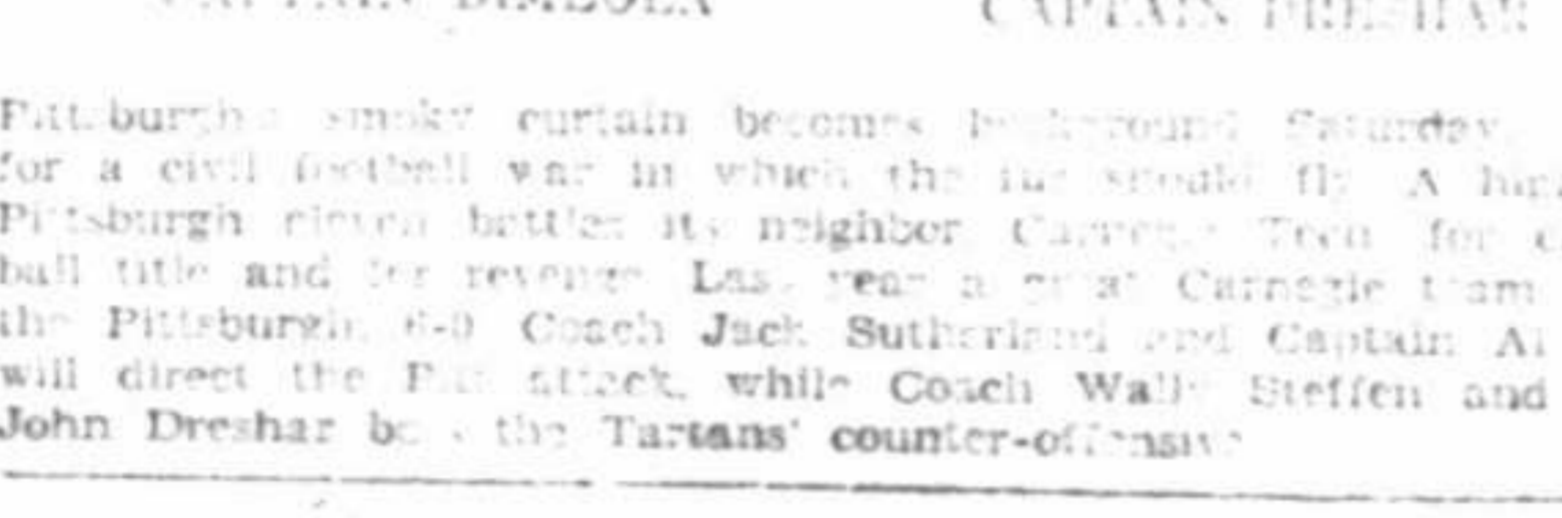

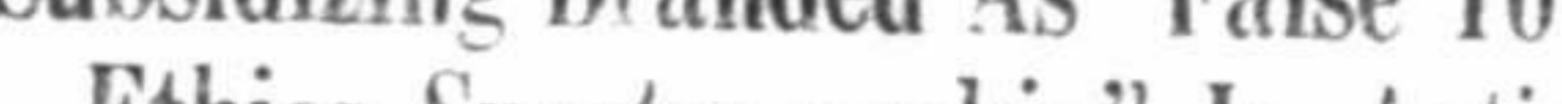

### American Woman's Trial Is Resumed


**Bernice Rush Is First U. S. Woman To Face Charges Of Murder In Mexico; Admits Killing Husband**

### Aldridge, Allen Are Brought Step Nearer To Chair

Motions For Rerhearings Of Their Appeals Denied By Court Of Criminal Appeals At Austin

AUSTIN, Nov. 14. (AP)—Ben Aldridge from Dallas county and E. V. Allen from Eastland county were brought a step nearer the electric chair today when the court of criminal appeals overruled their motions for rerhearings of their appeals. The court already had affirmed the death sentences.

Aldridge and Lee Roy Merriman were alleged to have attacked two young women after stopping an automobile filled with boys and girls returning to their home from a dance. Merriman was sentenced to death, the judgment affirmed and his motion for a rerhearing denied.

#### Alleged Robber

Allen, who was alleged to have robbed the First State Bank of Carbon late in 1927 based his motion for a rerhearing on the grounds of jury misconduct in that the jurors engaged in prayer before reaching a verdict. The court said that the prayer "impresses us with the fact that the jurors were men anxious and desirous of arriving at a fair decision."

Reagan Pettite, sentenced to 15 years on a murder charge from Anderson county, Pettite was alleged to have killed J. W. Abbe last year. The judgment of the trial court was reversed and remanded.

The 30-year murder sentence against Sam Stapleton from Brazoria county, charged with the killing of W. E. Holmes in December.

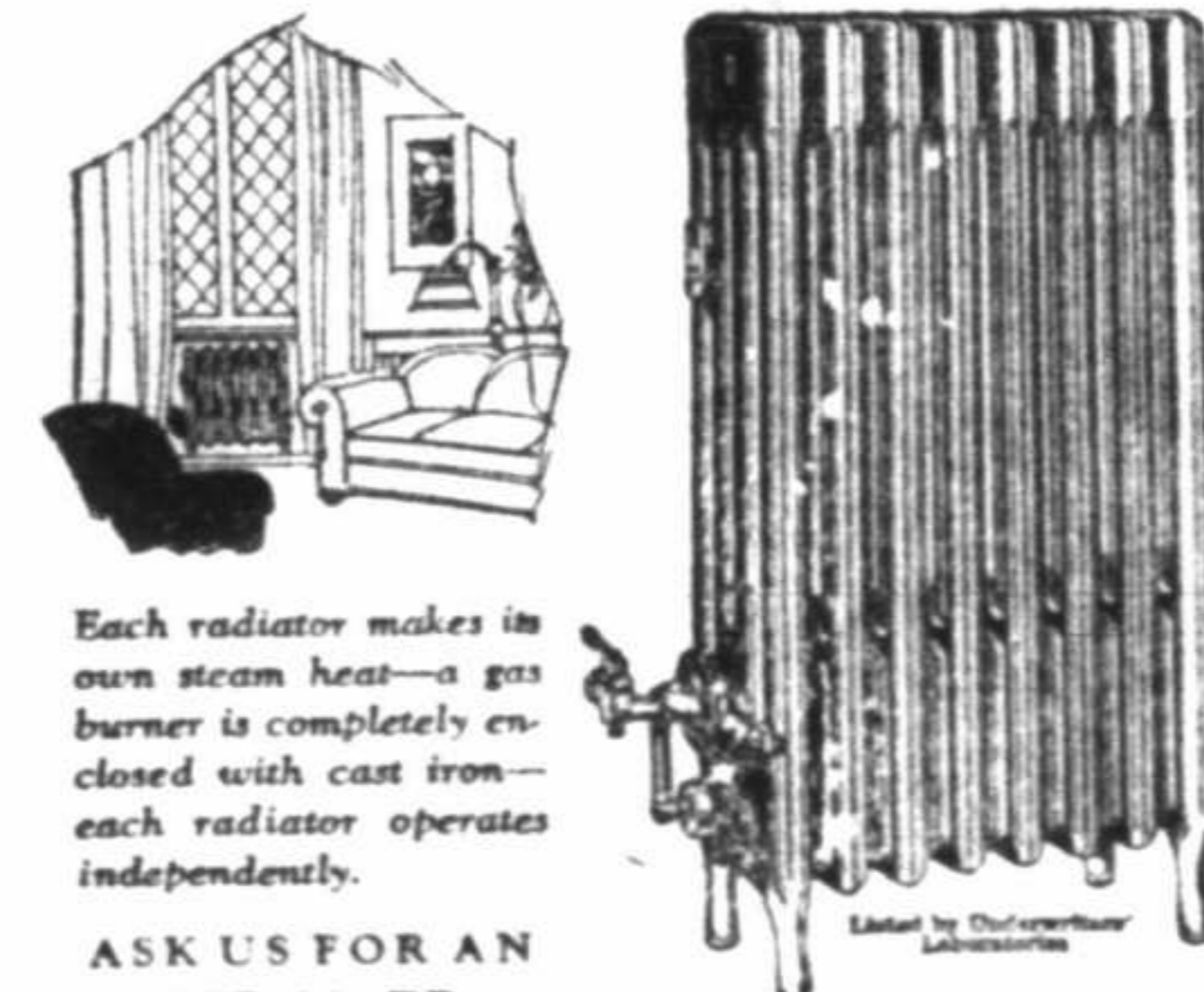

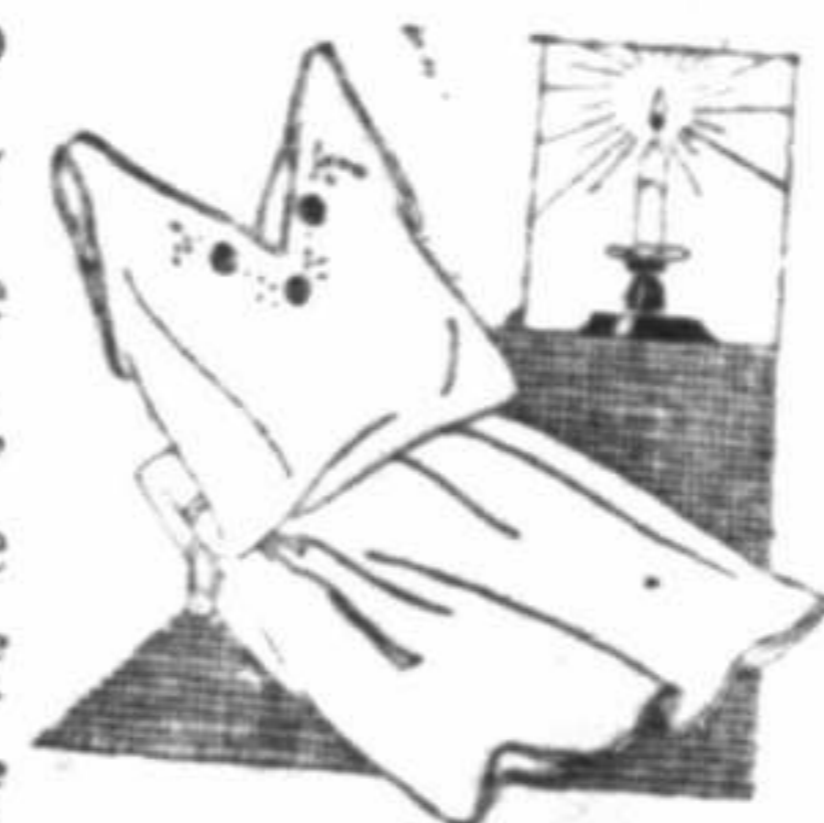
