Bomb kills Arab director

Victim praised

PLO on TV

SANTA ANA, Calif. (AP) — A bomb ripped apart the office of the American Arab Anti-Discrimination Committee on Friday, killing the group's local leader, who on television the night before had called the chairman of the Palestine Liberation Organization "a man of peace."

Seven other people were injured in the blast at the three-story stucco office building. One victim was blown into the street, a witness said.

Authorities evacuated the area and said they feared another bomb might be in the building.

"We've had some type of device explode," Fire Chief William Reimer said.

"As you know, there is no (two-way) radio communications being done at all because of the potential of a device being in there that a radio signal could set off."

Former captives fly back

CAIRO, Egypt (AP) — American passengers of an Italian cruise ship held captive by Palestinian gunmen flew out of Cairo Friday in a special U.S. military charter. Among the homeward-bound victims was the widow of an American invalid, killed during two days of terror on the Mediterranean Sea.

U.S. Embassy officials said the special charter was bound for either Newark, N.J., or New York after a refueling stop at the U.S. Rhein-Main Air Base in Frankfurt, West Germany.

Operations officers at the air base said the plane was due to land at 3:30 a.m. Saturday (10:30 p.m. Friday EDT) and would take off for the United States immediately after refueling. William Cahill, a spokesman for the Newark International Airport, said he had received a memorandum from the Pentagon that the Americans would arrive in New Jersey at 9:45 a.m. Saturday.

Before he left, Frank Hodes of Springfield, N.J. was asked where he and the other passengers were headed. He replied, "Home honey, wherever they take us, USA."

Kennedy renews Texas ties

AUSTIN (AP) — Sen. Edward Kennedy, D-Mass., visited Texas Friday, saying he wanted to see old friends and meet new ones. He also urged revitalization of the oil and gas industry.

Kennedy had no announcements about his political plans in 1988, a presidential election year and one in which his term ends.

He also had little to say about claims by Texas Republicans that Democratic Gov. Mark White longed to join Kennedy on the next

presidential ticket.

"I made light today at our luncheon that Mr. White had indicated he didn't support a Kennedy-White ticket, at least in that order," Kennedy told a news conference after meeting with about 100 politically prominent Texans who paid \$500 a plate for stuffed veal.

Later, Kennedy planned to join White in touring an industrial plant at Houston.

Friday night he was the guest of honor for about 30 people at the

Houston home of former state Democratic Party chairman Billy Goldberg. The cost was \$5,000 a couple.

A spokesman for Kennedy said the proceeds from the two Friday events would go to Kennedy's Senate re-election committee and a fund to help all Democrats in Senate races.

"I have indicated that the least well kept secret of mine is that I'd like to be president some day," Kennedy told reporters, "but we

have only barely gotten away from the last election. At some appropriate time in the future, I will make known my plans for my future."

Those attending the private luncheon included Barnes; State Treasurer Ann Richards; State Land Commissioner Garry Mauro; Texas Supreme Court Justice Raul Gonzalez; Pike Powers, White's former executive assistant; and former U.S. Sen. Ralph Yarborough of Texas.

Ecuadorans sever ties to Nicaragua

QUITO, Ecuador (AP) — Ecuador severed diplomatic relations with Nicaragua Friday, accusing Nicaraguan President Daniel Ortega of "gross, inadmissible attacks on the dignity, sovereignty and independence" of Ecuador.

Foreign Minister Edgar Teran announced the break in relations

with Nicaragua's left-wing Sandinista government Friday night, reading from a two-page declaration.

He said the Nicaraguan ambassador, Oscar Cortes, was informed of the government's decision and told that he and his staff must leave the country.

Recruits dropped because of AIDs

SAN ANTONIO (AP) — Two Lackland Air Force Base recruits whose blood showed signs of exposure to the AIDS virus will be discharged, an Air Force spokesman says.

The two were among 1,682 U.S. Air Force recruits, mostly from Lackland, whose blood was screened at Wilford Hall Air Force Medical Center, said hospital spokesman Cliff Enloe.

Enloe said he could not say if the recruits were men or women. They were not identified.

The two will be discharged from the Air Force within two days, he said.

The screening is part of a nation-

wide effort by the military to screen recruits for the AIDS antibody. If found, the antibody's presence means the individual has been exposed to the AIDS virus.

The antibody in the blood could trigger development of acquired immune deficiency syndrome, a contagious and usually fatal disease.

Experts say the presence of the antibody does not mean the individual has AIDS.

"The two recruits will be medically evaluated and counseled," Enloe said. "Then they will undergo a non-punitive processing and be advised to see a private physician."

Gunman shoots 7 in diner

DETROIT (AP) — A gunman armed with a rifle or sawed-off shotgun opened fire in a McDonald's restaurant crowded with lunch-time patrons Friday, wounding seven teen-agers, none critically, police said.

Police detained a witness in handcuffs but had no suspect in custody, Deputy Police Chief Joseph Areeda said.

"There were seven young people shot in the restaurant," Areeda said. "They were having lunch. Apparently there was an altercation between them and someone else."

"We feel it might be gang-related. We're not sure," he said.

Three of the teen-agers, boys ages 14, 15 and 16, were taken to Oakwood Hospital where they were in stable condition with "open abrasions," said hospital spokeswoman Pat O'Dowd.

She said the wounds didn't appear to be from handguns. "It could be some fragments," she said.

Four people suffering gunshot wounds were taken to Mount Carmel Mercy Hospital in Detroit, said hospital spokeswoman Virginia Calihan. She said they were 14 to 15 years old.

Bob Keyser, McDonald's Corp. spokesman in Hinsdale, Ill., said he had no information or comment about the shooting.

Bank deposits show increase from year ago

Howard County bank deposits through the third quarter of this year increased slightly from third-quarter figures a year ago but decreased slightly from the previous quarter.

Total bank deposits amounted to \$292,327,407 through the third quarter in 1985. This compares with \$298,002,483 tabulated at the end of the second quarter for 1985. A year ago, total bank deposits through the third quarter amounted to \$291,858,269.

Two other local financial institutions also showed third-quarter increases over a year ago. Citizens Federal Credit Union had \$39,684,256 in shares as of Sept. 30, compared with \$38,733,080 last

year. First Federal Savings had \$154,815,000 in third-quarter deposits, compared with \$130,530,000 a year ago.

First National Bank recorded the highest deposit amount through the third quarter with \$151,522,824. State National Bank followed with \$96,675,463. Security State Bank registered \$32,138,120 and Coahoma State Bank registered \$11,991,000.

Second-quarter deposit figures for banks were:

- State National — \$101,121,561
- Security State — \$31,701,955
- Coahoma — \$13,258,829

A year ago, banks registered these deposit figures for the third quarter:

Banks extended their loan totals by nearly \$4 million for the third quarter in comparison to the second quarter. Third-quarter total loans totaled \$141,423,353. Second-quarter loans amounted to \$137,234,272, and a year ago, third-quarter loans reached \$140,816,509.

First National had the highest total of loans with \$60,219,387. State National followed with \$58,583,236. Security State registered \$14,764,730 and Coahoma State registered \$7,856,000.

CIA tie probed

CAMBRIDGE, Mass. — A Harvard professor who said he took \$50,000 from the Central Intelligence Agency to organize a secret campus conference on Islamic fundamentalism is under investigation by university authorities.

Nadav Safran, director of Harvard's Center for Middle Eastern Studies, said he sought and obtained CIA money for the conference, scheduled next week.

A. Michael Spence, dean of the Harvard faculty of arts and sciences, said Wednesday he is investigating the matter.

The Boston Globe reported today that a copy it obtained of a 1982 contract with the CIA revealed that the Egyptian-born Safran also received \$107,430 from the agency to finance the research and writing of his book, "Saudi Arabia, The Ceaseless Quest for Security," published in September by Harvard University Press.

Schroeder going home

LOUISVILLE, Ky. — Artificial heart patient William Schroeder's surgeon has given the green light for him to leave Louisville with his mechanical pump, and his family hopes to have him back home in Jasper, Ind., by Thanksgiving.

"Something could happen tomorrow that would prevent it. But we're definitely looking toward that possibility," his eldest son Mel said.

Dr. William C. DeVries, who implanted Schroeder's compressed air-powered pump Nov. 25, said Schroeder has shown signs he is recovering more rapidly from two series of strokes suffered since the surgery and wants to be reunited with his wife, Margaret.

New smoking risk

SALT LAKE CITY — A previously unidentified pattern of birth defects including mental retardation, abnormal facial features and heart defects may occur in infants of women who smoke two packs of cigarettes or more per day during pregnancy, a researcher says.

Smoking has long been known to produce smaller-than-normal babies. But the new study is the first to suggest the possibility of a consistent pattern of defects comparable to the so-called fetal alcohol syndrome produced by heavy alcohol use during pregnancy, said Dr. Bryan Hall of the University of Kentucky in Lexington.

House for balanced budget, but not Gramm's plan

WASHINGTON (AP) — The autumn epidemic of deficit fever hit the House of Representatives Friday as lawmakers overwhelmingly embraced the spirit but not the specifics of a balanced budget plan passed by the Senate.

The Democratic-controlled House voted 327-50 to begin bargaining with the Senate on legislation to increase the national debt limit above \$2 trillion and an accompanying amendment embraced by President Reagan to revise the federal budget process and place statutory limits on the government's red ink.

In addition, the House voted 354-15 in favor of a procedural motion by House Republican Leader Robert H. Michel of Illinois to instruct the House bargainers to "provide mechanisms for deficit reductions, including specific and mandatory budget goals for achieving a balanced budget within the next six years."

With the negotiations, likely to begin the middle of next week, has come a debate over who has now captured the political high ground on the issue of federal budget deficits.

Senate Majority Leader Robert Dole, R-Kan., said the amendment the Republican-led Senate passed this week has put House Democrats on the defensive and sent them scrambling to catch up.

"It'll have the Democrats over there climbing the wall," Dole said. However, Democrats portrayed the renewed in-

terest in taming budget deficits as a repudiation of the Reagan administration's economic policies.

Rep. Richard A. Gephardt, D-Mo., said the balanced budget plan adopted by the Senate marked "the end of the supply-side Reagan revolution."

During debate before the House votes, Democrats pointed out that the national debt Reagan inherited when he took office in 1981 was \$935.1 billion and now, despite promises to balance the budget by 1984, Congress is now considering legislation that would peg the national debt at \$2.078 trillion.

Republicans said it was decades of free spending that has caused the seemingly incurable problem.

"We are turning our backs on 40 years of failure," Michel said. "For that long — and longer — the Washington establishment, in Congress and in various administrations, has been feeding the habit of deficit spending. We have become the biggest bunch of deficit junkies in the world."

Still others, though, noted that no procedural changes, no matter how sweeping, will make up for a lack of resolve to deal with the problem.

"There is no process that can replace the guts we need to make tough decisions," said Rep. Leon E. Panetta, D-Calif.

Special camps built

JOHANNESBURG, South Africa — An anti-apartheid group said Friday that the white government may have built special camps to hold opponents of the race law system who have been arrested this year under sweeping security laws.

Police headquarters in Pretoria reported rioting in 11 black areas late Thursday and early Friday, and said a patrol killed a black man who ran a roadblock in Soweto. Most of the incidents occurred near Cape Town, Johannesburg and Pretoria.

Headquarters said 4,960 activists had been arrested under a state of emergency imposed July 21 in 36 black districts, and 1,006 still were in custody Friday.

The Detainees' Parents Support Committee said 1,168 people had been picked up since January under other security laws allowing indefinite detention without charge, and 441 still were in jail at the end of September.

Soviets level charges

MOSCOW — The Reagan administration's reaction to the new Soviet arms-control proposal indicates it may be preparing Western public opinion for failure at next month's Geneva summit, a Soviet spokesman said Friday.

"We see it as an attempt by the American administration to gain some ground in the propaganda war," Vladimir A. Morozov, deputy Foreign Ministry spokesman, said in an interview with The Associated Press.

In a related area, both Morozov and influential Moscow commentator Valentin Falin said any U.S.-Soviet agreement on Star Wars would necessarily have to allow basic research.

Search for MIAs

UNITED NATIONS — Vietnam and U.S. officials are considering arrangements for a joint excavation to search for Americans missing in action in an experiment that could be a breakthrough toward resolution of the MIA issue, officials said.

"In principle we are agreeable except in the crash sites where our security cannot permit foreigners to have access," Vo Dong Giang, a Cabinet minister without portfolio and the second-ranking official in the Foreign Ministry, told The Associated Press on Wednesday.

Reagan: Jet incident shouldn't interfere with US-Egypt relations

WASHINGTON (AP) — President Reagan, while saying he disagrees with Egypt's handling of the Achille Lauro hostage crisis, declared Friday he is determined not to allow the incident to interfere with U.S.-Egyptian friendship.

"There is too much at stake with regard to peace in the Middle East for us to let a single incident of one kind or a disagreement of this kind color that relationship," Reagan told reporters. Privately, U.S. officials had expressed outrage Thursday over a statement that morning by Egyptian President Hosni Mubarak that the four Palestinian hijackers of the vessel had already left Egypt even though subsequent events proved they were still in the country.

The officials also said they were distressed at Egypt's decision to allow the Palestinians to leave Egyptian territory despite urgent U.S. appeals that they be kept in Egypt or be turned over to a sovereign government for prosecution.

By Friday, however, with the hijackers safely in Italian custody after the American intercept mission over the Mediterranean, the official indignation over Egypt's role had subsided considerably.

"Obviously, we're not happy with Egypt's performance but we've made our point," said one official, who asked not to be identified.

"Even a husband and wife have good spats ... Now, we have to turn down the flame."

The official ridiculed reports that the U.S. intercept mission that led to the capture of the Palestinians was carried out with Egyptian collaboration. Reagan also maintained that the United States had acted alone.

Reagan clearly was in a mood to

play down U.S. irritation over Egypt's performance. He even praised Egypt for negotiating an end to the hostage-taking without the loss of additional bloodshed, adding almost in passing that he

"disagreed with their disposition of the terrorists." Mubarak said he had learned

The Kopper Kettle is expanding to add a decorating center and home building service and Helen's will expand to include a tanning salon.

The Kopper Kettle's center will include wallpaper, carpet and custom window coverings and will work with area contractors for installation, said owner Roxanne Rich. The building services will help customers build a house, starting with drawing up plans, she said. No time has yet been set for the additional services to open.

The change came about because "we had a lot of people ask us to help decorate their homes," Rich said.

Rich said she and Helen Vaughn, owner of Helen's, designed and

decorated the building into which they moved. "It's something I've always wanted to do," she said. The decorating and home building center will be on the second floor.

The Kopper Kettle is a bed, bath and kitchen store, Rich said, but she is expanding to include more gift items. For the kitchen, the store has 15 different gourmet coffees, many varieties of tea, 23 flavors of gourmet jelly beans and cheese and caramel popcorn.

For the bedroom, it features bedspreads and silk plants as well as other bedroom and bath items.

Helen's is a clothing and shoe store. Owner Helen Vaughn said she moved because she wanted to set her own hours and "not be limited in a lot of ways, if I wanted to expand."

The new tanning salon will be called Bronze Touch, she said, and will have four beds. It should be open in two to three months, she

said, and will have an outside entrance.

Tanning salons are healthier than the sun, she said, because "it's a controlled environment. You do away with burning rays and just have the tanning rays. You take it gradually and build up" a tan.

Vaughn doesn't see the salon as conflicting with her shoe and clothing business. "A lot of our customers love to sun and tan," she said. "It will fit in very well." Helen's carries mainly casual clothing and mostly junior sizes. Vaughn describes her shoes as "a little of everything."

Vaughn has been a shoe salesman since the age of nine. Her father, Travis Denton, owned the Village Shoe Store.

"I tried other jobs and it just didn't work out. That's when I decided to open my own business," several years ago, she said. "I love to see women in business."

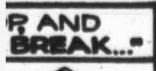

Farmers Market

A few weeks ago, I ran a survey to determine the interest in a Farmers Market in our area through this news column and a producers' mailout. This same survey was made in each county in the Permian Basin area.

Last week all respondents to this survey were notified of a meeting in Midland at which time such a market was discussed. Interests appear high for such a market to serve our area. Each county is to have an elected representative to serve on a board of directors to coordinate the market. Howard County will hold such a meeting on Monday night, Oct. 21, at 7 p.m. in the County Extension Office (located in the basement) of the Courthouse in Big Spring. All interested parties are invited to attend.

Rules and regulations of the Farmers Market have been developed and are as follows:

Permian Basin Farmers Market Rules and Regulations

Use of the Market: Members of the Permian Basin Farmers Market Association (PBFMA) will receive first priority for space. Non-members, other agricultural producers and non-producers (peddlers) will be allowed to reserve space in the market if available and upon meeting all applicable quality criteria.

Products to be Sold: Agricultural produce such as vegetables, fruit, nuts, honey, eggs and ornamental plants grown in Texas. Meats, poultry and fish must be Texas produced. Vendors shall be responsible for meeting all county and state health regulations for all agricultural products sold.

Quality Control: All produce will be inspected by the Market Manager prior to display and sale. All produce must be fresh and grown in Texas. Sellers will be asked to give refunds to consumers that are dissatisfied with products they have purchased at the Farmers Market.

Hours of Operation: 10 a.m. to 3

p.m., Saturdays will be primary hours of operation. An additional market may be scheduled on Sunday from 2 p.m. to 5 p.m. if quantity of produce warrants an added day.

Assignment of Stalls: Stalls will be assigned to Permian Basin Farmers Market Association members calling the Market Manager before 1 p.m. on the Thursday before the Market. Reservations may be made up to one week in advance. Spaces not reserved by Association members may be reserved between 2-5 p.m. on the Friday before the market by non-members, agricultural producers and non-producers meeting market regulations. Stall reservations will be held until one half hour before the Market opens. Any stall vacated by 12 noon may be purchased by an Association member at the regular daily rate.

Stall Fees: Fees are \$10 per day for PBFMA members. Fees are \$20 per day for others meeting Market regulations.

Sanitary Condition of Sales Area: Each seller will be responsible for keeping the Market area clean. Failure to clean stall with require future stall rental approval by PBFMA Board of Directors.

Inspection of Weighing and Measuring Devices: All scales used at the Market must be inspected and certified by the Texas Department of Agriculture.

Parking: Only vehicles containing produce will be parked at Market stalls.

Adult sitters

Another Adult Sitter Clinic will be held from 9 a.m. to 3:30 p.m. Monday through Thursday, October 21-24 at Westside Community Center.

The clinic is being conducted to provide skills and knowledge that will qualify persons to be effective sitters.

The clinic is sponsored by the Extension Home Economics Committee, Texas Agricultural Extension Service and Westside Community Center.

Cost of the clinic is \$6 per person for books and supplies. Contact the County Extension Office to register. (Phone 267-8469 or come by the office located in the Courthouse basement). Participants need to bring their lunch each day. Coffee, tea and dessert will be provided.

Choosing a Sitter

As a result of publicity about Adult Sitter Clinics, several persons have contacted the Extension Office for names of trained sitters. The Extension Service does not release names of program participants and cannot serve as an employment agency. Names and a brief resume of each person trained in the Adult Sitter Clinic who desired to work as a sitter were provided to local hospitals, nursing homes, home health care agencies and the Texas Employment Commission.

Since matching the sitter to the patient and situation requires thinking through the patient's needs and yours and the sitter's concerns, here are some ideas to consider before interviewing and hiring someone.

The sitter needs to know:

- Patient's age
- Special problems (i.e. diabetic, Alzheimer's, Parkinson, need for sitter to lift patient, incontinence, or need help with bowel and bladder care).
- Patient's personality and behavior (Examples) Likes: Card

games, hobbies, riding in a car, eating out. Dislikes: Taking medication, loud noise, T.V., bright light. Impatient, fearful, demanding, withdrawn.

- Do they need to wear a uniform

- What emergencies might occur and who to call

- Any allergies
- Where and how will they have lunch (bring their own, eat with patient...)

- How to handle medications

- Who will be relaying instructions (we tell sitters to take instructions from one person only... family members may not agree and sitter is in the middle).

- How to use special equipment such as lifts, etc.

- How often they will be paid

Be clear about your concerns or expectations (Examples):

- How much you pay
- Hours/time required
- House rules: smoking, having visitors, use of telephone

- Being on time
- Changing bed with patient in it
- Giving baths or bed baths
- Keeping patient's room neat
- Moving patient from bed to wheelchair
- Following directions carefully
- Keeping a log of daily activity/observation of patient
- Preparing simple foods
- Laundering patient's bedding and clothing
- Does sitter have a substitute to help if sitter is ill, etc.
- References from other jobs
- Daily exercise (Passive bed exercising of joints or active — such as walking — how long?)

Plan to discuss patient and/or concerns with sitter at regular intervals or at least once a week. Ask sitter about problems, listen to what sitter says. Don't let misunderstandings accumulate.

Consider a trial period of employment then sit down with the sitter and evaluate the situation.

Cooper Cougs drop Steers, 27-15

Big Spring's fumbles costly errors

The Abilene Cooper Cougars took advantage of four Big Spring Steer fumbles, scored all their points in the second half and went on to down the Steers 27-15 last night at Memorial Stadium.

Led by the one-two punch of tailback David Nowlin and quarterback Bill Dehlinger, the punchless Cougars offense came to life in the second half, thanks to two costly Steer fumbles.

At the time of the fumbles, the Cougars trailed 7-0, after being stopped cold by the Steer defense in the first half.

The first costly fumble came midway in the third period. It followed a 30-yard punt by Dehlinger that rolled out at the Big Spring 2-yard line.

Facing a third and 11 from their own one, Big Spring's Jimmy Rogers burst up the middle for 18 yards. But he fumbled when he was hit and the Cougars recovered at the 19.

On the second play Dehlinger, who was under heavy pressure from the Steer front line all night, rolled to his left away from the rush and threw back right to a wide open Nowlin. Nowlin caught the ball at the 10 and stided into the endzone.

A fake two-point conversion pass was no good, leaving the Steers with a slim 7-6 lead with 4:43 left in the third period.

On the ensuing kickoff, bad luck again struck the Steers as Jose Hilario fumbled the ball and Cooper recovered at the Steers 28.

On the next play Dehlinger hit Nowlin on a crossing pattern for the score. Dehlinger added the point-after-touchdown and all of a sudden, the Cougars had two touchdowns within 25 seconds.

That was all the momentum the Cougars needed as Dehlinger and the Cougs' Wing-T offense begin to roll.

"The third quarter is definitely what hurt us," said a disappointed Steers coach Quinn Eudy. "We make a good play at the goal line and fumble. Then we give them the ball right back. They didn't have to drive very far for their scores. In essence, our defense was on the field 10 of the 12 minutes in the quarter."

Moving the ball was something the Cougars failed to do in the first half. The Big Spring defense, led by tackles Jay Burchum and Luis Puga, along with teammates Mike Cahill, Deeg Young, Charles White and Stacy Kilgore, gave up yards grudgingly.

In the first 24 minutes of play, the Cougar offense was confined to only 80 yards and four first downs. They crossed midfield only once in the period.

Meanwhile, the Steers offense rolled with authority in the first half, as throughout the game, indicated by their 400 yards total offense. The only blemish was two penetrations deep into Cooper territory in which they came up empty-handed. One drive ended with a missed 21-yard field goal by Colin Carrol. The second time came late in the second quarter on a fumble by tight end David

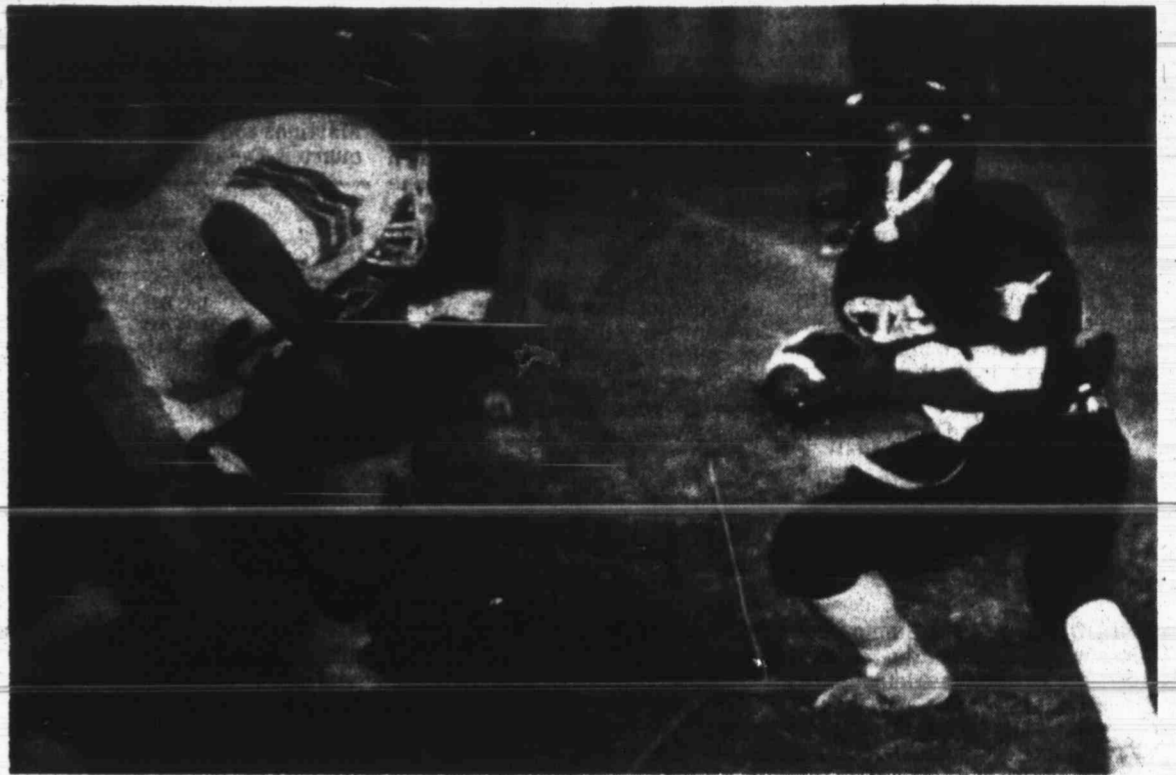
Shortes at the Cooper 27.

"If we had scored on those two times, we would have been in great shape. We didn't take advantage of our scoring chances," said Eudy.

The Steers opened the game with a bang as they scored on their first possession. Following a Cooper punt, the Steers moved 82 yards in only four plays. The first good gainer was a 12-yard option keeper by quarterback Speck. The final big play was a 56-yard run by junior running back Phillip Matthews.

COLORADO CITY — Coahoma head coach Bruce Mitchell came into Friday night's game against Colorado City fearing the big play. The fear proved to be well-founded as the Wolves used two long, second-half touchdown runs by Sammy Rivera and an aggressive defense to whitewash the Bulldogs 20-0 at Wolf Stadium.

The Colorado City backfield pair of Rivera and quarterback Mike Ligon proved to be the difference in the game that was a low-scoring, defensive struggle through the third quarter.

Brett helped make it 2-0 in the fourth, and two fine plays by Barfield in right kept the Royals from getting more.

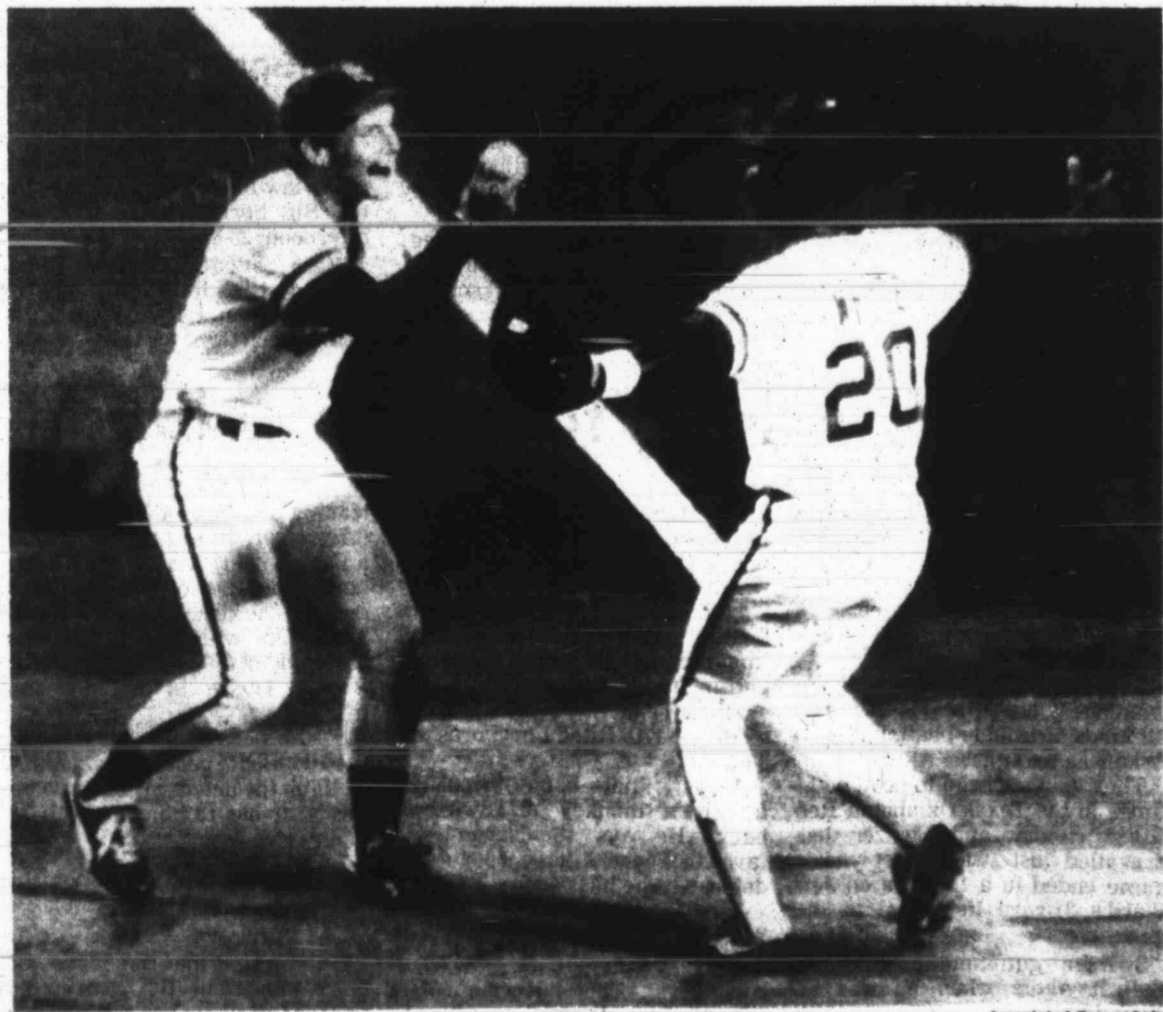

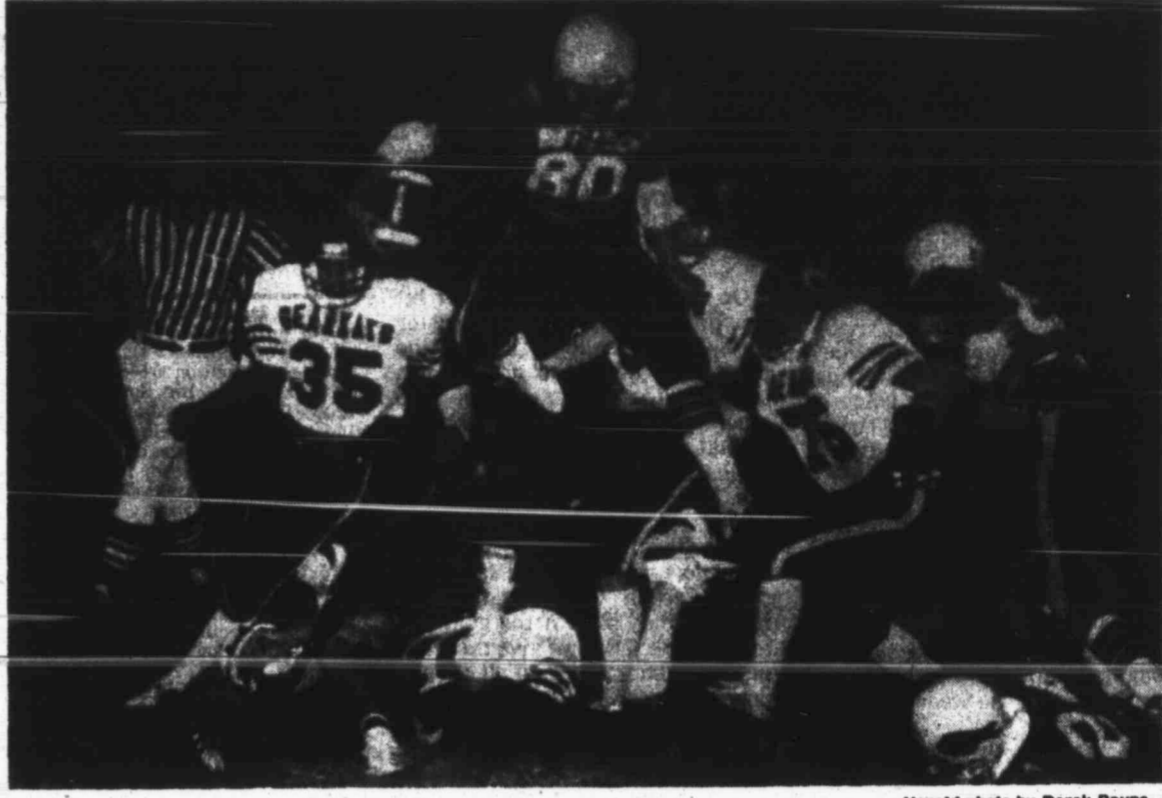

DALLAS (AP) — In 12 years at Oklahoma, Coach Barry Switzer has lost only 23 games.

It comes as no comfort to Sooner fans that five of the losses have been at the hands of Texas Coach Fred Akers.

Switzer, collegiate football's winningest coach at 117-23-4, has all kinds of trouble beating his old Arkansas teammate, Akers.

They've gone head-to-head eight times in the Texas-Oklahoma Red River rivalry and Switzer has prevailed just twice. Last year's game ended in a 15-15 tie on Jeff Ward's 31-yard field goal at the gun.

Switzer got another victory against Akers when he was at Wyoming.

"I always enjoy seeing Barry," said Akers. "I've got a lot of respect for him. It seems like a

long time ago when we were Razorbacks."

The rivalry between the two is warm but intense.

"I like beating Barry and he likes beating me," said Akers. "I can't imagine any player or coach not getting up for this game."

No. 2 ranked Oklahoma is 2-0 while the 17th-rated Longhorns are 3-0.

Akers is quite happy to put the favorite's monkey on Switzer's back. He says the seven-point favorite Sooners have as good a defense as he has seen.

"I think they are the No. 1 team in the country and that should say enough of what I think of them," said Akers. "They have the usual amount of speed that they have and just a great defense."

Saturday's 80th meeting between the two old rivals finds Texas

leading the series 47-28-4.
