FUNERALS OF TWO VICTIMS HELD SUNDAY

SEPARATE SERVICES ARE HELD FOR DOUBLE TRAGEDY COUPLE

Separate funeral services were held Sunday afternoon for Walter Simmons, 24, and his wife, Juanita, 19, whose lives ended tragically Saturday afternoon at 12:10 o'clock, when the husband, melancholy after a week's separation, shot and killed his wife of three years and then turned the gun on himself.

Final rites for Simmons, until recently a member of the Lubbock police force, were conducted yesterday afternoon at 2:30 o'clock at the 19th Street Baptist church, Rev. C. J. McCarty officiating. Burial was in Lubbock cemetery.

Sent To Dimmitt

The body of Mrs. Simmons was sent yesterday morning to Dimmitt, where services were conducted at 1:30 o'clock in the afternoon, and where the two were married three years ago.

Hundreds of friends and acquaintances of the former policeman filled all seats of the church building at the services.

13 SHOPPING DAYS TILL CHRISTMAS

MECHANICAL TOYS ALWAYS ARE THE WIND-UP OF CHRISTMAS SHOPPING.

HONGKONG, Dec. 9.—Twelve persons were killed, about 60 native passengers drowned and 40 or more wounded last night when a swarm of Chinese Pirates fought with the crew of the British steamship Heilung for its possession.

Three American women were witnesses to the bloody conflict and spent hours of the night aboard the ship before British destroyers, the *Sterling* and the *Sirdar*, came to its aid. Much of the super-structure of the vessel was burned. It finally made port here from Swatow.

Ship As Passengers

The Heilung was left Swatow for Hongkong Saturday with 300 passengers, including an Englishman and three American women. Early Sunday 50 or 60 pirates who had shipped as passengers sprang upon the decks with terrifying yells and attempted to seize the ship.

They first stormed the bridge, firing revolvers. One of their shots killed Third Officer Woodward. The bridge was protected by barbed

STATE OPENS REBUTTAL IN TRIAL TODAY

FORMER DUBLIN MEN DECLARE MAN HAD APPEARED SANE

Two peace officers who have known Clay Lester since his childhood testified this morning that the alleged wife slayer has, so far as their observations are concerned, always appeared normally minded, as the State rebuttal testimony opened in the trial in 99th district court.

The defense rested this morning at 11 o'clock, shortly after Judge Clark M. Mulliken had recessed court to allow attorneys of both counsels to make arrangements as to settings of their cases now docketed in the Lubbock division of federal court, which convened this morning, with Judge W. NEW PASTOR IS SELECTED

BAPTISTS NAME DR. R. G. LEE HERE; WILL VISIT CITY

Dr. R. G. Lee, pastor of the Bellevue Baptist church of Memphis, Tenn., has been unanimously elected to succeed Dr. W. R. White, who recently resigned as pastor of the First Baptist church of this city to accept a position as state secretary of the Baptist board of Texas. The election took place at the regular church service Sunday evening following a recommendation from the board of deacons presented by Judge John L. Ratliff, chairman.

Dr. Lee was telegraphed immediately after his election and was invited to pay a visit to the church in the near future.

Called Outstanding Man

J. D. Carroll, educational director, made the following statement this morning: "Dr. Lee is an outstanding preacher among southern Baptists. It is said that he can quote more science and literature from the platform than any other preacher of the Baptist denomination."

"In addition to being an unusual speaker, Dr. Lee is an author of no small note, two of his most recent books being 'Lord I Believe' and 'Feet to Fathoms.' He is a regular contributor to nearly all of the Baptist periodicals."

"Dr. Lee is former pastor of the First Baptist church of New Orleans, La., and of the First Baptist church of Charleston, S. C. He is about 45 years old."

COTTON CROP REPORT GIVES LOWER TOTAL

ESTIMATE PRODUCTION OF 14,919,000 BALES GIVEN TODAY

(By Associated Press)
WASHINGTON, Dec. 9.—An estimated production of 14,919,000 bales of cotton of 500 pounds gross weight was shown by the department of agriculture report today on the basis of December 1 indications, compared with a forecast of 15,000,000 bales made a month ago, and 14,478,000 bales produced last year. Indicated yield of lint cotton per acre is placed at 155.3 pounds per acre, compared with 152.9 pounds last year.

Abandonment of Acreage

Abandonment of acreage since July was shown as 3.3 per cent of the acreage planted, leaving 45,981,000 acres for harvest.

FREDERICK WARDE, VETERAN ACTOR, IN LUBBOCK FOR LECTURE AT COLLEGE

With more than 62 years of his life spent upon the stage, Frederick Warde, tragedian, lecturer, world-traveler, author, while of hair, sprightly of step, intensely spirited of eye, is in Lubbock today for a lecture at Texas Technological college tonight.

At the age of 17, upon the date of September 4, 1867, to be exact, Frederick Warde first stepped upon the boards in London, his Bloombury days preceding those of George Arliss by a number of years. He is now 79 years of age.

Born in 1851

"I was born February 23, 1851," he said, "as days stand accursed on the calendar. And it appears that today I am very much alone of my conferees. Otis Skinner and Walter Hampden are of a younger generation."

SHAKOPEE, Minn., Dec. 9. (P)—Three bank bandits were shot and probably fatally wounded today when police officers, lying in wait for them, opened fire with a machine gun as the robbers left the First National bank here.

Working on a tip from the protective department of the Minnesota Bankers association that the bank would be robbed, the officers had maintained a watch at the bank for several days. The robbers were permitted to enter the bank and were preparing to drive away with \$15,000 when the officers opened fire.

HOOVER GIVES ORDERS TODAY FOR ACTION

APPROVAL OF SENATE IS ONLY BARRIER TO MEMBERSHIP

(By Associated Press)
GENEVA, Switzerland, Dec. 9.—Jay Pierrepoint Moffat, American charge d'Affaires at Berne, today signed in behalf of the United States government the protocol for adhesion of the United States to the World court.

WASHINGTON, Dec. 9. (P)—America today stood upon the threshold of the world court with the statutes of that famous tribunal revised to facilitate her entry.

By the authority of President Hoover, a diplomatic representative of the Washington government was directed to sign at Geneva a protocol of adherence on behalf of the United States.

Senate Approval Needed

The next step, and the one which will carry the Washington government formally into the permanent court of International Justice, will be ratification by the senate, which approved such a step in 1925, but with reservations of such a nature as to lead other nations affiliated with the court to refuse to admit the United States under the conditions stipulated.

Since then, however, a revision of the statutes under which the court operates has been effected, designed to obviate the difficulties which the senate three years ago saw as standing in the way of American adherence.

The senate at that time stipulated five reservations, of which four were acceptable to other nations. The one and the one to which they could not agree, set forth that the court should not without the consent of the United States entertain a

Dr. B. L. Lockett Tells Of Improved Conditions In Africa

Address By Medical Missionary Is Under Auspices Of Baptist Women

"Almost unbelievable changes have taken place during the decade in the living conditions of the people of Africa," said Dr. B. L. Lockett, returned medical missionary from Nigeria, in a lecture Sunday afternoon at the First Baptist church. The lecture was under the auspices of the Woman's Missionary society of the church, and at the close of the address, various persons in the audience subscribed \$700 for the upkeep of native school boys in the Baptist school at Abokuta.

"The uncivilized state existing 17 years ago, for example, Dr. Lockett continued, may be illustrated in the treatment of leprosy. I was riding about the city of Oyo, when I saw an aged white-haired man just outside the wall of the city. He wore no clothes, and his toes and fingers were gone. His home was in a thicket of bushes. Leprosy was considered incurable, and those having the disease were not given so much as a decent burial.

But such a condition is largely a thing of the past. Two years ago a 16 year old student came to me, and upon examination it was found that he had leprosy. This boy was intelligently treated and in a short time was cured of the terrible disease and was able to resume his studies. This is Christianity. Jesus healed, and we should not ignore this part of the gospel.

"Another example of the progress being made in Africa is the Baptist girls' school at Abokuta. Sixteen years ago, girls who entered the school wore practically no clothes and had no conception of civilization. Today they are as reverent in a religious service as the most select group which can be found in America. In the school they are taught academic work through the eighth grade, and are given instruction in Bible and in household duties.

Women's Work

"Baptist women of the city have a well-organized Woman's Missionary Union, and are conscientious workers. They carry the gospel of cleanliness, usefulness and Christianity to nearby towns.

"Former lack of civilization is further illustrated in death of the king of the Yoruba tribe 18 years ago. He had always been the custom that the head of a king, along with many other possessions, be buried with him. One of our Baptist missionaries pleaded with the king that this custom be abolished, explaining that his mother with the head died. Natives have been taught for their mothers, and the king finally dared to abolish the ancient custom. Here again we see the result of Christianity.

Reverent People

"Never have I seen a more reverent people than the African Christians are today. On one occasion, a native carried several miles in order to be baptized. About this same time, I read where a man was rolling a peanut with his nose from one Texas town to another in order to pay an election bet.

"I thought of how much time was wasted by Americans—how many of them were rolling peanuts. They are doing things every day which show they are ignorant to both health and happiness. Why do they not spend this time in service, perhaps in helping these poor Africans?

"As you are providing for your loved ones this Christmas, consider those things which will bring the sweetest joy and lasting satisfaction. Ask yourself the question, 'Have I been faithful as a steward?' and helped to carry the gospel near and far."

DIRECTOIRE INFLUENCE IS SEEN IN RECENT MODE

In some of the more recent importations from Paris, especially in the evening or group for formal wear, we find the waistline raised so very high, and the skirts so long, that it reminds one of the era when women were daring enough to leave off their hoop skirts and crinolines for the long, flowing gowns that caress the figure with the waistline marked by a girdle just under the bust.

In fact, not a few of the buyers and stylists returning from Paris, see a trend toward the directoire period in the new models. It is not quite back to the empire days, but the intricate manipulations, involved cuts, fittings, points, shirings and crossed bandings that give the flat waistline effect in front, do bring the lines up under the bust.

There is one thing to be said about the raised waistline, and that one thing is rather important. It does give a youthful silhouette which offsets the more mature long skirt. It certainly looks as though waistline would go higher and skirts drop lower before there is any lengthening of the one and shortening of the other. Some of the later model evening skirts in the Paris openings were but five inches from the floor, just the length our rainy day sisters had such a fuss about when skirts touched the ground in their effort to shorten them a quarter of a century ago!

Fitted Lines Favored

Since "girls will be their own sweet selves, and no longer boys, the fitted lines are gaining favor. Everything is now fitted, from the top of the head to the toes of the feet. Curves are once more curves and not straight lines. Shoes are simpler, but daintier than ever before, and kid is most generally used because it gives the glove-like fit in keeping with the snug hipline and close-fitted body lines of the silhouette.

The empire or directoire influence will be noted in the evening model sketched at the left. Here the waistline is not only raised to slightly above normal, but the soft bodice, with its molded bust lines and crossed front coming well up under the bust, as well as the long flowing skirt, show the directoire influence. The gown is of transparent velvet in one of the lighter dahlia shades, and is worn with kid pumps of the same color.

In the center sketch is shown an afternoon frock of navy blue crepe, as worn by Elsie Ferguson in her recent Broadway success. Here, too, the higher waistline is featured in a princess model with bolero treatment, which gives the effect of the under the bust line. The bolero, itself, however, would mark the Spanish influence which is strong in this season, both in silhouette and colors. Blue kid pumps with the self leather bow replacing the buckle, are worn with this frock.

Still another model showing the directoire influence is shown at the right of the sketch. Here the manipulation of the bodice gives the flat front and the raised line coming under the bust. The frock is of brown cloth, and a leather belt, felt hat and kid shoes in darker brown accompany the costume. The bow at the neckline is also in the darker shade of brown.

STORMS SPREAD DEATH AND DESTRUCTION IN BRITISH ISLES AREA

DEATH TOLL OVER SCORE; SHIPS SINK

MORE THAN 50 SHIPS NEEDING AID, RADIO REPORTS SAY

(By Associated Press)
LONDON, Dec. 9.—Winds of hurricane force still swept across the British Isles today leaving death and destruction on lake and sea in their wake. There were indications there would be no cessation for many hours. The week-end was the wildest in the history of British weather bureau records.

Night steamship services were suspended, all airplane service stopped and the hotels at ports were crowded with passengers waiting to cross the continent. Wireless distress signals from the seas told of more than 50 vessels in dire need. Estimates of loss of life ran into scores.

Steamer in Distress
The Cunard steamer *Albatross*, from New York, went out of its course to assist the steamer *Tylenbridge*, in distress in the channel 24 miles west of Bishop's Rock. Its radio said the steering gear was disabled, and three men were injured.

The British steamer *Britannic* went ashore between Limerick Head and Saint Gowan's, Pembroke, Wales. A lifeboat from Milford Haven reached it, and on its return reported the ship was in no danger of breaking.

Man Is Lost
The *Homeric* arrived from New York 20 hours late, with reports of a strenuous two days at sea in which waves smashed windows on the promenade deck, 60 feet above the main deck.

The American liner *President Roosevelt*, from New York, reached Plymouth, after battling wind exceeding 100 miles an hour. George Stoffer, German, was lost overboard, but it was believed his sight had been a suicide.

Two members of the crew of the destroyer *Walpole* were washed overboard and drowned. Lieutenant Gibbs aboard the ship was injured, and the destroyer itself was forced back into Portsmouth. The Italian cargo boat *Alfri* sank about 100 miles off Bordeaux, with six of its crew drowning.

Bad Bad List
The Blue Star liner *Andalucia* arrived at Plymouth with some of its passengers cut by flying glass sent through the air when mountainous seas struck the ship while they were at dinner. Some said the ship at times had a list of 40 degrees, and they expected it to sink.

Other ships reporting varying degrees of distress were the Danish cargo boat *Helen*, whose first mate and a sailor were swept overboard; the Spanish freighter *Gaidames* aground outside Brest Roads with two of crew drowned; the British ship *Essex Heath*, waterlogged and reported sinking between Ushant and Brest.

The three masted schooner *Notre Dame De Bonne Nouvelle* and the schooner *Berthe* foundered near Ushant Light, but the crews were saved. The German steamer *Kellwald* put into Plymouth for repairs.

The Greek steamer *Georgias P.*, the Japanese steamer *Tasmanian Transport*, the Wilson line steamer *Carolo*, the British liner *Valencia*, and the steamer *Laristan*, whose captain's leg was broken, also had difficulties.

Paintings Aboard
The Italian steamer *Leonardo Da Vinci* reported by radio it was still fighting the furious storms and had hopes of riding it out without mishap. The ship has paintings valued at 14,000,000 pounds aboard, bringing them here for an exhibition. The pictures had not been damaged at the time of the report.

Wind and rain were not the only aspects of the hurricane. Large inland areas suffered severely from floods. Many square miles of the rural districts were under water, with about 250 homes isolated in Somerset alone and reached only by boat. Railroad traffic was hampered seriously. Hundreds of roads were blocked by fallen trees.

Nelson's half opened parachute was trailing from his back. He is believed to have crashed during a blizzard en route from Bellin, Pa., to Cleveland. BRUNSWICK, Me., Dec. 9.—Togo is dead. The big, shaggy Siberian husky that four years ago raced across the Alaskan wastes at the head of a dog team with serum for the diphtheria stricken inhabitants of Nome, went painlessly across the big divide to the dogs' valhalla.

Grown too old and too slow for the trail, Togo, two years ago, was given to Mrs. E. P. Ricker, Jr., of Poland Springs, Maine, by Leonard Seppala, his master, who had given credit to Togo for leading him safely across miles of frozen snow to Nome on their memorable dash.

Mrs. Ricker, wishing to have Togo's splendid body preserved while he was still alert of ear and poise and before he had become subject to the pains of aged dogdom, decided to have him painlessly put to death and his body given to the Peabody Museum at New Haven, Conn., for mounting.

Thursday Ralph Morrill, taxidermist of the Peabody Museum, called at Poland Spring, got Togo and brought him here, where, assisted by a veterinarian

he put the 16-year-old dog to sleep. Today his body was taken to New Haven.

EDGE SAILS FOR FRANCE
NEW YORK, Dec. 9.—(AP)—Former Senator Walter E. Edge, of New Jersey, newly appointed ambassador to France has sailed on the liner *De France* for Paris. He was accompanied by Mrs. Edge and their children.

Two Liners Collide In New York Harbor

NEW YORK, Dec. 9.—(AP)—A heavy fog which shrouded New York harbor, delaying all shipping, resulted in the collision of two out-bound ocean liners today—the anchor liner *Transylvania* and the Southern Pacific *Creole*. They came together while just off the battery and were forced to return to their piers for repairs.

No one was injured. The *Creole*, bound for New Orleans, had 69 passengers aboard and the *Transylvania*, Europe bound, carried 309 on its passenger list.

Both liners were proceeding slowly down the river. Captain David Bone of the *Transylvania* said the collision occurred when the *Transylvania* turned to avoid two tug which loomed out of the fog bound up the river. A hole three feet in diameter was torn in one of the *Transylvania's* plates just below the deck and several feet of railing was twisted, as the ships scraped sides.

WESTERNERS GUNNING FOR UNOFFICIAL HONORS IN STATE RACE

IN THE REALM OF SPORTS

Just a few more days of shouting, and the curtain will drop. It will all be over for 1929 and another memorable page will be written in the grand old football ledger.

Grid fans of Lubbock and vicinity have one more big attraction to wait for, and that won't be long. The invasion of the Cleburne Yellow Jackets this week marks a new era in Western football competition. Hereafter for the most part, Lubbock has stayed within its own district and section in searching for gridiron opposition. Friday, the Franks-Morgan crew is facing the team that is recognized by all as one of the state's outstanding, and by many as the club that missed the state title by one point. That of course, happened when the Yellow Jackets lost a 7-6 decision to the Waco Tigers.

The Jackets have already established themselves as favorites in the contest Friday, despite the fact that Coach Parker is bringing his crew more than 300 miles for the skirmish. It has been generally agreed that the game is further advanced in Central and East Texas, but in recent years, the teams in West Texas have come to the front with alarming speed. Cleburne apparently holds the edge over Lubbock in the matter of outstanding performers, but we will wager our hard-earned cash that there's not a team in the state that is better drilled and that has better team co-ordination than our own Westerners. No team this year has been able to count more than one touchdown against the Westerners; this sort of looks like Lubbock has a defensive club in addition to a scoring machine, and the boys who are free with the "points" had better watch their step.

New we come to the semi-finals of the state race, with four powerful teams arrayed against the other. The Buckner and Breckenridge High were plenty lucky in getting the Waco Tigers away from the Cotton Palace gridiron in Waco. By winning the toss, the Old Belt champs and conquerors of the Amarillo Saddle will meet the Tyson Tigers at Breckenridge and the little independent gives Shorewell's crew a decided advantage. Playing at Waco, it would be on the order of a toss-up.

Port Arthur's surprising 15-12 triumph over the Brownsville Eagles is the prize shock of the year. Tossed to the sky as a sure finalist in the state race, the club from the extreme point in the state hit a rock, and how! Its two-touchdown lead was worth a yell, but after the Yellow Jackets got organized and scored their brace of counters and kicked one point after touchdown. It was just another case of thorough scouting on one side and too much overconfidence on the other. Now the Port Arthur team meets Denton in the semi-final.

First hand information from the Breckenridge-Amarillo battle Saturday is that the Golden Saddles made their most pitiful showing of the entire year. Previous rumors of disintegration within the ranks of the club were borne out by the apparent feud between a pair of sandy backs in the Buckaroo encounter. Our informants tell us that the broken morale of the Amarillo aggregation was more in evidence at Breckenridge Saturday than it has been all season. While the Saddles were floundering about in midfield with no serious threat to score, the Buckaroos like a whirl in a rail-roader performance. Undoubtedly, if Shotwell's men could have scored more than two touchdowns had the necessity presented itself. A Lubbock fan who witnessed both the Breckenridge-Amarillo game Saturday and the Nov. 2 Lubbock-Amarillo scrap is certain that the Westerners could have downed the Buckaroos last week with the same class of football they displayed on Butler Field in Amarillo.

Unless we have been badly misled, the situation which presented itself at Breckenridge Saturday will have a strong bearing on the return of Dutch Smith and Marshall May to Amarillo. It had already been reported that both boys mejoors were leaving the club at the close of this year, and one can hardly blame them when it is considered that 17 members of the squad are to be lost.

NEW YORK, Dec. 9. — Otto Von Porat of Norway and Phil Scott, fireman from London, clash in a 12-round bout in Madison Square Garden tonight for charity's sake and for a possible "shot" at the heavyweight championship of the world.

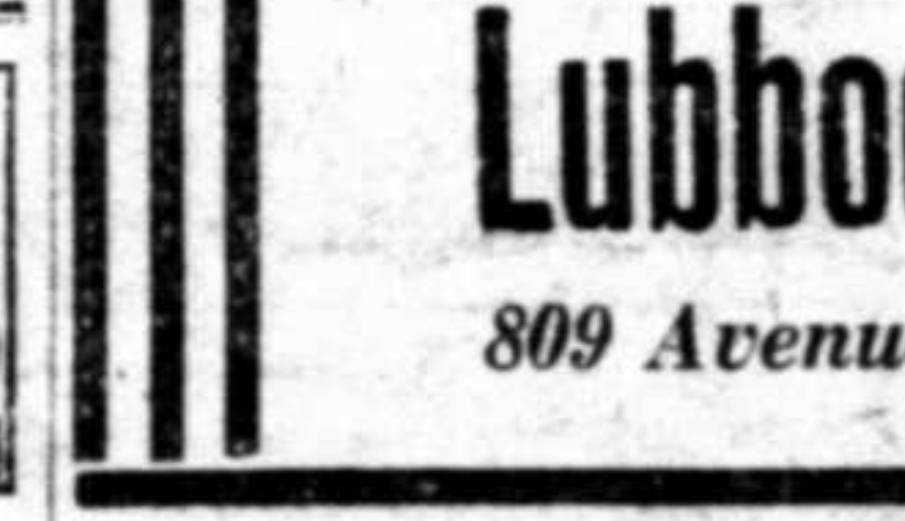

REVIEW OF THE WEEK'S FOREIGN NEWS

The little powder charge set off when Manchurian authorities raided the Russian consulate in Harbin and seized the Chinese eastern railway last spring flared up all over the world during the past week.

The chief powers of the Kellogg-Brand pact, led by the United States sent a note to Russia and China reminding them of their obligations to settle their differences peacefully under the pact. Japan refused to join the movement, because she believed a settlement between Moscow and Mukden was at hand. Russia received the note with great indignation, and a sharp reply was sent to the United States through the French ambassador to Moscow.

Draw Up Protocol
Russian and Manchurian plenipotentiaries, who had met in Siberia before the powers intervened, drew up a protocol for an agreement on the Chinese eastern railway, which was approved by Nanking at the end of the week.

The agreement restored the previous status on the railway and pledged the signatories to strict observance of the agreement under which the road has been operated since 1924.

The Nanking government is passing through a crisis at home, which has shaken its prestige and menaced its existence. Mutiny in central China, war in the south, and threats in the north confronted President Chiang Kai-Shek. There were rumors he intended to resign.

Haiti Has Trouble
An outbreak of discontent in the protected republic of Haiti gave official Washington something to think about in its own backyard.

Martial law was declared by U. S. marines corps authorities at Port-

Au-Prince and Cape Haitien, and reinforcements of troops were sent from the United States.

Mexico's president-elect and his rival in the recent elections seemed to start their campaigns all over again in the United States.

Supporters of Jose Vasconcelos, defeated candidate, who left Mexico after charging fraud in the count of votes, announced funds were ready for a revolution and Vasconcelos might attempt to take office by force.

Polish Cabinet Resigns
The Polish cabinet of Premier Switalsky, associate of Marshal Pilsudski, resigned after defeat in the diet, but agreed to continue temporarily in office.

King Victor Emmanuel and the Italian Royal family visited Pope Pius in the Vatican, marking the reconciliation of the house of Savoy and the Holy See.

The French government sent a note to Italy explaining France could not accept naval parity with Italy because she had coastlines on three seas and many distant colonies to defend.

Dr. Schacht, president of the Reichsbank and chief of the German delegations at the Paris experts conference, the Hague conference and the Baden-Baden bank conference, protested publicly against what he called attempts to tamper with the Young plan by the German government and the creditor powers.

To A Banker

In a certain small town in Iowa
there lives a banker. Being a corn-
belt banker, he is in spirit at least,
a farmer; that is, he has the farmer's
viewpoint. He is not a banker in the
ordinary sense of the word.

Well, this banker has a brother,
who is an official in a very large
and important bank in Chicago. This
man, quite naturally, has the bank-
er's viewpoint right up to the hilt.
To the marrow of his bones he is
a member of the financial oligarchy.

A short time ago, when the great
stock market collapse left this olig-
archy gasping and blinking, the Iowa
banker wrote to his brother, the
Chicago banker.

"What you people need," he wrote,
"is to reduce by half the number of
loans you have outstanding, so that
those you retain will be worth more.
On top of that, you must all get
down to work and get your own
salvation by the sweat of your brows
for nobody can help you. Industry
and frugality must be your watch-
words now."

This is rather strange advice to be
giving to a big city banker, but the
giving of it gave the Iowa man
intense pleasure. Because, you see,
he was merely handing back to the
Chicago banker the advice that the big
city bankers had given the farmers a
few years ago when the whole agricul-
tural region was seized by a de-
pression.

That is exactly the sort of thing
the Big Business and Big Money
— was unaccountably telling the
farmer recently. Government help?
Special legislation to help the farmer?
To hell! Let the farmer work out
his own salvation. Let him cut down
his acreage, let him let his crop pro-
duction will be smaller and the price
per bushel will be higher. Above all,
let him work and work hard, trust-
ing to his own industry for salvation
and not to any help from the outside.

That is the sort of stuff on which
the farmers, every to the wall by
the post-war depression, were fed
for years.

Now, however, the shoe is on the
other foot. But is anyone talking
to Big Business as they talked to
the "farmers"? Not at all. The highest
and most influential officials, not only
in Washington, but in the nation,
are ringing with the trumpet calls that
summon the captains of industry
and finance to the barricades.

All of this is perfectly natural, of
course, and probably it's all perfectly
proper. It is, however, rather in-
humanitarian. It helps one to under-
stand the exact nature of the civiliza-
tion in which we are living.

The dollar, if squeezed hard
enough, talks louder than any group
of men can possibly talk. The banker
and the farmer are men from two
different worlds.

Soot

If you ever wonder why the at-
mosphere of big American cities is
contaminated, consider these fig-
ures:

Every ton of soft coal contains
nearly 180 pounds of soot, which is
distributed throughout the sur-
rounding air when the coal is burned.

In a great industrial center such
as the Chicago area, nearly 30,-
000,000 tons of soft coal are burned
yearly. If you take the trouble
to figure that out, you'll find that
every inhabitant of that district gets
about 100 pounds of soot each month.

The situation is much the same in
every large city. Small wonder that
the housewife in a big city finds it
almost impossible to keep her curtains,
drapes and linens from getting
soiled.

Holiday Tourist Season, As Usual, Draws Many Visitors
To National Capital And There's Plenty To See—Dutcher

WASHINGTON, Dec. 9.—For a
dollar, you can purchase about the
biggest eyeful in Washington that is
to be had anywhere.

The holiday tourist season is on
again and the sight-seeing bus-
es, most of which have their stand-
down at the foot of Pennsylvania
avenue under the brow of Capitol
Hill, are doing a rushing business.

Lower Pennsylvania avenue isn't
one of the city's beauty spots, by
any means, so the visitor's first im-
pression of the nation's capital city
is likely to be misleading. It is lined
with dingy little hotels, upstairs
rooming houses, cheap restaurants,
gaudy souvenir shops, dime muse-
ums, shooting galleries and the like.
It is the city's Chinatown, too, and
blatant-eyed Chinese children frolic
on the sidewalks.

And all this at the foot of Cap-
itol Hill.
But as the bus threads its way
through the traffic up Pennsylvania
avenue toward the treasury and
White House, these scenes are soon
left behind. The bus-voyager, now
seated beside the driver, points
out various points of interest as
the city's business district is entered.
Among them, just then, are the
huge Postoffice Department building
on the left and the Galt jewelry
store, still owned by Woodrow Wil-
son's widow, who inherited it from
her first husband, on the right.

Turning, the bus swings through
the shopping district and the the-
ater district—and Washington has
some real department stores and
theaters. As in any other town,
the streets are dense with traffic,
but unlike most other towns they
are lined with trees at the curb.
Washington has 100,000 of these
trees and is proud of them.

Through the trees that dot the
spacious lawn on the other side of
a high iron fence, one gets a
glimpse of a big building with
dingy gray walls. It is the White
House. It sits far back from the
street, the concrete walks and drives
curving through the grassy acres
to meet at the stately entrance with
its tall gray columns, where two
policemen always stand guard.

A turn to the right and the bus
heads out Sixteenth street, toward
the exclusive residential section and
the foreign embassies and legations.
The Barker points out each in turn,
for they are not so very far apart.
Most of them are buildings of im-
posing appearance, the interest in
which is heightened by the strange
flag flying from the roof.

The return trip is usually made
via the Lincoln Memorial, one of
the most beautiful of all architectu-
ral masterpieces in Washington; the
Washington Monument (you
don't have to walk up unless you
want to, because it is equipped with
a high-speed elevator); the Depart-
ment of Agriculture buildings, the
Smithsonian Institution, the Na-
tional Museum (with the Roosevelt
African trophies) and the capitol
itself.

At the capitol, the members of
your party pay 25 cents each to
be escorted through the building
by a uniformed guide, who ex-
plains everything in a sing-song
lecture.

You see the historic paintings in
the great rotunda (you've seen
copies in your school books, but the
originals are here); and the marble
statues of great statesmen of by-
gone days in statuary hall. You also
see (from the visitors' galleries only)
the Senate chamber and the House

Trucking Charge Is
Allowed To Be Cut

AUSTIN, Dec. 9. (AP)—The rail-
road commission today gave per-
mission to the Texas and Pacific to
eliminate its charge for trucking
from and to points of origin and
destination.

A short time ago the railroad was
authorized to operate trucks to pick
up freight at the point of origin
and haul it to the station and to
take it to the station to which it
was consigned and move it to the
place of destination. An additional
charge was made for the service at
that time but the line asked for its
elimination. The service will be
available from Dallas and Fort
Worth west to Midland and east to
Marshall and from El Paso east to
Midland.

The commission also passed an
amendment permitting cantaloupes
to be mixed with fresh fruits and
vegetables at mixed car rates.

there and maintained by the quar-
ters that visiting sightseers pay at
the gate.

NEW YORK, Dec. 9.—The "king
of the bums" in New York is a mer-
ry, chuckling fellow they call "Hap-
py."

What his name may be no one
seems to know and "Happy" won't
tell. As in the case of all such am-
biguous characters, the legends go
that he comes from a good family.
At any rate he is a product of New
York and is to be found spinning
various yarns over his "hand-out" of coffee
and doughnuts at Mrs. Zero's "rub,"
or any one of a half-dozen spots in
the "bum" belt.

The heart of "bumdom," or what-
ever you'd call it, is St. Marks place
over the East River.

Here you'll find the quarters of
Mr. Zero, who feeds and clothes the
needy.

Here, too, you'll find the national
headquarters of the Hoboes' Union.
As one might expect, the hoboes
hang out in the "bum" belt, and
through dingy hallways and down
dingier stairways. Finally, out in a
tiny back yard, you'll come upon
what once was a shed, or coal bin,
or something of the sort. It's a one-
room brick affair with a couple of
windows, heavily barred.

Here, for many years, lived Liv-
ingston Pratt, secretary of the New
York chapter of Hoboes. Here he
lived and here he died, with a couple
of philosophical works between him-
self and the world outside.

Into this spot, when he died, moved
Dan O'Brien, who at the mo-
ment happens to be "king of the
hoboes."

Dan, it would seem, is sufficient-
ly Irish to dramatize his position.
Far from looking like the average
bumble-stuff, Dan wears one of those
colonel-brimmed, black "southern
colonel" hats. His collar is pictur-
esquely turned and his face is
chiseled with becoming lines. If you
met him on Broadway, you'd swear
he was an actor. If you met him
at the home town depot, you'd swear
he was one of a troupe of traveling
Shakespearean players.

Once Dan found his name on the
New York ballot. He ran for mayor
on the hobo ticket, or something of
that sort. At any rate, it brought a
few smiles.

Dan runs to "hobo poetry," or
whatever it is, and writes the flow-
ery, sentimental stuff appearing in
pamphlets and verse books sold up-
on the street. By way of instance,
the following prose is lifted bodily
from his "Lights of Broadway":
"The lights of Broadway gleam and
a thousand shadows are moths to
night. Many a dead and buried rose
comes forth fluttering down like
long and teeming lane—they drift
like snow flakes, cold and still from
night to noon—they seek to warn
the youth that Broadway plans to
kill."

Returning to "Hobo poetry," he in-
forms me that the business of being an
"irresponsible bum" in New York
isn't what it used to be. To be sure,
a dollar here and there may still
be picked up carrying wood and coal.
But the times that used to be gath-
ered for hanging up laundry, no
longer are to be had.

Time was, relates "Happy" when a
bum could get his feed by going
through the Bronx and washdays
and hanging clothes up for the busy
housewives. But trick pulley lines
and modern inventions have changed
everything.

However, Manhattan remains a
bum's paradise, I'm told, but hoboes
shun it. There, if you believe
"Happy," no dyed-in-the-wool hoboes
east of Chicago.

Diet and Health

REDUCER SAVES ENOUGH
ON FOOD TO HELP PAY
FOR ALTERING CLOTHES
Reduced For Ten Cents
"DEAR DOCTOR: I have been
looking forward to this very
day when I could write and tell you
of the wonderful results I achieved
simply by following your advice in
the little diet pamphlet.

"I am 40, and only five feet two
inches tall, and less than two
months ago I weighed 166
pounds. I started with the three-
day liquid diet and have since
kept as close as possible to about
900 calories a day. I had 200
for breakfast, no lunch (never
have eaten lunch), and the balance
of 600, perhaps a little more, for
dinner.

Am up bright and early in the morn-
ing for the first class on the radio,
walk briskly back and forth to the
station, and have lost 26 pounds in
seven weeks. Am down to 140 and
would like to stay put. How many
calories a day can I allow myself
and remain at 140?

"I am in perfect health, play golf,
drive a car and do all my housework
besides going to the city every day,
filling a secretarial position. The
only ill effects seem to be in my neck
and chin—had a double chin which
has vanished completely, but left it
very flabby. Will this right itself?

"To think of reducing without any
drugs or hardships for the mere sum
of ten cents! The only expense has
been at the tailor's, as I have had
to alter all my clothes. MRS. P."

You have probably saved enough
on your food bills to pay your tailor,
haven't you, Mrs. P.? And isn't it a
glorious satisfaction—this taking in
clothes!

I think the reason your neck is
flabby is that you reduced too rapid-
ly. However, perhaps by taking spe-
cial exercises, you will help it re-
cover its tone. Do you know some ex-
ercises good for the neck?

The Tummy Ton that we have been
talking about all the time—exercises
specially designed for the trunk!
When you lie on the floor or on a
hard bed, and raise your body to

the upright position, or raise your legs
to the upright position, you will no-
tice how much it pulls your neck
muscles. Then, you can do special
head exercises—bending it back and
forward and to the sides, for a few
minutes at a time, during the day.
Put on some cold cream at night,
and rub up and down. It doesn't
have to be any special kind of cream
(there is no "skin food" that is ab-
sorbed to put fat under the skin).

As to the number of calories you
need to maintain you, you will have
to find out for yourself. With all
your activities, I should think it
would be around 2000. (Perhaps less,
because you are short.) Experiment,
and watch your scales. Of course,
there may be a variation of the
weight of two pounds or so, from
one day to the next, on account of
the water balance factor, but you
will be able to tell after a period of
a week. Have the same type of food
the day before weighing that you
had the week before when you
weighed, and at the same time weigh
clothes.

Anyone who has a tendency to
overweight should have a bathrobe
scale so he can weigh every morning
before the bath. It is a good idea
for a family that expects a baby to
buy a ready pair of balanced scales
so it could continue to be of service
for the child and the rest of the fam-
ily; these do not cost so very much
more than a baby scale.

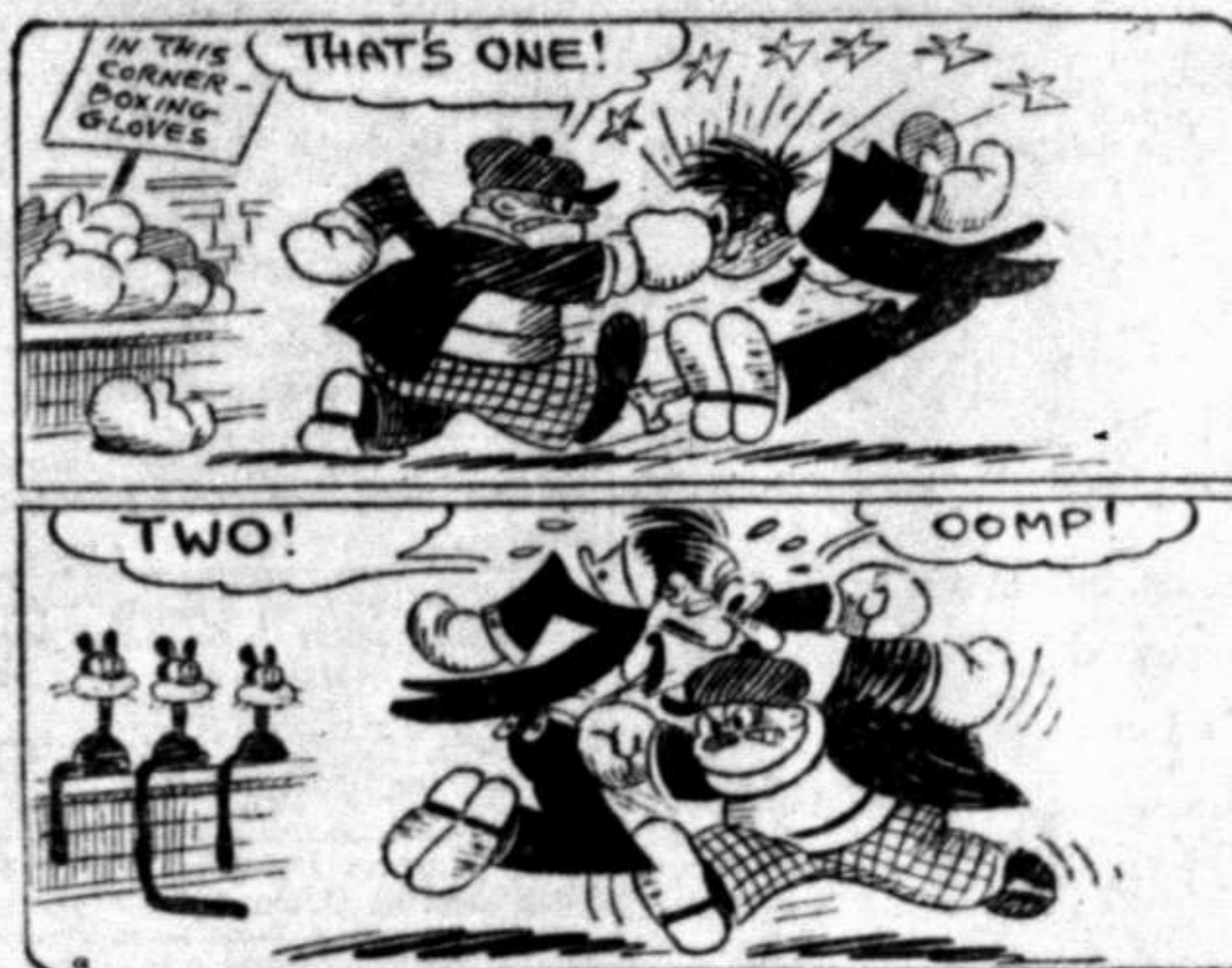

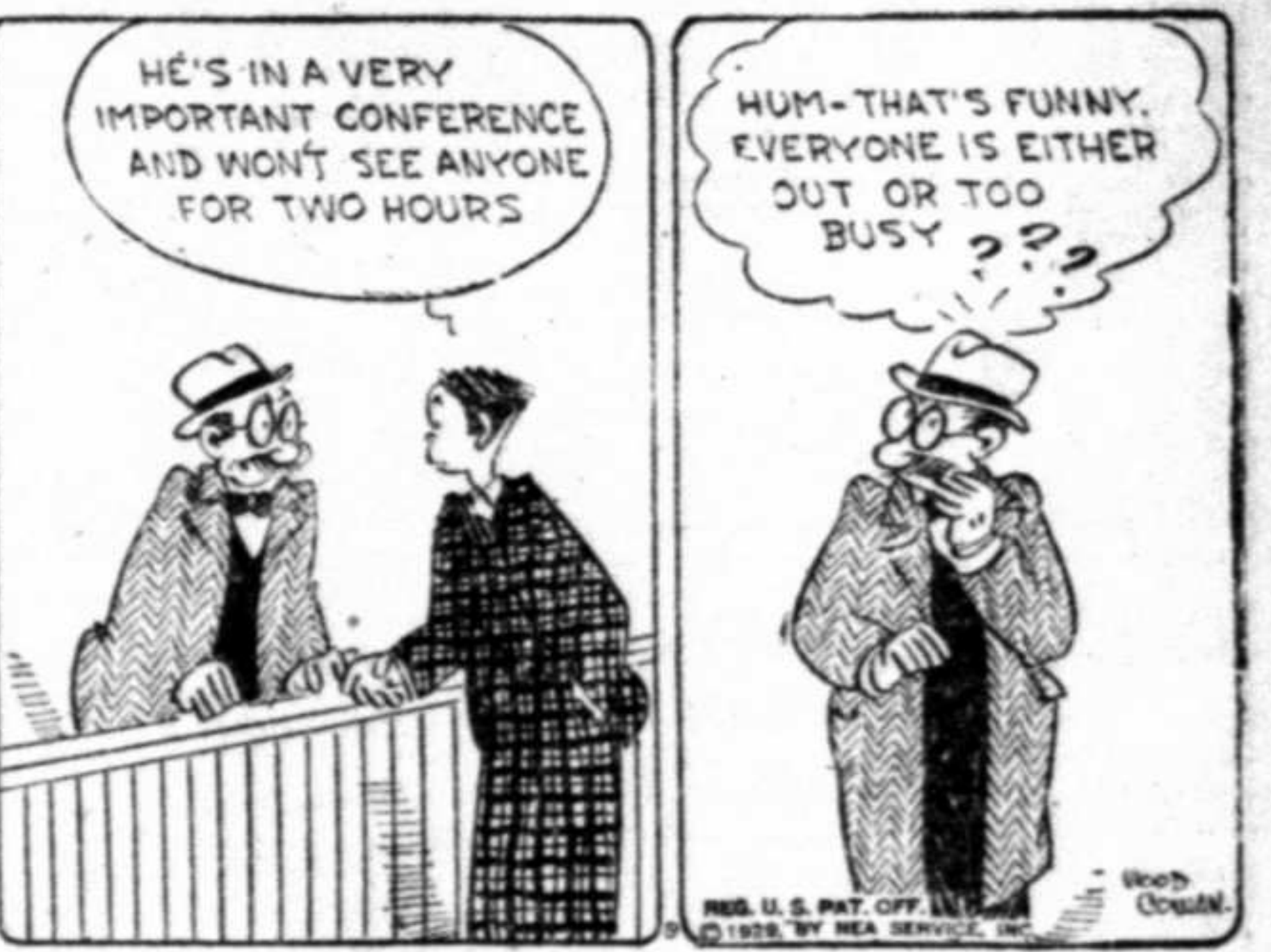

CLEAN-UP OF DRIVE COMING

The wheels of the Lubbock Community Chest organization once more will begin to turn when a meeting will be held tomorrow morning in the offices of the chamber of commerce at 8:30 o'clock. A final effort is to be made by the workers to bring the total subscriptions to the first set goal of \$30,000.

Reports this morning at headquarters of the organization state that today several persons who have been out of the city for the past week, turned in subscriptions amounting to several hundred dollars and that firms listed in the employees division were just now making their drive.

Near Goal, Belief
When a final check is made by the auditor, officials state that they are of the opinion the goal will have been reached. Colonel G. P. Kuykendall, of the mens division, has urged that every working member of his army be present at tomorrow's meeting in order that an early start may be made and that no time will be lost. Several names are yet to be checked off the list of prospect and these will be distributed among those who report Tuesday.

General Chairman Neil H. Wright has expressed confidence that the campaign will yet go over the top when everyone in the city has had a chance to subscribe. "I believe that it is just a question of a short time, just enough for us to meet everyone, before we will have the amount required," he stated.

At the last report meeting, when the campaign was to have officially closed last Friday night, the total subscriptions had fallen short by some \$6,000. Directors voted to carry the campaign on over into the present week.

De parting from his voluntary discussion of the subject of predestination, Lester remarked, "Now, they say in the testimony that I never went further than the third grade. I will write letters and work out problems of mathematics against any of them."

Failed in Description
"I remember," he continued, in critical fashion, "that one of the witnesses, in describing my wife's restaurant, said there was a window on each side of a certain door. He should have said on either side of the door. I notice also that they don't seem to know the difference between a cafe and a restaurant, but there is a difference. Cafe originally meant a coffee house, while restaurant means a public eating house."

"I have never noticed anything peculiar about him," stated Gibbs. "He has always appeared like any other boy. I believe that he knows the difference between right and wrong."

Arrested Once
J. A. Arnold, of Memphis, former constable at Dublin, related that he at one time had occasion to arrest Clay Lester when the latter, then a 13-year-old boy, held members of his family at bay with a pistol. "Because he was mad at his father," "Did he surrender to you at that time without offering any resistance?" asked George Dupree, special prosecution who conducted examination for the State.

"Yes," replied Mr. Arnold, who also expressed the opinion on the stand that Lester is sane and knows the difference between right and wrong.

Was Officer Once
Mr. Arnold stated that he saw the defendant but a few years ago at Memphis. "At that time Clay Lester held a commission as a Brown coat."

YOUTH IS GIVEN SIX-MONTHS STAY

OKLAHOMA CITY, Dec. 9 (AP)—Ted Cole, 17-year-old boy who was sentenced by Judge Saul Yager of the Tulsa county district court to die December 31 for robbing a bottling works plant at Tulsa will not be executed, nor will he be required to serve a life sentence for the crime. Governor W. J. Holloway said today.

Issuing a reprieve of six months to allow Cole time for an appeal to the Criminal Court of Appeals, Governor Holloway ordered Dr. J. Q. Newell, warden of the state penitentiary, to remove Cole from death row.

The governor's action followed an opinion from the attorney general saying that in event Cole did not appeal the sentence must be carried out December 31 unless the governor issued a reprieve.

Cole pleaded guilty to a charge of robbery with fire arms. No shots were fired in the holdup.

tion. They are two who are upholding the classic drama, or what we might call the legitimate drama, in America today."

This venerable, exceedingly genial and twinkling-eyed actor has played parts in the whole range of standard and Shakespearean dramatic plays. His favorite of them all is the part of King Lear.

"Not that I think the play of King Lear is Shakespeare's greatest, but this character is the most human; in my estimation. It is the most difficult part of all his works, although Macbeth is Shakespeare's greatest play."

Came Here in 1874
Ward came to America from England in 1874. In 1878 he crossed this continent for his first time. Since then he has crossed it for at least 30 times. He has been back to England numerous times, but not since the World war, preferring to remember his native land as it was before that tragic period and as it was in his boyhood and youth. A philosophy of life is only gained

by our experience in life, in this veteran actor's declaration. "It all depends upon yourself," he says. "Here I am meandering around the country, taking journeys at the age of 79 which require 20 and 30 hours each to complete in many instances, and finding a lot of fun in it. This world is full of humor. Human nature is the same today as it was when Eve wept because of the murder of one of her sons by the other one. Life does not change. It is only our humor that changes. Humor is local, while life is universal."
