### THINGS IN GENERAL.

The latest census reports on manufacturing, while showing a satisfactory comparative increase in the total number of establishments and in the capital invested, have in them a vein of sadness when the statistics on the flour and grist milling industry are considered. The mills show a decrease of fifty-one establishments and nine million dollars in investment and a twenty million dollar decrease in the output. This is exceedingly unfortunate in view of the early opening of the Panama canal which gives us access for the wheat belt of the Mississippi valley and it is only artificial obstructions that can cause the wheat to detour via interior mills an eastern seaports on its journey to continental and island trade. It will be recalled that the state laid a threatening hand upon the millers a few years ago and without reference to the merits of the case it is unfortunate that the government has not learned how to correct without blighting. The Interstate Commerce Commission has repeatedly threatened the withdrawal of rates under which the millers have built up their business, and taken all in all, governmental disturbances have badly frightened that industry.

Press reports from McLennan county announcing that one hundred and fifty split log drags were in operation in that county maintained jointly by popular subscription and appropriation of the Commissioners court are a tribute to the progressive spirit of that community as well as to the efficiency of the split log drag. The drag has contributed more toward the economic maintenance of the public highways than any implement of modern usage. It does not require special acts of the legislature, bond issues nor expensive educational campaigns to make it available as usually precedes construction work. A drag can be built or purchased for twenty dollars and is easily operated by any one who can drive a team. We need more drags in Texas.

The big silk worm colony which F.

H. Williams of Brownsville is cultivating is almost ready to begin spinning. During the past six weeks the worms have been fed upon mulberry leaves and the owner estimates that fifty thousand cocoons will soon be made by the colony of silk spinners.—Commercial Secretaries.

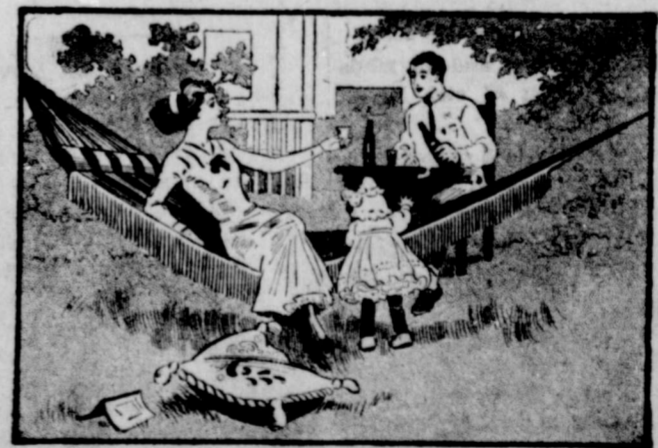

#### COMMISSIONERS COURT.

Furniture Bought for New Court House—Other Business Given Attention.

Commissioners court has been in session this week and has transacted a great deal of business.

Bids for supplying the furniture for the new court house were received from six competitive firms and the contract was awarded to C.H. Meyers & Co. of Houston, for \$8391, for furnishing the wood furniture of every description for the court rooms, offices, rest rooms, balcony, etc. The metal furniture was purchased from the Art Metal Construction Co. of Dallas for \$2065. This includes iron beds for the jury rooms, metal stands and shelving, etc. The total cost was several thousand dollars less than those informed on the price of such furnishing estimated it would cost and the contractor's prices were considerably less than some of the bids submitted.

The court went to Blanket creek Thursday to inspect the site where a bridge is needed, but no definite action was taken on the subject.

The county board of education recommended to the court that the Payne school district in this county and the Gray district in Lampasas be consolidated into one county line district, this county to have jurisdiction over the new district, and the recommendation was adopted. It is understood that the new district will erect a new high school building at Moline.

The Merril school district was created by the court. The territory in this district was formerly in the Look-out district, which is a county line district composed of territory from this and Hamilton county.

A petition from the president of the county singing convention to be allowed the use of the new court house when completed for holding a singing convention was granted.

The supreme court reports were bought for the county's library in the county attorney's office.

The contract for supplying the vault doors for the new court house was awarded to Mills County Hardware Co. for \$500. By this deal the county makes \$300, as the court house contractors are to pay the county \$800 with which to buy these doors.

The San Antonio Hardware Co. was awarded the contract for supplying radiators and other hardware for the court house for \$200. The building contractors are to pay \$175 of this amount.

The court bought lots 3, 4, 5 and 6 in block 20, which is south of the square, and will use them for a public hitching place for teams and horses and will also locate the cess pool from the court house at that place.

Center City school trustees were granted authority to sell the Long Branch school building, that district having divided between Star and Center City.

Authority was granted the Star rural telephone company to construct a telephone line along certain public roads in that section.

The court was busy yesterday afternoon inspecting and checking the collector's report of taxes collected. The court adjourned yesterday, after noon.

#### STOP ROLLING OF SHIPS

Frahm System of Anti-Rolling Tanks May Become Common Feature Great Liners.

As the result of experiments showing the effectiveness of the Frahm system of overcoming the rolling of ships by the placing of tanks of water athwartship, these anti-rolling tanks are likely to become common features of the great ocean liners of commerce. The German imperial navy has already gone so far as to experiment with an apparatus for recording the heeling movements of ships. This device, called the "rolling pendulum," consists of a pendulum of very slow period of oscillation and great inertia. The relative motions of the ship toward the pendulum are recorded on paper that is moved uniformly. The pendulum will work eight days without special attendance. Oscillations traced when the tanks were not in action on several steamships of more than 12,000 tons displacement show violent departures from a straight line, while when the tanks were in action the line of the recording pencil was almost straight.

The general health of the passengers was markedly improved through the action of the anti-rolling tanks and when the tanks were put out of action for the purpose of comparison they protested to the captain.

#### WAS NOT POSTED ON DOGS

Charley Ellison Was Up on Horses, but Habits of Canine Was Closed Book.

Charley Ellison is up on horses, but was not up on dogs. At one time in Hot Springs he paid \$100 for a bird dog, partly through a fanciful notion and partly because the dog was a handsome animal.

He sought the seller next day and said:

"I thought you claimed this was a bird dog. He was gone for three hours yesterday and didn't bring back a single bird."

One cent will buy a cigar superior to that which sells for a nickel in the United States, while five cents will purchase a box of 50 cigarettes; six cents will furnish the same with gold mouthpieces.

The standard English lunch of bread and cheese, purchased at a coffee house, costs two cents, and one cent more washes it down with a large glass of buttermilk. The high cost of living does not furnish a subject of inquiry in the Dutch parliament. Lodging is correspondingly cheap and one is sure of an immaculate room, no matter how low a price he pays.

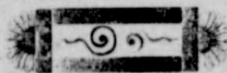

The condition of Pope Plus X, head of the Catholic church, has been extremely critical for some days and his recovery is scarcely expected, although it is possible. The belief that his death is not far distant is fully shown by the discussion as to his successor.

The legislature of New Hampshire this week expelled Representative Clifford Snow from that body on a charge of having offered to sell his vote to candidates for United States senator and other positions. This was the first case of the kind ever recorded in that state and party lines were eliminated when the vote was taken to expel him.

It is reported that the proposed law being considered by the California legislature, which caused the protest from Japan, does not differ materially from laws of other states relative to aliens holding land. It seems the Japs are simply hunting something to object to in this country. President Wilson and his cabinet will not likely attempt to dictate to California in the matter.

The lower house of the New York legislature has passed a bill allowing \$1 per day for every day spent in a state prison by one convicted and afterwards proved innocent and pardoned by the Governor. The bill also allows the institution of suits against the government for damages by such persons.

Some of the military and political leaders of Mexico passed through the state this week en route to the state of Coahuila, Mexico, to join the rebel forces that are backing Governor Carranza for the presidency of the republic. They came from Vera Cruz via New Orleans and thence to the Mexican border. Some of them were interviewed and claimed that 70,000 organized rebels were active against the Huerta government and he who secured the reins of government by treachery would be forced to leave the country and take with him his co-conspirators.

Every report of Turkey's reverses should be occasion for rejoicing everywhere.

Many people are disturbed because of the President's determination to revise the tariff and many are they who predict injurious consequences to the various industries in this country. No need for imagining these evil consequences. Wait and see and then there will be no reason for alarm or regret. The people of the nation should remember that the country is in the hands of the Democrats and is, therefore, safe from all danger of harmful legislation and the result of the tariff revision by congress will be decidedly beneficial to the country.

In a speech before the National Democratic club in New York Saturday night Vice President Marshall reiterated the Eagle's statement of last week that the trusts and combines have already seen their best days and that the great people had become alarmed because of the oppression and avariciousness of the unholy combines. He said his knowledge of the subject was gained from experiences and observations in 27 states of the Union during the last presidential campaign. He is right. There are better times and better opportunities ahead for the plain people and the people of moderate means.

There is an automobile to every three houses in the principal cities in Texas, population basis, and the number of cars in these cities totals 10,026, while the horse population is 30,282, according to data compiled by the Texas Commercial Secretaries and Business Men's Association from information furnished by the Census Department and the commercial organizations of San Antonio, Dallas, Houston and Fort Worth. The latest Federal census gives these cities an aggregate population of 340,830, which is an average of 11 persons to each horse and 34 people per automobile. San Antonio has more horses than any other city, while Dallas ranks first in number of cars.—Commercial Secretaries.

Proposed amendment to the state Constitution authorizing the issuance of bonds for the purpose of the construction of the necessary buildings for the University of Texas and also for buildings of various institutions, and authorizing improvement bonds for the purpose of navigation, irrigation, construction of bridges and the maintenance and operation of public warehouses. (S. J. R. No. 18.) Senate Joint resolution.

To be entitled A Joint Resolution proposing and submitting to a vote of the people of Texas an amendment of Sections 49 and 52 of Art. 3, of the Constitution, authorizing the issuance of bonds and the levying of a tax to pay the interest and sinking fund on same for public improvements.

Be it resolved by the Legislature of the state of Texas:

SECTION 1. That Sections 49 and 52 of Article 3, of the Constitution of Texas be amended so as to hereafter read as follows, to-wit:

Section 49. No debt shall be created by or on behalf of the state except to supply casual deficiencies of revenue, repel invasions, suppress insurrection and defend the state in war or pay existing debts, and no debt created to supply deficiencies in current revenues shall ever exceed in the aggregate at any one time five hundred thousand dollars. The Legislature, however, shall have power to authorize the issuance of bonds to be approved by the Governor for the purpose of purchasing additional ground and erect necessary buildings for the University of Texas, including a medical department, an Agricultural and Mechanical College and all departments and activities of a complete university of the first class. The revenue received from the permanent university fund shall be available for the payment of interest on these bonds and for the creation of a sinking fund for their redemption at maturity and the Legislature shall also have power to issue bonds for the construction of necessary buildings for state institutions. The Legislature shall also have the power to authorize the issuance of bonds secured by lien on the real property of the penitentiary system to be approved by the Governor for the purpose of constructing buildings and making permanent improvements.

Section 52. The Legislature shall have no power to authorize any county, city, town or other political corporation or subdivision of the State to lend its credit or to grant public money or thing of value in aid of or to any individual association or corporation whatsoever or to become a stockholder in such corporation, association or company; provided, however, that under Legislature provisions any county, any political subdivision of a county, any number of adjoining counties or any political subdivision of the State or any defined district now or hereafter to be described and defined within the state of Texas and which may or may not include towns, villages or municipal corporations upon a vote of a majority of the resident property taxpayers voting thereon who are qualified electors of such district or territory to be effected thereby in addition to all other debts may issue bonds or otherwise lend its credit in any amount not to exceed one-fourth of the assessed valuation of such district or territory, except in case of improvement of rivers, creeks, and streams, in building of levees to prevent overflows, in which case the bonded indebtedness may be for an amount not to exceed one-half of the assessed valuation of the lands of the district to be reclaimed; and except, further, that the total bonded indebtedness of any city or town shall never exceed the limits imposed by other provisions of this constitution, and levy and collect such taxes to pay the interest thereon and provide a sinking fund for the redemption thereof as the legislature may authorize and in such manner as it may authorize the same for the following purposes, to-wit:

(a) The improvement of rivers, creeks and streams to prevent overflows, and to permit of navigation thereof or irrigation therefrom or in aid of such purposes.

(b) The construction and maintenance of pools, lakes, reservoirs, dams, canals and waterways for the purposes of irrigation, drainage or navigation or in aid thereof.

(c) The construction, maintenance and operation of bridges and macadamized, gravel, sandy clay, or clayed sand or paved roads and turnpikes or in aid thereof.

(d) The construction, maintenance and operation of public warehouses or in aid thereof.

SEC. 2. The foregoing amendments to sections 49 and 52 of Article 3 of the Constitution of Texas shall be submitted to the qualified electors of this State for adoption or rejection at a special election hereby ordered for the third Saturday in July, 1913, the same being the nineteenth day of said month. All voters on this proposed amendment at said election who favor its adoption shall have printed or written on their ballots the following:

For amendment to Sections 49 and 52 of Article 3, of the Constitution, authorizing the issuance of bonds for the University of Texas, Agricultural and Mechanical College, State Penitentiary System, and other public improvements and building of warehouses for agricultural products. Those voting against its adoption shall have written or printed on their ballots the following:

Against amendment to Sections

49 and 52, of Article 3 of the Constitution, authorizing the issuance of bonds for the University of Texas, Agricultural and Mechanical College, State Penitentiary System, and other public improvements and building of warehouses for agricultural products.

Previous to the election the Secretary of State shall cause to be printed and forwarded to the County Judge of each county, for use in said election, a sufficient number of ballots for the use of voters in each county on which he shall have printed the form of the ballot herein prescribed for the convenient use of the voters.

Sec. 3. The Governor of the state is hereby directed to issue his necessary proclamation ordering this election, and have same published as required by the Constitution and laws of the state. The sum of five thousand (\$5,000) dollars, or so much thereof as may be necessary is hereby appropriated out of any fund in the State Treasury not otherwise appropriated to defray the expenses of publishing said proclamation and printing of tickets and necessary blanks to use in said election.

Proposed amendment to the state constitution, providing all state, district, county and precinct officers within this state shall be compensated by the payment of a fixed salary.

(H. J. R. No. 41.) A Joint Resolution of the Legislature of the state of Texas, proposing an amendment to the constitution of the state by adding to Article 16 thereof a new section to be known as section 58, providing for the tenure and compensation of public officials.

Be it resolved by the Legislature of the State of Texas:

SECTION 1. That there be added to Article 16 of the Constitution of the state of Texas a new section to be known as section 58, which shall read as follows:

Section 58. All state, district, county and precinct officers within the state of Texas shall hereinafter be compensated by the payment of a salary to be fixed or provided for by the Legislature.

SEC. 2. The Governor of this state will, as directed by the constitution, make publication of this proposed amendment in the manner and for the time as required by the Constitution, the amendment to be voted upon by the qualified electors for members of the Legislature of this state at the general election to be held for state officers on July 19, 1913, the returns of which shall, as provided for in the Constitution, be made to the Secretary of State, the result ascertained and proclamation made as provided for in Section 1, Article 17, of the Constitution. Cleveland Abbe, who received the Symons medal from the Royal Meteorological society of England a few days ago, is the man who inaugurated the daily weather report which is served with the coffee every morning.

In 1869 he furnished a daily report to the Cincinnati Chamber of Commerce, and became known as "Old Probs." Soon afterward the government took up similar work, engaging Professor Abbe as meteorologist for the Signal Corps in 1871. He held his post for 20 years.

Another of Professor Abbe's achievements was his report (issued in 1879) on standard time—a report that started the agitation that resulted in the modern standard-hour meridians from Greenwich.

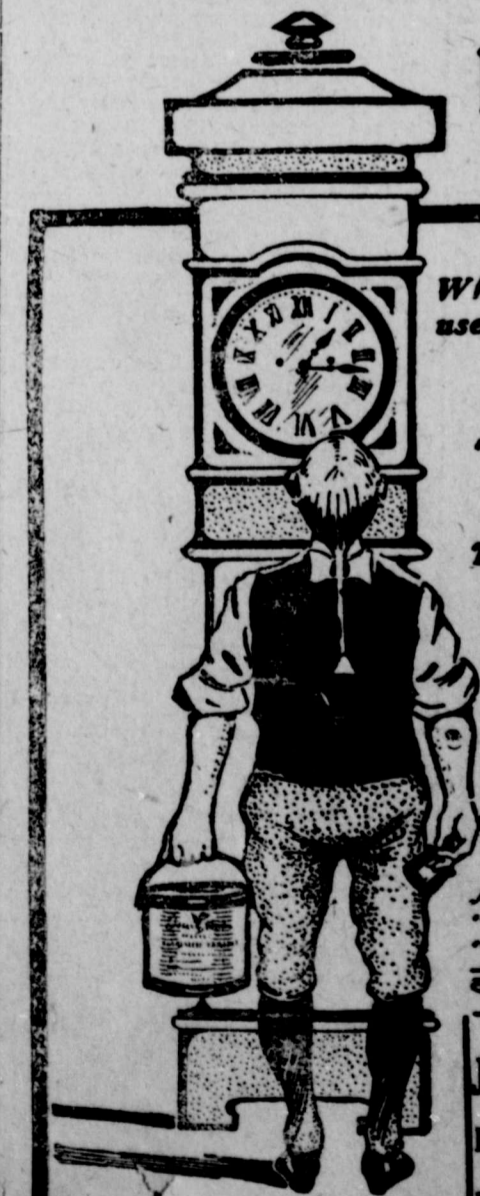

**TALKED**

amendment to the Consti-  
tution of this state authorizing the  
issuance of bonds for improvement  
of public warehouses for storing,  
handling, classing, measuring, weigh-  
ing, elevating and loading agricul-  
tural products.

(S. J. R. No. 4.) Joint Resolution.  
A Joint Resolution proposing an  
amendment to Section 52, of Art.  
3, of the Constitution of this state:

SECTION 1. Be it resolved by  
the Legislature of the state of Texas,  
that Section 52, of Article 3, of the  
Constitution of the state of Texas, be  
amended so as to hereafter read as  
follows:

Section 52. The Legislature shall  
have no power to authorize any  
county, city, town or other political  
corporation or subdivision of the  
state, to lend its credit or to grant  
public money or thing of value in aid  
of or to any individual, association or  
corporation whatsoever, or to become  
a stockholder in such corporation, as-  
sociation or company, provided, how-  
ever, that under Legislative provision  
any county, any political subdivision  
of a county, any number of adjoining  
counties, or any political subdivision  
of the State, or any defined district  
now or hereafter to be described and  
defined within the state of Texas,  
and which may or may not include  
towns, villages or municipal corpora-  
tions, upon a vote of a majority  
of the resident taxpayers voting there-  
on, who are qualified electors of  
such district or territory to be ef-  
fected thereby, in addition to all  
other debts may issue bonds or other-  
wise lend its credit in any amount  
not to exceed one-fourth of the as-  
sessed valuation of the real property  
of such district or territory, except  
that the total bonded indebtedness of  
any city or town shall never exceed  
the limits imposed by other provisions  
of this Constitution, and levy and  
collect taxes to pay the interest  
thereon, and provide a sinking fund  
for the redemption thereof, as the  
Legislature may authorize, and in  
such manner as it may authorize the  
same, for the following purposes, to-  
wit:

(a) The improvement of rivers,  
creeks and streams to prevent over-  
flows and permit of navigation there-  
of, or irrigation thereof, or in aid of  
such purposes.

(b) The construction and mainte-  
nance of pools, lakes, reservoirs, dams  
canals and waterways for the pur-  
poses of irrigation or in aid thereof.

(c) The construction, maintenance  
and operation of macadamized, grave-  
led or paved roads and turnpikes or  
in aid thereof.

(d) The construction, maintenance  
and operation of public warehouses  
for storing, handling, classing, meas-  
uring, weighing, elevating and load-  
ing agricultural products. Provided  
the Legislature may establish such  
means and agencies as may be neces-  
sary for accomplishing the purpose  
of this amendment and if a state  
warehouse commission be provided  
for, their term of office shall be fixed  
by the Legislature.

SEC. 2. The Governor is hereby  
directed to issue the necessary pro-  
clamation for submitting this amend-  
ment to the Constitution to the qual-  
ified electors of the state of Texas on  
the third Saturday in July, the same  
being the 19th day of said month, and  
the amendments proposed to section  
52 of Article 3, as above indicated  
shall be voted upon separately.

Those favoring the amendment to  
authorize road or other public im-  
provements by a majority vote shall  
have written or printed on their bal-  
lot: For amendment to authorize  
road and other public improvements  
by a vote of a majority, and those  
opposed to said amendment shall  
have written or printed on their bal-  
lot: Against amendment to author-  
ize road and other public improve-  
ments by a vote of a majority.

Those favoring the issuance of  
bonds for the construction of public  
warehouses shall have written or  
printed on their ballot: For the  
amendment authorizing the issuance  
of bonds for the construction of public  
warehouses for agricultural prod-  
ucts. Those voting against said amend-  
ment shall have written or printed  
on their ballot: Against the amend-  
ment authorizing the issuance of  
bonds for the construction of public  
warehouses for agricultural products.

SEC. 3. The sum of five thousand  
(\$5,000) dollars or so much thereof  
as may be necessary, is hereby ap-  
propriated out of any funds in the  
Treasury of the state of Texas, not  
otherwise appropriated, to pay the  
expenses of such publication, procla-  
mation and election.

Proposed amendment to the State Constitution prescribing qualifications for District Judges of this state and prescribing their tenure of office.

(S. J. R. No 11.) A Joint Resolution Amending Section 7, Article 5, of the Constitution of the state of Texas, relating to the creation and formation of judicial districts, the terms of compensation and qualification of the judges of the district courts and the times of holding court.

Be it resolved by the Legislature of the State of Texas:

SECTION 1. That Section 7, Article 5, be amended so as to hereafter read as follows:

Section 7. The state shall be divided into as many judicial districts as may now or hereafter be provided by law, which may be increased or diminished by law. For each district there shall be elected by the qualified voters thereof, at a general election, one or more judges, each of whom shall be a citizen of the United States and of this state, who shall have been a practicing lawyer of this state, or a judge of a court in this state for six years next preceding his election, who shall have resided in the district in which he was elected for two years next preceding his election; who shall reside in his district during his term of office; who shall hold his office for a period of four years, and shall receive for his services an annual salary of three thousand dollars, until otherwise changed by law. Court shall be held by a district judge at the county seat in each of the several counties at such times and in such manner as may be prescribed by law. The Legislature shall provide for the holding of the district court when the judge thereof is absent, disabled or disqualified from acting. The district judges who may be in office when this amendment takes effect shall hold their offices until their respective terms shall expire under their present election or appointment.

SEC. 2. The Governor of the state of Texas is hereby directed to issue necessary proclamation for the submission of this amendment to the qualified voters of the state of Texas at an election to be held on the 19th day of July, 1913, at which election all voters favoring this amendment shall have written or printed on their ballot the words: "For the amendment of Section 7, Article 5, of the Constitution of the State of Texas, relating to district judges and district courts," and all voters opposed to said amendment shall have written or printed on their ballots the words: "Against the amendment of Section 7, Article 5, of the Constitution of the state of Texas, relating to district judges and district courts."

SEC. 3. The sum of five thousand dollars or so much thereof as may be necessary is hereby appropriated to pay expenses for carrying out the provisions of this resolution.
