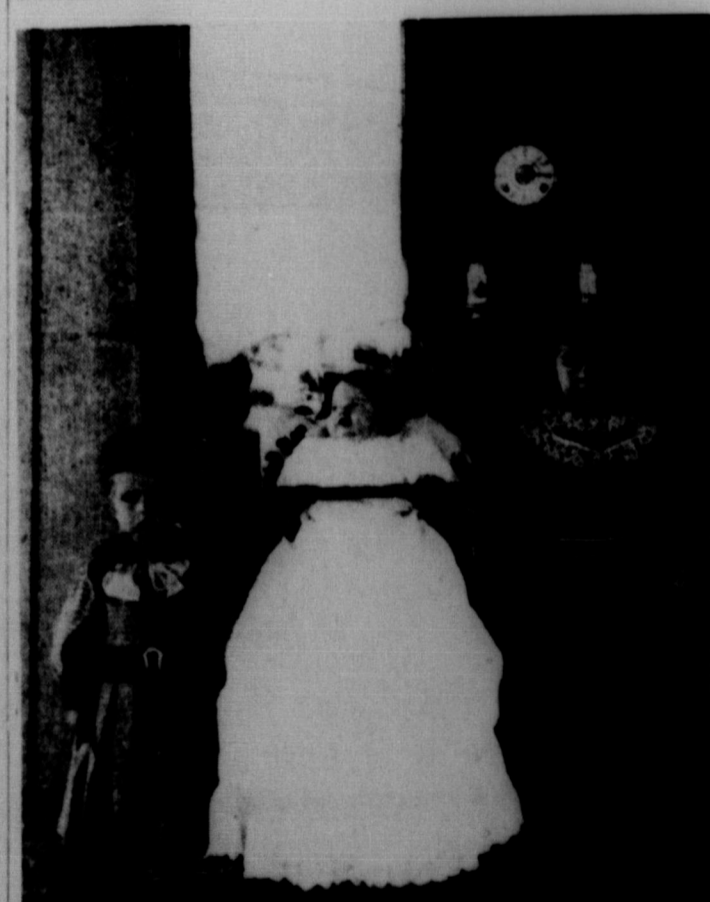

appointed last December to fill out his unexpired term after his sudden death from a heart attack, won the nomination by a margin of 126 votes over her run-off opponent, Troy Williams. Mrs. Jones polled a total of 650 votes to 524 for Williams.

Williams was making his second bid for the office of county judge, having been defeated four years ago by Mrs. Jones' late husband in the run-off primary. Mrs. Jones widened the lead over that her husband registered in 1962. Mr. Jones defeated Williams by a 41-vote margin, this vote being 554 to 513 in what was at that time a record vote for this county in a run-off primary. A total of 1080 voters cast their ballots in the 1962 run-off while last Saturday's election found the number swelled to 1178. The vote was just 103 shy of the all-time record 1281 ballots cast in a record primary a month earlier.

In a spirited race for the Precinct 4 County Commissioner post, incumbent Glenn Sutton defeated Jake Young by a vote of 152 to 117. This race, too, was a repeat of the 1962 run-off in which Sutton defeated the then incumbent Commissioner Young by a vote of 137 to 120. Sutton's margin widened to 35 this year against 17 four years ago.

Sutton must wait until the General Election in November to be certain of his reelection. He will face a Republican opponent in the November election, Roger Dudley, Jr., having been nominated by that party in a token vote in the first primary, May 7.

In the only statewide contest of the primary, Crockett county voters went along with the rest of the state in approving the candidacy of Crawford C. Martin for the office of Texas Attorney General over Franklin Spears of San Antonio. Martin received 767 votes to 326 for Spears in this county.

### Photos Of Fort Lancaster Sought By Archeologists

Scott Hays, SMU graduate student in archeology, who is in charge of the exploratory excavation work now under way at Fort Lancaster, is anxious to get some early pictures of the Fort to be used as a guide in helping to authenticate any plans for restoration that may be made.

Hays and his crew of diggers are busy digging and sifting the fort ruins, outlining building foundations, preserving artifacts, and, in general doing the preliminary archeological exploration work at the fort ruins which may lead eventually to partial restoration of the fort and creation of a park and tourist attraction.

"I feel sure there are many snapshots around taken in earlier years at the Fort site if we could locate them," said Mrs. R. A. Harrell, chairman of the Crockett County Historical Survey Committee. "We can have copies made of the pictures and return them to the owner unharmed. Anyone knowing of the existence of any such pictures of the fort ruins in earlier years is urged to call me or the Stockman office, or notify Mr. Hays."

**PERPETUITY**

Harshly spoken, the word sounds as though somebody needs a spittoon. But it means, unending, forever, or for an unlimited time. And that was the language of our Nation's treaty with Panama in 1903 opening the way for US taxpayers to pay for building the Panama Canal, and enabling the country of Panama itself to get on its financial feet. That 1903 treaty specifies that the United States would hold sovereignty over the Canal Zone "in perpetuity."

Now, in response to the clamor of certain political factions in Panama, and the pressures of some home-grown derogators of our National sovereignty, President Johnson proposes to "renegotiate" the Panama Canal treaty. He offers, in effect, to relinquish all US claims and controls in the Canal Zone and over that vital, ocean-connecting passage-way which it contains. Not only would this betray the legitimate interests of American taxpayers, it would set a precedent inviting just about everyone else to use Uncle Sam and his nephews in lieu of a cuspidor. There are other territories, which the US government acquired

by treaty and "in perpetuity," whose previous "owners" would be quite as justified in reclaiming as are the Panamanians in demanding that we give back the Canal Zone.

For example, there's the region once known as the Louisiana Territory, which was acquired from France by purchase and treaty in 1803, just one hundred years before the Panama treaty. Suppose Charles deGaulle were to demand that we sell it back to him on a basis of the original costs. (He could probably pay for it, including compounded interest, with the gold he's accumulated in recent years from our dwindling stocks at Ft. Knox.)

Then there's that deal we made with the poor Russians in 1867 when we bought the territory of Alaska at the ridiculously low price of about 2c per acre. Given the precedent of a renegotiated settlement with Panama, could not the present rulers in Russia claim that Alaska transaction was illegal and unfair, and demand a new settlement or a new treaty?

And come to think of it, Mexico has never acknowledged the legality of the 1836 declaration of independence by what has since become the State of Texas. Perhaps Mr. Johnson, if he's reminded of that, will change his mind and not go through with a precedent-shattering, perpetuity-violating renegotiation of the Panama treaty. It may be that he figures the Great Society can get along without the Panama Canal. But we're sure he wouldn't want to give up LBJ Lake or Ranch.

**WASHINGTON NEWS LETTER**

A "Negative Income Tax" plan got a boost when the House last week voted 192 to 183 in favor of a \$22 million second down-payment on a multi-billion dollar renticare subsidy scheme. It was reasoned that any member who would vote for the rent subsidy would be expected to embrace the newest welfare tax proposal.

Only recently the House, by an 8-vote margin, and the Senate by a one-vote margin, had approved \$12 million to finance renticare through June.

Renticare designed to channel more lower-income tenants into middle-income neighborhoods ("integration by scattering") would mean that subsidized tenants, no matter what their income level, would have to pay no more than 25% of their income for rent; a benevolent Uncle Sam would pay the balance for them.

The triumph of renticare is regarded by some welfare advocates as a forerunner of the adoption of a "negative income tax" for the benefit of the poor.

Here is an example of how the tax plan would work: A family of four, with an income of \$1500, with four exemptions of \$600 each, plus the family standard deduction of \$600 — making a total of \$3000, would become eligible for a \$1500 "negative

refund". And the Treasury would send \$1500 to that family.

This idea has wide support in liberal circles. Back in 1964, a citizen group called the "Ad Hoc Committee on the Triple Revolution" said the government should guarantee every American an adequate income as a matter of right, whether he worked or not. Similar talk about a minimum income as a right of citizenship had been heard earlier that year at a conference on poverty held at Georgetown University.

Milton Friedman, a University of Chicago economist, proposes it as a substitute for all other forms of welfare aid. Sargent Shriver, chief of the War on Poverty has endorsed it. A committee of the Democratic Study Group — composed of 150 liberal House Democrats — recommended it.

In February a National Commission on Technology, Automation, and Economic Progress, appointed last year by the President, called for a serious study of a "minimum-income allowance" or a "negative income tax" program in this country.

Thus, this brainstorm idea to promote unemployment and reward indolence, is not to be treated lightly. With the advancement of renticare, a "taxicare" aid movement for the poor sounds — to the liberal — more plausible than ever.

**288 In Crockett Received Social Security In 1965**

Two hundred eighty-eight persons in Crockett County received a total of \$208,392.00 in social security benefits in 1965. J. G. Keen, social security assistant district manager in San Angelo, revealed today, an increase of \$33,228.00 and 11 people over the year before.

A large part of the increase in payments resulted from changes made by the social security amendments of 1965, Keen said.
