For Nov. 7 special election

Absentee voting starts

The in-person, absentee ballot period opened Wednesday for those registered to vote in the Nov. 7 election, County Clerk Joan Beach said.

Registered voters will have until Nov. 3 to appear in person at the county clerk's office in the courthouse and cast ballots in next month's election.

Under a 1987 state law that relaxed absentee balloting requirements, Texans were given the option of casting absentee votes by personal appearance without having to give a reason for doing so.

A separate period still exists for those who cast absentee ballots by mail. That period began Sept. 8. Those who vote absentee

by mail must give a reason for not being to cast their ballot on election day.

The Nov. 7 statewide ballot will include 21 proposed constitutional amendments. The Mitchell County ballot will include a proposal asking the voters to create "a board of development and authorizing the commissioners' court of Mitchell County to appropriate from the county's general fund an amount not to exceed five cents on the \$100 assessed valuation to advertise and promote the growth and development of Mitchell County".

Next month's proposed constitutional amendments election includes measures that would raise the salaries of state legis-

lators, the lieutenant governor and Texas House speaker; authorize the issuance of bonds for water projects and state prison expansion; let the Legislature pass laws permitting courts to instruct juries on good conduct time and parole eligibility for defendants; allow state lawmakers to sanction and regulate raffles conducted by non-profit organizations; and several other issues.

Records show that of the estimated 12.3 million Texans eligible to vote, about 8.2 million are registered.

The Secretary of State's toll-free number for election information is 1-800-252-8683.

Concerned citizens hear reports

C.P.R. (Concerned Citizens Rebuilding) - Mitchell County heard reports and formed committees to study the duties/qualifications of elected members serving on public boards during a Monday night meeting.

Molly Bruce, chairman of the organization which meets every first and third Monday nights at the Lone Wolf Electric Medallion Room, said she had talked with the manager of the McDonald's restaurant in Snyder

who told her it will be decided Nov. 14 at a meeting in Dallas whether or not to locate one of the world-wide chain restaurants in Colorado City.

"They'll know by Nov. 14 if land has been secured or not," said Bruce, adding that the "man in Snyder is very anxious to locate here."

The group also heard about a proposed regional landfill. Jimmy Moody of Colorado City, one of the organizers of the proposed venture, said a 795-acre site in the

Iatan area is being eyed as a possible site because of the red clay in the area which will act as a natural liner. He anticipates 70 persons to be employed directly, and "about 125 all together". Life expectancy of the landfill is 95 years.

He said officials from Union Pacific Railroad are studying the possibility of providing rail service to the site.

Moody estimated that it will

Eldon Mahon saluted for judicial service

EDITOR'S NOTE: The following story was written by former Record publisher and editor Joe Bell, now residing in Fort Worth.

FORT WORTH - More than half a century ago when growing up in Loraine, Eldon Mahon dreamed of being a baseball player.

He is a failure to his ambition. All that he ever accomplished was to become one of the most respected judges within our whole 50 states. And, that really means in all the world.

U.S. District Judge Eldon B. Mahon's outstanding status as a jurist was attested to here during a day of tributes by his peers - judges who sit beside or above him on federal benches and lawyers who have won or lost cases in his courtroom.

Actually, Mahon and his wife, Nova Lee, had been toasted, toasted and toasted again by Fort Worth in a series of events which began three weeks ago.

But the most impressive ap-

plause came Friday, Oct. 5, during the observance of Judge Mahon Day, proclaimed by Fort Worth Mayor Bob Bolen.

First, when a portrait of a judge, commissioned by the Tarrant County Bar Association, was unveiled before a crowded courtroom in Fort Worth's U.S. Courthouse during a special convening of the entire U.S. District Court of the Northern District of Texas.

Second, when 600 persons - more than the Fort Worth Area Chamber of Commerce gathers for its annual banquet - paid \$35 per plate to dine with and to salute the judge for his 17 years of service on the federal bench.

Appellate justices, church bishops, judges, attorneys, university presidents, pastors, congressmen, mayors, business and community leaders joined in the salute.

They joked about Loraine. And, they brought guffaws from the crowd when they located Mitchell County's second largest city somewhere between Hermleigh and Silver or any other small community with an un-

familiar Texas name.

But there was no laughing when they spoke of Mahon, who at age 71 is moving to senior status as a federal judge, a sort of semi-retirement for anyone except Mahon, who will continue a busy court schedule.

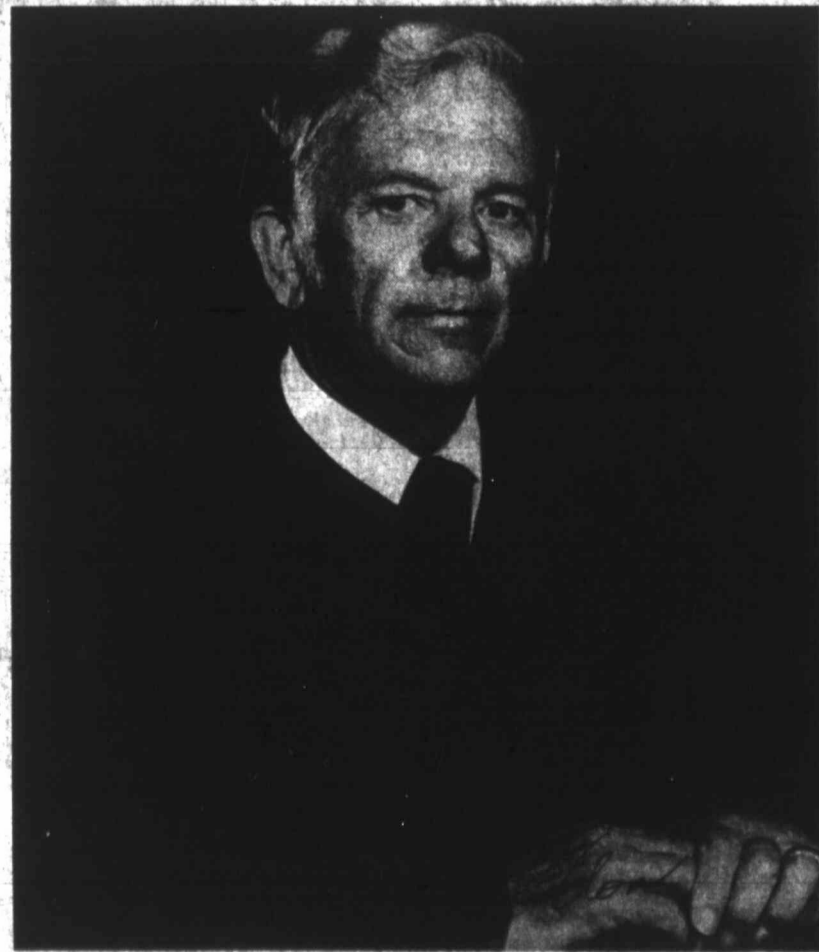
What the speakers said at the unveiling and dinner - in as many ways as a thesaurus - is that this jurist who began his public service 42 years ago in Colorado City is the kind of a judge our nation can look up to in trying times or good.

Justice Tom Reavley of the 5th Circuit Court of Appeals summed it up when he compared Mahon to a fine musician being true to his music. Mahon is a servant of the law just as the virtuous musician is a servant of his music.

"He is understanding," Reavley continued. "He understands the capacity of a human being for error. He is courteous, patient, studious, open minded, dignified, industrious and honest."

"No wonder he is my favorite

State president to be guest at meeting here

Mrs. Jewell Harris of Abilene, president of the Texas Retired Teachers Association, will be guest speaker at a TRTA district meeting here Wednesday, Oct. 5, 10 a.m.-2 p.m., at the Wallace Center.

Harris has served her community and state as a classroom teacher, as director of information, as a leader in her professional associations (both active and retired), and as a member of the state board of education.

A native of Abilene, she received her bachelor of arts degree at Christian College and her master of education degree at McMurry College. Further graduate study was at both Hardin-Simmons University and the University of Texas.

She began her teaching career at Holliday, Archer County, and entered upon a 22-year experience as a speech, drama, and English teacher at Abilene's Jefferson Junior High School. Next came a three-year assignment as director of information for Abilene schools.

Harris is a past president of the Texas Classroom Teachers Association, 1965-66, and also is past president of the Texas State Teachers Association, 1970-71.

In 1971 she was appointed by the governor to serve on the Professional Practices Commission, which produced the Code of Ethics adopted by teachers. During this period, she also served as a National Education Association director for Texas until 1974.

Harris retired from the Texas State Teachers Association as a professional staff consultant, regional director, in 1981 and that year received from the TSTA the State Human Relations Award for her leadership and promotion of human relations.

She was elected to the state board of education in 1982 and served there until 1985.

She also served as president of the Abilene Retired Teachers Association from 1983-85.

On March 10, 1989 she was awarded the Grover C. Morlan Medal for Education by Abilene Christian University.

In March, 1989 she was elected to the Region XIV Education Service Center's board of directors for a three-year term.

Mahon was born, reared in Louisiana and was graduated from Loraine High, McMurry College and University of Texas School of Law. He became Mitchell County attorney in 1947, then was elected to consecutive terms as district attorney (1948-60) and district judge (1961-63) for the 32nd Judicial District.

His "roots" in rural rearing, family ties and closeness to the people he served during his early career in Mitchell County are credited by Senior U.S. District Judge Hal Woodward for helping shape Mahon for distinguished service as a federal judge.

"He was taught high values, to accept responsibility," Woodward said. "He loves responsibility...the full satisfaction of serving that responsibility."

Woodward also cited Mahon's signal honesty in making judicial decisions. He emphasized that "no judge in the northern district...don't stop there...in the United States" is more astute defending the U.S. Constitution.

The burden of virtually being a special one-person board of education for Fort Worth's 90 public schools has been Mahon's for 14 years because of a desegregation/busing case ongoing in his court since 1975.

He is the "most powerful man in Fort Worth" on the basis of the school litigation alone, according to Tom Law, principal in a prestigious Fort Worth law firm, a leader in community affairs and

former regent of the University of Texas.

"Judge Mahon has treated his power as a trust," Law said, while describing Mahon as the "last bastion between the person and all-powerful government."

Law said Mahon stands high because he uses the constitution to "substantiate rights, not to maintain theory. He is a kind and generous human being...wise, honest with deep-felt humanity."

"More than any other," Law added, "He avoided judgeitis."

Mahon is recognized for the prodigious work ethic which sends him back to the office consistently on weekends. His court docket is increasingly crowded with a broadening array of civil and criminal cases.

Only a few weeks ago he finally declared Fort Worth schools integrated after 14 years of hearings, meeting with divergent citizen groups, extensive studies and decision-making. But the judge will monitor the school system for three more years before deciding if there should be or not be more hearings and remedies.

Fort Worth's most influential leaders in business and industry are among his friends, but he is tough on white collar crime.

He sent one of Fort Worth's prominent country-clubbers to prison in a matter fraud, but not before having the millionaire cough up \$2 million as part of his retribution.

When a group, including airline pilots, manufactured their own so-called church as a haven

for evading federal income taxes, Mahon sent them all to jail.

In his court he has tried more than a score of federal defense cases with swindlers and fraud that cost taxpayers in excess of \$200 million.

Ten weeks of testimony were completed three weeks ago in a civil racketeering case with 11 attorneys representing two savings and loans suing four defendants.

Cases generated by the savings and loan crisis is typical of the trend to bigness, complications in cases being filed in federal court. To have multiple defendants in the same trial with 40 to 100 counts is not unusual for cases now.

Nineteen defendants were indicted in the drug conspiracy case in which Mahon recently sent to prison for life the man police identified as the kingpin of Fort Worth drug trafficking. Four of the defendants were tried at one time.

Mahon mentioned none of the headline cases when he stood to respond to the commendations voice by his peers.

Briefly he choked as his eyes teared when he recognized the oodles of his family seated at a bevy of tables front and center of the crowd.

Then the man who has been in public service 39 of his 71 years spoke of his blessings and what

being a judge meant to him.

"We are judges of the law, not judges of politics or persons or special interests," Mahon said. "If this country ever falls prey to special interest, we lose our democracy."

Mahon noted that his transition to senior status coincides with the 200th anniversary of Congress' adoption of the Federal Judiciary Act establishing the federal court system, now with 712 justices and judges.

"Our federal courts reflect a true commitment of the American people to the rule of law," he said.

Recalling his participation in a recent U.S. judges mission to Russia, Mahon said that everywhere the judges traveled, they were besieged by Russians asking about America's rule of law.

Rule of law with an independent judiciary is what has kept America free and independent, he said.

Not only Loraine, but Mahon's church singing voice was the brunt of humor. However, the judge had the last laugh...

Just before returning to his table seat, Mahon croaked out his own vocal version of the country musical hit: "It's hard to be humble...but I'm doing the best I can..."

Naturally, that broke up the party.

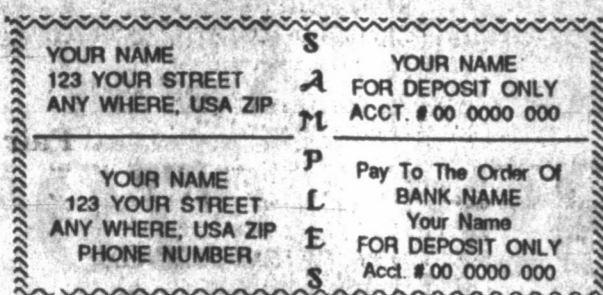

Arbor Day to be observed on April 27 next year

COLLEGE STATION—Texans wanting to help overcome the global warming trend by planting more trees will want to be aware of a new Arbor Day date in 1990.

Dr. Michael Walterscheid, forester with the Texas Agricultural Extension Service, said the state's Arbor Day will be celebrated next April 27, the last Friday of April. Texans had been observing it previously on the third Friday of January.

He said the Texas legislature

passed a resolution that was signed by Gov. Bill Clements changing the Texas Arbor Day date.

"Having Arbor Day in April allows trees to be planted by Texas residents when the trees are readily available for purchase from local outlets. The April Arbor Day date also coincides with attempts to establish a National Arbor Day," Walterscheid said.

He said the 1989 Congress established the last Friday in April for National Arbor Day, but each year the bill has to be introduced and hopefully a permanent National Arbor Day will be established soon.

Walterscheid said that because of a wide range of climatic regions in Texas, it has been difficult to establish one date for Arbor Day that is suitable for the entire state.

"Some trees are planted bare-root and the April date would be too late for seedlings. However, some homeowners plant trees

grown in containers and these are readily available for April planting," he said.

Walterscheid said agencies and organizations that work closely with trees in Texas have suggested that the state celebrate an "Arbor Season," beginning on the last Friday of January (the old Arbor Day) and ending on the new Arbor Day.

"Then trees could be planted throughout the Arbor season, with bare-root trees being planted in January and February and container-grown trees planted in March and April. Then arbor season could close with an April ceremony recognizing all the trees planted from January through April," he said.

Walterscheid said the Arbor Day observance provides an opportunity for schools, youth groups, service and garden clubs and other groups to focus attention on trees.

He said Arbor Day has been observed continuously in Texas since 1889, when it was initiated at Temple. But Nebraska was the first state to observe such a date as early as 1872.

Walterscheid said specialists with the Extension Service and the Texas Forest Service are helping evaluate the feasibility of planting enough trees around the world to ease the global warming threat.

Wolves prepare for Clyde

The Wolves are preparing to saddle up and ride into battle against a Clyde Bulldog team that also posts a 1-0 district record. The only difference being that Clyde hasn't lost a game out of the district either.

The Wolves are coming off of a 15-13 nailbiter against Merkel while Clyde thrashed Coahoma 26-0. And with Ballinger falling from their pedestal as the #2 team in the state after their loss to Wylie, this shapes up to be an important match-up.

"Ballinger's loss really opens up the district. It really was quite a surprise," Tom Ramsey said.

The Bulldogs have compiled a 6-0 record behind an offense that loves to throw the ball. They put the ball in the air more than any Clyde team in recent history, and are off to a better start than any other team in the district.

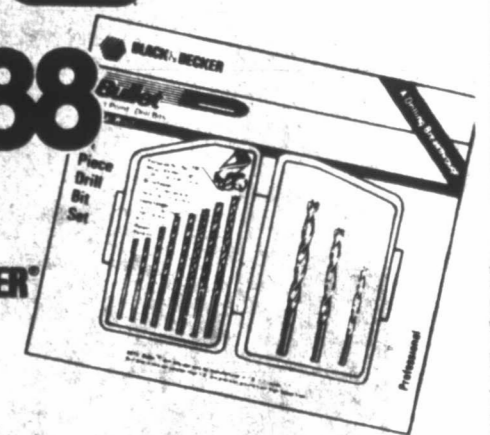

Bulldogs roll over Blackwell

The Loraine Bulldogs came off of their loss to Christoval in grand fashion as they stormed into Blackwell and came away with a 77-26 victory.

Loraine got the gears grinding early when Shawn Findley scored a two point safety when he caught a Blackwell quarterback in his own endzone and slammed him to the turf.

Less than one minute later Findley broke a tackle and dashed 40 yards for a Bulldog TD. Findley hit Rudy Sanchez for the point after and a 9-0 lead with

6:40 left in the first period.

Running back Rudy Sanchez broke free for a 24 yard scoring run and the Findley PAT left Blackwell down 17-0.

The Bulldogs struck again when Chris Phillips scrambled out of the pocket and found Sanchez for a 17 yard TD pass. Findley's kick put the score at 25-0.

The first quarter came to an end with a 12 yard scoring pass from Sanchez to Joey Lujan. The kick failed, but the Bulldogs were sitting pretty with a 31-0 lead.

The "Bulldog Blitz" struck Blackwell in the face two more times in rapid succession as Sanchez scored on a one yard run and Heath McGhee blocked a punt and fell on it in the endzone. The PAT on both scores failed and Loraine held on to a 55-14 with 1:23 remaining in the half.

Jason Jones took the ensuing kick-off and rambled 75 yards for a touchdown. Blackwell, however, was still down with 1:10 remaining in the half.

Findley struck paydirt yet again with a 44 yard run just 18 seconds after Blackwells' score. The PAT was good.

The half ended with the Bulldogs well in control of the game with a 63-20 lead.

Loraine slammed the door in Blackwells face quickly in the third quarter as Findley intercepted the ball in the endzone for six points and then rambled 14 yards for the final score.

The Bulldogs upped their record to 6-0 on the year with the district opening victory. Sanchez carried the ball 15 times for 184 yards while Findley added 171 yards on 11 carries.

Leading the defense was Leo Garcia with 12 tackles.

The Bulldogs host Ira in Loraine this week as thoughts of another playoff season run rampant.


been out and about I don't know much and there are those who probably think I don't know anything. You probably are right.

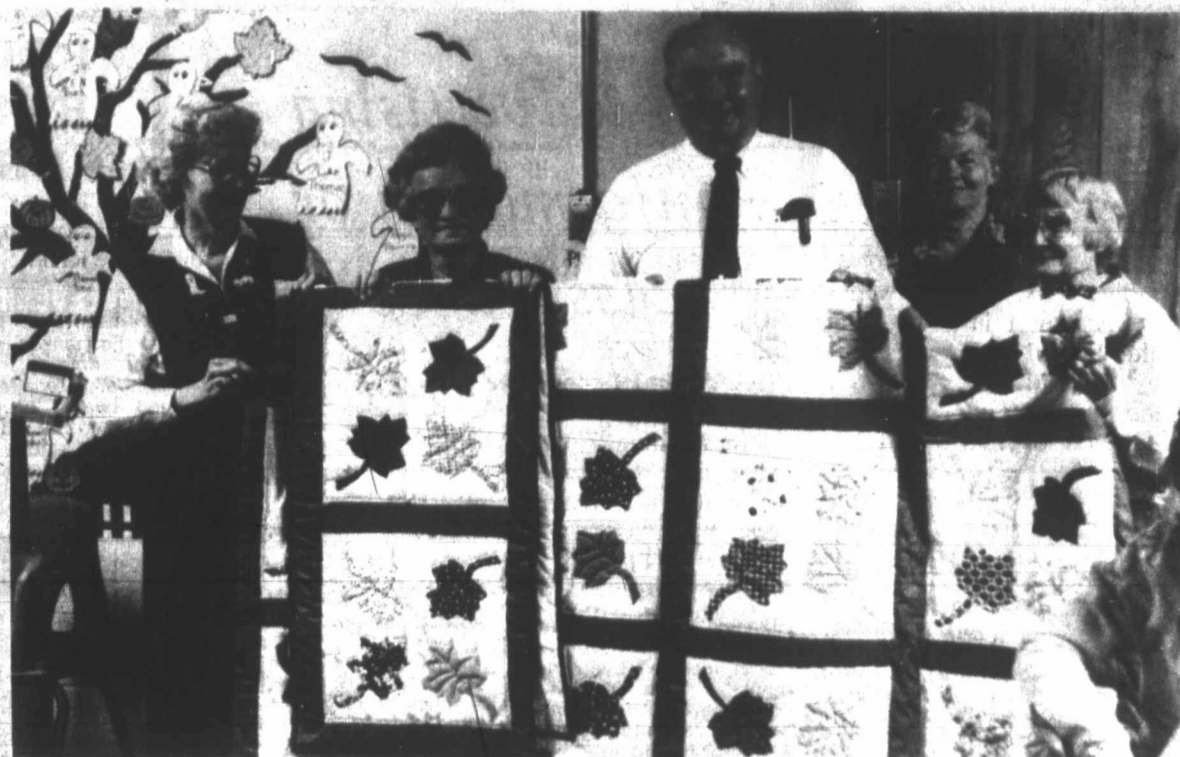

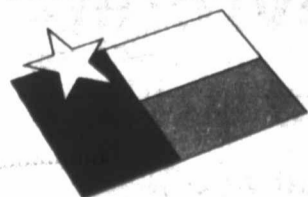

Letter to the Editor

Human rights

TO THE EDITOR: Recently, I visited your community investigating a local landmark and experienced the hospitality and friendliness of the townfolk. Still, I was a bit apprehensive about running around the area not knowing the tolerance for strangers in your community. After all, someone of my ethnic persuasion probably hasn't frequented Mitchell County for anything other than a rest-stop for over 100 years.

However, the manner in which this letter is taken will depend largely on the open mindedness and flexibility of the local populace.

Before I mention the theme of this letter allow me to cultivate a little food for thought on the subject of humanity vs. bureaucratic indifference.

During the "Buffalo Wars" of the 1870s, U.S. Army anthropologists under orders from Washington collected Native American specimens. These specimens were plains warriors killed in battle with U.S. troops. The army anthropologist would dismember the bodies of the plainsmen then throw the human parts into an oversized kettle and boil the parts until all that remained was defleshed bones. (Old Sergeant's Story - John Carlton) Of course, this was all carried out under the guise of science.

Today, eighteen thousand-five hundred skeletal remains of Native Americans collected during the 19th century are currently

stored in numerous forgotten compartments in the upper levels of the Smithsonian Institute.

One should keep in mind that these skeletal remains were obtained almost immediately and were not subjected to the standard unearthing when compared to the archeological discovery of the Australopithecus specimen dubbed "Lucy" in Hadar, Ethiopia during 1974.

Furthermore, from the Native American perspective one might say that eighteen thousand-five hundred skeletal remains could - in a symbolic sense - represent an act of genocide against one of the larger plains tribes of the 1790s such as the Comanche, Sioux or Osage, thereby, eradicating either of these tribes entirely. Yet, these human remains are considered historical artifacts in the name of natural science and subject to public display.

Granted, Archeology is a science and much can be learned by studying prehistoric cultures and ancient societies. If this is the case, then why is the vast majority of the human skeletal remains at the Smithsonian of today's ethnic people? In addition, doesn't it seem ironic that the Smithsonian is the only American institution where the minority in America is the majority?

Tom Parry, archeologist of the Bureau of Indian Affairs for the Anadarko/Muskogee Area in Oklahoma, stated that the continued disrespect of Native American burial sites, "...keeps open a festering wound of racism and discrimination."

Now for the theme of this let-

ter. While reviewing the Colorado City Museum, I had noticed a collection of human skulls and various skeletal pieces. Most of these items were identified as being "Indian". Yet, I did not see any remains labeled "Anglo-Saxon", "Mexican" or "Negro".

In light of these perceptions wouldn't it be an outrage, somewhat callous, and even ghoulish if the Kiowa Museum here in Carnegie, Oklahoma had procured and exhibited the skeletal remains of early Texas pioneers? Of course this idea is ridiculous - such an act would be criminal in today's society. Or is it?

The sad fact is that many 19th century Native American burial sites throughout the U.S. have been desecrated by "new world" ghouls. The most recent being the "Slack Farm" site in western Kentucky.

Last month here in nearby Anadarko, Oklahoma during the '89 American Indian Exposition federal agents raided the Indians

Arts and Crafts exhibit and confiscated a "deer skull".

Certainly, everyone must now be aware that the federal government operates on a completely contrary plane of existence. For instance, Native Americans weren't declared "human beings" until 1879 and were not declared citizens of the United States until 1924. Now that the federal government has said it's "okay" to burn the American flag, maybe the conscience of Anglo-America can become focused on the issue of human rights and human dignity of Native Americans and their culture.

America's reputation for defending human rights throughout the world is well known. Supposedly, this idea is one of the cornerstones for the "Bill of Rights" of the United States Constitution. Speaking as a Native American, it has become almost excruciatingly painful to see a nation such as communist Russia make such huge strides in

the area of human rights. Whereas, a nation that professes life, liberty and the pursuit of happiness has become bogged down in fineline and exclusive bureaucratic "doubletalk".

Imagine that! A nation that suppressed and smothered the ideas of free-thought and self-expression of the people is now recognizing the ethnic sovereignty of such people as the Poles, Armenians and Hungarians - not to mention the Jews. Getting the drift yet?

I close with the verse of Robert Freeman's, The Heathen, which expresses the hopes of the biblical adage; "Love thy neighbor as thyself".

Yes, you'd know him for a heathen If you judged him by the hide, But bless you, he's my brother, For he's just like me inside.

Guide teenagers into healthy snack habits

COLLEGE STATION--Now that school has resumed, families with teenagers may notice their snack supplies are usually low. Teenagers seem to eat constantly.

However, because teenagers also are growing constantly, they need the vitamins, minerals and protein they get from meals and from snacks, said Dr. Mary Kinney Sweeten, a Texas Agricultural Extension Service nutrition specialist.

Nutritionists admit that snacking or grazing is important to today's lifestyles, Sweeten said, citing a recent FDA Consumer article by Cheryl Weinstock.

However, getting into good snacking habits is critical for teens to benefit from snacking.

"Teenagers often fall into the habit of eating the same foods all the time," Sweeten said. "And sometimes the snacks they choose may not provide the variety of nutrients these youngsters need."

Sweeten pointed to an example from Weinstock's recent article "The soda that replaces milk at lunch may reduce the calcium in the diet. Weinstock suggested that teenagers replace the calcium by adding cheese to their hamburger they eat with the soda."

"Weinstock also cited a slice of

cheese pizza as an item popular with teenagers that also is a good source of calcium," Sweeten said. "Another good choice for teenagers is high-fiber foods, said Weinstock. They stimulate salivation, which helps wash away excess sugar from sugary snack foods. The nutrients provided by foods such as popcorn, fruits and vegetables are a welcome addition to the youngsters' diet."

Although snacking can be an asset, it becomes a liability if it results in more calories than the teen needs, Sweeten said.

"Obesity commonly starts during the teenage years," she said. "So, sensible snacking habits should be encouraged."

Weinstock said that nutritious snacks frequently are not as tasty and satisfying as the traditional candy, potato chips and sodas. However, there are methods to satisfy both the sweet tooth and still hold down the calories.

Sweeten said, "If you have a craving for sweets, a bite-sized candy bar or half a popsicle is better than a regular-sized candy bar or a whole popsicle."

Nutritional literacy and simply paying attention to foods they choose is the best way for teens, or adults, to develop good snack habits and to make eating between meals work to advantage.

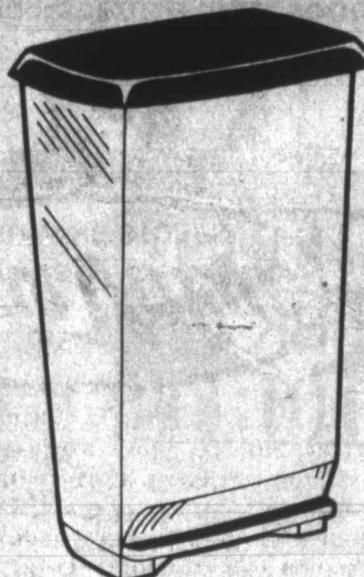
