

Doc Barjenbruch Hired as City Manager Here

William (Doc) Barjenbruch, Wellington business man and former member of the City Council, has been hired as city manager, Mayor Hiram Cudd announced this week.

He will begin work Sept. 1 and will succeed the late Bura Handley.

Barjenbruch did not apply for the job, but it was offered him by the council, which is familiar with his knowledge of city affairs as well as his knowledge of engineering and those other qualities that will be required in his work as city manager.

Barjenbruch was elected to the city council in a special election July 22, 1954, and he served until April 20, 1959.

He has owned the Barjenbruch Implement Company here since 1955.

Barjenbruch said that he has hired John Nash to operate the business for him.

A native of Omaha, Nebr., Barjenbruch came to Wellington when he was 9 and was graduated from high school in 1930. He attended Draughon's Business College and Hemphill Diesel School.

During the World War II period, he served in the Air Force five and one-half years, and attended a number of its technical schools.

Dr. J. C. Agee Dies Wednesday in Dallas

Dr. J. C. Agee, who lived in Wellington for more than 20 years before moving to Dallas two years ago, died there of a heart attack Wednesday night, Aug. 5. He was about 60.

Funeral services were conducted at Dallas Friday morning and graveside rites were held at 4 p.m. Friday at Childress Cemetery. Masonic rites were conducted by members of the Wellington Lodge.

Dr. Agee was a member of the Kiwanis Club here and active in other civic affairs. He was educated at West Texas State College and taught for several years before studying to become a chiropractor.

He was married to the former Miss Opal Glover of Childress.

Survivors are his wife; three children, Mrs. B. W. Hughey of Houston, Billy Frank Agee of Dallas, and James C. Agee of Kilgore. There are three grandchildren.

Official AQHA Show

100 Quarter Horses for Show Sept. 12

At least one hundred of the Southwest's finest quarter horses are expected for the annual Collingsworth County Quarter Horse Show Saturday, Sept. 12, according to John Holton, chairman.

This will be approximately 25 per cent more than were in the show last year.

Inquiries already have been received from a number of points over Texas and as far away as Houston, from Oklahoma and Kansas.

There will be two sections to the event, which is an American Quarter Horse Association approved show.

The cutting contest and reining contest will be held at the rodeo arena Saturday at 10 a.m. and the halter classes will be seen at Marian Airpark baseball field at 1 p.m.

The show is held in conjunction with the Collingsworth County Free Fair each year. Horses shown in the performance classes do not have to be shown at halter.

Both halter and performance classes are limited to AQHA registered horses, Holton said.

Gene George of Amarillo will judge the show. Cliff Campbell will be ringmaster and Frank Anderson secretary.

The cutting contest is open to cutting horses of all ages, as is the reining contest. Both are official AQHA contests.

First place animals will receive a trophy.

The grand champion mare, stallion and gelding and the reserve champions in the same groups will be named. Each grand champion will receive a trophy and ribbon and each reserve champion a rosette.

First place winners will receive a trophy and ribbon and winners of second through sixth places will receive ribbons. The halter classes include:

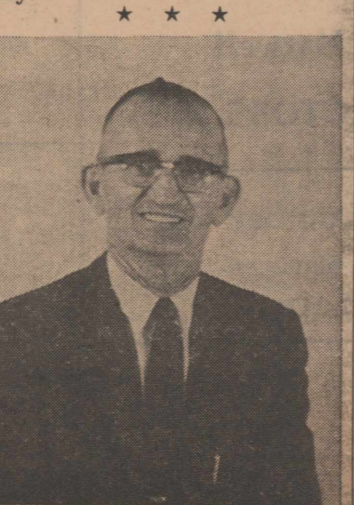
This is the first time he has held a meeting there, although it is near where he grew up.

Deadly to Other Insects

Big "Killer" Wasps Vicious in Name Only

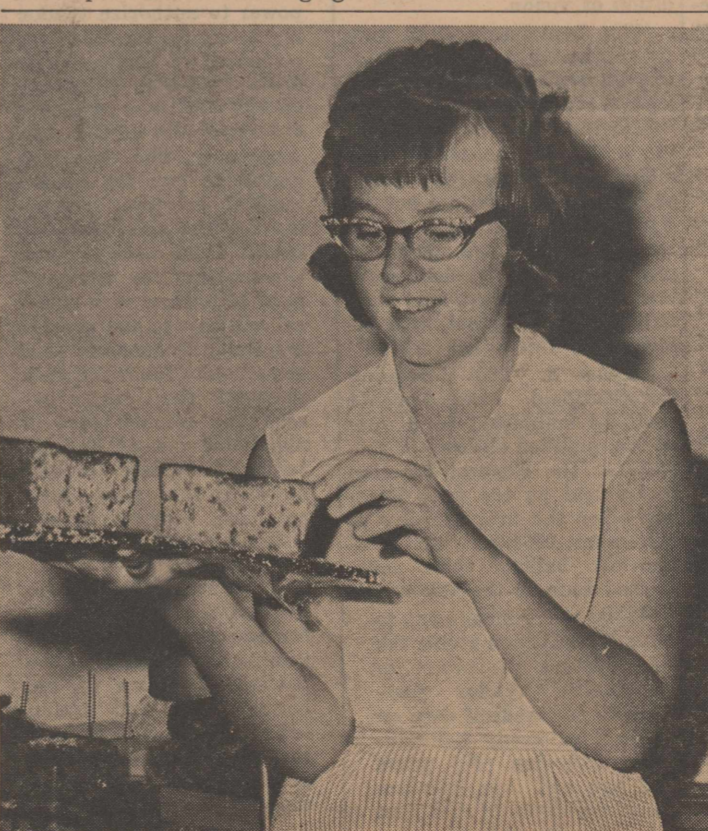
The big black wasps seen in large numbers here this summer, are identified as killer wasps by County Agent Cecil Regier.

"That doesn't mean their sting is fatal to man; it isn't," he hurriedly assured. "They get that name because they are the enemy of other insects."

"They are the worst enemy of the cicade or locust, as well as other damaging insects. In fact they may be classed as a beneficial insect." Their sting has a paralyzing effect on insects much larger than they.

The wasps reach an inch or more in length and are considerably larger around than a bumble bee. They are responsible for holes up to three-quarters of an inch in diameter often found in yards. While there are always a few around, the number this year is much larger than at any time recently.

As for their sting, in spite of their size and the size of their stinger, even a child will hardly feel it. Apparently they do not bother humans at all unless provoked into stinging.

59 Rockets Report for Practice Mon.

Hundred-degree weather notwithstanding, the defending district champion Wellington Skyrockets report Monday, Aug. 17 for football practice.

Fifty-nine boys, including 12 returning lettermen, are due to start work under head coach Don Beck and B team coach James Stavenhagen, and to get acquainted with their new line coach, Raymond Kauffman.

Rocket workouts in the morning will include skull practice from 9 to 10, then the boys will go on the field, working in shorts, from 10 to 11.

Evening skull practice will be from 4 to 5, followed by workouts in full pads on the

field from 5 to 7 p.m.

The Rockets were the heaviest losers by graduation of any 2-A school, Coach Beck said, with 12 lettermen going off the team. Another 12 are returning, however, and these include three offensive and three defensive starters.

Assessing prospects, Coach Beck said the Rockets will be two deep in experience in every position and three deep in some. These are boys with either B team or varsity experience.

One scrimmage is scheduled with the Claude Mustangs on Monday, Aug. 24 at 7 p.m. at Powell Field.

Claude, playing in District 1-A, won 9 games and lost only one last year, and has 10 starters back. The Mustangs are ranked second only to Stratford in their district.

White Deer Bucks comes in to District 2-A this season, having dropped from Class AA. They replace the Lefors Pirates who stepped down to Class B.

Already the Bucks are the pre-season favorites to win the 2-A title—the position the Rockets now hold.

Rocket coaches are taking a hard look at their opposition this year.

The accident occurred near Flomot, as Tommy and Danny Martin were on route here from Lubbock, where they were summer students in Texas Tech.

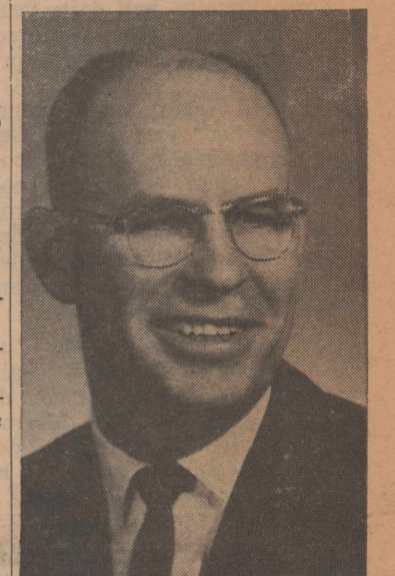
Cheer Leaders to Tech School

Divisions for baked products, food preservation, textile furnishings, crocheted and clothing are included, and any woman 18 years of age and over who is not enrolled in school is eligible to participate.

These rules will apply: entries must be in place by 10 a.m. Friday, Sept. 11 and remain until 5 p.m. Saturday. In the canned foods division, all fruit jars must be clean and of standard quart or pint size, with pints used for jams and jellies. Paraffin seals will not be allowed.

All articles must have been canned during the year from September 1963 to September 1964.

First, second and third place ribbons will be awarded in each class.

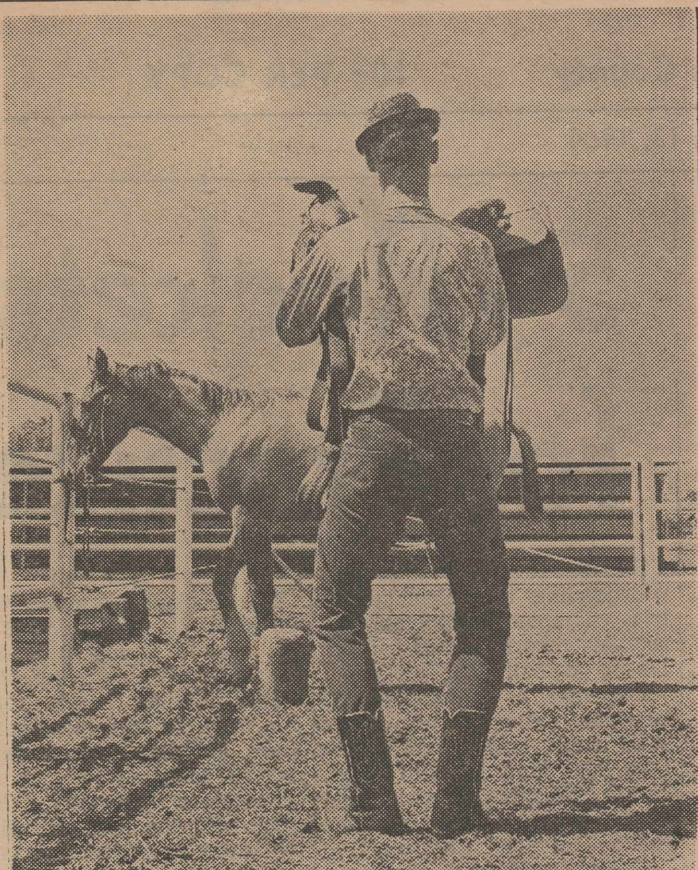

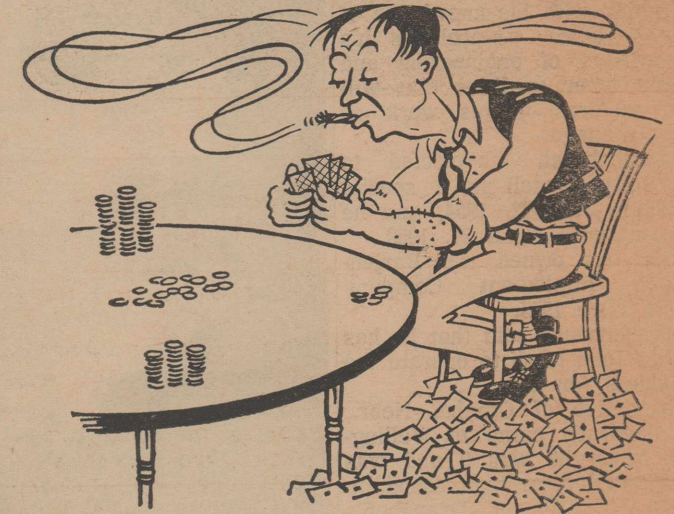

Proposed CONSTITUTIONAL AMENDMENT NUMBER THREE ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 3, 1964.

SENATE JOINT RESOLUTION NO. 10 proposing an Amendment to Section 51a of Article III of the Constitution of the State of Texas by adding a new Subsection to be known as 51a-2; giving the Legislature the power to provide, under such limitations and restrictions as may be deemed by the Legislature expedient, for direct or vendor payments for medical care on behalf of individuals sixty-five (65) years of age or over who are not recipients of Old Age Assistance and who are unable to pay for needed medical services; providing for the acceptance of financial aid from the Government of the United States for such medical payments; providing that the amounts paid out of state funds shall never exceed the amount that is matchable out of Federal funds for such purposes; providing that certain means relating to the correction or remedying of abnormalities of vision shall be included within such medical care service or assistance; providing for the necessary election, form of ballot, proclamation, and publication.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 51a of Article III of the Constitution of the State of Texas be amended by adding thereto a new Subsection to be known as Subsection 51a-2, which shall read as follows:

"Subsection 51a-2. The Legislature shall have the power to provide by General Laws and to make payment for same, under such limitations and restrictions as may be deemed by the Legislature expedient, for direct or vendor payments for medical care on behalf of needy individuals sixty-five (65) years of age or over who are not recipients of Old Age Assistance, and who are unable to pay for

needed medical services. The payments for such medical assistance on behalf of such needy individuals shall be in such amounts as provided by the Legislature; provided, however, that the amounts paid out of state funds for such purposes shall never exceed the amount that is matchable out of Federal funds for such purposes; provided further, however, that such medical care, services or assistance shall also include the employment of objective or subjective means, without the use of drugs, for the purpose of ascertaining and measuring the powers of vision of the human eye, and fitting lenses or prisms to correct or remedy any defect or abnormal condition of vision.

"The Legislature shall have the authority to accept from the Government of the United States, such financial aid in the form of medical assistance on behalf of the needy individuals sixty-five (65) years of age or over who are not recipients of Old Age Assistance, and who are unable to pay for needed medical services, as such Government may offer not inconsistent with restrictions herein set forth."

Section 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors of this state at the General Election to be held on the first Tuesday after the first Monday in November, 1964, at which election all ballots shall have printed thereon the following:

"FOR the Amendment to the Constitution giving the Legislature the power to authorize vendor payments for medical care on behalf of needy individuals sixty-five (65) years of age and over who are not recipients of Old Age Assistance, and who are unable to pay for needed medical services; providing for the acceptance of funds from the Federal Government for the purpose of paying such medical assistance; and providing that the amounts paid out of state funds for such purposes shall never exceed the amount that is matchable out of Federal funds; provided further, however, that such medical care, services or assistance shall also include the employment of objective or subjective means, without the use of drugs, for the purpose of ascertaining and measuring the powers of vision of the human eye, and fitting lenses or prisms to correct or remedy any defect or abnormal condition of vision."

Section 3. The Governor of the State of Texas is hereby directed to issue the necessary proclamation for said election and have the same published and held as required by the Constitution and the laws of the State of Texas.

Proposed CONSTITUTIONAL AMENDMENT NUMBER TWO ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 3, 1964. HOUSE JOINT RESOLUTION NO. 8 proposing an amendment to Section 59 of Article XVI of the Constitution of the State of Texas establishing certain requirements relative to the enactment of laws affecting particular conservation and reclamation districts; providing for an election and the issuance of a proclamation therefor.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS: Section 1. That Section 59 of Article XVI of the Constitution of the State of Texas be amended by adding thereto a new Subsection which reads as follows:

"(d) No law creating a conservation and reclamation district shall be passed unless notice of the intention to introduce such a bill setting forth the general substance of the contemplated law shall have been published at least thirty (30) days and not more than ninety (90) days prior to the introduction thereof in a newspaper or newspapers having general circulation in the county or counties in which said district or any part thereof is or will be located and by delivering a copy of such notice and such bill to the Governor who shall submit such notice and bill to the Texas Water Commission, or its successor, which shall file its recommendation as to such bill with the Governor, Lieutenant Governor and Speaker

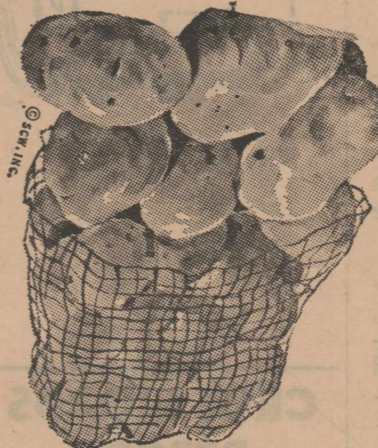

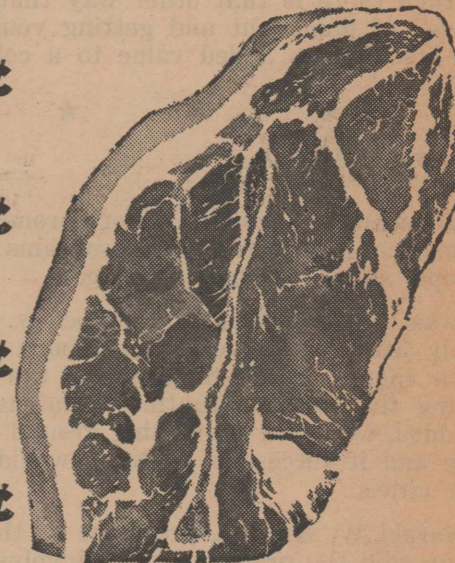

Finances No Longer Are a Reason for Not Going to College

This newspaper believes that any qualified Collingsworth county student who really wants a college education can get one in spite of high costs. An article by scholastic authority William Levy in a current magazine points out that more than \$1 million in potential scholarship funds were unused last year, even as thousands of students did not go to college because they did not have the money.

"Besides the direct awards from colleges and universities which often go unclaimed by the public, millions of dollars of scholarships and loan funds offered by private groups such as corporations and unions often are not issued because of lack of publicity given these opportunities," he says.

Because of this lack of use and lack of interest, some of these funds are being withdrawn—unfortunate since education to the individual is becoming more and more important.

Some resourcefulness is due on the part of the student who wants to go to college and feels he can't. He may have to write many letters and he can be sure he will run into some dead ends. But somewhere, this student and a college can get together.

At mid-summer, it is a little late for a student to start hunting a scholarship, but there is still the possibility. It is not too late for the student who will graduate in 1965 or 1966.

This is only one approach to the problem of a student finding his or her way through college. There are student loans and some of the best of these loan plans are those offered through participating local banks.

And then there is that other way that many students use of going out and getting yourself a job. That in itself gives added value to a college education.

How to Stop

The government's tobacco report prompted a number of medical groups to set up programs designed to help people stop or curtail smoking.

One was the American Cancer Society. Almost immediately after the government report, the Society set up a course in Washington for the purpose of "upsetting the smoking routine." The nation's capital, it added, would be the testing ground for the new program and if successful there, it would be offered in other cities.

Dr. Harold W. Krough, president of the Washington group said the program would involve seven one-hour sessions over a five-week period. "An attempt will be made to control, without necessarily giving up, the smoking habit," he said.

The system involves no drugs, nor does it require abstinence from foods or liquor. It was devised by Dr. Daniel Horn, of the U. S. Public Health Service.

The Cancer Society would say nothing about the program's method except that it is designed to help stop or curtail smoking.

Smokers who want to quit, but can't, at least on their own volition, might find encouragement in the ACS method, and approach.

Proposed CONSTITUTIONAL AMENDMENT NUMBER ONE ON THE BALLOT

PROPOSED CONSTITUTIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 3, 1964. SENATE JOINT RESOLUTION NO. 6 proposing an amendment to Section 5 of Article VII of the Constitution of the State of Texas so as to remove the authorization to transfer not exceeding one per cent annually of the total value of the permanent school fund to the available school fund.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS: Section 1. Section 5 of Article VII of the Constitution of the State of Texas is amended to read as follows:

"Section 5. The principal of all bonds and other funds, and the principal arising from the sale of the lands hereinbefore set apart to said school fund, shall be the permanent school fund, and all the interest derivable therefrom and the taxes herein authorized and levied shall be the available school fund. The available school fund shall be applied annually to the support of the public free schools. And no law shall ever be enacted appropriating any part of the permanent or available school fund to any other purpose whatever; nor shall the same, or any part thereof ever be

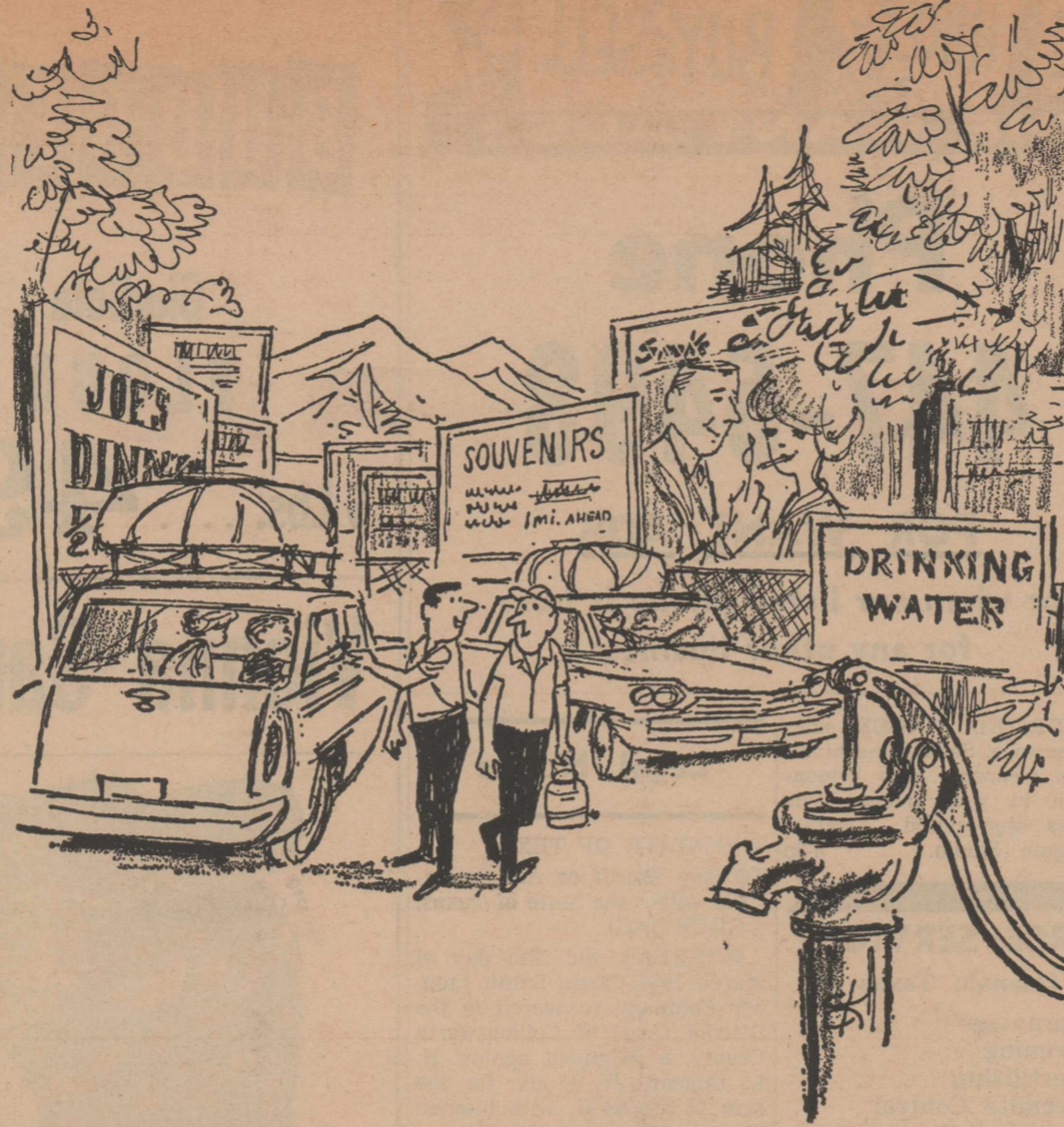
appropriated to or used for the support of any sectarian school; and the available school fund herein provided shall be distributed to the several counties according to their scholastic population and applied in such manner as may be provided by law."

Section 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified electors at an election to be held on the first Tuesday after the first Monday in November, 1964, at which election all ballots shall have printed thereon the following:

"FOR the Constitutional Amendment to remove the authorization to transfer not exceeding one per cent annually of the total value of the permanent school fund to the available school fund."
"AGAINST the Constitutional Amendment to remove the authorization to transfer not exceeding one per cent annually of the total value of the permanent school fund to the available school fund."

Section 3. The Governor of Texas shall issue the necessary proclamation for the election and this amendment shall be published in the manner and for the length of time as required by the Constitution and laws of this State.

Hunting Season and Bag Limits Announced

AUSTIN.—A longer big-game season in more than half of the State, and other fall wildlife harvest benefits were announced by J. Weldon Watson, executive director of the Parks and Wildlife Department.

Earlier it had been reported that a two-weekend open season on white-winged doves had been requested and approved by the U.S. Fish and Wildlife Service.

Here is a detailed rundown on the hunting seasons as the result of action taken by the Parks and Wildlife Commission at its July meeting:

The Commission authorized opening the deer season in most counties under regulatory responsibility on the second Saturday in November (Nov. 14) two days before the legal opening in 105 counties under statutory regulations. The mule deer country in the Trans-Pecos was excepted. Season for deer, elk and turkey in those counties west of the Pecos was set to begin the last Saturday of November for 15 consecutive days (No. 28 to Dec. 12).

The Commission barred the .22 rimfire cartridge in the taking of deer, antelope, elk, aoudad sheep and desert bighorn sheep in all counties where the Commission has regulatory responsibility for these animals.

A sanctuary area in South Texas border counties where white-winged doves and chachalacas may not be taken was redefined as that portion of Texas south of a line extending along U.S. Highway 83 from the Starr-Japata county line to Mission, from Mission to U.S. Highway 281 via FM 1016 and FM 1926 and along U.S. 281 to the west city limits of Brownsville.

Following is the list of the bag limits and seasons on the major game species in the various regulatory authority districts:

Panhandle District
(Armstrong, Bailey, Briscoe, Carson, Castro, Childress, Cochran, Collingsworth, Cottle, Dallam, Deaf Smith, Donley, Gray, Floyd, Hale, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lamb, Lipscomb, Moore, Motley, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher and Wheeler counties).

Antelope: Open season shall be Oct. 3 through Oct. 6 by permit only. Bag limit one antelope per season.

Deer: Open season second Saturday of November through Nov. 29. One buck per person, or by permit only, one antlerless deer may be taken on areas to be designated by the Parks and Wildlife Department. No person may kill or possess more than one deer taken in the Panhandle district. There will be an open season on aoudad sheep for the second time in the history of hunting in Texas. This season will be Dec. 11, 12 and 13. Bag limit, one sheep per person by permit only. The Parks and Wildlife Commission will designate the number of aoudad sheep to be taken at a later date.

Greer, Harmon Counties To Save Indian Relics

The Museum of the Great Plains in Lawton, Oklahoma, has received a \$5,100 contract to conduct salvage archaeological excavations in the proposed Mangum Reservoir on the Salt Fork of Red River in Greer and Harmon counties, Oklahoma, it was announced in Mangum Tuesday by Marvin E. Tong, Jr., director of the museum.

The museum will spend approximately twelve weeks excavating eight sites that were originally located by a survey party of the University of Oklahoma several years ago.

The field work will be directed by Tyler Bastian, museum research associate in anthropology, and Frank C. Leonard, curator of anthropology, Tong said. There will be several laborers employed, and a laboratory assistant will also be on the excavating crew.

The contract was awarded the Museum of the Great Plains by the Southwest Region of the National Park Service located at Santa Fe, New Mexico, and is a part of the nationwide River Basin Surveys administered jointly by the National Park Service and the Smithsonian Institution.

Sites to be excavated in the area, Tong said, include late prehistoric Indian sites, dating from about 1100 to 1400 A. D., as well as some earlier sites that may date as much as 3000 B. C.

The scientific archaeological excavations by the Museum specialists will reveal additional information concerning the prehistoric Indians of western and southwestern Oklahoma prior to the arrival of the white man in the New World.

Tong said the work in the proposed Mangum Reservoir area is most important since very little information is known about early Indians of this area. Representative artifacts recovered by the work will be made available to the National Park Service, and the University of Oklahoma. The major portion of the material, however will be returned by the Museum of the Great Plains for further research and study by archaeologists.

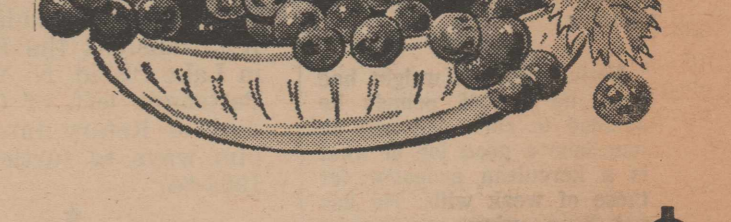
