BANDITS ROB GOLDTHWAITE BANK

CENSUS ENUMERATORS FAIL TO FIND MANY RESIDENTS

DISCOURAGED, HOUSTON MAN KILLS HIS CHILD AND HIMSELF

WIFE BADLY HURT BUT IS TO RECOVER

Charles Whitlock Is Dead of Pistol Wound

LEAVES NOTE FOR CORONER

Wants Cheap Burial by Episcopal Church

HOUSTON, April 16. (P)—Charles H. Whitlock, 52, was found dead in bed today with a pistol clutched in his right hand, his five-year-old daughter, Carolyn Louise, suffering from gunshot wounds which subsequently proved fatal and his wife seriously injured by hammer blows on her head.

According to hospital attendants, the 34-year-old wife said her husband called her out on the porch to talk about financial matters. She said he grabbed a hammer, hit her over the head and tried to choke her.

The woman said the baby ran out on the porch screaming and the husband grabbed the child and put her on the bed in the room. Mrs. Whitlock ran downstairs calling for help. It was while she was gone, Mrs. Whitlock said, that Whitlock shot the baby and then himself.

A note in the man's pocket read: To the Houston city coroner.

Dear Sir: No mystery here. Just a fact of thorough discouragement. I am at my capacity in every way. I am taking my wife and baby with me to avoid suffering on their part; without my providing protection I am no longer able to furnish.

Please order our bodies to the city hospital there to be held until Rev. James E. Allen, rector of Christ Episcopal church, gets in touch with you. I have asked him and his congregation to furnish a cheap funeral for us.

Please be advised, I am the last of my tribe, my wife has no close relatives, so please do not allow any undertaking establishment to have our bodies, as there is no source from which they can expect a dollar for their services and without the dollar they will not be interested. I wish you all good-yours truly, Charles H. Whitlock.

LEWIS COX IS CANDIDATE FOR ANOTHER TERM

Announcement of his candidacy for re-election as commissioner of precinct 2 was authorized today by Lewis O. Cox, who is serving his first term in the position.

Mr. Cox, a Democrat, is well known by reason of his civic activities and his connection with the American Legion, of which he was formerly commander.

Believing that he has been a "working" commissioner in the fullest sense and that his record entitles him to another term, Mr. Cox has come out for re-election. Since the first day of his term, he has taken county affairs, and particularly in county affairs, and participated in the road problems of this precinct.

He has often been found with his road crew, and has wielded a shovel on more than one occasion when emergency work was demanded. This large precinct has so many miles of road that constant decisions must be made as to which parts need work most.

Recently Mr. Cox made a trip to Austin and secured a settlement of the highway 33 problem. Contract for grading and drainage of this road from Pampa to the Carson paving will be let April 22.

STOCK JUDGING PLANS DRAWN BY LOCAL MEN

More details of the stock judging contests to be held here May 3 under the auspices of the Board of City Development and the vocational agriculture department of Central high school, were announced today.

Poultry judging by boys from Gray and neighboring counties will begin at 10 a. m. at the B. C. D. auditorium. In the production or utility class, Rhode Island Reds, Bared Rocks, and English White Leghorns will be used, while in the American Standard class Rhode Island Reds, Bared Rocks and American White Leghorns will be judged. All the boys will participate in each class.

At noon the B. C. D. will entertain the teams at luncheon. Then at 1:30 p. m. all will go to nearby farms to judge Jersey and Holstein cows.

Poultry judging will be directed by R. B. Galoway, extension worker for the Panhandle Lumber company. Frank B. Phillips, head of the department of agriculture at Canyon Teachers college, will be in charge of dairy judging.

Loving cups will be given the winning team in both divisions, and ribbons will be given members of each team. In addition, highest scoring individual judges will get prizes of \$5 and \$2.50 for the first two places and ribbons for the first three.

George Briggs and Prof. J. L. Lester are in charge of local arrangements.

CRISIS HERE IS RECORDING OF CITIZENS

Those Missed Asked to Use Coupon at Once

PERIOD MAY BE EXTENDED

Hundreds Believed to Have Not Been Seen

A last plea to the citizens of Pampa and Gray county who have not yet been enumerated, to send in their names to Galen R. Smith, supervisor of census, Amarillo, was made today by civic bodies and others. The enumerators reported today that they are having extreme difficulty in securing information, and that although tomorrow is the last day they still lack hundreds of names in completing their enumeration.

Mr. Smith has indicated that the time for enumeration may be extended in Pampa but he has not yet made an authorized announcement to that effect. All citizens who have not been enumerated—and there are hundreds of them in Pampa, the census takers say—are urged to fill out the census coupon which appears on this page today and mail it to Mr. Smith.

"It's the loyal duty of every citizen to be counted in this great enumeration," Postmaster W. A. Crawford said today. "In fact, a man is not patriotic if he isn't. It's not only the duty that he owes Uncle Sam, but a citizen should assume the same attitude toward fulfilling this duty as he does when there is a call to arms. He not only owes this duty to the government which protects him but to his native state, county and city."

One enumerator stated she seldom found residents at home in the afternoon, but that she left blanks to be filled out and has never received them. Mr. Crawford pointed out that a person who refuses to answer the questions, or fill out the blanks is subject to a heavy fine.

Many citizens, the enumerators say, have said, "I haven't got time to answer your questions, I'm busy now, come to see me next week." Some of them have been indignant that the enumerators "presumed to inquire into their business." One woman said, "I can't see you; I can't do nothing for you."

Supervisor Smith of Amarillo has instructed the enumerators to have any person who refuses to give the necessary information arrested. He also warns those who have been given blanks to fill them out and send them in at once.

Hope for Rains to Quench Fires

IRVINE, Ky., April 16. (P)—Forest fires, which for days have been raging on the other side of the mountains in Virginia and North Carolina, today were consuming hill sides of timber near here and other points in Eastern Kentucky.

Conditions near here became serious yesterday when a sawmill was destroyed, with lumber valued at several hundred dollars. Fears were expressed that if the flames were not checked within 36 hours they would reach the oil storage tanks at Bear Tracks.

This section is not under the jurisdiction of the state forestry department and is sparsely settled, so no efforts were being made to control the flames.

At Lexington, W. E. Jackson, state forester, said wardens were trying to check the flames at other districts. He expressed the opinion the menace would be ended by rain.

KANSAS "JAKE" VICTIMS WADE IN OIL SLUSH HOPING TO HELP AILMENT, BUT EFFORT FUTILE

GULF WELL IS FLOWING AFTER SHOT OF NITRO

WICHITA, Kans., April 16. (P)—With scores of men and even women and girls dragging inert feet to petroleum slush ponds of Southern Kansas for a week, hoping to find relief from "jake paralysis," a malady believed caused by drinking Jamaica ginger, health authorities here today said the pilgrimages were futile.

Dr. R. E. Hobbs, city physician, who was conducting a survey to learn if there were enough needy victims here to warrant opening an emergency ward in the civic auditorium, declared the slush pond waders had not been aided.

"It's the bunk. It would be impossible for the sulphur compounds in the fluid to get through the skin," Dr. Hobbs declared. "If it were a skin disease the wading might help. But 'jake paralysis' is clearly a nervous ailment, and the victims must rest and wait for the nerves to become built up."

Some of the waders have reported, after their footbaths, that they felt a little better, but so far as could be learned nobody has been visibly helped.

Church Observes Holy Procession

ROME, April 16. (P)—A solemn procession in the Church of St. Mary Major, otherwise known as the Liberian Basilica, this morning ushered in ceremonies attendant on Rome's observance of the Wednesday of Holy Week. The chanting of priests recounted the story of the passion, as told in the gospel of St. Luke, preceded by two lessons taken from the prophet Isaiah, foretelling the sacrifice of Christ.

The afternoon was marked by the signing of the office of "tenebrae," so-called in remembrance of the darkness said to have spread over all the earth at the moment of Christ's death on the cross.

CENTRAL GIRLS WIN DEBATE HERE

The girls' debating team of Pampa high school was awarded a decision from the Panhandle girls' team at Central high school last night. Miss Leona Raibourn, teacher of LeFors, who acted as judge, explained that she was unable to stay for the debates between the boys' teams of the two schools. Miss Fannie May, the Pampa debate coach, was unable to secure a judge on such short notice, and the teams debated without one.

At Panhandle, Tuesday night, the girls' team won from the Panhandle while the Pampa boys' team lost. A critic-judge from White Deer gave the decisions. Miss Raibourn last night in announcing her decision said she had no criticisms to make.

The Pampa teams included Ruth Wakeman and Vivian Vickers, and Sam Kieth and Charles Frost. The Panhandle girls' team comprised Frances McKenzie and Jenine Nelson. The Panhandle boys' team included Alfred Fullington and Miss Fern Crum. Miss Crum was permitted to take the place of the other boy member of the Panhandle team after he broke an arm.

The subject debated was: "Resolved, That the Sterling Plan for financing a State System of Highways in Texas Should Be Adopted."

The Pampa teams will compete in the district tournament at Canyon Friday and Saturday.

Land Campaign Will Be Tried

WACO, April 16. (P)—Recommendations, adopted just before the land utilization conference adjourned, pointed the way today for better conditions on Texas farms.

One recommendation would provide for a union of all agencies having to do with proper utilization of land in an effort to carry forward an educational campaign through a committee appointed by President T. O. Walton of Texas A. and M. college.

Such a campaign would be aimed at dissemination of information on conservation, on growth of feed products, on finishing of Texas cattle in Texas, on production of food and other products and a "live at home" program.

TWO MEN IN NOON RAID ON SMALL TOWN

Loot Is Estimated to Be Not Over \$4,000

CAR SPEEDING SAFELY AWAY

Cashier and Patron Forced to Delay Alarm

BROWNWOOD, April 16. (P)—The First National bank at Goldthwaite was robbed of between \$3,000 and \$4,000 by two men shortly after noon today, according to reports here.

Goldthwaite is 40 miles south of here. Daniel H. Harrison, cashier, and a customer were said to have been the only persons in the bank when the robbers entered with drawn guns. They quickly gathered up all available money and fled in an automobile after warning the cashier not to give an alarm until they were out of sight.

The robbers' car was said to have left Goldthwaite in the direction of Brownwood, but a traveler who arrived in the town shortly after the robbery said a car of the same description of that used by the robbers was seen speeding towards Waco.

NEW ORLEANS, April 16. (P)—Three bandits with shotguns and pistols today held up the Broadmoor branch of the Hibernia Bank and Trust company here, locked four employes of the bank in the vault and escaped with \$3,600.

Student Flier Is Killed in Crash

SAN ANTONIO, April 16. (P)—Lieutenant Stanley H. Ayre, student flier at Brooks Field, was killed when a De Havilland airplane he was flying crashed near Southton, six miles southwest of here this morning. His home was at Monticello, Ill.

The accident, the second fatality at Brooks Field from airplane accidents within the year, happened near the same point, almost exactly a week to the hour from the crash that resulted in the death of his classmate, at both West Point and Brooks field, Lieut. Bert C. Muse. Both accidents were similar also in that a De Havilland plane, the last of which will soon pass from the service, were being flown by pilot pilots.

Officers who investigated the wreckage expressed belief that the accident was not due to structural failure. The ship did not burn, as in the crash that killed Lieut. Muse.

HAYS, Kans., April 16. (P)—An airplane pilot named Lacey, whose first name was not learned, was killed, and his wife and two other party injured today when the monoplane in which they were riding crashed in a wheat field nine miles southwest of here.

PROTECTING TEXAS' NEW CITIZENS

Recently a strip lying along the western border of Oklahoma, containing about 28,500 acres, was transferred to the State of Texas by a decision of the United States Supreme Court.

The protection of the landowners is in the hands of the Texas legislators, where the responsibility should lie. The property-holders should not be penalized by an act not of their own making.

Mr. Small has assured the landowners involved, whether resident in the strip or not, that he will do all in his power to protect their interests.

I have your letter of March 27th inquiring about the status of land in the strip taken into Texas by decision of the Supreme Court of the United States.

The legal effect of this decision is to place the disputed strip in Texas and to make it a part of the unsold state school land. Those who now occupy this land are in law nothing more than occupants of state land.

I wish to assure you that I will do all I can to protect the rights of the people in this strip. I know of no action that should be taken by you at this time.

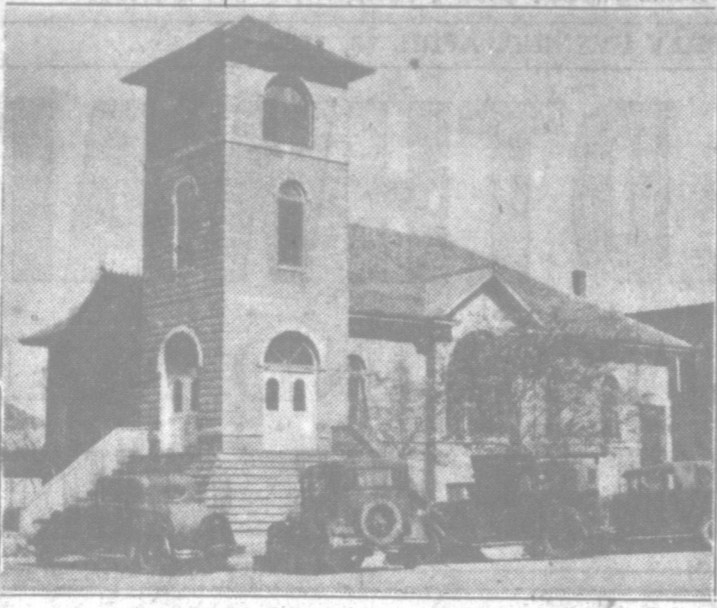

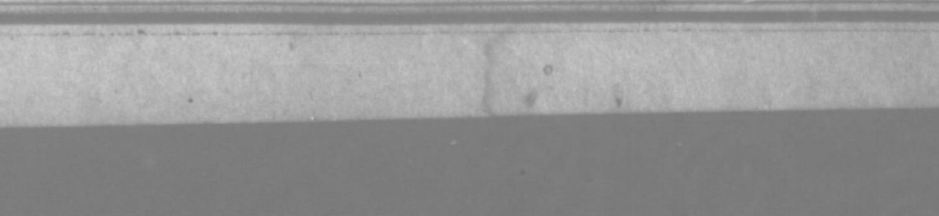

Ferguson Will Test Eligibility in Next Primary

AUSTIN, April 16. (AP)—Former Governor James E. Ferguson will test his eligibility as a candidate for governor in the 1930 Democratic primary, he announced in his Forum, weekly paper.

He said he would institute proceedings in the supreme court to determine his status in order to head off any last minute move by his opponents to keep his name from the ballots on grounds he had withdrawn from the party after his impeachment by the legislature and organized the American party.

In 1924 Mrs. Miriam A. Ferguson, the former chief executive's wife, became a candidate when it became evident his name would not be permitted to go on the ballots.

Student Flier Is Lost; Ocean May Reveal Disaster

NEW YORK, April 16. (AP)—Coast Guard boats were ordered out today to drag the ocean bottom at the mouth of Gravesend bay in an attempt to learn the fate of Ralph White, student pilot, who disappeared Sunday.

Captain Lewis E. Yancy, navigator of the New York-to-Rome, and the New York-to-Bermuda flights, located an oily spot on the ocean yesterday at Gravesend bay, which he said he believed indicated the missing airplane and its pilots went down there. Witnesses said a plane was seen to dip to the surface of the bay in the vicinity where the oil spot was located.

Indians Do Not Approve Trial

BUFFALO, N. Y., April 16. (AP)—The council of the Seneca nation of Indians at a pow wow at Salamanca which ended this morning expressed dissatisfaction over the manner in which the recent Marchand murder case was handled.

The Indians held no briefs for Nancy Bowen, the old woman who hammered the Buffalo artist's wife to death, or Lila Jimerson, the Cayuga spinster who pleaded guilty to second degree murder before her case went to the jury, but were emphatic in their conviction that all the evidence in the case was not uncovered and all the guilty parties not brought to justice.

Estate of Texas Woman Involved in Court Suit

COLEMAN, April 16. (AP)—Suit involving the estate of Mrs. Martha Tyler Overall, valued at several million dollars, was docketed for district court here today.

Mrs. Overall, who died in 1927, was owner of the famous Overall ranch and other property in Coleman county. She bequeathed approximately \$175,000 to relatives and friends, \$10,000 each to Southern Methodist university, Dallas, Southern western university, Georgetown, and Central college, Fayette, Mo., and \$5,000 each to Texas Woman's college, Fort Worth; Methodist Orphans' home, Waco, and the Virginia K. Johnson Rescue home, Dallas.

After making these bequests, beneficiaries of which are among defendants in the suit, she left the residue of the estate to be divided equally between three daughters of Mrs. Overall. This portion of the will enters principally in the suit, brought by John Overall Carter of Minnesota. He is a son of Lida O. Carter, deceased, who was a sister of the late Richard H. Overall, husband of the testatrix.

The plaintiff, who was bequeathed \$1,500, sets forth in his petition that Mrs. Lucy R. Van Cleave, one of the daughters of Mrs. Miller, is dead; that the residuary part of the estate is worth several million dollars because of the discovery of oil on the ranch and that the portion due Mrs. Van Cleave should go to all the heirs of testatrix and her deceased husband, instead of to heirs of Mrs. Van Cleave.

Mrs. Overall stipulated in her will that if any beneficiary found fault with the distribution of her wealth such fault-finder should be cut off without anything.

Thirty-six individuals and seven institutions are named as defendants in the suit.

Capone's Brother Arrested
MIAMI BEACH, Fla., April 16. (AP)—Albert Capone, said to be a brother of Al Capone, Chicago gang-leader was sentenced today to serve 30 days in prison and to pay a fine of \$100 for vagrancy.

Capone was arrested last week while playing golf on a municipal course. Chief of Police R. H. Wood said the arrest resulted from complaints of other golfers.
