City electric system offered for \$5 million

In a counter proposal to Southwestern Public Service Company's offer, the Floydada City Council has voted to "sell to Southwestern Public Service Company the Floydada municipal electric system for five million dollars, payable over a 20 year period at a minimum interest rate of eight per cent."

The council is asking principal and interest payable monthly. Last Oct. 14, SPS tendered an offer of \$1.75 million for the city's electric system. SPS's latest offer was its second in 18 months.

After the city council declined the offer, SPS invited a counter proposal. While presenting the SPS proposition in October, Gary L. Gibson, SPS vice president (marketing) termed the "book value" of the system "a little over a million dollars." The fact sheet presented by Gibson to council members stated that "the SPS offer of \$1,750,000 is 169 percent of the book value."

In its counter offer, the city stipulates that it would "retain ownership of the three trucks, two pickups, the generating building, baseball park lighting, the electric debt and all electric bank

accounts. The city proposal adds that "Southwestern Public Service Company would purchase all lines, transformers, substation, street lights, generating engines and accessories."

RATES NEGOTIABLE

The letter to Gibson, signed by Mayor Parnell Powell, adds that "the city council would like to negotiate the street light rates if you accept the offer."

In its fact sheet offered in October, SPS placed the amount estimated to retire the city's outstanding obligations related to the electric system at \$345,000 and the city's certificates of deposit in reserve for the electric system at \$245,000, leaving "approximate net cash proceeds to the city upon closing" at \$1,650,000 from the \$1.75 million offer.

SPS estimated increase in the annual franchise tax payments to the city, should it acquire the city electric system, at \$20,000 and the estimated increase in ad valorem taxes paid by SPS to the city at \$4,141.52.

City Manager Bill Feuerbacher says

the electric system's bonded indebtedness currently stands at \$340,000 and has \$207,071 in reserve, leaving a balance of \$132,929. This would leave \$64,000 in annual payments for slightly

over two years.

Floydada has been served by the two electric systems for many years. SPS or its predecessor companies have operat-

ed in Floydada since 1916. The municipal electric system was established in 1939.

According to SPS figures, the municipal system serves approximately 1,200 customers in Floydada and the SPS system serves about 600 customers.

SPS and municipal electric rates to the customer are identical.

Crabtree chosen commissioner

Floydada area farmer Kay Crabtree was sworn in at exactly 2 p.m. Friday as commissioner of Precinct Four. Floyd County Judge Bill Hardin, who made the appointment, administered the oath of office in the county courtroom to the new commissioner.

Crabtree succeeds Jack Lackey, who resigned Jan. 28.

The 53-year-old Floydada area farmer will serve by appointment until the next general election, which is in November 1988. At that time, two years will remain on the term to which Lackey was originally elected.

Judge Hardin told Floyd County newspapers that 13 applicants were received for the post, although one later withdrew his name.

"I feel like there were a lot of extremely fine men who could have served as well or better than I," Crabtree said during an interview immediately after taking the oath. "I know Judge Hardin must have had a hard time making the

decision. "I realize I was not elected, and I will do everything within my power to warrant the peoples' respect until they do have a chance to express their opinion."

Crabtree, who resides just east of Floydada on the Matador highway, added that "I haven't looked at the books, but I understand funds in Precinct Four are in good shape... they have been left in healthy condition. I don't have any excuse not to do a good job."

"I will ask people to be patient. I will start immediately checking our roads, but I understand they are in pretty good shape despite the October rainings."

"From what I know of the crew, I am extremely pleased with the men we have on the roads."

"I would invite the people to contact me with any problem or to answer any question. I may not know all the answers at first, but I'll do my best to find out for

Floydada lads exhibit champions

"Several people looked at him, but nobody wanted to buy him. So we just kept him and fed him," Craig Edwards said moments after judge Dick Vestal had named his son Chad's 1,287 pound homebred cross as grand champion steer of the 43rd annual Floyd County

4-H and FFA Junior Livestock Show.

But the big, black steer — called "Blackie" — that nobody wanted accomplished a feat no other calf had reached. He became the first animal to reign as grand champion steer of both the Floydada and county stock shows.

The sleek, balanced beauty caught the eye of judge Vestal, vo-ag teacher at Baird High School, when it entered the ring to show in the heavyweight cross class. It won this class and became cross breed champion before advancing to grand champion of show laurels.

Sunday was the day for crosses, as Zach Nutt's 1,163 pounder was made reserve champion steer of the county show. Also a black steer, Nutt's animal won the medium lightweight cross class and stood behind Edwards' calf as reserve champion cross before being called back into the ring to vie for the reserve grand champion banner.

For both Chad Edwards and Zach Nutt, Sunday presented their first walk to the winner's circle.

A 17-year-old Floydada High School junior, Edwards showed under the Floydada 4-H banner. He is the son of Craig and Betty Edwards.

The reserve grand champion steer owner, son of Mr. and Mrs. Edd Nutt, is a 15-year-old Floydada High ninth grader who showed as a Floydada FFAer. His steer was bred by Cage of Floydada.

HOMBRED TOP HEIFER

A 17-month-old Angus, with Matt Williams of Lockney at the halter, was

tabbed by Vestal as grand champion heifer. Like the champion steer, she is a homebred, coming from the Williams' JK Angus stock.

She was selected as the class one winner before garnering top heifer honors.

The owner is a 16-year-old Lockney High School junior. A son of Jerry and Kay Williams, he showed as a Lockney FFA member.

Exhibiting the reserve champion heifer, calved Jan. 3, 1985, was Billy Zane Colston. The 12-year-old son of

Auction nears \$100,000

Fears that the depressed economy would curtail the county livestock show premium auction failed to materialize.

When auctioneer Kenneth Gregg's hammer fell Monday afternoon to sell the 154th and final animal, show officials believed the premium total was nearing \$100,000.

Final figures show \$95,776.25 in total premium bids and \$3,650 for add-ons, a total of \$99,426.25. This was a "nice gain" over the approximately \$86,000 in premiums which about 156 animals brought in 1986.

Producers Cooperative Elevator and Floydada Businessmen & Farmers combined forces to pay \$1.85 per pound for Chad Edwards' 1,248 pound grand champion steer.

Floydada Livestock Sales Co. was the successful bidder on Chad Quisenberry's grand champion barrow, which weighed 252 pounds. The bid was \$4 per pound.

Premium on Hunter Smith's grand champion lamb was paid by Floydada Co-op Gins, Inc., at \$4.50 per pound. It weighed 129 pounds.

Muncy Elevator and Barwise Gin & Elevator paid \$1.75 per pound for Zach Nutt's 1,128 pound reserve champion steer.

Shannon Barbee received \$3.50 a pound from Floydada Businessmen & Farmers for his 223 pound reserve champion barrow.

Michael Mercado's 127 pound reserve champion lamb was purchased by Floydada Businessmen & Farmers for \$4 per pound.

The abovementioned prices for grand and reserve grand champion stock do not include add-ons.

Under guidelines of the auction, an exhibitor may choose to sell his/her animal or he/she may choose to receive the premium and retain ownership of the animal. This system allows an exhibitor to keep the animal for other shows, such as Houston Livestock Show.

Among the top six animals, Smith, Nutt and Barbee opted to accept the premiums and retain ownership of their champion stock. Edwards, Quisenberry and Mercado sold their animals.

Offering high floor bids were: H.E. Frizzell of Lockney, lambs, 70.25 cents per pound; Plains Hog Market of Lubbock, swine, 49 cents per pound; and Caprock Industries of Lockney, steers, 62 cents per pound.

Burleson Memorial and Fulton & Fulton Cattle added one-half cent per pound to the steer floor bid.

NO FILINGS FOR SCHOOL BOARD

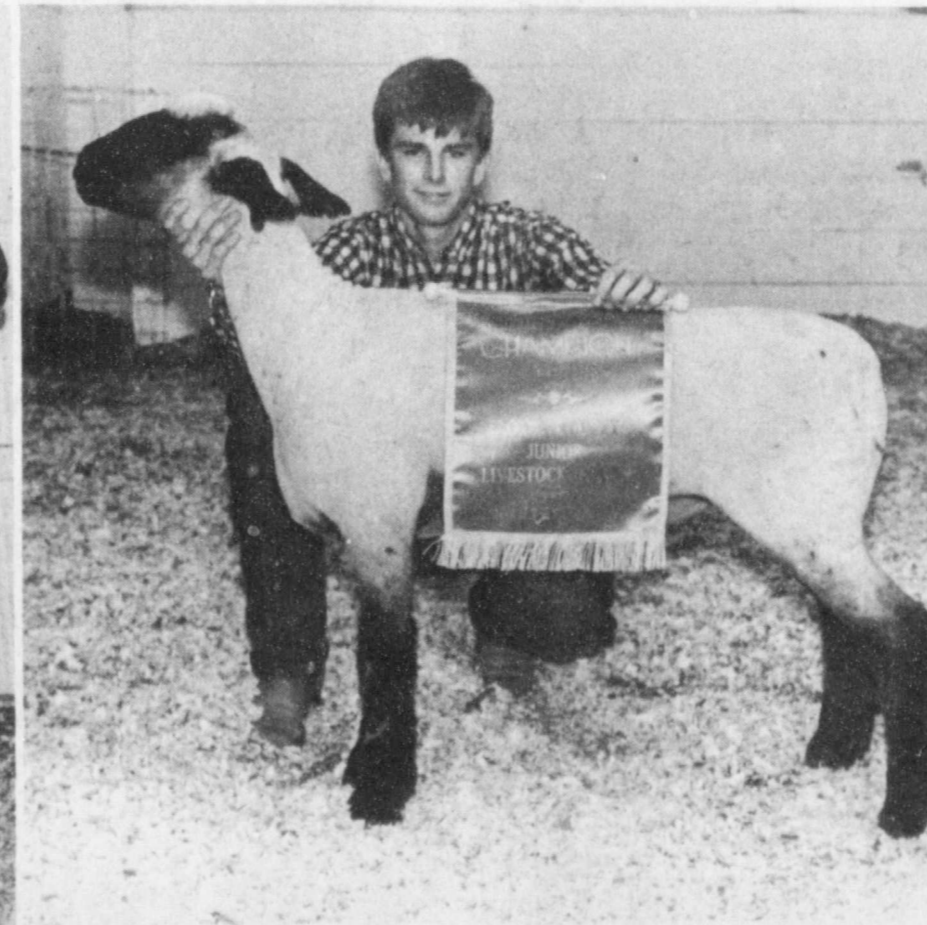
According to administration officials, there have been no filings for the two positions on the Floydada ISD ballots in the April 4 election. Filing dates in this race will remain open until March 4.

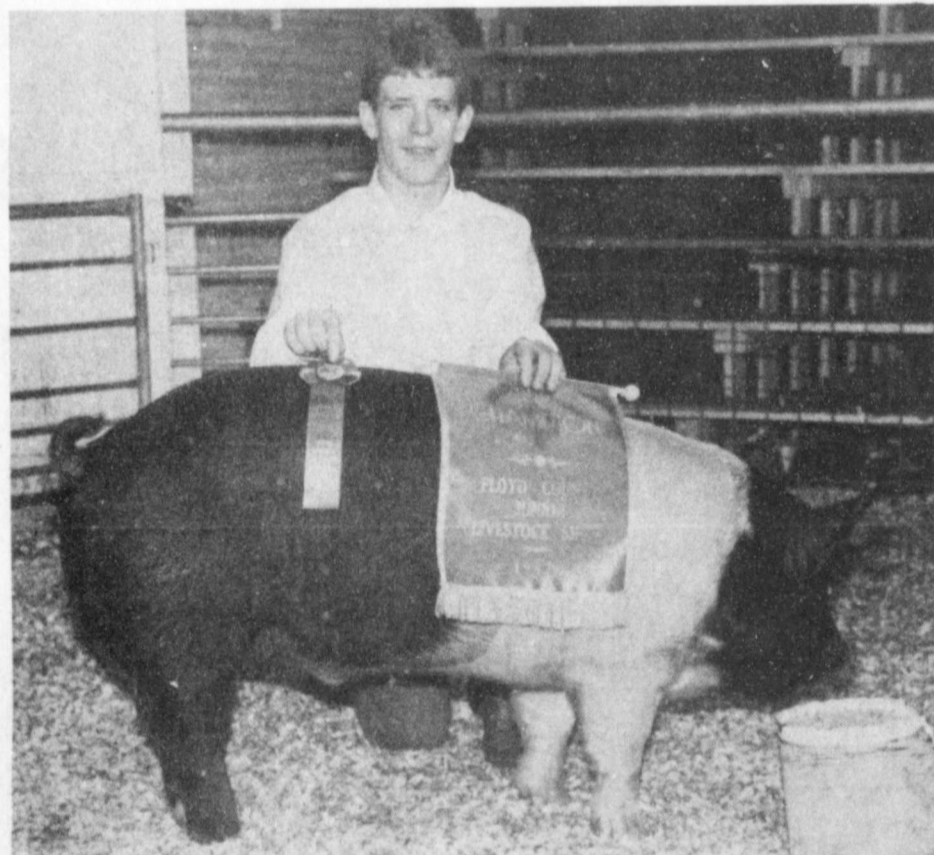

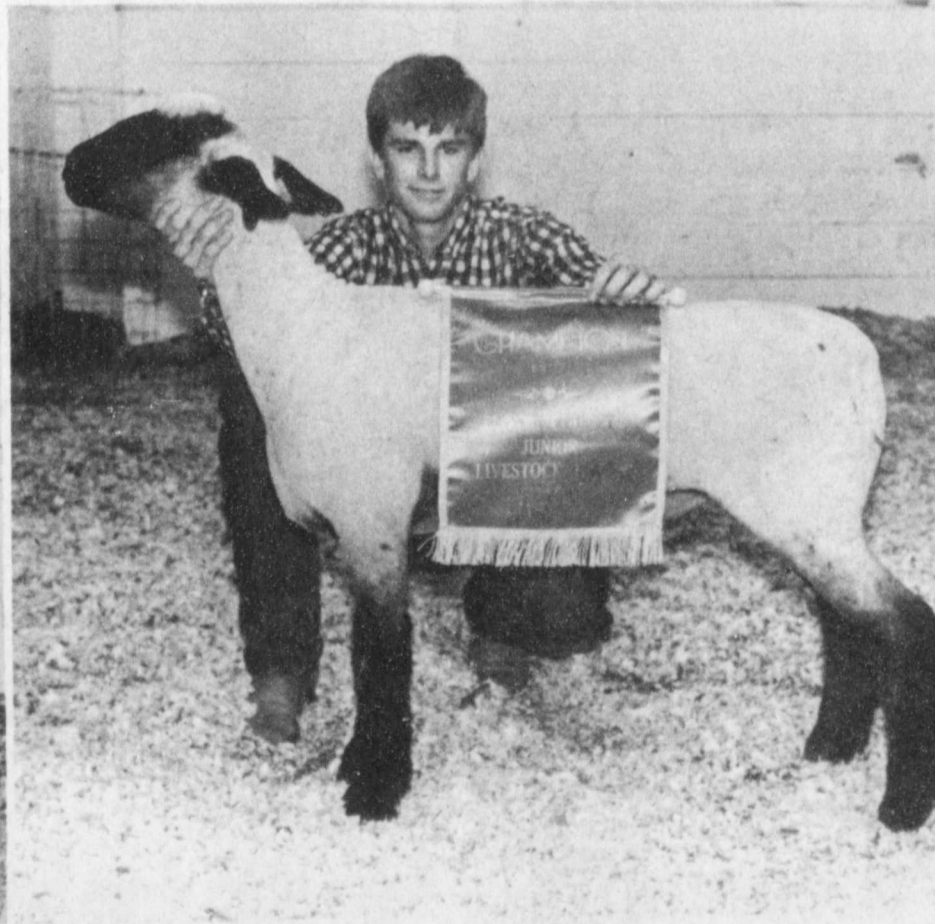

Suspect arrested prior to rural burglary discovery

Even before a Thursday night burglary was reported, a suspect had been taken into custody by Floyd County Sheriff's Department.

The Rodriguez family reportedly had left their home, located about six miles south of Lockney, at 8:30 p.m. Thursday to attend a church function. Burglars

entered their residence, possibly within the next 15 minutes.

At 9:02 that night, a deputy sheriff stopped a vehicle five miles west of Floydada. Suspecting the man had been involved in a burglary, the deputy arrested one of the vehicle's two occupants on traffic charges.

The Rodriguez family returned home to discover the burglary and reported it about 11 p.m.

The following morning, the second occupant of the vehicle which had been stopped Thursday night was arrested at his Floydada residence "before he got out of bed."

Both suspects are 22-year-old Floydada residents. Burglary of a habitation charges have been filed against the pair.

Entry to the house had been gained through the back door. Reportedly taken were a stereo, a VCR, a remote control TV and speakers.

BURGLARY OCCURS WHILE FAMILY MOVING

The Noe Ramirez family was in the process of moving from the Lone Star community to a house "right along the county line" west of Barwise, when the latter residence was burglarized "between 5 p.m. Friday and 3 p.m. Saturday."

This residence is "half in Floyd County and half in Hale County."

Burglars, who pried open a window, reportedly took household items, mostly dishes, and some appliances. The loss was placed at \$240.

Friday blood drive to honor Rev. Earl Blair

In honor of its pastor, Earl Blair, First United Methodist Church is sponsoring a blood drive this Friday, Feb. 20, from 4 until 8 p.m. Donors will be accepted in Fellowship Hall of the church.

The Rev. Blair has received "between 40 and 50" units of blood while receiving medical treatment since early December in Methodist Hospital in Lubbock. He has undergone six surgeries.

"This blood drive is an effort to help replace some of the blood used by Floydada's hospital and patients from Floydada in other hospitals," according to a blood drive organizer. "Each day over 100 units of blood are delivered from United Blood Services in Lubbock to 35 area hospitals.

Donating is both "easy" and "safe," according to the individual.

"It only takes 20-30 minutes for the entire process, which includes screening — taking temperature, blood pressure and checking the blood iron level." The actual donation requires "only about 10 minutes" and refreshments are served afterwards.

"Donating blood is completely safe," the drive sponsors relate. "All materials used for each donor are sterile and disposable; they are used one time only and then thrown away.

"The screening process can be looked upon as a free mini-physical, including checking temperature, pulse, blood pressure and blood iron level."

Appointments can be scheduled between 4 and 8 p.m. for the convenience of donors. "If you would like to donate or would like more information, call the Methodist Church, 983-3706, or Judy Lloyd, 983-2967," donors are advised.

"These bills are for books that are in the office of Kenneth Bain, the county attorney and in the office of the District Judge," said Judge Jardin.

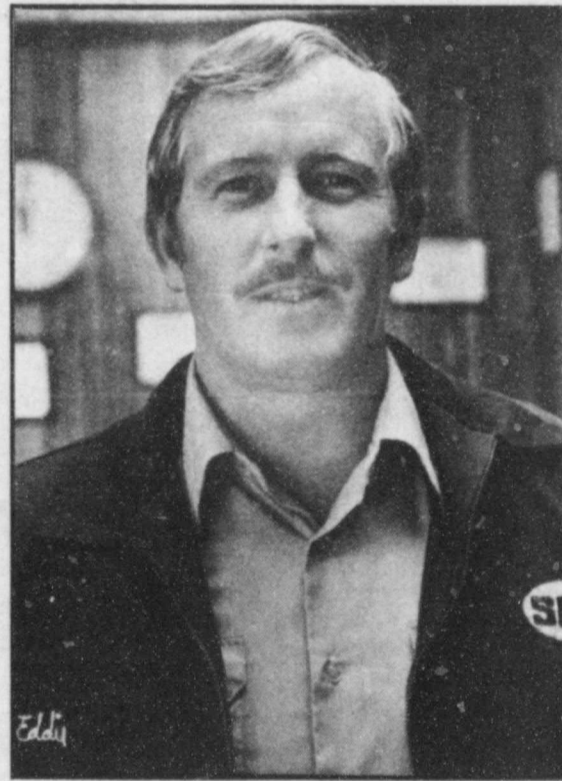

PRO™ TEXAS
A NEW OPTIONAL CALLING PLAN FROM AT&T


On November 13, 1986 AT&T Communications of The Southwest, Inc. ("AT&T") filed with the Public Utility Commission (PUC) of Texas to introduce a new intrastate, optional calling plan, PRO Texas. A comparable interstate plan, known as PRO™ America, is currently available to Texas customers.

PRO Texas gives Texas consumers an opportunity to save money on direct dialed in-state long distance calls. Customers who choose this new AT&T plan will receive a 10% discount on all AT&T intrastate direct dialed station calls by paying a monthly charge of \$15.00.

The PRO Texas discount applies to calls placed during all rate periods and all days. The discount is in addition to the AT&T intrastate evening discount of 25% and the night/weekend discount of 40%. A one time charge of \$6.00 will be billed to initiate the service. However, this charge will be waived during the first 90 days that the offering is available.

PRO Texas will be available to all Message Telephone Service customers in Texas. AT&T estimates that it will generate revenues in the first year of almost \$8 million, which is .7% of AT&T's annual revenues for all Texas intrastate service.

The PUC has assigned Docket No. 7194 to this proposed service offering. The proposed effective date for PRO Texas is March 16, 1987. Persons who wish to intervene or otherwise participate in these proceedings should notify the PUC as soon as possible. Recollections of Fannie Green

By Her Children
[Read at Mrs. Green's Funeral]

Between 1889 and 1987—almost a century—the world changed from horse-and-buggy to space exploration and laser technology. Her lifetime spanned this time. She spoke of her childhood, when her family lived in a half-dugout at Mt. Blanco near the canyon edge, and the happy Saturdays she, Nancy and Tarp, her sister and brother, spent fishing in Blanco Creek.

After her mother's death, her father remarried and she had two more sisters, Gertrude and Winifred, and a stepsister, Ruby.

She enrolled in North Texas Normal College at Denton in 1909 and roomed with Pearl White, who later taught music in Floydada as Pearl Fagan. Mama alternated teaching and college, finishing her degree in 1914. She taught nearly ten years in all, at Steel Hill, Robertson, Wake, Floydada, Ralls and Mt. Blanco.

In September of 1913, she and Nancy went by horse and buggy to apply at Steel Hill, below Spur. Night was falling as they stopped at a house just below the caprock, but for some reason they were not asked to spend the night, so they went on.

Turning north out of Crosbyton about midnight, they found themselves in a driving rain. The horse turned his back to the rain and refused to budge. The buggy was enclosed with isinglass curtain so the girls did not get wet, but they were a bit chilly. They sat there until sunup, when the rain stopped, the horse consented and they proceeded, arriving home about noon.

Their father had many unkind things to say about the people who had failed to offer his daughters a night's lodging.

Mama taught at Steel Hill for \$55 a month. She would stay a month in the home of one trustee and move to another home for the next month. She often got up at six a.m., went out in the snow to hitch the horse to the buggy, drove several miles to school, built a fire in the big stove, and had the classroom warm before the first pupils arrived.

She had several proposals, but no one really interested her until she met Jim Green, the nice new young man working for Mr. Appling at Mt. Blanco. Jim came back from the navy after the war and they were married on March 27, 1921. They were both 31. Both had been born in November 1889 in Hill County.

We lived all our childhood on a farm in the Center community—a farm rented from Mama's uncle, D.I. Bolding. The focus of our spiritual life was Center Baptist Church; other aspects of community life centered around the school. Mama was active in both, and in the Home Demonstration Club. She was always at club meetings; our green 1928

Pontiac was a familiar sight tearing along the country roads with Mama at the wheel and Mrs. Sims gamely at her side.

She sometimes drove to town alone in our car—foolhardily, perhaps, for when she was ready to come home, the car might start or it might not. One day when it didn't, a friendly man gave her car a push with his.

Mama's car started, so she honked and waved, but it seemed he didn't get the message because she was going faster and faster out onto the Silverton highway. Finally in desperation she leaned out of the driver's window and looked back to shout. To her surprise, there was no one in sight. Her car was the only one on the road.

She had her last haircut at age nine; Daddy always liked her hair long. Once after their marriage she had the ends trimmed, and he was not pleased.

The work done by her small hands was impressive. Each Wednesday was washday. She would have us hang out the sheets on the line and clothes on the fence. Washday-nights we enjoyed the smell of clean sheets dried in the sun and wind. Thursdays were ironing days. Her sewing machine hummed day and night; those Sunday afternoon football games with the Robertson and Anderson boys were hard on clothes.

We had no bathroom, but Mama saw to it that everyone bathed at least twice a week. She was of Alabama stock, and there were certain standards that WOULD be kept up. Every Sunday there was a clean, freshly ironed cloth on the dining table, silverware, fried chicken, and her famous coconut cake for dessert.

She baked pies and made ice cream for suppers at the schoolhouse, and helped organize 42 parties, which she especially enjoyed. In the fall, she and Margaret sometimes picked cotton with us, which made it seem like a picnic.

Saturday evenings she sat with us on the front porch to listen for wagon sounds far down the road; Daddy would be returning from the cotton gin, possibly bringing a bushel of apples.

In late summer we sometimes took a four-day trip in the wagon to pick wild grapes and plums below the caprock, explore, and play in the creek. On the return trip, her hands would be busy rubbing cold cream and lotion over tender, sunburned backs.

In the thirties, when home-grown food was plentiful but money was scarce, she worked out a plan with her beloved Uncle Clark Bolding for a loan of \$30 to buy a piano, and with Mrs. Sims a plan for two music lessons a week for \$3.50 a month, to be paid when we sold our cotton in the fall.

Four of us took lessons from Mrs. Sims, and two from Mrs. Fagan; those were paid for with butter and eggs.

Mama's persistence has brought enjoyment of music to three generations.

Probably the greatest real shock of Mama's life was the notice that Jimmy was missing in action in the South Pacific. It came January 1, 1944. She did not give up hope for years and even planned to go search for him. She specifically asked that Jimmy have special mention at this service, because he never had any kind of memorial service of his own.

Before we lost Jimmy, we did not usually pray at the table, but after that, we never ate a meal without praying. Our parents were both timid about public-speaking, but after that loss, they assumed more leadership in the church and began to lead prayers publicly. Somehow, through their loss, their faith was strengthened.

In our home, it was simply assumed that the next thing after high school was Wayland. All of us graduated from Wayland. After Jimmy was missing, Mama established a student loan fund at Wayland in his name.

Mama had become a Christian at age 17. One quiet day in the attic, she accepted Jesus as her Saviour. She was so timid that it was several days before she told anyone.

She loved the Center Baptist Church, and particularly the last pastor, R.C. Hodges and his wife, Nellie. After they moved to town and Center disbanded, she and Daddy came to love the people of Calvary Baptist Church with Pastor Hollis Payne and his wife Jo.

The remarkable fact that Mother lived alone in her home until last year was possible only because of constant care and concern by many people. For many years Vic and Sue have come from Plainview to bring food, mow the lawn, take to medical care, and run countless errands. In later years, Anthony and Evelyn have tirelessly helped in many ways.

Mama's good neighbors, James McGregor, and Paul, Brenda and Dawn Attebury constantly kept an eye out checking her light at night and giving any needed help in the daytime. Mama spent her last months in the loving care of Margaret and her family at Hubbard.

She remained active and her mind keen almost to the end. One day after a fall, when she was in her early nineties, Paul came over to make the suggestion that she go to a rest home. She replied quickly, "I do go there—every time I get a chance."

He then explained that he meant moving to a rest home to live. To this, she answered, "Listen, sonny—those places are for old people."

We are thankful that today she can once again hear well, that she can walk without a walker, and that she is with her Saviour, where she will never grow old.

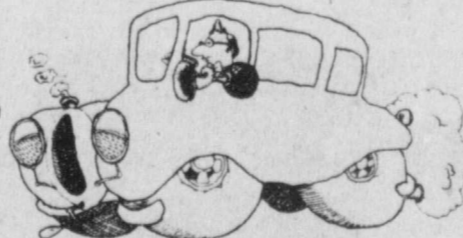

CRP bids will be accepted all next week, including Tuesday morning, Feb. 24, and Thursday morning, Feb. 26.

Senator Phil Gramm has announced that farmers who suffered low yields or abandoned their crops due to adverse weather will receive approximately \$400 million in disaster payments. About \$132 million of this amount will be made to eligible producers in Texas.

Congress allocated \$400 million for the 1986 Disaster Program. After all the applications from eligible producers nation-wide were received, it was determined that each producer's payment would factored to 73.9 percent to stay within the amount appropriated by Congress.

Senator Gramm had estimated earlier based on preliminary data that a smaller factor would have to be used in order to stay within the \$400 million. Senator Gramm further stated that these funds will be very beneficial to the hard-hit farmers in Texas.
