FIRE DESTROYS TOWN; SHERIFF INVESTIGATES

(By Associated Press)
 DECATUR, Tex., Oct. 12.—Greenwood, fifteen miles Northeast of here, was virtually destroyed by fire last night, and today an investigation is being made which will probably lead to the arrest of the party responsible for the fire.

The sheriff of Wise county has sent to Ft. Worth for blood hounds to assist in a search for a man, who it is believed, started the fire. The man was seen to leave the place where the fire originated shortly after it was discovered.

The loss is estimated at \$75,000.

DALLAS MAN FINED FOR VIOLATING LIGHT LAW

 DALLAS, Oct. 12.—"You are charged with violating the light law. Guilty or not guilty?" a man was asked in the police court here.

"I guess I am. The policeman who arrested me said I was lit up like a circus tent," was the prisoner's reply.

It later developed that two men with the same name had been arrested and one was charged with violating the light law, while the other with being intoxicated.

When the case against the man charged with violating the light law was called, the other man responded. He was fined five dollars.

TRYING TO GET FOUR FOR ONE

The Texas Highway Association, under the management of Wm. T. Wheeler, of Ft. Worth, has ahead of it a gigantic task, and one in which every forward thinking citizen of Texas should be interested, for the problem which they have to solve is one which affects the pocketbook of every Texas taxpayer.

The object of the association is to obtain the necessary legislation to enable the state government to co-operate with the federal government in constructing a connected system of highways in Texas and to remove all legal obstacles which stand in the way of full compliance by Texas with the requirements of the federal law governing federal aid for highway construction.

Unless the association attains this object, no federal money will be spent on Texas roads after 1925.

Many unthinking individuals have stated that such a condition would suit them exactly, expressing the view that it would decrease the federal taxes payable by citizens of Texas, but this is not the case. The truth of the matter is that other states contribute four out of every five dollars of the federal money that is spent on Texas roads, the taxes paid by Texas citizens forming but a small part of the total aid received.

The Highway Association and its purposes have been endorsed by state and local civic organizations, chambers of commerce, leading business and professional men and bankers, and should have the moral and financial support of every loyal Texas citizen.

CAMERON COUNTY HAS \$300,000 ROAD PROGRAM

BROWNSVILLE, Oct. 12.—The \$300,000 issue of road bonds to supply funds for the completion of concrete work on Highway No. 12, which traverses Cameron county from Brownsville to the Hidalgo county line, will be placed in the hands of the purchasers. Plenty of funds are now available for the completion of the 35 miles of concrete roads in the county, fifteen miles of which were completed last spring.

CORNER STONE LAYING SOON

Work on the new building for the Baptist church is progressing nicely. The chairman of the building committee announces that the corner stone will be laid at an early date and that a prominent speaker has been invited to deliver the address. Definite announcement will be made in a few days.

300 ABOARD BURNING STEAM SHIP AT SEA

NEGRO ROBS 2 PULLMANS ON SANTA FE

 KANSAS CITY, Oct. 12.—The police today are searching for a negro, who late last night held up passengers in two Pullman cars on the Santa Fe California Limited soon after the train pulled out of the union station here.

The negro robbed the passengers of an undetermined amount of cash, jewelry, etc., and made his way through the cars robbing travellers while the train was moving. He jumped off near the city limits, and made his escape.

CHICAGO, Oct. 12.—Six men aided Mrs. S. D. Sweet, of Detroit, to evade the negro bandit who held up the passengers on a Santa Fe transcontinental train at Kansas City last night, according to a story of the hold-up as related by Mrs. Sweet upon her arrival here today.

Mrs. Sweet stated that six men threw their pocket-books to the negro when he attempted to rob her, and she was given time to hide her valuables. The conductor of the train said that the negro escaped with only about two hundred dollars.

CASE IN FEDERAL COURT

Judges C. P. Shepherd and A. K. Doss spent Wednesday in Abilene trying an important case in the Federal District Court of that city. The litigants were the Ballinger State Bank & Trust Co. of Ballinger as plaintiff and the Invinible Oil Co., a foreign company, whose domicile is in Oklahoma, and the subject in question was the fee title to 44 acres of land a few miles from the Pioneer oil field. This land lies in the middle of what is known as the Hilburn field and has oil wells all around it within a few hundred yards and was and is considered very valuable. After hearing the evidence, the court, Judge James C. Wilson, judge of federal district for the Northern district of Texas, rendered a judgment holding that the Ballinger State Bank was entitled to and owned the fee title. This case has attracted considerable attention, as it has been litigated in the state courts twice and the questions involved were rather novel.

**SECRET ORDER WORK
 CAUSES NEGRO FIGHT**

Richard Green, a high district officer of the Masonic Lodge, colored, and Rev. Clark, pastor of the M. E. Church South for colored, engaged in a fracas which proved a bloody affair for Green, Wednesday afternoon. The fight took place in the alley near the First National Bank building, where the colored men met to discuss the efforts of Rev. Clark to organize a Masonic lodge at Rowena.

It seems from reports given by those who heard the discussion leading up to the fight that Rev. Clark had been at work organizing a lodge at Rowena, and for some cause the charter had not been delivered, and Green, who claims to be the authority on colored Masonry in this district, accused the colored preacher of robbing the colored folks at Rowena, and that he was acting without any authority in trying to organize a lodge at that place. The colored preacher resented the charges in such a way as to give Green some ugly wounds about the head. The difficulty was being adjusted in court Thursday morning.

A rather exciting fistie combat was pulled off just behind the First National Bank yesterday afternoon, Richard Green and Rev. A. Henry Clark, both colored, being the participants. Several eye witnesses were present and saw this interesting combat. It is said that the real cause of their differences grew out of work that Clark is and has been doing for a certain lodge known as some kind of a colored Masonic order or claims to be such, and Green belongs to another branch than the one Clark represents. Some words passed between the parties prior to this mixup. In the mixup Green attempted to use a standard hastily taken from W. D. Gregory's freight wagon but his stroke went "wild" when Clark dived under the liek and with a meat cleaver hooked Green on the head, making two rather ugly wounds. Both parties appeared in Judge Willingham's court Thursday and plead guilty to an affray and after receiving the usual admonition from the court, went their way.

Sixty-five musicians have signed up for the band to this date, giving Ballinger the best prospects for a band which have ever been had in the history of the city.

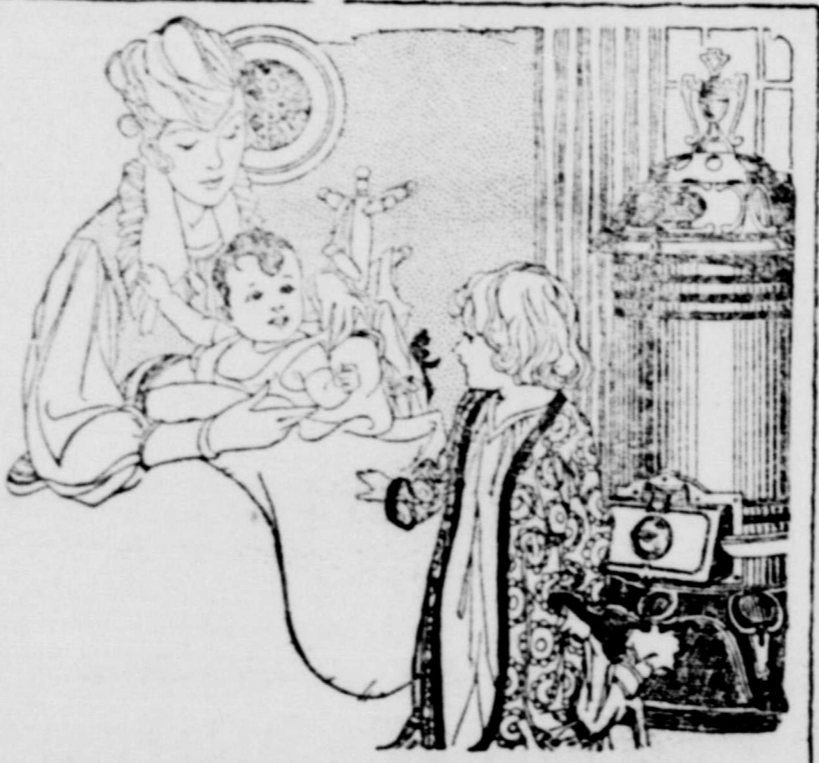

**PIONEER LADY
PASSES AWAY**

Mrs. J. A. Grimes, of Bronte, died in Ballinger at 7:30 Wednesday evening. She was brought here suffering with a prolonged attack of gall stones Tuesday, and efforts to save her life failed. The remains were removed to the home of Mrs. W. L. McAuley on Tenth Street, where they were prepared for burial by Undertaker Crews and carried to Bronte Thursday afternoon. The funeral will be held at Bronte Friday afternoon and the body laid to rest at that place.

Mrs. Grimes was 64 years of age. She was a pioneer wife and mother of Runnels county, having located with her husband in the Maverick section more than a quarter of a century ago, and had been living in the Bronte and Maverick country for many years.

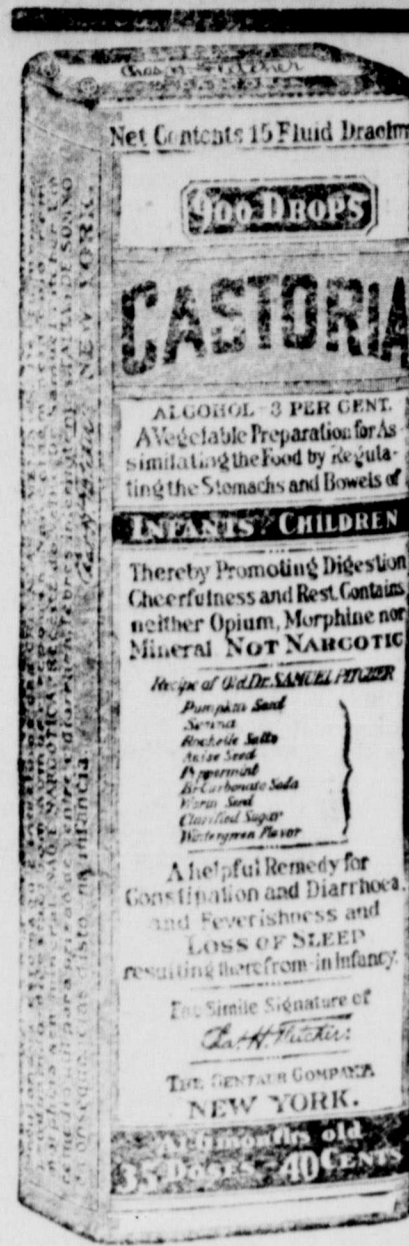
