Hoover Inaugurated As Nation's 31st President Dynamite Explosion Near Quitaque Claims Two Lives

Two Workmen, S. Apperson, and C. Itschner, Victims

Two More Injured, One Seriously As Result Of Terrible Blast In Gravel Pit Monday

Another May Die

Premature Explosion Of Sticks Blamed For Tragedy; Plane Is Used To Aid Injured

(Special to The Avalanche)

PLAINVIEW, Mar. 4.—Two workmen are dead and a third is so badly mangled that he is not accredited with a chance to live, as the result of an accidental explosion near Quitaque, Briscoe county, shortly before noon Monday.

THE DEAD.

SAM APPERSON, 23 years old, married.

CHAM ITSCHNER, 45 years old, married.

THE INJURED

E. F. HODGKINS, 55 years old, unmarried.

Virgil Aguler, about 22, escaped with minor scratches and bruises although the force of the blast hurled him from the pit and over a small shack nearby.

The accident occurred in a gravel pit, 10 miles southwest of Quitaque, where four men were setting dynamite caps in preparation for blasting. They were employees of the Panhandle Sand and Gravel company and in the pit with them were 15 sticks of dynamite.

Men Hurled From Pit

In some unexplained way the sticks were ignited and in the terrific explosion which followed the men, together with rocks and sand, were hurled from the pit, high in the air.

Fellow workmen, toiling nearby, rushed to their assistance and the three men, immediately after receiving first aid, were placed in an ambulance.

Scout Workers To Start Drive Today

One Hundred And Fifty Men Of City Meet At 9 To Begin Financial Campaign; \$10,000 Sought

The \$10,000 drive for Boy Scout funds, necessary to carry on the work of this organization in Lubbock and to wipe out a deficit of about \$5,000, will begin at 9 o'clock this morning, when a small army of Lubbock business men meet at the Chamber of Commerce rooms in the city hall to launch the campaign.

George Dupree, general chairman of the drive, with Tom A. White, finance chairman, will be in charge of the army, which has been divided into four divisions, with a scoutmaster and four patrol leaders working under their command directly. In addition to these there will be about 150 men otherwise assisting, according to K. N. Ciapp, secretary scout executive for the South Plains Area council.

Finds Highest Type Here

"I've found the highest type of scouting out here in any place I have ever seen," George Dupree, chairman of the committee that will go out today to raise the \$10,000 scout budget stated last night when the workers held a brief, enthusiastic meeting at Scout headquarters at the city hall.

Dupree told the group of workers that in Central Texas and other sections of the Southwest where scouting has been studied and scout troops have been organized many years longer than here on the South Plains, that the scout work is not on a par with scouting here.

Rev. Luther G. H. Williams, president of the South Plains Area Council declared he had also been connected with scouting in a number of places and that here on the South Plains scouting is on a par with the other places where he has been connected with scout work.

Coolidge's Pen To Be Kept Busy

NEW YORK, March 4. (AP)—Curiosity as to what Calvin Coolidge would do on returning to private life was satisfied at least partly today by announcements that his contributions would appear in three magazines, and that he had received a request for a conference on an offer of a \$25,000 annual retainer fee plus a dollar a word for material for an encyclopedia.

The Ladies Home Journal announced that the former president had written three articles on "promoting peace" which will appear in June, April, May and June issues.

Merle Crowell, editor of the American Magazine said a series of articles by the ex-president had been contracted for by that periodical.

Ray Long editor of Hearst's International Cosmopolitan announced that Mr. Coolidge already had written the first article of what is to be a series for the magazine. The articles will run under the heading "On Entering and Leaving the Presidency."

Roar Of Shotgun Ends Herd Trial; Robertson Held

Brother Of Murdered Man Shoots Slayer As Jury Is Deliberating On Verdict

CLEBURNE, March 4.—The roar of a shotgun today ended the murder trial of Ed Herd while the jury was deliberating his guilt or innocence.

Herd fell near the courthouse square, fatally wounded by slugs from the shotgun of Hugh Robertson, brother of E. W. Robertson, for whose murder Herd was on trial. E. W. Robertson was Herd's business associate in the real estate business here.

Robertson Surrenders

Robertson, a Johnson county farmer walked to the office of the sheriff and surrendered to a deputy and later was released on bond of \$10,000 to await action by the grand jury, ordered by District Judge O. B. McPherson to convene Monday.

While Robertson was with officers in an office at the courthouse Dudley Herd, 13, son of Ed Herd, was in another office with a deputy sheriff, and other county officials investigating threats said to have been made at the scene of today's killing. On orders of Judge McPherson, to whom Herd promised there would be no further violence, he was not charged.

Robertson told the reporter that his life had been threatened by the elder Herd and that Herd had

War Clouds Hover Low In Mexico As Factions Mobilize

Activities In Mexico City Move Under Veil Of Censorship; Nine States Are Claimed By Rebels

Conflict Expected

Concentration Of Troops Is Made At Various Points Throughout Republic; Religion Is Blamed

(By Associated Press)

BEHIND the veil of censorship in Mexico City last night President Portes Gil and his loyal generals laid plans to subdue the revolution, while revolting military commanders in the states of Vera Cruz and Sonora consolidated positions and claimed a total of nine states won to their cause.

Governor Fausto Topete of Sonora proclaimed religious liberty under the rebel government, which would strengthen the cause in Jalisco, and other western states. He also declared that the revolution was directed against former President Calles and demanded that he leave Mexico.

Confined To Two States

"The central government at Mexico City maintained during the day that the revolt was confined to two states but last night acknowledged that General Gonzalo Escobar had added the state of Coahuila to the insurgents.

Rebel leaders, however, claimed the entire west coast as far south as Colima against which their forces were marching, the north central states of Durango and Coahuila, as well as the southern state of Oaxaca and Vera Cruz.

President Portes Gil declared that his government had the situation in hand and would crush the movement, which was led by what he called a dissatisfied military-political group. To effect this he had as secretary of war, General Plutarco Elias Calles, recalled from retirement to lend his strong hand.

PEORIA, Ill., March 4.—The fourteenth victim of poisonous bootleg liquor distributed in Peoria over the week-end died tonight, and a coroner's inquest was held in abeyance to await the death or recovery of others who imbibed the tainted alcohol.

Been Teel, 60, of Vermont, Ill., was the latest to succumb. He was one of a group of stockmen who became ill after a party at a hotel Thursday night.

State's Attorney Pratt announced tonight that Maurice Mannstedt, arrested as local distributor of the liquor, had admitted he imported 50 gallons from a Chicago bootleg syndicate, but refused to name its source.

PAIR ARE IN MASON

Alleged Slayers Held In Jail Report Says

COLEMAN, March 4. (AP)—Anton Chevris and Otilio Herrera, charged jointly with killing Sheriff Allen T. Murray of Mason, are in jail at Mason. It was learned today. Previously it had been announced the men were in custody at an unknown place.

Herrera was arrested last week. Chevris was arrested near Santa Anna, early Sunday morning by Robert Miller, state highway officer.

Murray was found shot to death in a lane early last week after he had attempted to arrest two men in an automobile.

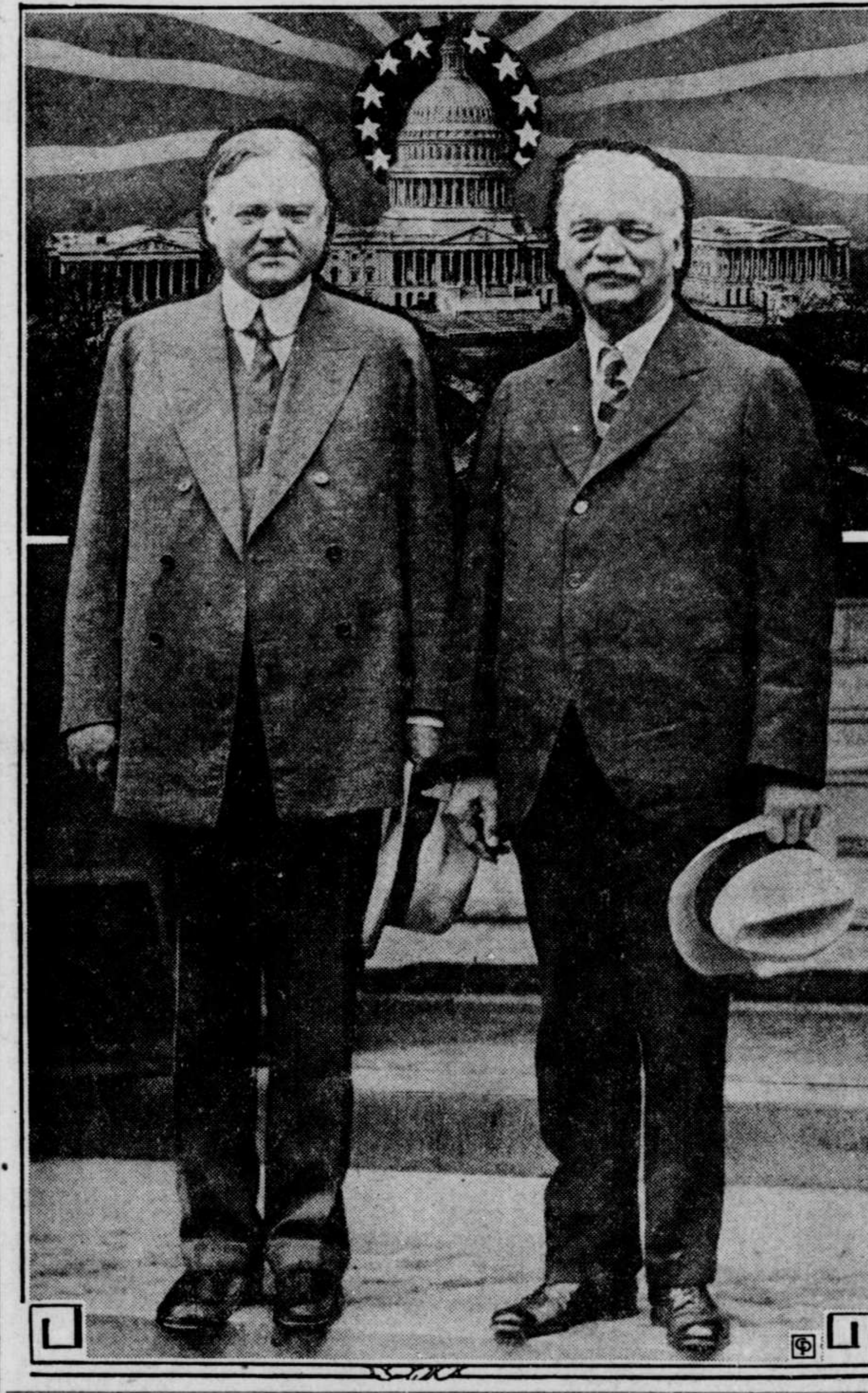

Fire Insurance Rate Is Reduced

Again will Lubbock citizens benefit by the city's good fire record of last year, with the announcement received by wire yesterday from J. W. DeWeese, state fire insurance commissioner, to the effect that a 15 percent reduction in fire insurance rate has been allowed for the current year, beginning March 1, according to City Manager G. W. West Texans Dislike Moody's Action On Title Measure

(By Associated Press)

STAMFORD, Mar. 4.—Special consideration will be given the Small bill affecting river bed lands, recently vetoed by Governor Moody, at the regional convention of the West Texas Chamber of Commerce at Snyder tomorrow. A. M. Bourland, president, said today.

Bourland, en route to the meeting, was joined here by Homer D. Wade, manager of the chamber.

Bourland expressed disappointment over the veto, and said the Governor's recommendation of a constitutional amendment would mean a long delay. The Governor should have signed the bill and let the courts decide its constitutionality, Bourland contended.

Several hundred delegates from a score or more towns and cities are expected at the Snyder gathering.

American People Place Republicans' Choice At Government's Helm Monday In Solemn Ceremony Before Throngs

Stinging Rain Breaks Into Impressive Inaugural Activities In Washington; President-Elect Promises To Uphold Oath; Parade Is History's Greatest

WASHINGTON, D. C., March 4.—(A. P.)—The American people today with solemn ceremony placed Herbert Hoover in the highest office within their gift—that of President of the United States.

With a stinging rain falling, he swore to uphold and defend the constitution of the United States, kissed a verse in the Bible and began the gravest duty ever demanded of him in his life of far-flung activity. And, turning to his inaugural address he made a pledge to enforce all laws, including the prohibition amendment, to the full extent of his ability.

Into office with this California engineer and orphaned Quaker went Charles Curtis whom fate had taken from an Indian reservation and elevated to the vice presidency. The two then rode down the historic route from the capitol to the White House, bare-headed, rain-beaten, but smiling their happiness over one of the most remarkable omissions given any president or vice president in recent years.

For nearly four hours the thousands stood in the driving rain waiting to do honor to the foremost two Americans. They filled the long rows of water soaked stands lining the route; they perched upon perilous, slippery ledges or buildings flanking the street. Dripping windows were filled with peering faces, and rooftops were heavy with humanity.

Thousands Witness Ceremony

On the capitol plaza, shining with its watery film, the thousands with water dripping clothes saw Mr. Hoover kiss a verse in the Bible which sealed his fealty to his countrymen. That verse said: "Where there is no vision the people perish; but he that keepeth the law, happy is he."

And when that ceremony was over they remained defiant of the

Six Youths Are Held For Thefts

Lemond Orders Round-Up Of 'Alley Rats' Following Theft Saturday Night; Two Confess

Six Lubbock youths ranging in ages from about 15 to 17 were arrested yesterday, following instructions from Chief of Police John Lemond, "to round up all alley rats," after a large quantity of stolen articles, including clothing and several bicycles, were recovered at the homes of some of the boys.

Two of those arrested will probably face charges in county court today for theft of more than \$50. Chief Lemond indicated last night these two being the ones who are said to have unlocked an automobile that was parked near a local hotel last Friday night and took six sample cases from it.

Two Make Confessions

The sample cases belonged to a boys' all of them taking the cases, salesman representing the Monnier Dry goods company, of Fort Worth, who had parked his car for the night while stopping here. Confessions from the two, made to officers, are to the effect that one of the

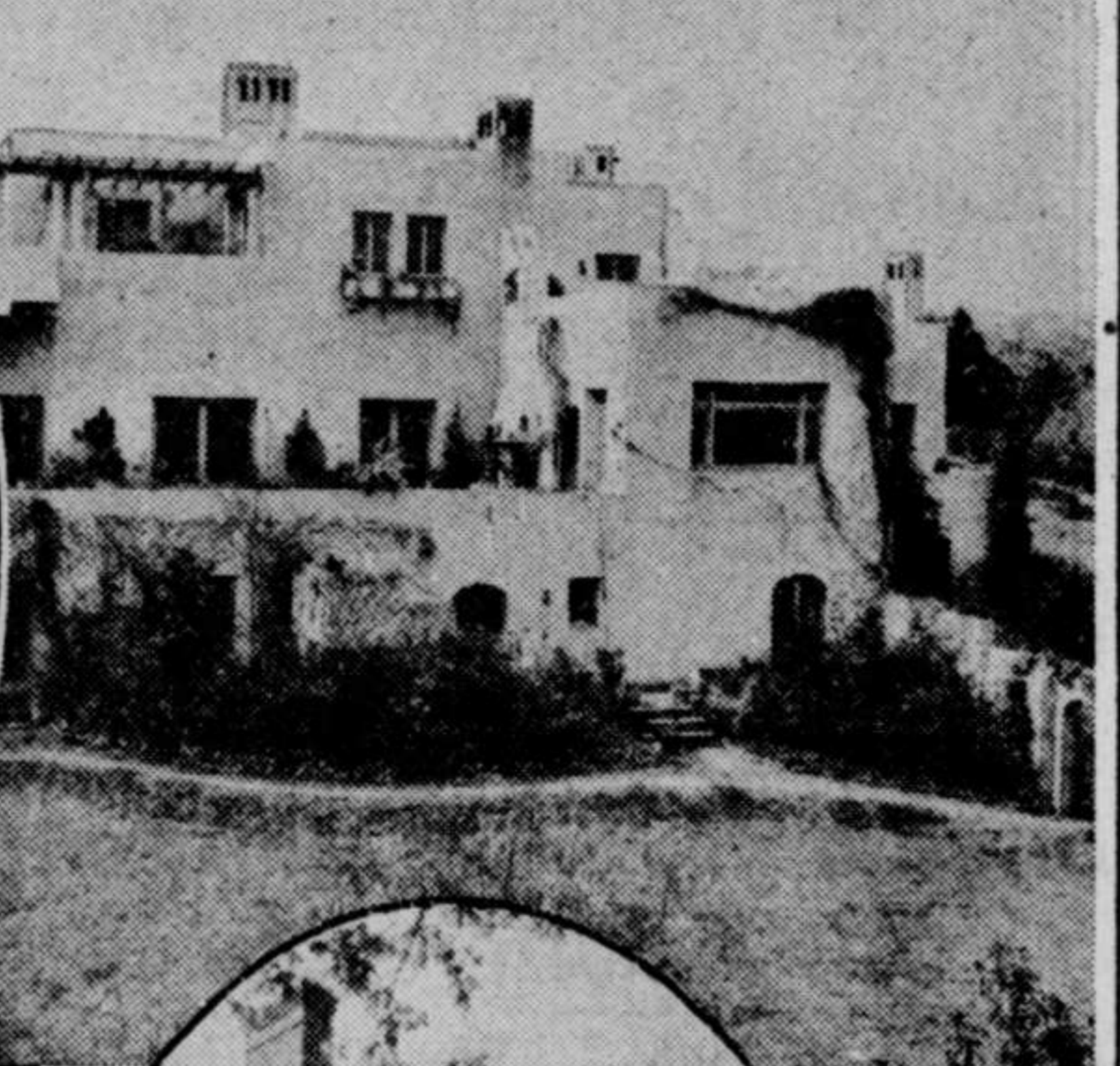
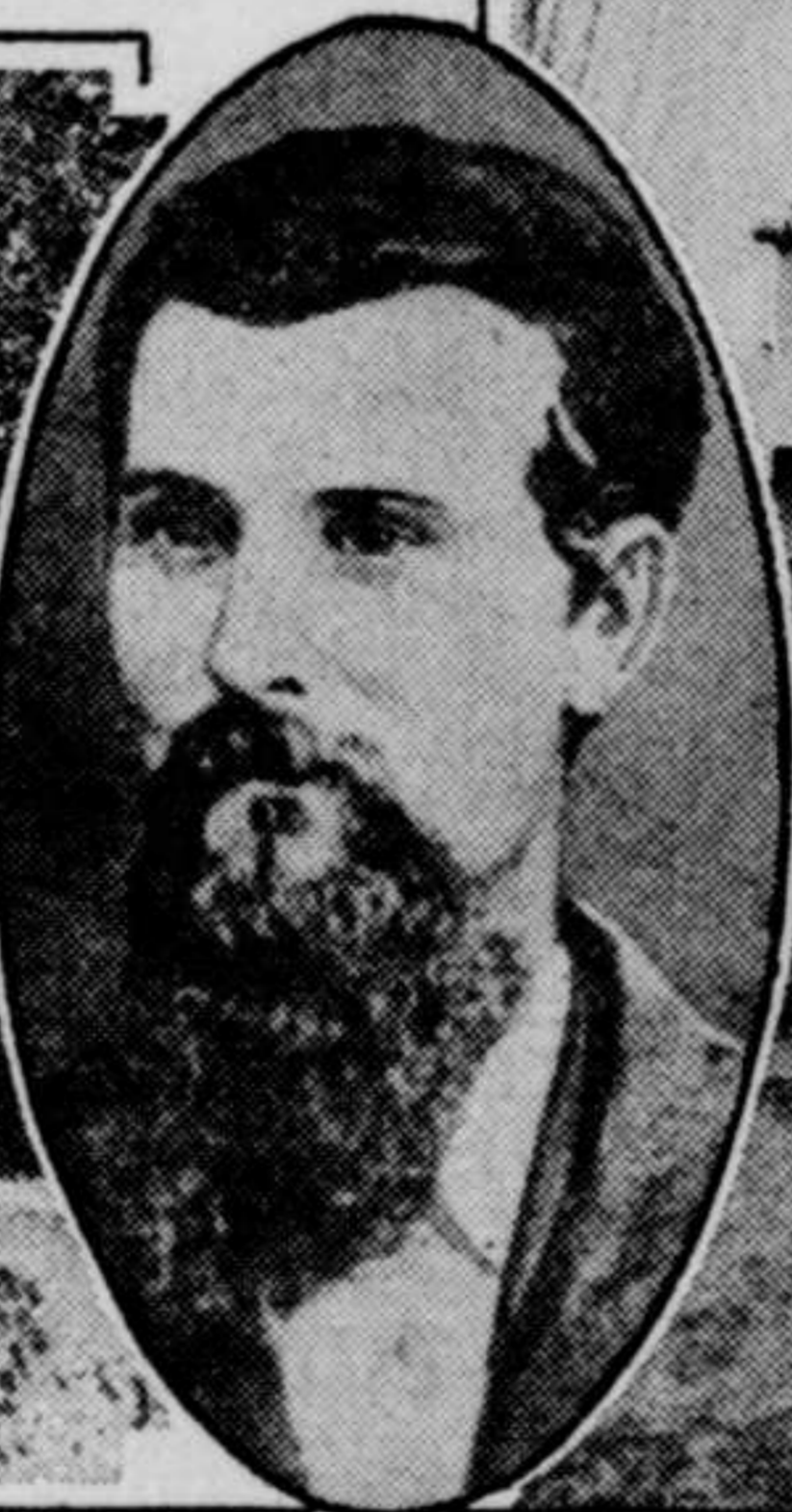

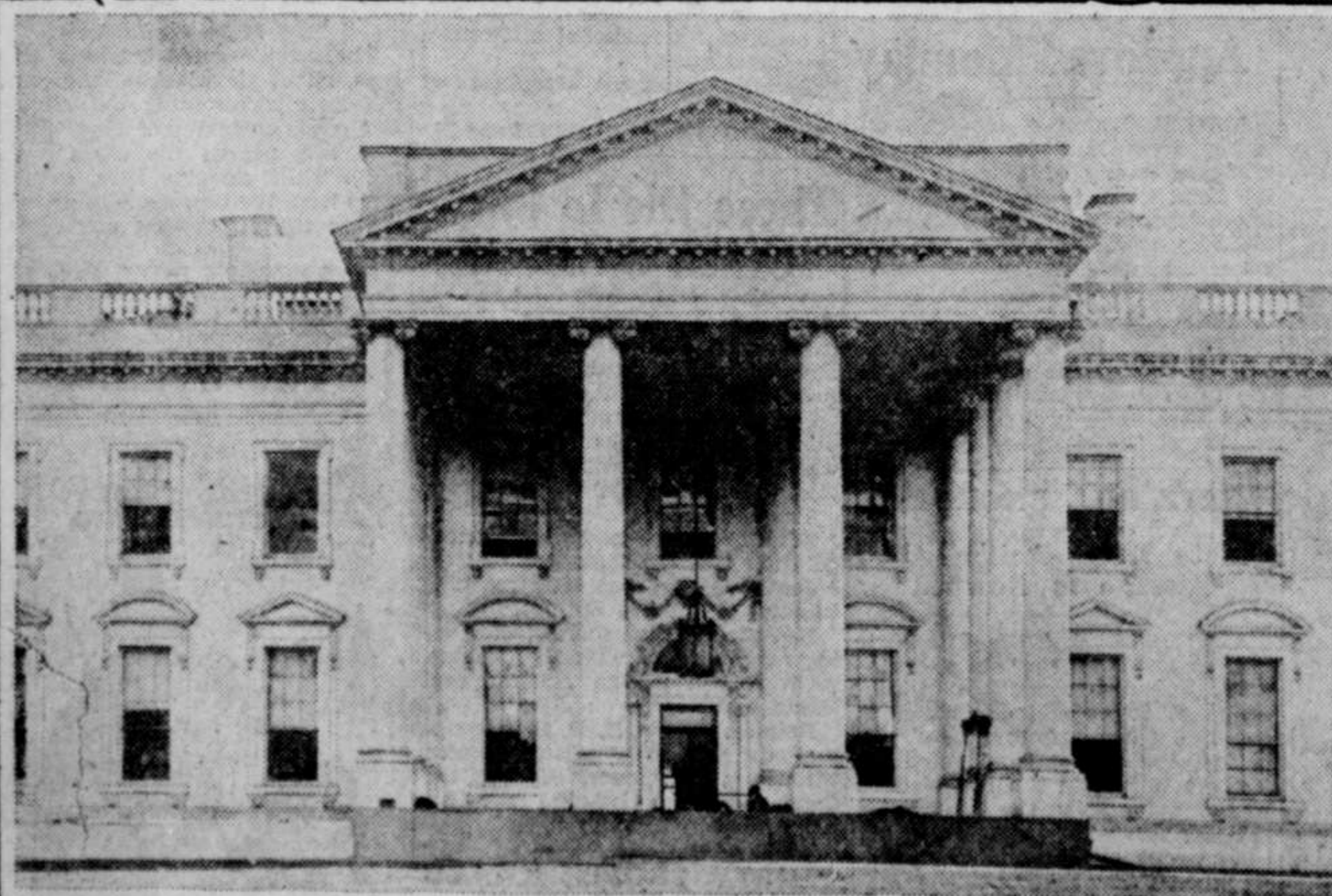

A body will rust out and a mind will rust out much more easily than they will wear out. Too much work is bad, but too little is worse. This goes for children, too, although in their case we must class work and play together under the head of "activity." Play is Nature's way of developing every mental and physical process a child possesses. If he spends hours aimlessly idle he will become a dullard.

Don't Overdo Reading

Reading is excellent, but there is one trouble with too much time spent on books. A child who reads constantly is living vicariously—picking up impressions through the experiences of others, either in fact or fiction. He is not coming into first-hand contact with life—not getting his knowledge and impressions from actual experiences under the head of "activity." Play is Nature's way of developing every mental and physical process a child possesses. If he spends hours aimlessly idle he will become a dullard.

Encourage Activity

They should be mentally or physically active, or better still, both, most of their waking hours. Little children, of course, must have intervals for sleep and rest, and for that matter, older children should rest, too, for a short time through the day, the length of time depending on their age, strength, and health.

The Morning Avalanche Menu for the Day

By SISTER MARY

BREAKFAST — Stewed rhubarb, crisp boiled bacon, shirred eggs, Graham muffins, milk, coffee.

LUNCHEON — Cream of celery soup, croustons, stuffed apple salad, rice and fruit pudding, lemonade.

DINNER — Casserole of round steak and onions, rice, potatoes, jellied cabbage and pepper salad, old-fashioned bread pudding, milk, coffee.

No cereal is suggested in the breakfast menu but the meal is well balanced and nourishing. Children under eight years of age should have a well-cooked cereal with plenty of cream regularly for breakfast but adults and older children need a change.

Rice and Fruit Pudding

One-half cup rice, 1-2 cup chopped dates, 1-2 cup chopped figs, 3-4 cup sugar, 2 tablespoons granulated gelatin, 1-4 cup cold water, 1-3 cup orange juice, 1-4 cup lemon juice, 1 tablespoon preserved ginger syrup, 1 cup whipping cream, 1-5 teaspoon salt, 1-2 teaspoon vanilla.

Cook rice in boiling salted water until tender. Drain and add at once sugar, dates and figs. Mix thoroughly. Soften gelatin in cold water for ten minutes. Dissolve over hot water. Add oranges and lemon juice and ginger syrup. Whip cream until firm and beat in gelatin mixture. Add to rice and beat mixture. Stir until mixture begins to set. Turn into molds and let stand until chilled and firm. Unmold and serve with minced preserved ginger sprinkled over top. (Copyright, 1929, NEA Service, Inc.)

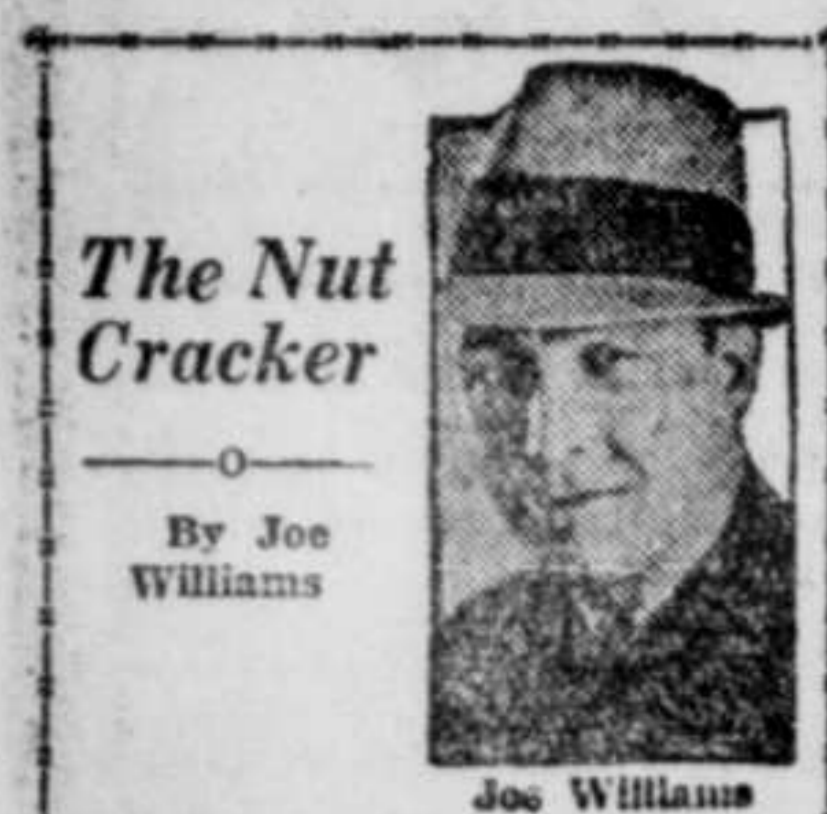

Jack's Success As Promoter Of The Miami Meach Tussle No Sign He Will Fill Position Left By Tex Rickard

Farrell Thinks Ex-Champ Will Promote In West; Rickard's Job Doesn't Pay Enough

NEW YORK, March 4.—Jack Dempsey stepped out with the regular Dempsey being as the front man in the promotion of the Sherkey-Stripling fight at Miami Beach but his success does not mean that he will step into the shoes vacated by Tex Rickard.

It was assumed when Dempsey volunteered to protect the interests of Mrs. Rickard in the Miami Beach fight that he would be tendered the big job in the Garden if he managed the show successfully in his first effort of the kind. It was also assumed that Dempsey had a lot of his own money involved in the show that was almost flat by the death of Rickard, but it has been learned from a very good authority that Dempsey didn't have any money in the venture and that he was acting as a Samaritan.

It is very unlikely that Dempsey will consider an offer to step into the head office in the New York Garden. He refuses to say that he had been offered the job but he speaks of situations that obviously are not based on dreams or long thoughts.

"I don't believe the Garden would be willing to pay enough money to interest me," Dempsey told the writer after the fight. "Tex got thirty or forty thousand dollars a year in salary and that's a pretty good salary but Tex spent fifty thousand a year on the job. There's no percentage in that. I have to make some money."

"Haven't you a lot of money?" I asked him.

"What do you call a lot of money?" he asked.

"Well, what would be a terrific lot of money for me possibly would not be so much for you," I answered.

"That's just it," he went on. "No matter how much money you have you can always use more. Most of my money, now that I am not fighting, is being put out. I live comfortably and it takes money to live as I do."

"I'm not broke and never will be broke, if that is what you mean. I have enough money invested in principal that I can't touch to keep me independent for the rest of my days but I don't want to live on that money."

Brick Owens At The Plate

Base Running A Lost Art But Has Been Valuable In Stopping Double Plays

(This third of a series of inside baseball yarns as related by the veteran artiller of the American League.)

Base-running has become a lost art with the advent of the "rabbi" ball. The high records of some years ago appear all out of proportion to the batting averages of other days. However, some years ago, during spring training, I was sliding on a field of the day, the daily grind. John McGraw has always been a strict advocate of base stealing. And yet, the leading base stealer in the major leagues falls far short of those of a decade ago.

The slide is made valuable in recent years in an endeavor to stop a double play. A second baseman or shortstop must need a dancing master to escape the flashing steel of the runner coming in from first base, whose idea is to prevent the batter from being put out in a double killing.

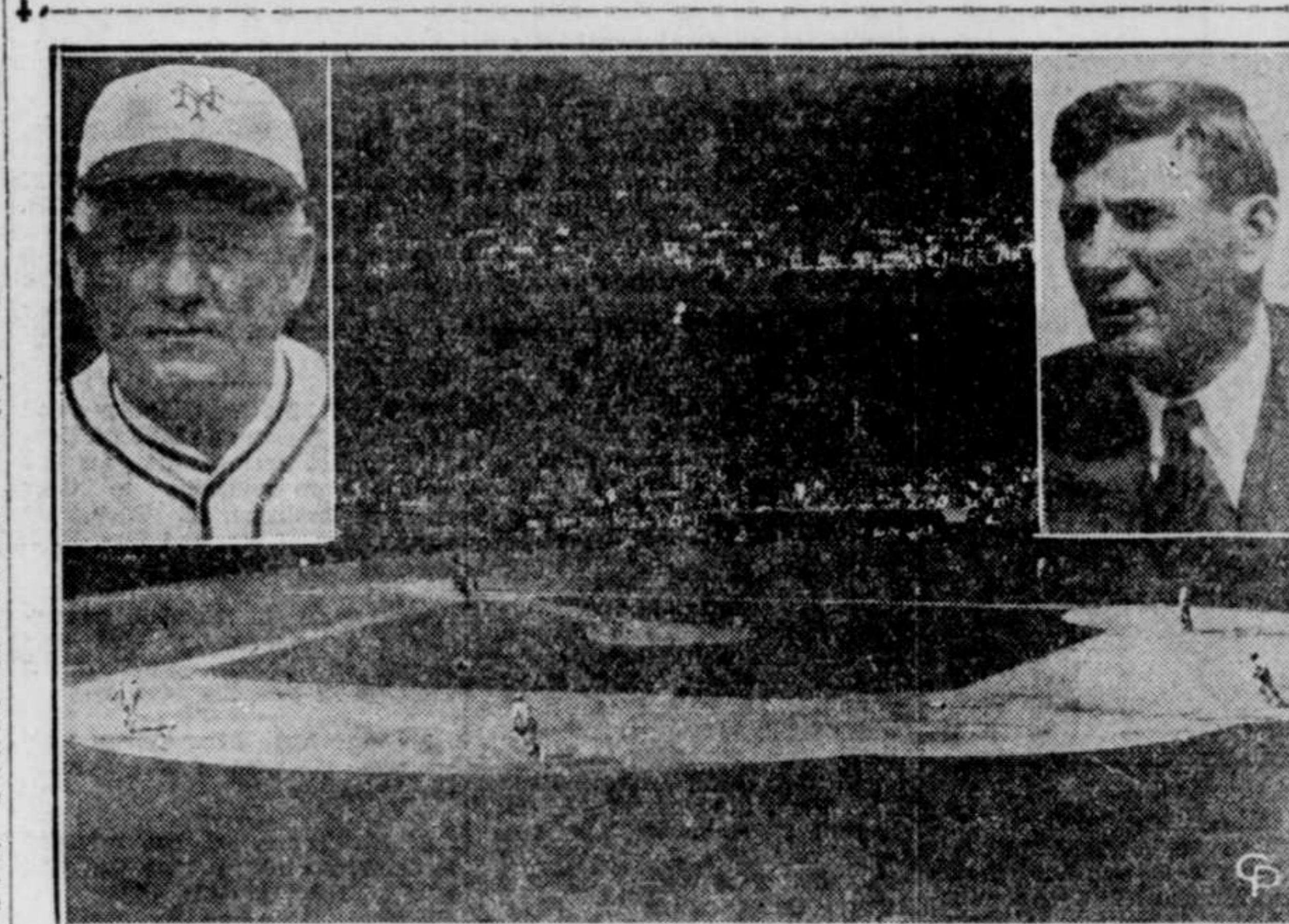
Some there are who slide into second base completely upsetting the pilot man in an attempted two-ply killing. They have timed their slide so as to knock the fielder over. Nothing in the rules covers any play of this kind. It is perfectly legitimate. The only harm is to the uniform of the bowled-over player.

Teams who play the "hit and run" need that additional help. It is not always successful and, occasionally, the batter hits directly an infielder. The result—bases cleared and two hands down.

In the New York-St. Louis series, last fall, one of the best examples of breaking up a double play came to light. The third game of the series was played in St. Louis. 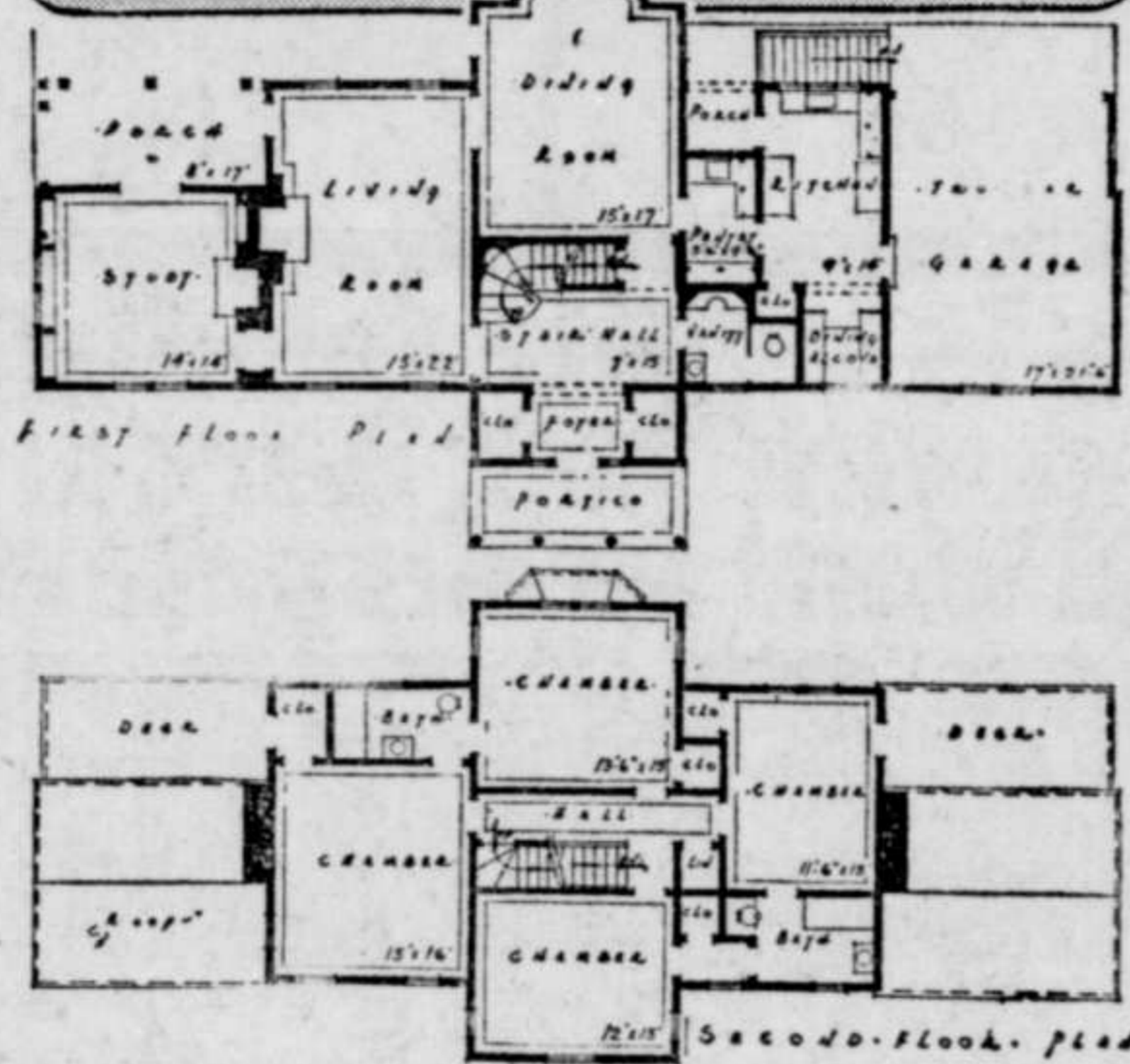

Kellogg Rose To Top From Poverty

Parents Left Only Heritage Of Handicap To Retiring Secretary Of State

(By Associated Press) WASHINGTON, March 4.—Some seventy-two years ago a son was born in Potsdam, New York, to parents who could leave him little but a heritage of handicaps. In a few days that son will be closing the book of his long public service with an achievement that bulks large in the history of statecraft.

A new ark of the covenant of peace has been prepared; there is in the making the first universally given pledge of civilized peoples and their governments to abstain from aggressive warfare. And across that document a self-made American may write his name in this wise: Frank Billings Kellogg, his wife.

Lie became a grinding actually for Kellogg and the daily, endless drudgery of boyhood on a frontier cabin farm in Olmstead county, Minnesota. That toil wrought into his small, slender frame all the endurance of the pioneers. Now his years sit lightly on bent but

vigorous shoulders. Despite physical mischance that robbed him of half his sight, he is a hale, hearty man at 72.

A thick thatch of snowy hair shades a face, round-cheeked and ruddy as a June apple. And all the tension time has laid on his nerves cannot best the ability to drive a golf ball straight and far.

Behind this hearty friendly little man lies a record of advancement, strikingly American. Opportunity has been his steed from boyhood, ambition his spur. Self discipline drove him to pore over text books as a boy as he rested from work with plow or hoe. It urged him ceaselessly until he now looks back to see himself successively a noted lawyer, president of the American Bar association, government trust buster, senator, ambassador to London, secretary of state. Growing it all he leaves office with foreign relations more tranquil than in many years.

Damage Suit For \$30,000 Comes To Trial Here Monday

Trial of the \$30,000 damage suit, brought by Mrs. Clara McCallan and Mrs. Elmira McCallan against the Lubbock Sanitarium, in the Seventy-Second district court, which started Monday afternoon, was not completed at 5 o'clock, Judge Homer L. It is claimed by them that McCallan was operated on at the institution, for appendicitis, on June 18, 1928, and again on July 14, and that the wound from the operation never did heal, his intestines being perforated, and that he died on December 2, 1928, as the result.

Young Mexican's Trial Is Started

Concho Torres Is Guarded Against Attack; Claims Mix-up In Marriage Customs In Texas

(By Associated Press) DALLAS, Mar. 4.—Concho Torres, guarded against possible attack, today sat through selection of a jury to try him for criminal assault here while his lawyer was taken off to jail for contempt and a pistol was removed from the pocket of one of the state's witnesses.

Torres is charged with criminal assault on the daughter of a Hill county farmer. Traditional Rise Fails To Appear On Stock Market

Inauguration Day Held Little Encouragement For Shares; Numbers Sell Off Sharply

By CLAUDE A. JAGGER, Associated Press Financial Writer

NEW YORK, March 4.—(AP)—Inauguration day on the New York Stock Exchange provided little cheer or "bull" traders today as the market sold off sharply after several ineffectual attempts to bring about a general rally.

Several reasons were advanced or the reactionary price movement, one observers attributing it to the traditional "selling on the good news" following the publication of the Hoover inaugural address, while others regarded it as reflecting speculative disappointment that the address had failed to come up to earlier forecasts.

Revolutionary disturbances in Mexico and the prospect of a further hardening of money rates here were regarded as reflecting speculative disappointment that the address had failed to come up to earlier forecasts.

The monthly report of stock exchange member loans, issued after the close of the market, showed a total of \$5,678,545,917 at the end of February, a decrease of \$56,168,325, compared with the end of the preceding month.

There was little in the day's business news to influence the price movement. Dividends were inaugurated on National Tea new stock at the annual rate of \$1.50, equivalent to \$6 on the old stock which paid \$4 annually, and on International Nickel new at the annual rate of 80 cents, equivalent to \$4.80 on the old, which paid \$3.

Heavy over-subscription was reported for the new Kolster-Brazides, \$4 annually, and on International Nickel new at the annual rate of 80 cents, equivalent to \$4.80 on the old which paid \$3.

American Express, which established a new high record at 330 last week, broke 25 1-2 points to 302 on a couple of sales.

Packard Motors turned reactionary on the announcement of a price cut for the company's 8 cylinder cars, but Chrysler was run up more than 5 points at the expense of an over-crowded short interest, but lost nearly half its gain.

Stocks of copper companies operating in Mexico, namely American Smelting, Home Sound and American Metal, were under pressure, but the losses were held at a point or two.

Rails, which were heavily bought last week on rumors that the Hoover inauguration message would recommend early legislation to facilitate railroad consolidations, fell back when publication of the message disclosed no such reference. Canadian Pacific, New York Central and Atlantic Coast line each lost 3 points or more.

Except for declines of a cent or so a bushel in grain futures, the commodity markets developed little of interest.

Cotton Irregular And Unsettled On New York Market

NEW YORK, Mar. 4. (AP)—After selling up to 20.73 for May, or 20 points net higher on buying promoted by continued favorable reports from the cotton goods trade and reiterated complaints of delayed farm work, cotton became irregular and unsettled in late trading today.

May reacted to 20.53 and closed at 20.68. The general market closed steady at net advances of 3 to 13 points on the old contracts. New contracts for new crop deliveries were net unchanged to 5 points lower.

The opening was steady at an advance of 7 to 10 points on renewed buying apparently stimulated by reports of good sales in cotton goods last week, favorable trade advices from Manchester and reports of further rains in the south. The advance met considerable realizing, but was absorbed on slight setbacks.

The market worked up to 20.70 for March and 19.94 for the new October contracts in the early afternoon or about 12 to 20 points net higher.

Wall Street and western interests were reported buying on the advance. The advance was supplied by re-advancing as prices approached the 30 3-4 cent level for May contracts and the market became rather irregular and unsettled in the late trading. Prices sold off rather sharply under profit-taking and some local and southern selling. The trade, however, bought old crop months on the reaction and these deliveries showed rallies of several points from low points in the last few minutes.

One of the large local dry goods houses reported that its sales last week had been 55 percent in excess of production. Cable advices reported fair cloth goods from India and China at Manchester. Private cables said trade calling and continental buying had been supplied by re-advancing in Liverpool.

Cotton Weakens In Orleans Exchange Over Hoover Talk

NEW ORLEANS, Mar. 4. (AP)—After working 14 to 15 points higher on a demand stimulated by Secretary Hester's bullish fertilizer report the cotton market weakened in final trading today on a wave of selling said to have been induced by disappointment over President Hoover's inaugural speech relative to agriculture and business. May contracts after selling to 20.92 eased off to 19.87 and closed at 19.93, or 6 points net up. The general market closed steady at net gains of 3 to 10 points.

Liverpool cables were rather indifferent at the start here and first trades showed no change to 4 points up compared with Saturday's close. Soon after the start good buying developed when Secretary Hester announced fertilizer sales for the seven months ending with February were 541,240 tons less than for the same period last season.

The subsequent bulge met considerable realizing and hedge selling but the demand proved sufficient to absorb offerings at setbacks of 1 to 4 points in the early afternoon March traded to 19.82, May 20.02 and July 20.08, or 14 to 15 points net up.

Some of the afternoon buying may have been promoted by anticipation of constructive passages in President Hoover's address but towards the end early buyers re-sold and prices dropped practically to Saturday's closing levels. There was a moderate rally near the end on covering and July closed at 19.99 and October 19.70, or 3 to 5 points net up.

Troop movements were reported on both the east and west coasts and another concentration at Monterrey indicated the possibility of combat in that section. The United States government was watching the situation but had taken no action.

MEXICO CITY, March 4. (AP)—Announcement was made tonight that General Juan Andreu Almazan would lead federal troops against the Aguirre rebels in the state of Vera Cruz.

CALEXICO, Cal., March 4. (AP)—As a part of the mobilization movement in Lower California, the Mexican government commandeered 12 commercial trucks at Mexicali tonight to transport soldiers and supplies from Tijuana, Tecate, Alaska and other border points to the federal garrison at Mexicali.

VERA CRUZ, March 4. (AP)—Gen. Jesus Maria Aguirre, head of the revolutionary movement in the state of Vera Cruz, in a statement to the Associated Press tonight, said the

revolt of which his activities are a part is headed by Gen. Jose Gonzalo Escobar, former federal military chief in the state of Coahuila.

LAREDO, March 4. (AP)—Two squadrons of the garrison at Nuevo Laredo, across the border from this city, were ordered to Monterrey, 150 miles south of here, today.

Reports said that an army regiment had revolted there and entrenched itself at Topochico, five miles south of Monterrey. Monterrey is in the state of Nuevo Leon.

NUEVO LEON, State of Tamaulipas, Mexico, March 4. (AP)—Local banks transferred their funds to the north side of the Rio Grande today. This step was taken, presumably, because of fear of a rebel movement from the state of Coahuila. The international bridge here remains open.

BROWNSVILLE, March 4. (AP)—The regular train from Matamoros, across the Rio Grande from Brownsville, to Monterrey, Mexico, did not make the trip today. Military and rail officials refused to comment on cancellation of the run, but it was taken to indicate revolutionary activities along the railroad.

EAGLE PASS, March 4. (AP)—All rail traffic from the United States to Piedras Negras, across the border from here, was halted this afternoon on the orders from the superintendent of the Mexican International lines at Monclova. The order stopped passenger as well as freight trains. To date traffic over the foot and vehicle bridge has not been disturbed.

Johnston Defense Attempt To Prove Coercion In Case

Story Of Purported Threats And Questioning Is Told In Sooner Trial; Nance Is Named Leader

(By Associated Press) OKLAHOMA CITY, March 4.—A story of purported threats and questioning by what he termed a "kangaroo" court was elicited by defense counsel of Henry S. Johnston, suspended governor, in his impeachment trial here today from T. N. Crosthwaite, Ardmore cobbler. Crosthwaite is the father of R. D. Crosthwaite, who as a fugitive from the state penitentiary to which he had been committed for murder, was granted a pardon by Governor Johnston that forms the basis of one of ten articles of impeachment preferred against the suspended governor.

Limps To Stand The cobbler limped to the stand to relate that James Nance, state representative, had tried to coerce him with threats of imprisonment to change testimony which Crosthwaite had given before the house investigating committee. Another attempt was made by men, whom he said he did not know, Crosthwaite said, to make him forswear his testimony before Edwin Dabney attorney general.

After he had been subpoenaed to appear before the investigating committee and before he testified, the elderly cobbler said, he was hauled at his hotel before a group of men who represented themselves to be the investigating committee, but who, he said, he thought really were a "kangaroo court". They questioned him in relation to the pardon case, Crosthwaite said.

Eaker Goes Ahead With Flight Plans

Pilot Of Endurance Plane Anxious To See That Preparations Are Carried Out; Takes Off March 10

(By Associated Press) SAN ANTONIO, March 4.—Anxious that no preparation for his dawn-to-dusk Brownsville, Texas to Panama flight attempt be overlooked, Capt. Ira Eaker will go to Brownsville Tuesday to oversee all arrangements for housing and servicing his little Boeing army plane, he revealed today. He will take-off from Brownsville about 5 a. m., March 10, in the Brownsville-Panama attempt.

In the meantime he plans to spend two days in Oklahoma, arriving back in San Antonio Thursday a day in advance of the dedication of his ship as the "Pan-American." Eaker, the famous pilot of the Question Mark, expects to start for Oklahoma sometime Tuesday, after the Brownsville arrangements have been completed. Wednesday morning at Oklahoma City, he will appear before a joint session of the state legislature; Wednesday night he will be honored at the Tulsa chamber of commerce dinner.

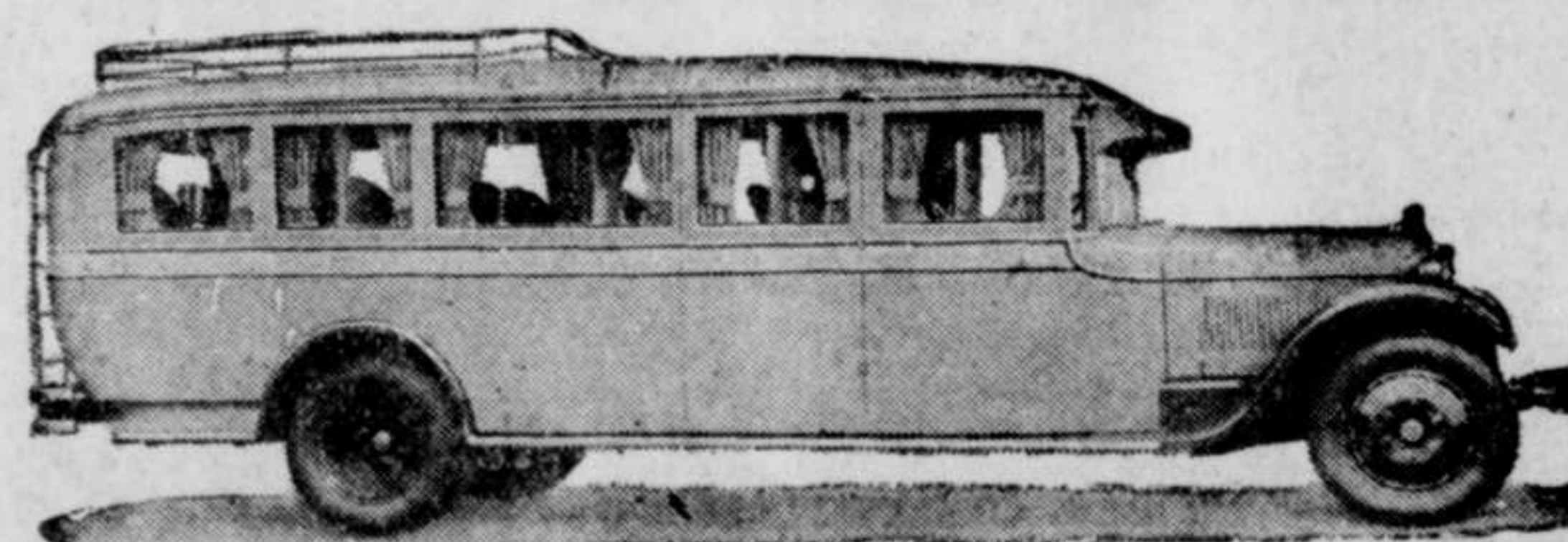
