STATE'S RECORD CLEMENCY LIST AGAIN BOOSTED

JIM OKEYS PARDON MADE FOR DECHERD, A ONE TIME ENEMY

AUSTIN, Texas, Jan. 11. James E. Ferguson endorsed the full pardon of E. A. Decherd of Dallas, who as state senator in 1917 voted for Ferguson's impeachment as governor, the proclamation released Tuesday by Governor Miriam A. Ferguson showed.

Gov. Ferguson's clemency acts today amounted to 1,177, with the granting of 32 full pardons, two citizenship restorations, the commutation of a 25 year murder sentence to three years, five paroles, one furlough extension, three bond forfeiture remissions, and two full sentence remissions.

Lipstick More Than Beauty Aid—It Helps Your Health

Give credit where it is due and thank the lipstick for what it contributes to beauty even though too often it conceals more than it reveals. For undoubtedly those who use a lipstick conscientiously and frequently are rarely troubled with chapped lips. This constant application of lip salve forms a protection which wind and cold cannot penetrate.

However, it is not the coloring that does the trick but the grease in which the color is held. You can obtain the same effect by applying any lubricant such as camphor oil, white vasoline or heating cream. Or you can buy colorless lipsticks that come in handy little tubes that may be applied just as the stick is.

If you do have frequent recourse to your lipstick, don't forget the little French trick of going over the divide between the lips and the complexion around it with powder to relieve the harsh line and give a more natural look.

In the winter time many women are afflicted with cold sores and fever blisters, which are anything but attractive. To remedy this, soften the afflicted spot with vasoline or cold cream and then bathe with spirit of camphor. For fever blisters, bathe with a solution of peroxide of hydrogen and anoint with borated vasoline. I cannot be too emphatic in urging you not to aggravate by picking or undue rubbing any small pimples or blisters that may appear about your mouth. The danger from infection is very great, and serious consequences often result from what would have been taken care of itself had it been given the opportunity.

HIGHWAY BIDS WILL BE SEEN

County Commissioners Are To View Propositions On New Road To Brownfield

The Lubbock county commissioners court will receive bids at 2 o'clock Wednesday afternoon in the court house here on a little over 14 miles of highway from Lubbock to the county line in the direction of Brownfield. The bids to include grade and drainage construction pursuant to eventual hard surface, county officials said today.

This is the second of the county's projects, one contract on the Slaton highway having been let by the state highway commission, and work is now being finished under supervision of Fred Holt, contractor. Three more projects in the county are contemplated, plans on which have been received by B. K. Garrett, resident engineer. Bids were to have been received by the state department December 26 on the Shallowater project, but negotiations were halted temporarily by the recently dissolved injunction granted Attorney General Dan Moody.

It is understood that several contractors will be here Wednesday to submit proposals on the Brownfield project.

Final Authority Received
Final authority authorizing the county to proceed on the original plan of the county paying half the cost, and the state the other half was received by County Judge Chas. Nordyke Monday, although authority had been tentatively given in a recent vote from the state department.

Judge Nordyke wired the commission at Austin stating that the county is ready to proceed on the above outlined plan, and confirmation of the authority to proceed was immediately wired back.

It is expected that at least eight bids will be submitted on the project.

NEW YORK, Jan. 10.—It is true that the gowns and coats of this season are not startlingly different from those of last, but how the accessories have changed! And how they have increased in importance!

In assembling her day costume, a woman no longer considers the job done when she has her hat, shoes, gloves and handbag purchased. No, indeed—there is yet at least a scarf, fancy kerchief, bouquet, bracelet and costume jewelry to be attended to.

And as for the evening costume, it is only begun when the gown is bought. Fans, for instance, are absolutely indispensable. Ornate fans, in plain colors and in shaded effects are very smart. The model photographed is one of Callot's latest creations—a gold colored coque feathers on a shell frame.

And Many Flowers

Fans all larger than ever, and consequently more costly. With the simple frock they are usually darker than the gown, or else they contrast colors. With a pink gown, nothing is lovelier than a fan in the deep red tones, or in the bright shades from

In the spring the Bisons will get three more players in option two from Brooklyn and one from New York. In this involved shuffle the Giants obtained Henline and Harper for Thompson and Scott, then shifted Henline to Brooklyn for Grimes.

MY LIFE STORY

"He's broken one of poor Johnny's ribs—I see it sticking through his jersey!"

Can you imagine how it felt to have a big, dynamite-punching fellow pounce on you with terrific force right over your short ribs, hear someone yell the above cry of alarm, imagine your side has been blown away and then reach down with your glove and feel the protrusion?

I was ready to drop from sheer fright when this incident occurred in my memorable fight at the Evergreen cemetery at dawn one Sunday with Jake Karcher, who used to work at the same cooper shop with Jack Dempsey, and who challenged me to my first secret fight.

That day I had forgotten I had two plasters on my back over my kidneys. Karcher lammed me with a couple of stiff body punches. One of the plasters loosened at the corner and rolled up like a ball.

I was sure relieved after that round to find his terrific poke in the ribs had busted only the kidney plaster instead of a bone.

We battled on and on and I began to cut his face unmercifully. We were using kid gloves and with kid gloves you can sure clench your fist tighter than bare knuckles and deliver a killing blow. In the seventeenth round I smashed him one on the chin and he sank like a rock.

Well, sir, the funniest thing happened after the fight. Everyone left in the customary threes and fours and finally only Karcher and myself were there. We walked out together and Karcher's face was a mess. He looked as if he'd been run over by a steam roller. We walked up to a car. The conductor took one look at Karcher and wouldn't let him on.

"You'll say you've been hit by a train and try to collect damages—get off!" He shouted at poor Karcher.

I fought in a number of amateur tournaments after this and later became acquainted with a nice young chap named Arthur Brisbane, who was writing space on the Sun. He attended quite a few of my shows.

I worked my way up to the finals for the amateur lightweight title and met and walloped Bill Ellingworth for the crown. Then I followed Jack Dempsey's advice and quit the amateurs.

No Czar Ever Had Power That Big League Magnates Have Given Judge Landis

NEW YORK, Jan. 11.—No czar in all world history was ever given the supreme power that the 16 owners of major league ball clubs have delegated to Judge Landis, commissioner of baseball.

While Judge Landis has given no final decision in the Speaker-Cobb case, merely making public the evidence as presented, baseball fans are wondering just how great is the power of Landis in handling such cases.

The jurisdiction of Judge Landis in the latest baseball scandal is covered by section two of article one of the major league agreement. It reads:

"The functions of the commissioner shall be to investigate, either upon his own initiative or upon complaint, any act, transactions or practices charged, alleged or suspected to be detrimental to the best interests of the national game of baseball; with authority to summon persons and to order the production of documents; and in case of refusal to appear or produce, to impose such penalties as hereinafter provided.

"In case of conduct detrimental to the best interests of baseball by major league, major league clubs, officers, employees or players, punitive action by the commissioner may in any case take the form of a public reprimand.

"In the case of any official or employee of a major league or major league club, punishment may extend to suspension or removal. For such conduct a player may be declared by

Sled Allen And Grady Higginbotham, Former Big Leaguers, See Different Sides Of Present Baseball Scandals

A varied opinion is expressed here on the recent baseball scandal, in which "Swede" Risberg and "Chick" Gandil, two former White Sox players of Chicago, have charged some of the greatest diamond performers in the history of baseball.

Sled Allen, who for the past four years has led the Hubber forces of Lubbock, and who during 1910 was a member of the St. Louis Browns, states that he does not believe in the charges that have been brought forth by "Swede" Risberg and "Chick" Gandil on other players and is of the opinion that K. M. Landis will do nothing toward putting any of the accused out of the game.

When Sled Allen was asked of his opinion as to the moral conditions, generally speaking, of organized baseball, he stated that he thought it was good and that all of this publicity attacking the morals of the organized baseball was centered around the famous "scandal" which was brought out in 1919 implicating the Chicago Black Sox. "Morals in organized baseball are good at this time," he says they have an absolute power ruling the game in Judge Landis, who since his time as the 'Car of baseball' has certainly cleaned up the game, and it is now one of the cleanest games in sports," Mr. Allen stated.

Many College Grads
"Baseball is like any other institution; it has its good and bad characters, but on the whole men in organized baseball today are of high type of people, many of them college graduates," the Skipper added.

"I do not believe there is a thing to

the commissioner as temporarily or permanently ineligible to play with any club that is a party to this agreement.

For reasons best known to himself, Judge Landis did not formally declare Cobb and Speaker temporarily or permanently ineligible.

It is the intention of Ty Cobb, according to his latest statements, to force Judge Landis to give a definite decision in his case as to his eligibility.

the charges made by "Swede" Risberg, "Chick" Gandil, and the "Dutch" Leonard charges are nothing more than for revenge," Mr. Allen said.

"Judge Landis will clear the whole matter in the best way he sees and it will surely be final, for Landis is the supreme ruler in organized baseball."

Higginbotham Differs
While on the other hand, Grady Higginbotham, coach of the Tech-Malador football and basketball teams, is of the opinion that apart from the recent accusations, which implicates a number of the noted baseball stars, is true; but does not think that anything will be done toward removing any of the characters of the organization.

"I do believe this, and that is should Landis think that any part of the charges that have been made by Risberg and Gandil are true that he will pop it to them, for Judge Landis is that kind, he doesn't care who you are or how important you are," Coach Higginbotham said.

6 Members Of Cleveland City Commission Call Move Foolish But Vote

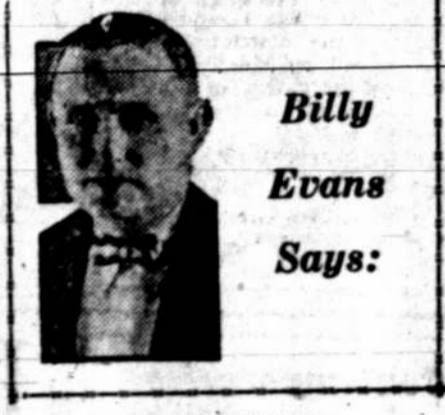

The feeling has grown that the commissioner while passing on the Gandil-Risberg charges, also will commit himself in some manner on the Cobb-Speaker case. If he does not, it has been intimated that attorneys for these two will press upon him their demand for a definite ruling on the status of their clients, with the threat of some legal action if the commissioner does not give Speaker and Cobb clean slates.



Billy Evans Says:

Intentional Pass

Recently I wrote an article dealing with the intentional pass in baseball. The fact that Babe Ruth, baseball's greatest slugger, received 11 bases on balls in the last series prompted the story.

Prior to the opening of the series, Manager Rogers Hornsby of the Cardinals said Ruth was just hummer and that he had issued orders to all of his staff to pitch to him.

For a time, they did, and then in one game Ruth made three home runs and put an entirely different aspect on the situation.

While it is doubtful if the intentional pass is ever abolished, still there is no denying that it is one of the most unpopular features of the game.

I commented upon several suggestions or not I cannot say," Coach Higginbotham said.

"The moral conditions of organized baseball are just like any other big institution; there are good and bad men in baseball. But generally speaking the morals are good in my opinion."

Play Unpopular

That was about two weeks ago. Since then every mail brings from one to five letters expressing their disgust of the intentional pass.

While all seem a unit in the belief that the intentional pass should be abolished, only a few offer suggestions as to how it could be done without hurting the game.

I am taking the liberty of printing one of these suggestions that to my way of thinking have some merit.

"My suggestion," writes a Chicago fan, "deals with the unintentional as well as the intentional pass. If a pitcher lacks control to the extent that he makes only four pitches to the batsman, all of them being called balls, he should be penalized."

"The suggestion applies only when there are four pitches to a batsman and let of them are called balls. That is usually the case when an intentional pass is issued, the pitcher throwing the ball so wide of the plate that the batter couldn't reach it were his bat twice as long as ordinarily used.

"If five or more balls are pitched, there would be no penalty, as the batter had been given an opportunity to hit and failed."

When the bases are empty, allow the batsman who receives four straight balls to go to second base. It's a simple solution of the evil that certainly has some merit. I would like to see some of the clubs try it out in spring training.

District Judge Clark M. Mullican, in his charge to the grand jury yesterday, literally "took the breath out of" some of his hearers as he told the newly empaneled inquisitorial body to investigate fully a number of startling conditions which the judge said were rumored to be prevailing in this county.

There is no doubt concerning some of the judge's statements. Some of them are proven almost every day in the news reports of the press. Others, however, came as a distinct shock and, if the information given Judge Mullican concerning them is found to be correct, they will present the most important session of district court in the annals of Lubbock county.

The Journal hopes, and is sure that the grand jury will follow the judge's instructions to the very end. Yet at the same time it also hopes that the findings of the body will not bear out all of the rumors which the court has had occasion to come into contact with. If such is not the case Lubbock and some of its institutions might fall under a cloud—the shadow from which might make for unfavorable publicity.

In expressing its hope the Journal does not wish to be interpreted as being opposed to Judge Mullican's charge. Further than that, and keeping in mind that official record, emboldened as it is with his many fearless acts in behalf of law enforcement, this newspaper is behind the district judge in his every effort to make and keep Lubbock county a better place in which to live.

It merely expresses the hope with the good name of Lubbock uppermost in mind.

Of course, no one in sane mind will object to the curing of ills, whether they be in the form of personal handicaps or public discrepancies and in urging that these conditions be cured, do prevail be removed, Judge Mullican is following the only logical path.

One bad apple, the old adage says will spoil a whole barrel of good apples. If not removed and the same undoubtedly holds good in regard to public peace and public morals.

The Journal's hope is merely that the percentage of bad apples in Lubbock's barrel is not as high as is rumored.

ALASKAN VOTE STILL BEING BROUGHT IN, VINDICATING SUTHERLAND'S STAND

WASHINGTON, Jan. 11.—Final returns from the November election have not yet dribbled in.

In far away Alaska, land of the sourdough and the malamute, Nome has still to receive the ballots from the country's wildest and most remote sections. Some day they will all be in, brought by boat or dog sled.

The main business, election of a territorial delegate to congress, has been decided long since. But there is enough romance in the situation to incite Robert W. Service to imagine a time of suspense when those votes might decide a prohibition referendum or something and to write such verse as:

Oh, how did they vote at Bristol Bay And Kotzebue Sound on election day? Did Russian Mission vote "yes" or "nay"? And what did the lover Yukon say?

The poem might be in print for months before Alaska knew the result of the poll.

In the present case, Bristol Bay, Kotzebue Sound, Russian Mission and the lower Yukon region probably will boost the huge majority piled up by Dan Sutherland, elected to his fourth term as delegate to Washington.

Sutherland's election by a 2 to 1 vote was Alaska's overwhelming vindication of his vigorous fight here against two judges and a United States attorney, first recommended for appointment by the department of justice while Harry M. Daugherty was attorney general.

These gentlemen are Judge Thomas Reed of Juneau, Judge Elmer Ritchie of Valdez and U. S. Attorney A. G. Shoup. Their terms expired in 1925. President Coolidge reappointed them on recommendation of the department of justice, and Sutherland promptly got busy to prevent confirmation by the senate.

The late Senator Cummins, then chairman of the judiciary committee, asked Mr. Coolidge to withdraw the names, which he did.

But Reed, Ritchie and Shoup still hold office and Sutherland, who made his opposition to them the principal issue of his Alaskan campaign, doubtless wonders when other appointments will be made.

The three federal officials have been charged with corrupt practices by John W. Frane, Republican national committeeman from Alaska, and one of the chief objections to them is that they are subservient to the packing and canning interests.

It has been alleged that Reed conspired with Shoup to prevent Frane from being seated on the Republican committee; rules of the justice department forbid them to mix in politics. One charge against Reed is that he sent three men to jail for 90 days for contempt of court merely because he believed their alibi was false.

These men, on trial for trap robbing on complaint of the canning companies, were acquitted both of that charge and a perjury charge brought against them. Ritchie, said to have been a fugitive from justice in Utah many years back, is accused of becoming vindictively abusive on the bench and scandals are charged against his court.

Under these three men, Sutherland and his friends say, the administration of justice and enforcement of law along the Alaskan coast has become demoralized.

The word "woman" says The Monitor, was put together in Anglo-Saxon times, in the form of wifman, meaning "female," that is "female human being." It is amusing to know that though this was its meaning, the compound was grammatically of the masculine gender, and the first part, which survives separately in our word "wife" was, when appearing alone, a neuter noun.

Even in early days the f tended to merge into the following n, so that we sometimes find wifman instead of wifman. Long ago the f vanished altogether. The original vowel sound, however, is more nearly preserved in our plural "women," than in our singular. Dialect writers used to think it humorous and quaint to spell the plural "wimmen," but in doing so they merely followed the accepted pronunciation. Why the u sound in the singular? Probably the u affected the sound of the adjacent vowel. The plural, women, had a differing sound in the second syllable, and therefore was better able to resist this influence.—Gainesville Register.

Lubbock's New Paving Program Will Begin As Soon As Possible; 38 New Blocks To Be Put Down By Dalrymple

The paving program, launched by the commission late Monday when contracts for nearly a quarter million dollars worth of additional paving and storm sewer was awarded to the Panhandle Construction company, of this city, will start just as soon as legal matters in connection with the program can be shaped up, John Dalrymple, manager of the construction company said today.

Contracts between the company and property owners on the streets involved in the program will be signed at the earliest moment possible, and with much equipment ready here, no delay is anticipated.

The Panhandle Construction company was awarded the contracts with a total bid of \$223,646.58, the paving to cost \$210,649.23, and storm sewer \$12,997.35. The winning bid on both projects was approximately \$1,500 under the next lowest, offered by L. H. Howard, of this city, who is now finishing up a contract at Station.

Brick On Concrete. The paving is to be 2 1/2 inch brick on 4 inch concrete, similar to the giant program finished here late in 1925, but the cost of this project is much less than the former. The unit bid on this project was \$2.70 while on the other it was \$3.03 per square yard, making a difference in saving to the property owner of \$25.36, based on a fifty foot lot and 30 foot street.

The saving in storm sewer work is a little over half in comparison to the other program, the price this time being \$1, while before it was \$2.03, based on 15 inch tile sewer.

On the basis of a 50 foot lot and 30 foot street, the paving will cost a little over \$200 per lot, which may be paid in six equal annual payments, the first payment to be made when the paving on abutting property is completed.

38 Blocks Involved. A total of 38 blocks, some of them 600 feet in length, is involved in the program, and the south part of the city will, when the program is finished, have access to the business district on two more paved streets.

Nineteenth street will be paved from Texas Avenue to College Avenue 30 feet wide. Texas Avenue from 14th to 19th will be 72 feet, with 20 feet of paving on each side and 32 feet parkway in the center. 16th street from Avenue Q to College Avenue will be 30 feet; Avenue H north of the railroad will be 30 feet; and Avenue G from 10th north to the tracks will be 55 feet wide.

U. S. Women Launch Fine Arts In China

PEKING, Jan. 11 (AP).—Transplanted art is flourishing here in what was formerly barren ground. The Peking Institute of Fine Arts, organized in 1919 by a group of American women, expects shortly to be housed in its own building with studios for the teaching of piano, voice, violin, cello, cornet, harmony and composition and with a school of modern Chinese painting.

It has occupied buildings in the former Austrian legation compound which were vacant since the war, but an old Chinese palace on the Nanchihite, one of the chief thoroughfares of the capital, has been purchased and is being remodeled. The institute was organized by Mrs. Koris, wife of Dr. John Koris of the Rockefeller foundation.

900-BARREL OIL WELL COMES IN AT SHAMROCK

SHAMROCK, Jan. 11 (AP).—What is said to be the best well in the Shamrock area came in late Monday when the water was cleaned out of the Gibson oil corporation's Bently number one, fourteen miles northwest of here at 2,334 feet. It is flowing by heads at the rate of 900 barrels, making the 14th producer in Wheeler county.

Here's How To Combat Cimex

Lectularius

BY DR. MORRIS FISHBEIN

Editor Journal of the American Medical Association and of Hygiene, the Health Magazine. Whenever there are men who are none too careful about the hygienic character of their surroundings can be found the little insect Cimex lectularius, more familiarly known as the bedbug.

It has no wings, but its body is quite flat and it conceals itself easily in the narrowest cracks and crevices of the bed and the walls.

The bite of the bedbug is accomplished by four thread-like filaments which glide over each other with an astringent motion and pierce the skin. Then it sucks blood through its beak. Some people are much more irritated by the bites than are others. These people will have swelling and inflammation after the attack.

When the householder decides to eliminate this insect he should realize that bedbug powders can not get at the eggs and the bugs concealed in narrow cracks.

Scalding water or soapuds will kill them but may also ruin the furniture.

Perhaps best of all is the use of a liberal amount of gasoline, benzine, kerosene or any other petroleum oil, in connection with which, however, there is always the possibility of fire.

Fumigation with hydrocyanic acid gas is effectual, but can be used only with great caution.

The bedbug has a peculiar odor, produced by certain glands. Otherwise he seems to do no particular harm since he never has been definitely connected with the transmission of disease, though often suspected.

The presence of this insect around a bedroom offends the sense of cleanliness and if many of his family are along they can produce insomnia.

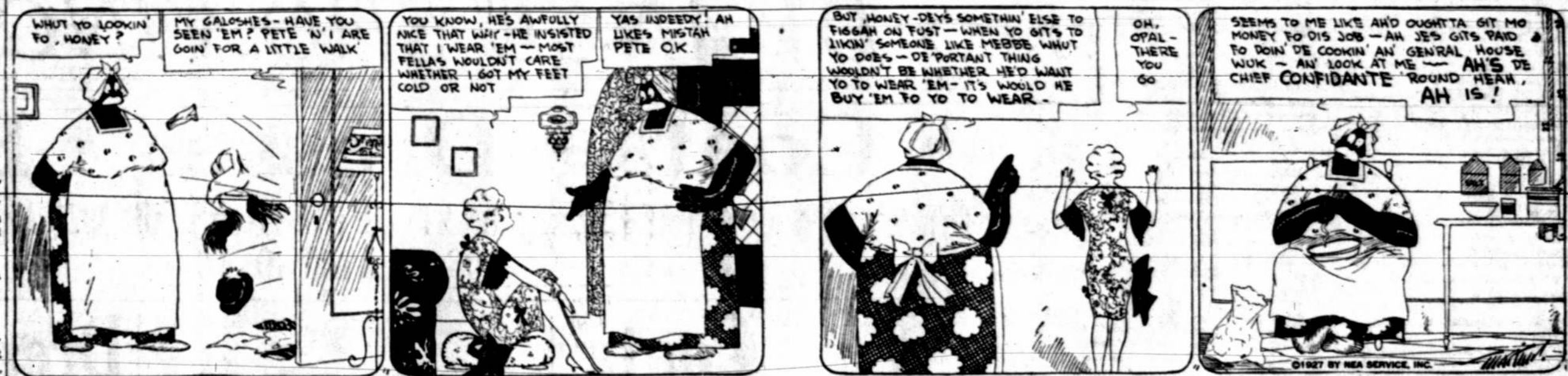

WAR IN MEXICO ASSUMES RELIGIOUS PHASE

CATHOLICS RAID CITY; 21 KILLED IN STREET WAR

SCATTERED REPORTS ARE RECEIVED AND SHOW MUCH FIGHTING

(By The Associated Press)

MEXICO CITY, Jan. 11.—Special dispatches from Guadalajara state that 21 persons have been killed and ten wounded in a clash between Catholics and the municipal authorities in the town of Coscuta, state of Jalisco.

The mayor, Coscuta and the local deputy, Sustenia Castilla, were among those killed.

The dispatches, which were lacking in details, reported that the municipal authorities offered opposition to a religious demonstration where upon the Catholics attacked municipal officials, employees and policemen, a battle ensuing.

Agrarians Support Calles

The Agrarians, it was announced today, have decided to support President Calles and Mexico City headquarters has instructed all Agrarian organizations throughout Mexico to cooperate with federal troops in pursuit of rebels where ever found.

Dispatches from Torreón state that an official report has been made by Colonel Salvador Yáñez saying that his troops overtook a group of rebels who began hostilities at Parras de la Fuente, state of Coahuila, killing two and capturing ten in a clash at Palo Alto.

The report states that nine of the ten captured were summarily executed, the only one spared being Jesse Reyes, aged eighty. The rebel leader Antonio Hunez was among those executed.

MEXICO CITY, Jan. 11.—The Mexican religious situation, considering since issuance of the government's church regulations, seems to have taken a serious turn.

There are reports of armed Catholic uprisings in the states of Durango, Michoacan and Jalisco, and one bishop claims to have information that important cities have been captured, the news being unconfirmed. These reports, however, have not been confirmed.

Bandit outrages are also increasing, and a half dozen villages within a score of miles of Mexico City are virtually deserted, the inhabitants having fled to the capital in fear of outrages by the self-styled revolutionists who have been attacking towns within the federal district itself.

Two Big Developments

The most unusual developments affecting the situation within the last twenty-four hours were two in number. The first was the proclamation by a junta at El Paso of a "provisional government" of Mexico, with Rene Capistran Garza, prominent Catholic and vice president of the Mexican National League for the Defense of Religious Liberty, as "provisional president."

The second was the arrest and ordered deportation of Bishop Pascual Diaz of Tabasco, secretary of the Catholic Episcopate in Mexico. Five other prelates were taken with him to the Episcopate building.

Clarence Dubois, correspondent for the Associated Press, who went to the Episcopate to get the prelates' comment on the development at El Paso, was taken into custody while William Folger, United Press correspondent, followed when he learned of Dubois' detention, also was held.

The correspondents succeeded in getting word to the American embassy but were held several hours despite their protests that they were American.

Prelates Are Listed

The prelates arrested with Bishop Diaz are Arch Bishop Ruiz Y Flores of Chichauacan, Bishop Jesus Echavarría of Saltillo, Bishop Miguel de la Mora of San Luis Potosí, Bishop Nicolas Corona of Papantla and Bishop Ignacio Valdespino Y. Diaz of Aguascalientes.

Bishop Diaz, who is a Mexican citizen, was led from the Episcopate building soon after his arrest and word was later received that he would be expelled from the country. He went to his home for some personal belongings. Government officials refuse to give any information as to his whereabouts, but it is thought he is enroute to Vera Cruz under military guard.

It is known that there have been numerous arrests of Catholics throughout the republic, and many of the seven arch bishops and twenty-three bishops in the country are expected to be in custody.

The five prelates taken with Bishop Diaz are held without specified charges.

Troop movements under direction of the war department continue. Most of the details are kept secret, but it

is known that strong reinforcements are being sent to the northern states. Every railroad train in the republic carried a heavy military guard. However, the burning of bridges and disruption of traffic by outlaws, some of whom call themselves revolutionists, continue.

Flashes Of Life

The Battle Starts

WASHINGTON.—If some forecasts are correct the mole will be so hobbled that he will have a hard time kicking the elephant next year. In the senate Senator Bruce of Maryland said that if a dry should be nominated by the Democrats for president the wetts would hold a convention of their own to select a candidate. Heflin of Alabama took exception to the prophecy.

Against Al Smith

NEW YORK.—If Al Smith is nominated, there will be an independent Democrat in the field, take it from Warren Shaw Fisher, head of the progressive political league. Fisher says he has received word from W. G. McAdoo that McAdoo within ten days will start on a visit to the south, Washington and New York. Fisher says a speaker's bureau will be opened in Washington and a national anti-Tammany campaign started. Papers favoring Smith, attribute to Alfred M. Leavitt, secretary of the league, the statement that Fisher is doing nothing but belly-whooping.

Queer Request

CHEROKEE, Okla.—Blind, C. E. Marble, 65, prefers death in the electric chair to life behind prison bars for murder. When he expressed his choice in court, physicians were ordered to examine him, but they found him sane and electrocution was ordered for March 15. "Thank you," he said. "To be blind and in prison at the same time would be unbearable."

CHICAGO.—There appears to be no use in fat folks exercising if they wish to reduce. Professor A. H. Steinhilber of the Y. M. C. A. college tried this theory on dogs and proved it. Congressmen Study Coolidge Speech On Nicaragua; Different Views Are Propounded After Bombshell Bursts

(By Associated Press)
WASHINGTON, Jan. 11 (AP)—President Coolidge's message to congress, in which he laid bare in unmistakable language evidence of Mexican "interference" in Nicaragua, and reaffirmed administration's policy as one designated to protect all interests of the United States in Central America, came with such an unexpected suddenness that many members were still perusing the document today before making known their views.

It was being given particular attention by members of the senate who contemplated taking part in the examination tomorrow of Secretary Huggins by the foreign relations committee on the Nicaraguan situation. The president made it plain that the government was acting not only to preserve American lives and property in the internal warfare in Nicaragua, where it has recognized the conservative regime of President Diaz as opposed to the liberal government set up by Juan B. Sacasa, with Mexican recognition, but to protect its interests of "this government itself," whether affected by internal strife or "outside interference."

Has Conclusive Evidence
He said he had the most "conclusive evidence" that arms and ammunition in "large quantities" had been shipped on several occasions to the "revolutionists," that boats carrying these munitions were fitted out in Mexican waters, that some of the boats had evidence of having belonged to the Mexican government, and it appeared the ships were fitted out "with the full knowledge of and in some cases with the encouragement of the Mexican officials." In one instance, he added, one of the gun runners was commanded by a Mexican naval reserve officer.

Message is Praised
Senator Hiram Bingham, Republican, Connecticut, said the message would clarify the situation in the public mind. Senator Moses, Republican, New Hampshire, said it was "an admirable statement" while Senator Smoot, Republican, Utah, declared it "ought to allay all apprehension of the American people."

Among the critics were Representative Garrett, Democrat, leader in the house, who said the message was unsatisfactory in that it did not make clear "just what is the danger to American life existing in Nicaragua now." Senator King, Democrat, Utah, said his information as to Nicaraguan conditions was "not in harmony with statements of the president."

Senator Willis, Republican, Ohio, while not commenting on the message, declared in a speech in Philadelphia that England, France and Italy had appealed to the United States to protect their nationals in Nicaragua, and if the latter did not agree to do this, "they will do it themselves," especially England, for that country will see Englishmen protected wherever they go.

Coolidge is Rapped
WASHINGTON, Jan. 11 (AP)—The statement that President Coolidge's Nicaragua-Mexican message to congress was a deliberate affront to Mexico was made in the house today by Representative Huddleston, Democrat, Alabama.

He reiterated his charge that America "deliberately and consciously" is drifting into war with Mexico, and declared the president had brought Mexico into his message yesterday for the deliberate purpose "to put her in a bad light."

Reed Charges Reheard
Mr. Coolidge sent the message to congress, the Alabamian said, to back up the charge "that Mexico is a Bolshevist government."

Huddleston added that as he listened to the reading of the message, he felt sorry for Mr. Coolidge. He believed in Russia, a Root, or some one else "could have sent a communication to congress that would have displayed more tact. The president had had poor advice, he said and "it indeed an unfortunate man."

Herring For Mexico
MEXICO CITY, Jan. 11 (AP)—Mexico should be given a chance to work out her own program without interference, in the opinion of Hubert C. Herring, leader of a group of forty Americans who have been studying conditions in Mexico.

Before leaving for New York last night Mr. Herring said: "The Mexican government has a program. It is idle to attempt any appraisal of the land, oil or church situation without first attempting to understand the entire program. I believe that Mexico should be given a chance to work out her program in her own way and without interference."

Mr. Herring is head of the social relations department of the congressional churches of the United States.
