WOMAN HELD IN TEXAS SHOOTING

Pro Forces Move To Stop Coast Rum Running

GIANT COMBINE SAID OPERATING OUT OF CANADA

CUSTOMS PATROL SET UP TO GUARD PORTS OF ENTRY ON COAST

(By The Associated Press)

SAN FRANCISCO, Nov. 30.—Prohibition forces moved against the organized liquor traffic of the Pacific coast from four directions yesterday. While a royal commission at Victoria, B. C., was learning in its investigation of rum smuggling that great quantities of liquor are being shipped by Canadian exporters with the full knowledge that it later will find its way into the United States, indictments were returned here against alleged leaders of what the San Francisco newspapers call a \$10,000,000 smuggling combine which has been operating all the way from Canada to Mexico.

Customs Patrol Set Up

In addition the federal government today set up a 24 hour customs patrol which will operate against liquor running at every port of entry in California. This force will supplement the guard by patrolling the shores. Names of a picturesque rum runner, who was wiped off the shipping register when the three masted schooner, Merdon G. Douglas, recently confiscated as a runner of contraband, was sold at auction here and will become a fishing craft.

With the indictments returned by the federal grand jury here were kept secret pending arrest of those named, they are assumed to accuse several men of wealth and influence on the Pacific coast of connection with the rum circle.

"King" Is Arrested

Previous to the meeting of the grand jury, federal officials had arrested Joe Parente, known as king of the San Francisco rum runners, J. W. Nard, millionaire British Columbia liquor exporter, certain members of the board of directors of the Consolidated Exporters, Inc., of British Columbia; officers of vessels known to be in the rum running business, and other men connected with the exporting as agents in this country.

At Los Angeles federal officials announced that evidence against several persons believed to be connected with rum running activities would be placed before a grand jury in a few days.

THEFT TRIAL FOR PAIR HELD UP

After driving 537 miles on Monday, a Kansas father and mother were present in the office of Judge Nurdyke Tuesday morning when the examining trial of their son, charged with burglary, was held. Owing to the absence of County Attorney McWhorter it was necessary to defer action later in the day when it is thought he will be present.

The young men charged with the act, were arrested two or three days ago. One of the boys is an orphan, though both of them are from Kansas. Several homes, including the Helbur home and the home of Judge Nurdyke, were entered, though most of the stolen property has been returned to owners.

The boys admit their guilt, but because of their youth drastic punishment is not likely.

Tailor Shop Here Is Damaged By Fire

Fire which originated in a gasoline cleaner in the Ideal tailor shop, 804 Main street brought the fire department into action during the noon hour today. Considerable damage was done, though firemen say it is next to miraculous that the loss was not greater.

The fire originated when someone in the front room struck a match. The door to the cleaning department was open and the blazing match followed the escaping gas to the vat.

Amarillo Police Probe Is Opened

AMARILLO, Texas, Nov. 30. (P)—Mayor Lee Bivins and a score of other witnesses were called before the Potter county grand jury today which, acting on instructions from District Judge Henry Bishop, is conducting an investigation of the Amarillo police department. Judge Bishop told the jurors to investigate complaints of indiscriminate arrests without proper authority and alleged mistreatment of prisoners. Charles J. 30 HELD AFTER RAID ON RANCH

Death List Now Stands At Eight With Others Of Band Near Death

(By The Associated Press)

BROWNSVILLE, Texas, Nov. 30.—More than thirty agrarians who Monday attempted to seize and occupy the Juan H. Fernandez estate plantation near Matamoros, Mexico have been rounded up and are in the custody of the military, according to advices to the headquarters of the estate here.

Death List Now Eight

The death list in the battle which was precipitated when Hacienda employees investigated the activities of the agrarians remained at eight early today. Five wounded are in a Matamoros hospital.

A railroad clerk, said to have been formerly employed in the Matamoros office of the National Lines of Mexico, was declared to be one of the leaders of the agrarians. The farming district surrounding Matamoros has been upset for weeks, according to information here, by the activities of small leaders who exorted ranch and farm employees and tenants to take the reins in their own hands, and parcel out such lands as they wanted.

Refused Recognition

This followed their failure to receive recognition from the governor of Tamaulipas on petitions asking that they be given land near Matamoros, although a "Agencia" and properties were not mentioned in these petitions. The Matamoros district has recently become one of the important cotton growing sections of Mexico, producing the past season about 20,000 bales of cotton.

A. B. ATER DIES OF PARALYSIS HERE

A. B. Ater, 64, died at his home, 1515 Sixth street, this morning at 8:30. Funeral will be held from the First Baptist church, Wednesday afternoon at 2:30 by Rev. W. A. Bowen, pastor. Mr. Ater and family had been residents of Lubbock for the past twelve years. Mr. Ater suffering a stroke of paralysis some four years ago, and two years ago he suffered the second stroke which made him almost an invalid, since which time he has been practically confined to his bed. Monday afternoon, while sitting in his chair, he suffered another stroke, from which he died this morning at 8:30.

Besides his wife, eight children survive. Six boys and two girls, as follows: Frank Ater, Big Spring; George Ater, Morton, Mrs. F. L. Shull, Big Spring; Mrs. E. T. Putnam, Amarillo; Henry, Jenkins, James and John all living in Lubbock. Two brothers, J. M. Ater, Breckenridge and Joe Ater, Gatesville, are expected here to attend the funeral.

Father Of Mrs. Geo. Boles Seriously Ill

Mrs. George Boles has received a message that her father, John T. Brown, of near Duncan, Ariz., has suffered a stroke of paralysis and is in a critical condition and, pending further word, she is prepared to go to him.

Mr. Brown is a pioneer of this section, having come to Crosby county in 1884 and organized the Saint Louis Cattle company. He built the first pasture fences in this country soon after coming here and one of these still standing in the Yellowhouse Canyon in the vicinity where an oil well is now being drilled. Mrs. Boles said, Mr. Brown is past eighty years of age now and is living on a ranch in Arizona.

Gas From Reservoir Fatal To Guager

BORGER, Texas, Nov. 30. (P)—Leaning over the edge of a large storage tank to gauge the oil with a short stick, W. A. Parker, 26, who had been in the employ of the Gulf Production company four days, died early this morning when he was overcome by the gas.

The dead man was found lying on top of the tank by his brother, half an hour after he had climbed to the top. Coroner Malone declared death was due from gas poisoning. Parker leaves a mother, four brothers and four sisters at Littlefield, Texas.

Depth Of Cushions Is Test Of Motor Cars Many 'Accessories' Shown In Gotham Show

NEW YORK, Nov. 30.—The depth of the cushions—not the purr of the engine—is the season's test of the elegance of motor cars.

The practical perfection of the mechanical side, automobile men said today, has caused the shifting of emphasis. Now the "dolled up" body is the thing.

Elegance Is Forecast

Just how elegant the very ultra car will be for next season, 100 cars worth \$1,000,000 were rolled into the ball room of the Commodore hotel this week and there left to gladden, amid soft music and elegant society, sporting, the following "accessories": Automatic cocktail mixers; ice chests; three-tier trunks, with 14 brass locks; hardwood bars, with gold and silver plated goblets; automatic cigarette lighters; boudoir chests, containing hair brushes, combs, etc.; Cararra marble-topped leather seats; polished aluminum hoods; inlaid imported wooden door railings; monogrammed foot mufflers, and period upholstery.

The well-dressed car, the exhibits in the twentieth annual salon show, will cost from \$10,000 to \$20,000.

Antique Craze Noted

An outstanding feature of the season is the application of the antique craze to motor cars. One maker, a builder of very inexpensive cars, has "periodized" twelve bodies of his more expensive brand and wealthy buyers may now have a car to match their colonial country house or their favorite estate.

One of the curious cars of the period group is a perfect reproduction in cream yellow and black of a coaching brougham. An eighteenth century body on a 1927 chassis boasts everything from archaic outside hinges and a square window lamp near the "coachman" to little leather tassels on the inside doors.

This is, however, frankly, a selling stunt and according to the dealer he does not "hardly expect to sell it unless perhaps in Los Angeles."

Internally there are few innovations this season, cylinders still running from six to twelve, with eight predominating.

HUGE CROWD TO MEET HIM HERE

Avalanche-Journal Party For Saint Nick Will Envelope Entire Community

Tonight's the night! Hundreds of little children, eyes dancing and cheeks aglow, are anxiously awaiting 7 o'clock when Santa Claus will arrive at the Avalanche-Journal office, and will greet them before starting on his trip over the retail sections of the city showing the children and their parents the toys and other gift articles which he has prepared for the 1926 season. Practically all of the retail establishments of the city will remain open until 9 o'clock tonight in cooperation with Santa Claus.

Parrish To Speak

Mayor Pink L. Parrish has declared a city-wide welcome should greet Santa as he arrives and his proclamation calls for everyone to be on hand at the Avalanche-Journal building and for all of the retail stores to remain open during the early part of the evening. Mayor Parrish, himself, will introduce Santa to the kiddies.

A permit from Chief of Police T. E. May gives the Avalanche-Journal the right to rope off the block on Avenue I between Broadway and Thirteenth street and a big bonfire will blaze a warmth for Santa after his long and cold trip from the polar regions.

Message Is Received

A radiogram received from Santa this afternoon stated that he was making the trip all the way by airplane, due to the fact that Dunder and Blitzen, the far-famed leaders of his reindeer team had been turned out in a far-off pasture and will not be back to Old Santa's corral before time to make his regular visit to all the little children on the night before Christmas. Santa, however, in his message, reassured the Avalanche-Journal that he would be here and that his plane was swift enough to make the trip in plenty of time.

The Avalanche-Journal's mail has been loaded with letters for Santa Claus from the children of Lubbock and all of them received thus far will be given to him upon his arrival. Those which the children write after Santa's departure tonight will be forwarded to him at the North Pole.

IRRIGATION PLANS ARE DISCUSSED

AMARILLO, Texas, Nov. 30. (P)—Plans to harness the flood waters of the Canadian river and turn impounded waters onto farms of New Mexico and Texas and at the same time control the stream to prevent flood damage in Oklahoma, are materializing rapidly, irrigation commissioners from the three states in question reported today.

The commissioners met last night and went into session here again today. One of the chief problems facing the commissioners is the question of agreement between New Mexico and Texas on division of costs and distribution of the impounded waters.

E. E. Blake of Oklahoma City is chairman of the meeting. A. S. Stinnett and F. P. Works of Amarillo are representing Texas, while R. J. Freeland of Tucuman and E. R. Wright of Santa Fe are looking after New Mexico's interests.

Women In Quarantine Fire House And Flee

AUSTIN, Nov. 30. (P)—Two young women, held in quarantine in the Austin city hospital here in connection with a police campaign being conducted by the police department, set fire to the building last night and escaped during the confusion which followed discovery of the blaze.

Another woman who participated in the attempt to fire the hospital, was captured by hospital attendants after a chase through the hospital and a brief struggle. The fire was extinguished with only slight damage to the building.

QUEEN LANDS

CHERBOURG, France, Nov. 30. (P)—After being delayed several hours by rough weather, Queen Marie of Rumania landed from the steamship Berengaria this evening and entrained for Paris, where she is due at 10:30 o'clock tonight.

SECOND CHARGE IN TWO MONTHS TIME IS FILED

MAN SHOT BECAUSE HE WOULD NOT RETURN CLOTHES, SAID

(By The Associated Press)

DALLAS, Texas, Nov. 30.—For the second time in two months, Mrs. Louise Hassan, 25, is in jail here Tuesday charged with shooting, while two men said by police to be victims of her bullets, lie fighting for life in Dallas hospitals.

Mrs. Hassan was charged with assault to murder following the shooting last night of James T. Broadnax, who was shot three times as he left a parked automobile and started to walk across a street. A woman fired the shots from an automobile and then stuck the pistol in the side of her chauffeur and ordered him to drive away, police stated.

Says Shot Broadnax

The district attorney announced that Mrs. Hassan stated she had shot Broadnax because he would not return some of her clothes she charged he was keeping.

Two months ago Ahmed Hassan, a Syrian lace and silk dealer, was shot in a hotel, a few days after he had married Mrs. Hassan. He is still in a hospital, and Mrs. Hassan was out on bond on a charge in connection with this shooting.

Don't Want To Prosecute

As he lay in the hospital with emergency doctors working over him, Broadnax stated that Mrs. Hassan shot him as he started to walk across the street. At the city hospital he said he did not want to prosecute the woman.

A. D. Robertson, chauffeur for a taxi cab company, who had been driving the coupe about, told police that as soon as the shots had been fired, the woman jumped back into the automobile and forced him at the point of the gun to drive away.

PROBE ORDERED IN COTTON RATES

WASHINGTON, Nov. 30. (P)—A general investigation into freight rates on cotton moving to practically all destinations was ordered today by the interstate commerce commission.

A conference to complete arrangements for it was called to be held in New Orleans, December 17.

A large number of complaints by cooperative producers of cotton and by cotton shippers generally as to rates are now pending, the commission's announcement said, and in addition a congressional joint resolution has required a general survey of freight rates upon agricultural enterprises.

The large area of the country involved and interested in cotton makes it desirable, the commission said, for a general investigation to be started.

At the New Orleans conference commission proposed to summon representatives not only of the complainants but also of the railroad and state railroad commissions. The scope of the investigation and the program for it will be outlined at that time.

Leg Of Mississippi Governor Amputated

MEMPHIS, Tenn., Nov. 30. (P)—The left leg of Governor Henry L. Whitfield of Mississippi, was amputated above the knee here today. The governor, who is 58 years old, was said to have stood the operation well. He suffered from a bone disease that followed an injury while playing tennis several years ago.

STUBBORNNESS IN MARRIAGE

A judge who had granted 275 divorces in one week remarked, "I wish there was another word for stubbornness."

"Men and women who can't get along seem to think there is something unusual and rather fine in their make-up when the word 'incompatibility' is tacked on to them. I believe that incompatibility is just about stubbornness in nine cases out of eleven, and caused stubbornness at that."

SUCCESSOR TO TRIS SPEAKER NOT YET NAMED

TASK NOT EASY ONE IS VERDICT REACHED BY CLEVELAND FANS

(By the Associated Press)
CLEVELAND, Ohio, Nov. 30.—Now that Tris Speaker has resigned as manager of the Cleveland Indians and is through with baseball for good, Cleveland baseball fans are casting about for a possible successor.

It is agreed that the task of filling the place of one of the most colorful players and managers the game has known will not be easy.

Makes Big Change
Speaker converted Cleveland from a dead baseball town in 1915 to a hot bed of fandom in 1916 and has been instrumental in keeping it on the baseball map since.

He led the Indians to Cleveland's only pennant and world championship in 1920. Speaker, the dangerous hitter, sensational outfielder and fighting manager, has been Cleveland's greatest drawing card since Napoleon Lajoie sang his swan song.

McAllister Considered
Jack McAllister, who has been with the Indians for twelve years as scout, coach and assistant manager, is regarded as a likely successor to Speaker. Eddie Collins, who recently was released as pilot of the White Sox has also been mentioned. But club officials have refused to comment on either of these prospects.

Speaker's post will not be filled for a month or six weeks, E. S. Barnard, president of the club, says.

GOULD WINS IN MAINE VOTING

Election Assures Control By Republicans Of Next Congress Session

PORTLAND, Maine, Nov. 30.—Election of Arthur H. Gould, Republican, as senator from Maine assures Republican control of the next senate.

The line up will be Republicans 48; Democrats 47; Farmer labor 1.

Maine voters apparently were not greatly worried over the matter as only two-thirds of those who cast their ballots in the state election in September turned out to vote yesterday.

Margin Is Heavy
Gould's margin of victory over Fulton J. Redman, Democrat was about 48,000. With 24 precincts missing representing small and remote towns the vote was:

Gould 75,523; Redman 31,540.

The special election was occasioned by the death of Senator Bert M. Fernald, who was re-elected in 1924. Redman, the Democratic nominee in that year also, was defeated by a majority of 51,555. Gould term will expire in 1931.

Irregularities Charged
As soon as the result of the election was known Redman reverted to the issue which had caused great excitement in the campaign by asserting that he would press at Washington charges that Gould had spent an amount largely in excess of the legal limit obtaining his nomination. A few days before the election the Maine secretary of state refused to act on such charges filed by a leading member of the Ku Klux Klan and supported by Governor O. Brewster, Republican. After a hearing Secretary Ball declared that the evidence was insufficient.

EDDIE COLLINS LONE SURVIVOR OF OLD GREATS

PASSING OF OTHERS NOW LEAVES FAMOUS STAR ALONE IN TENT

With the departure of Ty Cobb from the major league ranks, Eddie Collins recently deposed manager, and second baseman of the Chicago White Sox is the only 20-year pastime in the big show. While his status is as yet undetermined, he is certain to be retained by some American League club.

Eddie just gets in that class, having come to the Athletics direct from Columbia University in 1906. For three seasons Collins starred in baseball and football at Columbia.

Next to Collins in point of service comes Walter Johnson, the dean of hurlers. Johnson made his big league debut with Washington late in the 1907 season. He's spent his entire major league career with the Senators. Walter is one shy of the 20-year club.

Tris Speaker, pilot of the Cleveland Indians and one of the greatest outfielders in all baseball history, has been in high society continuously since 1908. This really got his first trial in 1907 with the Boston Red Sox but was shunted back to the minors for another year's experience.

Collins and Johnson—now that the illustrious Cobb has quit the game—are all that remain of the many players that made up the 15 major league clubs of 18 years ago; in fact, there is but a mere handful left of those of 15 years back.

Of the 1911 gang Max Carey, Roger Peckinpaugh, Hank Severid, Zach Wheat, Grover Alexander, Stuffy McInnis and Jack Quinn are the only ones still cowering around the major league fields.

Quinn, McInnis and Wheat came up in 1909, though the first named has been in and out of the big show several times since. Wheat has worn a Brooklyn uniform down through the years. Quinn has played on several clubs. So has McInnis. Peckinpaugh first broke into a major league box score with Cleveland in 1910. He's been in fact company continuously since 1912. Brock has played with New York and Washington besides the Indians.

Carey, Severid and Alexander made the grade in 1911. Carey, up until the last few months of the 1926 chase when he went to Brooklyn, played as a major league pitcher with the Pittsburgh Pirates.

Severid has been with Cincinnati in the National League and St. Louis, Washington and New York in the American. (Hank hasn't seen 1926 play as a major yet.)

Each survivor of the old 1911 guard has taken part in at least one world series with Eddie Collins topping them all with six.

Hendrix And Taylor Get League Trophy
MEMPHIS, Tenn., Nov. 30. (AP)—Harvey Hendrix, New Orleans out-fighter and Tommy Taylor, Memphis featherweight, were jointly awarded the Southern Association \$500 prize for the most valuable player today. Directors decided to divide the prize as the two players each received the same number of votes.

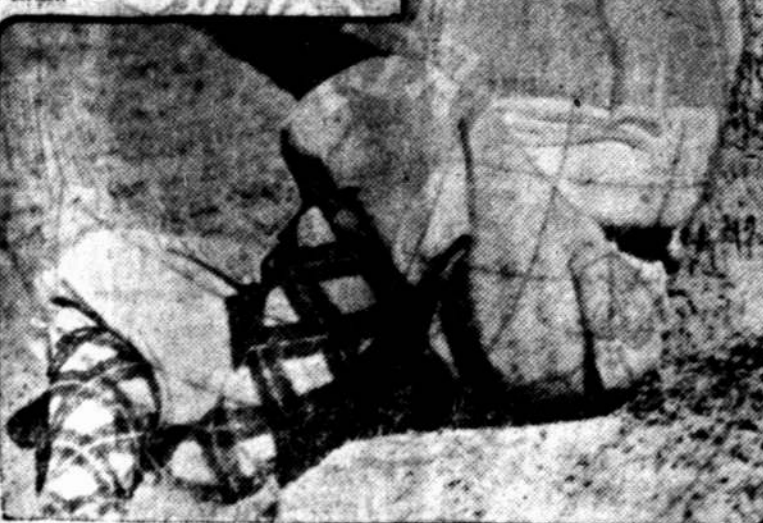
The directors voted to open the season April 12 next year and to meet in New Orleans February 14, for adoption of the playing schedule of 164 games.

BLAMING THE DEAD

Woodrow Wilson was the author of
the Land and Oil Statute of Mexico.

have already nailed the statement as
a lie.

This business of blaming the dead
is a serious matter—especially in view
of the reverence in which nearly all
Americans hold Mr. Wilson—and more
than likely it will find faster
flames of hatred between our country
and Mexico.

In thinking over the matter Ameri-
cans—sane minded Americans—must
take into consideration the fact that
Mexico is unstable and independable
and that government there, at its best
today, appears from a distance to be
little more than a farce.

Yet even with these facts in mind
Americans will not regard lightly this
effort to place the blame on the pre-
sent squabble upon the honored dead.

KIPLING, MAN OF SORROW

Rudyard Kipling is pictured here—
Kipling recently gave to the pub-
lic another book of stories and poems.
"Deeds and Words" is the title of the

gifted pen?

The answer perhaps is found in the
history of the fighting done by the
Irish Guards in the World War. In
the appendix, there is a list of the
Guards who were killed in action.
And there is this significant line:
"Second Lieutenant J. Kipling, 27-9-
1915."

That, perhaps is the whole pathetic
story. The light went out for Rudyard
Kipling when his handsome young
son was slain.

John Kipling died in the battle of
Loos. The Irish Guards had gone to
the front in the first months of the
war. The battle of Loos came in
September 1915.

Young Kipling at first was reported
wounded and missing. Like many
other fathers, Rudyard Kipling hoped
against hope that some day the day
when the war office corrected the
first report to read "killed in action."

Life has been ashes in the mouth
for the famous father ever since.
Like some other Englishmen, perhaps
he holds America responsible.

Had America entered the war at
the beginning, or even early in 1915,
the lives of hundreds of thousands
might have been saved. That's the
way the thoughts of some men run.
And you can't argue with men who
think like that. They have been too
deeply hurt.

They have lost their only sons.

THE 'SPOKESMAN' SPEAKS

By NEA Service

WASHINGTON, Nov. 30.—Twice a
week the office of President Coolidge
is virtually filled by two or three
score newspapermen eager to tell the
American people what the president
thinks and intends to do about mat-
ters concerning the nation. These
conferences occur at noon Tuesday
and at 4 o'clock Friday.

In a large, circular room, looking
out through great bay windows to
the White House grounds at the rear
sits Mr. Coolidge, dressed in a se-
verely cut black sack suit. He wears
a stiff collar with points and a dull
gray cravat. The reporters assemble
in a semi-circle about his massive old
walnut desk.

There is one book on the desk—
"Foundations of the Republic," a col-
lection of "speeches and addresses" by
Mr. Coolidge himself. There are news-
papers laid out neatly at one side.
Various types of White House sta-
tionery are pigeonholed before the
executive and a dozen newly sharpened
pencils lay at his right. A typed
appointment list is ever under his eye.

Behind the president, at confer-
ence time, is an unobtrusive secret
service man and two others are in
the rear of the room, at the backs of
the newspapermen.

The room's only picture is an etch-
ing of Lincoln, high on the wall at
the president's left. It portrays a
much homelier Abe than most por-
traits.

The correspondence all are inside
and at attention when the president
slowly arises, puts on his tortoise shell
glasses and takes up a sheaf of type-
written questions which the report-
ers have submitted in advance. The
newspapermen poised with pencils and
note-paper ready for action. Some
of the press association men stay at
the rear to dial for telephones if Mr.
Coolidge makes news too hot to wait
until the end of the conference.

The president having cleared his
throat, the White House spokesman be-
gins to speak. He does all the talk-
ing, in fact, for the president himself
must not be quoted. It is interesting
to note that the spokesman, who, as
has been said, looks remarkably like
the president, has lost some of the
two Vermont twangs which he
first came to Washington, although he
still says "dunno" and his accents are
not to be mistaken for those of a
Scandinavian.

The spokesman takes up the ques-
tions one by one. A majority of them
he refers to the cabinet heads. The
president knows these situations in a
general way, but would prefer to have
a subordinate discuss the details.

He will not elaborate on his Kan-
sas City speech—it is his general
policy to make a speech plain enough
so all can understand and let it go
at that. He would like to clear up
the "ambiguity—not to say misunder-
standing" that arose over the presi-
dents tax rebate suggestion. What
everyone concerned meant, the spoke-
man said, was a tax reduction. The
matter of the Mexican notes is refer-
red to the State Department.

Finally the spokesman says he
recuses that is about all and the
president sits down, resuming his long
chair, which reposes on a dinky little
plain white holder.

The new correspondent then is in-
troduced to the president. The presi-
dent greets him, not exactly like a
brother Elk but cordially and with a
smile. The president talks with this
correspondent several minutes, dis-
cussing the conference, newspaper
work and another subject or two of
mutual interest. As the correspon-
dent goes out he is told to feel at home
and that everyone at the White House
will be glad to do anything for him
that is possible.

Who of us can not remember the
delight we used to feel when, as chil-
dren, we found each year the dainty
spurred blossoms of the columbine
growing on the ledge or rocky hill-
side where we sought it?

What a wonderful thing it was to
see again its beauty, and perhaps to

taste the nectar in its ripened petals,
where at the tip of its curved spur,
Nature has stored in tiny bulbs the
sweets that attract its wild visitors.

Only the humming bird and the
largest bees can reach the honey-
bulbs in the usual way, for a long
tongue or bill is required, so many of
the smaller insects cut into the spurs,
and steal the coveted nectar.

In the eastern part of the United
States we have only the red colum-
bine, but from Minnesota westward,
especially on the mountains, an ex-
quisite blue-flowered species is found.
This is the state flower of Colorado.
The columbine has been proposed as
the national flower but the choice of
a plant for this honor is so difficult
that amicable agreement is doubt-
ful.

Those who love our graceful wild
flower will scarcely wish its selection
since it would be so much sought after
that its existence would be endan-
gered. Such is the fate that threatens
the blue columbine in Colorado, where
columbine excursions were conducted.
The fields of blossoming plants were
invaded by their hordes, the excursions
turned to their homes laden with wil-
ling armfuls of their innocent victims
resulting in its becoming scarce in the
very sections where the most people
had an opportunity to visit its haunts.

Helpful Health Hints

PROPERLY FITTING SHOES FIRST
AID TO SORE FEET

Of all the uncomfortable people on
earth none are so disturbed as those
with painful aching feet.

Unfortunately many of them, in-
stead of submitting to careful study
as to just why the feet ache, trifle
about with changes in shoes, test out
all sorts of fancy foot supports,
plasters, and what not, and come to
serious attention only when the con-
dition becomes unbearable.

A properly fitting shoe is the first
essential to comfort of the foot. Some-
times the arch-support carefully
chosen accentuates the difficulty by
throwing a greater burden of weight
on the very part of the foot that is
producing the suffering.

Dancing

Another frequently overlooked cause
of sore feet and of pain and tender-
ness of the ball of the foot in these
modern times is the craze for too
vigorous dancing. Stress that is too
great should not be thrown upon mus-
cles and ligaments unused to the ef-
fort.

The professional dancer begins
slowly and develops the tissues to a
point at which they may carry their
burdens successfully. Various exer-
cises of the foot muscles will serve to
strengthen the arch.

A shoe that is too short may serve
to develop hammer toes that turn
downward and are exceedingly pain-
ful. A shoe with a heel that is too
high may throw a burden on the bones
and muscles of the back and of the
thighs.

Too Narrow

A shoe that is too narrow causes
rubbing and irritation with the pro-
duction of corns and bunions.

The human foot carries a heavy
and moving weight and should not
be too small for that weight. Along
with other changing feminine modes
has come a fortunate realization of
the fact that an active woman needs
a foot large enough to carry her
around on her multitudinous interests.

Judith broke in. "Are you alluding to Eric Waters?"

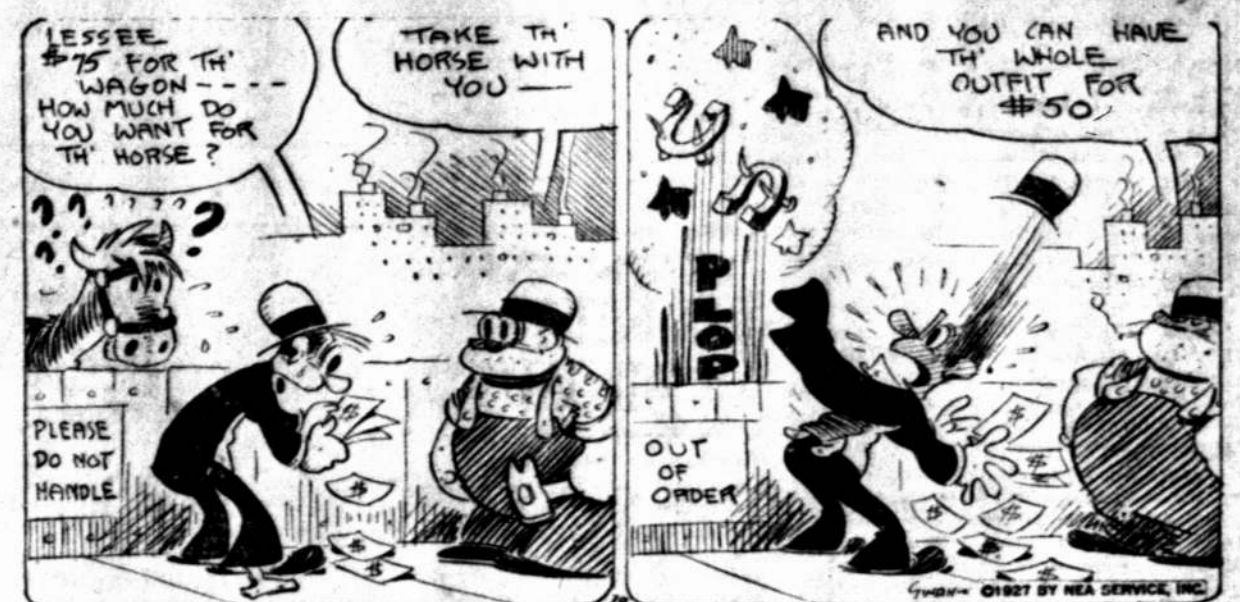
Dr. Dorn looked at her. "I am. If Eric Waters were king, he would not have let a blackguard like Shea gain ascendancy over him."

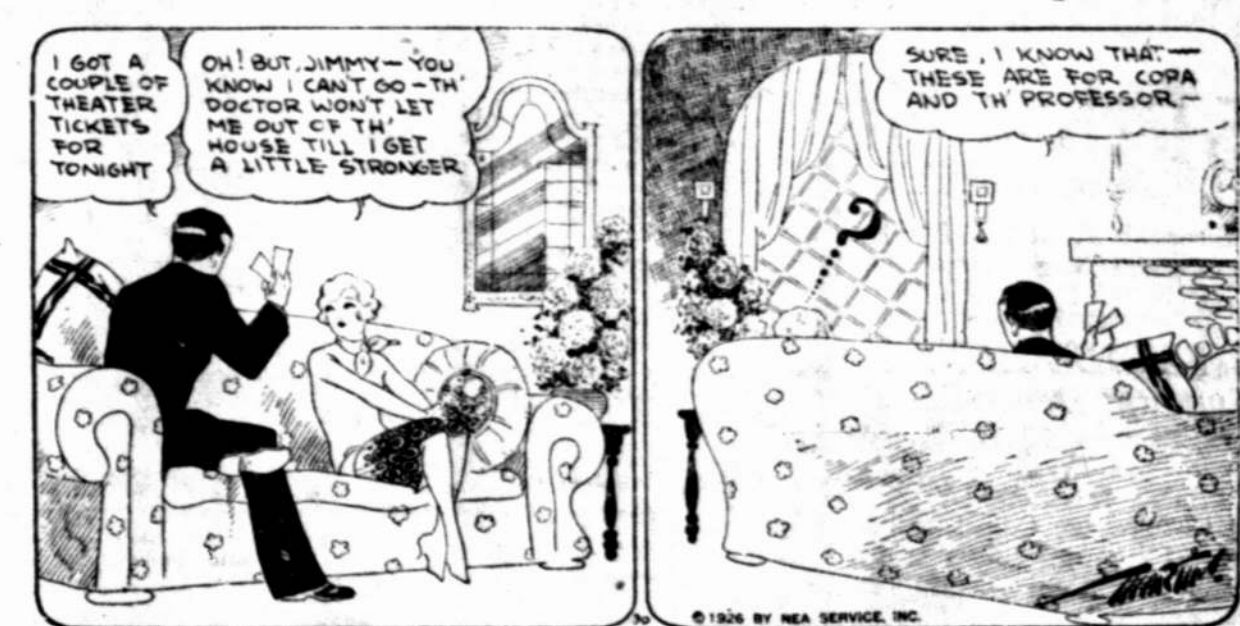

The market was almost at a standstill during the morning and although the undertone was easy prices remained within the earlier range. The near months hung near the low points all morning and around noon December traded at 12.39, January at 12.40 and March at 12.52.

The market became easy during the afternoon under active hedge selling and liquidation of near positions. December traded down to 12.32, January to 12.34 and March to 12.46. At the beginning of the last hour the tendency was still downward.

NEW YORK TRADING

NEW YORK, Nov. 30. (P)—Renewal of southern hedge selling and some local selling featured the cotton market early today, the latter promoted by reiterated reports of frost spot offerings in the south and relatively easy Liverpool cables.

The opening was 1 to 4 points lower in consequence, but there was a good deal of covering and trade buying on the decline and after selling off to 12.32 for January and 12.30 for May, the market held fairly steady at the end of the first hour.

Additional December notices amounting to about 5,000 bales were reported, but December held a premium of some 15 to 18 points over January. While there was a moderate volume of business, much of it was in the shape of switching between months, and orders were well divided later in the morning. As a result, fluctuations were narrow, with the market ruling around 12.34 for January and 12.79 for May at mid-day, or about 2 to 4 points net lower.

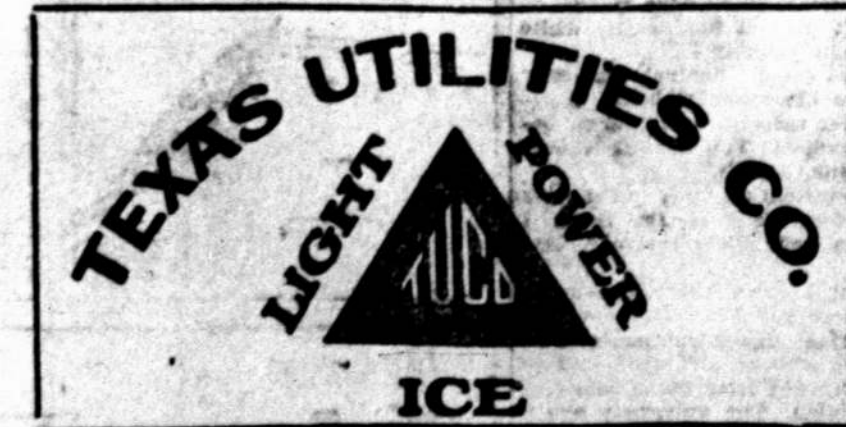
