PRESIDENT GETS PRIZE

For Services in Bringing About Peace

THE PRIZE IS \$40,000

He Will Devote Amount to Promoting Industrial Peace in America

WASHINGTON, D. C., Dec. 10.—President Roosevelt today received the Nobel prize for his services in promoting peace between Russia and Japan. The prize is \$40,000 cash and is one of the world's greatest honors.

Roosevelt will give the money to the people of the United States to be devoted to the cause of industrial peace. He believes the money cannot be better used than in the labor of bringing about more satisfactory relations between the employer and employed.

It is Roosevelt's plan to put the money in the hands of Chief Justice Fuller, Secretary of Agriculture Wilson and Secretary of Commerce and Labor Strauss, whom he intends to appoint as trustees. The latter will invest in securities and devote the interest to the promotion of industrial peace.

ASHINGTON, D. C., Dec. 10.—The Nobel peace prize is awarded to President Roosevelt in recognition of his services during the Russo-Japanese war. The candidates for this distinction must be proposed by legislative bodies, peace organizations or universities. It is understood that the President's sponsors were Professor H. P. Judson, acting president of the Chicago University; Professor Baldwin of Yale; Professor Harberger of the University of Munich and the faculty of the Georgetown University, Washington.

The peace prize went last year to Baroness von Suttner of Vienna and in previous years to W. H. Cremer, M. P., England; Professor D. Martenes of Russia and Henri Dunant, founder of the Red Cross Society.

The Nobel peace prize is a part of the bequest left by Dr. Alfred Nobel, a Swedish scientist, who died in 1896. By his will a large portion of his fortune is devoted to five annual prizes, which are valued at about \$40,000. They are awarded for the most important discoveries in physics, chemistry, physiology or medicine, for the most distinguished work of an idealistic tendency and for the best effort toward the fraternity of nations and the promotion of peace. The last named is awarded by the Norwegian parliament. The others are awarded by institutions at Stockholm.

The President will select two men to represent labor and capital. It will be their duty to promote industrial peace in whatever way, by arbitration or otherwise, they may be able to devise. To do all possible to bring harmony between the warring interests of the industrial world. John Mitchell, President of the coal miners, will be one of the peace promoters, the other to be some man in the capitalistic world who has made himself conspicuous by his fair dealing.

The two will serve for one year and then select two more. These men will each be presented with a bronze medal. The committee of four will choose two other men. The first two appointed will resign at the end of the third year. After that two new members will be appointed each year and two resign, making a committee of six.

COTTON MILL PLANNED

Promoter Trying to Create Interest at Abilene

ABILENE, Texas, Dec. 10.—While the name of the promoter is not given out, a proposition has been made to the citizens of Abilene to erect a cotton mill here that will employ 400 people. There is to be 285 automatic looms and 11,000 spindles. The contracts call for the people of Abilene to take \$100,000 worth of stock and the promoter agrees to take \$300,000.

TELLS OF JEWISH TERROR IN RUSSIA

Former Member Russian Parliament Here

NEW YORK, Dec. 10.—Dr. Schmarou Lewin, member of the dissolved lower house of parliament of Russia, addressed several thousand Jews at Durland's riding academy last night on the Jewish situation in Russia. He declared that his mission in this country was to arouse public sentiment for the freedom of members of his race in Russia. Jacob H. Schiff presided at the meeting.

Dr. Lewin said that the Jews in Russia were living in constant dread of being killed and that there were many more who were starving. He declared that if a Jew made money in Russia he was sent to prison.

At the conclusion of the meeting many pushed forward to the platform to congratulate the speaker. A part of the platform on which Dr. Lewin stood was a number of feet, a distance of several feet. A number sustained slight bruises and scratches.

HAS MADE STUDY OF CANCER CURES

Enamel Ware May Cause the Disease

NEW YORK, Dec. 10.—Professor W. H. Diefenbach has made a study of over 100 cases of cancer. He says the X-ray frequently produced cancer. He suggests that the remarkable increase in cancer of the stomach may be due to the abandoned use of copper or iron cooking vessels, and the substitution of modern enamel ware on the theory that minute particles of this gritty enamel are frequently passed thru the alimentary duct, causing irritation.

Further announcements of the remarkable curative effect of cancer of triptin, the new extract of the pancreas juices, are made in the current issue of the Medical Record by Dr. W. G. Norton, professor on the diseases of the mind and nervous system, at the postgraduate medical school. He says:

"The cancerous tumor itself exhibits very frequently a definite reaction to the triptin treatment. In some instances the tumor is accompanied by great amelioration of the disease. Two cases of quite extensive face cancers are noted to date. In many cases the progress of the disease has come to a standstill."

CHURCH CRISIS ON IN FRANCE

Deadlock Between Catholics and the State Serious

PARIS, Dec. 10.—France seems to face an alarming religious crisis. Reports of the pope's eleven-hour rejection of the Catholic worship proclamation that Catholic worship could be continued under the common law, turns out to be only too true, and the deadlock is now apparently complete.

According to the holy father's orders, declarations under the law of 1881 are prohibited, but the parish priests must remain in their churches until driven out by violence.

The official confirmation of this communication has created a sensation, both in government and Catholic circles. Cardinal Lecot, archbishop of Bordeaux, Archbishop Germain and others who have already had advised compliance with the law, have hastily instructed the parish priests of their diocese that their former advice is null and void, and Sunday in all the churches of Paris, bishops and priests, after mass, read the letter from Cardinal Richard, archbishop of Paris, containing the declaration of the holy see to continue in the churches but abstain from any declaration, and Cardinal Richard's only instructions, in the absence of the pope, have been to permit for the present the employment of ceremonial draperies at marriages.

The church wardens whose legal instance expires next Tuesday, were thanked by the pupils of the various churches.

Prayers were offered asking the protection of God during the coming period of confusion.

The government regards the action of the pope as little less than a summons of the French Catholics to open their eyes to the real situation in the world, and possibly entailing the most deplorable consequences.

Treasury Clemenceau and M. Briand, minister of public worship, were in conference all day Sunday. There is no sign of the government faltering, but it is expected that it will be forced to resort to extreme measures.

M. Briand said Sunday that the decision of the pope was entirely unexpected.

STEAMER ASHORE AT LONG BEACH

Carries Crew of Twenty-eight Men

BACK TO THE FARM

Medill Patterson Would Get Close to Nature

CHICAGO, Dec. 10.—Joseph Medill Patterson, who resigned his position as commissioner of public works of Chicago on his conversion to socialism, has left Chicago to take a course in agriculture at the university of Wisconsin. He will be accompanied by his wife and two children, and will spend about three months in Madison. While in the university he will take what is known as the "short-horn" course. This schedule of study is designed to fit a student to engage in practical farming work upon its conclusion. It may be followed by specialized work.

Mr. Patterson expects to apply his agricultural knowledge to the management of a large estate which he has purchased last spring near Lake Forest. He has severed his connection with the socialist paper, of which he was editor during the recent campaign.

The paper was started by Mr. Patterson and is known as the Chicago Daily Socialist. It was not anticipated, however, that it would remain as its editorial head longer than was necessary to outline its scope and put it in good working order.

WORMS KILL MANY

BOSTON FLAG WILL NOT BE RETURNED

Mr. Behrman announced that he had conferred with Mayor Fitzgerald of Boston about the flag and the Boston council will probably drop negotiations for the return of this flag.

ORPHAN'S HOME BURNED

All Were Saved Thru Efforts of House Mother

CHICAGO, Dec. 10.—Fire which destroyed the Wadsworth college of the Methodist orphanage and Epworth children's home in Lake Bluff early yesterday, imperiled the lives of forty-five inmates, and threw all of them into a panic.

All those sleeping in the burning building escaped. Miss Mary Springer, house mother, and Misses Sinners and Oehlberg, deaconesses, guided the frightened children to safety. Thru the smoke-filled rooms they groped, feeling in each bed and under each blanket empty and then they turned their efforts to saving the building. The blaze supposed to have been started by a defective fuse. The loss is \$8,000.

HUGH McLEAN HURT IN BICYCLE RACE

Racers Have Covered One Hundred and Seventy Miles

MADISON SQUARE GARDEN, New York, Dec. 10.—The score at the end of the eighth hour of the six-day bicycle race was 170 miles even, with Walthour leading. The first serious accident occurred at 3:30 a. m. today and resulted in the serious injury of Hugh McLean of Boston, the partner of Bobby Walthour. McLean was not able to ride in the race again. McLean was hurt in a spill which occurred on the turn at Fourth Avenue and Twenty-seventh street on the side of the high banked track just about the spot where little Johnny Nelson was killed about four years ago.

McLean was responsible for the mix up as he was the first to go down. Clark of the Australian, Leon Georgetoff of France, MacDonald of the New York team and Ruppertich of Newark, N. J., all fell over the Boston lad, who, when picked up, was found to be the only one seriously hurt. Dr. Cramer attended the injured rider, who was rendered almost insensible with a gash about three inches long on the right side of his head. McLean may also have sustained the fracture of a collar bone.

DIAMONDS ARE VERY SCARCE

Many of the Importers Have Returned from Europe

NEW YORK, Dec. 10.—Returning steamships have brought back in the last week many diamond importers who went to Europe to get supplies for the holiday season and they agree that the gems are scarce and higher in price than ever before in their experience.

The present holiday trade in New York is said to have called for the greatest quantity and value of fine diamonds ever sold in any country in a single season. With December's figures still to be added, the imports on precious stones at New York this year exceed in value by \$3,000,000 the total for all of last year, which was the record up to that time. The aggregate thus far in 1906 is \$40,500,000 and December promises to make a large addition to the figures.

Some authorities estimated that New York bought 60 per cent of the world's supply of stones.

EXPLOSION KILLS SEVEN

Man Started to Open Box of Dynamite With Hammer

CHARLOTTE, N. C., Dec. 10.—One white man, five negroes and an Indian were literally blown into fragments by the explosion in a tunnel on the right of way of the new South and Western railway Friday night. The white man had been ordered to open a box of dynamite for blasting purposes and started to comply. One blow from a hammer exploded the contents, and the man, who was blown thru the tunnel, has since died. Six others were dismembered and several were seriously injured.

A mule and car were blown thru the portal of the tunnel and down the mountain side. The car was wrecked, but the mule escaped unscathed and, of his own volition, galloped off to the stable.

Not a single person in the tunnel escaped injury.

The construction force is tunneling thru a mountain in a remote corner of the state, and owing to its inaccessibility and inability to secure telephone connections, the names of the dead and injured cannot be learned. The Indian was a Cherokee from the reservation in White Mountain county.

ATTACKED BY THUG

Mrs. Seng Was Robbed Saturday in San Antonio

SAN ANTONIO, Texas, Dec. 10.—Saturday night while going home, Mrs. William Seng of 605 Avenue B, was set on by a negro thug and badly beaten and robbed. She fainted after being struck a terrific blow in the chest and the thug made off with her purse, containing \$15 and other valuables. Mrs. Seng was coming home from the city, where she had been shopping. She was accompanied by her five-year-old son. When in about twenty steps of her front gate on a brilliantly lighted residence street the assault occurred. No arrests have been made.

MANY ATTEND THE BICYCLE RACES

Sixteen Teams Contesting in New York

NEW YORK, Dec. 10.—The many thousands of persons who went to Madison Square Garden last night to see the start of the six days' bicycle race remained for hours. It was nearly 4 a. m. before the crowds in the huge hall began to thin out. Up to that time there had been lots of shouting and excitement. There were a number of falls, but none resulted seriously.

At 4 a. m. the riders had covered ninety-four miles and down in the average of twenty-three and one-half miles an hour, a very fast pace. Leon Georgetoff of the French team was leading the riders at the time by a few lengths, but all were within striking distance and each man was watching his competitors wearily, ready to spurt should any one try to get away. Vanoni, Root and Steel made matters interesting during the night by occasional sprints which served to keep up the enthusiasm of the crowd.

Sixteen teams are contesting in the race and most of them are likely to remain until the end, judging from the fine condition and form displayed in the early hour of the race.

10 LIVES LOST

PICOU, Nova Scotia, Dec. 10.—Because the officials of the government railway in Prince Edward Island demanded \$60 before they would transport a lifeboat, the relief of the crew of the Russian bark Sovinto, which went ashore early in November, ten of the Russian sailors lost their lives, according to testimony brought out today at the investigation by a committee of the Canadian parliament. The officials of the road claimed that they would violate the rules if they transported the boat without payment of the regular rates and refused to allow it to be loaded on cars until they received the regular freight charges.

RIVER FLOWS INTO THE SALTON SINK

Southern Pacific Must Again Move Track

YUMA, Ariz., Dec. 10.—Once more the Colorado river is flowing into the Salton Sea and the Imperial and Coachella valleys are once more menaced by rising waters. The main line of the Southern Pacific Railway must again be moved to higher ground, unless the water can be brought under control. A thousand people in Salton basin must lose their homes, including a quarter of a million acres of farming land.

The government La Guna dam irrigation project may become an impossibility. At a conservative estimate, more than \$25,000,000 of present values are at stake upon the success of the engineers to close the break. What is known as the Hind dam was thrown across the new channel and an earth dike was built parallel to the river for ten miles, mainly in Mexico. On the Arizona side of the river is the government dike.

Four days ago water found its way thru both dikes, flooding the sink. This was thought to be serious, but was not considered critical until Saturday night, when the water developed a distinct channel and disclosed the fact that the entire river had found its way around the Hind dam into the channel from which it had just been barred. The dam itself is uninjured.

It is believed that the Southern Pacific will immediately begin the construction of forty miles of road around the Salton Sea about fifty feet above the present grade.

INTRODUCE A NEW GRASS

Guinea Grass Resisted Drouth in Cuba and West India

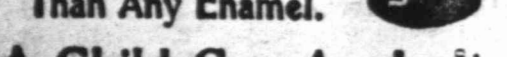

FRANCE FACES RELIGIOUS WAR

Gravity of Situation Reflected in Parisian Press

TIME LIMIT IS TUESDAY

Failure to Obey Government's Decree May Result in Invasion of Churches and Violence

By Associated Press.

PARIS, Dec. 10.—The press today unanimously recognizes the extreme gravity of the religious issue precipitated by the pope's attitude and many papers predict a veritable religious warfare. The government's calculations clearly have been upset and new legislative authority may be necessary to enable it to cope with the situation. It having been decided after tomorrow religious services may be held without preliminary declaration under the law of 1881, the pope's orders enjoining the immediate initiation of prosecutions in 30,000 communes and logistically the invasion of the churches by the police for the purpose of pronouncing the dissolution and expelling the parish priests. Militant Catholics seem likely to ally with the prospects of the violence which will compel the closure of the churches, with the attendant excitement and religious passions.

MAN AGED 80 HELD AFTER FIRE

Charred Body of H. C. Pride Found at Brownwood

BROWNWOOD, Texas, Dec. 10.—A fire alarm was turned in for the residence of John T. Sharpe, a Confederate Veteran, Sunday morning, and when the fire department arrived it was learned that a man named H. C. Pride was supposed to be in the house, which was then a mass of flames. By the use of chemicals the flames were extinguished so as to permit the firemen to enter and remove the charred remains. Pride was found on a pallet in the kitchen, face up. His arms and legs were burned off and his face charred beyond recognition. Foul play was at once suspected, and in an inquest this afternoon the coroner returned a verdict of murder.

John T. Sharpe is charged with the murder of Pride and is in jail. The cause of the murder, if there was a murder, is supposed to be jealousy. Sharpe claims to be more than 30 years old. He came to Brownwood with his wife a few months ago from Cooper, Texas, and was living in a tent in the suburbs of the city. He relied mostly upon a pension from the state for support.

LAY CORNER STONE OF NEW CHURCH

Services at Mulkey Memorial Sunday

With impressive ceremonies the corner stone of the new Mulkey Memorial church was laid Sunday afternoon at the building site, St. Louis avenue and West Ireland street.

Section 2. That upon the conditions, limitations and consideration aforesaid, and hereinafter mentioned, the city of Fort Worth has granted and does hereby grant unto the said Northern Texas Traction Company, and its assigns, the right to construct, equip and maintain along and over the said streets and portions of streets as set forth in Section 1 hereof, a single and double line of street car tracks, as specified with all necessary switches, side-tracks, connections and turnouts and all necessary poles and overhead equipment for propelling electric street cars by an overhead trolley system, and to operate and maintain the same over its said track, to carry goods and passengers for hire upon and over said track, and to do all other things necessarily incident to the rights and privileges in this ordinance expressly granted, except the places where turns are made, and where the street is partially occupied by some other street car track, shall be laid and kept as nearly in the middle of the street as is practicable, and the right to do all other things necessary and proper to the operation and maintenance of the street car tracks and the spaces between the rails shall be kept level with the street alongside, and safe street crossings over and under its tracks at the intersection of Calhoun, Jones and Grove streets, in such manner as may be required by the city of Fort Worth.

Section 3. The city of Fort Worth expressly reserves the right to lay, maintain and improve and permits to be laid and maintained, all sewers, water mains and pipes over and under the street car tracks, and the railroad tracks, in such manner as may be required by the city of Fort Worth.

Section 4. This ordinance shall become effective from and after the time it is published, voted upon and adopted, in accordance with the present charter provisions of the city of Fort Worth.

Section 5. The city engineer shall direct and point out the places at which poles erected under this ordinance shall be set, provided, however, that no pole shall be set in violation of any city ordinance.

Section 6. The rights, privileges and franchises granted by this ordinance shall continue in favor of said Northern Texas Traction Company, and its assigns, for a period of twenty-five years from and after the date of this ordinance.

ROOSEVELT'S FAILURE AS A COAL HUNTER Among the interesting stories about the President's homeward trip from Panama is the following incident:

"As the President sank his shovel deep into the coal, to the utter disregard of his work, and swung the shovel in the direction of the open furnace door, a lurch of the ship caused the President to miss the shovel and instead of striking the shovel of coal struck the boiler head and rolled upon the fireman floor.

"The President laughed heartily over his first failure. He is eminently well undismayed, he sailed into the coal pile again with renewed vigor. And to make the wheels of our round every man's work is necessary. What right have you, Mr. Pastidious, to look down upon any worker anywhere?

Opening Was Lower and Trading Slow, Waiting Bureau Report.

NEW ORLEANS, Dec. 10.—The cotton market opened steady at a decline of three points, and the price market was featureless. The market had a poor undertone and bid fair to work lower upon the publication of the census bureau report. Barring a radical ginners' report, and a government crop estimate well out of line with the average expectations, the talent, with some confidence, expects less excitement than such consequential documents usually furnish for the reason that comparatively little speculative interests will be carried over the first bureau day. In New Orleans this interest is "short," practically the long contracts outstanding being held as hedges. On the other hand, the net speculative interest in New York is practically an unknown quantity, an account of the fact that the selling of hedges there must be recovered with. There is little speculation in the operations of the week to any man unless the actual cotton shot has turned the easier tendency in the market. On the whole, the game has been profitless, while the altered temper of the talent has prompted some spot holders to relinquish on favorable terms than have recently been obtainable. But nothing approaching a general selling movement has been evidenced, and little covering the past few days. On the other hand, the longer have sold out and bullish sentiment is at a very low ebb.

Reports from all parts of the cotton belt indicates the prevalence of favorable cotton weather the past week with temperatures a little above the normal, with not rain enough to interfere with field operations, or with movement of the crops to market. Picking operations have progressed with rapidity, and the crops in many parts of the country have been picked out. Despite the late season, which has now been reached, and the progress that has been made, the probable size of the crop is as much in doubt as ever. The estimate, following the usual custom, or results, is from a half a million to a million, or a half too small, and the report today has no more claim to accuracy than former ones issued at the same time. The fact that will be issued after the publication of the census report will afford the statisticians of the agricultural department an opportunity to qualify their estimates in the light of the actual fact established by the gin returns, but it is impossible to forecast what will be done.

Trading Slow, Sales to Noon Being \$290,600 Par Value—Market Barely Steady to Lower

NEW YORK, Dec. 10.—The opening of the stock market was a shade lower than Saturday's close, and further declines were made. There was some activity in a few of the popular securities, but the larger portion of the list quoted on the New York exchange was slow and inactive.
