## Teen dies in pickup rollover

A 16-year-old Big Spring girl was one of two persons killed in separate traffic accidents this weekend in Howard County.

The other victim was a 42-year-old man from Tulsa, Okla.

Tammy Sue Marshall of 3821 Hamilton Ave. was pronounced dead at Malone-Hogan Hospital at 1:20 a.m. Sunday after the pickup truck she was riding in flipped over on Farm Road 669.

She was thrown from the vehicle, then struck by it as it rolled once, according to the Department of Public Safety accident report.

The driver, Stanley Steven Phillips, 19, of 1504 Kentucky Way was listed in good condition this

morning at Malone-Hogan with deep lacerations on his left arm, said a hospital spokeswoman.

Three other passengers were treated at Malone-Hogan for minor injuries and released. They are Terri Lynn Catron, 16, of 1905 Nolan St.; Arnold Solis, 18, of 704 N.W. 10th St.; and Lisa Deanne Bacon, 17, of 2501 Morrison Drive.

According to the accident report, Phillips was driving a Chevrolet pickup eastbound on FM 669 when it ran off the right side of the roadway, struck soft sand, and flipped. Both Marshall and Bacon were thrown from the truck in the 12:40 a.m. accident, according to the report.

In the second accident, Garry Albert Strickland of Tulsa, Okla.,

was killed at 7:32 this morning when a truck and trailer he was driving overturned twice on Interstate 20, 4½ miles west of Stanton.

He was pronounced dead at the scene by Martin County Judge Bob Deavenport.

According to the DPS accident report, Strickland was traveling at a high rate of speed when he hit a slick spot on the road and lost control of the truck.

The truck, which was pulling a flatbed trailer loaded with about 45,000 pounds of metal pipe, overturned twice before coming to rest on its wheels in the median, according to the report.

Strickland was thrown from the vehicle.

Funeral services for Marshall will be at 2 p.m. Tuesday at Nalley-Pickle & Welch Funeral Home with the Rev. Victor Sedinger, pastor of the First Christian Church, officiating. Burial will be in Trinity Memorial Park.

She was born Oct. 3, 1969, in Lubbock and lived there for five years before moving to Big Spring. She was a member of the First Christian Church and was active in the Christian Youth Fellowship.

She was a junior at Big Spring High School and had been involved in Girl Scouts for a number of years. She also attended Tri-Hi-Y and was a member of the Rainbows.

She is survived by her mother. FATALITIES page 2A

## County awards bid for annex

Johnston Construction of Big Spring was awarded a contract this morning to renovate the Howard County courthouse annex building.

Commissioners voted to award the job to the local firm at a cost of \$662,104 plus an additional \$26,000 for a polyurethane roof.

"We decided to go ahead" and include roof work in the contract, Commissioner Bill Crooker said.

All 12 construction bids commissioners reviewed during a June 12 special meeting included estimates for optional work on the roof.

The contract stipulates that Johnston complete the work within 220 days.

Architect John Gary said the contractors would be responsible for restoring the exterior of the building to its original condition and renovating the interior to contain new offices.

Commissioners this morning also heard an updated report from Dr. Jack Woodall of the Howard County Health Clinic about the proposed indigent health care program.

The county will be responsible as of Sept. 1 for assuming medical costs up to \$30,000 per patient for those who qualify as indigents.

Woodall said a 12-member investigative committee established by commissioners in May was still waiting for a proposal of services from Wayne Brannon, head administrator at Malone-Hogan Hospital.

They already have received proposals from Hall-Bennett Hospital and the Howard County Health Clinic.

At the conclusion of Woodall's report, Micki Potter, a registered nurse at Big Spring State Hospital, told commissioners she thinks the investigative committee is not being adequately represented by the nursing profession.

Potter is president of the District 24 Texas Nurses Association.

Crooker told Potter that Carmen Phillips, director of nursing at Malone-Hogan, was a member of the committee and that commissioners believed "this would suffice" for representation of nursing services.

However, Potter told commissioners that Phillips practiced more in an administrative level rather than a clinical setting.

"We are the ones who will deliver and implement care to the indigent," Potter said later, "and we should have a say. We've been excluded."

## Agency may have 20,000 farms by '88

WASHINGTON (AP) — Within the next couple of years, the federal government's farm lending agency could be in the process of kicking thousands of farmers off their land and adding substantially to its farmland inventory.

By its own estimate, the Farmers Home Administration could hold more than 20,000 farm properties by the end of next year. In 1979, before the current downturn in farm economic fortunes began, the FmHA held 288 properties. By March 31, that number had increased 14-fold to 4,075 farms comprising 1.2 million acres valued at \$709 million, government figures show.

The list of more than 4,000 farm properties — comprising an area larger than the state of Rhode Island — has made the FmHA one of the nation's largest farm landlords and is costing hundreds

of millions of dollars in losses, congressional investigators say.

On top of that, the agency is leasing much of the land it holds to farmers who then use it to grow crops already in surplus and which the government is paying other farmers not to grow, according to a new report.

"FmHA's ownership of farm property ties up a significant amount of government funds and results in increased government management expenses," the General Accounting Office, Congress' investigative arm, said in its report. "It also enhances a public perception that many farmers are losing their land and homes to the government."

In the 1983 fiscal year, the FmHA foreclosed on 356 farms. The next year, that figure dropped to 89 and

## Court to hear search warrant case

WASHINGTON (AP) — The Supreme Court today agreed to decide whether police may enter fenced-in property and look into a barn without first getting a search warrant.

The court said it will hear a Reagan administration appeal aimed at reinstating a Texas man's federal drug conviction.

The 5th U.S. Circuit Court of Appeals ruled last February that a federal drug agent and a local police officer violated Ronald Dale Dunn's rights when they looked inside the barn at his ranch in

Johnson City. The appeals court threw out Dunn's conviction and 16-year prison term for manufacturing phenylacetone and amphetamines in addition to possessing the drugs with intent to distribute them.

The 5th Circuit court said the barn was within an area where Dunn had a reasonable expectation of privacy and, therefore, law enforcement officials violated his rights by looking inside before they obtained a court warrant.

The officers crossed two fences Nov. 8, 1980, to reach the barn.

They said they saw drug-making equipment inside the barn and returned the next day with a search warrant for a closer look.

In a 1984 decision in a Kentucky case, the Supreme Court reaffirmed a 60-year-old legal doctrine by ruling that police may enter and search "open fields" without a court warrant.

In the Kentucky case, police seized marijuana growing outdoors on a farm that was surrounded by a fence with a locked gate. There were "no trespassing" signs posted.

The justices in 1984, at the Justice Department's urging, sent Dunn's case back to the 5th Circuit court for further consideration in light of their ruling in the Kentucky case.

But the appeals court refused to reinstate Dunn's conviction, saying there is a distinction between the two cases.

It said the open fields doctrine did not apply to Dunn's ranch because of its proximity to a barn house also located on the 196-acre property.

Reagan administration lawyers

said that since the ranch house was surrounded by a separate fence, Dunn's privacy rights were not violated by the police inspection of the barn.

In the appeal acted on today, government lawyers said, "Where a large ranch contains a residence surrounded by a fence, the area within such a fence" may not be searched without a warrant. But "the rest of the ranch is not associated with the sanctity of a man's home and the privacies of life" and no warrant is needed to search there.

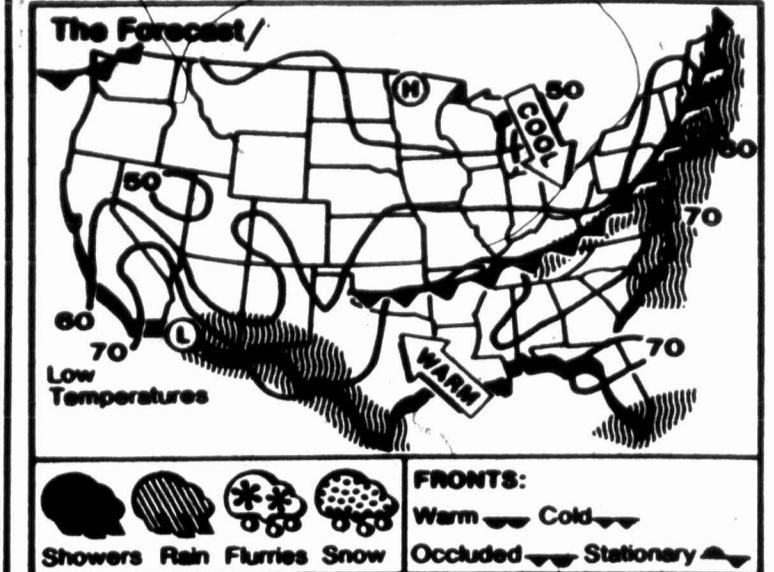
"Though the name of the city was changed, the spirit of the city hasn't," he said.

## Forecast

## State

Showers and thunderstorms dumped heavy rainfall over portions of West Texas early today, prompting the National Weather Service to extend a flash flood watch over a vast area.

The area of greatest concern, forecasters said, was an area along and to the right of a line from the New Mexico border east of Guadalupe Pass and south to Farwell, east to Silvertown, south through Big Spring to the Mexico border south of Sheffield and east of a Van Horn to Guadalupe Peak line.

An upper level low in Southwest Texas was expected to bring widespread rain and thunderstorms in the moist tropical air mass to the area today. The upper low was moving very slowly to the west and was expected to trigger substantial rainfall through Tuesday.

Thunderstorms continued over West Texas today. There were also scattered thunderstorms across the Trans-Pecos to Del Rio and across the lower coastal plains. Elsewhere skies were fair to partly cloudy.

Forecasters called for a chance of showers and thunderstorms tonight, scattered to numerous showers over West Texas, scattered over Southeast Texas and the western portions of South Texas and isolated over North Texas. Elsewhere it was to be clear to partly cloudy through tonight.

Lows tonight will be in the 60s and 70s. Highs Tuesday will be in the 80s and 90s.

Early morning temperatures were mainly in the 60s and 70s. Extremes ranged from 62 at Guadalupe Pass to 83 at Corpus Christi.

Other early morning temperatures around the state included 64 at Amarillo, 74 at Wichita Falls, 75 at Fort Worth, 74 at Waco, Austin, Houston and Brownsville, 72 at San Angelo, 66 at Lubbock and 68 at Midland and El Paso.

## Nation

Showers and thunderstorms were scattered from the Northeast to the nation's midsection today while a Plains cold front triggered rain and blustery winds.

A flash flood watch was issued in western Texas as showers and thunderstorms ranged from there to southwest Missouri.

Showers and thunderstorms also were scattered from western and central New York across western Pennsylvania and through the lower Ohio Valley.

## Scientists to study 'hole' in atmosphere

**WASHINGTON (AP)** — Scientists are trekking to the icy wastes of Antarctica, where they will use high-altitude balloons to study a mysterious and alarming ozone "hole" in the atmosphere above the South Pole.

Because of the importance of the atmospheric studies, 13 scientists will be on one of the first flights in August to the winter-locked U.S. base at McMurdo Sound, the National Science Foundation announced Sunday.

Six ski-equipped transport planes will make the 2,100-mile trip from New Zealand, a hazardous night journey normally restricted

to personnel essential for the seasonal opening of McMurdo and a few scientists manning crucial experiments.

The sun stays below the horizon for much of the Antarctic winter, which, south of the Equator, occurs in what is summer in northern climes.

Four groups of researchers will use 33 high-altitude balloons and sophisticated instruments in hopes of finding out what causes the recently discovered phenomenon of a drastic drop in the total amount of ozone each spring over the South Pole.

## Gramm boosts 'Star Wars' while professors blast it

While U.S. Sen. Phil Gramm was busy boosting President Reagan's "Star Wars" project in Texas over the weekend, a group of Houston-area professors were working just as hard to blast it.

Gramm escorted Lt. Gen. James Abrahamson, director of the Strategic Defense Initiative Organization, to Texas university research sites in Austin, Houston, College Station and Lubbock in his bid to make sure Texas gets a financial hunk of the Star Wars pie. Meanwhile in Houston, the local branch of Peace Links honored 23

scientists from Rice University and the University of Houston who have vowed not to work on SDI.

Donald Clayton, a Rice space physics professor and former department head, said Saturday that 12 of Rice's 20 professors have signed a pledge not to work on SDI because it is "technically dubious and politically unwise."

"The rest, except for one, think it is a lousy idea but didn't want to sign it (the pledge)," said Clayton, who did not identify that one professor.

for the first half of fiscal 1986 foreclosures stood at 34 farms.

About half of the properties ended up in the agency's inventory because farmers voluntarily signed them over after realizing they were unable to pay their debts. Another 40 percent came from liquidations forced by other lenders.

Often called the government's farm lender of last resort because it serves borrowers who can't get money elsewhere, FmHA began earlier in the year to crack down on \$6.4 billion in delinquent accounts. Letters informing borrowers of their plight went to 65,000 of the agency's 270,000 borrowers.

About 23,000 of those got really tough letters, telling them to contact FmHA offices or suffer the consequences. By and large, those were people who have been delinquent in their loan payments for three years or more.

The FmHA says that between 8,000 and 9,000 of those heavily burdened farmers did not bother to respond to the agency notices.

Under the rules, the agency now will "accelerate" collections,

meaning that the hard-core delinquents will have to settle up, sell out or be subject to FmHA foreclosure. But foreclosure can take two or three years, a drawn-out legal process that might go on well into 1988 or later.

Adding to the growth in farmland inventory has been the agency's restraint in selling off land. Because of depressed and falling farmland values, the agency has held off selling property wherever markets already were glutted to keep from adding further downward pressure to land values.

While the souring of the farm economy has been a major factor, it isn't always to blame for failure of FmHA borrowers, the GAO said. Its study found poor management, personal problems like illness or divorce and excessive FmHA debt were far more likely to be to blame for the farm failures studied.

In response to the report, the Agriculture Department largely agreed that better management of inventoried land is needed, but added that it planned no prohibition of planting of surplus crops because the impact of such production is minimal.

### Reagan to meet Soviet

WASHINGTON — As President Reagan prepared to greet new Soviet Ambassador Yuri V. Dubinin, administration officials voiced caution on whether the meeting would bring any breakthrough on prospects for a summit this year.

Dubinin, who has returned from consultations in Moscow, was among several ambassadors formally presenting their diplomatic credentials to the president in the Oval Office today.

Dubinin was named Soviet ambassador to the United States to succeed Anatoly Dobrynin after Dobrynin was appointed to the Communist Party Central Committee Secretariat on March 6.

### AT&T strike continues

WASHINGTON (AP) — The strike at American Telephone & Telegraph enters its fourth week today with negotiators for six AT&T divisions still trying to reach agreement with the Communications Workers of America.

"We are still bargaining," union spokeswoman Rozanne Weissman said late Sunday after a bargaining committee for 35,000 CWA members employed by AT&T's Information Systems division unanimously rejected the company's last offer. The workers install and service business telephone equipment.

### Chain stores may merge

NEW YORK — May Department Stores Co. of St. Louis has made a \$2.7 billion bid for Associated Dry Goods Corp. that would merge the department store giants into one of the nation's largest retailing companies, a May company spokesman says.

May is the nation's third-largest department store operator and Associated is the fifth. Both operate stores across the country under a variety of names.

In a letter released Sunday, May Chairman David C. Farrell said the two companies have talked about combining businesses for two years in discussions which have been "friendly and positive."

### Denver celebration ends

DENVER — Denver's black community ended its annual celebration of emancipation on a quiet note after two nights of violence that included the wounding of a policeman and the use of tear gas and dogs to disperse unruly crowds.

The Juneteenth celebration, which marks the day Texas slaves learned of their freedom in 1865, closed out its five-day run Sunday afternoon. Police said late Sunday that there had been no reports of trouble and a special police team armed with submachine guns had left the area.

# Final farewell

## Bias buried today; probe continues

COLLEGE PARK, Md. (AP) — While friends, family and fans bid a final farewell to Len Bias, questions about the circumstances surrounding the death of the 22-year-old University of Maryland basketball star will not be laid to rest.

The tragedy of Bias' untimely death last Thursday, two days after he was selected by the champion Boston Celtics as the second player taken in the NBA draft, has been further marred by unconfirmed reports that traces of cocaine were found in his system and a packet of powdery white substance was found in his car.

The answers to those questions won't be known until the medical examiner releases his report and those with Bias in his last hours are questioned. A Prince George's County prosecutor says friends and teammates of Bias will be called before a grand jury.

But today, mourners were remembering the strapping 6-foot-8 player who created magic on the basketball court and died just as he was about to make a longtime dream come true.

Bias collapsed in his dormitory room in College Park Thursday morning and died of apparent cardiac arrest.

Thousands began paying their respects in Washington on Sunday, filing past his coffin at a wake in the small brick Pilgrim African Methodist Episcopal Church in the Capitol Hill area.

A private funeral service was set for 10:30 a.m. EDT today at the University of Maryland chapel. A public tribute is scheduled for 7 p.m. at the Cole Field House, where Bias played and practiced.

Prince George's County state's attorney Arthur M. Marshall Jr. said Sunday night that those he expects to be questioned Tuesday include University of Maryland basketball Coach Lefty Driesell as well as basketball players Terry Long and David Gregg, who were reportedly with Bias in his college dorm early Thursday morning.

Marshall said police were still looking for Brian Tribble, a longtime friend of Bias', and another unidentified man, who were with the player in the hours before he collapsed.

A police official acknowledged there were reports that Bias had been seen hours before his death in a Washington area known for its on-the-street drug sales.

According to some of Bias' teammates, Tribble drove with Bias to a street in northeast Washington several hours before the basketball player died.

The investigation likely will stretch beyond the Bias death into alleged drug use in the sports program and on the College Park campus in general, Marshall said.

Responding to reports that Driesell had instructed players on how to respond to questions from reporters and the police, he said, "I don't think the role of a basketball coach is to tell student athletes not to talk to police."

"If these rumors are wrong, we'll give him a chance to talk about it," Marshall said, stressing that Driesell's role did not appear to be criminal obstruction of justice.

Prince George's County police are continuing their investigation into Bias' death, which they call suspicious. Police today planned to question Long and Gregg, as well as Tribble, but there was no word on if, and when, he would talk with authorities.

Alan J. Goldstein, attorney for Long and Gregg, refused to comment on whether the players had talked with police or whether interviews with police were scheduled.

### Oil refinery bombed

JOHANNESBURG, South Africa — A pro-government newspaper today reported that South Africa's nationwide state of emergency will remain in force after the expected signing this week of tough new security legislation.

Meanwhile, the government dropped treason charges against four anti-apartheid activists in Natal, and two beaches were shut in Durban because of an oil refinery bombing that caused an oil slick.

The Bureau of Information said today two landmines were found Sunday on farm roads in northern Natal and were detonated safely by bomb experts. The African National Congress guerrilla movement has previously claimed responsibility for planting landmines in farming areas of Transvaal Province, north of Natal.

### Waiter I.D.'s gunman

GENOA, Italy — A Portuguese waiter and an Italian hairdresser who were aboard the Achille Lauro testified today that a hijacker forced them to throw overboard the body and then the wheelchair of an elderly American passenger.

The waiter then identified one defendant in court, Youssef Magied al-Molqi, as the gunman who gave them the order.

The testimony came on the fourth day of the trial in the Oct. 7-9 hijacking of the Italian liner and the shooting death of Leon Klinghoffer of New York. The court is trying 15 defendants, three of them accused as hijackers.

### Dynamite truck explodes

CAIRO, Egypt — A truck carrying dynamite to a stone quarry south of Cairo crashed into a fruit peddler's cart and exploded today, killing at least six people and damaging dozens of houses, police said.

Police Capt. Ahmed Abdel-Wahab said the explosion occurred at about 6:30 a.m. on the main road linking Cairo and southern Egypt.

"Police said four people were hospitalized, but did not know the total number of people injured. Earlier, police said 15 people were killed and 30 injured.

### Shultz to discuss dispute

SINGAPORE — Secretary of State George P. Shultz said today he is likely to meet later in the week with Prime Minister David Lange of New Zealand to discuss the dispute over whether U.S. ships can visit New Zealand ports.

Shultz told reporters traveling with him on a five nation trip to Asia that he may meet Lange while they are attending the meeting of foreign ministers of the Association of Southeast Asian Nations and their key trading partners.

The meeting will be in Manila beginning on Tuesday.

## Women speak via satellite

NEEDHAM, Mass. (AP) — U.S. and Soviet women linked by satellite for a television program disagreed on political issues but found they had common family problems like getting husbands to help around the house.

"A working woman is an extremely busy person. We have husbands. We have children," a Soviet woman said. "I think right now this is a universal problem."

Two hundred women in Leningrad, including doctors, housewives and laborers, and 200 of their American counterparts in this Boston suburb quizzed each other for three hours Sunday on issues ranging from nuclear war to a lack of available men.

The event, billed as a "Citizens' Summit," will be televised in most major U.S. cities beginning Wednesday, producers said. Soviet national television also is expected to air the program in a one- or two-hour segment.

The first satellite summit linked men and women in Seattle and Leningrad in December.

TV talk show host Phil Donahue served as moderator in the Massachusetts studio, while Soviet commentator Vladimir Pozner was the Leningrad moderator. The women exchanged views while watching each other on large-screen monitors and listening to translators.

In their exchange, some of the Boston-area women noted the renewed opposition to nuclear power plants in the United States following the Chernobyl accident and wondered why the Soviets were not protesting to try to close down atomic plants in their country.

"Calm down, comrades," one Soviet woman chided the Americans. "Everything is back to normal. We coped with it as an-

tire people."

Others said shutting down the plants was impractical.

"We cannot stop the development of science that is going on now in the world," a Leningrad woman said. "Our entire development depends on nuclear energy."

With a show of hands, all the participants indicated both governments should be working to end the nuclear arms race.

"We are really trying to save our species from extinction. How can we resolve conflict between our nations ... without resorting to violence?" asked a U.S. woman.

"We are actually one big family. Not just friends, family," said a Leningrad woman.

The women shared family problems, including high divorce rates and the difficulty of juggling the responsibilities of a job, husband and children. And a Soviet woman agreed with U.S. participants who said husbands were not pulling their fair share of work around the house.

"The majority of men in our country do very little at home," she said. "Men today have been a little infantile, perhaps." Her remarks drew nods of approval and applause from the Massachusetts

audience.

Some of the U.S. mothers complained about the lack of day care in their country, while the Soviet women told of round-the-clock nurseries close to home.

The Soviet women criticized their American counterparts for carrying misconceptions about Soviet life. Stories Americans had heard about huge lines to get food and clothing were false, they said.

They also brushed off questions about human rights violations against Soviet Jews. "Americans should take a good look at themselves," said one of the women. "We've heard of incidents of anti-Semitism and vandalism taking place in the United States."

Outside the WCVB-TV studio where the show was taped, members of the Jewish Community Council of Metropolitan Boston urged participants to push the Soviets on human rights questions. Council spokeswoman Carol Saivetz said the Soviet participants were handpicked to defend their government's positions.

But WCVB spokesman Burt Peretsky said both audiences were selected by U.S. and Soviet producers through random questioning of women in public places.

### Teen returns from Moscow

By The Associated Press GRAPEVINE — A week after being hospitalized in the Soviet Union following a severe asthma attack, Lisa Riggs returned home to Texas where she got a hug from her mother and a clean bill of health from her family doctor.

While attending a circus in Moscow a week ago with high school classmates, the 17-year-old Irving senior stopped breathing after an asthma attack.

On Sunday, she came home, arriving in a wheelchair at Dallas-

Fort Worth International Airport. Carrying a red rose, she said she felt much better and her Soviet doctors had treated her well.

The silence that followed her hospitalization a week ago proved her parents to pursue several bureaucratic channels before finally untangling the red tape that kept them from getting reports about their daughter's condition.

But on Sunday, Lisa's parents were relieved.

### Houston man scheduled to die

HUNTSVILLE — A 25-year-old man convicted in the 1980 rape-murder of a Houston travel agent will become the third Texas inmate in 15 days to be put to death unless a court intervenes before his scheduled execution early Tuesday.

Assistant Attorney General Paul Offenbender said late Sunday that Williams' execution by injection is still scheduled for shortly after midnight, although an appeal is pending.

Attorney Craig Washington, who is handling Williams' appeals, and officials with the Texas attorney general's office could not be reached for comment Sunday.

However, Washington said last week he has filed an appeal for a stay with the Court of Criminal Appeals in Austin. Washington con-

tends potential minority jurors were excluded from the trial.

In April, the U.S. Supreme Court ruled that prosecutors cannot strike potential jurors solely because of race. Washington, a state senator from Houston, said prosecutors in Williams' capital murder trial excluded eight blacks and two Hispanics for no reason.

Williams was convicted of capital murder in the June 2, 1980 slaying of Emellie Anderson at her boyfriend's apartment. Authorities said she had become sick at work and had gone to the apartment because it was closer than her own home.

Assistant Harris County District Attorney Ned Morris, who prosecuted the case, said the jury took only six minutes to return the death penalty.

### Plant faces budget squeeze

AMARILLO — The expected loss of 75 jobs at the Pantex nuclear weapons plant between now and Oct. 1 is only one of the problems the plant faces from federal budget cuts.

The Amarillo Globe-News said in its Sunday edition that federal budget pressures are squeezing the plant's ability to meet delivery schedules of nuclear warheads for the military.

The newspaper said it obtained a heavily censored transcript of congressional hearings.

Dr. Richard L. Wagner Jr., an assistant to the secretary of defense for atomic energy, ex-

pressed his concern about the workload at Pantex during hearings earlier this year before a subcommittee of the House of Representatives Appropriations Committee.

"There is today, for the first time that I can remember in 20 years in this program, no slack between the DOE (Department of Energy) warhead production, warheads coming out the door at Pantex, and the need date for the DOD (Department of Defense) deployments," Wagner testified.

Pantex, the nation's final assembly point for nuclear weapons.

## Reading labels is important

Americans spend over a billion dollars a year on cereals. What consumers get for their money depends, in part, on how carefully they read the nutrition labels on the cereal boxes.

Nearly all breakfast cereals are grains, such as corn, wheat, rye, oats or barley. In their natural state, grains contain vitamins, minerals and fibers. But during the processing of grains into cereal products, many nutrients are lost.

Most cereal manufacturers restore the lost nutrients by fortification. Some ready-to-eat cereals are fortified with more vitamins and minerals than the grains contain in their natural state.

The Food and Drug Administration requires that fortified foods which provide 50% or more of the U.S. Recommended Allowance of one or more nutrients be labeled with the terms "dietary supplement," or "multivitamin and iron supplement."

If you really want to know what you're getting in a cereal, read the label. All packages have a list of ingredients in order of predominance by weight. Cereals also have nutrition labels that tell you what percent of the daily requirement for basic nutrients is provided. By comparing labels you can select a cereal which is high in a particular nutrient, such as

iron. Or you can check the labels to avoid buying cereal high in sugar, sodium or preservatives.

As you read the nutrition labels, remember that they are based on a one-ounce serving. Since cereals vary in bulk and consistency, an ounce of one kind might make 1/4 cup, while one ounce of another cereal could be 1-1/4 cups.

If your customary serving size is more or less than the one ounce standard, you'll want to take that into account when figuring the cereal's nutritional value.

Fiber is More Than Just Bran

To listen to the television commercials or read the magazine ads, you would think the only way to get adequate fiber in your diet is to eat bran cereal and fiber supplements.

In fact, legumes and some fruits and vegetables supply more dietary fiber per serving than bran cereal. One cup of bran flakes cereal contains

about five grams of fiber, while one tablespoon of the average fiber supplement contains about one gram. By comparison, 1/3 cup of baked beans contains seven grams and 1/2 cup of stewed prunes has 8 grams of fiber.

Kidney beans, red beans, dried fruits and nuts and fresh fruits and vegetables are all excellent source of fiber. Eating the skins of fruit or vegetables when possible will also increase your fiber intake.

The new Dietary Guidelines for Americans, published this year by the U.S. Department of Agriculture and the U.S. Department of Health and Human Services, recommend that we eat foods with adequate starch and fiber.

But that doesn't mean we need to go overboard, or rush out and buy special fiber supplements. Eating too much fiber may increase the excretion of some vitamins and minerals and deplete those nutrients in your body.

More Supermarkets Carry "Natural" Foods

Industry sources report that over 3,000 supermarkets now have "natural foods" sections. Among the ten largest chains, the number has doubled from 1,200 two years ago to 2,400 today. Since there are no clear definitions for "natural" foods, and many of these sections feature vitamin, mineral and food supplements, maybe they would be better named "artificial" food sections!

## Minister gets many invitations

DEAR ABBY: My husband is an ordained minister. One problem we have with people in our congregation is that we receive invitations from most parents whose children are graduating from high school and college.

In the first place, it is improper to send us invitations. In the second place, some of those families have three and four children, and since our salary is far below other professionals with equal education, we cannot afford to give gifts. (I wonder how many of these same people would have the nerve to send invitations to their doctors, lawyers, high school principals, etc.) And, Abby, it doesn't stop there, either. After college, we receive bridal shower and wedding invitations (even when my husband performs the ceremony), then come baby showers and housewarming invitations. In some situations we have spent as much as \$200 per family, depending on the number of children they have.

Please print this letter in hopes that the congregations that are uneducated in this area will read this and become more knowledgeable on what is proper etiquette. Thank you.

## Pain caused by tick-borne illness

DEAR DR. DONOHUE: Some time ago, you had a letter from a woman complaining of a rash that wouldn't go away. She had other symptoms as well, I recall, including muscle pain. There was also reference to Bell's palsy. Please look up Lyme's disease. It is becoming increasingly common in the Northeast U.S. and is caused by ticks. My sister and cousin both had it and our doctor hadn't heard of it. In my cousin's case, he finally got penicillin and the condition cleared up. — S.S.

Lyme disease is a relatively new illness, or at least it was not identified until 1975. In that year, a puzzling outbreak of what seemed to be arthritis occurred in youngsters living in the Lyme, Conn., area. Diligent detective work established that it was not juvenile arthritis, but a tick-borne bacterial illness. Since then, it has appeared in other parts of the country (West and Midwest) as well as abroad, and it is not confined to children.

Thanks for your note, for it does give me an opportunity to discuss it and make parents more aware of it.

The infecting bacterium enters the body via the bite of a tick. The earliest sign is a rash, a red spot,

that gradually enlarges to as much as a six-inch diameter. With enlargement, the inner part of the spot pales. Headache, fever, and stiff neck may appear.

The Lyme disease rash disappears in a month on its own, but that isn't the end of the story. In a week or two, joints begin to ache. That, too, subsides spontaneously, but may recur later. In some cases there may even be heart involvement, and sometimes nerve symptoms, like the Bell's palsy you mention.

It is well to recognize the signs of Lyme disease early, for when it is diagnosed penicillin (or tetracycline) stops the process effectively.

Another note: The ailment is most often reported in warm

weather, when ticks are most active. Campers should take repellent precautions when outdoors in tick areas.

DEAR DR. DONOHUE: Regarding the magnetic resonance test: Can it be used in pregnancy? Can you describe what happens to you? — Mrs. W.V.C.

There are presently restrictions to use of this most effective imaging process. It is not used in pregnancy, for people with heart pacers, or for those who have surgical clips in their bodies.

Little is required of the patient except for absolute stillness during the imaging, to avoid distortion. There is no discomfort except for uneasiness in those who tend toward the claustrophobic. Your body is slipped into a tunnel, where the magnetic field is located. You feel rather like an astronaut must, and you communicate with the doctors via a special phone. As you lie still, shortwave signals bounce off your body. They stimulate body cells to emit their own signals, which are captured and put back together into a detailed three-dimensional image. We have great hopes for what can be accomplished diagnostically with MRI (magnetic resonance imaging).

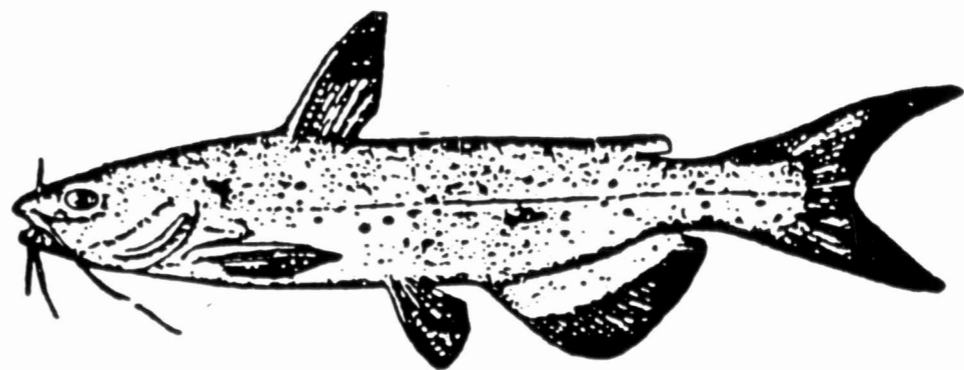

## Lions edge Rangers 3-2 for city title

The Little League city playoff title game between the Lions and Rangers was every bit the showdown it was billed up to be. The two National League teams locked up in a tight struggle that saw the Lions squeak out a 3-2 win.

The Lions, who finished first in the league ahead of the Rangers, rallied with two runs in the bottom of the fifth inning to preserve the win. Behind the strong pitching of Shane Myrick the Rangers held a 2-1 lead after the first four innings of play.

Myrick locked up in a duel with Lions' Joe Conaway. Both pitchers hurled excellent games, allowing four hits each. Conaway fanned 13 batters and walked one, while Myrick whiffed 10 and issued five free passes.

Taking advantage of a short wild spell by Myrick, the Lions rallied for the win in the fifth. With his team leading 2-1 Myrick walked Kenneth McCalister and Tim Duffey to start off the inning.

Next Joey Franco followed with a bloop single, loading up the bases for shortstop Gerald Cobos. Cobos came through with a base hit to left that scored McCalister and Duffey with the winning runs.

The Rangers drew first blood in the contest in the opening inning. Patrick Chavvaria's two run homer gave the Rangers a quick lead. Myrick got on ahead of Chavvaria with a bunt single. Chavvaria caught a Conaway fastball and planted deep over the left field fence.

The Lions got their first run in the fourth inning. Cobos walked

and eventually scored on an error by the second baseman. The Rangers' Clay Katt failed to field Nick Roberson's grounder, thus allowing Cobos to score.

In the top of the sixth Conaway got Myrick out on a grounder back to the mound and fanned Micah Epley for the first two outs. But the ever-present Chavvaria banged a double into the left-center gap to

keep the Rangers' hopes alive.

But the game ended when David Parks grounded out to second baseman Dennis Paulette.

## Maradona stuns England

### Argentina eliminates England from World Cup

MEXICO CITY (AP) — Entering the World Cup, some people questioned whether Diego Maradona's weight or maturity would keep him and his Argentinian teammates from winning the title.

They're not questioning anymore.

Diego Maradona scored twice in the second half, the second after driving from midfield and evading three defenders and goalkeeper Peter Shilton, leading Argentina to a 2-1 quarterfinal victory over England.

The game was the first major sporting event between the two countries since the 1982 Falkland Islands War in which 712 Argentinians and 255 Britons were killed.

But the players kept their pledge to stick to soccer and, although the game was highly competitive, it was played in a fair spirit.

In the stands, fears that fans of the two countries would wage their own vendetta four years after the South Atlantic hostilities proved unfounded.

While there was huge controversy over whether Maradona punched the ball in for the first goal, scored in the 51st minute, his second four minutes later was described by England Manager Bobby Robson as "a miracle goal."

Maradona said the goal "was not the best of my career, but the most important because it allowed us to clinch the victory."

England pulled within one as Gary Lineker scored his tournament leading sixth goal on a header with 10 minutes left, but England's concentrated attack could not score again, sending Argentina to a semifinal match against Belgium on Wednesday.

Argentina is the only Latin American club left in the 24-team event. A European nation has never won the Cup when the competition has been held in the Western Hemisphere.

While everybody marvelled and sighed at the second score, England screamed about the first. Shilton and Robson claimed the

ball went in off Maradona's hand. "There are no ifs and buts about it," Robson said. "It was obvious that Maradona had not got his head to the ball. That goal should never have been allowed. It was a bad refereeing decision and you don't expect that at World Cup level."

Maradona admitted that the goal was "a little of Diego's hand and a little of Maradona's head."

"We can talk other days about my goals," he said. "Today, let's talk about the win."

Television replays appear to support the English's claim, showing the ball bounce off Maradona's left hand, which was raised slightly above his head.

England defender Terry Fenwick made several hard tackles of the 25-year-old striker and was fortunate not to have been ejected after being shown a yellow-card warning in the ninth minute.

But Maradona had his revenge just after halftime, destroying England in four unforgettable minutes.

## Giants take over first

SAN FRANCISCO (AP) — The San Francisco Giants, despite injuries to key players, knew a 12-game stretch beginning June 12th could determine their destiny in the National League West.

Eight of those games were with the division-leading Houston Astros, who succumbed to the Giants, 4-2 and 3-2 on Sunday, to drop 1½ games behind first-place San Francisco.

A crowd of 47,030, largest of the season at Candlestick Park, watched the Giants complete a four-game sweep. They won six out of the eight games with the Astros, taking an 8-5 edge in the season series. Last year Houston won 15 of the 18 games between the clubs.

"It was like a World Series," manager Roger Craig said of the Giants-Astros showdown. "The guys had adrenaline flowing. They feel they can beat anybody now. They're playing well and they deserve to be in first place."

Right-hander Mike Krukow, 9-4, went the distance in the opener and third baseman Chris Brown knocked in a pair of runs with a double and a single to continue his solid clutch hitting.

Rookie second baseman Robby Thompson had three of the Giants' 11 hits, including the game-winning single in a two-run fifth off loser Manny Hernandez, 1-3, cracking a 1-1 tie.

Left-hander Mark Davis, making his first start after 30 relief appearances, yielded only two hits and no runs in six innings of the second game. The Astros moved into a 2-2 tie on Billy Hatcher's two-run single in the eighth off Berenger, 1-0, who eventually knotted his first National League victory.

The Giants won it in the bottom of the eighth off Houston relief ace Dave Smith, 1-4. Thompson led off

with a walk and went to second on Candy Maldonado's one-out bloop single to right.

Brown walked, loading the bases. Rookie first baseman Mike Aldrete, who drove in the first run with a double, then hit a run-scoring, fielder's choice grounder to the right side.

"There was a playoff atmosphere out there today," said Aldrete, who enabled rookie Chuck Hensley to register his first major

league save in the second game by leaping high for Craig Reynolds' line drive with two on and two out in the ninth.

Astros manager Hal Lanier took his hat off to the Giants.

"They played good and they pitched good, so they deserved to win," he said. "But it's not the end of the world, or the end of the season. We'll see who's in first place in October."

## Rangers "magic" whips A's

ARLINGTON (AP) — Things are going so well for the Texas Rangers right now that some of the players are calling it "magic."

On the other side of the coin, things are going so bad for the Oakland A's that manager Jackie Moore might be tempted to believe something other than talent is behind it.

Sunday night's 5-4 Texas victory was a classic example as the Rangers stretched their winning streak to four straight while the A's were losing for the 15th time in their last 19 outings.

Trailing 3-2 after six, the Rangers rallied for three runs in the seventh, then survived Oakland threats in the eighth and ninth to

hand the A's their 14th straight road loss.

"It's been like magic," said Ranger reliever Greg Harris, who pitched out of a ninth-inning jam to record his 14th save. "It almost seems like we can do anything we want after the seventh inning."

Oakland reliever Jose Rijo, 2-6, was the victim of the seventh-inning uprising while Dale Mohoric, Texas' 30-year-old rookie reliever, picked up a victory in his first major league decision.

Rijo replaced starter Bill Mooneyham to start the sixth and struck out the three batters he faced.

But Steve Buechele doubled leading off the seventh, Curtis Wilkerson and Oddibe McDowell

singled, and Gary Ward tripled, giving the Rangers a 5-3 lead.

Doug Bair replaced Rijo and left Ward stranded at third by striking out the next three batters.

Ward drove in four of the five Rangers runs after being hit by a pitch in his first at-bat. He singled home a run in the third to tie it at 1-1 and doubled home a run in the fifth to cut Oakland's lead to 3-2.

Mickey Mahler started for Texas and went five innings, allowing four hits and three runs. He was touched for solo home runs by Mike Davis, his eighth, and Mickey Tetleton, his second.

In the eighth, Oakland got a run off Ranger reliever Mitch Williams on Carney Lansford's single and Jose Canseco's double.

### 6-1 win over Mercedes delayed a week in court

AUSTIN (AP) — Carl Sullivan's hitting and David Crowson's pitching gave Brenham the Class 4A state baseball title and brought the 1985-86 school year to a delayed end.

Perhaps fittingly, the 4A championship game — the final activity of the school year — had been postponed a week because of courtroom battles.

Immediately after Brenham's 6-1 Saturday night win over Mercedes, the stadium announcer at Dusch-Falk Field told the crowd of 4,450, "We hope future activities are not held up by lawsuits and that games can be decided by the rules which all schools agree to follow."

The 1985-86 school year was marked by court challenges — still pending — of the basic literacy test that all educators had to pass to keep their teaching certificates.

The stadium announcer, reading words written by University Interscholastic League athletic director Bill Farney, said, "The students have played well, studied

hard. Teachers, coaches and administrators survived the TECAT."

The 4A baseball final survived a tangle of lawsuits sparked by Waco Richfield, which was denied a berth in the final four when it lost a rain-shortened series to Austin Westlake.

Champions in the other four classes were decided June 13, but the 4A teams had to wait until the Texas Supreme Court ruled against Richfield and cleared the way for the games.

Brenham, 30-3, blasted Snyder 10-0 in the semifinal, and Mercedes was a 2-1 upset winner over Westlake.

Sullivan, the Cubs' right fielder, drove in three runs and had two of Brenham's 12 hits in the title game. Crowson, 13-0, held the Tigers to four hits.

Mercedes wound up 22-8. Pitcher Carlos Pimentel was the loser Saturday in relief after going the distance in the Friday win over Westlake.

## Amputee postpones fight

**CHICAGO (AP)** A severe flu-like infection has forced cruiserweight Craig Bodzianowski to cancel what was to have been his third fight since a partial leg amputation, his manager says.

"Craig is really sick about this and I feel bad for his fans," his manager, Jerry Lenza, said Sunday about the canceled fight.

"He wanted to fight anyway, but no way — not against doctor's orders. I'm not going to risk this guy's health for one fight and then have to make excuses afterward," Lenza said.

"He has some kind of infection in his system. Maybe it's flu; I don't know what it is," Lenza said.

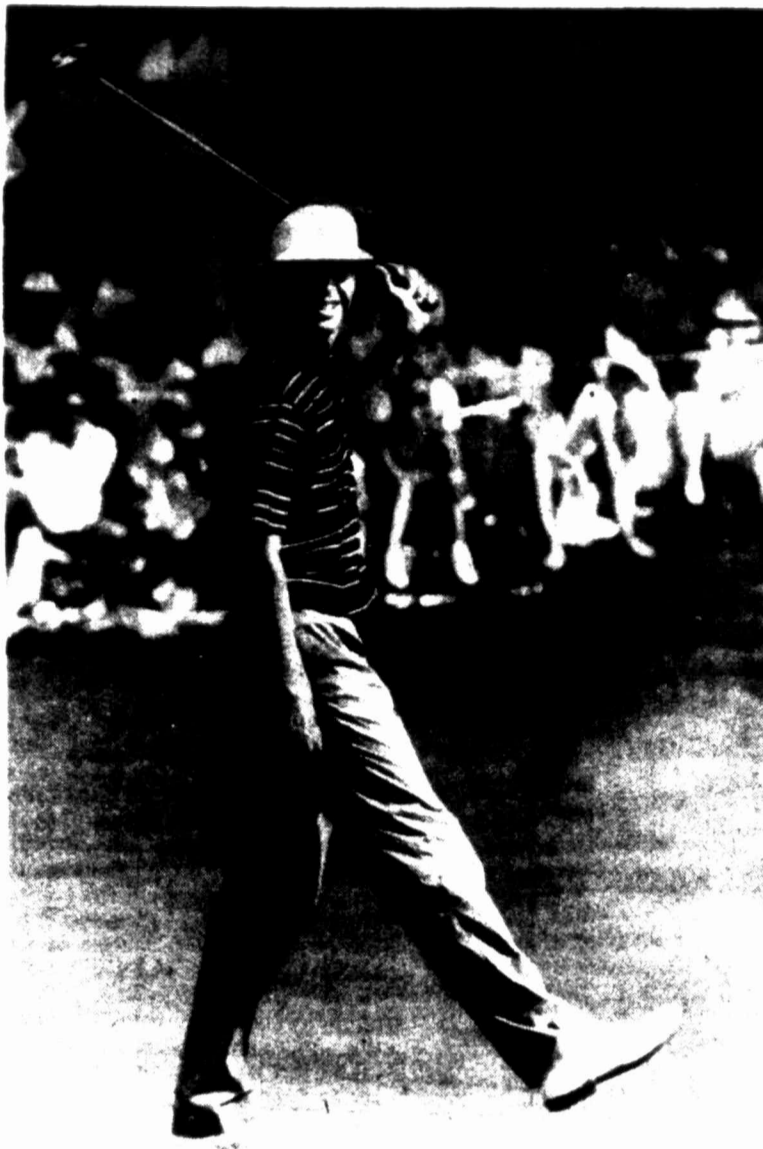
Bodzianowski, who has a partially amputated right leg, has been taking antibiotics for a week, Lenza said, and his doctor has advised him not to fight.

"Hopefully we'll fight again in three or four weeks," Lenza said. "We'll fight the same fella if he's available, and I think he will be."

The eight-round bout was to have preceded a closed-circuit telecast from Las Vegas of three fights featuring Thomas Hearns, Roberto Duran and Barry McGuigan.

"This costs him a nice day's pay, our expenses and seven days of training," Lenza said. "But what if Craig gets knocked on his butt and the ref has to stop the fight? I don't want to have to make excuses."

# Tway gets his third title in '86

**ATLANTA (AP)** — No one could have expected a second-year professional golfer to have the kind of year Bob Tway is having.

The 27-year-old former Oklahoma State University star became the 1986 PGA Tour's first three-time winner Sunday when he shot an 8-under-par 64 to win the \$500,000 Georgia-Pacific Atlanta Golf Classic by two shots over third-round leader Hal Sutton.

"I'd like to be on top in everything," Tway said. "But that's impossible to do. I'd just like to see how good I can be playing this game."

Coming from four shots back at the start of the day, Tway conquered the 7,007-yard, par-72 Atlanta Country Club course with exceptional iron play.

He placed his irons and wedges so close throughout the round that his longest birdie putt was only 10 feet on No. 9.

"I played very well today," he said. "I hit quite a few iron shots close to the hole."

The \$90,000 first prize lifted him into second place on the money list with \$446,119, trailing only Australian Greg Norman.

Norman also had a final round 64 Sunday to tie for third place, with his \$24,000 check lifting his season's earnings to \$482,979.

Tway won the Andy Williams Open earlier this year and added his second career victory two weeks ago at the Westchester Classic.

The 6-foot-4, 180-pounder had birdie putts of 4 feet on No. 2 and 3 feet on No. 5 before making the turn at 33 after his birdie at 9. He was still three shots behind Sutton halfway through the round.

Tway scored from five feet or less on the 11th and 12 holes — the latter giving him a share of the

lead with Sutton. He then birdied the 14th from three feet and took the lead for good with a 5-foot birdie putt on 15, which Sutton later bogeyed when he failed to sink a 5-foot par putt.

Tway's lead went to two shots when Sutton bogeyed No. 16, and Tway didn't need his two-putt tap-in birdie on the final hole.

Norman, who started the day in a tie for 23rd place, eight shots off the lead, said a 64 was the worst score he could have shot the way he was playing.

"I thought if I shot 64 I would have a chance to win," Norman said. "On the last day, things usually tighten up."

Norman highlighted his round when he dropped a 1-iron within 8 feet on the 546-yard 11th and sank it for an eagle 3.

Norman was tied with three others at 273 — Willie Wood, 68, Mark O'Meara, 69, and Scott Hoch, 70.

Gary Koch was alone in seventh place at 67-274 and Tom Purtzer finished eighth at 71-275.

## Wimbledon begins with Becker rout

**WIMBLEDON, England (AP)** — Boris Becker began his defense of the Wimbledon men's singles championship in powerful fashion Monday, defeating Eduardo Bengochea of Argentina 6-4, 6-2, 6-1 on a misty Centre Court.

Becker, the youngest-ever Wimbledon champ at 17 a year ago, broke Bengochea in the first game of the match and served out the first set, with the Bengochea looking nervous in the early going.

Darry Phelps of the United States registered the first victory of Wimbledon 1986, beating Britain's Amanda Grunfeld 6-2, 6-0. Paul Anacone of the United States beat Stewart Bale of Britain, 6-3, 7-5, 6-3, and Jay Lapidus of the United States defeated Kevin Moir of South Africa 6-2, 6-4, 6-3, in other early matches.

He's seeded fourth, the first time since Bjorn Borg in 1977 that the defending men's champion has not been the top seed.

He's not listed as the favorite

with any of the legal London betting parlors. That honor goes to 34-year-old Jimmy Connors, or Frenchman Henri Leconte, or top-seeded Ivan Lendl, or second-seeded Mats Wilander, depending upon where you place your wager.

Lendl, the French Open champion, began play on Court No.1 against Leonardo Lavalle, an 18-year-old who last year won the Wimbledon junior title.

Wilander of Sweden, a clay-courtier who has won the Australian Open twice on grass, opened against American Scott Davis,

while Connors played another American, Robert Seguso.

Only two of the women's seeds were in action on the first day, both against Britons.

No. 3 Hana Mandlikova played Joy Tacon, while No. 7 Helena Sukova played Denise Parnell.

The top two seeds in the women's draw, Martina Navratilova and Chris Evert Lloyd, are scheduled to open play Tuesday.

John McEnroe, the three-time winner, is home in the United States helping care for his newborn son.

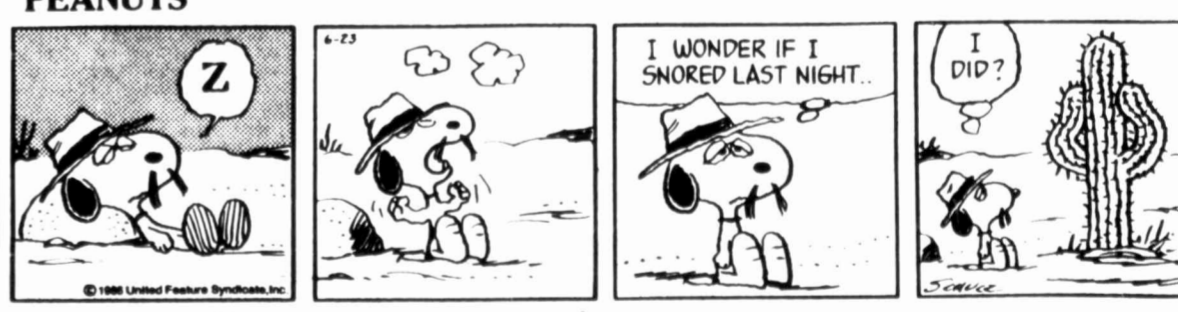

# Ageless Niekro two-hits Cleveland past Twins

By the Associated Press — Phil Niekro retained that winning feeling after five starts without a victory. Jim Fregosi returned on the winning track after five seasons away from the major leagues.

Niekro made a few adjustments with his knuckleball Sunday and the results were immediate. He pitched his ninth career two-hitter — holding Minnesota hitless over the final 8 1-3 innings — as the Cleveland Indians beat the Twins 4-1.

Fregosi, named manager of the Chicago White Sox on Sunday morning, made a successful debut with his new team. Ozzie Guillen and Bobby Bonilla drove in two runs each as the White Sox downed the Seattle Mariners 10-4.

"I don't care if it was sloppy, dirty or grubby as long as we won," said Fregosi, who replaced the fired Tony LaRussa. "There were some mistakes made but we didn't make a lot ourselves and that's why we won."

Fregosi had not worked in the big leagues since being dismissed as manager of the California Angels in 1981. He won two American Association championships with St. Louis' Class AAA Louisville team in the last three years.

The White Sox showed their new manager something from the start, scoring in the first inning when John Cangelosi led off with a walk, stole second, took third on an infield out and scored on Harold Baines' sacrifice fly.

"I was excited because the team was excited," Fregosi said. "They did the little things that don't show in the statistics like moving the runner from second to third three times with nobody out. And we got some sacrifice flies."

Guillen singled home two runs during a four-run second and doubled and scored on Cangelosi's double in the sixth.

The victory left the host White Sox in fourth place in the AL West, 9½ games behind first-place Texas.

Niekro, winless in his previous five outings, got off to another rough start in Minnesota. Kirby Puckett led off the Twins' first with a single, took second on a ground-out and scored on a single by Kent Hrbek.

But after that, Niekro was almost perfect as he retired 25 of the final 26 batters. The only other Twins to reach base were Gary Gaetti, who reached with two outs in the first on an error by third baseman Brook Jacoby, and Hrbek, who was hit by a pitch with two outs in the ninth.

"He threw a two-hitter against the best-hitting team in baseball," Minnesota Manager Ray Miller said.

Niekro, 4-6, won his 304th career game with help from Indians pitching coach Jack Aker and Mel Hall.

Aker noticed a slight flaw and helped Niekro fix his delivery. Niekro also said he adjusted his grip on the ball.

"You move your thumb a half-inch the wrong way and everything goes haywire," Aker said.

Said Niekro, "I'm not big on mechanics, go more on feeling. That feeling gives you the confidence to throw knuckleball after knuckleball."

Hall hit a two-run homer, his 10th, in the fourth inning that gave Niekro a three-run edge.

Niekro's outing was better than the one by his brother, Joe, who took the loss as the Yankees got routed by Toronto.

Blue Jays 15, Yankees 1  
Tony Fernandez and Ernie Whitt both hit two-run homers and two-run doubles, sparking a season-high 16-hit attack that powered Toronto past New York.

Fernandez went 3-for-5 while Whitt, Willie Upshaw, Lloyd Moseby, Jesse Barfield and Damaso Garcia had two hits each for the host Blue Jays.

Upshaw's two-run single keyed a four-run fifth inning that snapped a 1-1 tie. Toronto added three runs in the sixth and kept pouring it on with four runs in the seventh and three more in the eighth.

Jimmy Key, 5-5, yielded Willie Randolph's first home run of the season in the first inning, but shut out the Yankees on eight more hits through eight innings.

Joe Niekro, 7-5, pitched five-plus innings and allowed seven runs, five earned, on seven hits.

Orioles 4, Red Sox 0  
Storm Davis and Don Aase teamed on a three-hitter and John Shelby singled three times and drove in three runs as Baltimore won in Boston.

Davis, 6-7, yielded a first-inning single to Bill Buckner but did not allow another hit until Dwight Evans and Rich Gedman singled in the eighth. Aase got the final four outs for his major league-leading 18th save.

Shelby singled and scored in the third inning, had an RBI single in the fifth and added a two-run single in the ninth.

The Orioles had lost eight of their last 10 games. Baltimore's Cal Ripken went 0-for-4 and ended his 17-game hitting streak.

Brewers 5, Tigers 4  
Mike Felder singled with two outs and the bases loaded in the bottom of the ninth inning, breaking a 4-4 tie and lifting Milwaukee over Detroit.

Felder's single to right came off Willie Hernandez, the Tigers' third pitcher of the inning. The Brewers loaded the bases on one walk by Dave LaPoint, 2-6, and two more by John Pacella.

Dave Bergman hit a two-run homer in the top of the eighth that gave visiting Detroit a 4-2 lead, but Cecil Cooper's two-run single tied the score in the bottom of the eighth.

Royals 7, Angels 4  
Steve Balboni hit his 14th home run of the season, a three-run shot in the fourth inning that sent Kansas City over California.

The Royals broke a three-game losing streak and ended the Angels' five-game winning string.

Rookie Scott Bankhead, 3-0, gave up five hits in seven-plus innings. Bud Black yielded an RBI single to Reggie Jackson in the eighth that

made it 5-4 before Dan Quisenberry got the last four outs for his eighth save.

Frank White hit a run-scoring single in the second and Balboni homered on next pitch by Mike Witt, 8-5, for a 4-2 lead.

George Brett doubled in the sixth and scored on White's triple, his 1,500th major-league hit.

Padres 5, Dodgers 4  
Tim Flannery hit a tie-breaking home run with two out in the top of the ninth inning off reliever Tom Niedenfuer, the ninth homer allowed by Niedenfuer in 43 innings.

Craig Lefferts allowed two hits over the final 3 2-3 innings to get the victory.

The Padres, who erased a 5-0 deficit Saturday night, came from behind 4-0 this time, tying the game in the eighth inning when Graig Nettles singled with two out and Garry Templeton's single scored pinch-runner Bip Roberts, who had stolen second.

The game marked the debut of Los Angeles shortstop Craig Shipley, the first Australian-born

player to appear in a major-league game. The 22-year-old switch-hitter, a native of Parramatta, New South Wales, drove in a run with a second-inning grounder, singled, fouled out and lined out. In the field, Shipley did not have a chance during the game.

"It's a big moment for me," Shipley said. "It's something I've been working for for a long time now. I hope it can pave the way for some other players."

Shipley took up the sport as a seven-year-old under the encouragement of his father, who played for a team in Sydney. He came to the United States in 1982 and played three seasons at the University of Alabama.

## NFL-USFL trial heats up with Trump testimony

NEW YORK (AP) — Donald Trump, the man whom the NFL portrays as the mastermind behind the USFL's \$1.5 billion anti-trust suit against it, testified today that NFL Commissioner Pete Rozelle dangled an NFL franchise before him and urged him not to file suit.

Trump, the owner of the USFL's New Jersey Generals, said the offer took place in March, 1984 in a meeting with Rozelle at the Pierre Hotel in New York. That was at a time when Trump was urging USFL owners to move to the fall, a course they finally adopted five months later.

"He (Rozelle) said it was going to be doomed to failure," Trump testified. "That there weren't enough people who watched football in the spring. He said that if the league moved to fall it would also fail because he controlled the networks. He said, 'There is no way possible you'll ever get a TV contract in the fall.'"

Trump said that after he bought the Generals in the fall of 1983, "it was like I had the plague," as far as the relationship with Rozelle went.

However, Trump said he en-

countered Rozelle at a function in March, 1984 and the commissioner suggested they get together privately. They did, at a suite at the Pierre that Trump said he rented.

"Mr. Rozelle stated that the NFL was going to be around for a long time," Trump said of that meeting. "That I will have a very good chance of an NFL franchise whether it will be the Generals or another NFL team and that what Mr. Rozelle wanted was for us to stay in the spring and not bring a lawsuit."

Rozelle had earlier testified that the meeting took place, although he said he had not offered Trump an NFL franchise. He declined comment because he said he would be recalled to the stand later.

During cross-examination, NFL lawyer Frank Rothman introduced several documents showing that Trump had urged USFL owners to switch to the fall as the only way to effect a merger.

He also asked Trump about an NFL meeting at New York's Grand Hyatt Hotel. Trump is the owner of that hotel.
