## Students at Silver Learn Saving Early

Silver school children learn early the value of saving their money.

In fact, the kids at Silver are so diligent about savings that the City National Bank here has set up a special division in its savings department, known as "Silver School Savings."

The division includes 109 accounts with children from six years old to high school age.

Since the first Silver account was started in October, 1955 under the sponsorship of the Silver P.T.A., the Silver Savings division has grown steadily until today its deposits

have over \$4,750 in the City National Bank.

Mrs. Fred Theis, a member of the Silver P.T.A., brings the money to Colorado City each week for deposit.

The bank pays three percent interest on all accounts over \$5.

Since the Silver Savings began, a number of students have graduated from school at Silver and are now attending high school in either Colorado City or Robert Lee.

Many of them will be able to finance a sizeable portion of their college educations with the money which they have systematically saved through Silver School Savings.

The largest account in the division at present is for a little more than \$500, but many others hold between \$100 and \$200.

Collection of the weekly deposits are made through the school, with each class handling its own money.

At the end of the week, the money is picked up by Mrs. Theis and brought to Colorado City.

She says that a few depositors have closed their accounts since the school savings plan was begun, but that most of the students have not only maintained their accounts, but have added to them at regular intervals.

### ARMED ROBBERY SUSPECT FREED

A young, sharply dressed suspect in the \$3,369 armed robbery of an Abilene Safeway Store was freed by Abilene officers late Friday after questioning which lasted more than 24 hours.

The man, apparently in his early 20's, was arrested on suspicion by Colorado City police Wednesday night.

He told authorities that he had hitchhiked from Abilene, leaving there about 10 p. m. Wednesday. He had taken a room at a local hotel after arriving here.

He was quoted by police as saying he was looking for a job.

The suspect was returned to Abilene by detectives Thursday afternoon and was held there while a check was made with the Federal Bureau of Investigation. The man was believed to be an Army deserter, but the FBI failed to confirm this.

Also released after being held on suspicion by Abilene police was an Odessa man, also picked up Thursday.

The show is scheduled in conjunction with the 21st annual World's Championship Rodeo and the second annual International Range Bull Sale.

"Enclosed is \$5 to pay for two sweaters I took from your store without paying. 'I recently gave my heart to God and sincerely hope you forgive me.' Both envelopes were postmarked Colorado City. Neither letter was signed.

### Two Jailed Following Confessions

A wave of burglaries which began here Sunday continued this week and two Colorado City youths were jailed after admitting taking parts in two burglaries.

A 26-year-old local man was also arrested Thursday in connection with the theft of a tire from a service station.

A third youth was arrested by city police Thursday afternoon. Officers said he signed a statement admitting a part in two burglaries and three attempted break-ins within the last week.

Charges against the youths were pending in the Thursday night burglaries of Carey Lumber and Supply Co. on W. Second St. and Hutchinson Elementary School.

Both youths signed statements admitting the two burglaries. Police Chief Leon Yeager said Saturday. Both are 15.

The third youth is 16. One of the pair, previously involved in burglaries in Colorado City and Sweetwater, has already been declared a juvenile offender. The other also has previously been before the county court but was released with a warning.

The two Thursday night break-ins brought the week's burglary total to four, police said.

A janitor at Colorado High School, Albert Lee Jones Jr., had previously pleaded guilty to burglarizing a class room and the principal's office at the school last Sunday night.

Unidentified burglars also entered the Texaco Warehouse on E. First St. Wednesday night. They had not been apprehended Saturday.

The Thursday night burglaries reportedly took place around midnight.

The youths admitted removing a hamp from an outside floor to enter the lumber company building. They gained entrance to an interior office through a window.

An electric drill valued at approximately \$40, a number of other tools and coins from a gum machine were taken, police said.

At Hutchinson School, the two youths entered the building through a window on the east side, knocked the knob off the cafeteria door with a wrench picked up inside the building and also knocked the knob off the door to the principal's office, but could not open the door.

A number of miscellaneous items were taken from the cafeteria.

One was arrested by police at 9:30 a. m. Friday and the other was picked up two hours later.

Yeager said that officers spotted the youths' 1950 model Plymouth parked near the school shortly after midnight Thursday and took the auto's license number.

This tip led to their quick arrest.

After questioning, the pair took police to the spot where they had hidden the stolen articles. The articles were concealed in a pasture south of the city.

The youths remained in custody Saturday pending further investigation by police according to County Attorney Frank Ginzler.

## Peak Attendance Due for School

Peak attendance is expected Sunday night for the interdenominational school of Christian Living, sponsored by nine churches at First Methodist Church.

### County Bond Sales Total \$231,350

Mitchell County ended 1957 with a total of \$231,350 in U.S. Savings Bond sales, it was revealed Saturday.

The county concluded the year in third place in District 14 of the El Paso Area in both total sales and percentage of 1957 goal reached.

Percentage-wise, the county ranked behind Andrews and Gaines Counties with 75.4 percent of its 1957 goal.

In total sales, Mitchell County was second only to Scurry County with \$365,445 in sales and Howard County with \$628,724 in sales.

Mitchell County ranked eighth in the entire 34-county El Paso Area in total sales, according to J. C. Pritchett, local Savings Bond chairman.

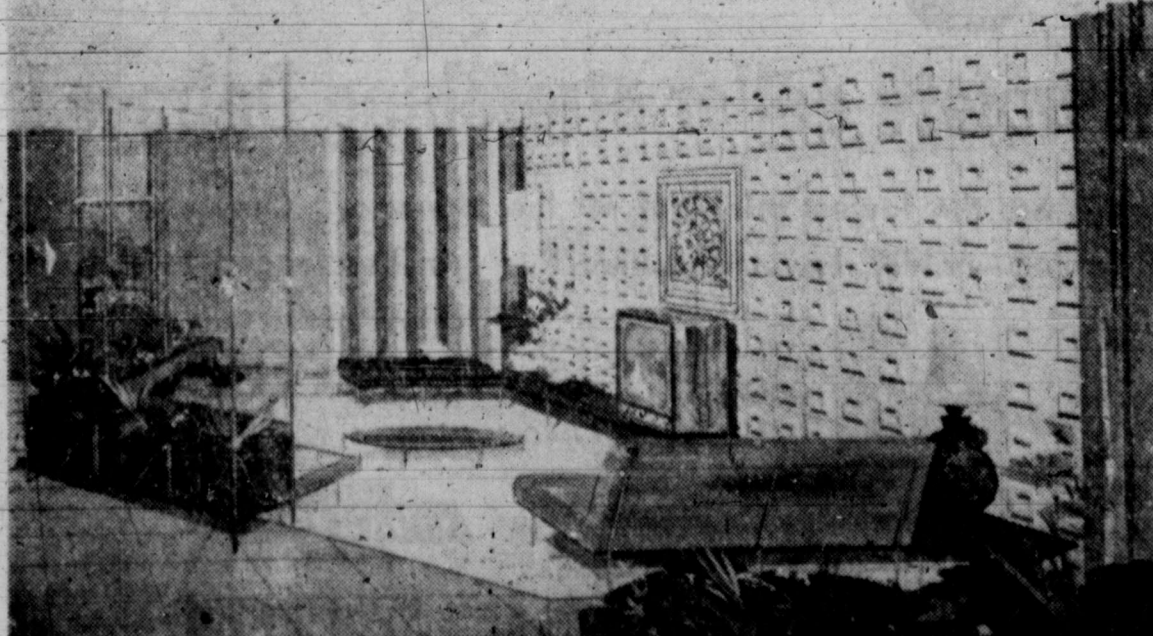
### New Location In Mitchell

One new location was announced in Mitchell County this week and a Pennsylvania wildcat drilled below 4,200 feet in the county.

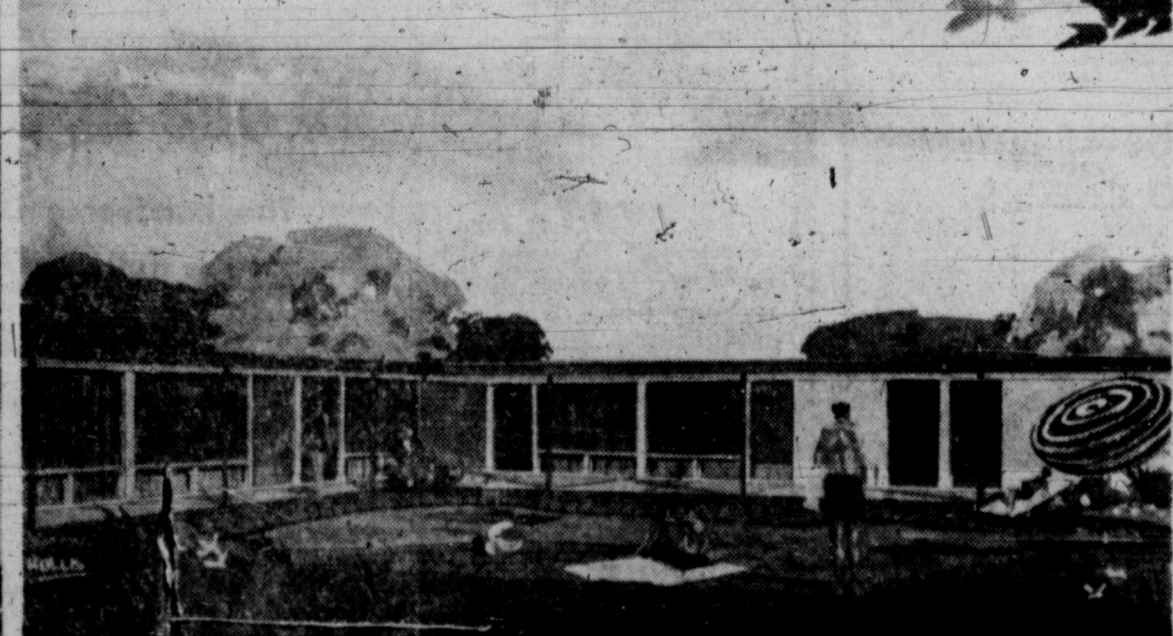
D. G. Gordon No. 2-D Strain is located in the Dockery (Clear Fork) field two miles south of Westbrook.

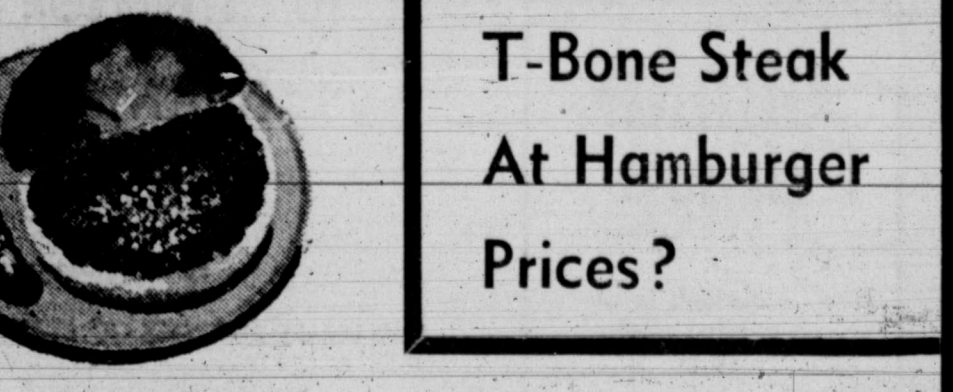

A crippled and listless Colorado High basketball team dropped its third consecutive District 3AAA game Friday night as the Snyder Tigers whipped to a 56-40 win over the Wolves.

Largest crowd of the season jammed the new C-City Gym. The Wolves didn't even resemble the team that displayed drive and aggressiveness in prior contests.

Richard Compton, Colorado City's leading scorer, was hampered by a finger rip, although he led the Wolves with 14 points. The senior guard didn't enter the game until the middle of the second quarter.

Marion Flippin, C-City's 6-6 center, was hurt on the tip-off beginning the second quarter and didn't re-enter the game until the last half.

But with Compton and Flippin in top shape, the Wolves probably wouldn't have been able to sidetrack the terrific Tigers who are now tied for the District lead with 20 record now.

Snyder's superior height, with three men in the lineup over 6-3, was a decisive factor. Wolves had numerous shots blocked with Snyder controlling both backboards.

The first quarter was a dismal affair with neither team able to find the basket. Barton, Smith with a two-pointer and Don Black with a free toss pushed the Wolves into a 3-0 lead.

Leon Reed, the Tigers' bulky 6-3 forward, slipped in a crisp shot early in the second quarter to send Snyder ahead, 6-5, and the Tigers were ahead to stay.

Hinojos hit three fast shots and Bill Phillips, Snyder's rugged center, rammed in two buckets to give the Tigers a 16-10 lead.

Compton came in to score five points but the Tigers' 10-point lead was too much to overcome as they led 27-17 at halftime.

Wolves held their own with Snyder in the third quarter, but were never able to gain any ground.

Ward, Phillips and Hinojos did the damage for Snyder during that third period while Compton's six points and Richardson's five kept the Wolves going.

With a 12-point lead, 44-32, going into the fourth quarter, the Tigers began to freeze the ball.
