SLAYING OF TWO BORGER OFFICERS
FOLLOWS ROBBERY OF PAMPA BANKTOTAL OF BOND
ISSUED IS SET
BY COMMISSIONCITIZENS WILL VOTE ON
MAY 3 ON \$65,000 RE-
FINANCE PLAN

The citizenship of Lubbock will have an opportunity to vote on a bond issue of approximately \$65,000 on Tuesday, May 3, to refinance all outstanding warrant indebtedness of the city government, with the sale of the issue already contracted for at an interest rate of five per cent on accrued par value when delivered, contingent on the success of the election. It was learned in official circles today.

The order for the election was passed Thursday afternoon following acceptance of the bid of two bond houses, but the amount of the issue was not decided upon until today. The \$65,000 asked for by the City Commission will take up all warrant indebtedness now outstanding which officials believe can be delivered in a reasonable time, and will cut the rate of interest from six and seven per cent on warrants to five per cent on bonds, saving the city at least \$6,500 annually the life of the warrants.

Successful Bidders Listed
J. E. W. Thomas, of the Morris Trust company, Chicago, and J. T. Moss, of the W. L. Stanton company, Toledo, were the successful bidders in a joint bid submitted at the auction sale of the issue Thursday afternoon. The bidders today posted with the commission a certified check for \$1,500 as an evidence of faith, and the contract was drawn up and signed. Their bid was five per cent flat interest, and they agreed to take over all warrants issued by the city which can be delivered.

A few of the warrants do not contain the optional recall clause that permits them to be re-financed with a bond issue, but these are very few, and warrant indebtedness will be funded by the bonds, if voted, nearly 100 per cent. The election was called in an effort of the commission to bring the city's financial affairs to a sounder business basis, and to reduce interest rate that is now being paid. It is purely a funding proposition, whereby the entire warrant indebtedness is taken up by bonds at a much lower rate of interest.

The commission also ordered issuance of a funding warrant to take care of and combine several small issues of warrants totalling approximately \$25,000 into one warrant to simplify proceedings in the refinancing program. This affects all miscellaneous warrants issued in payment of tract of land, etc., for the municipal park.

STORMS SWEEP OVER MIDWEST
EXACTING TOLL OF SIX LIVES

KANSAS CITY, April 1.—Thunderstorms of cloudburst proportions and swollen streams had taken a toll of six lives and caused heavy property damage in Central Missouri, Northern Oklahoma and Southeastern Kansas as farmers left lowlands today on reports of new flood dangers.

The floods followed heavy rain throughout the southwest Wednesday and yesterday. Wars, Missouri, reported 2.6 of rain within 48 hours while precipitation at some Kansas points reached 2.5 inches.

Ray Bunch, 22, of Fairfax, Oklahoma, was drowned yesterday when his motor boat tipped in Salt creek. Lee Russell, 7, drowned when he fell from a bridge over the Washita river, near Mountainview. Ivan Fry, railroad employee, drowned near Baxter, Kansas.

Three Killed by Lightning
Three persons were killed by lightning. Joe Burroughs, 45, supervisor of the Gypsy Oil farm near Davenport, Oklahoma, was struck as he entered his office. The building burned before his body was recovered. Elvis Trusty, 17, Muskogee, Oklahoma, was killed while leading a mule from the barnyard. Leslie Jones, 17, Springfield, Mo., senior, was the third victim.

R. D. Bryan, of San Antonio, arrived here late Thursday evening to assume his duties as office deputy of the division engineer of the State Highway Department of division five, supervising J. D. Hilton, who has been here in that capacity for nearly two years. Mr. Hilton was notified of the appointment of his successor late Thursday, and Mr. Bryan assumed his duties today.

Bryan, who formerly lived in Smith county, has been in San Antonio during the past few months except for a short time spent in Big Spring before the division office there was closed recently under instructions of the state commission. Pettus Hemphill, who is to succeed Geo. A. Field as division engineer, is expected to arrive here late today, and announcement of the personnel of the division probably will be made Saturday.

FARMERS TO BE
OFFERED SHORT
COURSE SCHOOLAPRIL 4 TO 9 SET HERE
AS DATES FOR A. & M.
INSTRUCTION

An agricultural short course, sponsored by the extension department of the Texas A. and M. college and the Farm Bureau, through the county agent's office here, will be held in this county April 4 to 9 inclusive. It was announced today by D. F. Eaton, county agent, at a meeting of the Southwest Ward, Barton, Carlisle, Hardy and the Northwest Ward will entertain meetings during the course.

The program for the week will touch practically all phases of the farm program, the subjects to be handled by well known speakers, including A. H. Leddigh, dean of the school of agriculture of the Tech college; J. D. Coughlin of the farm bureau; Mrs. Phoebe K. Warner, well known writer on topics of wide interest to farmers and their wives; W. L. Stangel, head of the animal husbandry department of the Tech college; Ray C. Mowery, of the college; Don L. Jones, superintendent of the experiment station here, and speakers on education subjects at the various places, who are yet to be announced, including Dr. J. C. Granberry of the Tech college.

The program as outlined to date follows:
Monday night—At Possey, with A. H. Leddigh and J. D. Coughlin to discuss pure seed varieties and marketing of farm products, respectively, and Don L. Jones to discuss farm management.
Tuesday night—Southwest ward, featuring Dean Leddigh and Mrs. Phoebe K. Warner, one of the best known women writers in the state on farm problems.

Wednesday night—Barton, with addresses by W. L. Stangel, who will talk on improvement of dairy herds, and J. D. Coughlin on marketing, with Mr. Jones talking on farm management.

Thursday night—Carlisle, featuring Dean Leddigh, Mr. Stangel and Mr. Coughlin on subjects mentioned above, and talk by Ray C. Mowery on poultry production.

Friday—Hardy, where a double session of the course will be held, including dinner on the ground at noon and an afternoon meeting. The day and night program will include addresses by Don L. Jones, Dean Leddigh, Mr. Coughlin and Mr. Stangel, in addition to an agricultural program to be offered by the Lubbock Kiwanis club, as one of its weekly farm co-operative features.

The Kiwanis program has not yet been announced. Dr. J. C. Granberry of the Tech, probably will talk on education.

Saturday night—Northwest ward, when a community program will be given. Mr. Coughlin also will deliver an address on marketing.

The program was designed as an educational feature, with farmers and business men alike invited and urged to attend.

May Order Other
Marines To China

WASHINGTON, April 1 (AP)—Orders have been prepared for the dispatch of two more battalions of marines to San Diego, to be held in readiness for service in China. If made effective, the orders would call for the collection of the force of between 800 and 900 from marine bases at Quantico, Va., Norfolk and other Atlantic coast points. They would be held at the California port until needed to reinforce American detachments already landed at Shanghai to protect American lives.

The fifth regiment of marines at Shanghai, and the sixth regiment now enroute to San Diego for embarkation, each are one battalion short of full strength. The two additional battalions, if sent to China would fill the vacancies in these organizations.

MEXICAN KILLS
WIFE; IS SLAINHidalgo County Officers Are
Forced To Shoot Man As
He Resists Arrest

BROWNSVILLE, Texas, Apr. 1.—Florida Canales, age 29, was shot and killed early this morning by a posse of Hidalgo county officers, while resisting arrest upon the charge of wife murder. His wife, age about 27, was found in her home at Weslaco, in a welter of blood, her throat slashed with a razor.

Officers who went to arrest Canales found him covered with blood and gory rags in his hand. Waving his weapon he charged the posse, and was killed by their bullets.

Wife Made Complaint
Canales' wife, who had four children by a former marriage, made a complaint several weeks ago that Canales had threatened to kill her. He was arrested and placed in the Weslaco jail, from which he made his escape the following night. He again appeared at his home and attempted to attack his wife and was again placed under arrest. He was taken to the jail at Donna, but again succeeded in breaking out immediately after his escape he went to his home at Weslaco, and attacked his wife killing her after a furious struggle.

Neighbors Frightened
Frightened neighbors apprised the officers of the tragedy, and a posse immediately formed to capture the man who is believed to have been demented. Canales was found in his home, slashes on his throat indicating that he had either attempted to take his own life or had been cut in the struggle with his wife. As soon as he saw the officers he charged them, waving his gory weapon, but went down before a fusillade of bullets.

Mullican May Not
Recover For Court

Col. Clark M. Mullican, judge of the newly created 99th district court here, who has been ill at his home here for nearly two weeks, was feeling some better today, and was able to be up a part of the day. It was announced at his home that he has had considerable temperature for several days, suffering with what doctors diagnosed as bronchial pneumonia, and was not clear of fever today.

It was said that he probably will not be able to preside over his court when it opens Monday, and up announcement has yet been made as to whether or not the court will go on by electing a special judge. Due to the fact that the court is opening its initial term, it is considered probable that a delay of a few days in its opening will be occasioned. If Judge Mullican is not able to take the bench.

HENRY FORD TAKEN TO HOME
BUT IS YET FAR FROM WELL

(By Associated Press)
DETROIT, April 1.—Henry Ford, injured in an automobile accident last Sunday evening, was taken back to his Dearborn estate from the Henry Ford hospital last night. It became known today.

The same secrecy that surrounded Mr. Ford's admittance to the hospital last Tuesday, 48 hours after the accident, attended the return to his estate, where his small coupe was forced from the road by a heavier machine.

Officials Prepare Statement
While the officers of the Ford organization were reported to be preparing an official statement, they declined at first to confirm or deny that

the injured motor king had left the hospital.

The removal from the hospital was made shortly before 9 o'clock last night. Mr. Ford, it was understood, was chafing under hospital restraint, and with the approval of Dr. R. D. McClure, chief surgeon of Mr. Ford's hospital, the ten minute journey back to Dearborn was undertaken.

In giving his approval of the return to Dearborn, Dr. McClure said the injured man could be treated as well at his home as he could at the hospital. Only time is now needed, Dr. McClure said, to complete full recovery.

He added, however, that Mr. Ford would have to "lie flat on his back."

POLICE BEGIN
HUNT FOR MEN
IN BANK CASEMATHEW KIMES, WHITEY
WALKER, RAY TERRELL
ARE SOUGHT

(By Associated Press)
BORGER, Texas, April 1.—Officers at Pampa began a search this morning for Whitey Walker wanted at Borger in connection with the killing of Deputy Sheriff Kenyon and Terry here this morning and Ray Terrell and Matthew Kimes. Terrell and Walker are believed to be the men who robbed the First National bank at Pampa of \$25,000 in a daylight hold up yesterday afternoon. All three men have been identified by photographs by bank officials who were witnesses to the holdup. None of the men wore masks.

Three Suspects Released
Three men held at Wheeler were released this morning when Pampa officers said they were not the men wanted and did not answer to descriptions.

According to a telephone conversation with the Pampa Daily News early this morning the bandits hid all day yesterday at the Archer farm between Pampa and Borger. The men drove into the farm with a black and blue sedan which they drove into the Archer garage and looked. They then went to the farm house and held W. E. Archer and sister at bay all day with pistols. Toward sundown they ordered the pair into a closet locked them in and drove off toward Borger.

Five Men In Robbery
Five men were involved in the robbery. Of these all unmasked, three are said to have been identified by bank officials from photographs as Matthew Kimes and Ray Terrell, notorious Oklahoma outlaws, and Whitey Walker.

Two men, Hugh Walker and Ed Bailey are held on charges of having killed Deputy Sheriff Kenyon and Terry at 3:15 this morning when, apparently from the position of the officers' car, the officers swung their automobile across the road to block the pursuing car and sprang out of their own machine. They were evidently killed at once, neither officer firing a shot.

Whitey Walker is also sought in this connection.

While no definite connection has been established by officers between the killing and the robbery, the theory is advanced that the officers may have been trying to make arrests in connection with the robbery and were shot down by men who could not afford to fall in the hands of the law.

Police Have Clue
Walker and Bailey were arrested at their home in Borger. Police said they considered they had a good clue from a pistol found lying near the two dead men. A pistol bearing two notches on the handle was found lying near Terry. Officers said this gun had been borrowed yesterday. A pearl handled pistol was recovered by officers, and Sheriff Owensby identified it as one of

Four members of the board are elected one year, and three the following year. R. T. Poffney, P. C. McCoy and J. R. Hearrell will be election judges. Polls will be open in the police court room at the city hall between 8 a. m. and 6 p. m.

No Arrests Made In
Liquor Haul So Far

No arrests had been made early this afternoon in connection with the seizure here late Thursday by city officers of approximately 40 gallons of "corn whiskey" during a raid on a downtown storage room. A Chevrolet touring car also was taken in the raid, and is now in custody of county officers.

The liquid loot consisted of two barrels, said to contain about ten gallons each, 19 fruit jars and several other smaller containers. The loot now is in the custody of Sheriff H. L. Johnston pending further investigation of the case. Agents are expected soon. It was said. City policemen Williamson, Bundy and Layne made the seizure.

TWO ARE HELD
AFTER FINDING
BODIES OF MENHUGH WALKER, ED BAILEY
OUT ON MURDER BOND;
ARE DETAINED

BORGER, Texas, April 1.—Deputy Sheriff Pat Kenyon and A. L. Terry were shot to death on the road near Whittenburg, a few miles from here, early today. Hugh Walker and Ed Bailey, out on bond in connection with the recent killing of Policeman Coke Buchanan, were arrested.

WHITE WALKER CAPTURED

BORGER, Texas, Apr. 1.—Whitey Walker, wanted in connection with the slaying this morning of Officers Kenyon and Terry, and with the robbery yesterday of the First National bank at Pampa, was arrested about 11:30 a. m., by Borger police, hiding in the house of his brother, Hugh Walker, held in connection with the morning's killing.

The bodies of Kenyon and Terry were found near their automobile, which was standing in the highway. Two pistols were on the ground beside the dead men.

Kenyon was shot once through the chest and once through the back of the head. Terry was shot through the left cheek.

Were Hunting Walker
Officers are combing the country for Whitey Walker who was also out on bond in connection with Buchanan's killing which occurred two weeks ago.

The killing occurred about 3:15 a. m. according to a Whittenburg woman who was awakened by the shooting. She said she heard four voices as the slayers prepared to drive away. Henry Fields, driving a wedding party, discovered the automobile in the road and the bodies lying on the ground.

National League Prexy To Go To Court, He Says, To Make Rajah Sell Card Stock

NEW YORK, April 1. (AP)—President John A. Heydler, of the National League, will go to court, if necessary, to prevent Rogers Hornsby playing with the New York Giants, unless he sells his stock in the St. Louis Cardinals, he indicated last night.

Taking cognizance of published reports that Manager John McGraw intended to play Hornsby at second base, whether or not he dispensed of his holdings in the St. Louis club, Heydler reiterated his ruling that the erstwhile Cardinal pilot must have official connection with only one team.

He issued the following statement: "I believe my ruling in the Hornsby case is sound baseball law. This is, in effect, that Hornsby cannot play championship games with New York while holding one-eighth of the stock of the St. Louis club."

"I further believe that in this stand I will have the support of the board of directors of the National League, even to the extent of defending my position in a court of law."

The hero of the last world series, who won his two pitching assignments and saved the deciding game, thinks he is good for several years yet, barring injuries.

"Of course we can't figure very far ahead on account of the possibility of being hurt," he said in talking of his expectancy in baseball, "but if I am lucky enough to keep whole I ought to go on quite awhile yet."

"My legs are still good and my arm never gives me any trouble."

"The older pitchers have one big advantage over the youngsters. They know more about it. They ought to, for most of us learned in a hard school experience."

"It's a lot easier for me to pitch a ball game now than it was a good many years ago when I had more stuff than I have now. Then I had it and was proud of it. So I showed it to all the batters as they came up. Now it's different. I try to keep my control and throw the ball where I want it rather than where the batter wants it."

"We're on different sides of the question, and the best place for him would be just about the worst place for me, so I try to keep it out of there."

The most important asset a pitcher can have? Control, I think. It doesn't really do you much good to have a lot of stuff if you can't do anything with it.

"I enjoy baseball. I like the spring training period, and it feels good to find myself coming around. I can't help being confident that I will have."

MURDER JURY HEARS WIDOW

Woman Who Labored With Dead Man On Farm Sobs As She Tells Story

(By Associated Press)

MARSHALL, Texas, April 1.—The woman who worked with her husband on their farm in Upshur county several years, this morning went bravely on the witness stand as she told her

version of the slaying of her former mate.

Mrs. J. M. Hunt of Dallas, formerly Mrs. W. A. Harris, wife of the man whom Walter Davis is charged with slaying, was on the stand throughout Friday morning. She said that her husband had gone to weigh some cotton and a few minutes later she heard the report of the gun. Looking up, she said she saw Davis running away from the scene.

A vigorous attempt was made by the state to break down the alibi of the defense, who said that Davis was not within the vicinity of the shooting, claiming that he was picking cotton with his family at the time Harris was killed. From the testimony, it appeared as though Harris and Davis were adjacent.

Upshur county when a new trial was granted by the court of criminal appeals following the conviction of Davis in 1925.

Stocks And Money

WALL STREET REPORT

NEW YORK, April 1 (AP)—Stock prices turned reactionary at the opening of today's stock market when heavy selling broke out in the rail and oil shares. Weakness of the rails followed announcement of a decision by the Interstate Commerce commission holding that federal valuation of rail-

roads for rate making and other purposes should be based upon 1924 costs instead of replacement value. U. S. Steel common nevertheless opened higher at a new high record of 167 3/4.

Early declines in the rails ran from 4 to 2 1/2 points with Atchafalpa, Reading, Delaware and Hudson and Missouri Pacific preferred the hardest hit. Good buying support was quickly forthcoming as it was generally realized that a final determination of the rate question would be carried to the United States supreme court with no likelihood of a decrease for many months. Railroad officials point out that recent decisions of the highest tribunal in public utility rate cases seem to bear out their contentions which the Interstate Commerce Commission has declined to accept. Norfolk and Western, which has been climbing steadily upward since announcement that the Pennsylvania railroad has increased its holdings of that issue, crossed 182 to a record high and Jersey Central sold at the highest price in several years. Oils were adversely affected by the new financing required by several of the larger companies. Marland, Standard Oil of New Jersey and Union Oil of California sagging to new low levels for the year. Colorado Fuel was again heavily accumulated crossing 66 to the highest price in several years. Commercial Solvents B touched 300 for the first time. Establishment of a new high level since 1923 by Italian lire around 43-4 cents and a sharp rise in Spanish pesetas featured the foreign exchange market. Demand sterling ruled around 44.85 3-16 and French francs around 2.91 cents.

WALL STREET ACTIVE

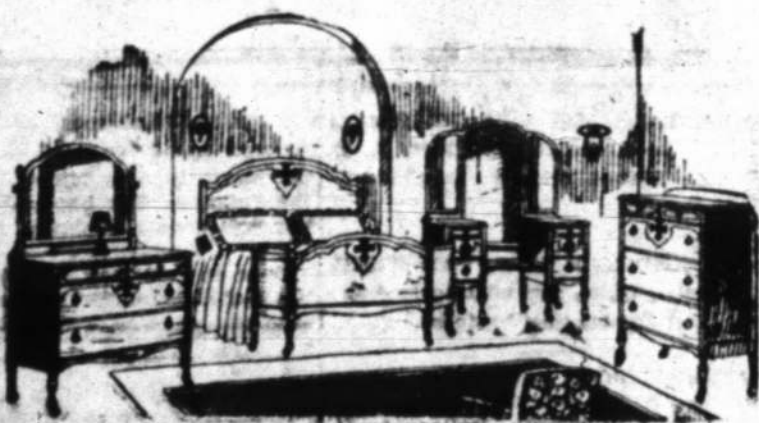

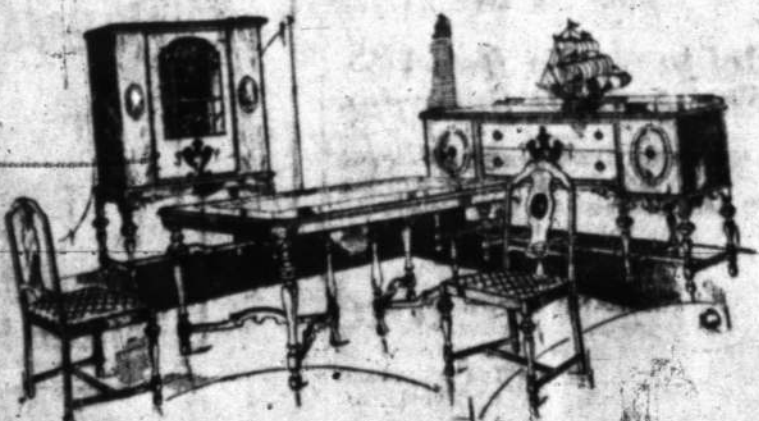

STATE DEPARTMENT PUTS DEAF EAR TO PLEA OF EXPLANATION

(By The Associated Press)
WASHINGTON, Apr. 1.—The American government is believed to be giving serious consideration to a policy of reparation for the reported outrages at Nanking and for the execution of prisoners for the safety of Americans elsewhere in China.

The state department today, however, maintained complete reticence on the subject and officials in other departments familiar with recent developments in China declined to throw any light on what might be going on.

British Reports Read
Press dispatches from London on

the other hand, intimated that exchanges were in progress between capitals of various powers involved in the Chinese situation. While conferences at the White House and state department late yesterday appeared to give foundation to the belief that the determination of one American policy is occupying the minds of officials. The statement says soldiers in nationalist uniforms committed the outrages at Nanking, has been emphasized in every dispatch forwarded to the capital from American representatives in China and reports from Shanghai have indicated this has been sworn to by Americans and other foreigners in the city at the time.

Both Chang, nationalist commander in chief, and Eugene Chen, nationalist

foreign minister, have expressed regret for the outrages and promised reparations provided it were established definitely that Cantonese were to blame. Apparently the next step for the United States is to build up through its own agencies a case that cannot be broken down.

British Report Denied
LONDON, Apr. 1. (P)—A spokesman for the British government today denied a story, printed prominently by several London newspapers, that the cabinet had decided to serve an ultimatum on the Cantonese demanding reparation for the number of British subjects at Nanking.

Downing street, however, is continuing its negotiations with Washington. Tokyo and Paris regarding the demands to be presented to the Cantonese for the Nanking outrages, and it is certain these demands will be presented shortly.

MINERS OUT AS ROW CONTINUES

Thousands Of Men Idle After Workers And Operators Fail To Agree

(By Associated Press)
CHICAGO, April 1.—The coal mining industry in the central competitive field today entered a curious phase which was neither a strike nor a lock-out but which forced thousands of miners into idleness and the Jacksonville wage agreement expired.

Many temporary agreements have been made throughout the mining area to continue work, but it was apparent that a large percentage of the nearly 200,000 men employed in the central field and adjacent fields had laid sick pick and shovel pending solution of a problem that the conference of miners and operators at Miami, Fla., several months ago failed to solve.

Shut Down Yet Question
Probably the full extent of the shut down will not be known until early next week, as organized fields observe April 1 as "eight hour day," marking the anniversary of the first eight hour day legislation for miners. Saturday is a half holiday and on Sunday mines are not operated, so that the actual counting of noses must go over until Monday.

Operators, who maintained that they could not continue the Jacksonville agreement and survive, estimated that approximately 150,000 coal diggers in Pennsylvania, Ohio, Indiana and Illinois had suspended work. In Iowa, which is outside the central field, about 9,000 miners were affected, while between 30,000 and 35,000 workers are employed in the southwestern area of Kansas, Missouri, Arkansas and Oklahoma, where wage agreements likewise expired.

Men Are Determined
Union men, equally determined that they cannot accept a wage cut, pointed to many individual agreements for temporary continuation of the Jacksonville pact.

The general public took the situation rather apathetically knowing that more coal was in storage today than ever before and that warm weather was approaching.

Union Loses One Mine
PITTSBURGH, Pa., Apr. 1. (P)—The Pittsburgh Terminal Coal corporation this afternoon announced that hereafter its mines in this district will be operated in a non-union basis.

Borger's History Laid

Policeman Coke Buchanan died with six bullets in his body in a battle with five men on Dixon Creek March 18, when he came to the aid of Officer Sam Williams. The other three officers, killed by pistol blows, were Ed Bailey and Whittier Walker, all charged in connection with the killing of Kenyon and Terry, were out on bond in connection with the Buchanan killing and Matthew Kimes and Ray Merrill, now in the hands of the law, sought in connection with the Pampa robbery yesterday are also suspected of complicity in the Buchanan affair.

Two Hijackers Killed
Officer Charles Hamby, former ranger, killed two hijackers here last night. Deputy Constable Charles Norton faces a charge of slaying a man in a local dance hall.

A number of dance hall and other killings, the slaying of a woman in a filling station robbery, hijackings, numerous, fatal explosions and one disastrous fire which threatened the existence of the town, go to make Borger's history a lurid one.

Men Known Here
Hugh Walker, held in Borger in connection with the murder of Sheriff Kenyon, was in the custody of Lubbock county officers here for some time in 1925 following his arrest and indictment by the grand jury on a liquor charge. His case was later dismissed when it developed that he was suffering with tuberculosis after discharge from the army and that his plea was to be that he wanted the liquor found on him for medicinal purposes.

"Whittier" Walker, wanted in connection with the murder and at Pampa in connection with the bank robbery yesterday, is believed to be a brother of Hugh, who while in Lubbock, went under the name of "Red" Walker. He was arrested here on a pro-law charge, and about 125 quarts of liquor taken from him, but his case also was dismissed when officers learned that he was a fugitive from justice from both Oklahoma and Texas. He was released following his arrest to penitentiary agents.

SAPIRO TELLS OF TEXAS FEE

Co-Op Chief Admits On Stand That He Received Large Sums For Labors

(By The Associated Press)
DETROIT, April 1.—Approximately \$20,000 was paid Aaron Sapiro for obtaining loans at Washington for co-operative farmers organizations, he testified today in his \$1,000,000 libel suit against Henry Ford.

The time he actually spent at the capital, appearing before the war finance corporation, Sapiro said was "several days" in the fall of 1921. He represented 13 cotton, wheat and tobacco associations.

After establishing the amounts collected by Sapiro who for 15 years has been organizing co-operative organizations, and the approximate time he spent in floating the loans, Senator James A. Reed, attorney for Ford, switched his cross-examination to the Mississippi Growers' association. The witness, who claims his reputation with the farmers was injured by articles in the Ford-owned Dearborn Independent, says his fees from that group for 1921-22-23, totaled \$12,750.

Texas Question Arises
Sapiro when questioned as to work with the Texas Cotton Growers' association, admitted he had demanded a \$2,000 fee and traveling expenses, New York to Dallas, to make speeches and explain contracts to the farmers.

The Ford attorney started his third day of cross-examination by going into the organization of the Texas farm bureau and cotton association. Sapiro testified there were bankers and heads of other agricultural associations, but no warehouse men that he could remember.

"You started in to get a million bales of cotton contracted for," said Reed.

"That was our goal," Sapiro said he had received no money for speeches explaining cotton contracts. That was considered part of his work. He admitted he related advantages he hoped would be realized by the association, and attempted to persuade farmers to join.

Sapiro identified an account of one of his speeches made in 1921 printed in the Texas Farm Bureau paper.

Reed quoted the article which quoted Sapiro as saying he was not interested primarily in money but wished to take the children of Texas out of the cotton fields, and put them in schools and to take the women from the fields and put them in their homes.

Sapiro, said the article, told of the success of co-operative organizations in California, where they had been in existence for 35 years.

Fees for work performed in Texas from 1921 until 1924 totaled approximately \$37,250, Sapiro testified.

Keeping One's Hair Isn't Such A Hard Task

BY DR. MORRIS FISHBEIN

Editor Journal of the American Medical Association and of Hygiene, the Health Magazine

If one wants to keep the hair as long as possible, he may take care of it in a relatively simple manner.

In some instances heredity or constitutional tendencies are such that the hair is bound to fall out. Investigations have shown that it not only disappears rapidly, but according to a definite pattern.

However, if such hereditary influences are not definite, simple care may be of service in promoting the hair's longevity. Persons living in the city may wash the hair once in two weeks, using a good untinted and unperfumed soap. After lathering the hair, rinse well with warm water, to make sure that all of the soap is removed from the hair and the scalp.

In drying the hair it is not necessary to rub vigorously, but rather to pat it with warm Turkish towels.

After the scalp has been dried a vigorous circulation of the blood may be induced by rubbing with the ends of the fingers, making certain that the nails do not scratch the scalp. If the scalp tends to be dry, a small amount of pure olive oil may be rubbed in, parting the hair and rubbing the oil into the scalp.

Dr. Herman Goodman gives excellent advice as to the type of comb and brush: "A wide-tooth comb is the only one to use. The space between the teeth of the comb should be oval so that the hair cannot be caught and pulled out. The brush should be only moderately stiff in the bristles and should be kept scrupulously clean. It should be washed every time the scalp is washed."

There is no real evidence that the wearing of a tight hat will cause the hair to fall out or that it will even stunt its growth. Dr. Goodman suggests that the conditions associated with wearing tight hats, such as city life, long hours and little open air exercise, have led to placing the blame on the tight hat.

"But suppose you bring your capital to New York. As you say, you are smart. You may, and likely will, lose every cent you've got. On the other hand, you may invest it in something good and find yourself making quick money."

"You may be able to live on Park Avenue and pay fifteen thousand dollars a year rent. You may be able to run a fifteen thousand dollar car, chauffeur and all. You may be able to buy your wife pearls and diamonds."

"But what are you? Except for a few friends and a very few, you'll have no more identity than a gum drop in a candy store. You'll lose human contacts and real living to a great degree. The elevator boy in a big apartment hotel is probably having more real life than the man he is opening doors for. Ask almost any one of the men you envy—say over fifty—about his life here and seven times out of ten he'll begin to talk about the old home town and the people he used to know—yes, the little red school house, too."

"No, I don't suppose they'd go back. Life does that to us. We choose a path and we must follow. But lose that feeling of utility! It's the most foolish thing in the world and the most wrong. You're a great deal more important as you are where you are than if you were a multi-millionaire here—dear, dear—something about preferring to be the mayor of a small town rather than the second man in Rome. Now go to sleep on that."

"Wasn't he right? Now that the world has discovered how the other half lives, don't we all have that feeling of utility at times when we compare our lot with others? And isn't it wrong? I'm a great believer in compensations of environment."

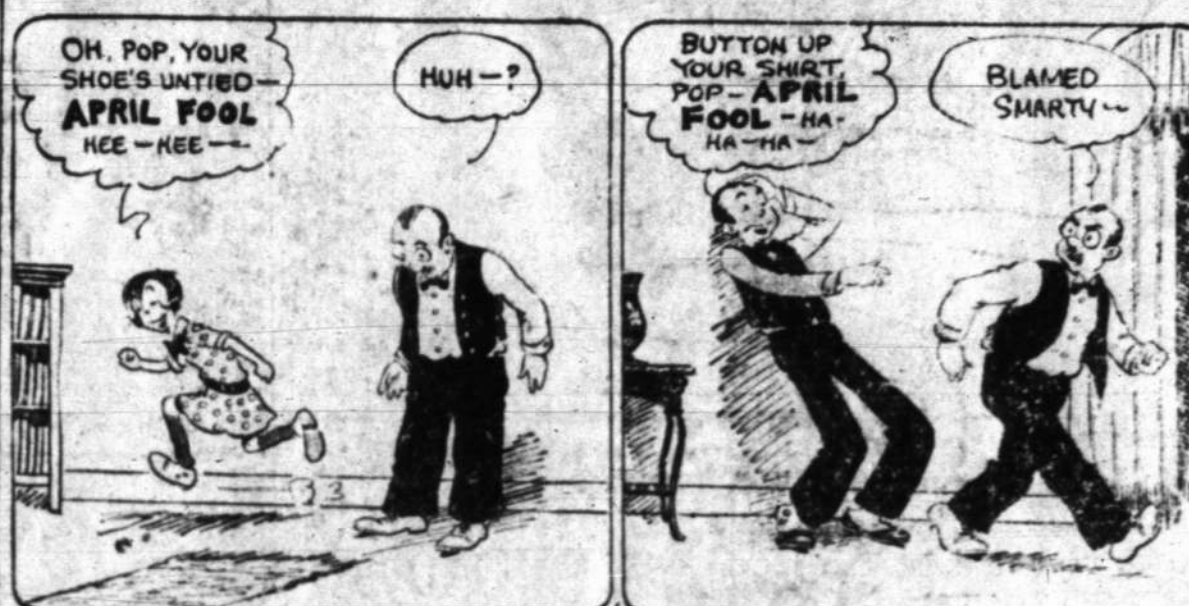

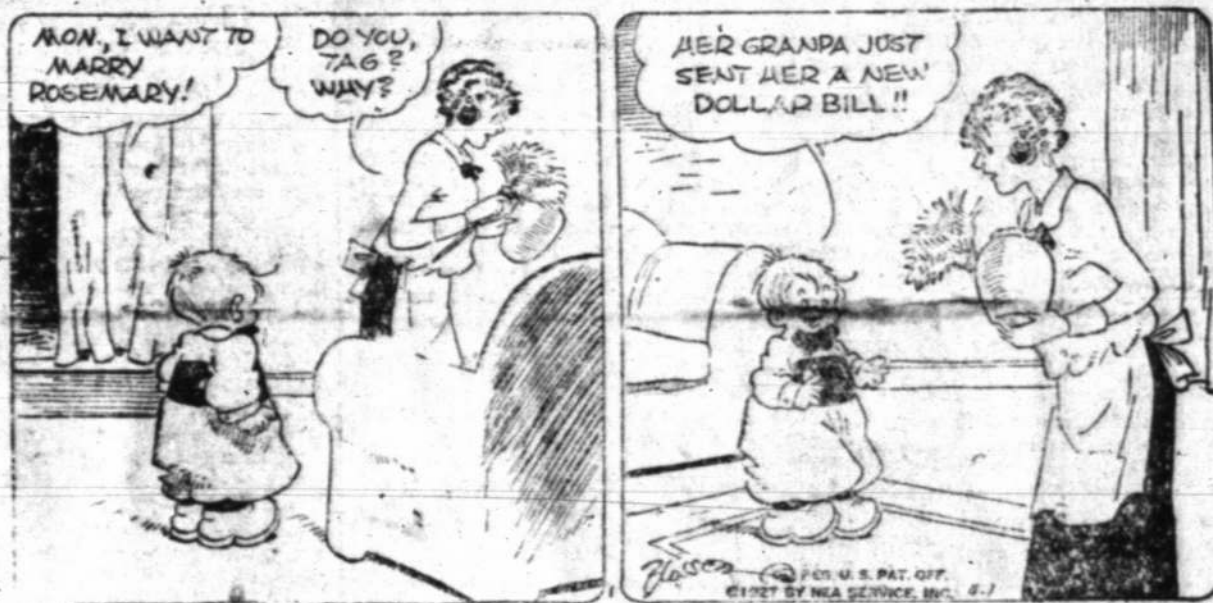

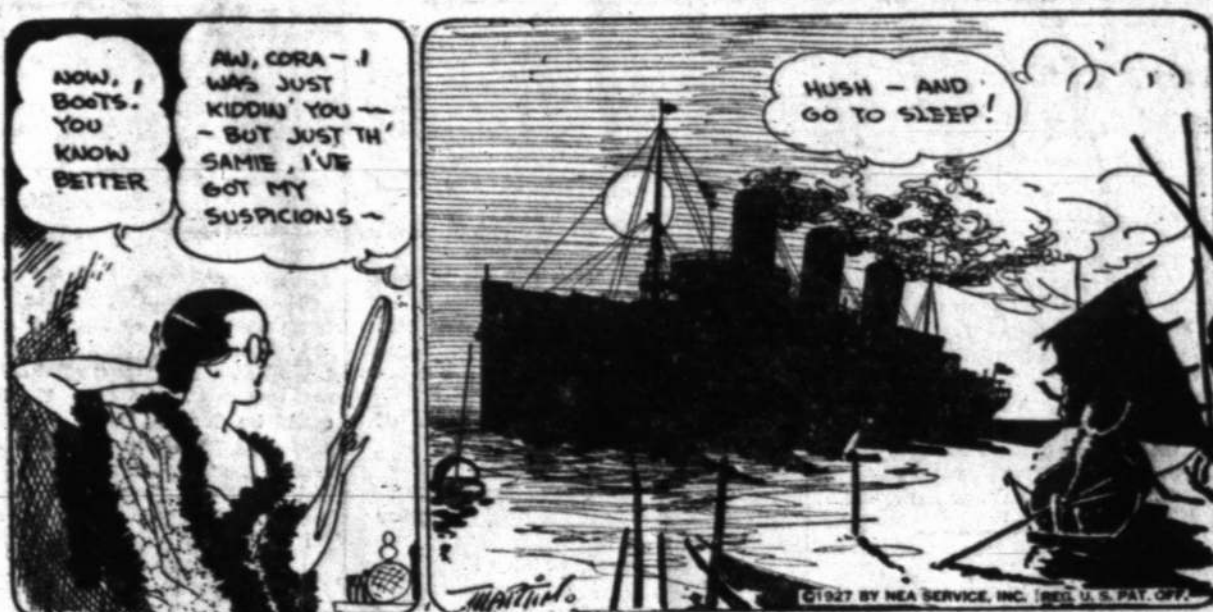

Editorials

Wonderful Machines

Clarence Darrow is a man who has
a large slice of our admiration. Yet
when he says, as he did in a debate
at Houston the other night, that man
is apparently only a machine, we are
impelled to voice our sharp disapprobation.

That conclusion of course is not
that Darrow delights in a number
of the wrinkles and lines on that face
of his were per se, doubt is not
by his zealous meditations on man
and his destiny. But, to Darrow, there
is no escape mechanism is the ex-
plaining principle of all life.

There is no way of definitely pro-
ving, in black and white, mathematical
exactitude, that this mechanistic the-
ory is wrong. But in the heart of
nearly every man there must rise up
an instinctive protest against it.

Are we machines? We do not be-
lieve we are, but if it be true, even
Darrow must admit that we are the
most cunningly devised machines that
ever graced this or any other planet.

For look you, while we machines
believe in some ways as all other
machines believe, needing fuel, repair,
and rest, and even wearing out when
worked too hard—we respond to some
very intangible stimuli. It is not
ed by things that move our per-
ceptions in existence; we have control-
ling buttons and levers that can be
pressed only by unseen hands; in-
deed, we generate our own commands
far down inside.

A little bit of colored cloth, with
stars in one corner and red and white
stripes across its breadth, has moved
myriads of these machines to face
death; abstract words like justice and
freedom have caused others to under-
take all kinds of hardships and self-
denials; such things as love and hate
have been mighty forces, more power-
ful than hunger or weariness or fear
or cold.

Furthermore, some of these ma-
chines have done very subtle and deli-
cate work. One of them wrote the
"Ereos" symphony, another designed
St. Peter's, another wrote "Leaves of
Grass"—a deed that, some think, if you
think you're a soulless machine, an-
other point of the Starline Madonna.

Machines like these are machines
of a transcendental kind. They are
not machines in the ordinary sense of
the word, and all the scientists in the
world cannot prove that they are.
They are woven out of finer stuff than
any of us have dreamed of, and the blind
body that is an integral part of them
was not put there without a reason.

Indispensable Pants

THE PLAINSMAN

Says:

Members of the appropriations com-
mittee of the House of Representatives,
who recently visited here, seemed to
be 100 percent in favor of the passage
of the tobacco tax—a bill which, af-
ter a hectic struggle, passed the house
and was stopped in the senate. Hon.
Claudio Teer, of Granger, chairman of
the committee explained the shortage
of necessary funds for the expansion
and the upkeep of Texas colleges and
in urging the institution of additional
funds through taxation, praised highly
the tobacco tax. His talk was seconded
by Hon. Lee Satterwhite, Amarillo,
and Hon. Arthur Steele, of El Paso. The
bill will come up again for further at-
tention in the special session which
Governor Dan Moody will call the lat-
ter part of April or the first of May.

In his talk on the subject Mr. Teer
told of the lobbying which was done
in the house and senate by the tobacco
manufacturers, characterizing it as
the "most determined and widespread
lobby" in his experience. He said that
for some reason the press of the state
had also fought the bill but that the
reason was unexplained to him. The
Plainsman, along with other writers
of Texas, opposed the passage of the
tobacco tax bill as it stands now, for
this reason: He believes that the tax
is unfair in that it reaches only one
class of luxuries. The Plainsman takes
this attitude: why single out tobacco
as a luxury? Why not make the tax
a general luxury tax? Why not make
it cover cosmetics, candy, chewing gum
and similar luxuries? Surely the addi-
tion of these other products to the
tax list would reach a greater per-
centage of the population and at the same
time bring in more money.

If the tobacco-tax bill is the only
available way to increase the funds for
the carrying on of education in Texas,
then the Plainsman favors its passage.
He believes that the great state of
Texas should care for its elementary
institutions, its public schools and its
institutions of higher learning in such
a manner that they can keep step with
the progress of the Lone Star state,
without an addition to the ad valorem
tax. However, if possible, out of fair-
ness it should like to see the tax made
a general one rather than a tax which
includes only one group of citizens—
namely those who use tobacco.

East Texas gets a big kick out of the
statement "The wind do blow in West
Texas and so do West Texas." We'll
admit the allegation with reservations.
It at least shows that there is some
similarity in West Texas and as to East
Texas—we'll leave that to your
own imagination.

WAR ON KIDNAPERS

The nation will watch with interest
the efforts of the officers of Cattan-
eog, Tennessee, to apprehend the
band of kidnapers that held the 2-
year-old daughter of the acting mayor
of the city until the sum of \$3,333.33
in cash was delivered to the abductors.
It has been a long time since kid-
napers flourished in any section of the
country, for such criminals spread so
much terror in the land that usually
there is little compunction about met-
ing out swift and drastic punishment
to them when they are apprehended.

The acting mayor of Chattanooga,
Tennessee, fearful for the fate of his daughter,
played a square game with the band
and did not try to seize the agent sent
to collect the ransom. With the little
daughter safe at home, however, nei-

entire country; for of all criminals the
kidnapers are about the most detestable.
Let the authorities track down the
guilty parties and then let the courts
of Tennessee do their best to strike
terror into the hearts of these malic-
ious and wicked terrorists.—Temple
Telegram.

Diversification is coming to be look-
ed upon as applying to cities as much
as to farms and a balanced city is now
declared to be of equal importance
with a balanced farming program.
Diversification has been the cry of the
farmers so long that even though just
as important now as ten or fifteen
years ago it is somewhat worn advice.
Cities have paid but little attention
to the diversification ideas and now
the question is being taken up serious-
ly in many parts of Texas. The Dallas
News carried a long editorial with dis-
play on page one, advocating industrial
growth for Texas. While the editorial
in fact favored no idea of central-
ization of industries in a few cities, the
Wichita Falls Times Tuesday com-
mended editorially diversification for
that city.

There are many cities in Texas
which depend entirely upon agricul-
ture and in the pinch of a bad year
for the farmers business suffers to a
great extent. Most of Texas "single
crop" cities depend upon the agricultural
territory surrounding them for sup-
port. But in this country there are
even large cities which depend upon
a single industry, and they flourish
and prosper when those industries are
active but are dull and depressed when
these are periods of inactivity.

"Diversification" must be held in
mind continually in shaping the growth
of Sherman. We now have support
not only from the rich agricultural
area surrounding the city but also
from three colleges and other schools
and railroad shops besides more than
fifty varied industries. One of the
healthiest signs of the industrial
growth of Sherman is in the variety
of the industries prospering here. And
the city will continue to grow when
she has a diversification of interests.—
Sherman Democrat.
