Ambulance Service Deadline Approaching Soon

Red River Ambulance Service is now selling memberships for six-month renewal. Those who are currently six-month subscribers, have until May 31, 1981 to renew. For those who are not members now is the time to subscribe, for immediate coverage is available.

Six-month memberships are offered to families for \$25 and to individuals for \$15. A member's mileage benefit is 75 miles. This means that a member receives the first 75 miles free and is charged one

dollar per mile for any over 75 miles. Mileage is figured from the point of pick up to destination. Six-month memberships are effective immediately upon purchase and expire on November 30, 1981.

In addition, for those who would like to have their memberships expire annually on May 31, the Board of Directors of Red River Ambulance Service, has decided to offer annual memberships during this six-month renewal drive. This allows those who are

renewing to pay the annual rate and have their next renewal date May 31, 1982 rather than November 30, 1981. Choosing this option,

gives the advantage of subscribing to the ambulance service at our current rates. Annual memberships are also ef-

fective immediately and are offered to families for \$50 and to individuals for \$30.

Business and industrial firms may purchase

memberships to cover employees while at work, going to and en route home from work, and anyone requiring ambulance service while on the premises. These memberships are available on the following scale; One to fifty employees for \$100; 51 to 100 employees for \$150; and 101 or more employees for \$200. School districts may purchase memberships based on the same scale determined by the number of

students in the district.

Charges for non-members are as follows: Base pick up charge \$60 plus \$1.50 per mile from point of pick up to destination.

Four Injured In Talco Wreck

A Talco housewife and her three children were hospitalized Sunday after a one-car accident two miles west of Talco reportedly caused by a bee stinging one of the children, according to a Department of Public Safety spokesman.

Ernestian Hernandez King and her three children were taken to Titus Memorial Hospital in Mount Pleasant following the accident reported at 5:43 p.m., the DPS spokesman said.

According to the spokesman, Ms. King said she lost control of her 1965 Plymouth while trying to

swat a bee that had flown inside the car and was stinging one of the children.

The car ran off FM 71 and struck a drainage culvert to the left of the roadway, the spokesman said.

According to hospital spokesman, Claudia King 6, was dismissed in good condition.

Alex King 9, was admitted to the hospital with a leg injury and is in stable condition as of Tuesday.

Mrs. King and her other child were treated and released, the hospital spokesman said.

The Bogata News took second place in the News Story contest and fourth place in Sports coverage Saturday in the annual newspaper contest sponsored by North and East Texas Press Association.

The Deport Times won third place in Sports coverage.

The winning entry for The Bogata News was a story by Pat Wright in the Jan. 24, 1980 issue entitled, "Hammer Welding Grandmother Terrifies Robbers." The story concerned an attempted forced entry into the home of Mrs. Emmie Kidd of the Rosalie Community. Judges comments were, "Lead paragraph appropriate, but a bit long. Story holds readers attention. Story concise, to the point."

The Deport Times third place in Sports coverage was awarded for the work of Casey Bailey, Nanalee Nichols and Richard Naylor for coverage of Prairieland sports. Judges comments were, "Casey Bailey, Nanalee Nichols and Richard Naylor of The Deport Times get more front page sports space than any other writers. The 1980-81 Basketball All Stars, which will compete in a north-south all star game on July 10, in Ft. Worth, Texas have been selected.

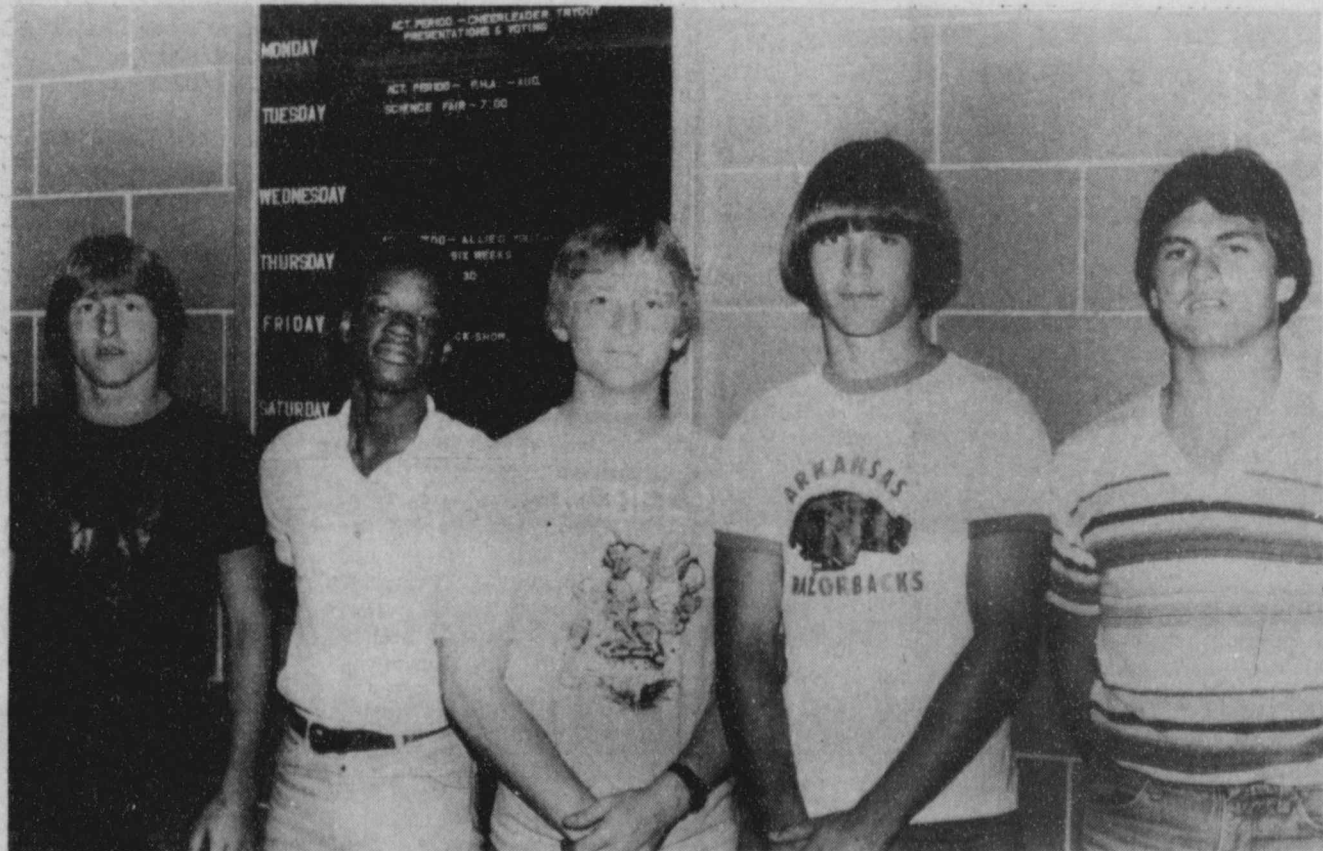
Playing in the outside position on the North Basketball All-Star team is senior at Rivercrest High School Scotti Wood.

offering will be taken. TRUTH is one of America's most popular contemporary gospel groups and is on the road every day fulfilling concert demands.

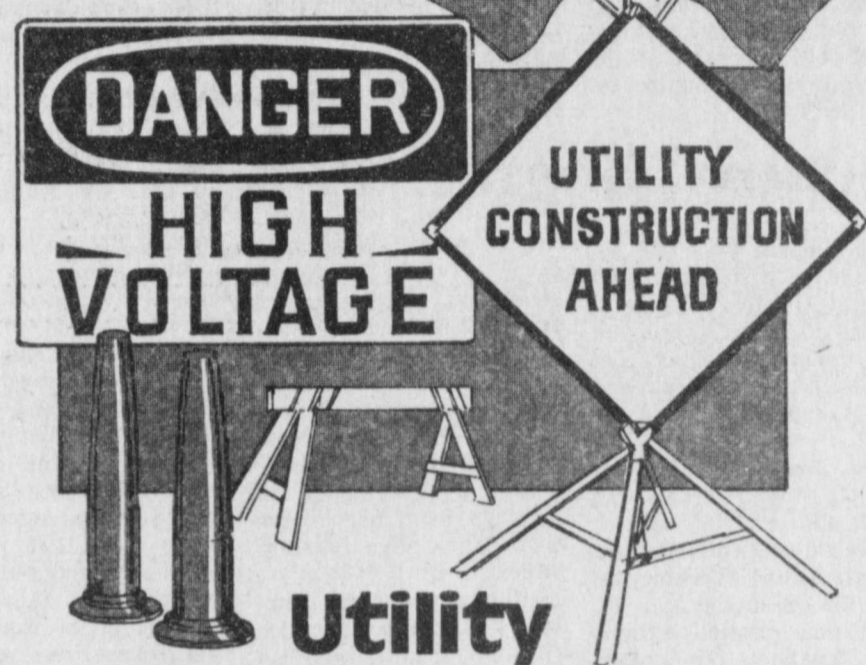

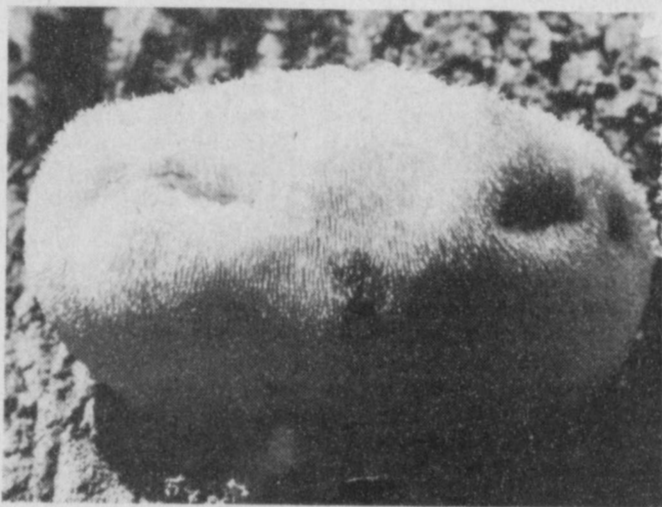
