C OF C COMMENTS Stockpens Letter

IMPORTANT- This office is doing one of the most important jobs this week it has ever done in its existence. We are mailing letters to all Sutton County ranchmen, Sonora businessmen, and to ranchmen to the south of Sutton County, setting out plans for the proposed shipping pens, sales arena and finances for the same.

What all of us want primarily is to have the facilities here, for the benefit of all concerned. In the beginning, it is felt that it is better that the project be home owned but that the man who built the business with his good management and hard work should have the right to own it, in time, at a price. That is the plan.

It is proposed that livestock growers and buyers find in Sonora every facility for handling and shipping their livestock to the best advantage of seller and buyer. This would include the sales ring and its many advantages, especially to the town.

One ranchman said that this project is for the ranchman, with the town being the biggest beneficiary. It is true that we are unlocking the gate, permitting fine people to come to Sonora to ship, sell and buy livestock with all the facilities that will cultivate such practices. Everybody wins, nobody loses.

HUNTING This day, Oct. 15, 1963, we have received three phone calls concerning hunting and have had fifteen (15) would-be hunters in our office looking for a place to hunt. This is about the daily flow of hunting business.

We are putting in the mail today self addressed, stamped cards asking land owners to let us know their plans. It will help us build a fine filing system, it will permit us to give more service to hunters and land owners, and it will save many people much aggravation by giving us the information. This year we could make it a half million cash industry, which isn't bad for a forty-five day period. Besides that, what are we going to do about the deer population?

Sewer, again the finest, just completed and being carried to many citizens for the first time. Paving, with the many miles of paved, curbed, and guttered streets in Sonora. More Screwworms Found This Week In Sutton County

Two screwworm cases were discovered in Sutton County this week. D. C. Langford, county agent, reports that one case was found on the Reed Jennings ranch 25 miles east of Sonora, and the other case was found on the Henry Wyatt ranch 15 miles south of Sonora on the Bond Road.

Five incidences of screwworm infestations have been reported in Sutton County since September 19.

A third case this week, just outside Sutton County in Crockett County, was reported from the Bill Savell ranch 45 miles southwest of Sonora. Langford emphasizes that ranchmen should check calves being dropped for flyblows and treat the navels. All suspected cases of worm infestations should be reported to him.

Broncos Move Back To 8-A Next Year

A rise in the break-off point from 200 to 215 has moved Sonora back to 8-A effective next year, announced the Interscholastic League last week.

The rating, based on a two-year average of high school enrollment, moves schools up or down in classification for a two-

year period. Sonora was moved into 7-AA in 1962.

Eight of the ten games to be played next season will be district tilts. They include Big Lake, Eldorado, Iraan, Junction, Menard, Ozona, Rankin, and Sanderson. Tentatively scheduled are two other non-district games with Mason and Rocksprings.

COMMISSIONERS VOTE TO LOCK CEMETERY AFTER DARK

The County Commissioners Monday approved locking the cemetery after dark. For some time the cemetery has been subjected to vandalism and night parties.

In other business the commissioners voted to make the courthouse voting place for all four precincts in the November 9 special election. Four amendments will be voted on at that time.

J. W. Elliott, county judge, said that he had followed the commissioners' request of the last meeting and sent a letter informing W. W. Tupper of the termination of his contract to collect delinquent county taxes.

The Boys' Tournament is open to all boys through 18 years of age. It will be a nine-hole play. Entry fee is one dollar. Entries close at 9 a.m., which is also tee time. Trophies will be awarded to winners and runners-up.

2 Defeats, 3 Wins Last Friday Night For 7-AA Squads

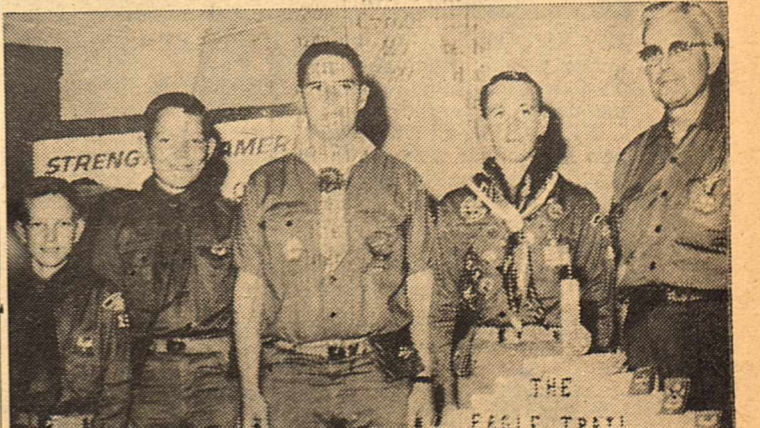
While Sonora received its first defeat of the season at the hands of Mason's Puncners, three other teams in District 7-AA won and one lost last Friday night.

National Newspaper Week

In 1690 in Boston, Benjamin Harris published this country's first newspaper, "Publick Occurrences Both Foreign and Domestick." Four days later it was suppressed by the British government. Subsequent difficulties led eventually to the celebrated trial of John Peter Zenger, whose crime was the use of a cartoon of the King's colonial governor depicted as a jackass.

Zenger won his case and established the right of the press to criticize and comment on public officials and their performance in office.

The guaranteed right to a free press, free speech, free religious practices, and free peaceable assembly are unique in America.

Today begins National Newspaper Week and we would be remiss if we failed to take note of one of the greatest safety values on self-government, which is the newspaper. This newspaper

attempts to give voice to all viewpoints so that the people can make choices. The primary role of the press is to inform the people as well as it can.

With a constitutionally-protected free press (as with free speech) goes the corresponding responsibility to use the privilege constructively. We try to do that without malice and, we trust, without prejudice—though with what we hope are informed opinions in these columns; and the views of our readers in the letters columns; and the events and expressions of the rest in the news columns.

It's The Law In Texas

STOP FOR SCHOOL BUSES

Thousands of school children are now trooping back to school throughout Texas. Many of them will be transported by school buses. Most people are careful when approaching a school bus which may be standing beside the road or school to pick up school children or allow them to alight. However, we have already had some very bad accidents this year because a child or a motorist, or both, were careless at that very time.

Most Texans are aware of the law which requires a driver to come to a complete stop when overtaking from the rear of a school bus which has stopped to receive or discharge school children. After stopping immediately behind the bus, he is then allowed by law to proceed past same at a speed "which is prudent, not exceeding ten miles per hour, and with due caution for the safety of such children."

What many persons do not realize is that the very same rule applies when MEETING a stopped school bus. While everyone is interested in protecting our children, unthinking violators of this simple safety rule greatly outnumber those who comply. Failure to follow the law in this case can lead to fine up to \$200 even when no accident occurs. Following an accident in which some child is injured or killed, the penalties are naturally much more serious.

Although the above rule does not always apply when passing a stopped school bus in a business or residential district of a town, the necessity for extreme caution even in those locations is obvious.

When it comes to overtaking and passing moving vehicles, exercise of ordinary common sense will generally keep a driver within the law. For instance, when passing a car it is only common sense to proceed on past it a safe distance before cutting back to the right side of the highway. Also, any driver would realize the danger of increasing his speed while another is attempting to pass him.

In the same category is the prohibition against passing on

the right under most ordinary conditions. Of course, you may legally pass on the right in a few specific instances, such as when the vehicle overtaken is making or about to make a left turn, or upon a one-way street with two or more lanes, or upon a four-lane highway.

However, our traffic laws state that even when passing on the right is allowed, it shall be done only under conditions permitting such movement in safety. And, in no event should such passing be accomplished by driving off the pavement or main-traveled portion of the roadway.

Familiar to all are the no-passing zones designated by yellow lines placed to one side of the center line on our highways. Not so well known are the restrictions against crossing the center line when approaching within 100 feet of or when traversing any intersection or railroad grade crossing.

A driver should never cross the center line of a highway when the left side of the road is not clearly visible and free of oncoming traffic. Generally speaking, when not engaged in passing another vehicle, one should not drive to the left of the roadway.

It is check your equipment time, suggests the Parks and Wildlife Department. Right now, hunters are in the field taking pot shots at doves, with faulty guns and ammunition. Do not become a member of the "Accidental Death Club." Texas had 48 shooting accidents in the field in 1962, 27 caused by the victim and 14 joined the "Club," dead on arrival.

All hunters going after deer and turkey this season must have valid hunting licenses, reminds the Parks and Wildlife Department. All persons 17 through 64 years of age must purchase a \$3.15 license if residents. Those 16 and under or 65 and over can get exempt licenses. Check with a warden to be certain.

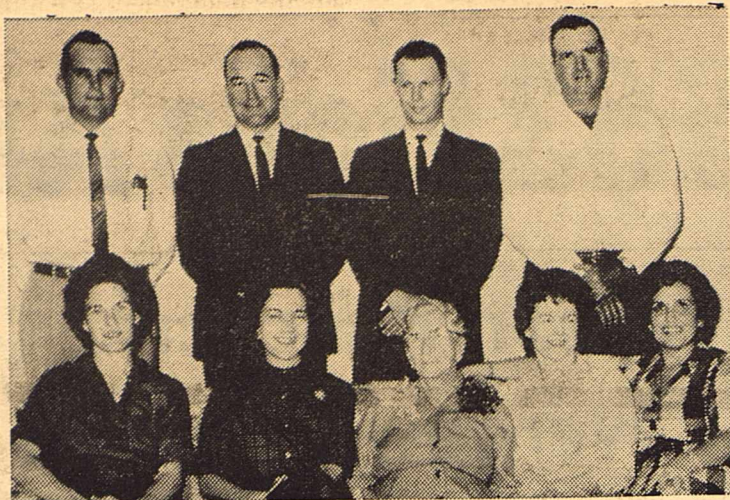

Devil's River Philosopher Amazed That Experts Think Part Time Ranching New

Editor's Note: The Devil's River Philosopher on his bitter-weed ranch on Devil's River disagrees with the experts on a modern trend in ranching, his letter indicates.

Dear editor:

For example, I was reading a magazine last night which a salesman had left out here during the afternoon, well he didn't actually leave it, he dropped it while he was trying to beat my log to his car, and in it I discovered a long article on the changing trends in agriculture. In case you're wondering, the salesman won.

At any rate, according to this article, some experts have discovered that the modern trend in agriculture is toward part-time ranching.

This is what I'm talking about. What other kind is there? The trend toward part-time ranching set in on this bitter-weed ranch the minute I started ranching it, and I expect it to stay that way. I could name you some more who share the same view.

Part-time ranching's not something new; what's new is that some ranchers are now working in town too.

Understand, ranching is a full-time job, there's always something to do. But that's not to say all us ranchers are always doing it. Why right now I've got jobs

staring me in the face which should have been done 10 years ago, but they've never stared so hard I felt like I ought to take a job in town to dodge them.

Of course, there are some young ranchers who work in town and still seem to get more done on their ranches than I do on mine, but this is a trend which I don't care to call attention to.

The fact remains though that part-time ranching set in thousands of years ago, or whenever it was man discovered you couldn't mend fences when the fish were biting, and as far as I can tell the trend is still under-

way.

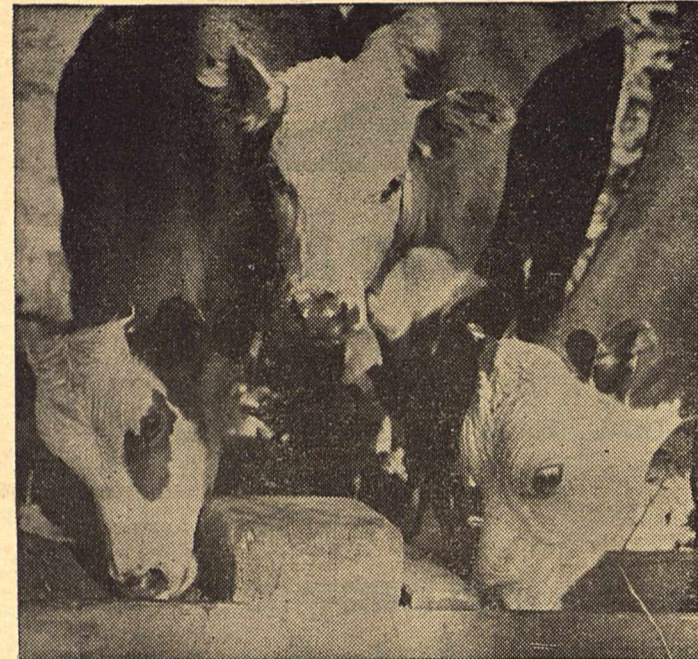

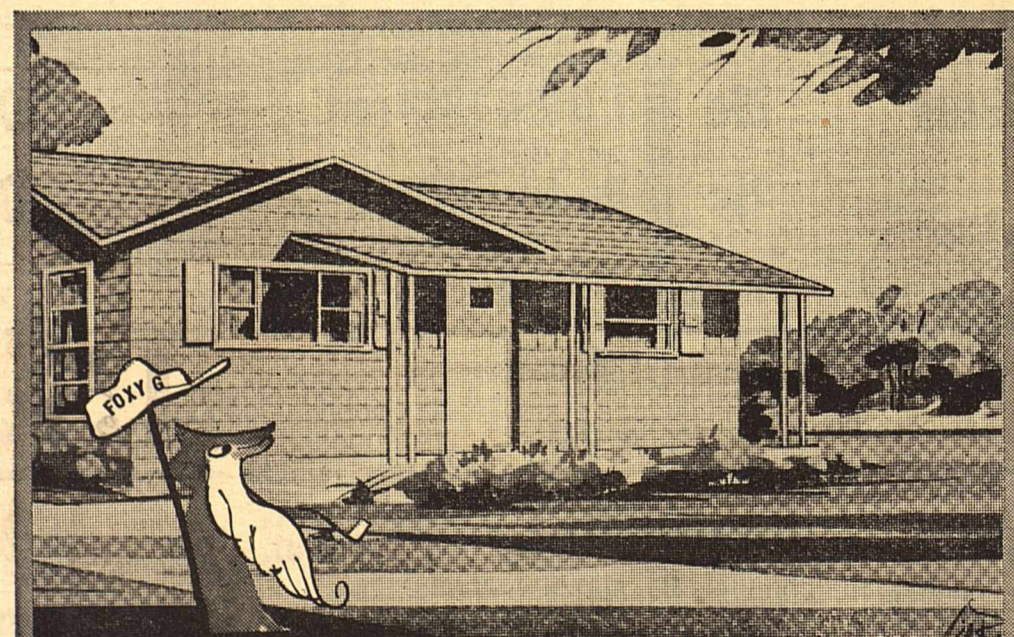

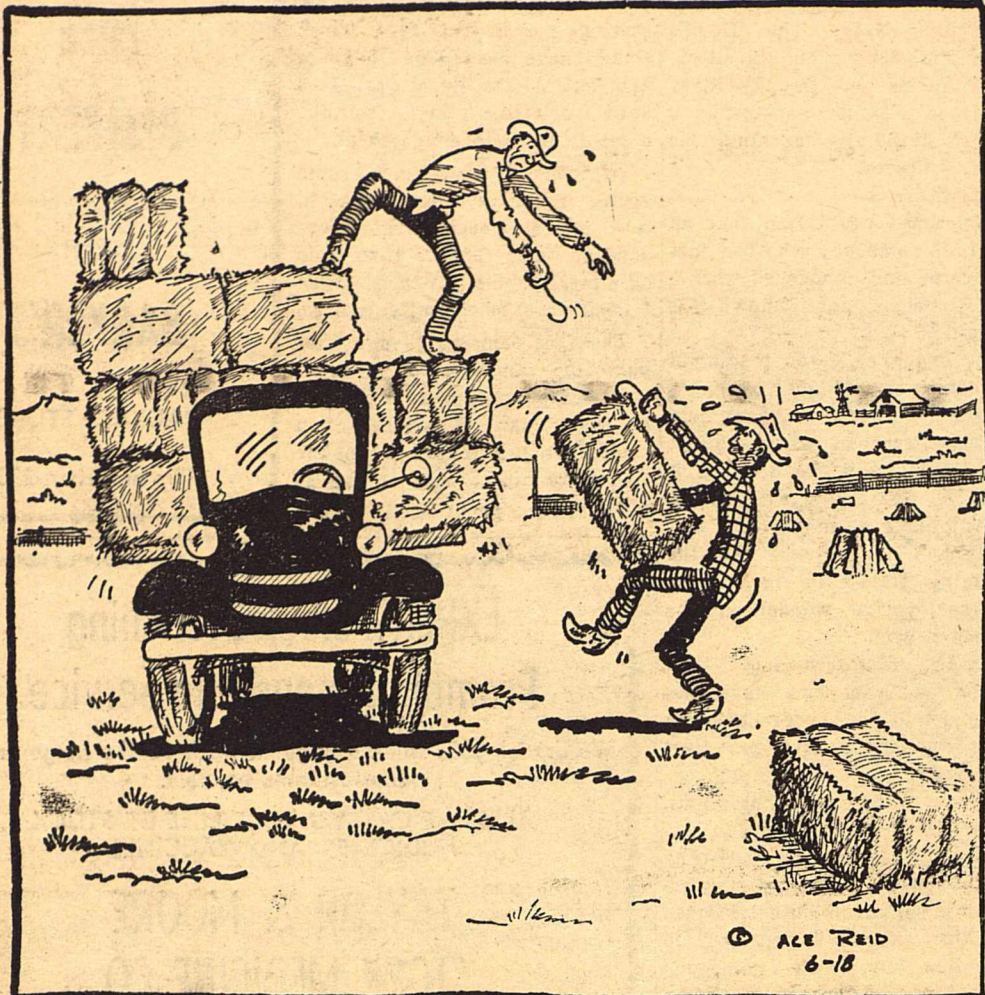

YOUR MINISTER SAYS

By James Billingsley, Rector St. John's Episcopal Church
There is a story of a man who showed up at a prayer group with which he met regularly and always with the same prayer: "O Lord, sweep away the cobwebs from the windows of my heart"—but his conduct during the week showed that not much progress was being made. Finally one evening, as he was beginning his familiar petition, a fellow worshipper cut him short with, "Dear God, kill that spider!"

The point of the story, for me, is that we can't be Christian alone, all by ourselves. Properly, we begin with our own personal lives in our striving for fulfillment, but there are always things and forces—"spiders"—outside our "innermost selves" which continually return to spin their webs on the windows of our hearts, and we need to deal with them.

These "spiders," these forces, come from the environment in which we live. For example, the complex and oppressive pattern of "courtship" and "dating" in our country is an environment from which spiders come to spoil life for our young people. How can we kill these spiders which weave cobwebs on the hearts of our youngsters, except by many of us together saying "No" to things as they are, and "Yes" to a pattern more open to Christian principles?

The racial feelings of "other people" is an environment from which spiders come to keep those of us who do not share their feelings from being free ourselves to live by the gospel of Jesus. Of what use is it to us to

Groups Will Seek Mohair Industries To Locate In Texas

Plans have been made for the Texas Industrial Commission to assist Angora goat raisers in attempts to entice mohair industries to Texas.

Armer Earwood, president of the Texas Angora Goat Raisers Association; James L. Powell of Fort McKavett, president of the Texas Sheep and Goat Raisers Association; L. M. Stephens of Lometa; Howard G. Hay of Bandera; and Houston Smith of Texas A and M will work as a committee with the Industrial Commission's staff.

It is hoped that some mohair scouring, sorting, grading, and combing industries can be established in Texas so that the product can be turned out in finished form. Goat raisers now sell raw, ungraded, sacked mohair to buyers from four eastern firms who ship it east for finishing.

D. W. (Speedy) Hicks of Bandera said the goat raisers do not know manufacturers' requirements. Harry W. Clark, director of the Texas Industrial Commission, said the commission is ready to lend a helping hand, through research and promotion.

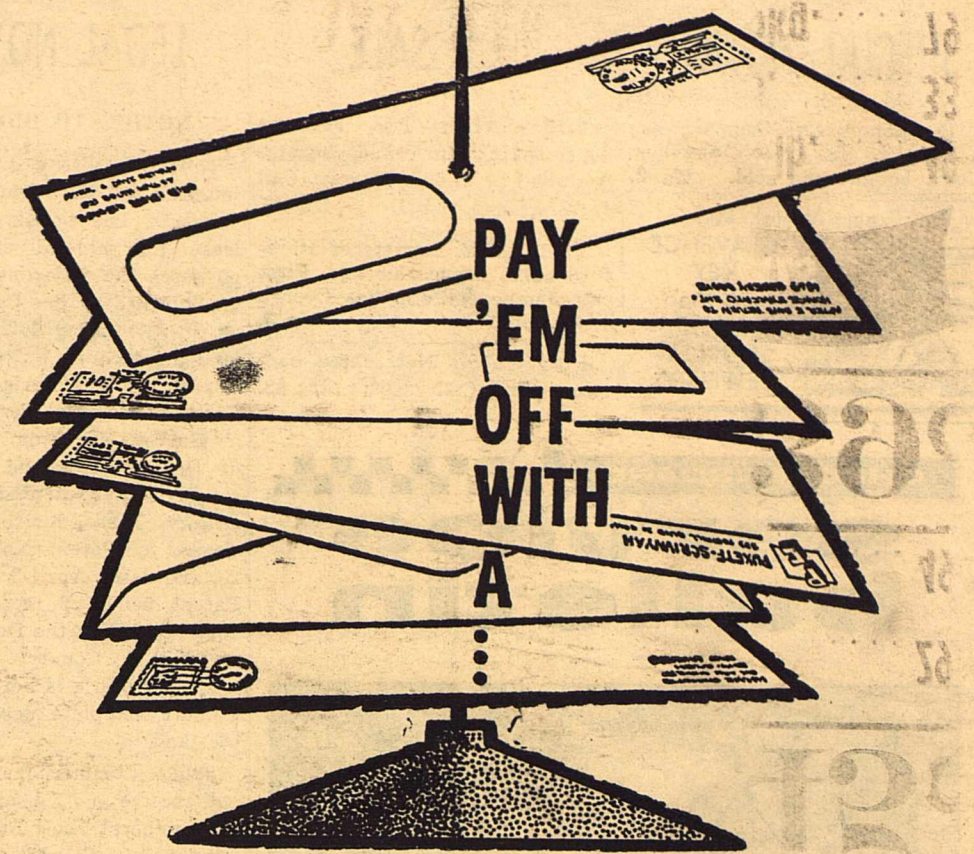

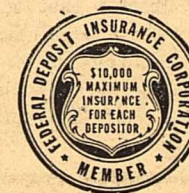
