LOUISIANA PREACHER TARRIED, FEATHERED

NEFF AGREES TO END MEXIA MARTIAL LAW

Will Decide Later on Action to Be Taken in Freestone County.

AUSTIN, Feb. 25.—Governor Neff late today authorized the statement that martial law in the Mexia precinct of Freestone county will be lifted either the night of Feb. 28 or the morning of March 1. The proclamation lifting military control will be issued Monday, the governor said.

The governor was undecided today whether the martial law now in effect in all of Freestone county would be lifted at the same time. He will announce his decision later.

The governor's statement followed receipt of a telegram from Brigadier General Jacob F. Wolters, commanding the military area, recommending that martial law in Mexia be lifted on March 1.

The national guard troops and state rangers now enforcing the martial law in Mexia will be withdrawn immediately after the martial law is lifted, the governor said. In event the martial law is not lifted in Freestone county at this time, a plan for holding sufficient troops and rangers there to enforce it will be worked out later, the governor said.

Martial law became effective in Mexia and two precincts in Freestone county at 5 o'clock on the morning of Jan. 11. State rangers and national guardsmen under command of General Wolters were sent to enforce it. Later, martial law was extended to all of Freestone county. Numerous liquor raids followed.

Last Saturday Governor Neff spoke to the citizens of Limestone county at Mexia and yesterday General Wolters delivered to him a copy of resolutions adopted by a citizens' committee, advising the governor of their intentions and plans to enforce the law. Governor Neff directed General Wolters to advise the citizen's committee that he had accepted its proposition.

JUDGE ADVOCATE NAMED MEXIA CITY ATTORNEY

MEXIA, Feb. 25.—Major C. H. Machen, judge advocate in the military district of Mexia, was appointed city attorney of the city of Mexia today. He will resign as assistant county attorney of McLennan county if he is learned tonight.

NEFF WILL MAKE SPEAKING TOUR ALL OVER STATE

AUSTIN, Feb. 25.—Beginning the latter part of March, Governor Neff will make a "thorough" speaking tour all over the state, he announced today. The governor plans to cover the entire state and speak four or five times a day. The governor said his subject would be "The Texas Government; Its Perils and Possibilities."

"Among other things I shall discuss with the people the necessity of working out a plan for more efficient rural schools and a better marketing system for various products of farm and ranch," the governor said.

"I shall also discuss the benefits to be derived from workable co-operative methods, by means of which the county, state and federal governments can unite in building and maintaining good roads throughout the state."

During his campaign for election, Neff said that if he was elected he would discuss with the people the problems of state government after he had learned something about its operation.

NEFF TO SPEAK AT MILFORD.

AUSTIN, Feb. 25.—Governor Neff has accepted an invitation to speak at Milford, Ellis county, March 2, at the ceremonies attending presentation of an American flag to the Milford American Legion post.

Tee Pee Man Falls 55 Feet; Not Hurt

THAT IS, NOT HURT MUCH

Falling fifty-five feet and lighting on his feet, practically unhurt, was the experience yesterday afternoon of E. J. Hicks, employe of the Texas Pacific Coal & Oil company.

Hicks was working on a derrick on the Langford lease, five miles west of town, when his foot slipped and he plunged down fifty-five feet to the ground. In

falling, however, he managed to check his speed by grabbing portions of the derrick.

When brought to the Ranger General hospital yesterday afternoon by Dr. Shackelford, it was found that aside from a bad shaking up and several bruises, the latter caused by splinters, Hicks was not injured. He will be confined several days.

MORE FAILURES ADD TO LOSSES IN WALL STREET

NEW YORK, Feb. 25.—Today brought the failure of three more brokerage houses, with combined liabilities estimated at \$120,000 and combined assets estimated at \$33,000.

Concerns which have gone to the wall since last November now total thirty. Total liabilities were estimated at \$21,788,000 and assets at \$10,549,000.

In the street the opinion was advanced that many houses of perfectly reputable character had gone smash because of the "cautious attitude" many investors assumed with the district attorney's inquiry into bucket shops.

'LIQUID ELECTRICITY' AD GETS PROMOTERS IN TROUBLE WITH LAW

AUSTIN, Feb. 25.—Nine complaints were filed here today against O. D. Thomas, L. F. Holmes and W. E. Ferryclear, all of Houston, charging violation of the so-called pure advertising law passed at the special session of the legislature last summer. Three complaints were filed against each defendant by County Attorney John W. Hornsby in the Travis county court.

The complaint alleged that the three defendants violated the law in advertising a substance as liquid electricity. It is charged that the defendants knew or should have known that there is no such thing as liquid electricity. They are charged to have unlawfully, wilfully and knowingly published, disseminated, circulated and placed before the public in this state and Travis county in a Houston newspaper the alleged false advertising. This is understood to be the first case filed for violation of this law.

SAN ANGELO OPPOSED TO KLAN CHAPTER

SAN ANGELO, Feb. 25.—San Angelo wants none of the Ku Klux Klan. It is a law-abiding city, its officers are efficient, and the reported organization of a klan chapter here would be a reflection on the city and inimical to its best interests, socially and morally.

These sentiments were emphatically set forth in a resolution adopted this morning by the board of city development, in vigorously opposing the forming of a klan chapter here now or at any time.

It was said a klan organizer has been here several days. The board is the city's commercial body, composed of fifteen representative citizens. It is believed to be the first organization of its kind to go on record against the klan.

OIL WELL FIREMAN BURNED IN EXPLOSION

MEXIA, Feb. 25.—H. Gentry, fireman on an oil well south of here, was blown 100 feet and badly burned when a boiler exploded yesterday at the well.

The explosion came just after Gentry had rushed to the boiler shed to extinguish a fire.

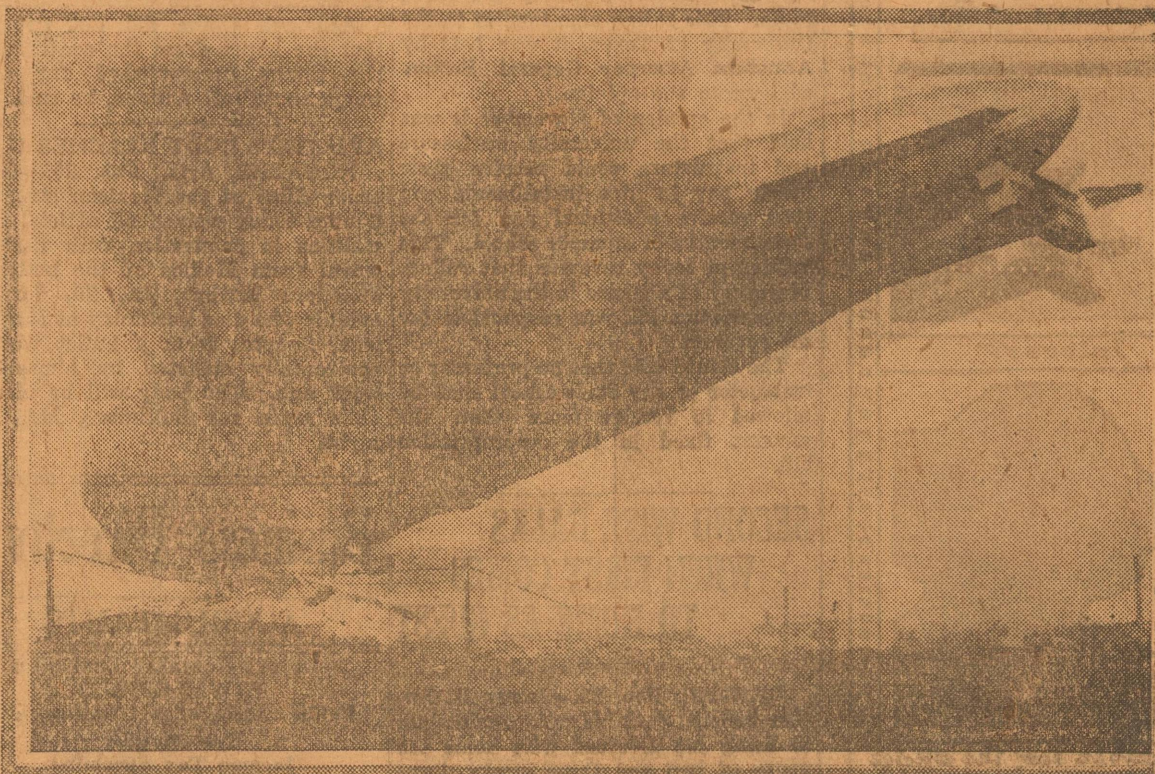

WEST TEXANS PLEDGE CROP DIVERSIFICATION

DALLAS, Feb. 25.—Co-operation of fully 9,000 farmers of West and Northwest Texas has been pledged in the crop diversification movement sponsored by the Texas Farm Bureau Federation, according to John T. Orr, president of that organization, who returned Saturday from a week's tour of that section of the state. Orr said that the continued drought in the section had prevented sprouting of much of the small grain planted last fall. This will necessitate the planting of some other crop where the grain failed to come up, he said.

Electric Wire Ignites Gas, Causing Roma Explosion



Explosion of the giant dirigible Roma, recently purchased by the United States from Italy, was caused by the ignition of leaking gas by a high voltage wire. The monster aircraft started her last flight downward when the elevation controls are believed to have given way. Hydrogen gas from her bursted tanks was ignited when the American queen of the air struck a high voltage wire about seventy feet from the ground. The steel structure of the great craft sagged quickly, burying most of the crew members under a seething cauldron of flames.

He Had Reported That Mob Held Him Up and Seized Slain Man.

TEXARKANA, Feb. 25.—Deputy Sheriff W. T. Jordan has been indicted for murder in connection with the killing of the negro, P. Norman, who was shot to death while handcuffed on a county road near Texarkana on the night of Feb. 11. It had been reported that masked men took the negro from the officer.

The indictment returned by the Bowie county grand jury, under which the warrant was issued that brought about the arrest, alleges that Jordan did, "with malice aforethought kill Norman by then and there shooting him with a gun."

Jordan voluntarily surrendered when he heard that the warrant had been issued and immediately sued out a writ of habeas corpus before Judge P. A. Turner of the Bowie county criminal court. He was released under a bond of \$3,000, pending the time when the case will be called for trial.

GORDON'S WELL FEATURES WEEK IN 'LAKE' AREA

Most of the drilling operations in northern Eastland county are centering in the Lake Eastland territory, where about ten wells are at various stages.

Colonel Gordon's 500-barrel producer on the Brelsford was the feature well of the week and also the best one so far struck in that territory.

Two other wells there are being watched with interest. One is Davis et al., on the Chett, drilling at about 2,500, which if successful will extend the pool to the west. Joe Ardizzone is drilling a deep test on the Brelsford. With only a small showing at 3,200, he will go to 3,600, making the first deep test, around the lake.

Day & Davis are spudding in Davenport No. 2, about two miles north of Eastland. Their No. 1 is making around 200 barrels.

H. R. Courtwright and associates will drill east of Eastland on the Rosenguest. A completion here will mark an extension of the producing area.

HARVEY DENIES HE SEEKS PACT WITH BRITAIN

LONDON, Feb. 25.—George Harvey, the American ambassador, today issued a statement saying Senator Reed was obviously misinformed when in an address in Chicago on Feb. 22 he was reported to have said that "I am in substance defying virtually a union between America and Great Britain, entailing an alliance between America and the O. World."

Mr. Harvey exhibited a clipping from a London newspaper which he said contained his exact words on the subject. The clipping quoted the ambassador as recalling Washington's policy against foreign alliances, and then quoted the ambassador as saying:

"In view of these circumstances and without considering the wisdom and advisability of the continuance of this definite policy and unbroken practice, I am doing more than stating a wholly obvious and unmistakable fact when I pronounce the binding of Great Britain and the United States into any permanent alliance, however desirable that action might seem, to be an utter impossibility."

"There is no truth in the statement attributed to me by Mr. Reed," said the ambassador.

BILLS WILL ENTER RACE FOR COUNTY ATTORNEY

EASTLAND, Feb. 25.—E. A. Bills, assistant district attorney, will enter the race for county attorney, he stated tonight. Mr. Bills has lived in Eastland county practically all his life.

He stated that he would make a formal announcement in the next few days.

JEWELER ALSO GIVEN LATEST STYLE CLOTHES

Bennet, itinerant preacher, was thrown from an automobile in front of a drug store in Washington avenue at 8:30 o'clock Saturday morning. He had been tarred and feathered on the outskirts of De Ridder by a number of men who are said to have been unmasked.

Early Saturday morning the party went to Bennet's home in Warren street and called him to the door. When he came out he was hustled into an automobile and rushed to the country. He was thrown out of the automobile on the return, just as Washington avenue was crowded with early Saturday shoppers.

DAVIDSON SAYS HE'S WILLING TO BE ELECTED

HOUSTON, Feb. 25.—Lieutenant Governor Lynch Davidson issued a statement this afternoon stating that it was not his intention to run for reelection as lieutenant governor and that he was considering favorably importing of friends to seek the United States senatorship.

Davidson indicated a possibility of being a candidate for the senate and said he would only be prevented from doing so by pressing business demands. He emphatically reaffirms the doctrine that every man of ability and capacity, and particularly the outstanding business men of the day, should subject themselves to the call of the people and the people should call them to active participation in the affairs of the government and stating further in proof of his belief in that doctrine, he was at times open to any demands made on him by the people of Texas.

KLAN SPREADS TO CALIFORNIA OIL FIELD TOWN

Notices Posted and One Service Car Driver Gets Tar Coat.

FRESNO, Cal., Feb. 25.—Reported activities of an alleged Ku Klux Klan organization in this section is under investigation, according to a story in the Republican Tuesday, by the police at Taft, and the district attorney at Bakersfield, following the complaint of Eli Andrews, a rent-car driver, that he was tarred and feathered by unmasked, unidentified men.

Shortly before the alleged mistreatment of Andrews, printed warnings headed "Ku Klux Klan" are said to have been distributed in Taft. The city authorities said Andrews was fined on charges of bootlegging and drug selling and once served six months in jail for vagrancy.

The posted notices, as published here, were as follows:

"First, last and only warning to gamblers, gunmen, bootleggers, loafers, lawbreakers of every class and description, black, white or yellow. We are sworn to preserve the sanctity of the home, the virtue of our wives, mothers and daughters, and we mean to do just that. We stand squarely back of law and order.

"We mean strict, impartial enforcement of the law. We are strong enough to enforce these demands and will back our officers to the last man in enforcing the law. We demand that the town of Taft and the county of Kern be made clean and that happiness and welfare be safeguarded.

"No law abiding citizen need fear our coming, but he who defies the law and common decency will do well to change his course. Law breakers, you cannot escape us. We know who you are, what you are and where you are. Change your ways this hour lest you be stricken as with lightning from the sky. The good will welcome us but the evil will meet with a swift, stern retribution. We have given fair warning. Beware!"

SAN ANGELO PROTESTS MOVING OF ORIENT MEN

SAN ANGELO, Feb. 25.—Restoration of general offices and shops of the Orient railway of Texas here to pre-war strength was asked today by the board of city development. A resolution adopted pointed out that the road's force have been reduced gradually, through transfer to Wichita, Kan., and offices consolidated and abolished. It further declares that these changes are a violation of the road's contract with citizens, made about fifteen years ago in return for the purchase locally of the Orient's bonds, with proceeds from which the line was built into San Angelo.

Superintendent A. J. Cleary declared today that although the road's employes here now number only 186 as compared with 213 in 1917, the payroll is approximately \$10,000 a month greater.

ANTHRACITE OPERATORS WILL MEET WITH MINERS

ATLANTIC CITY, Feb. 25.—The policy committee of the Anthracite Coal Operators' association announced late today it had granted a request of John L. Lewis, president of the United Mine Workers of America, for a conference with union officials, which will be held in New York on March 15.

The committee meeting which began yesterday, adjourned this afternoon. No announcement of any difficulty by the committee was made save the decision to meet mine workers' representatives.

PROFS CAN'T GET EXTRA PAY FOR SUMMER SCHOOL

AUSTIN, Feb. 25.—An attorney general's opinion today held that professors, instructors and teachers of any state educational institutions are inhibited from receiving any salary for teaching in the summer school of those institutions other than the salary fixed by the legislature. The opinion was given to President Brally of the College of Industrial Arts, who sought to have a similar opinion issued last winter reversed. This the attorney general's department refused to do. This ruling also applies to the University of Texas, it was held by Assistant Attorney General Sutton, who wrote the opinion.

In the opinion of November it was held that the university professors and instructors could receive their yearly pay in nine installments and then receive additional pay for the three months of summer school. This opinion of today reversed that ruling. Discovery of a clause in the university appropriation bill was responsible for the reversal.

The clause held that no professor or instructor of any state school shall be allowed to receive more than the amount fixed in the appropriation bill.

SECOND WIFE BALKS WHEN FIRST COMES TO HOME AS GUEST

DENVER, Feb. 25.—James E. Luther insisted that his wife permit him to bring his divorced wife home for visits of two and three weeks duration and demanded that his present wife accord her the best of the house, but Mrs. Sarah Rebecca Luther, the present wife, refused to be cook and housekeeper for the guest, according to the story she told Judge C. J. Morley Tuesday. Judge Morley decided it is not one of the duties of a wife to entertain her predecessor and granted Mrs. Luther a preliminary decree of divorce.

CHINESE GIVE HUGHES CREDIT FOR SUCCESS OF ARMS CONFERENCE

NEW YORK, Feb. 25.—Secretary Hughes is entitled to the lion's share of credit for the success of the armament conference, V. K. Although China did not get all that she hoped from the conference, the things accomplished far outweigh those left undone, he said.

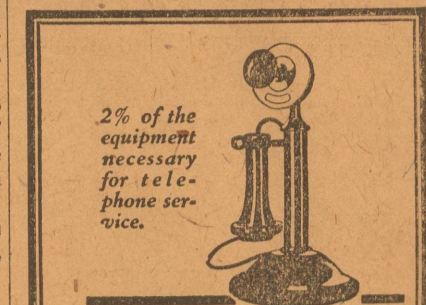
AVIATOR'S BODY REACHES U. S.

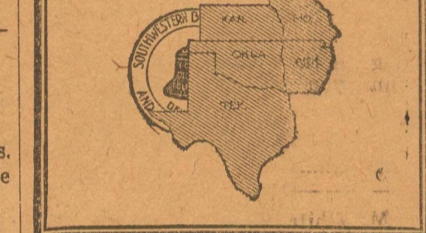

LENGTHY BRIEFS FILED IN RED MURDER CASES

DEDHAM, Mass., Feb. 25.—The final installment of the lengthy bill of exceptions prepared by counsel for the defense in the case of Nicola Sacco and Bartolomeo Vanzetti, convicted of the murder of a paymaster and his guard at South Braintree, was filed in the Norfolk county superior court late today. 
part of the bill was filed on Feb. 10. Today's portion of the bill consisted of two typewritten books, containing 121 and 141 pages respectively. The first part containing 129 pages. The matter filed today consisted of a review of the evidence to which defense counsel took exceptions and comments made by the court at the time. The murder occurred in April, 1920, and the two men were convicted in July of last year. They have not yet been sentenced. These are the men in whose behalf anarchists attempted to bomb American embassies and consulates in France and Portugal last year.

WHY STRIKE?

The coal mine strike is worrying Washington and other Eastern centers. And yet, glancing over reports concerning the points of contention, it is difficult to see how a strike would change the situation.

Some miners, union officials report, worked a total of twenty-six days last year. Others worked as many as forty.

Why not strike; they don't seem to be working anyway?

Then, too, why should the operators object to shorter hours? If a man works twenty-six eight-hour days in a year why shouldn't he be permitted to work thirty-five six-hour days if he prefers it? It would seem to be the same thing in the long run.

Taken, altogether, the coal mines seem to be the last stronghold of industrial feudalism. There is a well defined movement to "bust the union" regardless of the effect on the country's coal supply. There also is on the part of the miners a well defined idea that they will not succumb to the despotism of the so-called American plan, which has for its object giving the workers what the employers think is good for them. They are proving their belief in the righteousness of their contentions by living in tents, on scanty rations, despite the protestations of benevolency on the part of West Virginia bituminous barons.

The government, if it is a government of the people, by the people and for the people, should take a hand. In these times of intricate economic relations, it is no longer socialism for it to control coal mine wages and working conditions just as railroad wages are now controlled.

Possibly the miners are asking too much—more than the traffic will bear. Possibly the operators are offering less than the toil and risk is worth. For certainly coal mining is an arduous and risky occupation. At any rate they should be brought together on an equitable basis, and the most expedient way to do that is for the government to regulate the industry.

That way, there will be fair play, for the public, the miner and the operator.

UNIONS ARE USEFUL.

While on this question of unions, you ever consider the open shop question from the workers' viewpoint?

Leaving aside the fact that an open shop is generally a closed shop to union members, which is a point open to dispute, what does an open shop mean?

An open shop is one where the employer sets the hours of labor, the pay and the conditions. The worker has no choice: Take it or leave it. He may be all right when there is no shortage. But suppose in a few days a man has that choice? He gets the privi-

lege of working under onerous conditions or hunting a job.

Under the "closed shop"—from which no man is barred who is competent to do the work and who has not at a previous time betrayed the trust of his fellow workers—there is negotiation of the pay, like other business contracts. It enables the employe to tell his employer what his work is worth, and why. In other words, it gives him some say about his conditions of employment, which he certainly does not have under the open shop, even though its advocates say he has it only through that system. Workmen never organized an open shop association, did they?

The unions raise the standard of living for a community. They are a source of strength to the fair-minded employer, who looks on his men as friends and co-workers, and is anxious to do as well by them as his business will permit. They are a bar to the mean and avaricious employer, who would force lower scales and longer hours that he might have an advantage over his competitors. They introduce a stable basis for estimating jobs and a uniformity of cost which leaves business success up to personality and efficiency, where it belongs.

There is some criticism that union scales are not flexible; that they do not go down when business depression comes. That is true. But isn't it equally true that the workmen as a whole have to fight for every raise, no matter how much the cost of living conditions may fly upward?

Scales possibly should be more flexible. But their flexibility should mean that they could be raised when conditions permit, as well as be lowered when conditions demand it. In other words, if the worker should share in depression he should have some of the profits of prosperity.

As the world grows older, this problem perhaps will be solved. Meanwhile, it is up to every man to get the most he can. Nobody is giving away anything very valuable.

CAN THIS PEARL HYPNOTIZE YOU? EXPERT SAYS SO

NEW YORK, Feb. 25.—Residents of Tuxedo Park are wondering if Miss Marion Renee Carhart can be, in a way, "evidence" to strengthen the theory of a famous Paris gem expert that the pearl has a peculiar property which affects the mind of a wearer.

Another chapter has been added to the long story of missing pearl mysteries at the Tuxedo Park home of Mrs. Henry D. Brookman, where Miss Carhart's \$25,000 pearl string suddenly reappeared as strangely as it vanished. Miss Carhart is the granddaughter of Mrs. Brookman.

Under the theory of the expert, M. Roumassi, the pearl owner frequently loses all idea concerning what has happened to her pearls, and cannot, indeed, remember anything about them. They may be mislaid, and milady does not recall the last time she had them. They may have been stolen, and she has no notion of the time or the place of the theft.

Insulated in Lead Case. Roumassi has passed most of his life buying and handling pearls. He says he has been compelled to insulate pearls in a case lined with lead. When thus carried, he says, the "fluid," current, or whatever else it is that is possessed by the jewels, cannot be communicated to his body.

Miss Carhart missed her pearls Jan. 5, when she started to wear them to some function. Search was started at once, private detectives joining the police.

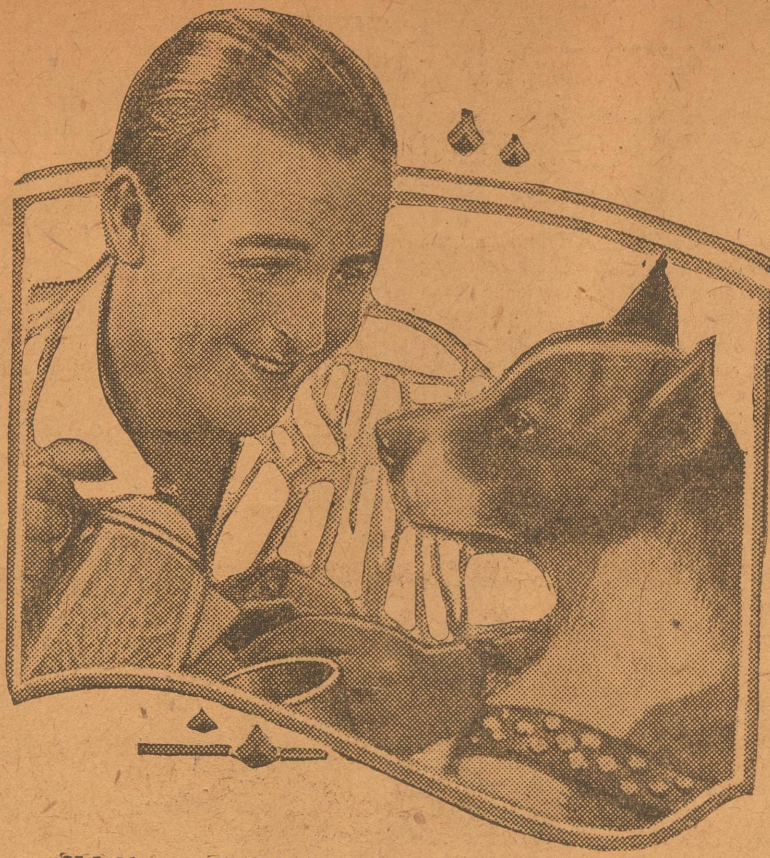
Now, Tuxedo Park is one of the most closely guarded residential districts in the world. As for Miss Carhart, she could not place the time definitely when the gems were last seen.

And then the strange thing happened. The police got word to drop the case because the pearls had come home as mysteriously as they went away.

Perfect Disagrees. Similar stories have come from all parts of the United States and foreign lands, giving the pearl credit for being a "hypnotist," but the Paris prefect of police declines to share Roumassi's views. He says that pearls are stolen more often because they are most valuable and easily handled.

But this heresy does not keep many women who own pearls from fearing the jinx. Mile. Godonowa, Parisian dancer, who is seen at the Folies Bergere with little other costumes than her remarkable pearls, became so obsessed with the Roumassi theory that she had false pearls placed in the settings.

NEAR THE DEPOT

Three Fishermen Win Race for Life on Breaking Floes

TRAVERSE CITY, Mich., Feb. 25.

—A ten-mile dash for safety over a breaking ice floe by Arthur Riant, Louis Culman and Frank Hoard ended in their spectacular rescue from Henry Ford island by Lester and Archie Buchan.

Almost a score of fishermen were at their cabins near here when the ice started breaking in a sudden thunderstorm. All but the three were able to jump or swim to safety. Riant, Culman and Hoard made several futile attempts to work toward shore, but each time the ice broke too rapidly shoreward.

The windward side of the ice was breaking behind them rapidly and it was only by keeping a fast pace toward Ford island, ten miles out in the bay, that the trio escaped drowning. Never were they more than a few feet from the breaking ice. In the rush ahead of the cakes they discarded tackle, overcoats and boots. The drifting floe passed within ten feet of the island and the men plunged ashore. If they had been swept past the island escape would have been impossible, for ten miles later the floe crumbled.

Lester and Archie Buchan, farmers living near the island, donned skates, and, shoving a rowboat between them, traversed the two miles of thin ice to the island.

Clinging to the boat, the five made their way to the mainland across heaving ice.

TENANTS FORGOTTEN BY LANDLORD FOR EIGHTEEN BLISSFUL MONTHS

NEW YORK, Feb. 25.—Through a freak of business administration fourteen families living in an apartment house at No. 431 East Seventy-second street were forgotten by the trustee of the estate of Nicolai Russo, which owns the building.

For fourteen months in some of the tenements and for eighteen months in others the monthly knock of the rent collector was absent.

At first the tenants thought it strange. Later they became used to not paying their rent.

So used had they become that yesterday when the trustees of the estate remembered the building and sent a collector to gather back rent, they were amazed, hurt, pained and even indignant. One of the tenants told Ernest N. Adler, the collector, that the house was not subject to rent collections.

Dispossess warrants were served on the fourteen heads of the families and the cases will be heard in the Sixth district municipal court. According to Adler, it will take some of the tenants forty years to save up the rent in arrears.

5,000 WEALTHY FRAULEINS BID FOR 133 BEAUX

By Associated Press.

BERLIN, Feb. 25.—Traveling matrimonial agents constitute the very latest idea in Germany where keen competition has developed among matrimonial bureaus because of the great surplus of women, partly due to the war.

The matrimonial agents go from one town to another seeking "gold fishes," as the Germans call them or, in other words, women with money who are desirous of obtaining true love and a good-looking husband, though poor.

Both men and women have taken to the work of nuptial agents and operate on the trains as they travel, seeking the acquaintance of likely appearing candidates to whom they explain their propositions when given even less than half a chance.

The matrimonial agents carry a

"sample case" in the form of a large album, leather-bound with handles, and which is nearly as large as a suitcase, the album containing photographs of men who have registered as being in the market for a "gold fish" wife.

These agents work on a commission basis, being paid by the bureau managers who when a match is made, charge 4 per cent of the woman's wealth, payable immediately after the marriage takes place, the bureau also receiving a certain percentage from the successful man candidate, payable in installments, a certain length of time after the wedding date.

One matrimonial bureau advertised recently that the names of 5,000 marriageable women were listed on its books and that there were only 133 men candidates to meet the emergency.

An automobile "rolling canteen" is being designed for the department of public safety of Philadelphia, Pa., to be used for distributing hot coffee and sandwiches to police and firemen at conflagrations.

PHYSICIAN, 99, GIVES GOOD WINE CREDIT FOR AGE

NEW YORK, Feb. 24.—Proper food, including wine, is the secret of longevity, according to Dr. Stephen Smith, founder of the New York state and national board of health and one of the East's best known physicians, who Sunday celebrated his ninety-ninth birthday. Wine, in particular, he said, was responsible for his excellent health today, declaring that it corrected digestive troubles of his youth.

"It was during a visit to Paris," he explained, "that I learned to drink wine, with the result that I have been well ever since. At a banquet I sat next to a famous French physician whom I told about my unfortunate handicap. He advised me to drink wine between courses saying it would digest the food I had eaten. I followed his advice and did not experience any further discomfort."

Dr. Smith declared that work was the second essential to the enjoyment of old age, saying the brain cells need stimulation.

TO WAGE WAR ON SPOOK.

HALIFAX, N. S., Feb. 25.—The famous ghost of Antigonish county today had won the second round of its fight with agnostics and entered upon its third.

First it drove Alex McDonald from his farm in Caledonia Mills in mid-winter, with a tale of mysterious fires and cattle that apparently had been stricken by a supernatural hand.

Last night it sent Detective McDonald of the provincial police and Harold Whidden, a reporter, back to Halifax satisfied by their investigation that the ghost exists and had snipped them.

Today the Cross Hockey club of Antigonish announced that two of its members had been selected to wage war against the spook.

EDISON FAVORS IDEA OF OUSTING GOLD STANDARD

NEW YORK, Feb. 25.—Following up the suggestion of his friend, Henry Ford, for the payment of the development of Muscle Shoals by currency issued on the proposed improvement, Thomas A. Edison has sent to leading bankers and economists throughout the country a questionnaire, asking if currency based upon the "real, actual wealth of the country" cannot safely be substituted for the present money based on the gold standard.

Edison, who had previously backed up Mr. Ford's suggestion of an "energy dollar," wants to know in his questionnaire what the value of gold would be if all governments of the world should demonetize it and why it would not be possible to make any known piece of matter a standard of value.

With the questions so worded that they constituted in part an argument for his and Mr. Ford's proposals, Edison suggested "Necessities of Life" stored in a series of government warehouses and vacant land susceptible of improvements by irrigation as two possible bases for his currency based on "real wealth" and asked how much of the present currency of the

United States was "good" and how much "fiat" money.

Bankers and economists here were reluctant to discuss Edison's questionnaire for publication, but it was said that he probably would receive answers dissenting from the views which he has implied.

It was the general opinion among them that Edison's questionnaire indicated in the inventor a trend of mind on the subject of finance very similar of that of Ford.

GIRL SUICIDE WOULD TAKE MONEY WITH HER

PITTSBURGH, Pa., Feb. 25.—Virginia Johnson, 19 years old, desiring to end her life, decided to take along all her available wealth, which consisted of a dime, three nickels and two pennies, so she swallowed them, in the belief that they would cause her death.

She was taken to the Allegheny General hospital, where it was stated that she probably would recover.

Miss Johnson had been arrested and held for a hearing in morals court. Late last night the matron found her to be groaning and apparently dying.

The girl admitted that she had eaten bread in which she had imbedded the dime, nickels and pennies.


