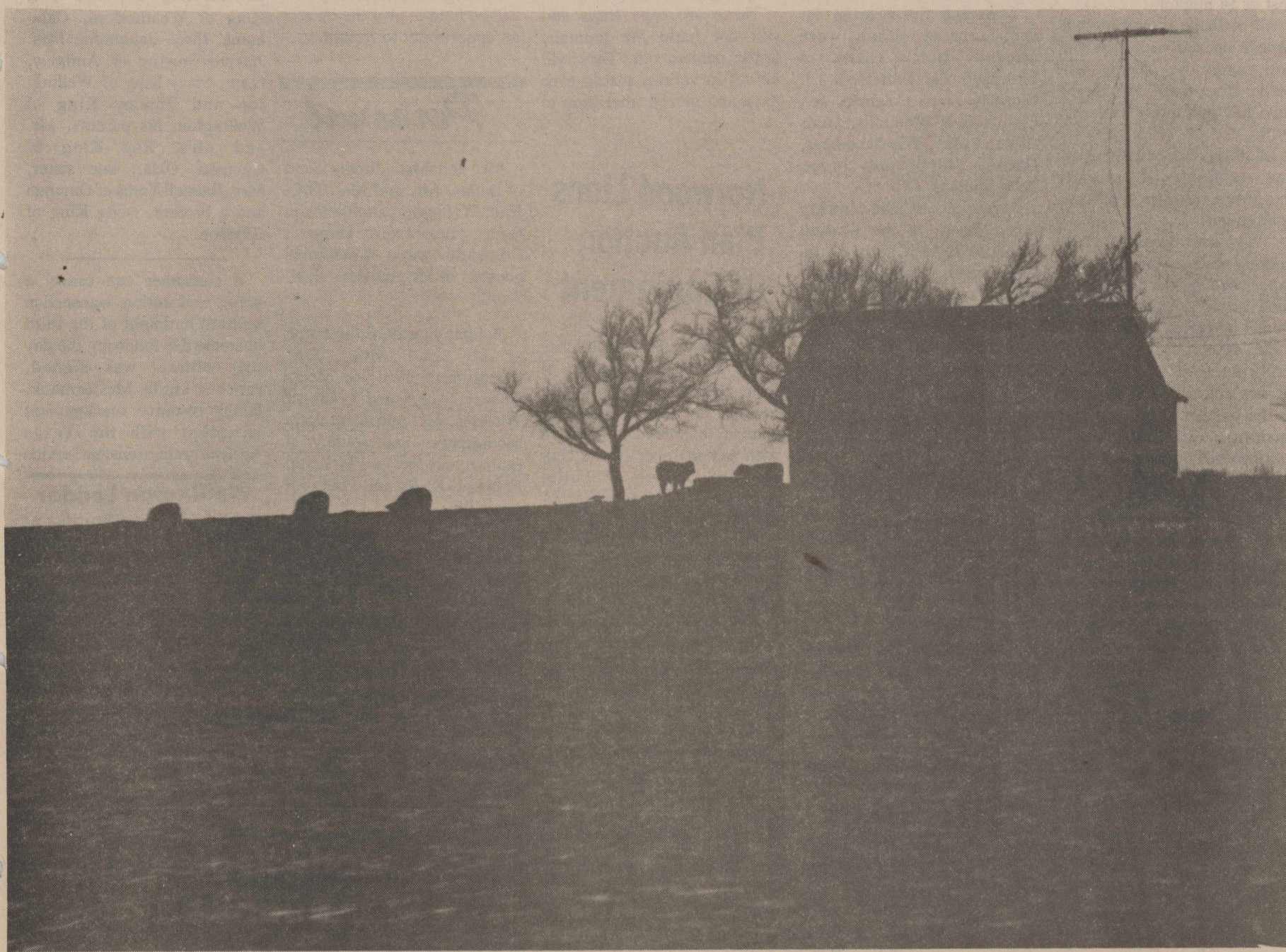

New Year Records Zero Temperature

The coldest weather of recent years settled over the county in the closing days of 1978, with readings of 0 degrees recorded, with estimates that in spots it may have been a little colder.

Wellington came into the new year with an official temperature of 9 degrees. As the weather bureau thermometer is located on the court house square, readings in open country were several degrees below this.

The lowest temperature

was on Tuesday, when three degrees was recorded in Wellington. Readings in the north part of the county were 0 and one degree.

Sleet and snow came in with the cold, and although the amounts were never more than two to three inches on the ground anywhere in the county, travel in Wellington remained hazardous through Tuesday. Highways cleared quickly, and bridges and slick spots were sanded by the Texas Department of High-

ways and Public Transportation, to facilitate travel. Travel on some rural roads was slowed by ice, at no time was it brought to a standstill. Some of the lesser traveled streets in Wellington still had ice Wednesday.

Area ranchers said cattle were suffering in the near-zero weather and a major problem was keeping iced-over water supplies open. Several reported the loss of new-born calves.

TEA Hears Quail School Petition Appeal

The Texas Education Agency Thursday, December 28 heard an appeal of the Collingsworth County School Board decision which denied a petition to detach a large portion of Quail school district and annex it to Wellington school district.

The county board turned down the petition on November 8. Then the taxpayer group which had filed the petition appealed the decision to the TEA. The decision was one of the last actions taken by the county school board, which, along with the county school superintendent's office,

was dissolved by Texas state law on December 31, 1978. All rural and common school districts in Texas have now become independent school districts.

Hearing officer Jay Brim of TEA took testimony from both the taxpayer group, those representing the school district and members of the county school board.

The hearing is similar to a state district court trial and the record of the case was made at the hearing in Austin. Any possible future appeal will be based on the facts presented at the hearing. There will be

no other trial on the matter, Brim said.

After studying the testimony Brim will write a proposed decision. Either side may file exceptions to that proposal, and then Texas Education Commissioner M.L. Brockett will study the proposed decision and the exceptions and make his decision on the appeal. He can either overturn the county board decision or let it stand.

Brim told The Wellington Leader he hoped to have his proposed decision written within 45 days from the date of

New Officials Installed, Look at Problems

Seven county and precinct officials were sworn in for new terms Monday morning, January 1, and an eighth took office later in the day.

Bob Watson was installed as Collingsworth County Judge by Judge R.L. Templeton, who held that office several years ago. Watson succeeds Judge

Zook Thomas, who is retiring after 12 years in office and who did not seek re-election.

Judge Templeton then installed three commissioners, John R. Henard, who was elected to fill an unexpired term in Precinct 1; Joe Frank Knoll of Lutie, Precinct 2; and Raymond Neeley, Precinct 4. Bill Lowe of Precinct 3 is the holdover member.

The third group taking the oath of office were Helen Gollighugh, county - district clerk; Yvonne Brewer, treasurer; Ann Wauer who was elected to fill an unexpired term as tax assessor-collector; and Beatrice McKinney, justice of the peace, Precinct 1.

Later in the day, Judge Watson in his first official act administered the oath of office to Wilson Porter, Constable of Precinct 1.

Outgoing officers in addition to Judge Thomas were Commissioners Melvin Seale of Precinct 2 and W.R. Breeding of Precinct 4, both veteran members of the court.

In an overall look at their job in 1979, the commissioners agreed that top priority probably goes to the construction of the new Collingsworth-Hall county jail and its staffing to meet state and federal guidelines.

All of the construction will take place during the year as well as setting up the operation.

"We have to get some member of the Railroad Commission here to look at the exposed gas pipelines in the county," said Henard. "That's a major hazard to our maintainer drivers. Some of these lines are not even marked."

This matter arose after a county maintainer driven on a dirt road ruptured a gas line 12 miles southwest of Wellington on June 19.

Part of the pipe lines in the county were laid approximately 50 years ago and some of these are near the surface of the ground.

The commissioners said they will work for the general

betterment of the county.

Upswing in Drilling Activity Seen in 1979

The coming year may mark a return to oil and gas drilling in Collingsworth County to a greater extent than in recent years.

Greasy Corner north of Lutie is the site of new drilling activity although other wells have reached production depth or are being drilled in the northwest part of the county. None has been completed. All are shallow wells, ranging in the 2,000 to 3,000 foot depth.

During the Christmas holi-

days, one new well was brought in on land owned by Della Faye O'Neil of Lubbock, with Frank Knoll as owner of half the mineral rights. This is more generally known as the Knoll place.

Mrs. O'Neil told The Wellington Leader she was not aware the well was being drilled until she was notified by a member of her family Monday night.

One well has been drilled to depth, about 2,200 feet on the

Edgar Wischkaemper, Jr., land, located two miles east of Greasy Corner. Again, this well has not been completed. It is the first well ever drilled on this tract.

Wischkaemper told The Wellington Leader two other wells are due to be drilled. The latest of these was revealed last week in an intention to drill filed with the Pampa office of the Texas Railroad Commission. It is designated as the DFC Oil and Gas Co., No. 1, Edgar Wischkaemper

No. 1, 2310' from the south and 330' from the west liens of section 61, block 16. The depth will be 2150 feet or production.

In the northwest part of the county, two wells have been drilled on the Dee Coleman ranch, one in the southeast quarter of section 7, block 23, and the other in the southwest quarter of the same section.

These went to depth of 2670 and 2700.

Drillings started on a well on the Jess Coleman Ranch

just before Christmas, and the last report indicated this was to a depth of 2700 feet.

Wells must be shot to fracture the surrounding rock formations, before production can be known. None of these wells has been shot in so far as could be learned. Pipelines must be laid from the wells to a gathering system, which in this county would probably be El Paso Natural Gas or Diamond Shamrock Pipelines.

Well operations have up to two years to complete this.

American Ag To Meet Jan. 8

An American Agriculture meeting has been called for Monday, January 8, to lay plans for the county's part in the upcoming tractorcade to Washington D.C.

The meeting will be at 8:00 p.m. in the directors room of Greenbelt Electric Cooperative Inc.

"All business people and farmers are invited to attend," said Doug Seal, an American Ag leader.

"The purpose of the meeting is to get 8 people to sponsor one tractor in the tractorcade," he explained.

Tractors will leave Amarillo Monday, January 15, for Washington. This is a new date, Seal pointed out.

Interest is growing in this, the American farmers first protest move of 1979, he said.

Those wanting more information may call Seal, David Caison or Denzil Lacy.

Collingsworth County American Ag is also making

plans for anyone interested in flying to Washington D.C. for the week that the tractorcade will arrive in Washington.

Denzil Lacy said that a group discount fare of \$199 round trip had been arranged, and that a group of rooms had been blocked at Skyline Motel in Washington, the American Agriculture headquarters for the tractorcade.

Lacy said plans needed to be finalized next week, and he asked anyone who was interested in going to attend the meeting should call the local American Agriculture office, 447-5012, for information.

"This is our big chance to get something done about farm policy," Lacy said. "And we want to encourage everyone, not just farmers, to go to Washington and help lobby for a better local economy."

The group will leave Sunday, February 4 and return Friday, February 9.

Livestock Show To Be January 13

The annual Youth Livestock Show will be held Saturday, January 13, Extension Agent Don Reeves announced this week.

It will be held in the Livestock Show Barn on Amarillo Street between 7th and 8th, and starting time will be 1:00 p.m.

Paul Sammons of Canyon, assistant extension agent, will be the judge.

"The calf show will be competitive, since they are much alike straight across," Reeves said.

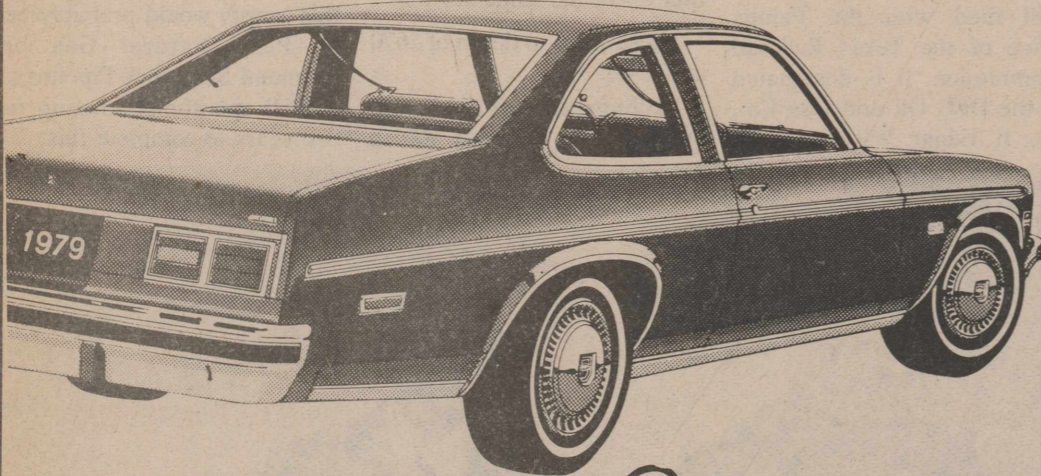
The money will be used for their loss prevention program.

The entire month of December was colder than usual, according to Mrs. Vern Barton, who keeps the Weather Bureau records.

Low readings for the month never got above 50 degrees and that was on December 20. The first few days of the month registered 35 and 26 degrees, and the below freezing lows prevailed until December 19, when a 42 was shown, followed by 50 degrees on December 20.

Most of the low readings were in the lower 20s.

On December 8, the temperature dropped to 15 degrees, and on the next two days, area residents awoke to 10 degree weather.

Several ice-related accidents occurred in Wellington, according to Chief Deputy Sheriff Jerry Settle.

The car driven by Gwdon Thomas of Route 1, Savoy, driving on US 83 December 30, skidded on ice, went out of control and hit a steel pole at a closed service station at 7th Street and US 83. The driver was not injured Settle said but there was considerable damage to the car.

In another ice-related accident, cars driven by Mrs. Benny McDanel and Mr. Hazel McKinney collided on the north side of the square, according to Settle.

Neither driver was hurt and there was only minor damage to the vehicles.

In the third accident, a late model pickup driven by Channy Wood skidded into a parked car belonging to Joe Cummings at the corner of 15th and Ruffin Streets. Wood was not injured and damage was described as minor.

Much of their time will be given to the routine operation of the county's business.

It was brought out that taxes which are now being collected do not include the upsurge in construction Wellington has experienced during the last year, and construction of the Perry Gas Pipeline through the county, at an estimated cost of \$4 million.

All of these properties will appear on the next tax roll, and taxes the county will derive from them will not be collected until after October 1, 1979.

All of the money the county has available is already budgeted Judge Watson pointed out.

"We are going to be working with a young court, as experience goes, but a very good group of hard working men," he added.

He spoke of the varied experience of the commissioners and called it an asset to the county. This includes farming, ranching, heavy equipment operations, gin management, and back-grounds in business.

The commissioners will hold their regular meeting Monday, January 8, and a special meeting has been set for Thursday, January 11, when bids on the new jail will be opened.

Resource Conservation Act To Affect Salt Fork SWCD

In November 1977, the Congress and the President of the United States enacted legislation that will have great effect upon the USDA and resource conservation activities in the years ahead. This legislation is Public Law 95-192. It is known as the Soil and Water Resources Conservation Act (RCA).

The purpose of the Act is to ensure that the programs administered by the USDA for resource conservation will be most responsive to the nations' long-term needs. The Soil Conservation Service of the USDA is the agency charged with leadership in implementing the Act.

The Act requires that several reports be submitted to Congress. These include an appraisal of the present status and condition of the nations' soil, water and related resources, and a soil and water conservation program based upon the appraisal which will guide future USDA conservation activities. Both are to be completed by December 31, 1979 and updated at each five-year interval thereafter.

Other reports to Congress are to contain policy statements on USDA soil and water conservation activities, budget comparative reports, and a program evaluation report.

"The Soil Conservation Service is presently involved in the resource appraisal and

program development phases of this Act," said Tommy Powell, District Conservationist with the Soil Conservation Service at Wellington. A public participation meeting was held in Wellington last May 23 to solicit public views on resource conservation and program needs and priorities. The meeting was sponsored by the SCS and the Salt Fork Soil and Water Conservation District.

Powell continued, "The SCS has felt from the very beginning that public views and ideas would be essential in developing the most responsive and workable conservation program for future years. This is why we have solicited serious input from local conservation districts and the general public to aid in setting program needs and priorities. We continue to solicit such ideas at every opportunity."

The single overwhelming public view voiced thus far has been that landowner participation in conservation programs should be of a voluntary nature. Most people have also felt that existing conservation programs have made important contributions to resource conservation, and that the cost share incentive offered by some programs is needed to allow landusers to install conservation measures under

present agricultural economic conditions.

Many other views and ideas of a more specific nature have been voiced by the public at different localities across the nation.

Powell concludes, "Let me again encourage people to express their ideas on this subject. We would prefer written opinions or ideas, because they are easier to transmit; but even oral statements would be of great value. Contact us at the Soil Conservation Service office in Wellington, or see one of the Directors of the Salt Fork Soil and Water Conservation District."

Accurate Records Mean More Accurate Returns

Taxpayers who keep good records during the entire year will be better prepared to file a complete and accurate tax return, the Internal Revenue Service said.

By keeping good financial records, the taxpayer can not only substantiate expenses, income, and itemized deductions listed on his or her tax return but also be aware of certain deductions that might otherwise be overlooked.

Taxpayers are not required to keep any particular types of records, but they must retain all receipts, cancelled checks,

and other written documents to prove their expenses.

These records must be kept for a least 3 years from the date that the return was due or filed or 2 years from the date that the tax was paid, whichever occurs later.

Some records should be kept even longer, the IRS advised, such as property records which should be retained as long as they are useful in determining the basis of the original or replacement property. In addition, copies of past tax returns can help the taxpayer prepare future returns.

For additional information on recordkeeping, taxpayers can order the free IRS Publication 552, "Record-keeping Requirements and a Guide to Tax Publications," by sending in the order blank found in the tax package.

Roast Prime Ribs of Beef Angus was offered at the same price.

Palace Drug, owned by T.E. Benge and W.H. Andrews, advertised these perfumes: Houbigant, DuBarry, Three Flowers, Coty, Fiancee, D'jer Kiss, and others.

On another page, Cochran Drug advertised leather goods

It is one of the few firms advertising then that is still doing business in Wellington. Those who did not want a Chevrolet, could buy a Durant two door sedan, coupe or roadster for \$595. J.F. Holley and W.A. Cook, Sr., were dealers. Goodwin Funeral Parlor also sold Columbia Portables, Majestic radios and Columbia records.

Another still in business was Warrick's Feed Store, now Warricks, Inc. J.E. Warrick was owner.

A subscription to The Wellington Leader was \$2.00. A few years later, in the depression, it would drop to \$1.00 during bargain days.

The Leader Store, now Saied's, had silk hose for 39 cents and 36 inch percale for 15 cents a yard.

The Famous Dry Goods Store, priced its ladies coats with fur collars from \$14.95 to \$24.95. Men's leather lumberjackets were \$7.85.

The high school paper, with Blanche Saied as editor-in-chief, was called The Sage.

Wellington's Growth Calls For More Work During 1979

If Wellington ever had a good base from which to start a new year, 1979 should be it. The economic momentum from the operation of Southwestern Rail Products, Inc., and an unparalleled residential building boom, will give economic strength in 1979.

But there are other needs that must be met in Wellington if we are to continue growing and remain fiscally sound.

Several other industries are looking at Wellington for a location, although there is nothing definite at this time. The favorable business climate we are enjoying must be encouraged.

Certainly high on the list is improvement of Marian Airpark. The city council has hunted until it found a possible source of funding. If this is secured it will give us an airport runway that will handle executive jets and other planes that cannot presently land here. That is the first step.

We are no nearer to securing ground passenger transportation out of Wellington than we were a year ago, and if we can read the signs right, it is going to be more important to us as the energy shortage grows.

A crisis in our health care system in 1978 has determined what we will have to do in 1979 and this is secure adequate financing for the hospital and to bring more doctors to Wellington. That is a big order for any town.

Progress was made in surfacing the streets north of the business section. Some remain to be paved, and work in the southeast part of town, for which funding is approved, is to be carried out. This will open desirable lots in two sections where building has been static for a number of years.

In spite of our housing boom we still lag in construction of housing for the low income elderly.

Make a list of your priorities for Wellington in 1979. It probably will be different to this one, but with everyone working together, Wellington should have a banner year in 1979.

Other Editors Say ...

Poor Public Relations

The Tortilla Curtain, the barrier fence to be erected, Berlin Wall fashion, along the Texas-Mexico border, is an incredibly poor piece of public relations, casting the U.S. in the role of bully over a weaker neighbor.

Worse, the Tortilla Curtain will not have any significant effect on illegal immigration. Where there's a will, the illegal alien will find a way, and as long as a sharp difference in economic climate separates the U.S. from Mexico, the flood of illegal immigrants.

More than 1,000 Mexicans move into the Houston area each week, according to a study by a migration expert, Louis Alfonso Valarde, with U.S. Catholic Conference in El Paso.

"I don't think there is a solution to the undocumented alien problem," said Valarde, "Congress can put patchwork legislation together to help alleviate it, but there is no permanent solution. We could erect a Berlin Wall along the U.S.-Mexico border tomorrow and it wouldn't stop the flow of illegal aliens.

"The reason most of them come into the U.S. is jobs. If our economy wasn't so much better than their own, they would have little or no reason for being here."

He added that for every job created in Mexico today, four people are born who need it to survive. So if there's no present solution, what the problem needs is understanding until a solution can be found. Such understanding is impossible as long as the fence barrier is the most original "solution" that can be devised.

STATE CAPITAL HIGHLIGHTS

AUSTIN — Seven state agencies and the U.S. Department of Justice entered historic agreements ending a 14-month dispute over alleged job discrimination in state government.

Separate orders were signed before U.S. District Judge Jack Roberts committing the agencies to affirmative action programs to improve job opportunities for minorities and women over a five-year period.

Assistant Attorney General Steve Bickerstaff, who headed negotiations for the state, said the settlement is unprecedented over the nation, because it also binds the federal government to assist state agencies in their efforts.

State Rep. Paul Ragsdale, an activist in the fight against job discrimination, called the settlement "the most significant stride toward true equal employment opportunity ever taken by this state."

All seven agencies denied any pattern of discrimination against women and minorities in their recruiting, hiring and promotion practices. But they agreed to specific goals of equal opportunity in future hiring and promotion, under justice department monitoring.

Instead of the old quota systems, the agencies are supposed to hire minorities and women in proportion to the "relevant labor force" for each group or class of employees.

Three-member "employee specific relief panels," will assess complaints and compensation for job denial, and monetary payments can be made ranging from \$250 to \$650 a year over a three-year period.

Entering agreements were the Merit System Council,

Department of Human Resources, Department of Health, Texas Employment Commission, Parks and Wildlife Department, Rehabilitation Commission and Texas Alcoholic Beverage Commission. Texas Department of Highways and Public Transportation, named in the original justice department complaint in October-November, 1977, declined to join the agreement. The Agriculture Department was dropped from the complaint.

Texas legislators will be coming back to town next week, for their biennial session beginning January 9.

A variety of major issues confront them.

Included on the agenda is the state \$18 billion budget, tax reduction schemes, school finance and other associated money problems, election law revision including consideration of reviving the Texas presidential preference primary, initiative and referendum proposals by which citizens in some states are allowed to initiate or veto legislation, the problem of products liability law changes, and proposed increases in the 10 per cent ceiling on home mortgages.

Governor-elect Bill Clements has taken strong positions on some of the key issues, placing him at odds with legislative leadership—mainly in the area of tax reduction. Clements demands a billion dollars in relief, in addition to that granted by the tax relief amendment of last November 7. Top legislators say the money just isn't there.

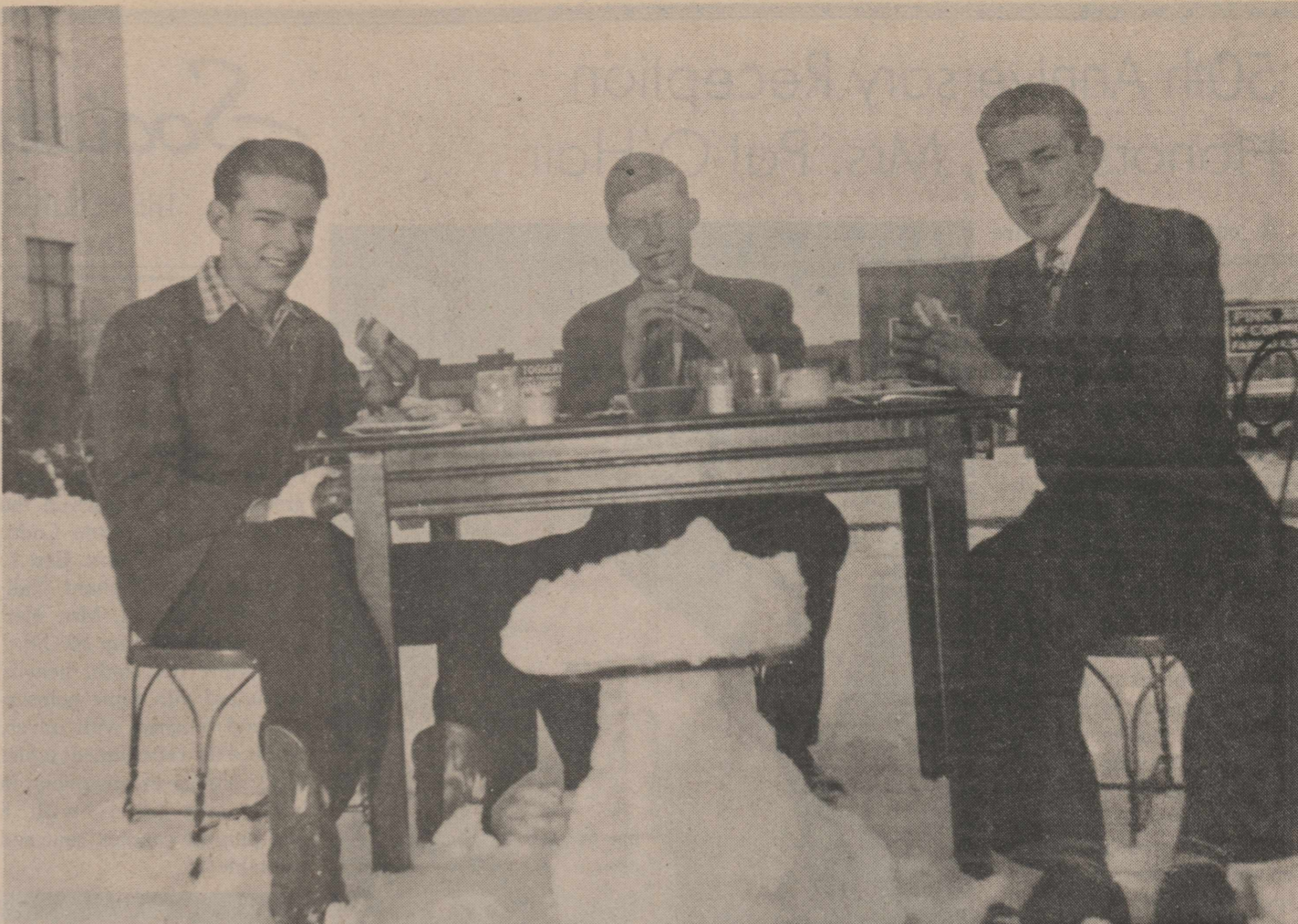
Clements has threatened vetoes and special sessions if he doesn't get consideration out of the legislature on some key points in his program.

Uncertainty over what to expect has lobbyists and other veteran legislative observers uneasy.

Homes Criticized

An attorney general's task force charged patients are abused or neglected in a small minority of Texas nursing homes and blamed the Texas Department of Health for lax enforcement.

The task force report claimed the health department takes a protective attitude toward the industry it is charged with regulating.

Three legislative proposals were advanced: direct fines for violations of standards, a receivership statute to crack down on serious abuses and right of patients to bring private actions to redress abuse and neglect.

A commissioner's court is

not required to approve a salary or budget recommended by a juvenile board.

A bank may participate on a fee basis in a cash dispensing machine network operated by a corporate vendor without violating the constitutional prohibition against branch banking.

A justice of the peace or municipal court judge has no authority or power to change a complaint charging a moving violation to a non-moving violation.

Gov. Dolph Briscoe appointed Travis E. Knowlton of Huffman and James E. Hood III of Richardson to the Polygraph Examiners Board and H.W. Monzingo of Del Rio to the board of regents of the Texas State Technical Institute.



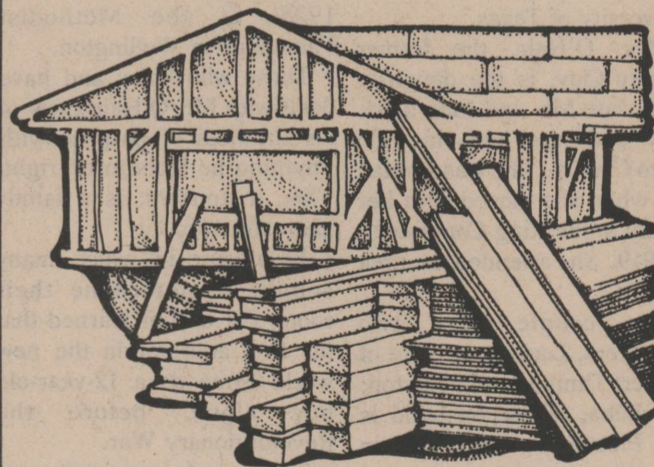

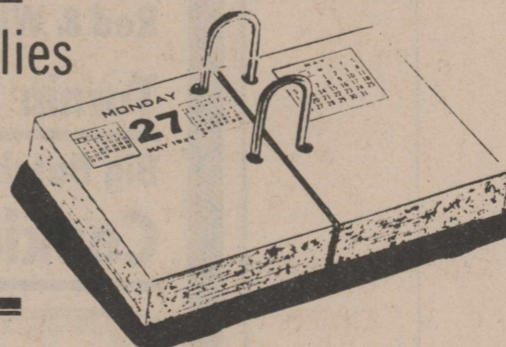

VA Pensioners Income Report Due

Elderly pensioners who this year must complete a Veterans Administration annual income report may find they qualify for higher pension, Jack Coker, Waco VA Regional Office Director, said today.

"We have asked all major national veterans organizations and veterans county service officers to help us assist pensioners age 72 and older in filling out the income form and, of course, all our local VA offices are staffed with benefits counselors who are standing by to provide any assistance requested," Coker said.

Because VA pensions for disabilities not related to military service are based on income, pension recipients must report the amount of their income from other sources to VA annually, Coker explained.

Exempted from the report in the past were veterans age 72 and over who had been on the pension rolls during two consecutive calendar years. Their exemptions meant that they did not have to file a full report, but the law required them to report any material changes in income.

Poison Hazards Greater With Cold Weather

COLLEGE STATION--Carbon Monoxide poisoning becomes increasingly dangerous as colder weather sets in, points out Dr. Gary Nelson, agricultural safety engineer with the Texas Agricultural Extension Service.

Enclosing of homes, garages, shops and other buildings that contain open fuel-burning appliances increases carbon monoxide contamination which kills hundreds of people each year in the United States. However, the most common cause of carbon monoxide poisoning is exposure to engine exhaust fumes, either by being inside the vehicle or being enclosed in a garage or shop with the engine running.

Fatal carbon monoxide poisoning occurs when fuels burn incompletely, as most of them do. This causes a buildup of carbon monoxide unless adequate ventilation is maintained, says Nelson.

Avoid carbon monoxide poisoning in the home by getting an expert to inspect fuel-burning equipment yearly to keep it operating efficiently. The engineer also offers

these suggestions:

-Vent all fuel-burning heaters to the outside. Also, never use a charcoal grill or hibachi inside; charcoal gives off a large amount of carbon monoxide.

-Vent properly all coal, oil or fuel-burning heaters in the shop or garage. Do not run engines unless the building is wide open to outside air.

-In cars, trucks and other enclosed vehicles, check the exhaust system for leaks that may enter the vehicle.

Symptoms of carbon monoxide poisoning include drowsiness, headache, dizziness, blurred vision and inability to concentrate. High Concentrations cause severe poisoning which produces nausea.

Commissioners Hold Last 1978 Meeting

Collingsworth County Commissioners Court held its final 1978 meeting on Friday evening, Dec. 29, to consider several items before Judge Zook Thomas and three commissioners ended their terms in office.

Taking precedent was the removal of the radio tower serving the sheriff's department from its present location a few blocks north of the court house to a new site at the northeast corner of the city landfill.

This move was required by the Federal Aviation Agency because it is in a direct line of approach to the present airport runway.

"Presently it appears that Motorola will move the tower and the county has agreed to dig the holes for the footing and move the tower building," said the new county judge, Bob Watson.

bill which the county received from Lone Star Gas for repair to a gas line ruptured by a county maintainer June 19. The statement was received Dec. 15.

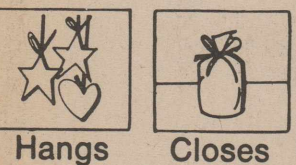
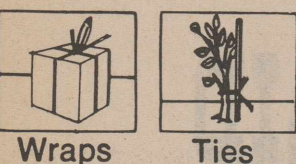
