# Photos Of Dismantling Shown; No Checkup Yet

WASHINGTON (AP)—The United States made public Saturday photographic evidence of the dismantling of Soviet missile bases in Cuba but the vital question of checking the rockets out of the island remained unanswered.

At the United Nations, Acting Secretary-General U. Thant expressed optimism that an inspection agreement—acceptable to the United States, the Soviet Union and Cuba—is near. He declined to estimate when it would come but informed sources at the United Nations indicated the United States and the Soviet Union already are agreed on basic principles. Cuba at least not flatly opposed.

The International Red Cross seemed a likely possibility to take over the inspection role as an alternative to U.N. inspection which both Moscow and Washington favor but which has been rejected by Cuba's Prime Minister Fidel Castro.

At its Geneva headquarters, the Red Cross said it would be willing to assume such a role provided all three interested parties agree. President Kennedy met for two hours with U.N. Ambassador Adlai Stevenson and the Executive Committee of the National Security Council, then left shortly before 7 p.m. EST to join his family at their leased Glen Ora estate near Middleburg, Va.

The White House gave no details, but Ambassador Stevenson told reporters on his way out of the White House the discussion concerned the progress of the negotiations with Secretary General U. Thant and the defense minister in implementing the agreements reached by President Kennedy and Soviet Premier Khrushchev for the removal of the Soviet missiles on Cuba.

Stevenson said, "a great many problems are still unresolved" in the case, ruled that Latham and York had been granted a fair and impartial trial.

Stevenson replied "that remained to be seen." He added that whatever decision was finally reached in this regard would be firmly safeguarded U.S. security.

In reply to another question Stevenson said the possibility of using the international Red Cross to inspect the missile sites was not being discussed. The next big development in the crisis seemed to hinge on the outcome of talks in Havana between Castro and Anastas I. Mikoyan, Soviet first deputy premier and ace troubleshooter for Premier Khrushchev.

Mikoyan reached the Cuban capital from Moscow after a New York stopover during which it was believed that the United States made clear to him its determination to persist in its limited aerial blockade and aerial surveillance of Cuba until it has firm proof not only that the missile bases are being destroyed but that their nuclear rockets are being removed from Cuba — as pledged last Sunday by Khrushchev.

The Defense Department released Saturday some of the photographs made during low-level aerial reconnaissance flights over Cuba on Thursday. They bore out statements made by President Kennedy and Secretary of Defense Robert S. McNamara on Friday that the raising of the hastily erected nuclear weapons bases has begun.

But the pictures released dealt only with the medium-range sites—a fact which a defense spokesman said had no significance—and naturally gave no final answers on what is happening to the rockets removed from the bases. The International Red Cross originally moved into the picture

as a possible source for inspectors for Cuba-bound ships, acting instead of U.S. naval officers in this role — although presumably from U.S. warships in the blockade zones.

But with Castro's rebuff of Thant's effort to put a U.N. inspection force into Cuba last Wednesday, the Soviets suggested that Red Cross representatives might assume a broadened role.

U.S. officials maintained the cautious optimism which has been Washington's position since Khrushchev's broad concessions in last Sunday's letter to Kennedy.

The policy remained that there must be some satisfactory inspection to insure that rockets are not being hidden away on the Communist-ruled island after the launching bases are dismantled—a trick which some Cuban refugees claim already is being pulled.

There appeared to be no tendency here to insist on a U.N. inspection team but neither was there any sign that the United States will settle for anything less than conclusive evidence that the deadly missiles are safely aboard ships sailing away from Cuba. U.S. military intelligence is believed to have a pretty good estimate on the total number of rockets imported.

The Defense Department would not say whether further surveillance flights were carried out Friday and Saturday but it was assumed they would continue as long as needed—along with the naval blockade against ships carrying any more offensive weapons to the island.

## Saboteurs Hit Again In Venezuela

## U.S. Soldier Is Killed In S. Viet Nam

By MALCOLM W. BROWNE SAIGON, South Viet Nam (AP)—A U.S. Army sergeant facing ammunition to a machine gun aboard his escort helicopter was fatally wounded Saturday as the South Viet Nam government scored one of its biggest successes in months against Communist guerrillas.

Another escort helicopter pilot had a narrow escape — a bullet pierced his armored vest just over the heart. He suffered only a bruise but turned the controls over to the copilot.

The dead Army sergeant was identified as Johnnie G. Lee of Houston, Miss.

Five HU1A helicopters escorted 10 other helicopters lifting a battalion of Vietnamese troops into a battle 60 miles southwest of Saigon where Viet Cong guerrillas nearly overran an outpost in the Vinh Long area last Wednesday. The government launched a counterattack that has been going on since.

Government sources said enemy dead in the four-day operation may number as high as 200. In Saturday's action, government soldiers had piled up 33 Communist dead by noon, and informants said the total dead for the day might be 100.

South Vietnamese losses also were large. Returning pilots poured more than 100 rockets into the enemy area, an estimate they had killed about 20 guerrillas.

The helicopter crews are instructed to withhold their fire until attacked, but they usually do not have to wait long. The Viet Cong apparently badly hurt by the HU1A escorts, have taken to concentrating their fire on the turbine-powered craft armed with rockets and machine guns. There is scarcely a helicopter of the escort unit which arrived from Vinh Long last night that was not hit.

Sgt. Lee was slain with a rifle in the United States and a child he had not seen. His wife was listed as Marie Lee of Houston, U.S. casualties in Viet Nam since last December are now 55 killed and 85 wounded. The figures include accidental as well as battle casualties.

For the second unit it was the first casualty in Viet Nam. But it was the first in a series in which it had been involved.

## Sentences Are Upheld

TOPEKA, Kan. (AP)—Death sentences for two AWOL soldiers convicted of killing a Kansas railroad man while on a crime spree were upheld Saturday by the state supreme court.

James Douglas Latham of Texas and George Ronald York of Florida were convicted in 1961 and sentenced to hang last Jan. 20. The execution was stayed to permit appeal to the Kansas Supreme Court.

## Estes' Lawyer Declines To Call Witnesses; Rests Case

TYLER (AP)—Veteran courtroom strategist John Cofer, rest of the case, ruled that Latham and York had been granted a fair and impartial trial.

Jack Carswell, Constitution party candidate, was in Victoria. None of the candidates planned special campaign Sunday.

Monday, Cox will get a breakfast-time airport rally from homebats in Breckenridge, then make flying visits to San Antonio, Fort Worth and Dallas. He ends the campaign with a statewide television speech Monday night from Houston.

Connally has nothing scheduled Monday until his campaign-ending speech that night from Austin.

## Chinese Complete Ladakh Conquest

NEW DELHI, India (AP)—Invading Chinese were reported rapidly completing their conquest of Ladakh on Saturday, giving the Chinese the western end of India's Himalayan frontier.

U.S. Ambassador John Kenneth Galbraith had warned Indians to expect no "magic results" from the U.S. weapons arriving in Calcutta and transported immediately to army camps in the northwestern section where the Indians have suffered heavy reverses in attempting to defend the Himalayan ramparts of the Assam plains.

Most of the 2,000 to 2,500 missing and dead, the only Indian casualty figures officially announced, have been lost on that front.

# OUR VIEW

## Amendments 4 And 7 Merit Support By Texas Voters

Fourteen amendments help lengthen the general election ballot which will confront Texas voters on Tuesday. Although it appears our state constitution is becoming such a hodge-podge that it probably should be revamped from stem to stern, the 14 proposed amendments reflect issues which have arisen in modern times and they must be resolved by the voters.

We can go along with all of the proposed amendments, except No. 14 on the list, which is popularly known as the "trial de novo amendment." We believe adoption of Amendment No. 14 would be a severe blow to grass-roots democracy—the right of people at the community and regional level to handle their own affairs.

Four of the proposed amendments, No. 3, No. 9, No. 12 and No. 13 are purely local or regional in scope and do not concern Snyder or Scurry County.

For the benefit of those who may not be familiar with the other proposals, here is a thumbnail rundown on the others:

No. 1 would provide for insurance for state employees. No. 2 would raise the limit on total funds the state could spend for the needy aged, needy blind and needy children from \$47 million per year to \$52 million per year.

No. 4 would permit the State Water Development Board to acquire storage facilities in reservoirs and thus hold water for use during shortages.

No. 5 would set up the procedure for creation of hospital districts.

No. 6 would authorize a retirement plan for public officials serving a minimum of 12 years.

No. 7 would provide for continuity of government during emergencies.

No. 8 would put a ceiling on state payments to the permanently and totally disabled.

No. 10 would allow state employees to serve on advisory committees for agencies and to serve on public school boards upon approval by proper authority.

No. 11 would permit the resale of lands of the Veterans Land Fund.

We believe that No. 4 and No. 7 are particularly needed.

## Voroshilov Gets 'Honor'

MOSCOW (AP)—Former president Kliment Voroshilov, denounced last year as an old Stalinist by Kremlin leaders, today was permitted the honor of writing in Pravda and denouncing Stalin and the Americans.

He wrote the article in honor of the 48th anniversary of the Bolshevik Revolution, which will be celebrated Wednesday.

At last year's celebration, Soviet plain clothes police prevented Voroshilov from climbing atop Lenin's Tomb to join Premier Khrushchev in a review of the military parade in Red Square. Voroshilov, 81, began his article

by saying communism had brought great rewards to the Soviet people.

"It goes without saying that these successes would have been much greater if during J. V. Stalin's lifetime there had not been violations of the Leninist norms of party life, crude violations of socialist legality which caused tremendous harm," he said.

Voroshilov devoted most of his article to an angry attack on the United States and its role in the Cuban affair.

A thousand-foot shaft was started in October 1962 on the west coast of Puerto Rico, as a new project of Project Mohole, the effort to pierce the earth's crust for the first time.

## Krush Says Workers To 'Bury' U. S.

BRUSSELS, Belgium (AP)—Soviet Premier Khrushchev has told a Belgian parliament member American workers will eventually "dig capitalism's tomb."

The interview was granted in September to Raymond Scheyven, a member of the Social Christian party, and published today in the Brussels newspaper 'Le Soir.'

"There are in the United States enough workers to bury capitalism," Khrushchev said. "They will do it and not me. And they will do it inspired by the Marxist-Leninist doctrine."

Khrushchev said that "capitalism will certainly be liquidated and replaced by communism" but expressed the belief that for the present the two should use the best in each other's economic system.

"We are ready to coexist," he said, "and reject forever the solution of disputed problems through the means of war."

Speaking of Cuba—a month before the crisis over the Soviet buildup of missiles there—Khrushchev said: "What does frighten American imperialism so much? It's not Cuba, it's Cuba's ideas, ideas of Marxism-Leninism which represent the strength which shakes the world."

The Soviet leader declared, "We will never pull out the sword first to attack other countries."

He once again plugged the theory that capitalism would eventually be defeated from the inside and not through "the victory of Socialist countries over capitalist countries which now exist."

## Husband Fee Is Returned

LOS ANGELES (AP)—Mrs. Dorothy Alzmann, who says she paid \$10,000 for another woman's husband, now reports that she has her money back.

She told Sheriff's Sgt. P. R. Shields Friday that she had accepted a cashier's check from Mrs. Norma Babcock, 44, of suburban Baldwin Park.

Central figure in the alleged transaction was Mrs. Babcock's husband, Quentin, 44, an insurance agent.

Mrs. Alzmann, 34, a widow, had filed a civil suit alleging that Babcock returned to his original home a day after taking up residence in her house at Glendora last April. She said she was returned only \$3,000 of the sum she "paid" for Babcock.

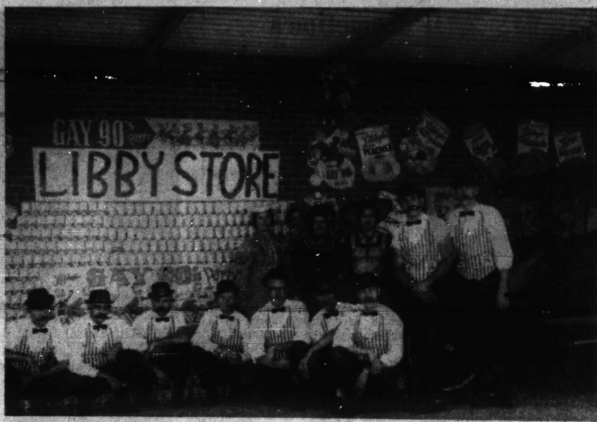

## Powers Quits Post At CIA

WASHINGTON (AP)—Francis Gary Powers, the U2 pilot who was a Soviet captive for 21 months, no longer works for the

Central Intelligence Agency. A CIA spokesman said Friday night that Powers resigned effective Oct. 6. "He had finished his work with us," the spokesman said.

Powers' U2 reconnaissance plane crashed while over Russia on May 1, 1960. He parachuted to safety, was captured, and convicted of spying. He was freed last Feb. 10 in an exchange for Rudolf Abel, a Soviet spy imprisoned in the United States.

When Powers returned, the CIA said he had lived up to his \$2,500-a-month contract and would be retained for an undetermined period.

Neither the CIA spokesman nor Powers' father, Oliver Powers, would give any information on Powers' whereabouts or plans.

**Judge Talks With Panel**  
AUSTIN (AP)—The House General Investigating Committee talked with Gladewater Dist. Judge David Moore for half an hour Saturday about East Texas slant oil well drilling. "He completely purged himself of any possibility of being held in contempt by the committee," Rep. Charles Ballman of Berger, chairman, said after the closed session. Last month in Dallas, Moore was one of several witnesses subpoenaed who did not appear. In previous hearings, Moore had been described as part owner of several oil wells drilled on a slant. Moore has denied any knowledge of the wells being slanted or deviated. "Since Judge Moore was unable to appear in Dallas because he was in court, he wanted to offer his cooperation to the committee," Ballman said. "He knew we had some questions and he gave us the answers." Ballman said Moore appeared voluntarily. The committee chairman called another executive assistant Roy T. Austin to discuss another missing witness, Gregg County Judge Earl Sharp. Ballman said Sharp has been served one subpoena and several other have been issued. None resulted in Sharp appearing as a witness. "Next Thursday we expect to make a statement after the meeting on whether Judge Sharp will be cited for contempt of the committee," Ballman said. Ballman said the committee's legislative recommendations concerning the slant well drilling investigation are in the final stages of preparation.

# Below Is The Complete Story Of Box 13-Jim Wells County, Texas!

For Coke R. Stevenson, three times Governor of Texas, Number 13 ended a long, illustrious public career, and returned him to his little ranch, completely crushed and disillusioned.

For Lyndon B. Johnson, Number 13, gave him a seat in the United States Senate, and launched him on a political career that is, by all reckonings, without parallel in American political history.

The 13 with which we are here concerned is the number of a voting precinct in deep South Texas. This Precinct No. 13 is in Jim Wells County, and includes the county seat of Alice.

In the overall picture of Texas Statewide politics, Precinct No. 13 is not now, and never was, important. In 1948 when it dominated for a brief span the headlines of the nation's newspapers from coast to coast, its maximum voting strength was on the books at slightly more than 800.

In the Senatorial election between Stevenson and Johnson, only 600 ballots were originally issued by the election officials. But, these were stretched to where the first returns gave Johnson 765 votes to Stevenson 60; and, when four days later, Johnson still trailed in state totals by 113 votes, the returns in number 13 were "corrected" to give Johnson a new total of 967 votes and Stevenson 61.

The 200 votes picked up by Johnson in this "corrected" return from Precinct No. 13, gave him a statewide majority of 87—a lead that was maintained in an 8-day contest in which the beleaguered forces of Gov. Stevenson were staggered by low blows, dazed by foul blows, and finally counted out by Justice Hugo Black, of the U.S. Supreme Court, with an order, angrily attacked by a Texas Federal District Judge as "too hasty" and "doubtless unlawful."

Five days after the election, with returns from all counties unofficially tabulated, Stevenson was in the lead by 113 votes. Despite this, however, Johnson took to the air with a "victory" speech Thursday, Sept. 2. "We have won," was his continual refrain.

This broadcast alerted and disturbed the Stevenson forces. Johnson's enthusiastic assurance was unmet in the face of all the known facts. Their fears were validated the following day, Friday, Sept. 3, when a source friendly to Stevenson reported from Jim Wells County that Precinct No. 13 had been canvassed that morning and a "correction" made favoring Johnson with 200 more votes.

JOHNSON'S radio forecast on Thursday, thus became a reality on Saturday. Precinct No. 13 had been corrected from Johnson 765-60 to Johnson, 967-61. This gave him a lead of 87 votes; with returns now complete and semi-official.

The State Democratic Executive Committee was to meet Sept. 13, in Fort Worth to officially canvass the returns. As the newly sub-committee had been convened, however, to receive and tabulate the returns; and this subcommittee, meeting in Austin had announced acceptance of the "corrected" returns from Precinct No. 13.

CHALLENGING in vain acceptance of the new returns by the subcommittee, Gov. Stevenson on Saturday, asked two of his workers, Kellis Dibrrell and Jim Gardner to go to Parr's country and investigate. Going by Laredo to pick up a loyal pilot, they arrived Monday morning and were joined at noon by Gov. Stevenson.

The three located George Parr in his office at San Diego. Johnson's campaign manager, John Connally, had been there to it. He had arrived the preceding day.

To their demands to see the poll list and returns from Duval County, which had been reported for Johnson, 4,622-38, Parr showed astonishment that they should ask him. He knew nothing about the election returns.

Crossing over into adjoining Jim Wells County immediately, the Stevenson forces, found reason for encouragement. Harry Adams and H. L. Poole, newly elected chairman and secretary, respectively, of the Jim Wells County Democratic Executive Committee, were already trying to upset the "correction" from Precinct No. 13 that had been made and reported by the old committee officials.

ADAMS AND POOLE had seen the "corrected" poll list the preceding Friday; and reported to Gov. Stevenson, that the new 200 names had been added in green ink, alphabetically, whereas the main list was in black ink. But, they were present of the account, only as spectators. The old committee secretary, Tom Donald refused to turn over the poll list and retain custody against vigorous protest of the new officials.

The revised poll list was in the vault of the Parr bank, where Tom Donald was an employee. Plans were laid to get possession of the list when the bank opened the following morning.

Overnight, tension had mounted to a high pitch. Dibrrell and Gardner sent out an urgent call for help to check the entire voting list and recruits began arriving hourly. Wild rumors they were all armed, former FBI men, spread rapidly and the newspapers reported an emergency call had gone to Austin for Texas Rangers.

Three men trailing Winchester were in position in front of the bank early the following morning. Gov. Stevenson wisely ordered his forces to appear in public only in their shirt sleeves.

As the hour approached for the bank doors to open, armed men sauntered onto the scene and took positions with an ominous silence.

Gov. Stevenson and his closest investigators arrived, escorted by Ranger Captain Frank Hamer. Not a word was spoken as the Ranger Captain took position directly before the bank door. The veteran Captain was well known to every man there. He was known as a stern, inflexible, officer who exacted, one way or another, prompt and strict obedience to his orders.

He waved the armed men to fall back from the bank door and they did. Very promptly the door opened and Gov. Stevenson and his men entered. Captain Hamer forbade any others to follow. None tried. Witnesses said later the Captain never lifted his pistol, nor even touched it; but Johnson charged him with force, threats, and intimidation.

Donald agreed to let the Stevenson forces see the list at a distance, but not handle it. Dibrrell and Gardner, both young lawyers and recently FBI agents, had planned to memorize all the names possible shown on the list. They thus got about 15.

Donald interrupted their hurried scrutiny to answer the phone.

Upon his return to the group, he said "that'll be all," and replaced the list in the bank vault and closed the big door.

Transferring their memorized names to their note pads, Dibrrell and Gardner, left for a field search as Gov. Stevenson departed to confer in a private residence with Adams and Poole.

The investigators found it difficult to locate addresses of the names they had jotted down—except for three, who lived in Austin without notice, and after only a brief hearing in chambers, was, because of the time element, virtually a death blow. Had it been delayed even an hour, the Jim Wells Committee would have doubtless, had a new certification in the mail.

The blow left Gov. Stevenson and his forces, as well as members of the Jim Wells Executive Committee, dazed and groggy. But, all talk of evasive action was vetoed by Gov. Stevenson. 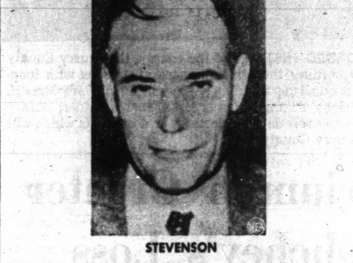

Their petition alleged that, through fraud and corrupting influences, Stevenson and those who voted for him had been denied the right to have their votes counted honestly.

plaintiff's claim he has been deprived of a seat in the United States Senate.

"If there was not a single law on the books, this man would be entitled to and would get a hearing in this court."

"This hearing shall be held over until Sept. 27; and this court will appoint a Commissioner to go into Jim Wells County, procure evidence and report back to this court when the hearing opens again."

This blistering decision by the rugged old Federal Judge, all but blew the Johnson ship out of the water.

TEXAS SECRETARY OF State Paul Brown sent the copy for the official November ballot to the printer, leaving the Senatorial space blank.

He acted on the assumption, obviously, that the injunction issued by Judge Davidson would stand on final hearing; and newspapers carried stories that it would be a write-in contest between Johnson and Stevenson.

Thereupon, Connally petitioned the Texas Supreme Court to take jurisdiction and issue a mandamus, directing the Secretary of State to print the name on the ballot.

He seized all the 17 county ballot boxes, some in an unlocked corner of the jail, some in the court house. He deposited a private locksmith to open them—and found only shreds of old newspapers and trash.

He issued a subpoena for the Secretary, Tom Donald—but he was in California on other business.

He issued a subpoena for Luis Salas, the presiding judge of precinct No. 13—found him called to Mexico on business.

His deputies had a dozen other subpoenas not yet reported on when Com. Smith got orders from Judge Davidson to halt proceedings and return to Fort Worth—as directed by the U. S. Supreme court.

AFTER A BRIEF hearing in chambers, Judge Hugo Black, of the U. S. Supreme court, signed a sweeping order, reproduced herewith on Sept. 29—just six days after Judge Davidson had held his last hearing, Sept. 23.

"We have no alternative but to submit to his order from the Supreme Court," Judge Davidson was quoted by the newspapers "but I personally think it was too hasty, and, probably, unlawful."

Secretary of State Paul Brown, telegraphed orders to all counties to include the name of Lyndon Johnson on the printed ballot. And the rest is history.

THUS, Justice Black, at one stroke of a fountain pen, ruthlessly nullified the judgment of a Texas Federal District Judge, who had heard the witnesses; and also the judgment of a Circuit Federal Judge, who ruled that the grave matter should be decided by a full court after an orderly hearing.

Whether or not Justice Black's order was based on the old political axiom of "Whose bread I eat, his song I sing," or based on the Supreme Court's sacred duty to administer justice only after both sides had been fully heard, only Justice Black can answer.

The crowning defeat seemed to have come in 1958 when a Federal court jury assessed a \$25,000 civil penalty against a man named George Parr. This was affirmed on appeal, until it got to the Supreme Court. In another of its infamous orders, the Supreme Court, of the United States, June 5, 1960, reversed the decision, set the sentence aside, and in a sweeping order, directed the lower Federal courts not to again try the case, but remove it completely from their dockets.

The Texas Supreme Court denied the application.

OVERNIGHT, this bitter fight erupted on three fronts, after the Texas Supreme Court declined to act.

1—Johnson appealed Judge Davidson's decision to the Fifth Court of Appeals at New Orleans; and his attorneys flew down with the appeal and procured a hearing on Sept. 26 before Circuit Judge J. C. Hutcheson, Jr.

2—Sam Rayburn summoned 70 Texas top leaders, including an alleged majority of the State Democratic Committee, to his home in Bonham for an emergency caucus.

3—Judge Davidson appointed W. E. "Bob" Smith, San Antonio attorney, his commissioner to go to Jim Wells County, impound all election returns; delegating to him the broadest possible powers to issue subpoenas, administer oaths, and depose all needed help to conclude his hearings within three days.

### Texas Rangers Enjoined

LYNDON B. JOHNSON vs. COKE R. STEVENSON, ET AL.

NOW COMES Lyndon B. Johnson, who resides in Blanco County, Texas, complaining of Coke R. Stevenson, who resides in Kimble County, Texas, Frank Hamer, who resides in Travis County, Texas, Kellis Dibrrell, who resides in Bexar County, Texas, H. L. Adams, Chairman of the Democratic Executive Committee of Jim Wells County, H. L. Poole, secretary of said Jim Wells County committee and (here follows names of 18 individual members of Committee).

Plaintiff is a resident citizen of the State of Texas and duly qualified to hold the office of United States Senator. At Second Democratic primary held August 28, 1948, plaintiff received a majority of the votes. . . . we would show that the defendants have entered into a conspiracy for the purpose of causing the votes in Precinct No. 13 in Jim Wells County to be thrown out on the grounds of fraud and irregularity. . . . thus taking from plaintiff sufficient votes to change results of election and deprive plaintiff of his seat in the United States Senate. . . . Plaintiff would show said county committee has no authority or jurisdiction to hear or determine an election contest of any kind, or to hear a final judgment on charges of illegality or irregularity of any nature. . . . but, unless restrained by an order of this Honorable court, said defendants will effect such unlawful conspiracy. . . . Plaintiff further alleges that defendants Adams and Poole, acting under threats and intimidation of defendant Stevenson, and in furtherance of said conspiracy, called a secret meeting in a private residence and declared fraudulent the returns in Precinct No. 13.

CHALLENGING in vain acceptance of the new returns by the subcommittee, Gov. Stevenson on Saturday, asked two of his workers, Kellis Dibrrell and Jim Gardner to go to Parr's country and investigate. Going by Laredo to pick up a loyal pilot, they arrived Monday morning and were joined at noon by Gov. Stevenson.

The three located George Parr in his office at San Diego. Johnson's campaign manager, John Connally, had been there to it. He had arrived the preceding day.

To their demands to see the poll list and returns from Duval County, which had been reported for Johnson, 4,622-38, Parr showed astonishment that they should ask him. He knew nothing about the election returns.

Crossing over into adjoining Jim Wells County immediately, the Stevenson forces, found reason for encouragement. Harry Adams and H. L. Poole, newly elected chairman and secretary, respectively, of the Jim Wells County Democratic Executive Committee, were already trying to upset the "correction" from Precinct No. 13 that had been made and reported by the old committee officials.

ADAMS AND POOLE had seen the "corrected" poll list the preceding Friday; and reported to Gov. Stevenson, that the new 200 names had been added in green ink, alphabetically, whereas the main list was in black ink. But, they were present of the account, only as spectators. The old committee secretary, Tom Donald refused to turn over the poll list and retain custody against vigorous protest of the new officials.

The revised poll list was in the vault of the Parr bank, where Tom Donald was an employee. Plans were laid to get possession of the list when the bank opened the following morning.

Overnight, tension had mounted to a high pitch. Dibrrell and Gardner sent out an urgent call for help to check the entire voting list and recruits began arriving hourly. Wild rumors they were all armed, former FBI men, spread rapidly and the newspapers reported an emergency call had gone to Austin for Texas Rangers.

Three men trailing Winchester were in position in front of the bank early the following morning. Gov. Stevenson wisely ordered his forces to appear in public only in their shirt sleeves.

As the hour approached for the bank doors to open, armed men sauntered onto the scene and took positions with an ominous silence.

Gov. Stevenson and his closest investigators arrived, escorted by Ranger Captain Frank Hamer. Not a word was spoken as the Ranger Captain took position directly before the bank door. The veteran Captain was well known to every man there. He was known as a stern, inflexible, officer who exacted, one way or another, prompt and strict obedience to his orders.

He waved the armed men to fall back from the bank door and they did. Very promptly the door opened and Gov. Stevenson and his men entered. Captain Hamer forbade any others to follow. None tried. Witnesses said later the Captain never lifted his pistol, nor even touched it; but Johnson charged him with force, threats, and intimidation.

Donald agreed to let the Stevenson forces see the list at a distance, but not handle it. Dibrrell and Gardner, both young lawyers and recently FBI agents, had planned to memorize all the names possible shown on the list. They thus got about 15.

to vote sanction of the proposed move.

However, shortly after ten o'clock Friday morning, Sept. 10, Gov. Stevenson, his leaders, and all members of the Executive Committee were served with notices an injunction had been issued by Judge Roy Archer in Austin, freezing the operation completely and forbidding the committee to meet.

And for the first time, and only time in Texas history a Texas Ranger was forbidden to preserve the peace and maintain order, and discharge his lawful duty. Johnson, in his petition for injunction alleged that Captain Hamer employed "threats, force and intimidation," to further the alleged conspiracy of Adams and Poole to investigate the irregularities in Box 13.

Captain Hamer scrupulously maintained the traditional neutrality of the Texas Rangers, according to every shred of evidence. He was sent in to prevent riot and bloodshed. He did just that, and nothing more. The Johnson charge that he was a partisan, still rankles Rangers.

IN A LIGHTNING fast maneuver engineered by Johnson and Connally an Austin judge was asked to restrain a Democratic county committee from holding an official meeting in their home county hundreds of miles distant from Austin. Attorneys say this is without precedent in Texas history.

The petition was presented in chambers to Judge Roy Archer 12th District Court, early Friday morning, Sept. 10.

Alleging that a "conspiracy" existed between the Chairman, secretary and a number of members of the Jim Wells County committee to "re-canvass the returns from Precinct No. 13," and take away from plaintiff Johnson enough votes to "change the results of the election and thus deprive him of a seat in the United States Senate," the petition recited the fact that the committee had already met once and found irregularities existed in Precinct No. 13.

THE RECORD reveals that on Sept. 10, District Judge L. Broeter, resident judge of Jim Wells County was in his district and, obviously, available for a hearing on the Johnson petition. Just why Johnson and Connally presented the petition to Judge Roy Archer in Austin, more than two hundred miles distant from Jim Wells County, and just why Judge Archer was prevailed upon to sign this order in chambers, without notice, is a question still unanswered. Archer alone has the answer.

AT A MEETING in a private residence Thursday night, Adams and Poole had definite commitments, and conditionally promised they deemed reliable, sufficient to officially make a new certification of returns to the State Executive Committee which it met in Ft. Worth, Sept. 13. They accordingly issued a call for the committee to meet at 11 o'clock the following morning.

THE INJUNCTION procured by Johnson in Austin without notice, and after only a brief hearing in chambers, was, because of the time element, virtually a death blow. Had it been delayed even an hour, the Jim Wells Committee would have doubtless, had a new certification in the mail.

The blow left Gov. Stevenson and his forces, as well as members of the Jim Wells Executive Committee, dazed and groggy. But, all talk of evasive action was vetoed by Gov. Stevenson. To him a court order was just that—an order of a court, that was to be obeyed to the letter until challenged in another court.

With nothing to show but a series of frustrations, Stevenson and his workers left for the momentous meeting of the State Democratic Executive Committee, scheduled to open at noon Monday, September 13.

Should the whole committee vote to accept the tabulations of their three-man subcommittee, that would automatically confirm the 87-vote lead of Johnson and place his name on the November ballot. Should the committee vote to conduct a new tabulation, that would give Stevenson the chance to introduce evidence.

THE STEVENSON forces were greatly encouraged when the first test vote showed the committee equally divided, 28-28. And the deadlock held through several hours of wrangling and voting on parliamentary procedures.

During this time, Committee C. C. Gibson of Amarillo had flown in; and, shortly after four o'clock cast the tie-breaking vote in favor of Johnson and acceptance of the sub-committee report.

# Revolution In Yemen Shakes Saud

JIDDA, Saudi Arabia (AP)—The republican revolution in Yemen has shaken Saudi Arabia's throne and stirred its people. King Saud has named his brother Crown Prince Faisal to head a government that may give the Saudi monarchy its last chance. More than one observer believes that unless Faisal acts decisively to bring progress to this rich but backward oil kingdom the country's next government will be republican.

Faisal—thin, hawk-faced and ascetic at 56—may be the man to save the throne. In March 1958 he took the premiership to fend off another type of crisis—Saudi Arabia was on the financial rocks because of royal spending. Thirty months later the king dismissed Faisal, with whom he had never gotten along. In the time given him the younger brother had put the country on a solid fiscal footing. His economizing was drastic—for one six-month period not a single new Cadillac was bought for the royal family. He curtailed expenditures so firmly that they have never since gotten out of hand.

# New Federal Projects Are Trotted Out

WASHINGTON (AP)—New federal projects to cost half-a-billion dollars were hustled into view of the nation's voters in the week before elections. The steady stream of contracts, grants and loans will provide something for every major sector of the electorate—big cities, towns and urban areas, farmers and industry.

The problems facing Faisal today are different. Winds of change sweeping across the Arabian desert make the growing educated classes restless for change and bored with the puritanism of Saud's Wahabi sect.

One big chunk of pre-election spending announcements stemmed from President Kennedy's allocation of the first \$185 million of the recently enacted \$400-million accelerated public works program. Federal agencies quickly went into high gear assigning the money to qualified projects ranging from multimillion-dollar grants to rebuild city slum areas to construction of recreational facilities in a remote Alaska moose range.

Their country has no constitution, no free parliament, no census and few roads. It has not a single movie house. Its fading puritan zeal still prohibits movies, alcohol and theoretically even music from records. Women are only beginning to emerge from their medieval Moslem seclusion.

The outpouring of government largesse presumably will benefit both Republicans and Democrats, and there were no complaints from Republican congressmen that their states weren't getting their share. But one GOP campaign spokesman said the timing of the announcements "seems to be a political means of favoring the Democrats."

Saud is a respected and gentle monarch with genuine regard for his people but some members of the royal family spend money with gross glee. Of the country's estimated \$200-million income this year, the 1,000-strong royal family will get about \$60 million.

The spokesman, Paul Thais of the GOP Congressional Campaign Committee, said there is "no question" that it will give campaigning Democrats a boost.

Against these liabilities Faisal can draw on solid assets. Thanks in part to his own previous work and to growing revenues from American oil companies, Saudi Arabia's finances are in excellent shape.

An official of the Democratic National Committee, Samuel Brightman, retorted, "If we were not doing normal business they would find fault with that and say we were too slow."

The trial is one of the strongest currencies and the foreign debt is paid off. Since the start of the Yemen crisis there has been no sign of panic in the country and no flight of capital.

Democratic members of Congress, at any rate, seemed to have more new federal projects to announce during the week than GOP members—perhaps because Democrats are much more numerous in Congress.

In recent years there have also been moves toward modernization, a generous and expanding educational program and improvements in communications, public health, agriculture and other technical fields.

In government protocol, members of Congress usually are given first whack at announcing new projects in their states.

The Saudi people have a strong tradition of loyalty to the royal dynasty. The armed forces, where Arab revolts usually start, are scattered and separately organized. Aided by Faisal, Faisal still faces a formidable task of speeding up progress if the monarchy is to survive.

# Kennedy Triumph Greater Than Khrushchev's Loss

WASHINGTON (AP)—President Kennedy won a test of wills in a dramatic showdown with Premier Khrushchev over missile bases in Cuba. But it was essentially the moral victory of a peaceful man who is finally provoked into going to war if he must.

The greatest danger for the United States is that the results will be exaggerated and their meaning for U.S.-Soviet relations distorted. The cold fact is that Kennedy's triumph appears to be much greater than Khrushchev's defeat.

This is a crucial point which the President and his advisers are certain to keep in the forefront of their thinking as they reassess cold war strategy in the light of the Cuban ordeal. For 12 days, Kennedy and the little group of close advisers who were almost constantly with him faced the spectre of nuclear war and the possibility that the fate man had feared from the dawn of the atomic age was about to overtake him.

As the tension began to ease with evidence of Khrushchev's backdown, the idea grew that such an agonizing experience should be of some value for the future of peace. An exact measure of its value may be months or even years away. Certainly not all the facts on which to base a judgment are yet known. But while the impact of the Cuban crisis is bound to be felt by many individuals and on many aspects of policy, there is no evidence to suggest that it means any profound change in the Soviet strategy of world conquest or any pulling back from the major purposes of Soviet foreign policy.

There are a great many unanswered questions, though some may gain partial answers in the next few weeks, depending on what Khrushchev decides to do about his campaign to get the Western powers out of West Berlin. If the resolution of the Cuban crisis leads to a Kennedy-Khrushchev meeting, one of the President's purposes will be to find out how Khrushchev personally has reacted to the confrontation.

Two key elements of the crisis with a heavy bearing on its future significance, are still mysteries, so far as the United States and its allies are concerned. One is: What caused Russia to undertake the fantastic Cuban operation? The other is: What conclusions will Khrushchev draw from the

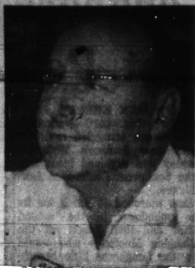

## Is Krush In Trouble?

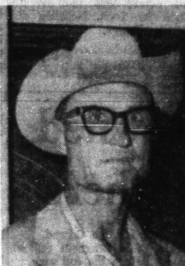

While the Cuban situation rocks precariously along, many have started to wonder, "Is Nikita Khrushchev in trouble at home?" Answers in Snyder this week generally reflected the prevailing opinions in Vienna, Bonn, London and Washington of those who feel that behind his show of bravado Khrushchev is a man beset by monumental and deep-seated troubles. Soviet farms are far below minimum expectations. Red China is compared to the tail that wags the dog, and West Berlin stands as a stark reminder of successful democracy in the midst of communism. Cuba, then, could have been a gamble to a man hoping for a lucky seven in foreign affairs. AGNES BROWN: "After listening to both sides of this question, it is difficult to form an opinion. I think possibly he has lost prestige, but you hear one thing one day and another the next. I shudder to think what would happen should Khrushchev be ousted, for we know more or less what to expect from him. A new premier could be a great deal more severe."

JOAN WATERS: "I think Khrushchev is in the same boat as Kennedy. They've both had to lose face in one way or another. He has to show the authority of his position to his people to maintain their respect. ## Adenauer Facing A Grave Crisis

BONN, Germany (AP)—Konrad Adenauer faced a crisis Saturday that threatened his 12-year career as West Germany's first and only chancellor. But the 86-year-old leader, a cagey politician, appeared to be holding his ground. He has until Monday to answer demands of the conservative Free Democrats—partners in a coalition with Adenauer's Christian Democrats—for the firing of two top civil servants involved in a dispute over the government's order for the arrest of top executives of the widely read picture magazine Der Spiegel. They are held on suspicion of treason. The free Democrats have threatened to pull out of the coalition, thus laying open a road for Adenauer's ouster.

Adenauer's party holds 241 seats in the Bundestag—parliament. The Free Democrats threw in their 67 seats to give Adenauer a clear majority over the opposition Social Democrats, with 191. But there is some skepticism here that the Free Democrats will go so far as to pull out of the coalition. In their campaign for the September 1961 Bundestag elections, the Free Democrats promised to remove Adenauer from office. Yet, when it came to the election of a chancellor, the Free Democrats swung enough votes to re-elect him. Even if the Free Democrats withdraw from their partnership with Adenauer, the chancellor can still hold on to the nation's leadership. Constitutionally, he can rule with a majority. But there is also the possibility of a coalition with the Socialists. Mayor Willy Brandt of West Berlin, leader of the Socialists, said he doubts that Adenauer's government will fall. "There is no doubt this is a serious political crisis," Brandt said, "but I'm not inclined to believe it will lead to a change in government." Adenauer's troubles spring from the cloak of secrecy surrounding the arrest of the publisher and four editors of Der Spiegel. Friday night, an army colonel was added to the list of the arrested.

## SHS Forum For Parents Set Monday

There will be a meeting of the Parents' Forum in the Snyder High School Auditorium at 7:30 p.m. Monday. This is a new organization for parents of high school students. Meetings will be held on the first Monday night of each month for the purpose of giving information about various high school activities and problems. The meeting this Monday evening will be in charge of Jack Longbotham, high school counselor. Topics to be discussed will include college entrance requirements, the school testing program and how parents can interpret the results, what parents can do to aid their children in school, and how the school is attempting to cut down on high school drop-outs. There will be a question and answer period at the end of each discussion. The meetings are open to all parents and interested citizens, whether they have a student in high school or not. ## More Layoffs On Schedule

CHICAGO (AP)—The Chicago & North Western Railway has served notice it will abolish the jobs of 39 telegraphers and 29 extra board members in its first such action since a 30-day strike over the issue of layoffs. The strike ended Sept. 28 when both sides agreed to binding arbitration, which subsequently held that the railroad could lay off workers it considers unneeded. Robert C. Williamson, spokesman for the Order of Railroad Telegraphers, said the layoff notice, effective in 90 days, came as a surprise. He said Ben W. Heineman, board chairman of the railroad, had promised that there would be no wholesale layoffs. A railroad spokesman said the layoffs could not be classified as wholesale because the road employs 1,000 telegraphers.

## Rig Count Up Slightly

Rotary rig activity edged upward in the Permian Basin oil fields during the past week. The basin had 207 active rotary units, compared to 203 the week before, according to Reed Roller Bit Company's Friday survey. The count, however, is still far below the 255 logged at the same time in 1961. Scurry and Mitchell Counties had increases, with the Scurry rig count rising from 4 to 6 and Mitchell County's tabulation increasing from 1 to 2. Fisher County, at 3-8, and Borden County, at 1-1, were unchanged from the previous week, while Garza County's rig count dropped from 3 to 2, and Kent County's count was down from 4 to 2. Lea County, New Mexico, continued as the basin leader with 33 active rotary units. Ector County had 21 and Andrews 18.

## Margaret's Son Is One Year Old

LONDON (AP)—Princess Margaret's son, Viscount Linley—fifth in line to the throne—is one year old today. His full name is David Albert Charles. But British newspaper affectionately dubbed "the barefoot viscount" today when he published his official birthday photograph taken by his father—the former Antony Armstrong Jones. The prince again, as in the early studies of Prince Charles, the royal family that made him famous. Armstrong Jones chose an unorthodox set up. Lord Linley was pictured in baggy pants and bare feet clinging to a wicker chair—a series of open shelves—containing pieces of royal bric-a-brac. 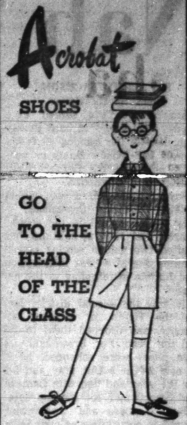

## National Confidence Revival Is Reflected By Wall Street

NEW YORK (AP)—Wall Street financial community began to think about the possibility of a bullish outcome to the elections Tuesday, when security markets will be closed. The rally continued strongly on Friday. The week's volume totaled 20,072,955 shares, compared with 25,062,260 the previous week. Biggest corporate news of the week was that U.S. Steel cut the quarterly dividend to 50 cents from 75 cents—but this news was so well anticipated that "Big Steel" emerged from the week with a net gain of 3% at 42 1/2. General Motors reported its quarterly profits more than doubled and the stock rose 3%. IBM

recovered 26% at 357 1/2, Xerox 12% at 150 1/2. Chrysler was the volume favorite as its turnaround from a loss to a healthy profit won investment support. U.S. Government and corporate bond prices both moved ahead Tuesday. Corporates regained 11 of after the easing of the Cuban crisis. Corporates regained all of the previous week's setback with one of the year's better showings, as measured by the AP average. Governments failed to do as well, but most were ahead. Corporate volume for the week was \$23,500,000 par value, compared with \$30,676,000 the previous week and the stock rose 3%. IBM

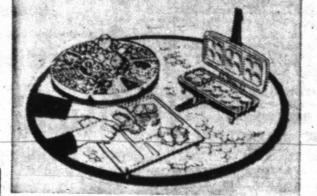

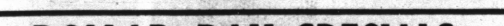

**AF Newfeatures**

Summertime means mildew troubles to many home owners. The whitish mold grows on wood, leather, cloth, paper and dozens of other organic materials and occurs indoors and outdoors. Where conditions are damp and warm all or most of the time, mildew thrives. While mildew can be washed off easily, sometimes with soap and water, sometimes with ordinary household chemicals, it will return again and again unless the conditions that caused it are eliminated. It frequently shows itself in damp basements, crawl spaces, closets and dark corners, and often makes an appearance on outside portions of the house where sunlight never hits.

One home owner found mildew constantly forming on the side of the house in an area about 20 square feet. He discovered that shrubbery, planted close to the house at that point, was keeping out the sun. As a result, the side of the house behind the shrubbery failed to dry out after a rainfall. He dug out the shrubbery and replanted it in a different location, not too close to the house. After the mildew was washed off, it never returned.

Where there is no such easy solution — and the product under attack can be painted — it is best to paint the surface with a mildew-proof paint. Years ago this was done by adding a mildew retardant to regular paint, but it now is possible to buy paint which contains what is called a mildewicide. Before painting, it is important that all traces of the mildew be removed from the wood or other

In mild cases, soap and a little warm water will do the job. But for an effective result, it is better to use any of the household liquid cleaners which contain either sodium hypochlorite or trisodium phosphate.

There are half a dozen or more household cleaning products which have one of these chemicals in them. The labels will give you this information. If the cleaner has sodium hypochlorite, mix one and a half cups of it to a gallon of water. If it has trisodium phosphate, mix three heaping tablespoons of it to a gallon of water. In either case, brush or scrub on the solution, allow it to remain for five minutes and then rinse with clean water.

You can combat mildew if you remember the combination that causes it — dampness and warmth.

**QUESTION:** I have reason to believe that rainwater is seeping through the rear wall of our brick house. I cannot see exactly where the water is making an entry, but there are many places where the mortar has loosened from between the bricks.

I have been reading about a liquid silicone product that waterproofs brick exteriors without changing the color of the bricks. Will an application of this liquid correct the trouble?

**ANSWER:** Silicones are effective in making masonry walls more water-repellent and will seal hairline cracks. But they will not substitute for mortar in filling joints that have begun to disintegrate.

If you want an effective job, you will have to patch the joints first, then apply one of the silicone preparations. Remove all loose mortar with an old screwdriver or a cold chisel and hammer. Soak the cavity and the surrounding area with water, then apply the mortar with a trowel. Be sure to pack it in firmly. Keep a damp cloth handy so that you can quickly wipe off any mortar that gets on the face of the brick.

The patched joints should be wet down once or twice a day for several days to prevent the mortar from drying out too quickly. You can buy a mortar mix which requires only the addition of water.

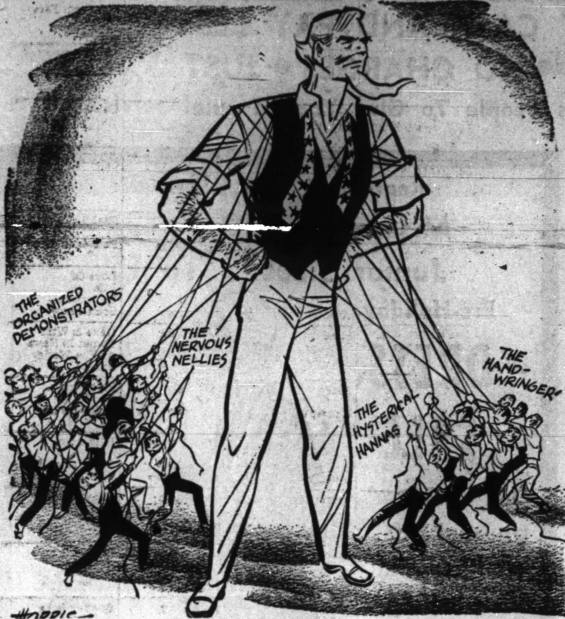

## Castro's Betrayal Of Cuba Followed A Graphic Pattern

EDITOR'S NOTE — Fidel Castro showed two faces to the world for long years before he finally revealed himself as the architect of what President Kennedy called the betrayal of the Cuban revolution. Here is the story of that betrayal.

Four months and four days after Fidel Castro drove into Havana on the fender of a jeep, waving and laughing and clutching flowers from the baskets of the campesinos come down from the hills at last, the Cuban bus workers union held an election.

It was a dull one, as elections go, because the candidate of Castro's 26th of July party defeated his only serious contender, the Communist party candidate, by 1,488 votes to 750.

Blas Roca, secretary general of the Communist party, was charged after all, he said, Castro's regime "has all the backing and sympathy of my party."

But, sighed the petulant Roca, "We aren't penetrating the government."

Two years later Blas Roca had become one of the highest ranking functionaries in the one-party Moscow-directed Communist government.

How did it happen? What were the key incidents in this betrayal, as President Kennedy termed it, of the Cuban people and their revolution?

What were the mile posts along the path of duplicity which led to a Soviet toehold in the Western Hemisphere? There were danger signals, easy to recognize in retrospect, which weren't heeded. Why?

Part of the answer must be that they were obscured by the aura surrounding Castro himself.

He was personally popular even since his graduation from law school when he used to defend peasants and various political figures in Cuban courts and refuse to accept a fee. His magnetism reached full bloom on July 26, 1953, when he led a column of 13 automobiles to Santiago's Moncada army barracks in the aid of the revolution. He was successful in his revolution, but the raid was a dismal failure, but Castro's name became a rallying cry—"Fidel sí! Batista no!"

Three years later, during the first weeks of his ultimately successful revolution, each government announcement that Castro had been killed—and there were about four such reports—served only to renew the zeal of his rag tag followers.

At the height of his rebellion in Cuba, when he was a high point in the dragged-out, two-year revolution—exact taxes from poor land owners to finance his guerrilla band was no problem; most gave anxiously. So did his admirers across the water. Donations from the United States and elsewhere came to about \$25,000 a month.

Shortly after his New Year's Day victory in 1959 Castro explained his unwillingness to call a national election on the grounds he would win without a truly democratic contest, and nearly everyone nodded.

Even when things began to go bad for Fidel in the spring of 1960—unemployment high, police terror on the streets, poverty in the countryside—Castro still could rely on personal esteem to see him through.

"Fidel doesn't know," said a man who had fought by his side. "It can't be he knows what is going on in Cuba. When Fidel knows, he will change things."

And so when the free world began to study the handwriting on the blood-stained firing wall and to wonder whether communism had infected Cuba, Fidel Castro was his own best witness.

Against communism and all dictatorships of all kinds he told an audience in Washington's National Press Club on April 30, 1959. "Whatever the nature of the dictator—class dictator, military dictator, or dictator of the oligarchy—we are opposed to it."

Ever popular, ever esteemed Fidel Castro had said it, and it was hard not to believe.

Castro visited Canada, Argentina, Brazil, Uruguay and Trinidad at that same year. Each place they asked the question: Is Cuba communist?

"It is a calamity that the Cuban government is Communist infiltrated," Castro thundered when he returned home May 8. "All such reports are an infamous attack on our revolution."

Maj. Pedro Luis Diaz Lanz, the chief of Castro's air force, fled to the United States on June 30. His

reason, he said, was that Castro had brought his country not freedom but a Communist dictatorship. He said anyone who had heard Castro's private utterances would have no doubt he was a Communist. Once, said Diaz, Castro told him "he was going to put in a system in Cuba like Russia has—much better than Russia has."

Castro denounced Diaz as "the Benedict Arnold of Cuba," and President Manuel Urrutia called him a traitor, maintaining that Castro's government "has nothing to do with Communism."

Meanwhile Diaz, testifying before the U. S. Senate Internal Security Committee, recited a litany of men in Castro's hierarchy he said he knew were Communists—Raul Castro, Fidel's brother and commander in chief of his armed forces; the Minister of Defense, Juan Martinez; acting Secretary of State Armando Hart, and others.

Diaz's defection was only one of Castro's worries. Criticism of his land reform law and nationalization measures caused him to make several changes in his Cabinet. When this failed, he used an old reliable weapon to help him to weather the crisis—his personal magnetism.

On July 17, arms outstretched like a martyr, Castro resigned.

The resignation of Urrutia to step down the following day, later to join those calling Castro a Communist. On July 26, the Fourth of July for Fidelists, adulating Cubans a million strong demanded Fidel to return to their bosom.

Castro "accepted their mandate," as he explained, and once again was premier—firmer in the saddle than ever.

If the confusing government shakeup left the peasants puzzled, it had the opposite effect on many in Castro's top echelon who for the first time began to see the situation clearly.

Maj. Huber Matos, a hero of the revolution and chief of the military in Camaguey Province, resigned Oct. 19 because of Communist infiltration. He was treated as a traitor and sentenced to 30 years.

A few weeks later Joaquin Sanjines Perdomo, director general of Castro's finance ministry, fled to the United States.

The list grew. Castro branded them all traitors.

In Cuba, things were going badly for Castro. Unemployment was 500,000 in a labor force of 2-1/2 million. Unrest was widespread. Castro selected the United States as a scapegoat, a haven for "counter-revolutionaries."

Great Britain refused to sell Castro jet airplanes, and Fidel claimed the United States was responsible—and that he would buy them from a Soviet bloc country. Czechoslovakia finally provided them. Anastas I. Mikoyan, Soviet deputy premier, arrived in Cuba to open a week-long scientific, technical, and cultural exhibit.

Castro gave Mikoyan an embrace; Mikoyan gave Castro a helicopter.

The two also agreed on a trade pact under which the Soviet Union would purchase a million tons of Cuban sugar for the next five years.

By Aug. 7 the course Cuba was taking was obvious. In a 78-page memorandum filed with the Inter-American Peace Committee, the U. S. State Department said: "Not only is Cuba under its revolution, but the revolution is being transformed rapidly into a dictatorial political state, but a state in which the reins of political control are increasingly being concentrated in the hands of the Communist party."

"The gravest danger to the security of the Americas," the memorandum said, "is to be found in the developing military relations between Cuba and the Soviet Union."

QUESTION: When did women start wearing trousers?

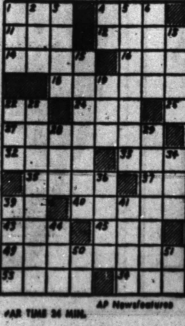
ANSWER: In China, women have worn trousers for a long time, especially for work. Early women also wore trousers long ago and still do, finding them necessary for warmth. Many women in the Middle East, in countries such as Turkey, have worn baggy trousers. But European and American women had little to do with trousers until, in 1851, a determined lady, Amelia Jenks Bloomer, began to lecture in favor of women's rights, wearing "Turkish pantaloons." A craze for knee length "bloomers" followed. Mrs. Bloomer did not succeed in dressing American women in "Turkish pantaloons," but the women's rights movement did succeed. Women got jobs, became interested in sports and the outdoors. By the 1890's, beach pajamas had appeared and it became smart to wear mannish slacks with jackets for sports wear; soon trousers were an established fashion. Ski pants appeared at winter resorts. During World War II, women in factories found trousers safe and comfortable. Horsewomen, of course, had been wearing riding breeches since the sidesaddle went out of general use.

### Retail Sales In State Show Gains

AUSTIN (AP)—Texas' retail sales are 9 per cent ahead of 1961 sales and forecasts for the rest of the year are for a good showing, the University of Texas Bureau of Business Research said today.

September sales dropped to \$43.7 million, a drop of 11 per cent from August and a gain of 1 per cent over last September.

"September sales fell below seasonal expectations due mostly to the unseasonably warm weather," the bureau said. Also missing were last year's "shots in the arm" such as the pre-sales tax buying surge and Hurricane Carla repairs.

Hurt worst by the slow September sales were apparel stores, whose sales fell 2 per cent from August instead of fulfilling the expected 11 per cent rise.

Other factors, however, appear good—unemployment fell in September, personal income is still high and the stock market drop did not change consumers' buying plans.

Although 1962 automobiles did not reach show rooms until mid-September or later, September 1962 sales were 13 per cent ahead of last September, when new models were in stock earlier.

Drugstore sales volume for 1962, now 2 per cent ahead of last year, is expected to top 1961 higher than expected if Asian flu epidemic predictions are correct.

Sales by automotive furniture and lumber, building material and hardware stores were 20 per cent ahead of last year in the nine-month comparison. September's total, \$311.9 million, is down 22 per cent from August but up 10 per cent from last September.

Austin led the state's six largest cities with 14 per cent in sales gain during January-September over the like 1961 period. El Paso turned in the only sales increase during September over August.

Other rankings for the nine-month period: Dallas and Houston, both 8 per cent ahead of the first nine months of last year; El Paso and San Antonio, 7 per cent of last year; and Fort Worth, 2 per cent of last year.

Other comparisons of August and September sales records: Fort Worth, down 6 per cent; Houston, down 8 per cent; San Antonio, down 12 per cent; Austin down 13 per cent; and Dallas, down 14 per cent.

### Independent Oilman Finds Life Tougher

HOUSTON (AP)—The top spokesman for independent oil operators says it is getting tougher to exist as an independent.

Harold Decker, president of the Independent Petroleum Association of America (IPAA), says the industry is going through a cycle of basic economic change.

Some independents, he said, have quit fighting.

"This is reflected in the acceleration of sales, mergers, and sellouts," he said. "To stay in the oil business is going to be tough even if we win every battle on the Washington front."

Decker told IPAA convention last week the worldwide surplus of oil has been aggravated by a sharp decline in the rate of growth in demand for oil.

Demand increases averaged 4 to 5 per cent annually after World War II but have dropped to less than 1 per cent a year the past six years.

"We are kidding ourselves when we think we are going to turn some trick that will enable us to sell another 500,000 barrels of crude a day or suddenly change the cost-price squeeze that threatens the existence of every independent producer," said Decker, president of the Highland Oil Co. of Houston.

He said the nature of problems is such it is more important than ever that the independent oil and voice and be heard in industry and in government.

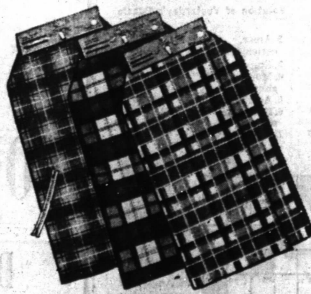
