

## Cattle Buying Starts Aug. 23

### Federal Agent Gives Plans For Buying In County

Program Allows Purchase Of 450 Head Each Week In Collingsworth Co.

### List 9,000 Head

Applications May Still Be Made In Office In Courthouse Here

Buying of cattle under the government program will begin here Thursday morning, August 23, according to the announcement of John O. Stovall, county agent, today. Under the program 450 cattle may be purchased each week, but the figure does not include condemned cattle, Mr. Stovall said.

Will Divide Work  
R. H. Speer, government appraiser and buyer, arrived here Monday morning and announced that he would divide his time between Collingsworth and Wheeler counties, working here Thursdays, Fridays and Saturdays and working in Wheeler county on Mondays, Tuesdays and Wednesdays.

Mr. Speer expressed himself as being well pleased with the preliminary work done in this county and stated that it would enable him to cover the county much faster and offer relief to people who have cattle in distress from the lack of feed and water. It is not known just

### Six School Busses Will Operate In County This Year

Six school busses will operate in Collingsworth County during the 1934-35 school terms, according to the announcement of J. D. Wilson, county superintendent today. During the past school year only one bus was operated in the county.

Three of the busses will serve the Samnorwood and surrounding school districts; two will serve the Dodsonville territory and the other bus will cover Rural Route 1, bringing students to Wellington.

The bus operated last year was out of Dodsonville.

### Lists Game Laws For Bird Hunters

Following numerous inquiries, Artin O'Neil, game warden, this week issued the following information for hunters concerning bird laws for 1934. Mr. O'Neil said that the laws were practically the same as in 1933.

The prairie chicken season opens September 1 and closes September 4, both days inclusive with a bag limit of not more than 10 a day or 10 a season. Neither Collingsworth or Wheeler county will have an open season.

The quail season opens December 1 and closes January 16, 1935, inclusive. Bag limits, 12 a day and not more than 36 a week.

Waterfowl and shore birds, including ducks in this county, are subject to Federal regulations and have not as yet been designated.

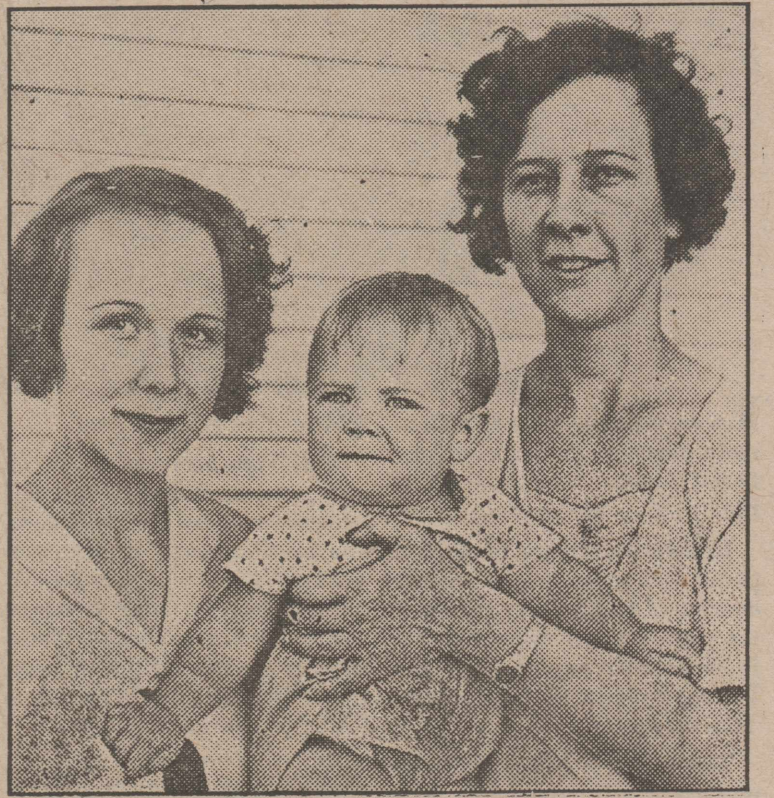
### Light Shower Tuesday Night Puts Town In Commotion And High Hopes

### Suspects Held

Three Men And One Woman Held In Connection With Shooting

Constable Ed Pryor Wednesday reported that four arrests had been made in connection with the fatal shooting of Elmer Barnes here last Saturday night. No charges had been filed in the arrests due to the fact that the justice of the peace, county attorney and county judge are out of town at the present time. District Attorney John Deaver was expected to question the suspects today.

Mr. Pryor was assisted in making the arrests by Nightwatchman G. N. Scruggs.

Four Arrested Here  
The three men and one woman under arrest denied any connection with the shooting and attempted holdup of Barnes.

The shooting occurred shortly after nine o'clock Saturday night, when two men accosted Barnes at the Lucky Corner Filling Station, at southeast corner of the town section. Barnes attempted to draw a gun when ordered by the hijackers to hand over the money and was shot.

Anticipating one of the largest enrollments in the history of Wellington Public Schools, G. L. Farrar, superintendent, today announced detail plans for the opening of the 1934-35 session here on Monday, September 3.

Seniors Enroll Thursday  
Seniors will enroll on Thursday morning, August 30 at 8 o'clock; Juniors will enroll Thursday afternoon, August 30, at 1 o'clock; Sophomores will enroll on Friday morning, August 31, at 8 o'clock and Freshmen will enroll Friday afternoon, August 31, at 1 o'clock.

Enrollment for the seventh grade will also begin at 8 o'clock Friday morning and the sixth grade will start enrolling Friday afternoon at 1 o'clock. The fourth and fifth grade students will also enroll on Friday morning at 8 o'clock, while the first and second, and third grades will enroll Monday morning, September 3, at 8 o'clock.

East Ward Transfers  
Special attention was called to the fact that the fourth and fifth grade students will go to the East Side School this year, following the same method of placement as year before last.

"The line for first, second and third grade pupils will be drawn again at East Avenue," Mr. Farrar said. "This is the avenue that runs along the east side of the square, along in front of the First Baptist Church and out by the City Park."

"All first, second and third grade pupils on the east side of East Avenue will enroll at the East Side School. All on the west side of East Avenue will enroll at the West Side School. If this division does not balance the teaching load in these grades, I reserve the right to make transfers along on either side of East Avenue until the teaching load is balanced."

Political Interest Generally Centered On Three Races In Primary

With only twelve races on the ballots for residents of Collingsworth County in the second primary here Saturday, August 25, political interests generally centered on three races.

The governor's race continued to hold interest as workers for Tom Hunter and James V. Allred, both of Wichita Falls, took last minute campaign steps and advanced arguments for their particular candidate. Speakers for both Hunter and Allred were in Wellington Saturday with Major E. A. Simpson speaking in behalf of Allred and Max Boyer of Perryton speaking in behalf of Hunter. Hunter supporters firmly stood their ground that Hunter had the election "sewed up" while Allred men predicted that their man would carry the county by an overwhelming majority.

Hold Local Interest  
Active steps also went forward in the race for State Representative of the 122nd district as John Puryear, seeking re-election and opposed by Eugene Worley of Wheeler county swung into the last lap of their race.

The race for county clerk of Collingsworth County also held active interest with Mrs. Dick Wiles and H. A. Phillips both seeking election in the run-off.

### Five Wellington Youths Place On College Farm

CANYON, Texas—Henry Young, James Young, J. T. Bradley, Ernest Morgan and Curtis J. Clement of Wellington have been chosen for five of the 50 places on the West Texas State Teachers College Farm which is under the direction of Professor T. M. Moore of the Agriculture Department.

The men who live on the farm are chosen annually from scores of applicants. In order to be eligible for a place, each young man must have at least \$150 with which to pay his college fees and his share in the co-operative living plan which is used on the farm.

These young men with their farm associates are to report in Canyon on September 18 when the fall session of college opens. Every man who works on the farm is chosen after a careful investigation of his grades in high school or college, his character and reputation, and his ability to do some one of the special duties in connection with the dairy and farm.

The college farm is located one mile from the campus and the young men reach the campus by means of bus transportation—the bus being locally known as the T-Anchor Fresh Air Taxi Cab.

## Diverse Crops Follow Move To Reduce Cotton

### Texas Farmers Put Lands To Other Uses When Acreage Was Cut

AUSTIN—Crop diversification followed the federal government's campaign to reduce cotton acreage, figures released by the United States Department of Agriculture for Texas reveal.

The 1933 Texas cotton cultivation of 11,488,000 acres was reduced to 10,576,000 in 1934, a decline of nearly 2,000,000 acres.

About 1,000,000 acres of this decrease was planted to wheat. The 1933 wheat acreage was 1,973,000 while acreage reported this year was 2,861,000. Despite extremely unfavorable growing conditions due to the drought the Texas wheat harvest this year was estimated at almost double last year's.

#### Expectation Double

The expected production of 1934 wheat was 25,749,000 bushels compared to 13,022,000 last year.

Farmers planted 271,000 more acres in corn in 1934 than in 1933 but the prospective harvest was sharply decreased by dry weather. The government estimated the Texas corn crop on August 1 at 59,930,000 bushels, 17,894,000 bushels less than last year.

Acreage planted to oats was 357,000 in excess of the acreage planted in 1933. Production was estimated at 34,012,000 bushels, 12,208,000 in excess of last year. The increase in the oats production was regarded as fortunate owing to the severe shortage of other feed crops.

#### More Barley

Nearly 1,000,000 more bushels of barley will be produced this year from only 34,000 additional acres than was harvested last year, the government estimated. Predicted barley production was 2,678,000 bushels this year compared to 1,720,000 last year.

The price received by producers of farm products on July 15 was estimated by the government to be the highest since June, 1931, owing to the substantial reduction in prospective production.

# What War Was Tom Hunter In? Queries Allred

## Attorney General Cites War Service As Point In Campaign

TEMPLE, Texas—Completing his Central Texas tour Saturday night, Attorney General James V. Allred appeared in fine fettle when he spoke here. His attacks on his opponent, Tom F. Hunter, were just as vigorous as those which have characterized all of his speeches this week.

His Temple speech was the fourth on his Saturday schedule, which included three counties—Limestone, Hill and Bell. His forenoon speech was made at Coolidge, where he was introduced by Gordon Satterwhite, a nephew of former Speaker Lee Satterwhite. His first afternoon speech was at Hubbard and he was introduced by Ben Davis, professor of public speaking at the University of Texas. The second afternoon speech was at Hillsboro, with R. L. Bobbitt of Laredo, former resident of Hill county, whom Allred defeated four years ago for Attorney General, introducing him.

Allred's night speech was made at City Park, Temple, where he was presented by DeWitt Bowmer, Temple attorney, and Allred chairman for Bell County.

Mr. Bowmer, referring to the large crowd present, referred to it as "what is known around here as an old time Ferguson meeting." Temple is the former home of the Fergusons.

Allred exhibited a platform on which appeared pictures of Sam Houston, Jim Hogg and Tom Hunter. "This shows a picture of Houston the size of a half dollar, that of Hogg as big as a dollar and Hunter's three times as big as both combined. The effrontery of it! What war did he fight or what battle did he win to place himself on a par with Sam Houston? What office has he held or what statesmanship has he displayed to liken himself to Hogg?"

"Both of Hogg's sons, Tom and Mike are supporting me in this campaign."

"He may want to call it the 3-H Club. I call it a lot of hokey."

"It's a disgrace to Texas, I think, said a man in the audience at Coolidge while Allred was commenting on the Hunter placard."

"In this instance," said Allred, "I think the three H's stand for Hoover, Hitler and Hunter."

Alluding to the question as to whether he was too young to be governor, Allred said, "I am willing to take the responsibility for mistakes we young men may have made in Texas if Tom will take the blame for the political blunders of the old codgers."

SECTION 4: That to pay the interest on said bonds and to create a sinking fund sufficient to discharge them at maturity, this court will levy a continuing direct annual ad valorem tax on all taxable property of said County, of and at an annual rate sufficient for the purpose stated; such tax to be levied, assessed and collected out of the Fifteen Cents Road and Bridge Fund Tax authorized by Section 9, Article 8, of the Texas Constitution.

SECTION 5: That the said proposed refunding bonds shall be examined and certified by the Attorney General and registered by the State Comptroller in a book kept for that purpose, provided, however, that such bonds will not be registered by the State Com-

troller until the warrants in lieu of which they are to be issued are presented to the Comptroller for cancellation; and, provided further, that after the registration of such bonds, the Comptroller will cancel the warrants and deliver the bonds to the proper party or parties; and, provided further, that the warrants may be presented for cancellation in installments and a like amount of the bonds registered and delivered, as provided by statute.

SECTION 6: That a copy of this order shall be published in a newspaper of general circulation within said County, and which publication shall be Notice of the Intention of said Court to pass the order authorizing the issuance of the refunding bonds, for the purpose and amounts herein stated, and this order, when marked "Notice of Intention to Issue County Refunding Bonds," signed by the County Judge and the Sheriff of said county, and countersigned by the county Clerk and Ex-Officio Clerk of the Court, and published at least once a week for three successive weeks in said newspaper, the date of first publication to be at least thirty days before the said 24th day of September, 1934, being the day of the meeting of the Commissioners' Court at which the proposed refunding bond order will be passed.

SECTION 7: At any time before the said 24th day of September,

1934, being the date fixed for the issuance of such refunding bonds, not less than ten percent of the qualified property tax-paying voters of the county, as shown by the records in the office of the county Tax Collector, may file a petition in the office of the County Clerk, praying this court to order an election for the purpose of submitting the proposition to issue such bonds to a vote of the qualified property tax-paying voters of the county; and upon the filing of such petition, such Court shall, at the next meeting thereof, order an election to be held in said county to determine whether or not such refunding bonds shall be issued as indicated in such petition.

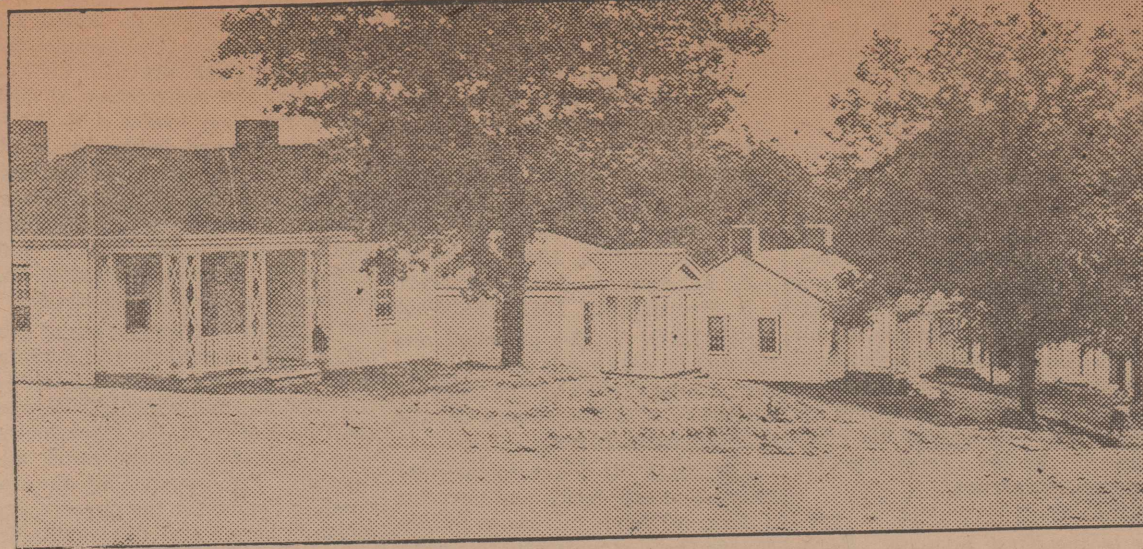

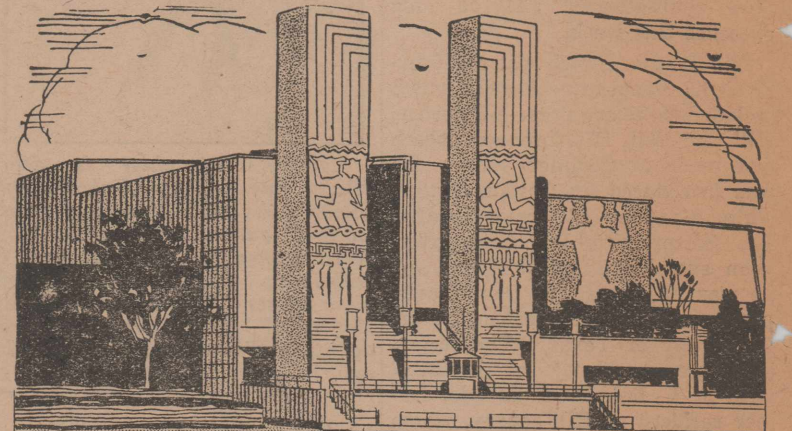

# Fire Prevention Board Holds Call Meeting Friday

## General Public Warned Of Danger In Crowds Rushing To Fires

A called session of the Wellington Fire Prevention Board was had on August 17th. All available information to date on the fire of August 14th, in which a residence belonging to R. C. Johnson and occupied by F. H. Melton was burned, was considered and weighed and a report authorized to the proper authorities. These investigations by this Board are for the fact finding purposes and may tend either to exonerate or condemn. We look with some degree of satisfaction on the decreased losses by fire since this Board has been functioning and assure the property owners of Wellington that everything in our power will be done to further mitigate this hazard. At this point we wish to again call attention to the necessity of cooperation from the citizenship in order that the greatest degree of safety may be had and that the losses by fire may be held to a minimum. Each one should watch closely the dry grass or combustible accumulations on or adjacent to their properties and see that this hazard immediately is eliminated. We wish also to call attention of the general public to the danger of crowds rushing to fires. Should you be injured or killed, and there is grave danger of such, no recourse could be had. The first few minutes of a fire offer the greatest opportunity for it to be extinguished with minimum loss and anything which delays the arrival of fighting equipment adds to the hazard.

We wish to commend the volunteer fire department of Wellington for their general efficiency and up to dateness in keeping abreast of the latest methods of fire fighting and for the general spirit of comradeship and cooperation within their ranks and trust that the citizenship as a whole may spend some thought as to how each may add his bit to their efforts to reduce still further the losses by fire in Wellington.

**HOUSE JOINT RESOLUTION NO. 42**  
Be It RESOLVED by the LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 30, Article 16 of the Constitution of Texas be amended so as to hereafter read as follows:

"Section 30. The duration of all offices not fired by this Constitution shall never exceed two (2) years, except that the elected officials of a city that has adopted and amended its Charter as provided in Section 5, Article XI of the Constitution of Texas may, by amendment to such city's charter, hold office not to exceed four (4) years; provided, that when a Railroad Commission is created by law it shall be composed of three (3) Commissioners who shall be elected by the people at a general election for State officers, and their term of office shall be six (6) years; provided, Railroad Commissioners first elected after this Amendment goes into effect shall hold office as follows: One shall serve two (2) years, and one four (4) years and they shall have qualified. And one Railroad Commissioner shall be elected every two years thereafter. In case of vacancy in said office the Governor of the State shall fill said vacancy by appointment until the next General Election."

"Section 2. The foregoing Constitutional Amendment shall be submitted to the qualified electors of the State on the next General Election to be held on the first Tuesday after the first Monday in November, 1934, at which election all voters favoring such proposed amendment shall write or have printed on their ballot the words: "For the Amendment to the Constitution of the State of Texas permitting Home Rule Cities to so amend their charters that the elected officials of such cities may hold office not to exceed four (4) years," and those opposed shall write or have printed on their ballots the words, "Against the Amendment to the Constitution of the State of Texas permitting Home Rule Cities to so amend their charters that the elected officials of such cities may hold office not to exceed four

(4) years."

**HOUSE JOINT RESOLUTION NO. 41**  
Be It RESOLVED by the LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 5, of Article XI, of the Constitution of Texas, be amended so as to hereafter read as follows:

"Section 5. Cities having more than five thousand (5000) inhabitants may, by a majority of the qualified voters of said city, at an election held for that purpose, adopt or amend their charters, subject to such limitations as may be prescribed by the Legislature, and providing that no charter or any ordinance passed under said charter shall contain any provisions inconsistent with the Constitution of the State, or of the general laws enacted by the Legislature of this State; said cities may levy, assess and collect such taxes as may be authorized by law or by their charters; but no tax for any purpose shall ever be lawful for any one year, which shall exceed two and one-half percent (2 1/2 percent) of the taxable property of such city, and no debt shall ever be created by any city, unless at the same time provision be made to assess and collect annually a sufficient sum to pay the interest thereon and creating a sinking fund for at least two percent (2 percent) thereon; provided further, that no city charter shall be altered, amended or repealed oftener than every twelve (12) months."

Section 2. The foregoing Constitutional Amendment shall be submitted to the qualified electors of the State at the next general election, to be held on the first Tuesday after the first Monday in November, 1934; at which election all voters favoring such proposed amendment shall write or have printed on their ballots the words: "For the Amendment to the Constitution of the State of Texas permitting any Home Rule City to alter, amend or repeal its charter every twelve (12) months;" and those opposed shall write or have

printed on their ballots the words, "Against the Amendment to the Constitution of the State of Texas permitting any Home Rule City to alter, amend or repeal its charter every twelve (12) months."

**SENATE JOINT RESOLUTION NO. 13**  
Be It RESOLVED by the LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 3 of Article VIII of the Constitution of the State of Texas be amended so as to hereinafter read as follows:

"Section 3. Taxes shall be levied and collected by general laws and for public purposes only; and the total amount of revenue which the State shall be authorized to collect during such biennium from taxes, licenses, permits and fees, (except fees paid by students to state educational institutions, and except rentals, bonuses and royalties obtained from public lands and other public property) shall not exceed a sum reasonably estimated to equal the product obtained by multiplying the number of inhabitants of this State by the sum of Twenty-two and 50-100 (\$22.50) Dollars; provided however, the total amount of such revenue which may be so collected, shall be reduced by the amount of any surplus funds or unexpended appropriations remaining at the close of the preceding biennium. The expenditures of the State government of funds derived from the sources above referred to shall never exceed during any biennium, a sum equal to the product obtained by multiplying the number of inhabitants of this State by the sum of Twenty-two and 50-100 (\$22.50) Dollars, provided, however, that the population of the State (in determining the amount of revenue which may be collected from taxes, licenses, permits and fees or expended from the revenue thus obtained) shall be determined by the then last preceding Federal census, to which population shall be added or deducted, as the case may be, for each year that has lapsed since

the last preceding Federal census, the average yearly increase or decrease of the population as shown by said Federal census, when compared with the Federal census which immediately preceded said last Federal census. Provided, further, that in case of war, riots, or insurrection, or a statewide calamity caused by earthquake, fire flood or an epidemic which seriously threatens the health of the citizens of this State, the Legislature shall have authority, by a two-thirds vote of both Houses, to suspend for a definite period this constitution limitation as to the amount of money which may be collected and expended during the biennium."

Section 2. The foregoing Constitutional Amendment shall be submitted to the electors of this State qualified to vote on constitutional amendments at an election to be held throughout the State on the first Tuesday after the first Monday in November, A. D., 1934, at which election each ballot shall have printed the words:

"For the Amendment of Section 3 of Article VIII of the State Constitution privileging for the levying and collection of taxes and fixing the maximum amount thereof which can be collected and expended each biennium."

"Against the Amendment of Section 3 of Article VIII of the State Constitution, providing for the levying and collection of taxes and fixing the maximum amount hereof which can be collected and expended each biennium."

**SENATE JOINT RESOLUTION NO. 21**  
Be It RESOLVED by the LEGISLATURE OF THE STATE OF TEXAS:

Section 7. That Section 1 of Article 9 of the Constitution of the State of Texas, be amended so as to hereafter read as follows:

"Section 1. The Legislature shall have the power to create counties for the convenience of the people subject to the following provisions:

First. In the territory of the State existing or to all counties now existing, no new counties shall be created with a less area than nine hundred square miles, in a square form, unless prevented by the pre-existing boundary lines. Should the state lines render this impracticable in border counties, the area may be less. The territory referred to may, at any time, in whole or in part, be divided into counties in advance of population and attached, for judicial and land surveying purposes, to the most convenient organized county or counties.

Second. Within the territory of any county or counties now existing, the Legislature may by a two-thirds vote of both Houses, create new counties, combine existing counties and parts of counties and abolish existing counties and change county boundaries at will, provided that no new county shall be created with an area of less than nine hundred square miles nor shall any existing county be reduced in area so as to contain less than nine hundred square miles, unless such new county or such remaining county, and both shall have a population of not less than fifty thousand according to the last United States census prior to the date of the creation or change of such county. When any part of a county is stricken off and attached to, or created into another county, the part stricken off shall be held for and obligated to pay its proportion of all liabilities then existing, of the county from which it was taken, in such manner as may be pre-

scribed by law.  
Third. No part of any existing county shall be detached from it and attached to another existing county until the proposition for such change shall have been submitted in such a manner as may be provided by law, to a vote of the electors of both counties and shall have received a majority of those voting on the question in each."

Section 2. The foregoing amendment to the Constitution shall be submitted to a vote of the qualified electors of this State at an election to be held throughout the State on the first Tuesday after the first Monday in November, 1934. At this election all voters favoring said proposed amendment shall write or have printed in that ballot the words:

"For the amendment to Section 1 of Article 9 of the Constitution of Texas, providing that the Legislature may, by a two-thirds vote of both houses, create new counties and change the boundaries of existing counties."

Those voters opposing said proposed amendment shall write, or have printed on their ballot the words:

"Against the amendment to Section 1 of Article 9 of the Constitution of Texas, providing that the Legislature may, by a two-thirds vote of both Houses, create new counties and change the boundaries of existing counties."

**HOUSE JOINT RESOLUTION NO. 30**  
Be It RESOLVED by the LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 16, Article VII of the Constitution of the State of Texas, be amended so as to hereinafter read as follows:

"Section 16. All land mentioned in Section 11, 12 and 15 of Article VII of the Constitution of the State of Texas, now belonging to the University of Texas shall be subject to the taxation for county and school district purposes to the same extent as lands privately owned; provided they shall be rendered for taxation upon the values fixed by the State Tax Board and that the values fixed for school district purposes shall not exceed the values fixed or county purposes on the same land; and provided that the University of Texas from the University Available Fund, shall remit annually to each of the counties and school districts in which aid lands are located an amount equal to the tax imposed upon said land for county and school district purposes."

Section 2. The foregoing Constitutional Amendment shall be submitted to the qualified electors of the State at the next general election, at which election all voters favoring said proposed amendment shall write or have printed on their ballots the words: "For the Amendment to the Constitution of the State of Texas, subjecting the lands of the University of Texas to taxation for county and school purposes, and providing for the payment of said taxes to the proper authorities of the counties and school districts where said lands are located," and all those opposed shall write or have printed on their ballot the words: "Against the Amendment to the Constitution of the State of Texas subjecting the lands of the University of Texas to taxation for county and school district purposes, and providing for the payment of said taxes to the proper authorities of the counties and school districts where said lands are located."

**SENATE JOINT RESOLUTION NO. 2**  
Be It RESOLVED by the LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That the Constitu-

tion of the State of Texas, Article 16, be amended by adding thereto another Section, Section 61, which shall read as follows:

Section 61. All district officers in the State and all county officers in counties having a population of twenty thousand (20,000), or more according to the then last preceding Federal census, shall hereafter be compensated on a salary basis. In all counties of this State the Commissioners' Court shall be authorized to determine whether precinct officers shall be compensated on a fee basis or on a salary basis; and in counties having a population of less than twenty thousand (20,000) according to the then last preceding Federal census, the Commissioners' Court shall also have the authority to determine whether county officers shall be compensated on a fee basis or on a salary basis. All fees earned by district, county or precinct officers shall be paid into the County Treasury where earned, for the account of the proper fund, provided that fees incurred by the State, county and any municipality, or in cases where pauper's oath is filed, shall be paid to the County Treasury, when collected, and provided that where any officer is compensated wholly on a fee basis, such fees may be retained by such officers, or paid into the Treasury of the county as the Commissioners' Court may direct. All Notaries Public, County Surveyors and Public Weighers shall continue to be compensated on a fee basis."

Section 2. The foregoing Constitutional Amendment shall be submitted to vote of the qualified voters of this State and the next general election to be held on the first Monday in November, A. D. 1934, at which election all voters favoring said proposed amendment shall write or have printed on their ballot, the words:

"For the Amendment to the Constitution of the State of Texas adding Section 61 to Article XVI, abolishing the fee system of compensating all district officers and all county officers in counties having a population of twenty thousand (20,000) or more; and authorizing the Commissioners' Court to determine whether county officers in counties containing less than twenty thousand (20,000) population shall be compensated on a fee basis or a salary basis; and authorizing the Commissioners' Court in all counties of this State to determine whether precinct officers shall be compensated on a fee or a salary basis."

"Against the Amendment to the Constitution of the State of Texas adding Section 61 to Article XVI, abolishing the fee system of compensating all district officers and all county officers in counties having a population of twenty thousand (20,000) or more; and authorizing the Commissioners' Court to determine whether county officers in counties containing less than twenty thousand (20,000) population shall be compensated on a fee basis or a salary basis; and authorizing the Commissioners' Court in all counties of this State to determine whether precinct officers shall be compensated on a fee or a salary basis."

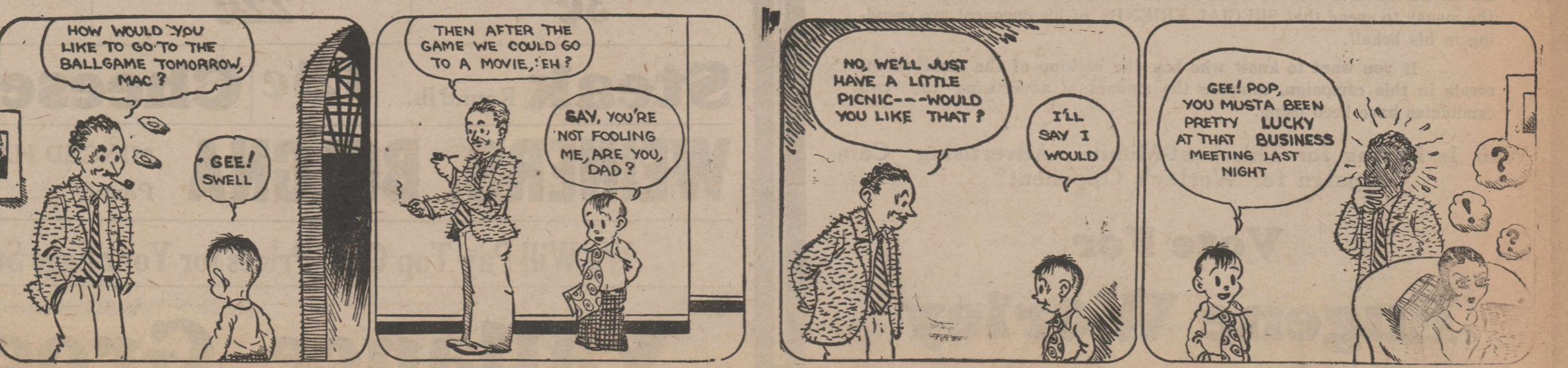

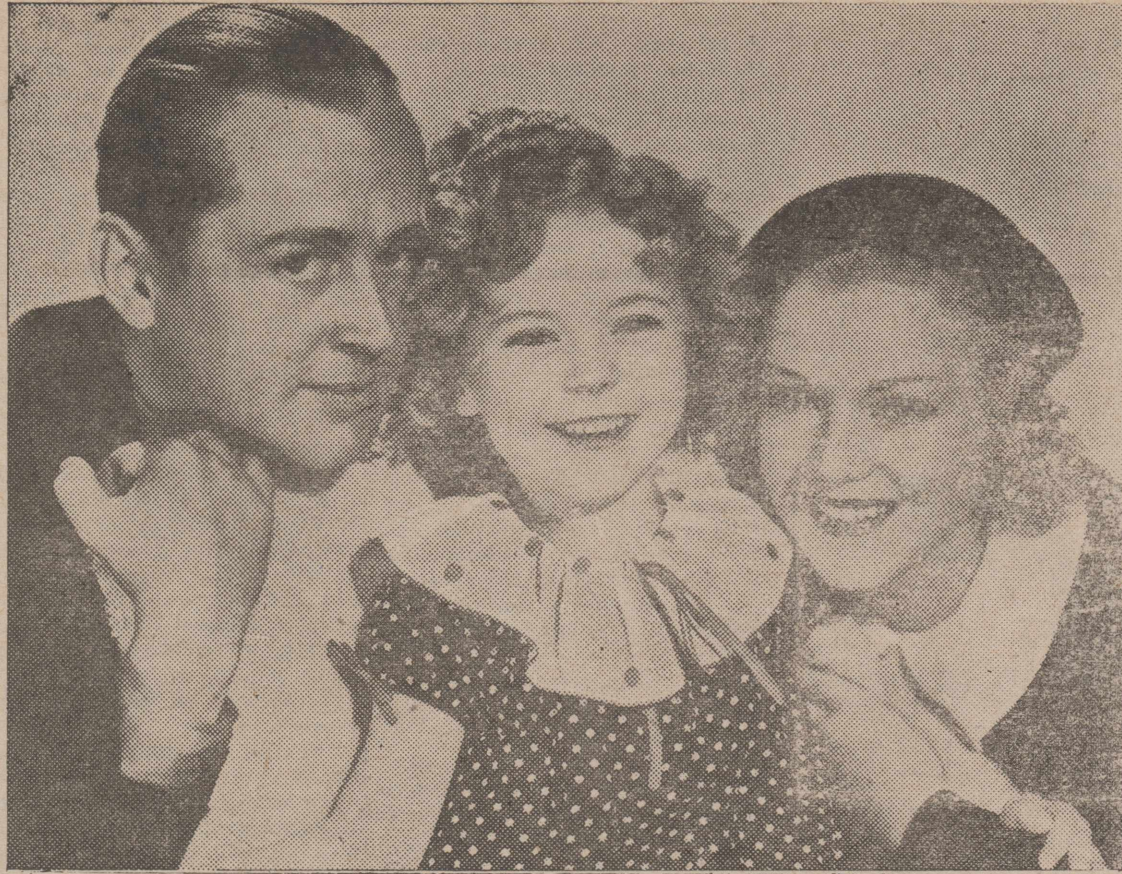

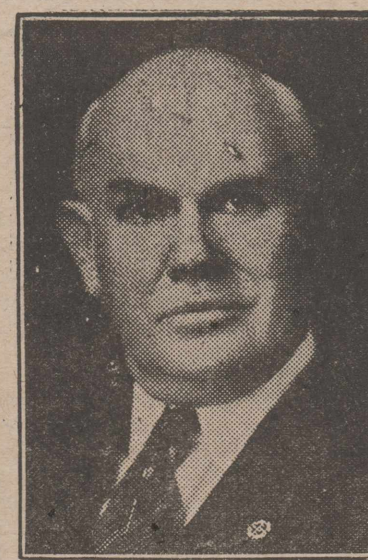

# Hunter Issues Tax Challenge To Jim Allred

## Tom Hunter Asks Opponent To Explain Opposition To Penalty Plan

BROWNWOOD, Texas—Two challenges were issued by Tom Hunter to James V. Allred in his Brownwood speech on Wednesday night. One dealt with legislation affecting relief from penalties on delinquent taxes. The other referred to what Hunter termed Allred's opposition to select taxes.

J. Edward Johnson, Brownwood attorney, presided. W. R. Chambers, dirt farmer of the May Community, fifteen miles north of Brownwood introduced Hunter.

Capt. Rex Gaither of Service Company, 142nd Infantry, Brownwood, in a brief address, predicted Hunter would carry Brown county by 4 or 5 to 1.

"The day has come," Captain Gaither said, "when the editorials in newspapers represent the idea of only one man. In Camp Hulen at Palacios, from which I have just returned, an Allred man is a freak."

Cleve Callaway, who headed the Cross Plains delegation, said, "The hunters are coming in, their game bags are all red."

In his introductory speech, Mr. Chambers referred to Hunter as "a leader who can save us in this critical hour. With the coming of Hunter the political hatred of twenty years is passing away; it means a rainbow of promise in the political sky of Texas."

Hunter's challenge as to penalties on delinquent tax payments dared Allred "to explain to the farmers and small home owners why he so bitterly opposed legislation that would make it effective."

"Though Allred declared the act relieving distressed taxpayers unconstitutional, the Supreme Court ruled otherwise, and upheld this measure over my opponent's protest," Hunter said. "If the Supreme Court had been forced to follow Jimmie's opinion, it would have cost the distressed home and farm owners many thousands of dollars. Apparently the court had more sympathy for those about to lose their homes than Jimmie."

"I challenge Jimmie to make another explanation. He flatly declares himself opposed to select taxes. If he intends to carry this to its conclusion, from what source would he get funds lost to the schools and the roads of the State by abolishing the cigarette and gasoline tax levies? These are select taxes of the type he has declared against."

### Says Allred Has No Plan

Allred had nothing to say about relief until the run-off began, Hunter contended. While attacking Hunter's blended tax plan and his proposal to relieve real estate of an unfair burden of taxation, Allred himself had no feasible plan to offer, Hunter said.

Issue was taken by Hunter with a statement he credited to Allred, that with the ad valorem tax removed from real estate big companies would profit. Hunter maintained his net earnings plan on the bigger brackets would compel large companies to pay many times in excess of that lost from the abolition of ad valorem tax on real estate.

Hunter declared Allred ignored the farmers and owners of small business buildings.

"In fact every step he has taken has been against their interests," Hunter said.

Repeating his plank to have a Government's cabinet in lieu of 131 unrelated bureaus and boards, and for the recall of State officials who forget their campaign promises, Hunter again charged Allred with favoring centralized government. As proof of this he said his opponent carried a page ad in an East Texas oil journal declaring himself for reorganization of State government along business lines to centralize power and fix responsibility.

The acceptance certificates have figures on them corresponding to table VII (8), of their contracts, and if the receiver of these certificates will just refer to their contracts, to the above mentioned table, the figures will be self explanatory, and will save a lot of time in this office in explaining the meaning of these slips. The most confusion in these, is the item of farm allotment, this does not in any way, refer to the ginning allotment, it is merely the figure on which the government will make the parity payment, and is 40 percent of the gross adjusted 5-year production of lint, on the farm covered by the contract.

OLD SETTLERS GRATEFUL

More than 1,200 persons Thursday gathered for the Old Timer's Re-union at the Small Grove. Not only the largest crowd in the history of the reunion, but the manner in which the event was conducted, undoubtedly acclaimed the affair a success.

One of the most pleasing conditions of the entire gathering was the fact that old settlers proudly wore and displayed their badges. The badges were in three classifications: for persons who came here between 1888 and 1890; from 1890 to 1895, and from 1895 to 1900.

Everyone of the 1,200 persons attending the reunion gave evidence of completely enjoying the affair—and it really did the younger citizens good to see those old settlers clasp hands and recall incidents which occurred 10, 20, 30 and 40 years ago.

The old settlers will always merit the high esteem of the county but those who worked to make the reunion a success also deserve special credit and the enthusiasm accorded the Reunion of 1934 was indeed outstanding.

Many of the early settlers, as they started to leave town, came by the Leader office and expressed their genuine appreciation for being able to meet their friends and for having once more been able to talk over old times.

"It was indeed an enjoyable day," many of them said, "we are glad the reunion was such an outstanding success. We want you to let the people know that we appreciate it and we are looking forward to another such reunion in 1935."

MOVIE SALARIES

When Sol A. Rosenblatt, code administrator for the motion picture industry, revealed recently that one screen star received a \$315,000 salary last year, and a few others came close to the \$300,000 mark, he mentioned no names. Ever since, writers who are supposed to have inside information concerning the salaries of big shots of the films have been trying to identify the top-notchers.

Taking Mr. Rosenblatt's figures, one writer picks a few of the highest paid stars as follows:

He concedes the highest salary of all, \$315,000, to Will Rogers. He places Constance Bennett second with \$296,250; Ruth Chatterton third with \$283,654; John Gilbert fourth with \$277,333; Nicholas Schenik president of two producing corporations, is rated fifth with \$273,596. The highest paid director is thought to be Ernest Lubitsch at a salary of \$150,000.

But Will Rogers' top salary is less than half the \$750,000 a year once spurned by Gloria Swanson, and far less than the \$12-

000 a week once paid to Colleen Moore. Weekly salaries, however, are usually paid only when the star concerned actually works. Last year, it is said John Barrymore received \$25,000 a week, but he worked less than four weeks out of 12 months, earning \$91,666.

To the average person all of these high salaries seem excessive, and the fact that most of the big producing companies have been in receivership or have gone bankrupt during the depression seems to confirm that opinion.

A DOUBLE FAKE

Among the many freaks and fakes exhibited by the great showman, P. T. Barnum, who declared that "people like to be humbugged" and cashed in on the idea, was the "Cardiff Giant," represented to be a petrified man, ten and a half feet tall.

The "giant" was a fraud, being a rude statue of a man, carved of gypsum in Iowa, and buried by a practical joker in the bed of a creek near Cardiff, a hamlet near Syracuse, N. Y. The joker then had the statue "discovered," and spread the news of the find far and wide. That was in October, 1869.

Later it was exhibited around the country as a "petrified man," and a good many scientific men were inclined to believe it to be genuine until a Yale professor made an examination and exposed the fake.

While the "giant" was in popular favor and drawing large crowds, Barnum tried to buy it to add to his collection of circus side-show attractions. When the owner named a price thought too high, Barnum proceeded to have a giant of his own made. This imitation of a fake—a sort of double fake—was successfully exhibited by Barnum as the Cardiff Giant, in America and abroad, for several years.

The original "giant" is getting some fresh publicity just now, owing to the fact that the Chamber of Commerce of Syracuse is trying to have it brought back to that city from Iowa, where it has been resting in obscurity for several decades. So great was the sensation created by the giant hoax that the statute has come to have certain historic value.

THE YOUTH PROBLEM

From the earliest times it appears that the problem of directing young folks in the proper way has engaged the serious attention of reformers and uplifters—and busy bodies.

A book on etiquette published in 1850 gravely warns young women of the perils of the waltz and declares that "unmarried ladies should refrain from the waltz altogether, in public and in private." It is assumed that married ladies were supposed to be immune to its demoralizing effects.

Every once in a while someone digs up an old newspaper or magazine containing an article which throws light on this tendency to worry about the young people of the past. The boys and girls of the present generation are causing consternation among the self-appointed guardians of morality.

There is little reason, however, for believing that the young folks of 1934 are any worse, morally or otherwise, than those of former times. Like others before them, they will probably grow up to worry about their own children and grandchildren.

OUR PAST

We can never tell what the coming day will bring forth. This was the case with Stephen F. Austin.

While Texas was a young colony in possession of Mexico, Austin's health had begun to fail him and he had planned a trip of a year's rest back to the United States.

Prior to his leaving on his visit, the colonists held a meeting in regards to their relations with Mexico and decided to send three representatives to Mexico City to try and secure some changes in the government of the Texas colony.

Austin, Miller and Seguin were chosen as commissioners to go on this mission. The two other commissioners found good and sufficient excuse to beg off, therefore leaving Austin to make the trip alone.

Then came his trip of five weeks at sea on a small schooner, buffeted by unfavorable winds, with only coarse salt food with very little fresh water, all of which had continued to affect his already failing health.

Shortly after arriving in Mexico City, his mission was misunderstood and Austin was arrested and placed in a dungeon, without trial or hearing of any kind.

The room he was placed in was about fifteen by thirteen feet, with a very high ceiling and two doors. It had no windows, a very small skylight in the roof which barely afforded light to read with on clear days, between ten and three o'clock.

At the time of his arrest Austin had a small blank book on his person, which he managed to conceal when he was searched. During his imprisonment he made entries in this book from time to time, which reflects his moods and discloses some of the thoughts that occupied his mind.

The following are some of the excerpts from his entries. "What a horrible punishment is solitary confinement," he wrote on February 22, after having been ten days "shut up in a dungeon with scarcely light enough to distinguish anything."

Again, he wrote, "A public agent should sacrifice himself, life and property, should it become necessary in order to carry out the views of his constituents. I perhaps have followed this rule to an extreme."

Another time his thoughts turned to his sister and he wrote, "My poor sister, who removed to the wilderness of Texas with her large family owing to my solicitations, and left a comfortable home and a large circle of warm and kind friends. How happy I could have been on a farm alongside of my brother-in-law, far from all the cares and difficulties that now surround me."

Another entry showed he had labored with pure intentions to benefit others and especially to advance and improve his adopted country and all he gained was enemies, persecution and imprisonment.

Love Tempers Hosea's Sermons

Text: Hosea 11:1-4, 8-9; 14:4-9. The International Uniform Sunday School Lesson for Aug. 26.

In previous lessons we have learned that Amos was a prophet with stern, rigid demands of righteousness. The sham culture, prosperity and religion of his day called forth from Amos bitter denunciation.

Hosea was no less righteous, or insistent, but in his preaching to his age there was a note of tenderness and love. He saw the sinful as erring and wandering from the right way. He put himself in the place of the Almighty, choosing a people and loving them, and filled with pity and remorse when they rejected his choice and went astray.

In spite of all their sinfulness as a nation, there was still in God's attitude, as expressed by the prophet, the luring note of love seeking to win them back to right paths, withholding vengeance and judgment and offering healing and restoration. It is a beautiful lesson that is before us, moving in its tenderness and in its vision.

Have the Amoses, or the Hoseas, accomplished the more in history? We need them both. We need the stern moralists who denounce evil and corruption, who tear off the things that cover shams, and who shake rotten things to their very foundation.

But we need, also, the tender and loving prophets who understand why men go astray, who see that even violence and corruption are perversions of right attitude and

character, and who would stand at the crossways of life appealing to men to avoid the wrong way and to travel the right road.

There is need, also, of luring those who have taken the wrong turning back into the right way. Hosea was a man of deep vision. His question in the closing verse of our lesson is still one that challenges the world.

"Who is wise?" he asks, "and he shall understand these things; prudent and he shall see them?"

Sin, after all, is foolishness and destruction. Neither individuals nor nations can go the way of selfishness and greed without destroying what they would uphold. The advantages of selfishness and dishonesty are illusory. When we allow shiftiness and self-seeking to get hold upon life in business, in politics, or in other relationships, it does not require a deep or far-seeing prophet to see what is going to happen in national and social life.

What does call for vision and faith and courage in the prophet is to discover the means of turning the hearts of men from the temptations of selfishness and greed to ways of right and truth.

Our task is not only to uphold goodness, but to make goodness effective. Righteousness will not save a nation unless it is practiced and organized. Technique is necessary, as well as good will and earnest purpose, in every effort, to establish a nation in integrity and to build society into a commonwealth.

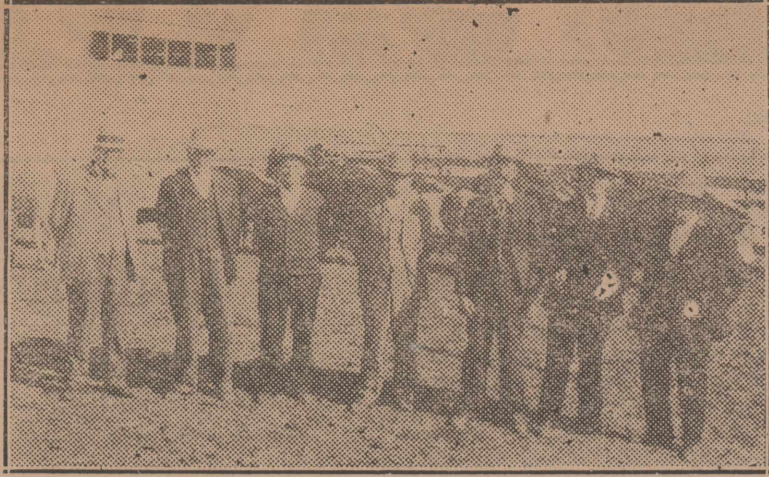

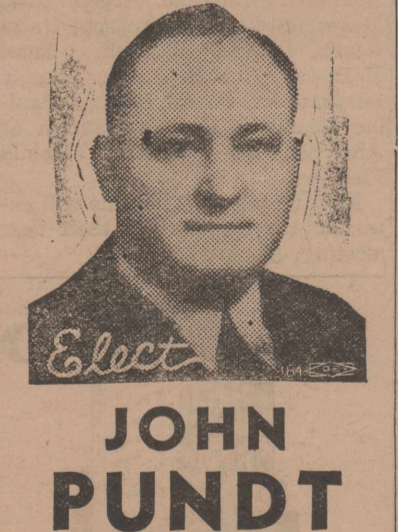

## Trench Silo Used To Store Feed On Ed Blaine Farm

### Chopping Cost Eliminated Through Placement Of Whole Bundles

Despite the fact that dry weather is cutting the feed crop in Collingsworth County very short, Ed Blaine says that he will have something to feed his stock this winter.

At the farm of Ed Blaine's, 2 miles north and 1 mile east of Wellington, with the assistance of Roy Fulcher, Robert, Frank and Clint Blassingame, a trench silo, 75 feet long, 11 feet wide and 10 feet deep has been constructed. There is no material in the structure and labor has been the only cost.

At this time the feed that is burning before matured is being cut and the entire bundles placed in the trench and packed. About 150 gallons of water per ton is being added and allowed to penetrate throughout. The feed will be rounded up some two or three feet high to allow for settling and covered with twelve to fourteen inches of dirt. This will exclude the air and prevent decay.

During the fall and winter one end of the trench will be opened and feeding begun.

Placing the whole bundles in the silo eliminates the cost of chopping with ensilage cutter. Silage will be just as good as if cut, may not be as easy to handle as if chopped. Mr. Blaine and his farmers will have the assurance of some good feed this winter, while other farmers are allowing their feed to burn up entirely at this time.

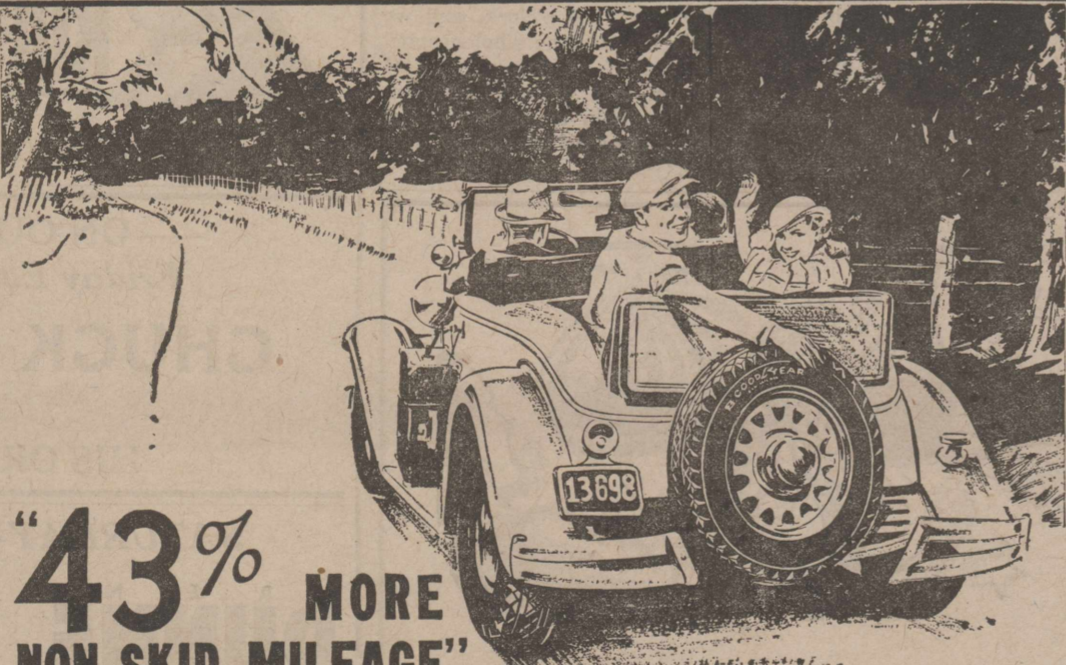


