BRITISH STRIKE DEADLOCK HOLDS

Methodists Rap Divorce As "Terrible Evil" PRONOUNCE JACKSON DEATH ACCIDENT

CORONER ISSUES REPORT IN CASE OF DEAD COWMAN

INQUEST DISCLOSES GUN WAS FIRED SOLELY IN ACCIDENT TUESDAY

The tragedy Tuesday afternoon, shortly after one o'clock, which resulted in the death of C. F. Jackson, pioneer South Plains cattleman, who was found shot to death in his car in his own garage, 1912 Tenth street, was purely accidental, the coroner's verdict, rendered Wednesday morning by Col. W. E. Johnson, justice of the peace, read.

Funeral services for Mr. Jackson will be held at the family residence on Thursday morning, at ten o'clock, with Rev. D. C. Doss, retired Methodist minister, in charge of the services. Interment will follow at the Lubbock cemetery.

Pallbearers Are Announced

Pallbearers announced from the Rix Undertaking company, in charge of the funeral arrangements, include O. L. Shotton, Walter S. Posey, Thurt O. McWhorter, Albert Taylor and Charles S. Middleton, all of Lubbock, and Ross Kentrol of Seagraves. All of the men named are pioneers of this section of the country and with the exception of Mr. Posey all are now or have been actively connected with the cattle industry in West Texas.

Mr. Jackson is survived by his wife and four daughters, the latter being Mrs. Joe Jackson, of Plainview; formerly Miss Gertrude Jackson; Mrs. Sam H. Stewart, formerly Miss Tressie Jackson; Mrs. B. K. Garrett, formerly Miss Neely Jackson, and Thelma, aged 15, all of Lubbock.

Mullicans To Visit In Hawaiian Islands

Judge and Mrs. Clark M. Mullican will sail today from San Diego for the Hawaiian islands, where they will tour for several weeks. Charles H. Smith district court reporter, told the Journal Wednesday upon receipt of a telegram from District Judge Mullican.

According to Mr. Smith the Mullicans, who were married here four weeks ago Tuesday and left immediately on an extended wedding tour, are sailing aboard the S. S. Wilhelmina. They made no mention of the date that they will return to Lubbock.

Slaton Mexicans To Face Robbery Count

Jose and Sebastiano Oregon, Slaton Mexicans, are being held in the Lubbock county jail in lieu of bond and facing charges of burglary, Sheriff H. L. Johnston stated Wednesday. The brothers were arrested Saturday night at Slaton by Chief of Police Sam Sellman, and later brought here.

According to the information given Sheriff Johnston by Chief Sellman the Mexicans are thought to have robbed a Slaton residence some six weeks ago. Upon their arrest some of the goods said to have been removed from the house was alleged to have been in their possession.

Hill To Address Boys In Union Service Tonight

Dr. J. A. Hill, president of the West Texas State Teachers college at Canyon, will deliver the principal address at the union service that will be held at the First Methodist church here tonight as a part of the Boys' Week program now under way here, and will have a message not only for the boys but for the parents as well.

Dr. Hill is recognized as one of the outstanding boys workers in this part of the state, and is also one of the most interesting speakers on boys problems that local people have ever had occasion to hear, according to leaders in the movement.

The service will begin at 8 o'clock, and various boys and girls organizations of the city are planning to attend the service in a body. Boys and girls especially are urged to attend, and an invitation has been extended to all parents also. All churches of the city are joining in the service.

D. E. COLP HERE ON TRIP PLANS

State Park Board Head Plans For Rotary Caravan: He Is Pleased With Conditions

D. E. Colp, of San Antonio, chairman of the state parks commission and manager of the Glacier-To-Gulf Motorway association, was in Lubbock Wednesday morning conferring with chamber of commerce officials concerning the entertainment of the Rotary Auto caravan which will come through this city in the early part of June. The caravan, which will be made up of 700 automobiles and their drivers, will be enroute to the organization's convention in Denver and will make the trip via the Glacier-To-Gulf highway, which traverses this city.

Mr. Colp, who in the past fifteen years has served as chief guide for a number of caravans of this nature, will be in charge of the travelers. He and Sid Hardin, of Mission, governor of the 47th district of Rotary clubs, will be through Lubbock again next week to make additional plans.

The regional park convention, which will embrace five states and which is scheduled for Amarillo on May 18 and 19, will be the largest meeting of its kind ever held in the United States, Mr. Colp said.

The Governors of New Mexico and Oklahoma will be in attendance, together with many other notables. Lynch Davidson, Houston, candidate for Governor of Texas, has already promised to appear on the program, and Dan Moody, Taylor, Attorney General and also a candidate for Governor of Texas, is expected to attend.

While in Lubbock Mr. Colp stated that he was very much pleased with the state parks program and said that every major candidate for Governor had promised support for the board if elected.

Business Better In Realm of Johnston

Business has picked up considerably in the Sheriff's department during the past several days and the county's "Hotel Register" shows a number of names, Sheriff H. L. Johnston reports. Starting on Sunday the officers staged several rapid-fire arrests and as a result eight gamblers, three vagrants and a couple more miscreants were placed behind the well-known bars. The majority of the prisoners are negroes, the Sheriff stated.

Livestock Rates Are Ruled Reasonable

WASHINGTON, May 5. (P)—Rates on livestock in the region between the Missouri river and the Pacific coast have been found by the Interstate Commerce Commission to be not unreasonable and complaints by the American National Livestock Association and others have been ordered dismissed.

The complaints had alleged that rates from points West of the Missouri river and Kansas, Oklahoma, Texas and extreme Western Arkansas and Louisiana to destinations in the territory other than recognized livestock market points, were unjustified.

The commission's decision differed from the recommendations of examiners.

RECOMMEND THAT MINISTERS MARRYING DIVORCEES SHOULD BE DEALT WITH AS IMMORAL

QUESTION OF UNIFICATION IS COMMENDED BUT AVOID RECOMMENDATIONS; PROHIBITION LAW OF AMERICA IS UPHELD

(BY ASSOCIATED PRESS)
MEMPHIS, Tenn., May 5.—While the bishops of the Southern Methodist church advise against "berry hunting," the outstanding portion of their address to the general conference in session here today deals with the "rise of false prophets in the church," and methods whereby the church is to "purify the fabric of the temple."

Contending for first place among the recommendations of the bishops was the pronouncement against divorce contained in a special section devoted to that "terrible evil." The church heads depart from precedent and recommend that any minister of the church who marries people who have been divorced except for infidelity "shall be dealt with as in the case of immorality."

Unification Commended.
Commending the question of unification to the conference for "its prayerful and careful consideration," the bishops carefully avoided any recommendation on the subject other than saying "let us not come to cherish the clad expectation of closer unity of the people of God in general and our own Methodist families in particular."

Under the head of "worldliness," the bishops launched a sweeping attack, declaring "exhibitions in playhouses were never more vile and by modern devices they are brought before all classes, especially to immature youth, to a degree unknown in former times. Without exaggeration it may be truly said that they have become 'schools of vice.'"

Pro Law Upheld.
The national prohibition law "is the most remarkable social enactment of any great nation to promote the general welfare by the restriction of the activities of the individual," the address said. "The full effort of such a law will not be secured immediately or even in a decade. The industrial, social, educational, moral and religious forces of the nation, led by its Christian citizenship, overthrow the legalized liquor traffic and secured national prohibition. The same great forces must untidely fight with equal vigor and persistence the outlawed criminal traffic and the would-be nullifiers of the law."

Two Ex-Convicts Meet SECOND PRISON MEETING Again In County Jail

Everyone has heard the story about the two boys who "went to different schools together," but here's a new one. It's about two men who went to different jails together and it's vouched for by Deputy Sheriff Vernice L. Ford. Sometime ago Lubbock county officers arrested one L. B. Clinkscapes, of Hall county, and placed him in jail on a charge of stealing an automobile.

Sometime later, upon advice from Navarro county officers, the sheriff's force here picked up George Granger, wanted in Corsicana for forgery. When Granger was turned into "the bull-pen" in the county bastille, he and Clinkscapes literally "fell on each other's necks," and all but wept for joy.

When questioned by officers concerning their former companionship both men admitted doing "a hitch" in the penitentiary and working together on one of the state prison farms. Wednesday Deputy Sheriff Pevhouse, of Corsicana, escorted Granger to Navarro county to stand trial. At parting the prisoners shook hands heartily and wished each other "luck."

"Goodbye, George," called Clinkscapes, from behind the bars. "So long, Airplane," returned Granger, as he left on Pevhouse's arm.

Officers are at a loss to explain the nickname "Airplane" but at any rate—that's that!

Britain Won't Yield To Strikers, Is Said

LONDON, May 5. (P)—Premier Baldwin told the House of Commons today that the government, under no circumstances, would ever yield to the general strike. The moment the strike was called off unconditionally, the government was prepared to resume negotiations. His statement was similar to that made in the House of Lords by the Earl of Bickenhead.

Committees Will Seek To Raise Ball Fund Soon

Committees of local baseball enthusiasts that will have the approval of the Lubbock Chamber of Commerce will take the field here the first of next week in an effort to raise sufficient finances for the local amateur baseball club the coming season, and a meeting is to be held in the city hall Thursday night when plans will be perfected for the drive, it was made known Wednesday.

It is the opinion of Chamber of Commerce officials who are concurring heartily in the movement, that the Lubbock ball team has brought more favorable publicity to the city than could have been secured by any other means of anything near the same cost, and they urge that the plan for funds be not turned aside.

The money will be raised through monthly pledges, and \$1,200 per month for about three and one-half months will be asked for. The solicitation committees will be named at the Thursday night meeting, it was said Wednesday.

Walter S. Posey Gets Rousing Ovation As He Completes Successful Presidency

Hubert L. Allen, manager of the Texas Utilities company here, Wednesday took over the office of president of the Lubbock Rotary club, at the noonday luncheon of the organization. RIOTING BREAKS OUT AND TROOPS ARE HELD READY

SHIPS MOVE INTO HARBOR AS HEAVY FOG ADDS TO CONGESTION

(By Associated Press)
LONDON, May 5.—Both sides held firm today in the great British general strike. The contending forces and the general public was well settled down for what it seemed might be a long, hard war.

Gang attacks on trams and buses run by volunteer workers in Glasgow, Leeds and other provincial centers were the only sensational developments of the day until mid-afternoon. That the government was prepared for any emergency along the Clyde was shown by the news that three large ships were anchored in the river. The giant battle cruiser, Hood, joined the Warspite and cruiser, Comus, moved up the river to Glasgow.

Traffic Conditions Better

The second day of the strike saw remarkable falling off in the crowds bound for London from all parts of the suburban areas. Progress on the main roads to the city was better than yesterday, and there were fewer traffic jams at the vital spots. The reason for this was that thousands of people were informed by their employers yesterday that they need not report for duty, as little business can proceed at present.

Yesterday's bright sunshine in London gave way today to a slowly increasing fog and a damp and rainy atmosphere, but up to noon the popular seemed to be still taking the strike conditions philosophically.

Both Sides Claim Advantage.
Both the government and labor continued to work intensively on their respective problems, but hopes that they might resume negotiations, did not materialize. Both sides issued statements claiming to hold the advantage.

The newspapers are beginning to re-appear in abridged or typescript form to give the news to the populace which thus far has generally been ignorant of the strike's progress. A big crowd surrounded the office of the Daily Herald labor organ, this afternoon, awaiting the first edition of the British Workman, a paper begun last week.

Suicide Verdict In Youth's Death Given

ABILENE, May 5. (P)—Unrequited love for a girl student at McMurtry College here is given as the reason for the death of J. D. Fitzgerald, 19, of Texas A. & M. College, who died from a bullet through the heart here last night. He arrived yesterday and visited the college and is said to have sought marriage with a young woman. He threatened suicide and the young woman left the parlor in Hunt Hall. A few minutes later a shot rang out. A verdict of "death by suicide" was rendered by Justice Ford. Fitzgerald was a freshman at A. & M. and came from Palestine.

Former Judge Takes Deanship At S. M. U.

SAN JUAN, Porto Rico, May 5. (P)—Former United States District Judge Peter J. Halliton, of Mobile, Ala., who was appointed by President Wilson, today announced that he has accepted the deanship of the law college of the Southern Methodist University at Dallas. He will take over his work September 1.

Menu for the Family

(By SISTER MARY)

Breakfast—Orange juice, cereal, thin cream, breakfast spinach and bacon, crisp rye toast, milk, coffee.

Luncheon—Tomato chowder, toast sticks, peanut butter sandwiches, old-fashioned strawberry shortcake, milk, tea.

Dinner—Saltisbury steak with horseradish sauce and broiled bananas, rice, potatoes, creamed carrots, molded dandelion salad, deep dish cherry pie, whole wheat bread, milk, coffee.

The breakfast dish of spinach and bacon can be used as a luncheon dish if there are no school children in the family who must have a hearty breakfast. If the spinach is carefully looked over and washed the night before, put into the kettle in which it is to be cooked and with the kettle closely covered the vegetable will be perfectly crisp and ready to put over the fire with the coffee for breakfast.

Breakfast Spinach With Bacon

Two pounds spinach, 1/2 teaspoon salt, 2 tablespoons butter, 2 tablespoons lemon juice, 1/2 teaspoon paprika, 6 slices crisp broiled bacon, six squares toast.

Cook spinach in its own juice until tender. Chop without draining and return to kettle. Add salt, butter, lemon juice and paprika and stir over the fire until very hot and thoroughly blended. LUBBOCK MEN TO PAGEANT TO OPEN ANNUAL MEET OF BAPTISTS GO TO HEARING ON WATER

H. N. ROBERTS AND ROBT. SOWDER TO ATTEND STANTON MEET

H. N. Roberts, city paving engineer, and R. A. Sowder, attorney for the engineering firm of Hawley and Roberts, Lubbock and Fort Worth, will go to Stanton, Martin county, on May 10, to attend a hearing concerning the creation of a water district. Mr. Roberts said Wednesday.

The water district will be known as the Martin County-Valley View Water District number one and will serve 24,000 acres, thirty seven and a half sections of land, with water. It will necessitate the drilling of three or four wells, the building of three or four reservoirs and the laying of thirty miles of pipe line.

County Judge To Preside

The hearing will be held before the county judge of Martin county, after which a president and a board of directors will be appointed by that official. A bond issue, to be put before the voters later, will create the district and afford funds for its operation.

The Martin county hearing will be the first affair of this kind ever held in West Texas. The creation of the water district is necessary, due to the fact that no water can be obtained below the 24,000 acres and the land must have some sort of irrigation before it can be sold, rented or put to any practical use other than for grazing.

J. A. Clements, of Stanton, is one of the principal owners of the tract of land and Hawley and Roberts will do the engineering work necessary. H. N. Roberts and Sowder expect to be absent from the city for two days at the time of the hearing.

TEX. WOMEN MEET TO TALK UNITY OF WORLD

SAN ANTONIO, Texas, May 5. (AP)—Women from four Texas cities—San Antonio, Austin, El Paso and Laredo—will meet here May 16 to review the efforts of nearly ten years spent in attempting to further better relations between the nations of North, Central and South America.

The occasion will be the annual meeting of the Pan-American Round Table of Texas, organized here in 1916 and composed of women who believe that when the women of the various countries understand each other, the men cannot misunderstand each other.

The San Antonio chapter, parent organization, will entertain the other organizations at the one-day assembly. The principal address will be made by Mrs. H. H. Sevier of Austin, and at the meeting proposals for strengthening the unity of the three Americas are expected to be discussed.

Peruvian women, through Mrs. Mercedes Gallagher Parks of Lima, recently expressed their appreciation of the work the Round Table is doing. Typical of the women's interest in the Latin-American nations was a Peru and Chile day, at which authorities discussed the Tacna-Arica dispute from the standpoint of the two countries involved.

Most of the Round Table's work, however, has dealt with relations between the United States and Mexico, due to the proximity of the latter republic. One of the outstanding achievements of the organization is considered by Mrs. Clarence T. Griswold, of San Antonio, the founder, to have been the first conference of American and Mexican women held here in 1919 and attended by 200 persons.

"The women who compose the membership of the Pan-American Round Table appreciated long ago that Texas was a cornerstone upon which to cement a closer and more lasting friendship between and among the Americans," Mrs. Griswold said. "Knowing that the fundamentals of every human institution rest upon sociability, the Round Table has for its object:

"First, to provide mutual knowledge, understanding and friendship among the women of the Western Hemisphere.

"Second, to foster all movements leading to a higher civilization, especially those which affect the women and children of these countries."

Each chapter in the state is composed of a director-general, and an assistant director, 22 women who represent the 22 countries of the hemisphere and an associated membership of 20—fifteen born in the United States and fifteen from Latin-American countries.

Meetings are held semi-monthly, and discussions led by one or two women selected to represent some particular country on that day. She tries to see the questions discussed through the eyes of a citizen of the nation she represents.

The Round Table was first organized here in October, 1916, and later the Laredo, Austin and El Paso chapters were founded. It is Mrs. Griswold's hope that in time each state in this country will have one or more Pan-American Round Tables, for, she said, "we feel we have found that there is much in common between the women of the Western Hemisphere that will cement the ties of friendship and humility."

THREE QUESTIONS PARAMOUNT AT BAPTIST MEET

HOUSTON, Texas, May 5. (AP)—Business efficiency in religion, reduction of convention membership, and growth of the church are three outstanding matters to interest messengers to the Southern Baptist convention which meets here May 12. The meeting will be the 87th annual session of the denomination-wide convention.

Reports will show great gains since the body last met in this city in 1915.

Among the outstanding gains that will be reported by the statistical secretary will be more than 3,000 new churches, over 1,000,000 additional members, 4,500 new Sunday schools, more than 1,000,000 new pupils, double the number of Young People's Unions and Woman's Missionary Union organizations, an advance of \$26,000,000 in the value of local church property, doubling of the investment in Baptist educational institutions, trebling the investment in hospitals and a gain of about \$25,000,000 in the annual contributions of churches to all objects.

There is a prospect that the number of baptisms for this current year will total 225,000, which will represent a gain over 1915 of approximately 75,000.

On the foreign mission fields the progress in the eleven year interim that has intervened has been even larger, for in that time the number of mission fields occupied has been more than doubled.

Of the special committees to report this year the two most important are those on business efficiency and basis of representation in the convention. The committee on business efficiency, headed by Dr. Austin Crouch of Murfreesboro, Tenn., is seeking to find more efficient business methods in accordance to the various general boards and other denominational agencies and institutions. The committee on basis of representation, of which Dr. E. Y. Mullins of Louisville, has been in the method of representation in the convention, the hope being that some plan may be discovered whereby the convention may be made more deliberative. It is contended by many that the convention as it is today with about 6,000 messengers is too large to properly deliberate.

There is little likelihood, however, that the body will vote to reduce the number of persons attending. It may be that the executive committee will be clothed with larger power for the consideration of various reports in advance of the convention and report its findings and recommendations to that body.

In addition to its regular business program this year, the convention will give attention at its Saturday night session to good citizenship, when Dr. John L. Hill, book editor of the Baptist Sunday School board, Nashville, will speak on "The Christian as a Citizen."

JOHNSON BEGINS HIS 2 YEAR TERM

Confesses to Mail Fraud in Mexico Land Case And Is Taken To Leavenworth

KANSAS CITY, May 5. (AP)—Albert C. Johnson, 61 year old promoter, who yesterday confessed to using the mails to defraud in a Mexican land settlement scheme, today was taken to the Federal penitentiary at Leavenworth, Kans., to begin serving a two year term.

Johnson wept as he entered his plea of guilty in Federal Court here and was unable to read a statement he had prepared on his part in the swindle. He asked to be taken to Leavenworth at once.

Johnson received thousands of dollars for worthless Mexican land from hundreds of persons in all parts of the West. He operated through the Mexico Land Company here and the West Coast Agriculture and Land Company of Los Angeles. Branch offices were established in Oklahoma and Texas.

He was president of the company and was arrested in Los Angeles in February, 1925. He was indicted by a Federal grand jury here in April 1925, with Mrs. E. M. Johnson. The charges against the others were dismissed yesterday.

The government charged the company did not own the land it offered for sale.

Nearly 100,000 acres of land was included in Johnson's colonization project. Federal officials said he obtained more than \$1,000,000 for the acreage sold, an average of \$70 an acre.

He was brought here yesterday by C. F. Washer of Kansas City who signed Johnson's bond for \$10,000. The investigation started when Johnson was turned back from the border by Mexican officials when he attempted to escort a group of "stockholders" to their prospective homes. The Mexican authorities told the would be settlers the land they wished to farm would not support them.

FRESHMEN SHOWED WELL IN SPRING TRAINING

AUSTIN, May 5. (AP)—Stellar showing of freshman gridirers was the most encouraging feature of Texas university spring football training, which ended last week, Coach E. J. (Doc) Stewart said today.

For a period of two months, 50 performers who hope to represent the orange and white next fall worked out three times a week under Stewart and Bill James, the line coach. All indications are that at least half of the regulars of the 1926 squad will be recruits from the 1925 Yearling outfit, coached by Clyde Littlefield and "Shorty" Anderson.

Among the most promising of the first-year performers who gave evidence of their worth in spring training were Ed Beular of Beaumont and Steve (Red) Wray of Donna. Beular, captain and quarterback of the 1925 "Fish," is the most formidable rival Joe King of Dallas, last fall substitute varsity quarterback, will encounter next fall. Both King and Beular are former all-state high school field generals and the two will wage a spirited battle for the honor of piloting the sturdy eleven "Doc" Stewart will place on the field.

King is probably the headliner performer; but Beular is the more effective ball-toter. Too, Beular is a bit heavier and a trifle more sturdy than the Dallas lad. He weighs about 155 pounds, and King 150 pounds.

Wray, 190 pounds of speed, light and power, barring accidents, will be the first string center of the 1926 Longhorns. This big lad from the Rio Grande Valley loves the game and plays it with a dash and vigor calculated to delight the heart of any coach. He is unquestionably the most promising of a likely crop of freshman forwards, and would have been a regular on the 1925 Varsity, had he been eligible.

The freshman group of candidates boasts a larger number of capable line performers than of backfield stars, which is fortunate, for the Longhorns will have available a wealth of veteran backfield material, including Captain Mack Saxon of Temple; Leo Baldwin of Wichita Falls; Rufus King of Austin; Johnnie Ester of Dallas; Fred Thompson of Rusk; Maurice Stallier of Eastland; and "Pettys" Allen of Lubbock. All these earned their "T" in 1925.

These veterans back of the line played, together with freshman recruits, should give Stewart one of the strongest backfield combinations in the Southwest Conference.

Among the first-year line men are: ends, Bill Ford, a product of Dallas Highland Park; Orval Rhodes, a star from Dallas Oak Cliff; and Charles Hogue, Cold Springs; tackle, Jack Cowley, a big lad from Blossom; guards, Harry Phillips, Dallas Forrest Avenue; John Mobley, Houston Central; Herbert Tigner, Julliff.

Tom Hughes, a product of Texas-Kahala, is among the most promising backfield stars of the first-year players. He weighs about 145 pounds, is fast, and knows how to hit and back up a line. Longhorn letter men will have to hustle next fall if they keep Hughes from handling a regular job with the Steer backfield.

Hughes has done the 100 yards dash in 16 seconds, flat, and he uses his speed to advantage on the gridiron. Jimmy Boyles, a graduate of Houston Central high school, ranks with Hughes; while Garrett McKinnon of Poth has given promise of developing into a long distance punter of note.

At least two transfers will bid for berths on the 1926 squad. They are: Dick Fonger, former Texas Christian university football and baseball letter man; and Oids, a former Trinity university player. Oids plays in the backfield.

Most of the "T" wearers who will be out for football next fall were engaged in either track or football and did not go out for spring grid training. Among the forwards who did go out were Basil Penney, Kerens, guard; "Ox" Higgins, Dallas, tackle; Murray Moore, Electra, tackle; and "Pettie" McCullough, Waco, guard.

Moore, who will be playing his 3rd season for the Steers next fall, is expected to be one of the most sensational performers of the conference. Coach Stewart, whose pessimistic predictions in other seasons, earned for him the title "Doleful Doc," is frank to admit he expects Moore to win the 1926 All-American honors at tackle. In 1924 and 1925, Moore played guard; but tackle seems to be his natural position.

Similarly much is expected of Higgins, who in 1923 won all-state honors when playing end for Dallas Oak Cliff. He played tackle for the Steers last year, and was ranked one of the outstanding forwards of the conference, though 15 pounds underweight due to sickness.

Brooklyn continues its sterling pace as the teams of the major league prepare for the first long journey of the year. Before the end of the week the National's battles will be taking place in the West and the American's in the East.

Jess Petty, big left-hander of the Dodgers, remains undefeated in five appearances, although yesterday he had difficulty in subduing the Boston Braves, 3 to 2. Petty allowed Boston only seven hits. Opposing teams have made only 24 errors in 47 innings off him this season.

Jacques Fournier, home run tender of the majors and Gautreau of the Braves became tangled when Fournier slid into second base on a double. Fournier was carried from the field with a sprained right ankle and Gautreau received a severe spine wound. Herman and Bell joined hands to give the St. Louis Cards a 3 to 2 verdict over the Cincinnati Reds. Verdman allowing only four safeties after the third and Lester pounding out the hits that meant victory.

The New York Yankees have lost two straight contests for the first time in 1926, Philadelphia, by hitting hard behind Jack Quinn won again yesterday, 10 to 5. Mickey Cochrane producing a home run.

Cleveland drove Van Corder from the mound in the fifth and ran away from the St. Louis Browns, 11 to 5. Ullie permitted 13 hits, including three doubles but remained in the box throughout with a long lead in his favor. He made three of the Cleveland safeties for a perfect day at bat.

BASEBALL HEADS MEET THURSDAY NIGHT HERE

A meeting is to be held in the City Hall here Thursday night when matters pertaining to the status of baseball, both financially and otherwise are to be discussed. It was announced Wednesday. A committee of baseball enthusiasts will meet a committee from the Lubbock chamber of commerce in an effort to bring out a plan of raising sufficient funds to carry the local club through the season.

The more enthusiastic baseball supporters here who have taken a lead

in the negotiations to keep baseball alive, have been promised full cooperation of the chamber of commerce and Board of City Development, and it is believed probable that the meeting will lead to the naming of a solicitation committee that will canvass the city the first of next week seeking to sign up sufficient funds in monthly pledges to support the club.

It is estimated by baseball leaders that approximately \$1,200 monthly will be required for proper financing, and this would care for only the salaries of players who will be brought here. Skipper Sled Allen said Wednesday that he and his four colleagues who have leased the park will care for all expenses except the salaries, but that the townspeople of this city are being looked to by them for the salary money. Gate receipts will be used for miscellaneous expenses, and if there be such a thing as a surplus from this fund at the end of the season, it is the plan to let this apply on expenses of the contemplated trip to the Denver tournament this fall.

The season will run about three and a half months, which at \$1,200 a month would necessitate the pledging of \$4,500 for salaries. It is not the plan, however, to raise all the money in cash, but to take pledges for monthly payments throughout the season.

Details in connection with the plans will be worked out at the meeting Thursday night, and local men are warned to be in readiness for the solicitors some time the first of next week.

FT. WORTH INVITES WEST TEXAS TO CELEBRATION

The citizenship of West Texas has been invited to attend a celebration that will be held in Fort Worth on Saturday afternoon of this week when "Miss Fort Worth," one of the air mail carrier planes that will run between Fort Worth, Dallas and Chicago, will be formally christened, according to advices from the West Texas Chamber of Commerce.

Fort Worth, in appreciation of the naming of the plane, has arranged a suitable program for the christening of the airship, and the ceremonies will be held at 2 o'clock Saturday afternoon at the flying field on the Decatur road north of the city.

Miss Mary Meacham, daughter of Mayor Meacham of Fort Worth, will officiate at the christening ceremony, and following this there will be a chorus of 500 girls ending with a flying circus that will last more than an hour. Approximately 50 planes will participate.

The opening of the air mail service on May 12 will mark a new epoch in transportation for Texas, for in addition to mail, the planes will carry express, which should be a great aid in filling rush orders for lighter class goods throughout the state.

Mail leaving Fort Worth, Dallas and Chicago in the mornings after the arrival of inbound mail trains will arrive in either city in ample time to reach out-of-city points on evening trains. All mail that reaches Fort Worth on morning trains will arrive in Chicago the same evening, and in New York the following morning, reducing the time of delivery about 36 hours. This also applies to intermediate points, such as Oklahoma City, Wichita, Kansas, and Kansas City.

POLICE HOLD TWO IN DEATH OF YOUNGSTER

PETERSBURG, Ind., May 5. (AP)—Mrs. Beatrice Hollis, 55 held in connection with the death of Leander Roe, nine year mascot of the nearby town of Winslow, has told the police that the youth was slain by his father, Thomas Roe, 35, but authorities today were skeptical that her statement revealed her entire knowledge of the case. Roe, in solitary confinement, has denied any knowledge of his son's death.

Prosecutor William Dugan resumed his questioning of the woman, insisting upon her signing a motive for killing the boy and checking carefully her statements. That Roe placed the lad's clothing on the bank of the Patoka River, hid the body in his home while searchers dragged the stream and then, when the search was abandoned dumped the body with the aid of two men, whom she refused to identify into the water where it was found last Friday.

REQUIREMENTS IN CONTEST ENTRY ANNOUNCED

AUSTIN, Texas, May 4. (AP)—Requirements for competing in the American Youth Award and the American Teacher Award contests to be staged in connection with the Sesqui-Centennial Exposition at Philadelphia have been announced by Judge A. S. Walker of Austin, chairman of the Texas committee.

One high school boy, one high school girl, and one woman teacher will be selected from every state in the Union to attend the 150th celebration of American independence the week of June 28 to July 5. They will be guests of honor of the directors of the exposition from the time they leave home until they return, with all living expenses and transportation paid.

Any girl or boy who wishes to compete must obtain official entry blanks from Judge Walker, 704 E. Third Building, Austin. These applications must be executed in duplicate and mailed not later than May 22 to the Sesqui-Centennial International Exposition board.

Any boy or girl who is a bona fide resident of Texas, and who by July 4, 1926 must have reached his or her thirteenth birthday, and not reached the nineteenth birthday is eligible. The entry form of each candidate must bear the endorsements of two sponsors, one of who may be any adult person and the other any clergyman, lawyer, physician, school official or teacher.

On the entry form of each candidate must be signed the permission of parents or guardian for the candidate to make the trip.

"The boy and the girl, who either by the performance of some act of heroism or devotion or by virtue of some other fitting qualification has been adjudged the best representative of American ideals and youth will represent Texas," Judge Walker said.

"Similarly, the woman teacher who has accomplished the greatest good for her pupils will be named to represent the Lone Star State. The manner in which these selections will be made will be announced later."

Applications for the Teacher Award must be obtained directly from exposition headquarters at Philadelphia, though the selection will be left to the state committee of award.

The candidate must be teaching school in Texas; her entry must be entered on the official form; and this form must be endorsed by two sponsors, one of them may be any adult person, and the other any clergyman, lawyer, physician, school official or principal.

NEW ORLEANS TRADING

NEW ORLEANS, May 5. (P)—The cotton market opened in sympathy with lower cables than due, first trades showing losses of 4 to 7 points. The early figures proved to be the low for the time being as the market rallied owing to the increasing prospects for unfavorable weather in the belt and by the end of the first hour July traded up to 17.43c and October to 16.59c or 5 to 9 points above the early lows and unchanged to yesterday's close to 2 points higher. At the end of the first hour, the market was steady at the highs while waiting for the weekly weather report.

The market ruled quiet but steady all morning. The weekly weather report was considered bullish and this with the official forecast for showers in the West caused prices to advance somewhat, particularly for October which traded up to 16.59c, or 15 points above the early low. December advanced to 16.66c, or 10 points up and July gained 8 points at 17.46c. At mid-session the market was at the highs.

The market ruled firmer after mid-session, owing to the press of liquidation of the May position. July traded up to 17.54c; October to 16.73c; and December to 16.74c. Weather reports showing rains in Texas helped the advance towards the beginning of the final hour prices reacted easing off 4 to 7 points from the highs.

NEW YORK TRADING

NEW YORK, May 5. (P)—The cotton market opened at a decline of 2 to 3 points, active points showing net losses of 5 to 8 points in early trading under liquidation, with local and Southern selling.

Failure of British labor news to show any apparent improvement, weak Liverpool cables and expectations of a fairly favorable weekly review of crop progress by the weather bureau, seemed responsible for the decline which extended to 18.55c for May and 17.16c for October.

There was considerable covering by near month shorts, however, while private reports of cold rains in Texas brought in some buying of new crop positions. Prices were two to three points up from the lowest at the end of the first hour.

The weekly report of the Weather Bureau laid rather more stress on unfavorable features in crop progress than anticipated by some of the early sellers and the forenoon market held steady. Old crop months recovered their early losses, May selling up to 18.60c, while new crops were relatively steady. There probably was some buying on private predictions of another showery spell in the Southwest. October advanced to 17.27c, the market ruling about net unchanged to 3 points higher at mid-day.

There was no fresh news factor in the early afternoon but covering continued and the market worked up to 18.63c for May and 17.32c for October, or about 2 to 3 points net higher. Trading remained quiet but the market held within 2 or 3 points of the best around 2 o'clock.

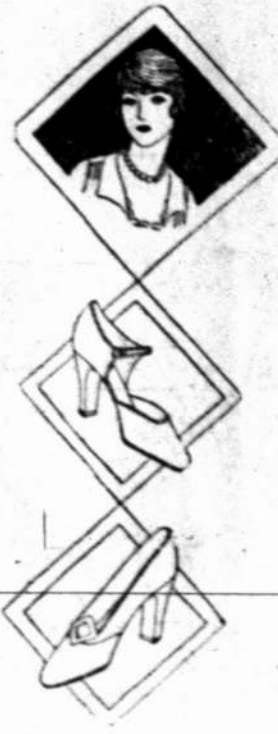

WATSON CONCEDED VICTORY OVER ADAMS

INDIANAPOLIS, Ind., May 5. (AP)—James E. Watson, veteran of many Indiana political battles was victorious in another engagement yesterday when he vanquished in the republican primary Charles Adams, an Indianapolis attorney, who was his sole opponent for the long term Senatorial nomination. As the tabulation of returns continued today, the majority of Senator Watson, a resident of Bushville, mounted steadily.

Mr. Adams admitted defeat. For the republican short term nomination Senator Arthur R. Robinson of Indianapolis maintained a majority over four opponents. In the event that he holds the majority until the final count he will be the nominee. Otherwise the party's state convention designates the nominee. Without opposition, Evans Woolen, Indianapolis banker, became the candidate for the democratic short term nomination. Albert Stump of Indianapolis was leading the field of six for the democratic long term Senatorial nomination. Figures tabulated early today gave: For the republican long term nomination: 1,277 out of 3,551 precincts in the state; Watson 88,459; Adams 34,728.

Republican short term nomination: 1,277 precincts; Senator Robinson 66,921; Arch Graham, South Bend, 21,869; Oswald Ryan, Anderson, 12,973; Ward A. Hiner, Indianapolis, 8,864; Dr. James R. Norrell, Indianapolis, 4,633. Democratic long term nomination, 1,169 precincts: Stump 12,452; William A. Cullen, Vincennes, 12,737; George Rauch, Marion, 8,178; L. William Curry, Indianapolis, 7,748; L. Ert Slack, Indianapolis, 12,289; John E. Frederick, Kokomo, 14,690. The voters also registered their preference for Congressional, Legislative and County office seekers. Eleven of those seeking congressional honors were unopposed. Three of these were republicans and the other eight were democrats. All 12 of the present congressmen sought re-election.

Fighting in London. LONDON, May 5. (AP)—Fighting occurred in the Shepherd's Bush District of London this afternoon. When a tram car running under police protection broke down, a crowd gathered and began flinging missiles through the windows. A motor bus was also stoned and finally overturned. Then a free fight broke out in which women participated. Many were injured by broken glass. The police used their clubs freely. In the Limehouse, one of the roughest districts in the city, taxicabs were

driven off and other demonstrations were held. At King's Cross, the unruly crowds were so large that many of the big shops closed.

A crowd at Southwark chased three mounted policemen who were forced to flee. **Tramway Workers Return.** PORTSMOUTH, England, May 5. (AP)—Fifty percent of the tramway employees who were on strike yesterday, returned to work this morning when it was announced they would be dismissed if they failed to report for duty.

Communists Enter Row. MOSCOW, May 5. (AP)—The executive committee of the Communist International says a proclamation issued here "appeals today to transport workers the world over. The English struggling proletariat and workers of other lands look to you. Yours is a task of the greatest responsibility. You must not let a single train or boat carry coal or oil to England until the struggle ends."

The all-Communist International section will immediately propose to the Social Democrats of all countries to organize united action by committees empowered to undertake all kinds of aid for the British workers. "With your leaders where they are willing and over their heads where they oppose. Social Democrats and non-party men must, with the Communists, create committees of action for the aid of the British worker." After stating that the greatest danger of the present situation lies in possible treason by local leaders who "lead to behind," the appeal winds up with the following statement: "This great struggle connects a new era in class struggle, not alone for England, but for the world proletariat." The proclamation lays stress on the point of the ultimate effect of the strike on the world's revolutionary movement, saying: "Whatever happens, regardless of the developments of the near future, no one can doubt that the events in England open a new era in England's and the world's labor movement. There is no power able to stop the quick Bolshevization of the British proletariat."

Strike Is Unbroken. LONDON, May 5. (AP)—Great Britain's monster general strike continued today without an indication of weakening by either side to the controversy. The coal miners and various other industries remained inactive by reason of the lockout by the mine owners and the declaration of the general strike by the trade union congress.

Two untoward incidents have occurred to disturb the otherwise orderly situation. Hoodlums in the East London dock district, where there is a large number of foreigners reputedly imbued with the Russian brand of Communism, started trouble by stopping street traffic. This culminated in rioting but the police used their clubs vigorously. Broken heads sent a score of persons to hospitals.

In Glasgow, another hotbed of radicalism, strikers attacked motor buses and smashed windows in them but did not harm the passengers. **Rumors of Settlement Discounted.** There had been rumors of a fresh attempt to resume negotiations looking to settlement of the strike, but these apparently were without basis in fact, for the deadlock continued. Both the trade unionists and the government claim that things are going satisfactorily to their respective viewpoints.

That the call to strike was widely responded to by the workers is obvious; but some industries, or at least some sections of them continue working, whether by permission by the trades union congress or of their own volition, is not clear. Similarly it is uncertain the amount and quality of the volunteer help being enlisted to keep the utilities services going. It is rumored that many of the transport workers are lukewarm to the strike and that these may gradually filter back to work. But this one of many rumors that cannot be verified.

No Shortage of Food. There has not as yet been any shortage of food. Great Britain, however, is so largely dependent on imported food stuff that if the strike continues and there is a stoppage of shipping there is bound to be a shortage which may lead to close rationing.

The orderliness with which the strike opened was somewhat alarmingly broken in the East London dock district yesterday in the Poplar, Canington and Blackwell district areas. The police say the mobs which gave them trouble were not legitimate trade unionists, but toughs of a dangerous

type. They began their disorder by holding up street traffic during the day and compelling cabs conveying workers to halt. They did little harm to the occupants. Late in the evening the mob grew dangerous. The machinery of several cars was wrecked and the passengers roughly turned out. Many of these were women who were forced to continue their journey on foot. When the police intervened there was lively rioting. The constables raised blows on the rioters with their clubs and numerous disturbers of the peace were in bad shape when, with the aid of reinforcements, police finally cleared the streets. The police today were apparently expecting a renewal of the trouble and were keeping a strong force handy.

Continental Workers Join In. Continental workers in many centers already have proclaimed sympathy with the British strikers, who rely on the support of European comrades financially, if need be, but in any case in preventing the transportation to Great Britain of coal and other merchandise which would be detrimental to the interests of the strikers. Today was the first day that Londoners were without their familiar newspapers. They were able to obtain only the government's British Gazette, printed on one side of paper, and a quaint little leaflet in typescript, issued by the Times. The British Gazette is being published for the stated reason of keeping the people informed as to the true aspects of the strike. The government sent large consignments of the issue by airplanes to Northern cities.

May Call Out Troops. LONDON, May 5. (AP)—Home Secretary Sir William Joynson-Hicks made a statement in the House of Commons this afternoon which heavers interpreted as meaning that the government was prepared to use troops to maintain services of vital importance, such as the railways, if necessary. Sir William said the government was empowered to call on the Crown forces to assist in maintaining any services that the government deemed vital. He designated such services as electricity, maintenance of the electrical and mechanical plant and machinery of the port of London, the transport of motor fuel and continuance of the railway services. His pronouncement was greeted with loud cheers from the Conservative majority.

French Workers Walk Out. PARIS, May 5. (AP)—Two thousand workers in an automobile factory at Saint Ouen, a suburb of Paris, have struck in sympathy with their British comrades.

The Extremist Labor Federation is trying to get its adherence to walk out. Frank Hodges, secretary of the Miners International Federation has telegraphed to affiliated secretaries to hold themselves in readiness for any eventualities.

An international strike is regarded in labor circles here as unlikely although Mr. Vign insists it is quite possible. He says Mr. Hodges will call a meeting of the international committee, either in London or in London in a few days, at which grave decisions may be taken.

Demands Halt in Strike. LONDON, May 5. (AP)—The British government will not negotiate for settlement of the coal miners' dispute as long as the general strike continues. Lord Bickenhead declared in the House of Lords today.

Strikers Attack Tram Car. LEADS, England, May 5. (AP)—Several thousand strikers attacked an emergency tram car with humps of coal taken from a passing lorry. The windows of the car were smashed. Some of the passengers had narrow escapes from injury.

Police Guard Jitney Drivers. NEWCASTLE, Eng., May 5. (AP)—Extra police, including a large number of volunteers, patrolled the streets of this mining center today to protect the jitney drivers, some of whom were attacked by strikers.

Liverpool Buses Attacked. LIVERPOOL, May 5. (AP)—Hooligans attacked buses manned by volunteers in Wallasey, a suburb of Liverpool this afternoon. Two policemen were injured. The drivers and conductors of the buses were roughly handled.

W. R. Standefer, 80, Buried at 2:30 Today

W. R. Standefer, pioneer surveyor of West Texas, was buried at 2:30 o'clock this afternoon at the Lubbock cemetery, following his death at Tredway, Borden county, about 10 o'clock Tuesday morning.

Mr. Standefer lived in Lubbock for many years and was County Surveyor for about 20 years, surveying many tracts of land in this section for the first time. He was living at Wilson at the time of his death but had gone to business. Word was sent to his family early Tuesday morning that he was seriously ill and he died before any of them could reach him. His body was brought to Wilson last night and to Lubbock this morning. Mr. Standefer was born in Alabama almost 80 years ago and was brought to Texas when he was six weeks of age. He has lived here since, coming to West Texas in the early days. He is survived by his wife, who is almost as old as her husband, by a daughter, Mrs. John Agnew, Lubbock, and a son, Earl, who lives in Canada and cannot attend the funeral. A grandson, Emmett Agnew, lives in Lubbock and another grandson, Hoyt Agnew, arrived from Cisco this morning to attend the funeral. A brother of Mr. Standefer, Jim, arrived from Clayton last night to attend the funeral. Mrs. Hoyt Agnew and Mrs. Jim Standefer accompanied their husbands here.

ORDER OF PARADE HERE FRIDAY IS GIVEN OUT

Leaders in the Boys Week movement here, which is now well under way are anticipating one of the biggest parades Friday afternoon that has ever been

seen in Lubbock. It will consist of possibly 25 sections, featuring every organization of boys in the city, and will include certain parts of the public school and representatives from various adult organizations that are interested in boys work. The details of the parade have been worked out by a committee headed by Chas. Whitacre, with the co-operation of public school authorities, who have agreed to dismiss a little early so that the parade may move off on schedule time. The procession will form at 3:15, and will move off at 4:00 o'clock in the following order:

The first three sections including boys with their donkeys, Lubbock's "big little" boys, and the DeMolay organization will form on Main St., between Avenues S and T facing toward the city. The Rotary float, Tech band, and Tech cadet corps will form on Main between Avenues T and U, and high school boys will form on Avenue U just south of Main St. The Junior high school boys and the Kiwanis float will form on Avenue T just south of Main. These sections will move off first in the order named, and on Avenue Q just south of Main the Central Ward school and American Legion float will form, while just north of Main on Avenue Q the High School band, Boy Scouts, Elk float and K. Carter school will form, these to join the parade in the order named as it passes.

On Avenue M just south of Main, the Lubbock Fire department with a truck and the Geo. M. Hunt school will form, and will bring up the rear of the parade, which will course through the main business section of the city.
